(57) **CLAIM**

I claim the ornamental design for a snake mug, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, left side perspective view of a snake mug showing my new design;

FIG. 2 is a top, rear, right side perspective view thereof;

FIG. 3 is front view of the snake mug;

FIG. 4 is a rear view of the snake mug;

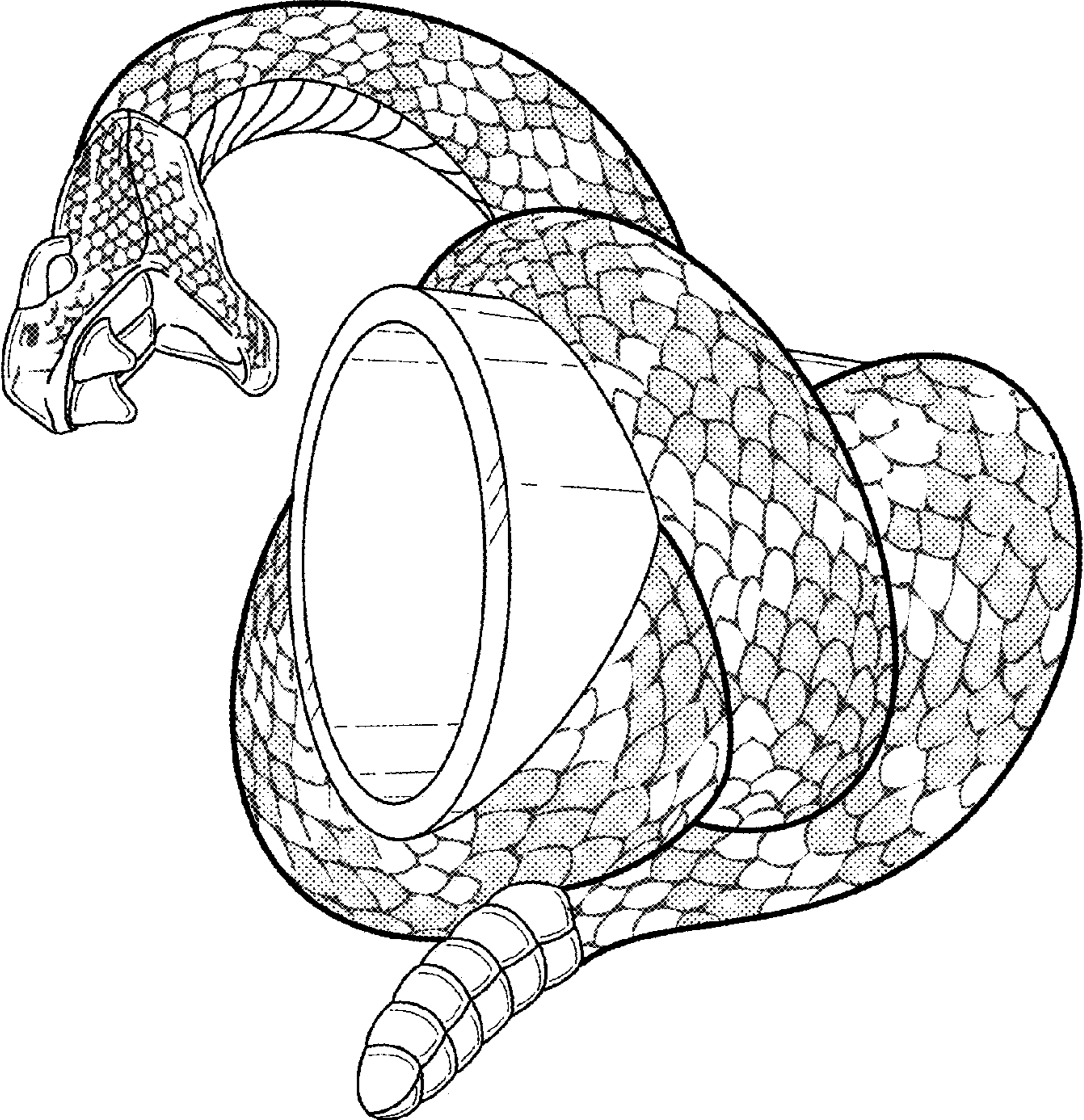

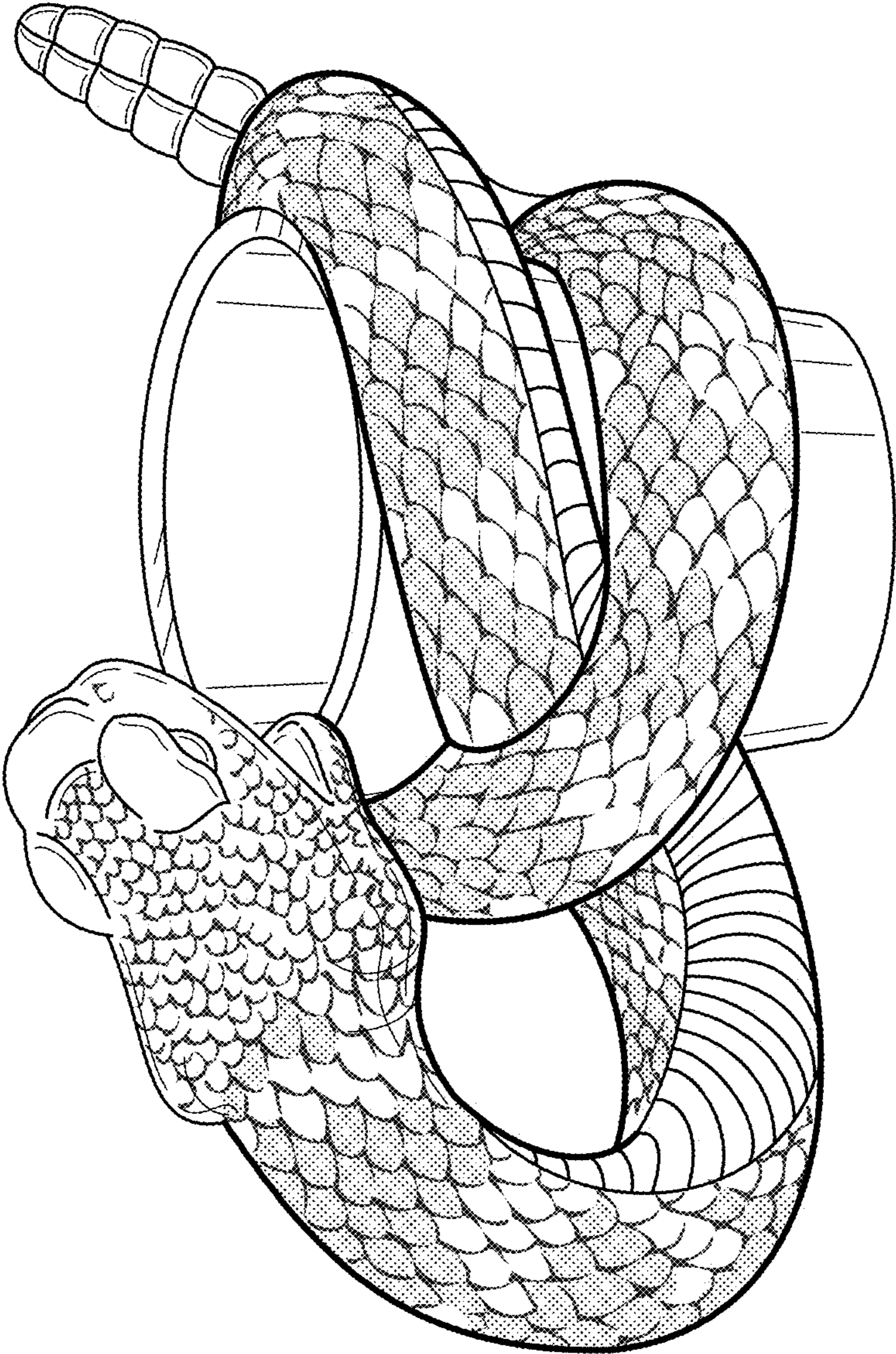

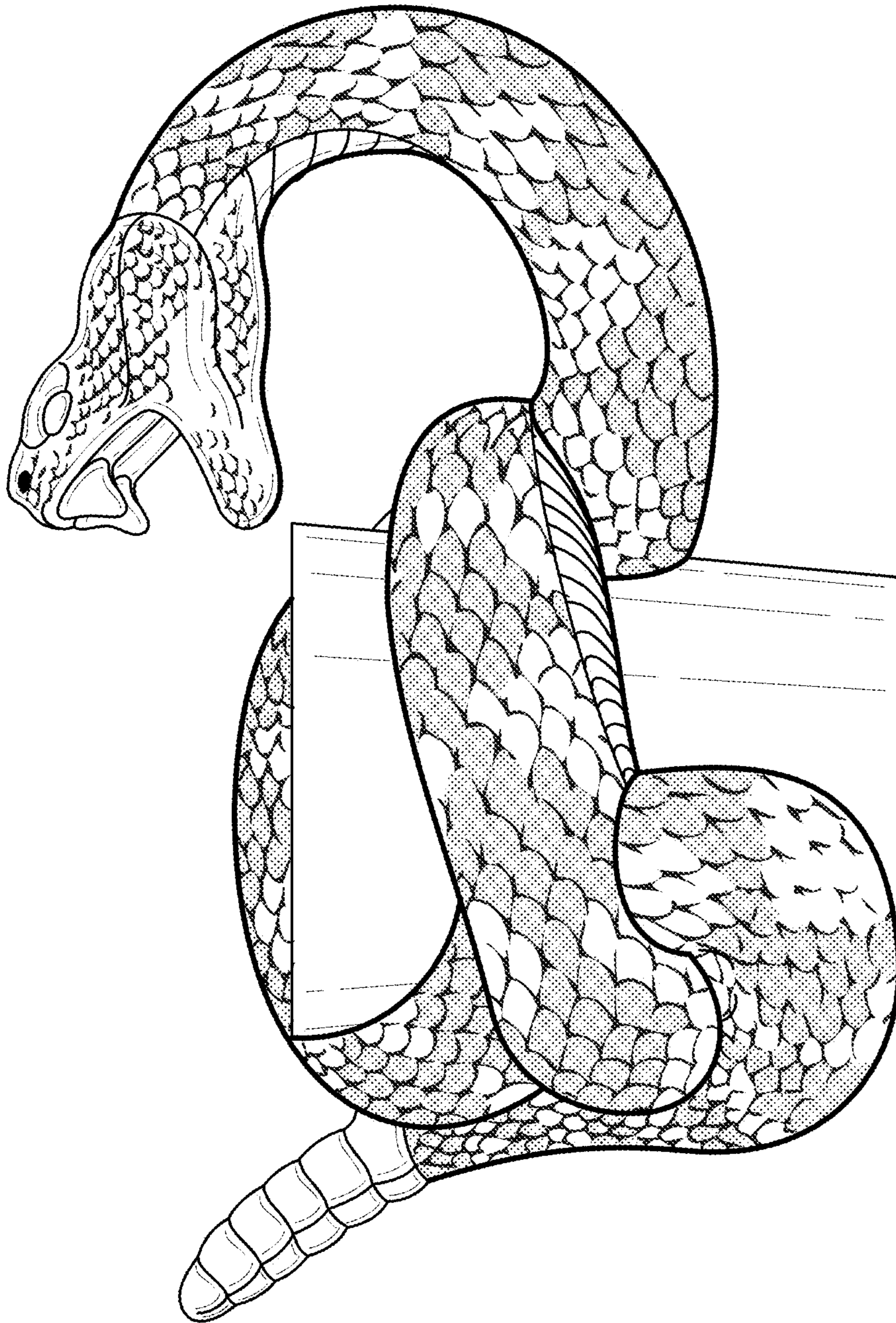

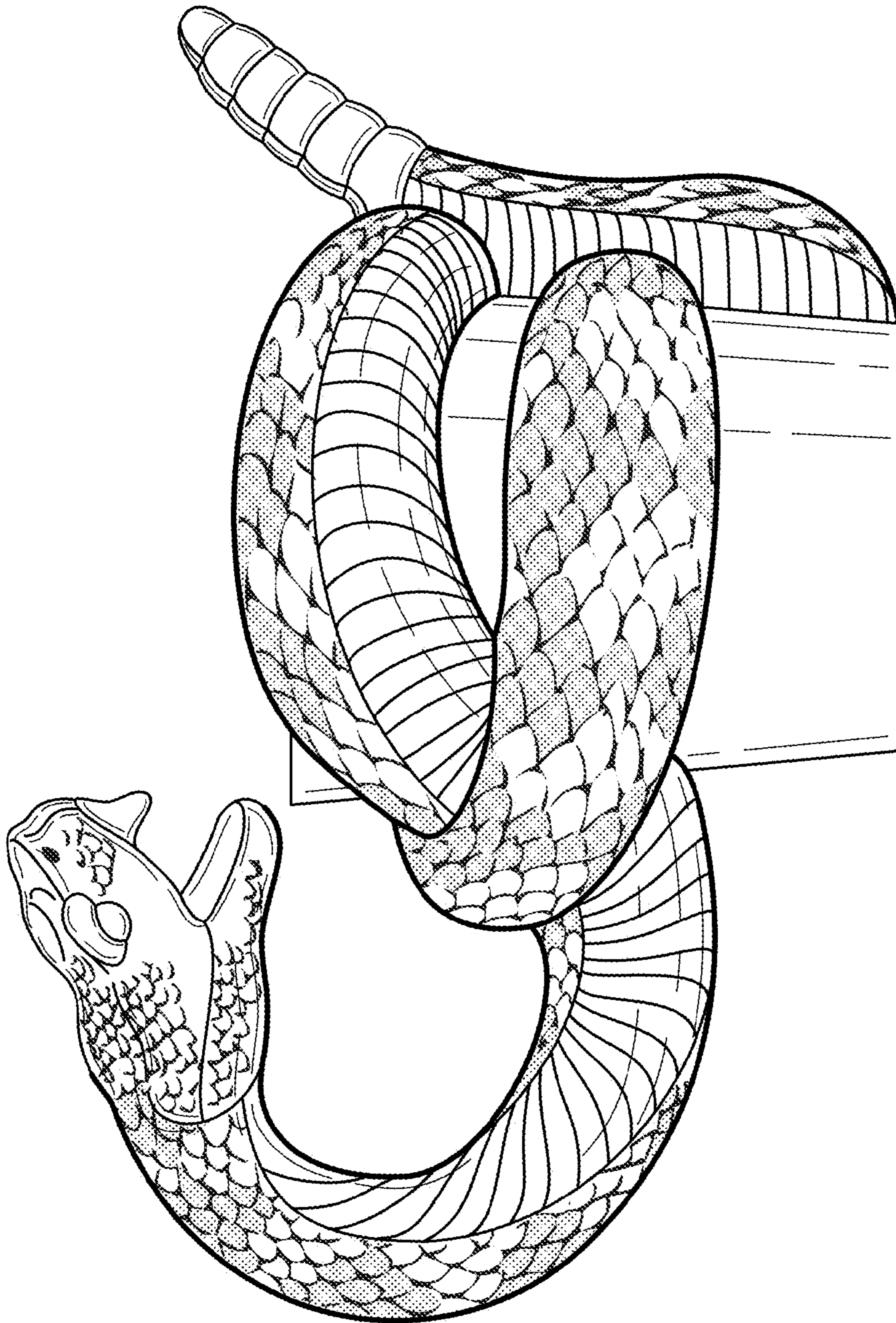

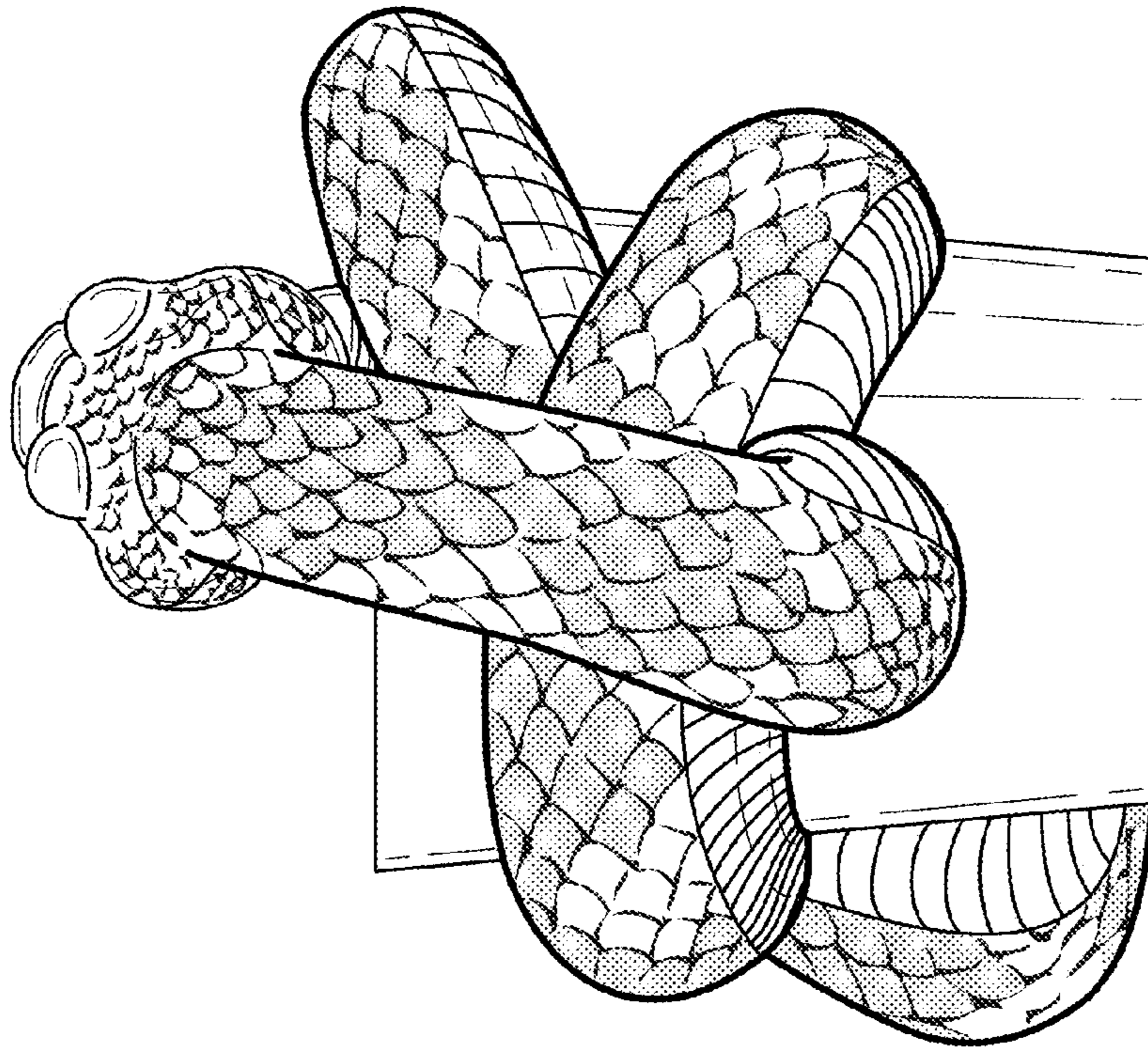

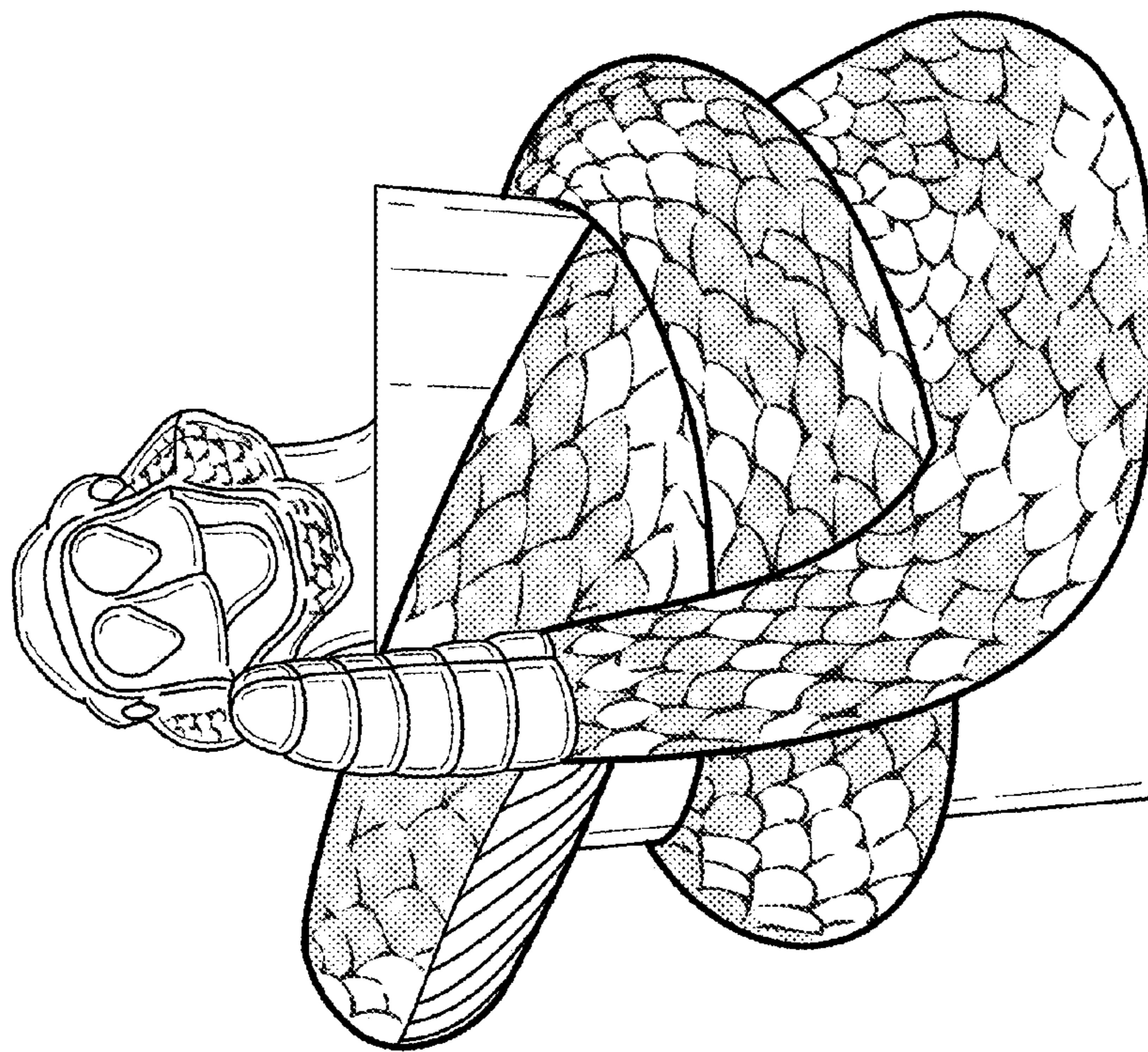

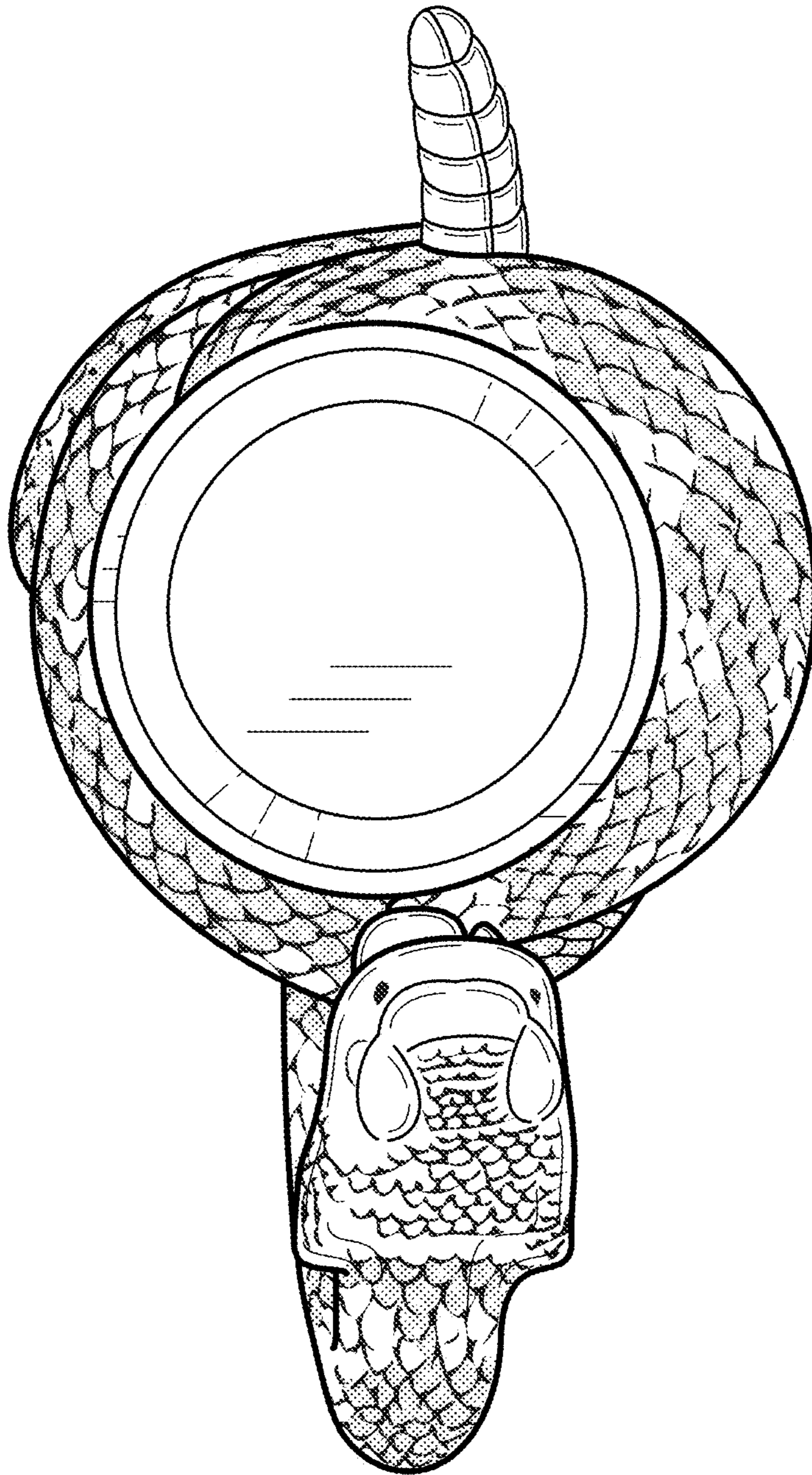

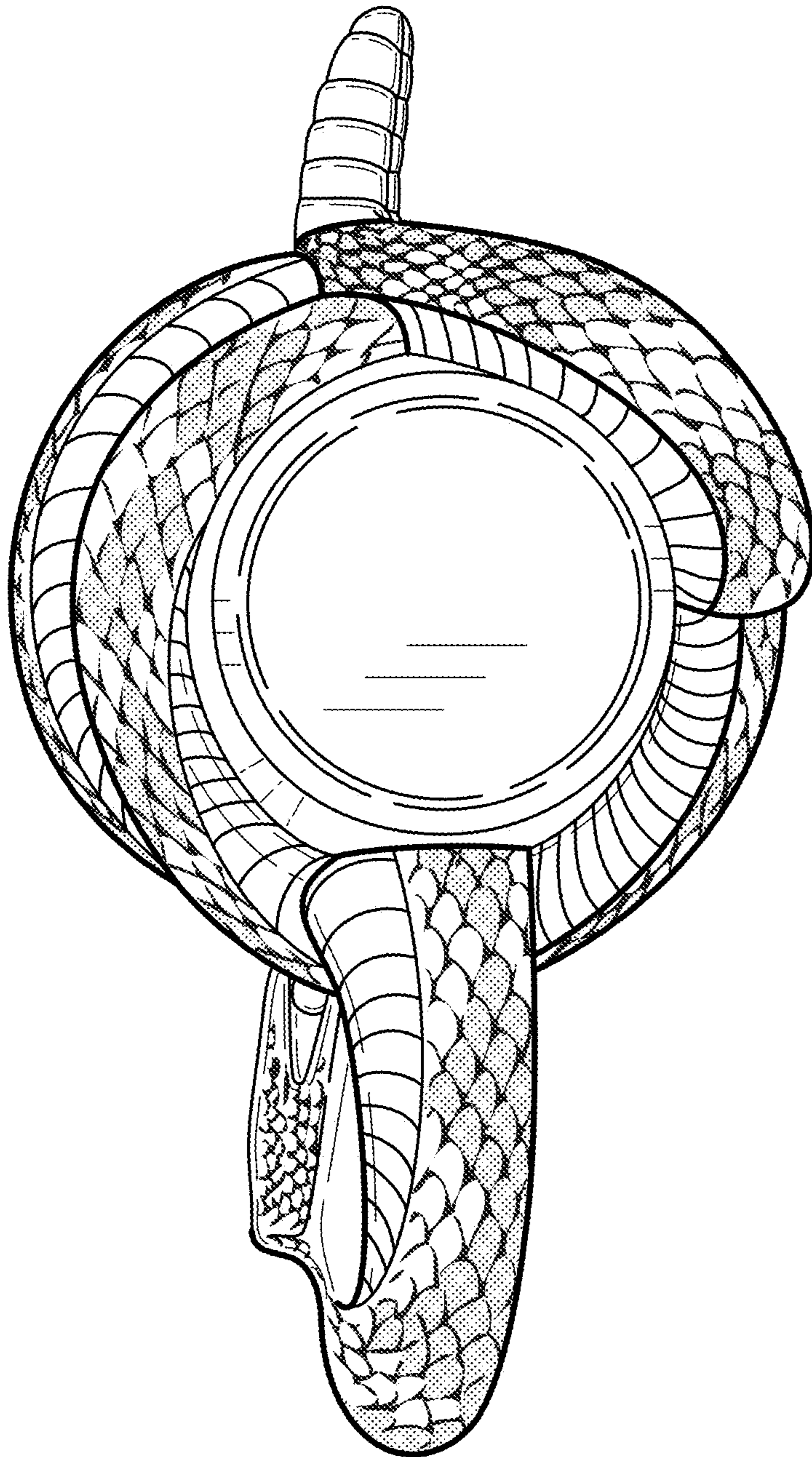
