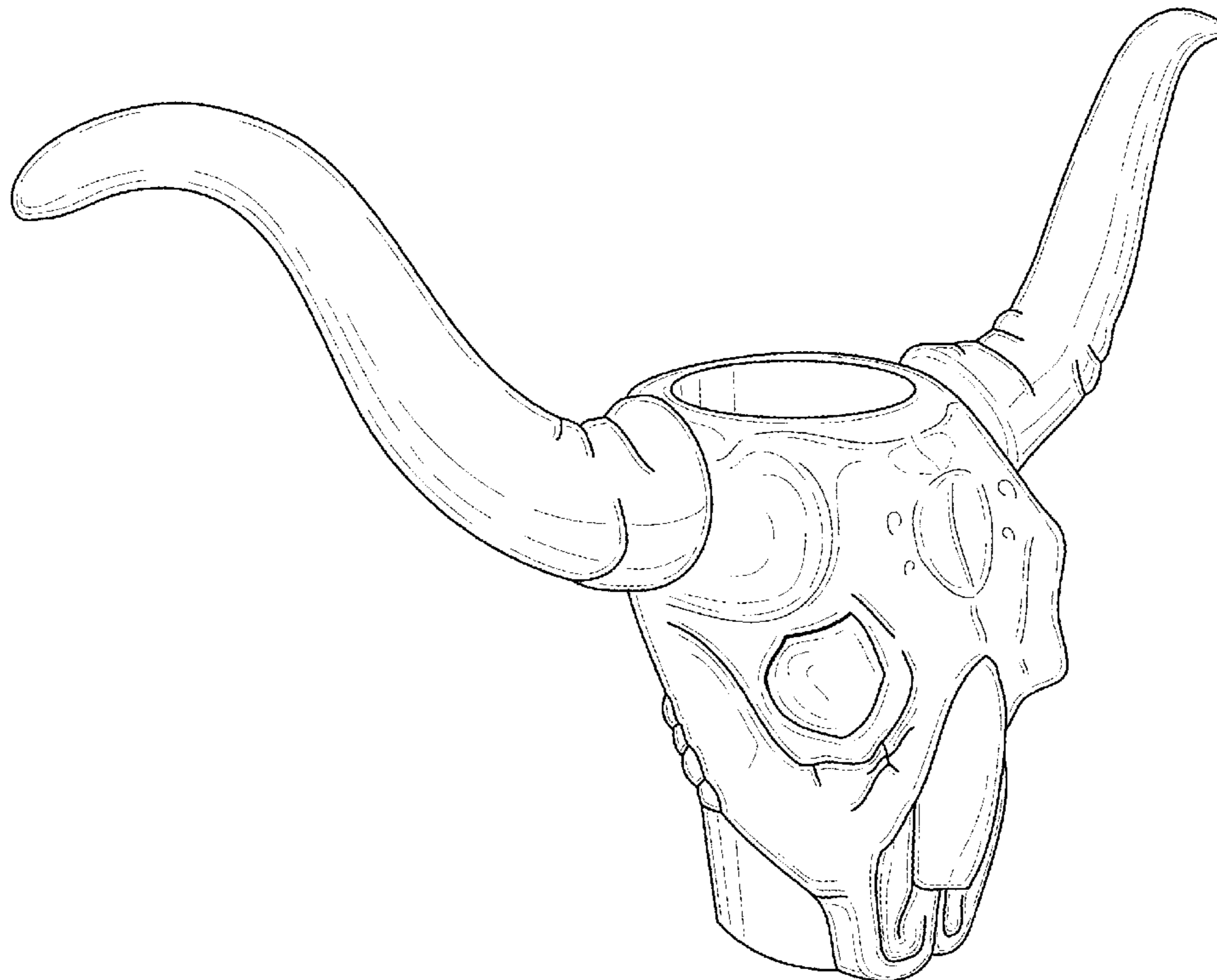
(57) **CLAIM**

We claim the ornamental design for a horned mug, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, front, left side perspective view of a horned mug showing my new design;  
FIG. 2 is a top, rear, right side perspective view thereof;

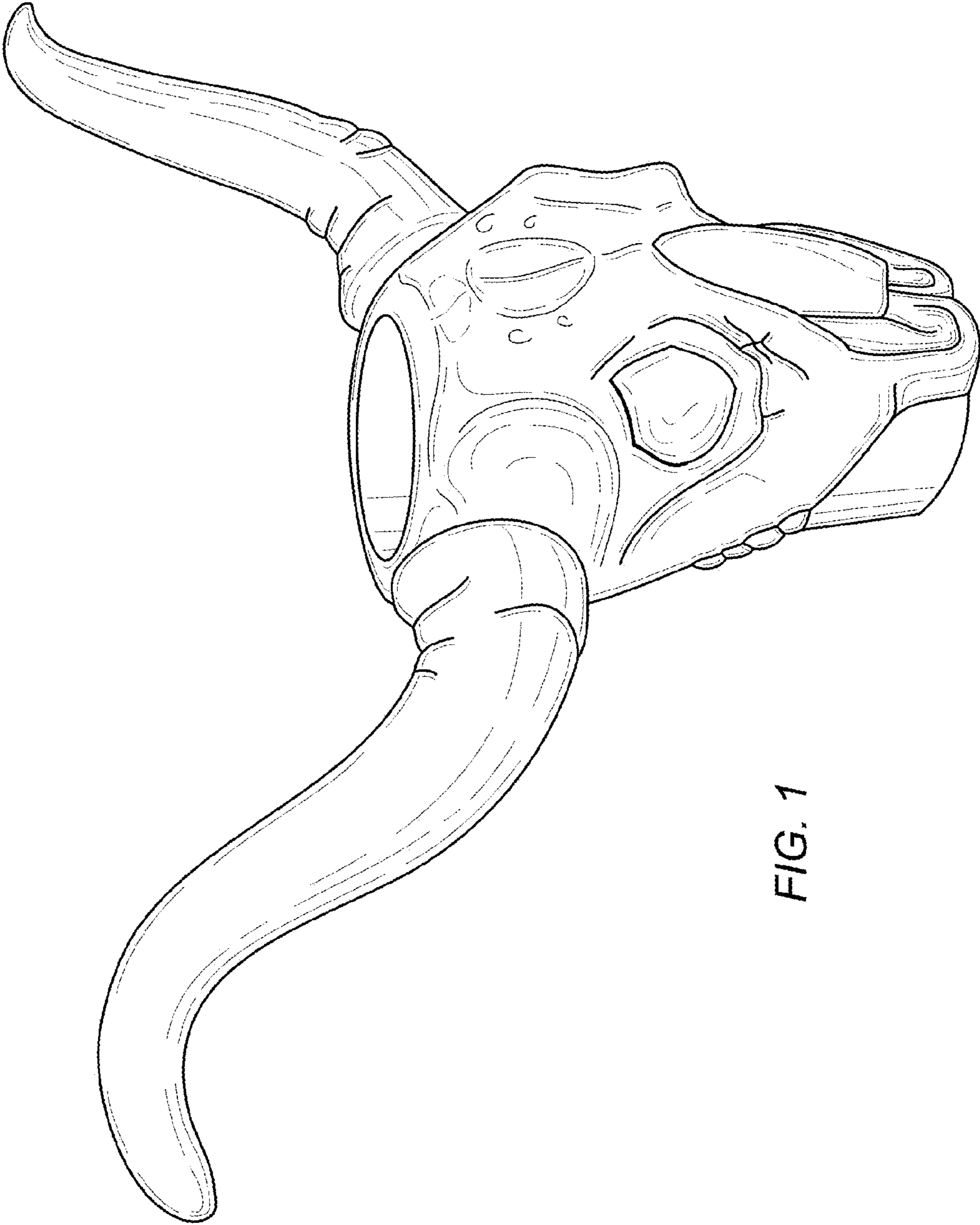

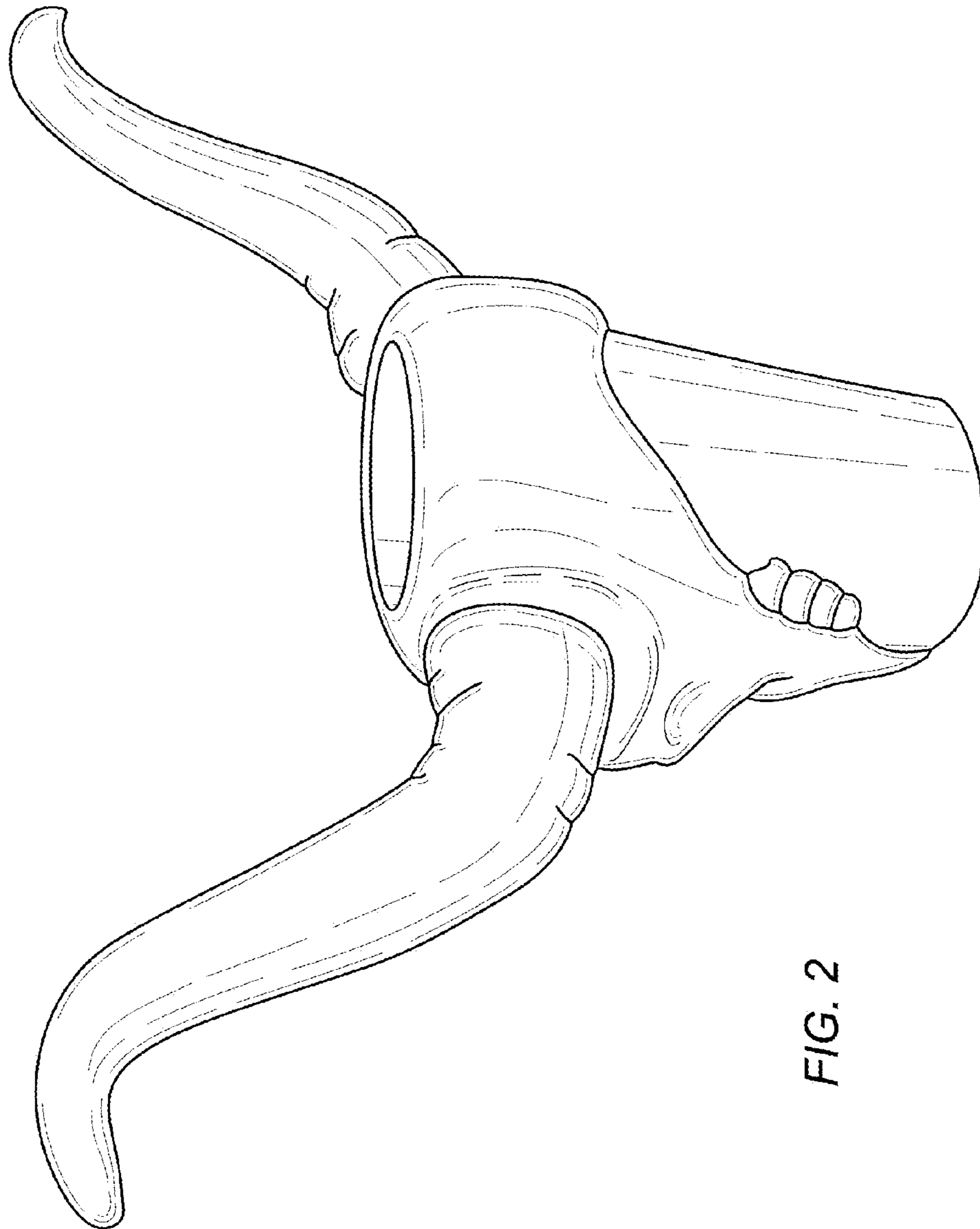

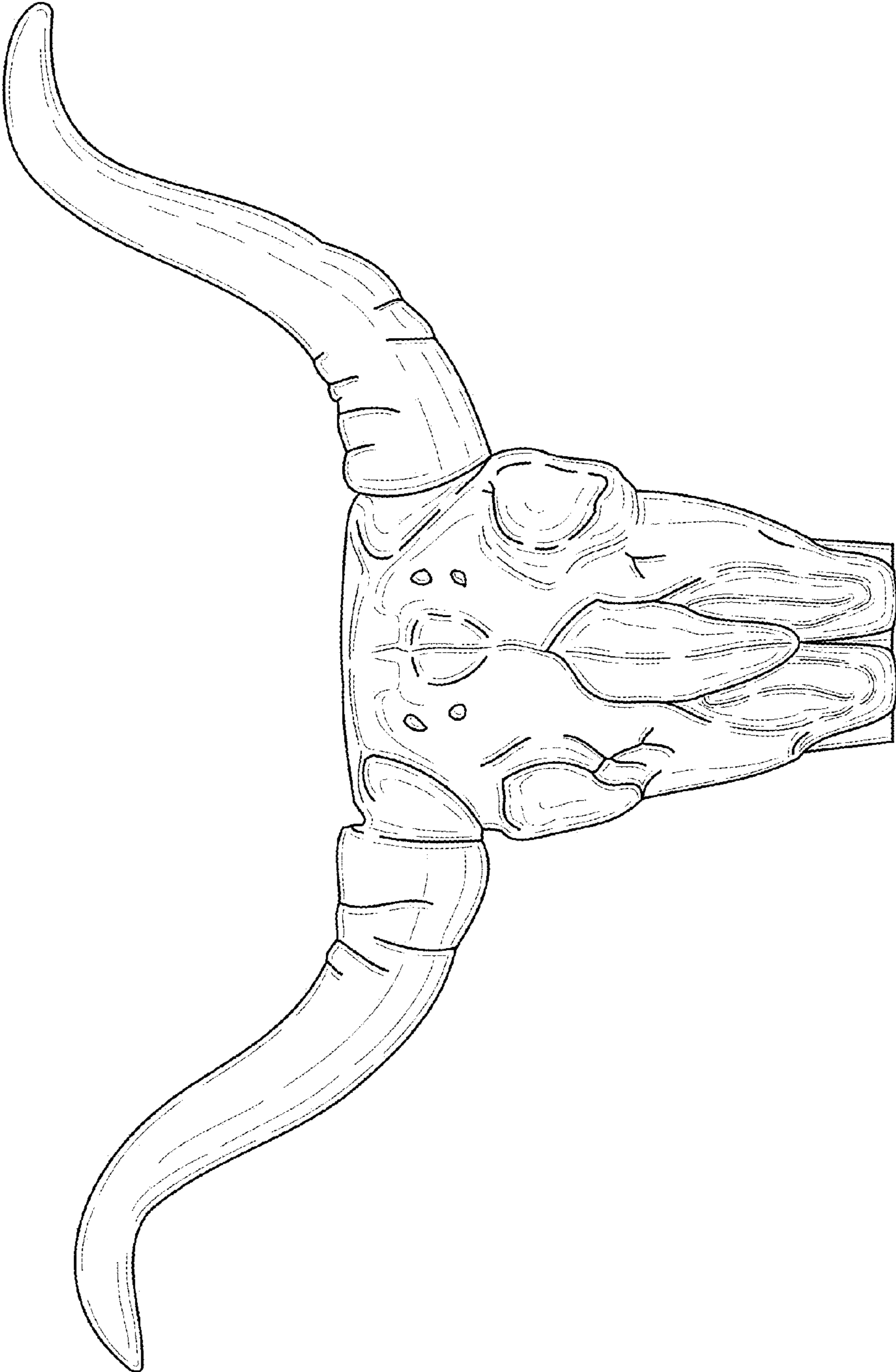

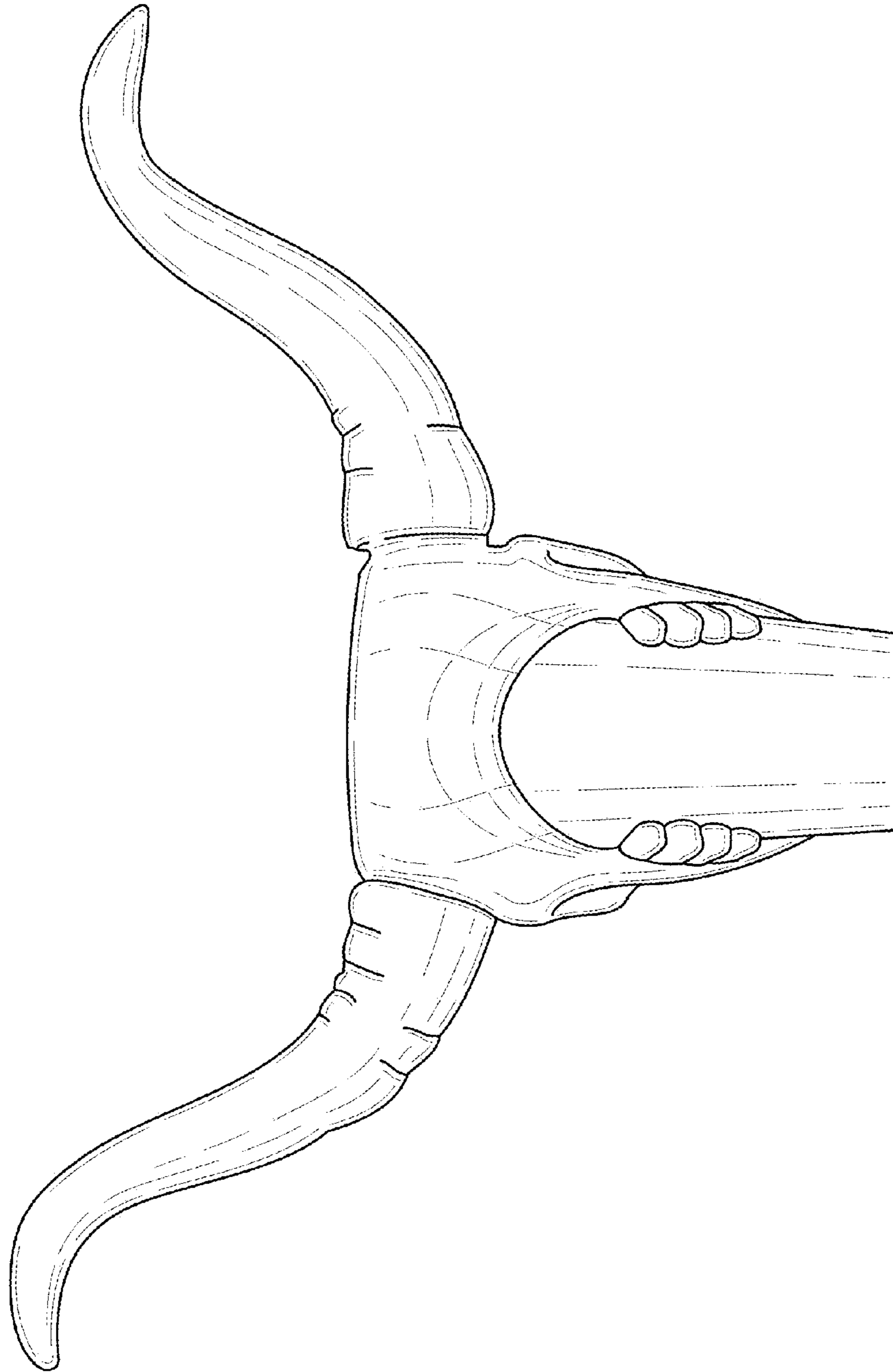

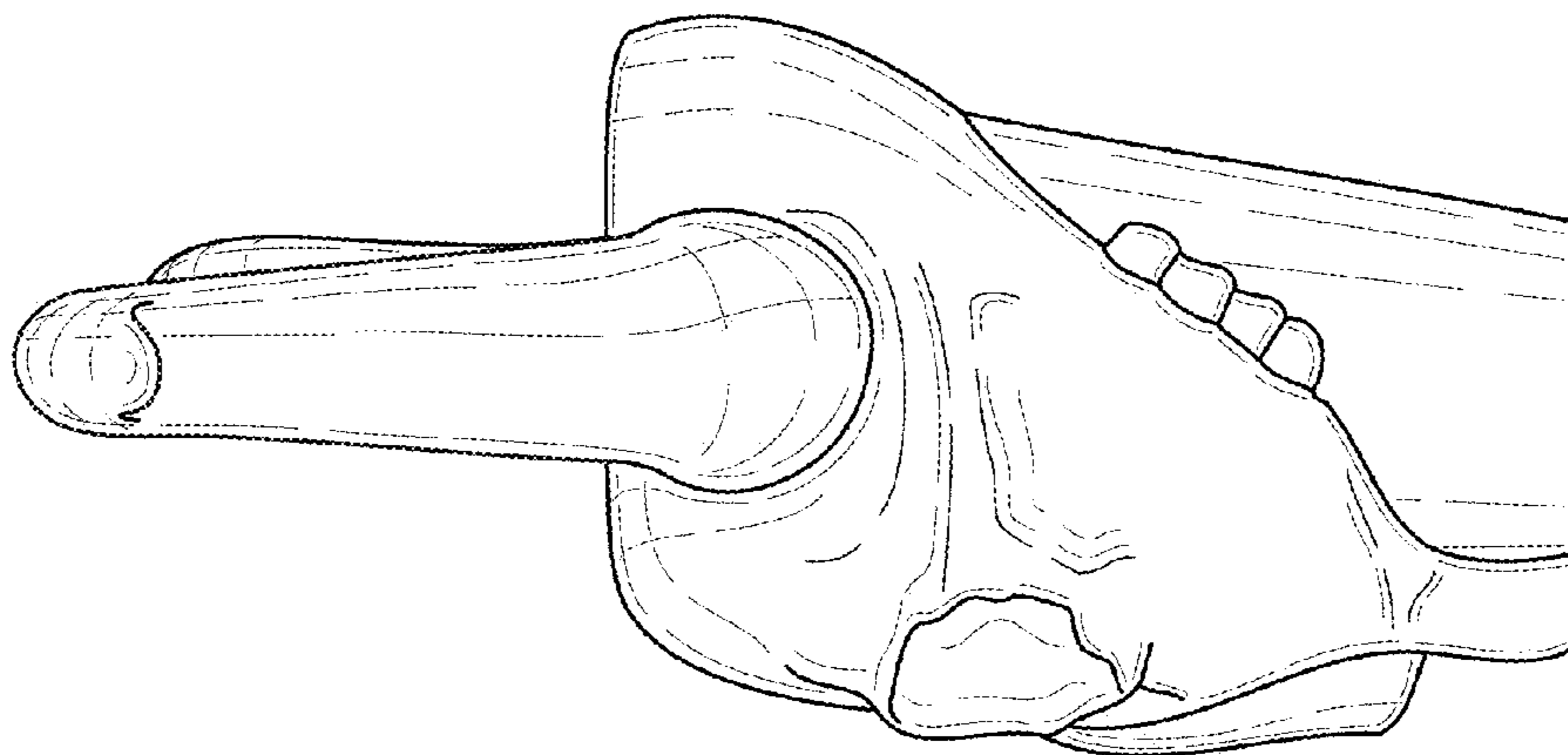

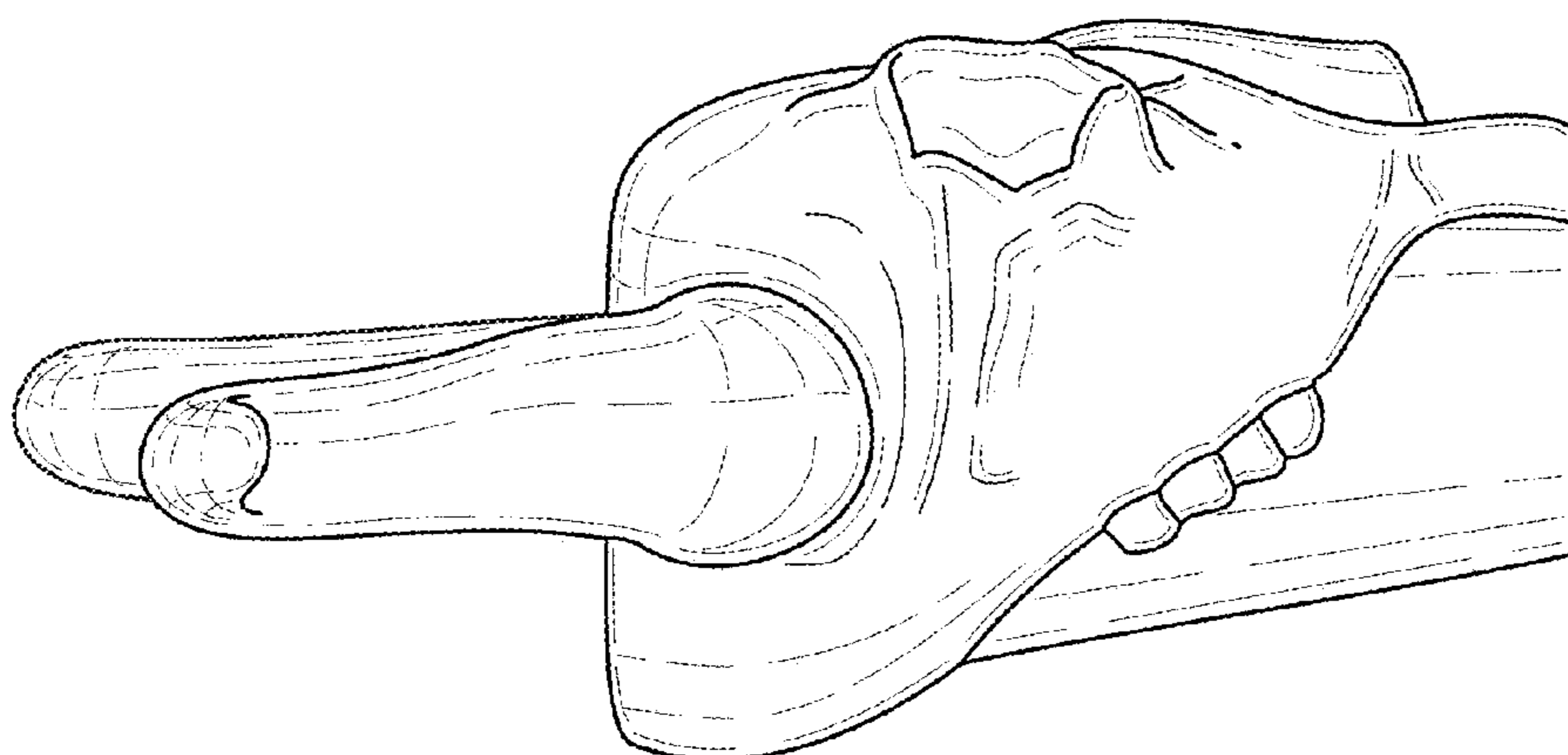

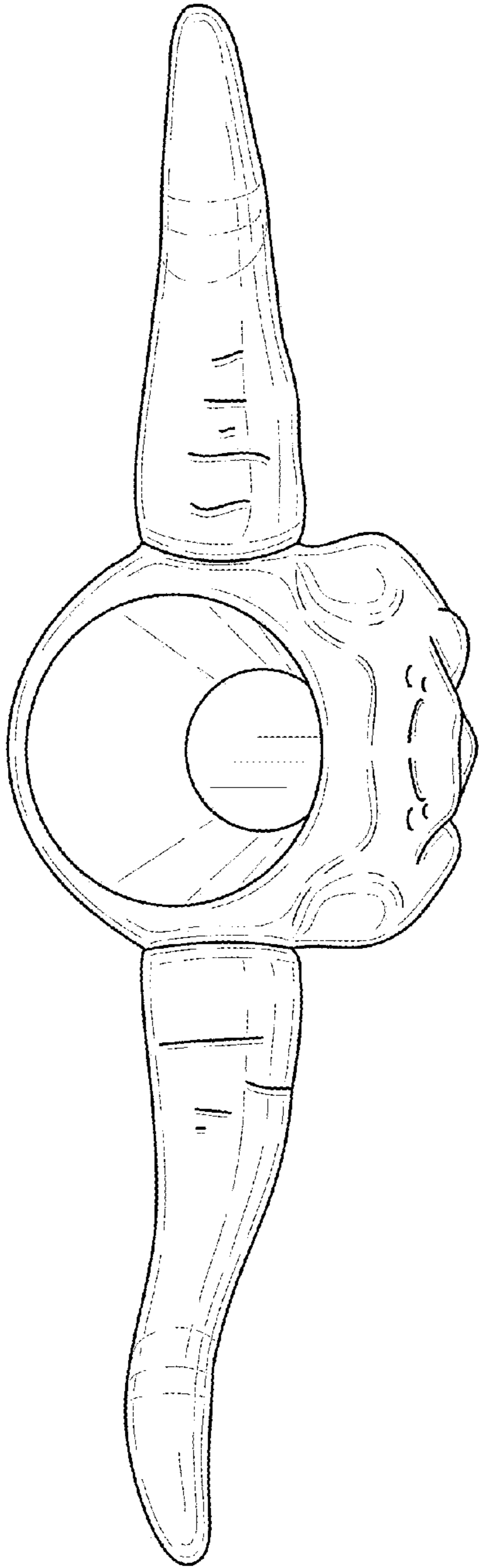

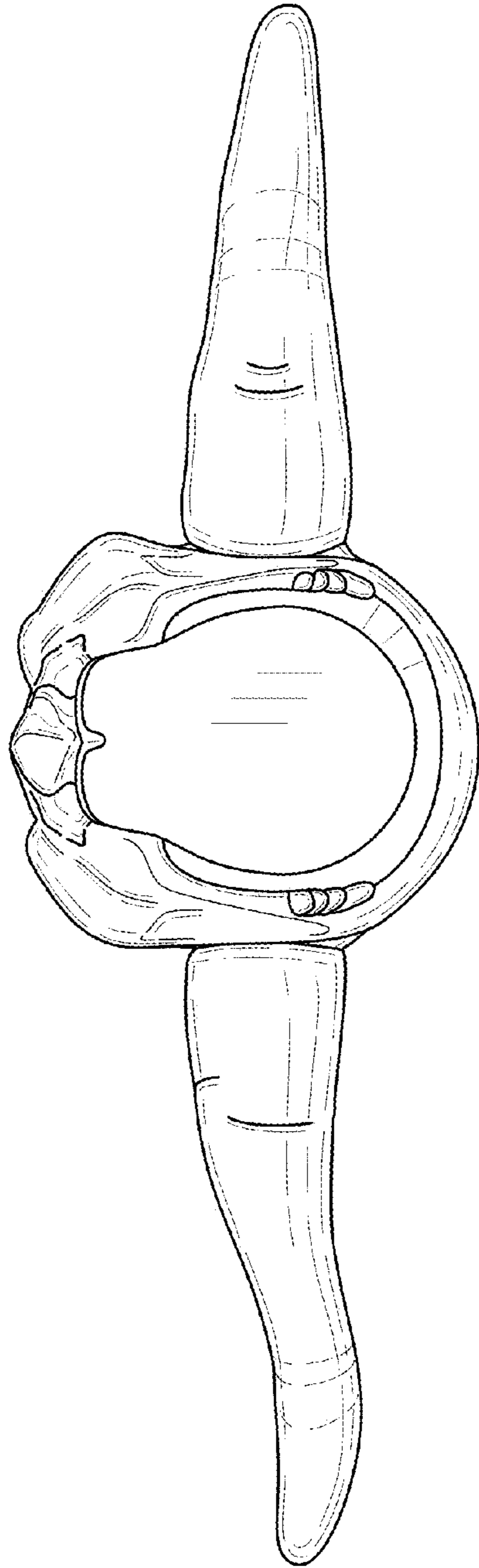
