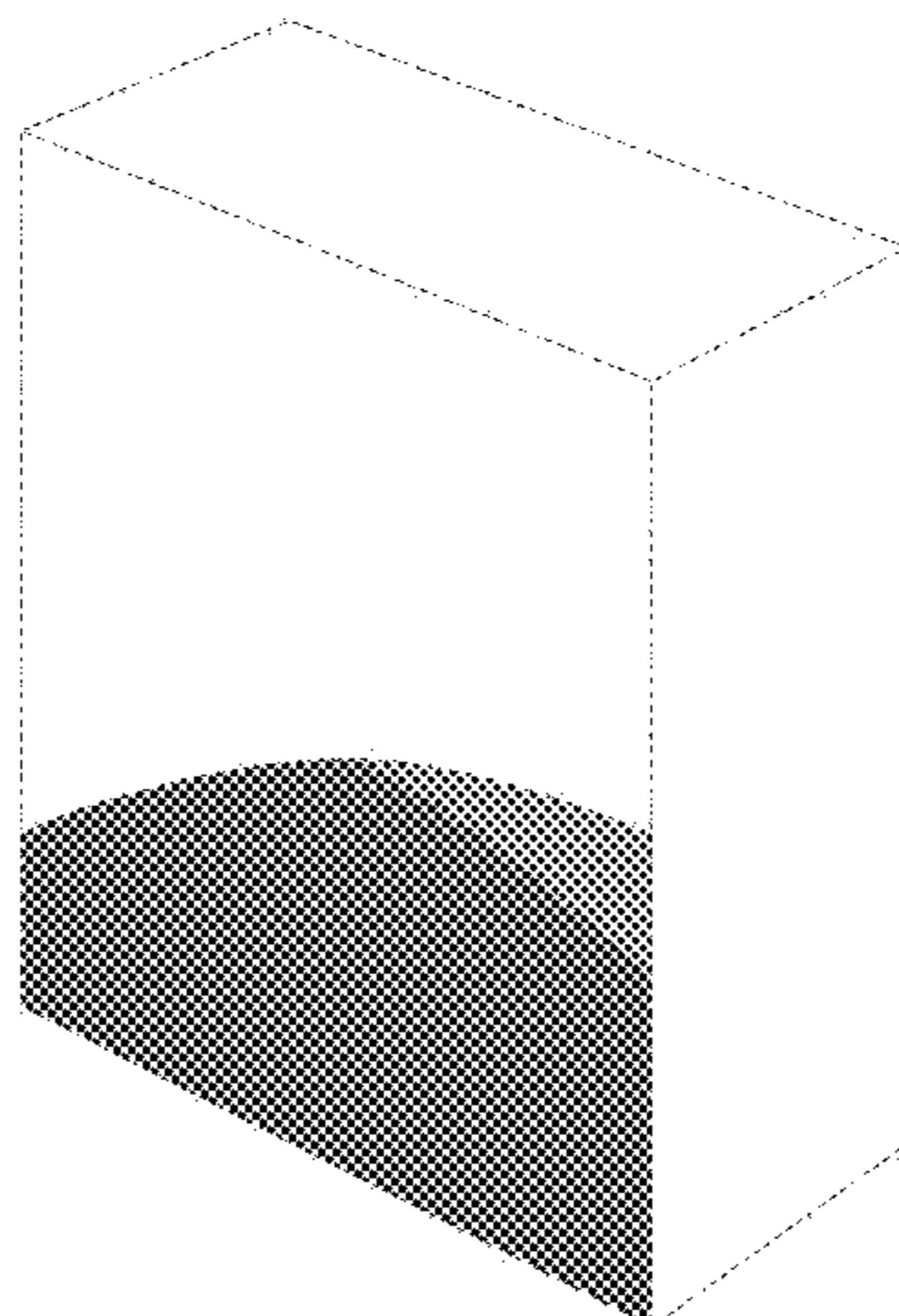
Broken lines in the figures depict environmental subject matter only and form no part of the claimed design. In FIGS. 8-9 the medicinal container is lined for color.

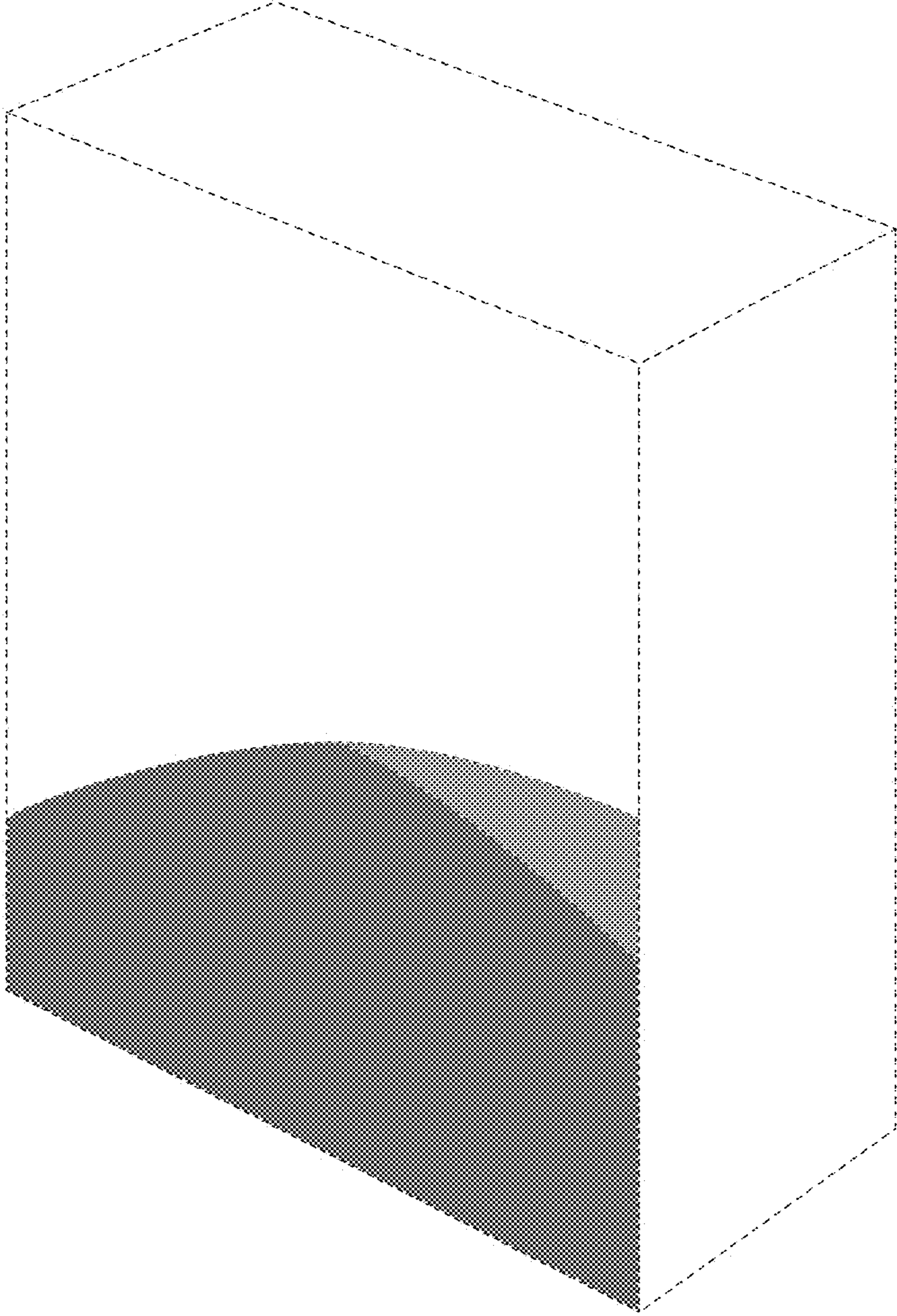

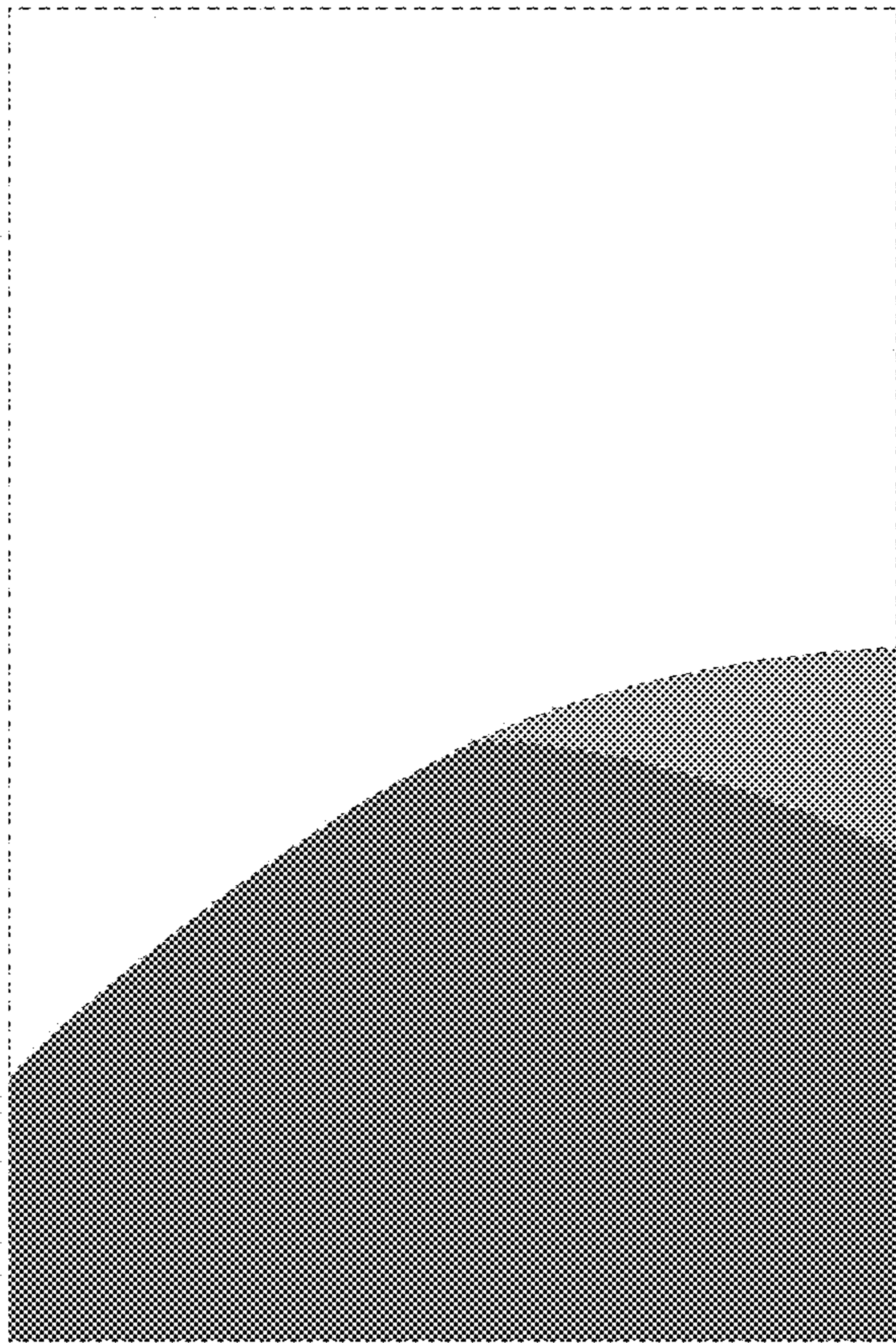

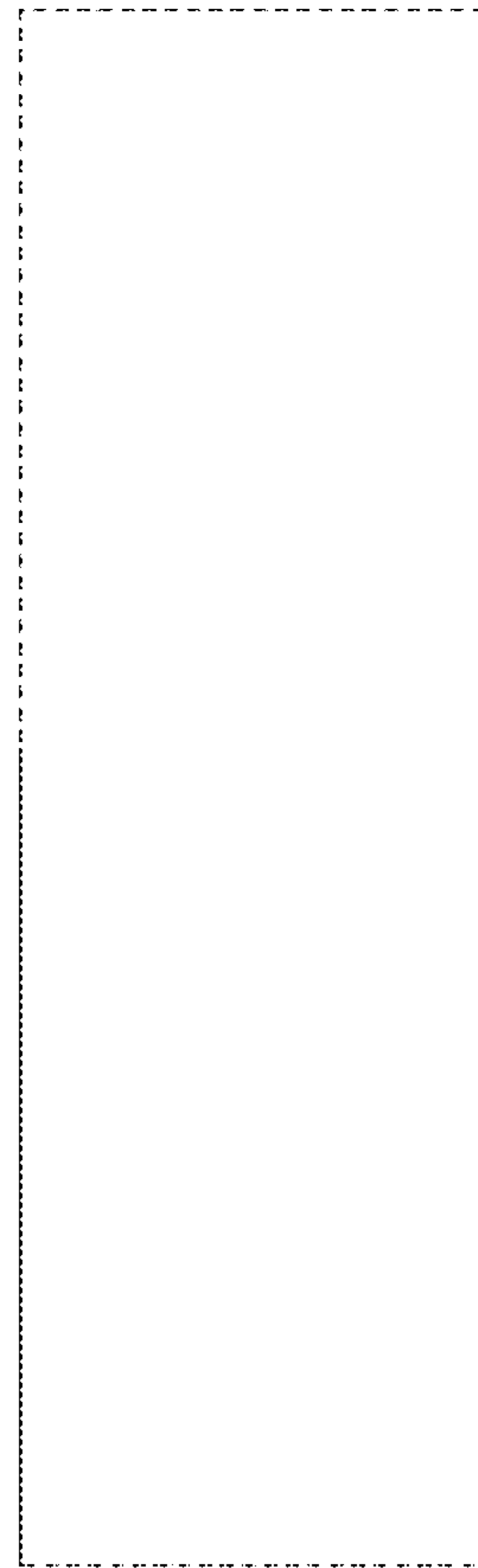

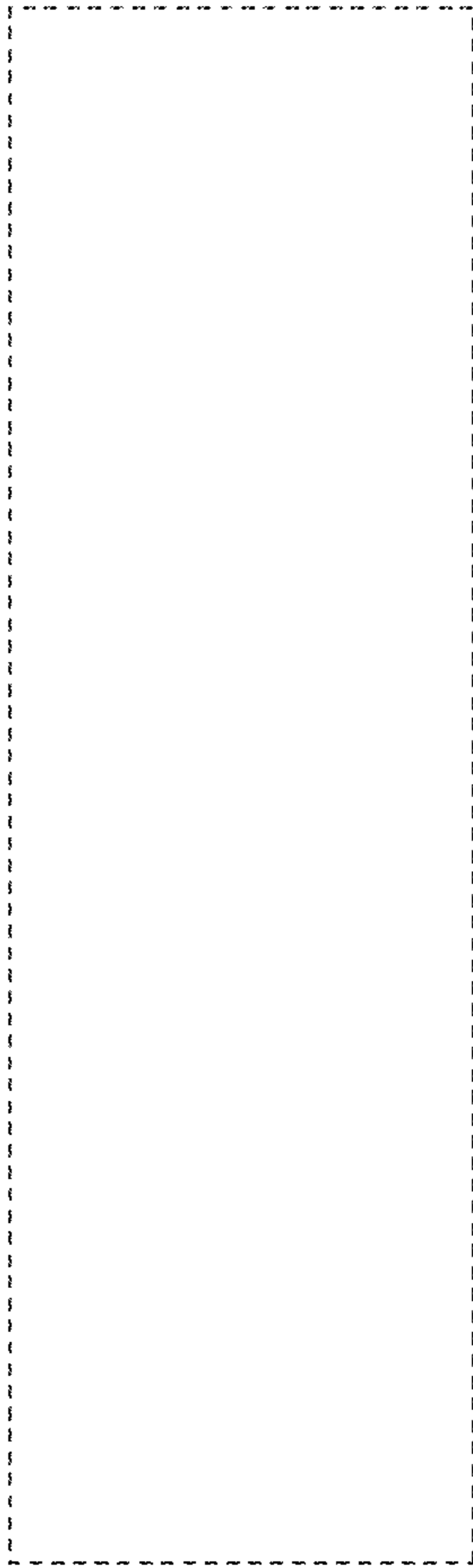

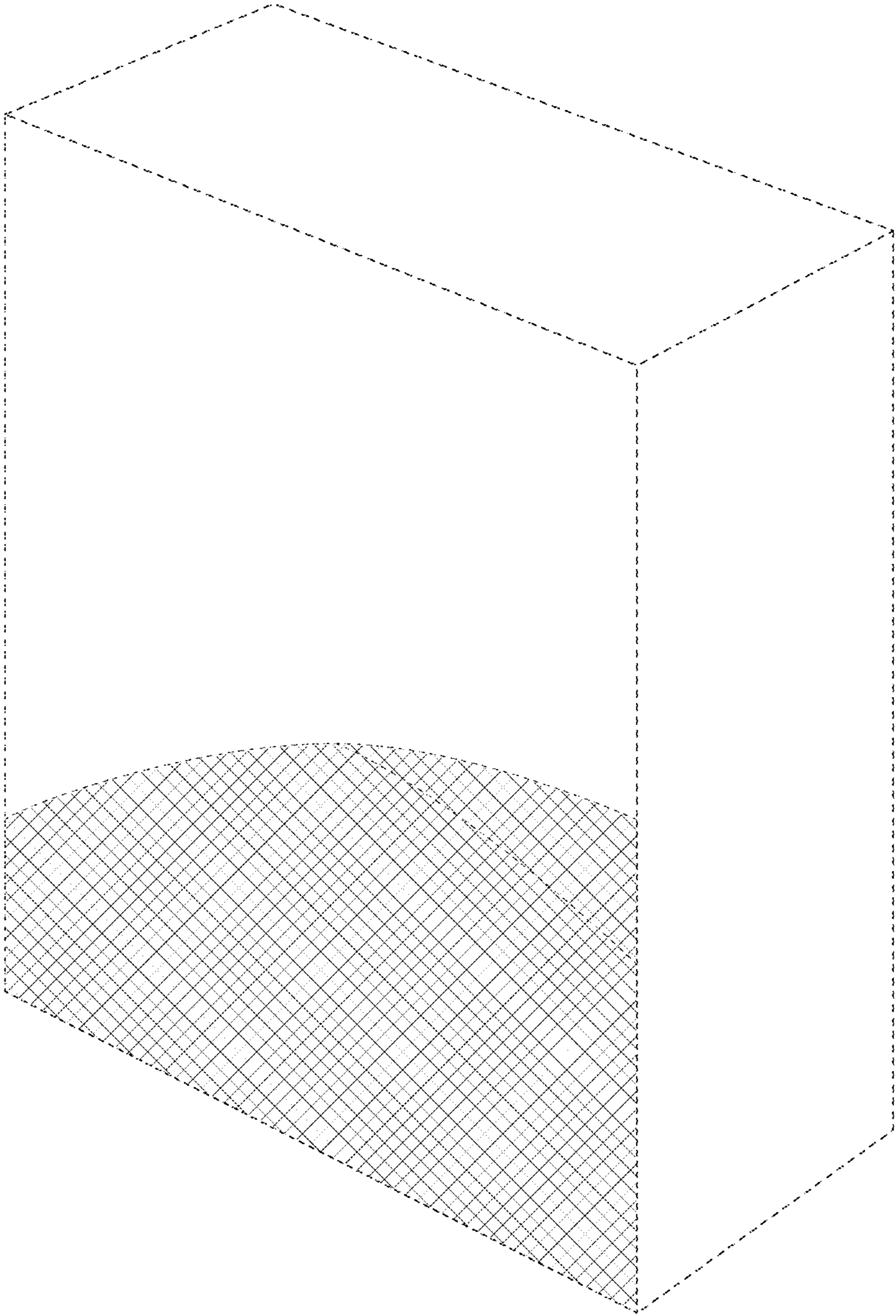

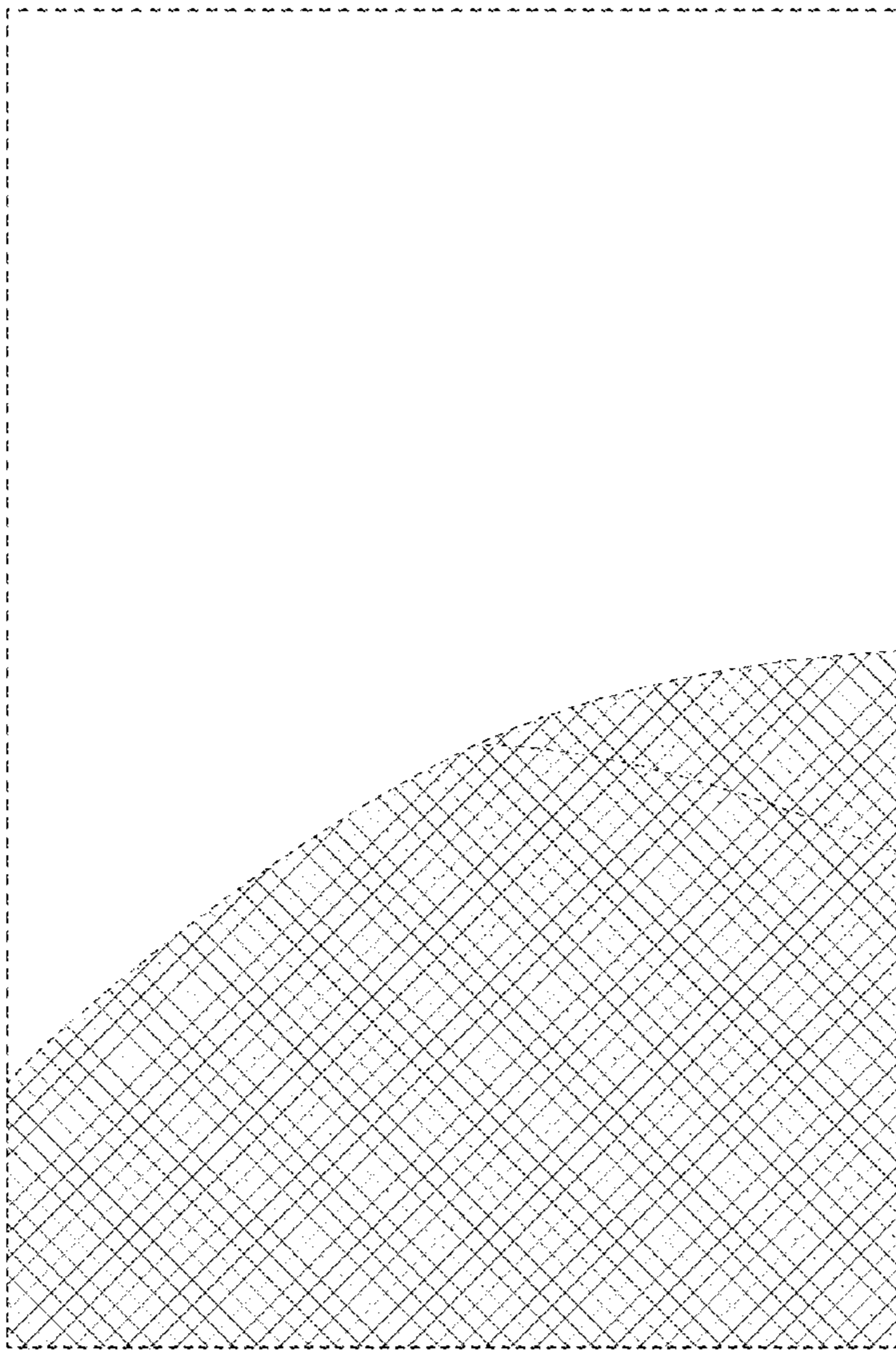

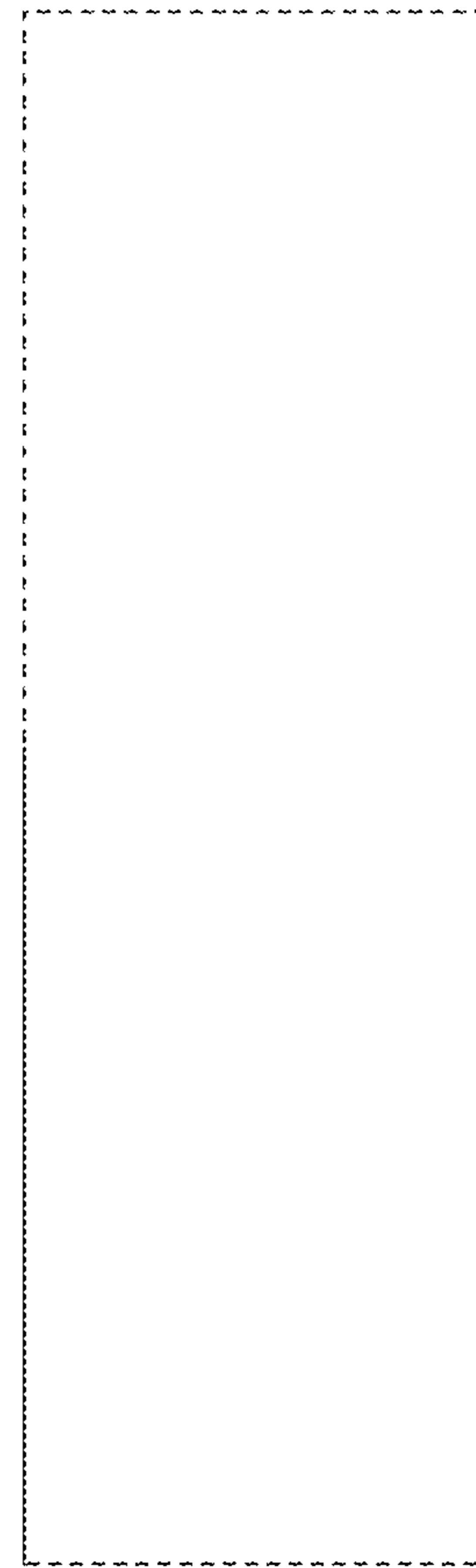

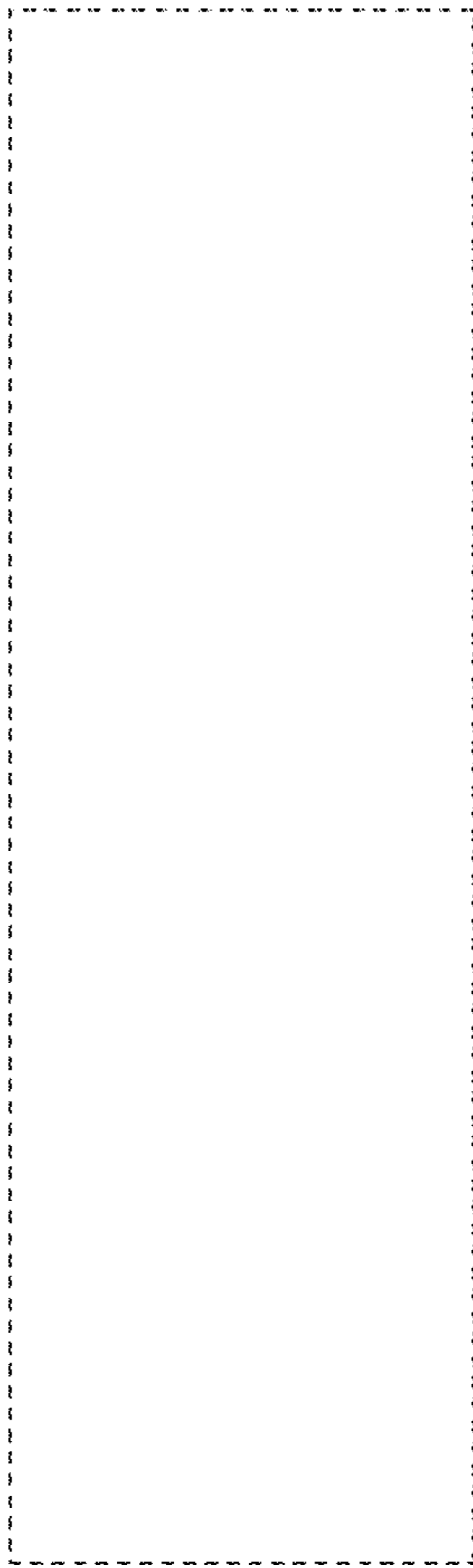
