**DESCRIPTION**

FIG. 1 is a top perspective view of a timer showing our new design;

FIG. 2 is a side view of the timer.

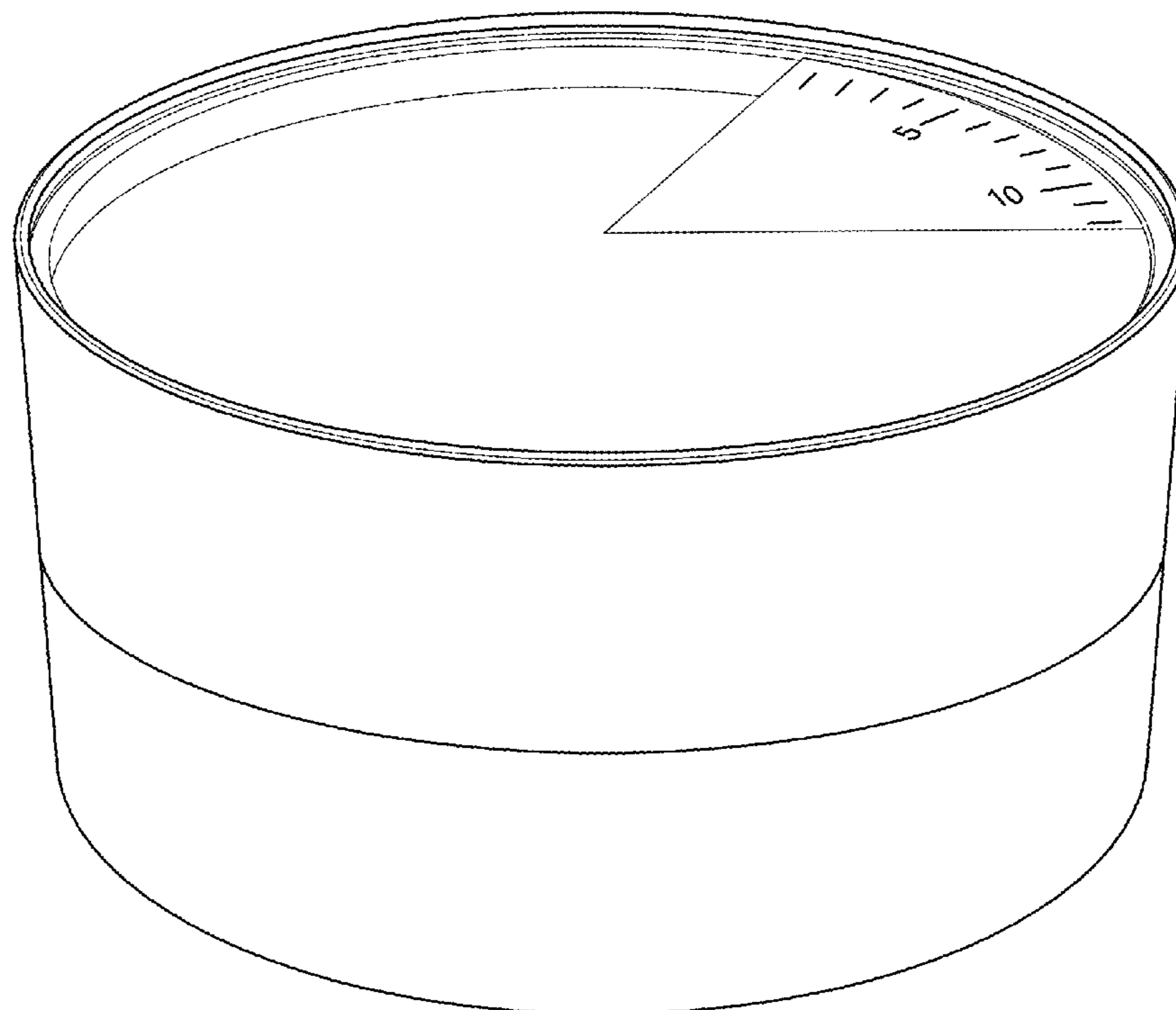
FIG. 3 is a top perspective view of the timer when fully closed.

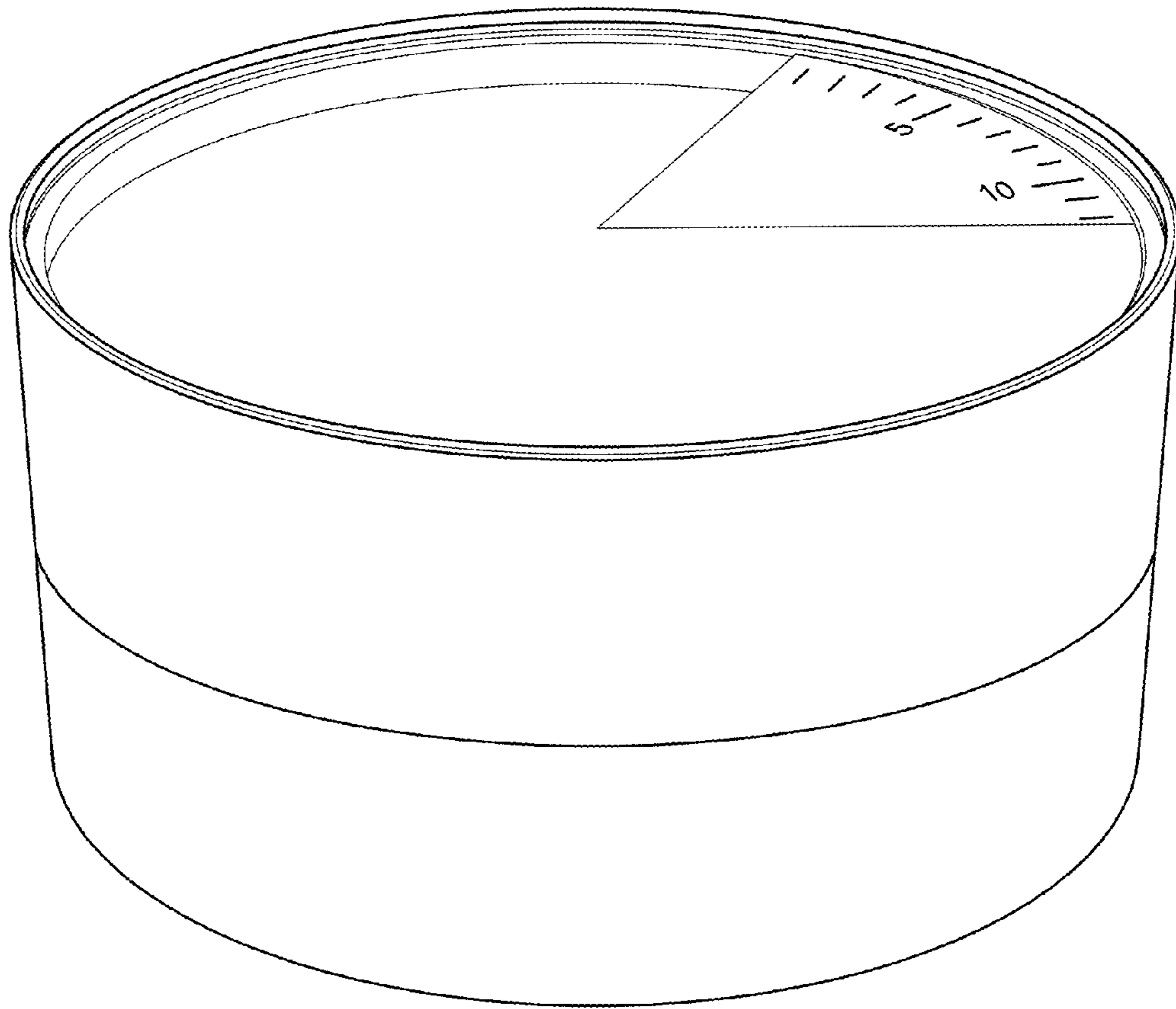

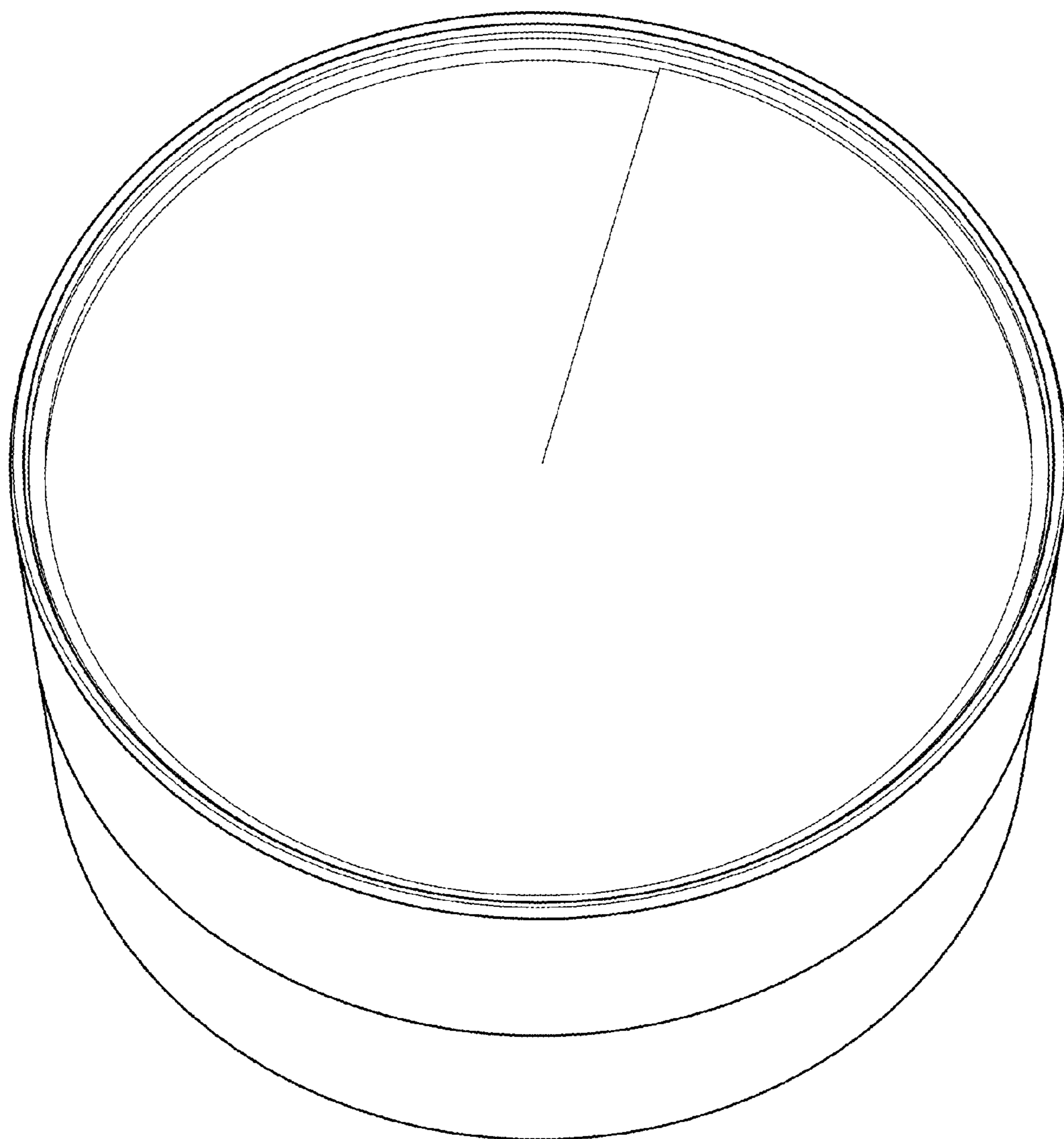

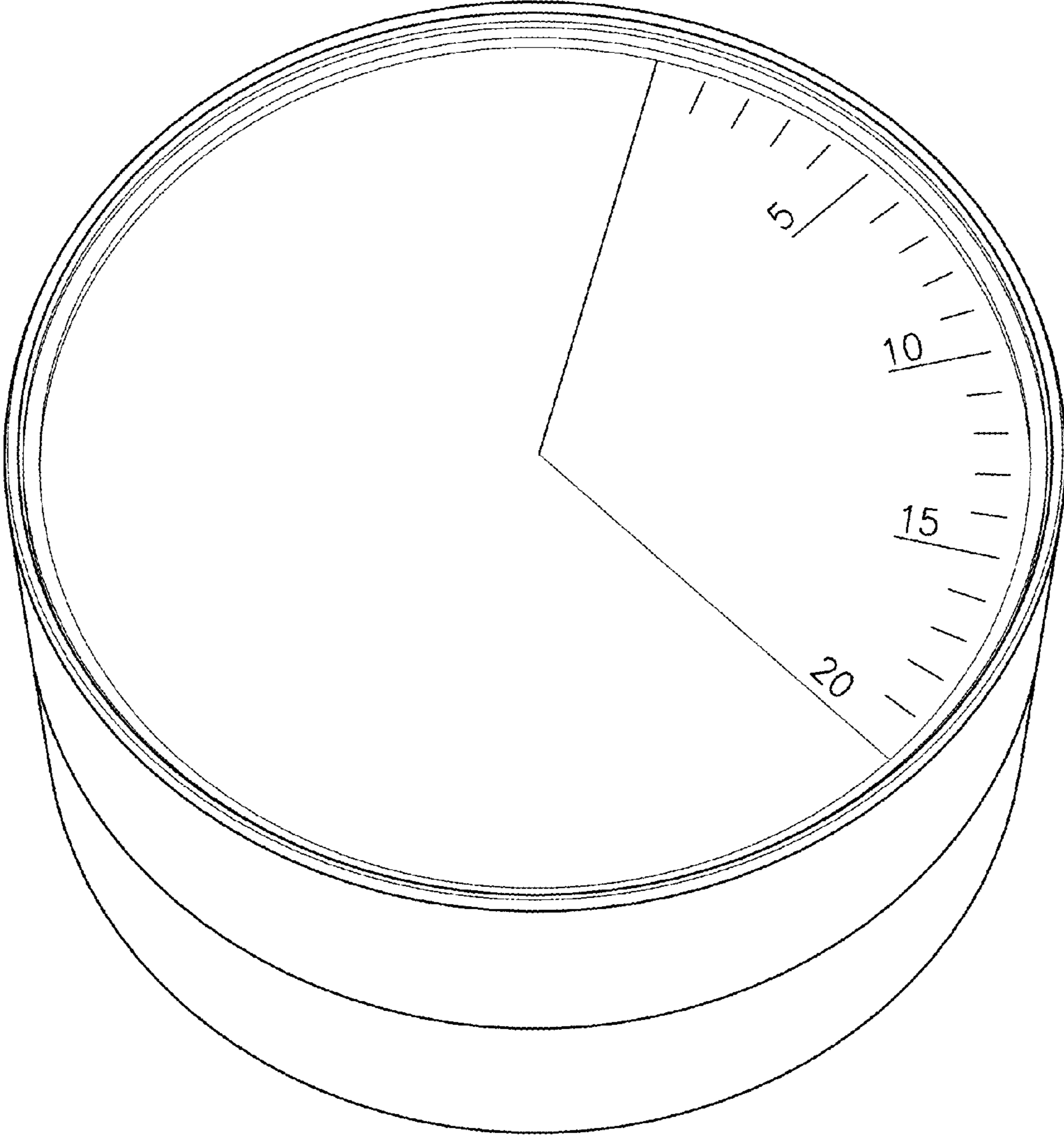

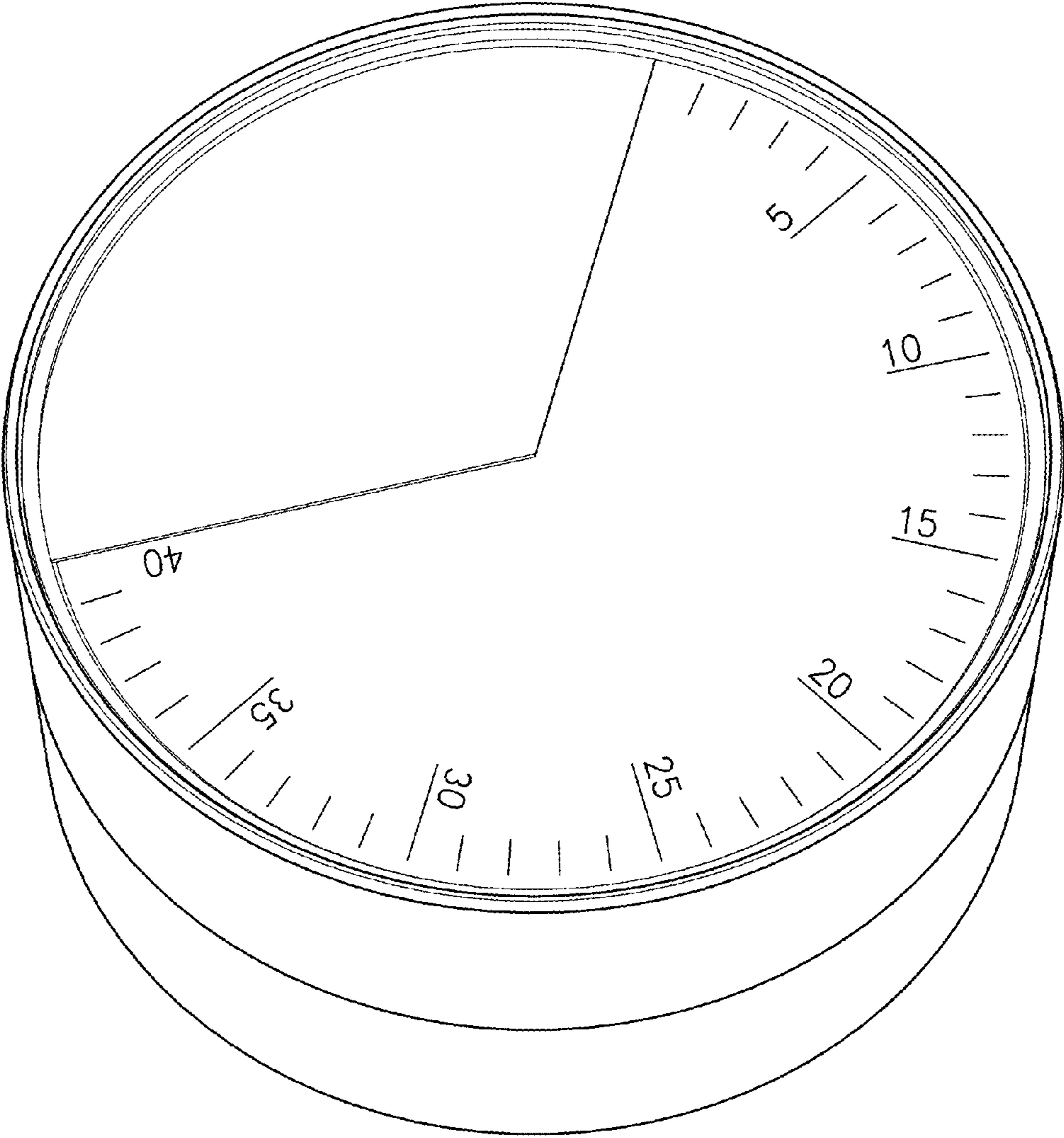

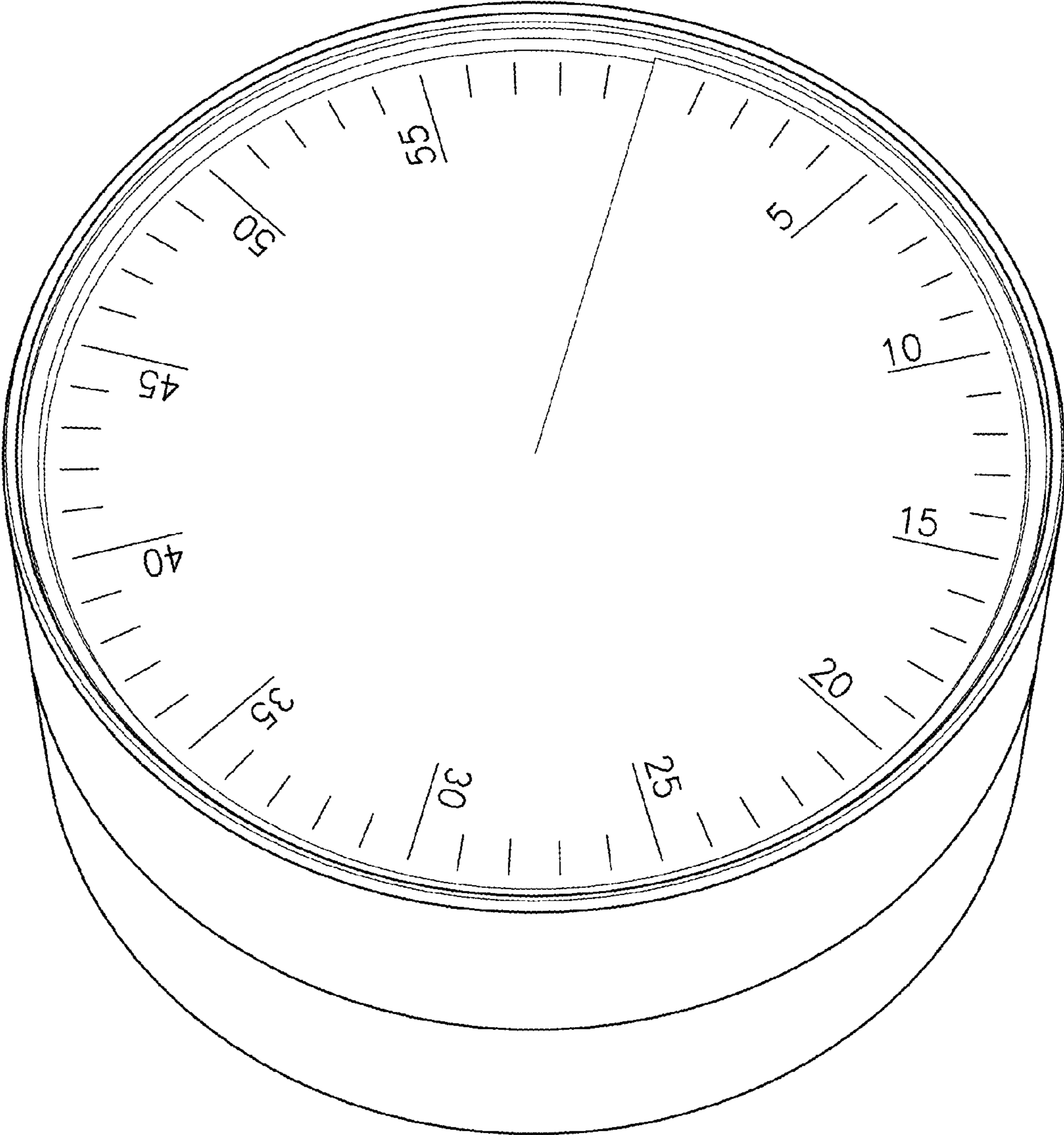
