(57) **CLAIM**

The ornamental design for a solitaire ring, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the solitaire ring showing the present design.

FIG. 2 is a front view thereof.

FIG. 3 is a rear view thereof.

FIG. 4 is a right view thereof.

FIG. 5 is a left view thereof.

FIG. 6 is a top view thereof.

FIG. 7 is a bottom view thereof.

FIG. 8 is an enlarged top perspective view of the portion of the solitaire ring identified by numeral 9 in FIG. 2; and,

FIG. 9 is an enlarged front view of the portion of the solitaire ring identified by numeral 9 in FIG. 2.

The broken lines shown in the drawings represent portions of the solitaire ring and form no part of the claimed design.

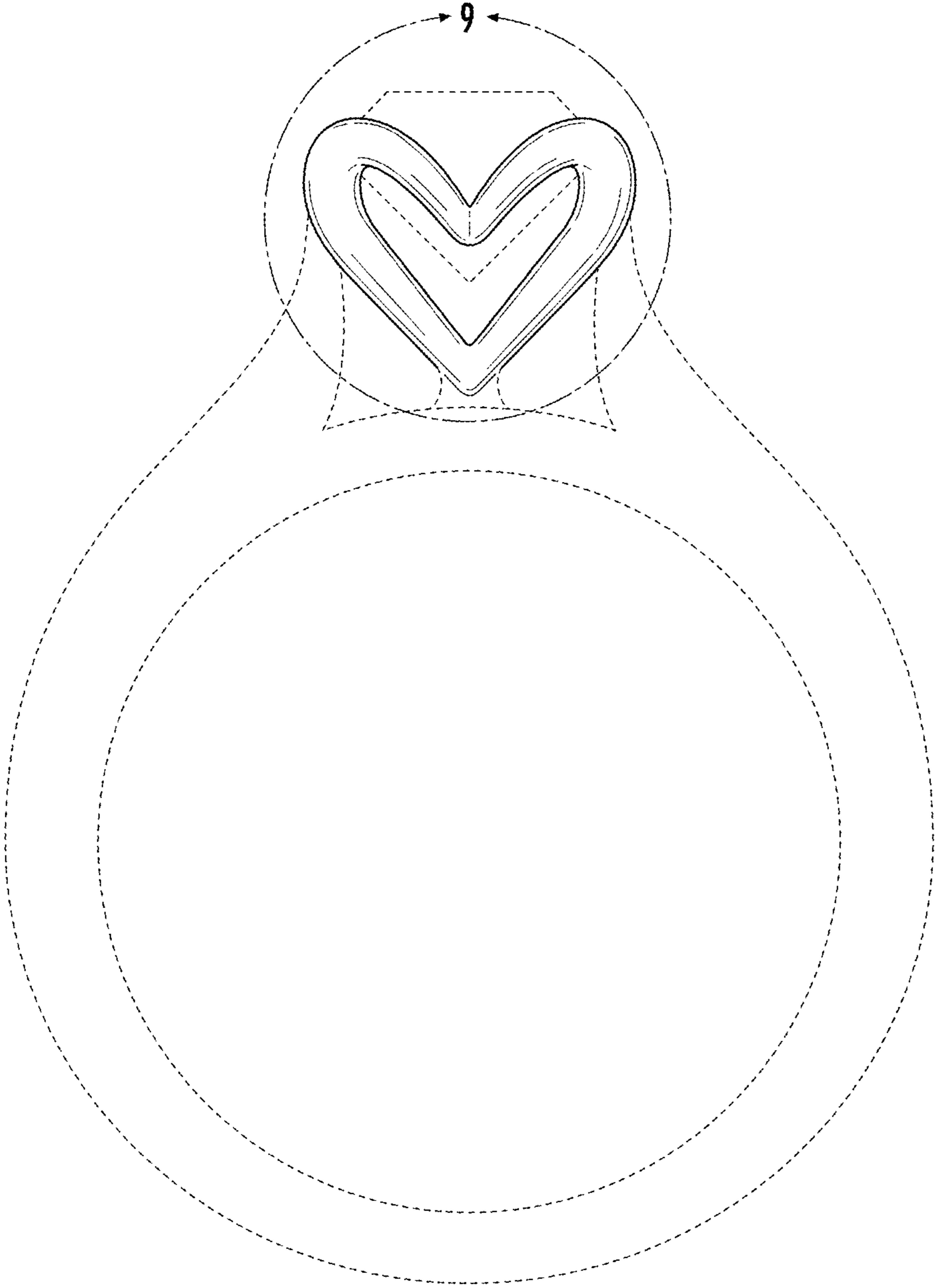

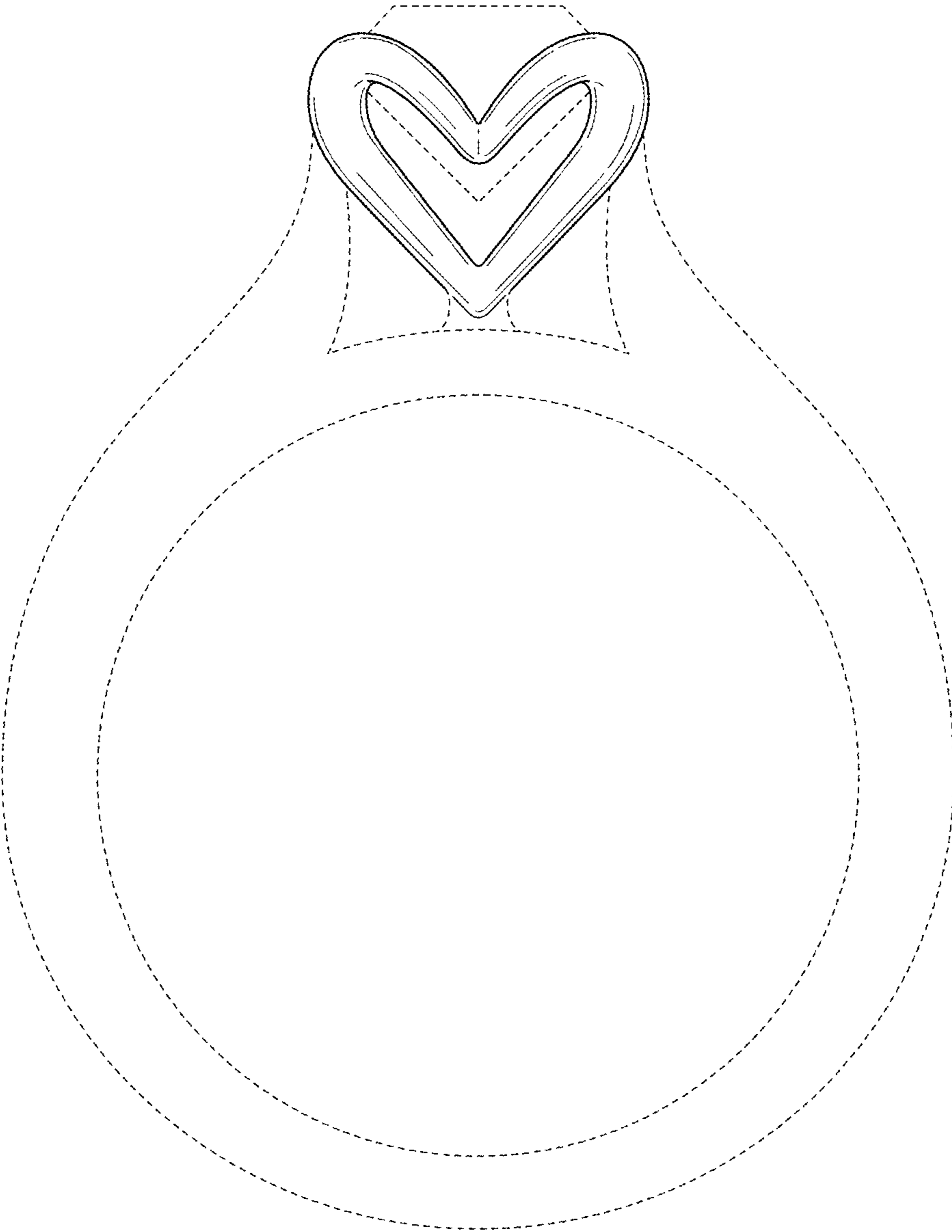

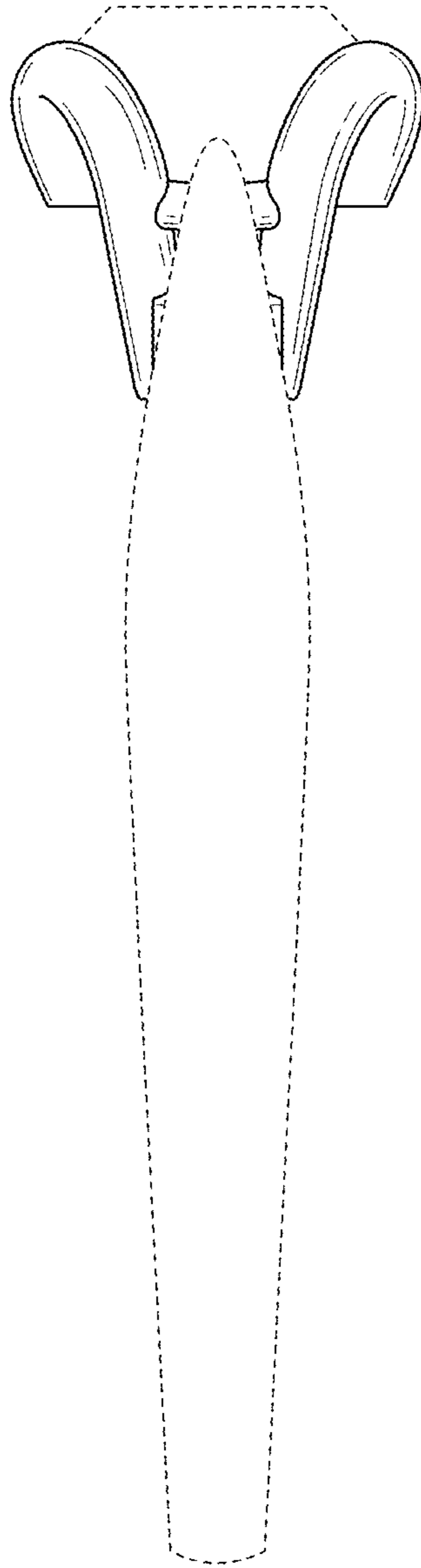

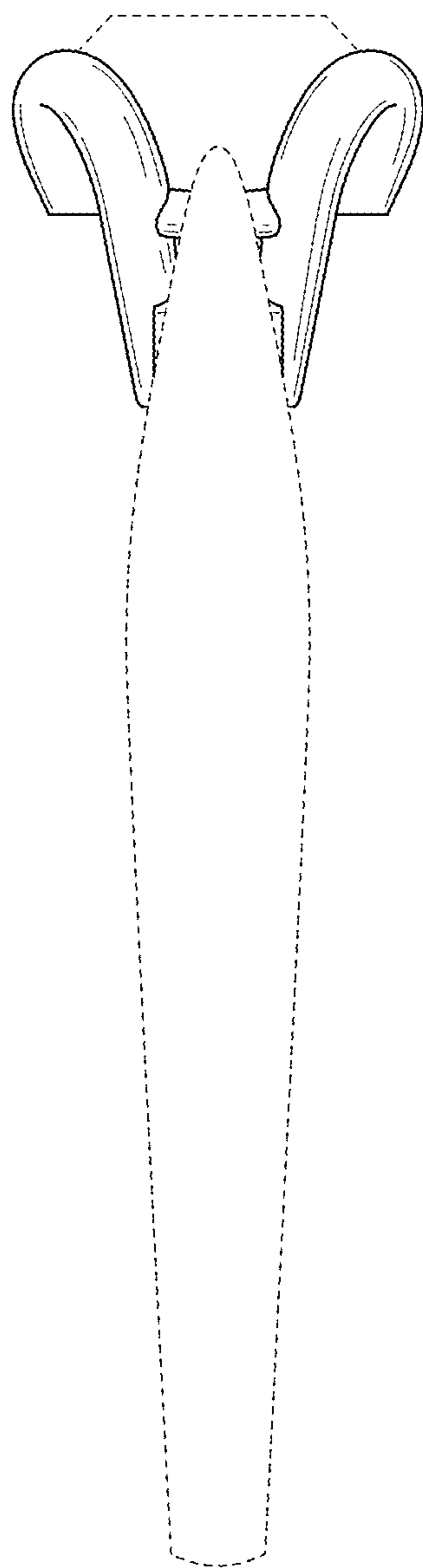

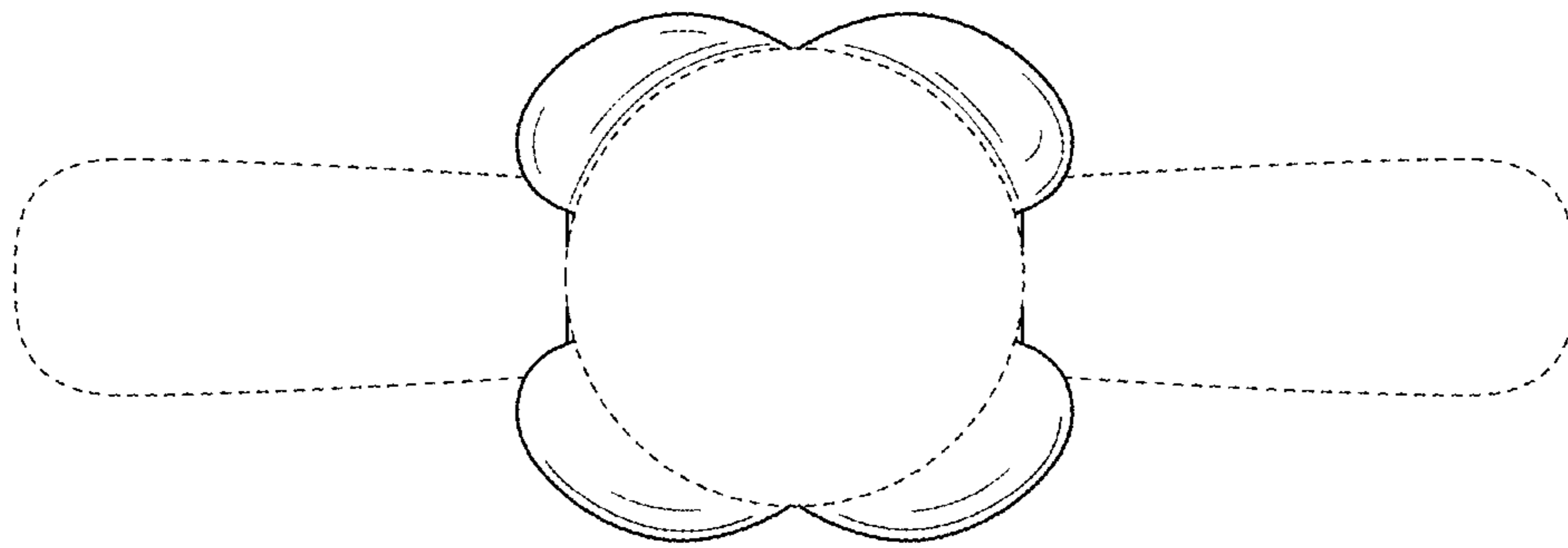

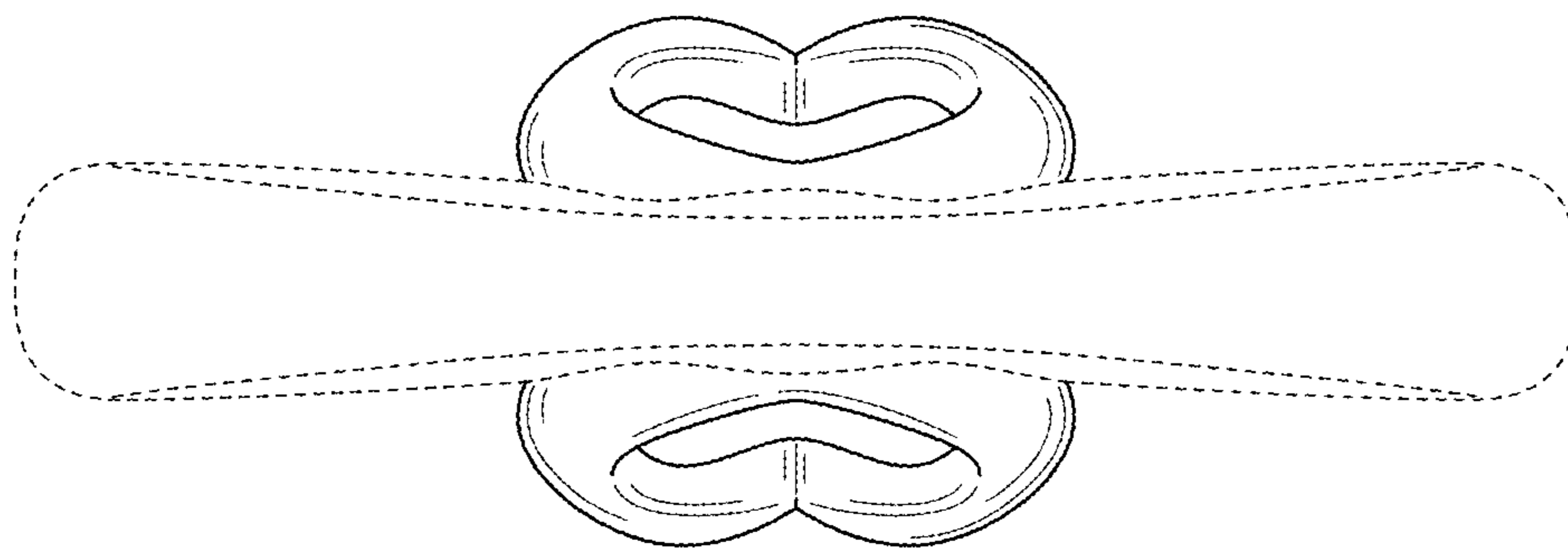

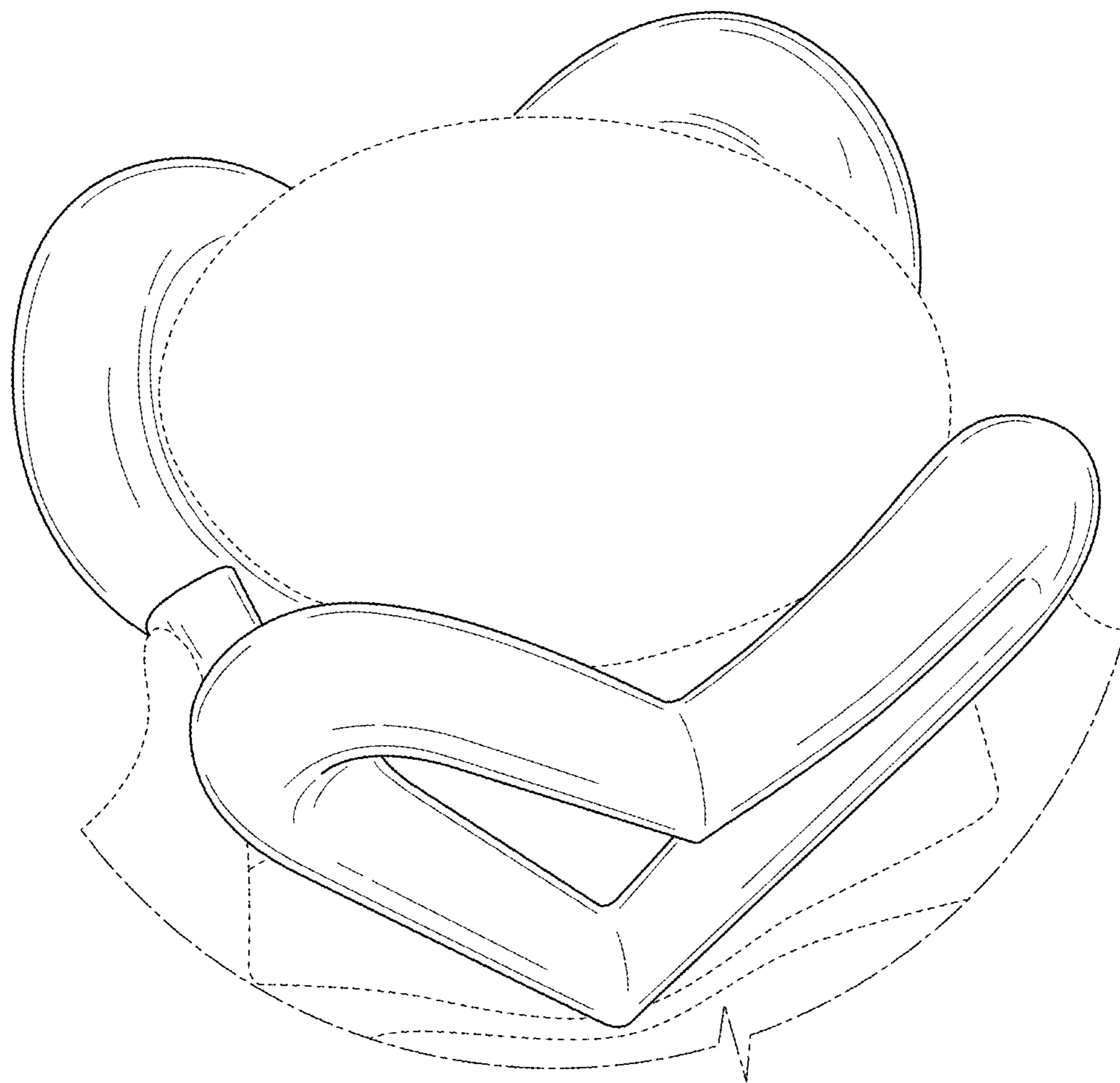

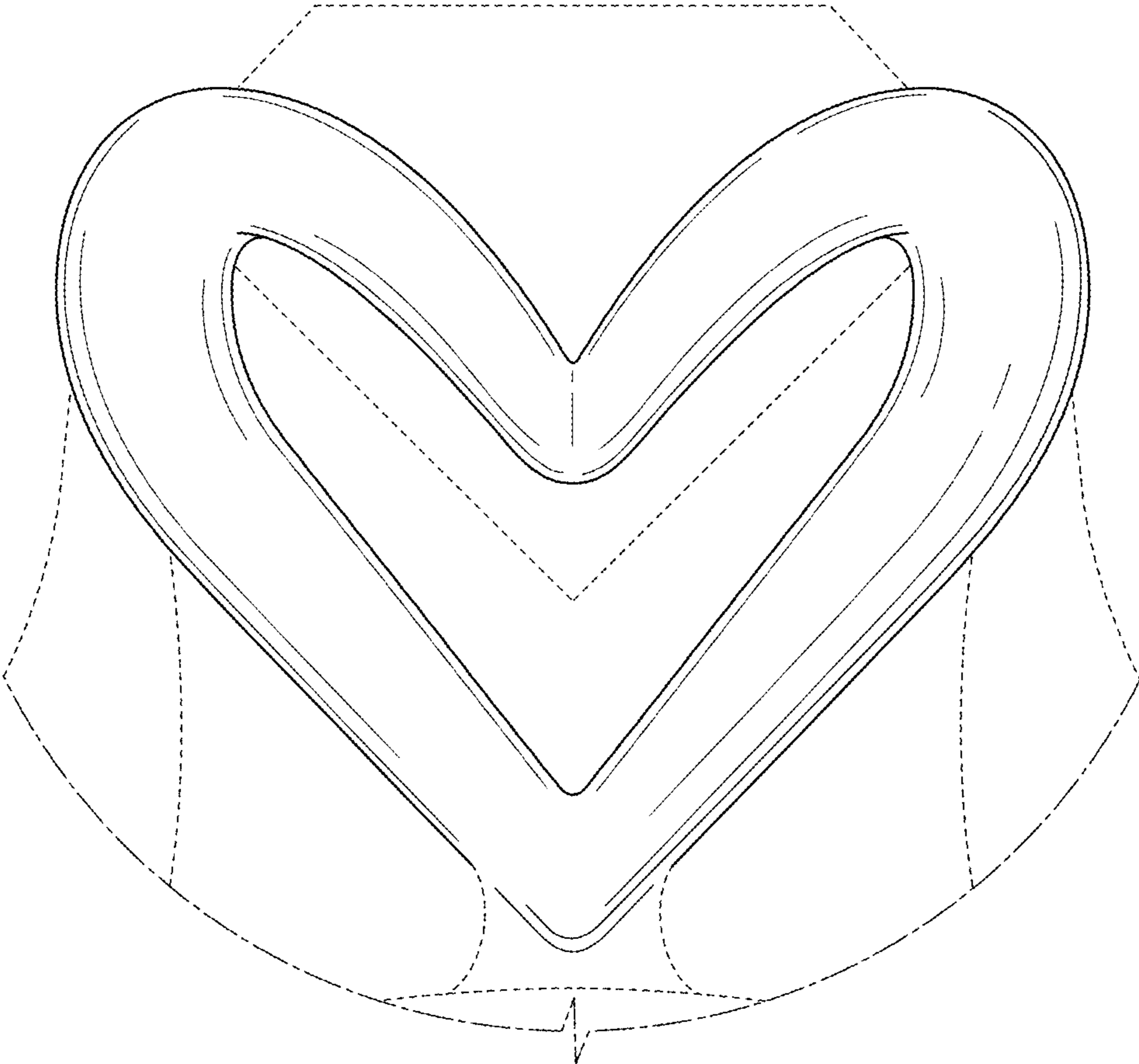
