(57) **CLAIM**

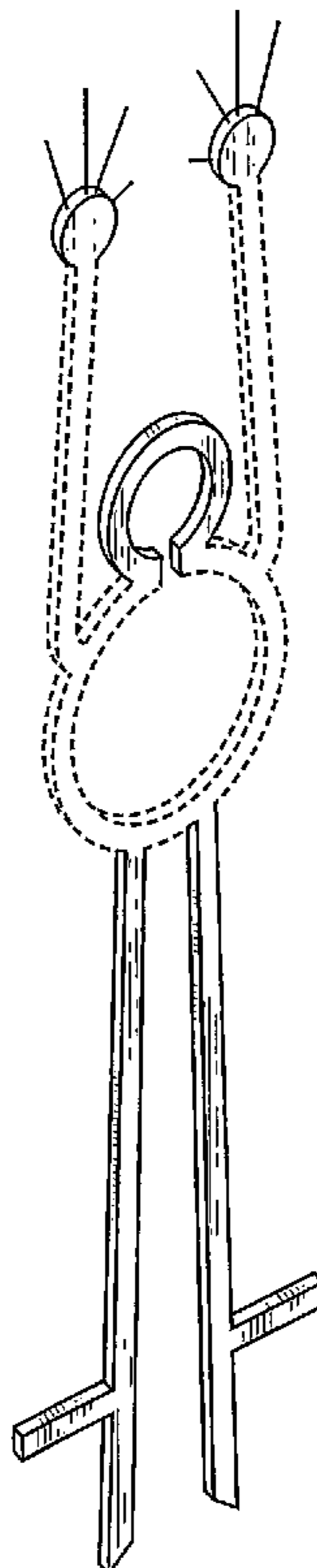
The ornamental design for a stick figure, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a stick figure of the present invention;  
FIG. 2 is a front view thereof;  
FIG. 3 is a right side view thereof;  
FIG. 4 is a top view thereof; and,  
FIG. 5 is a bottom view thereof.

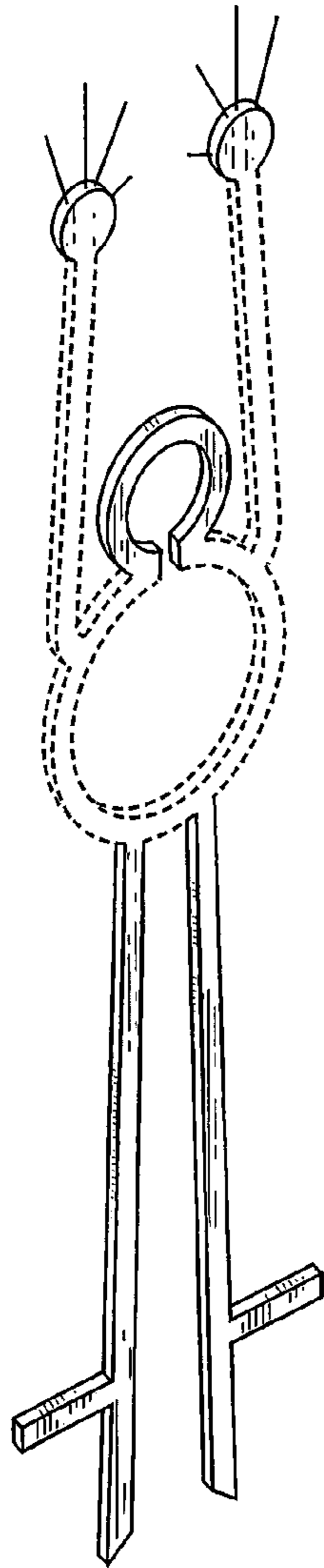

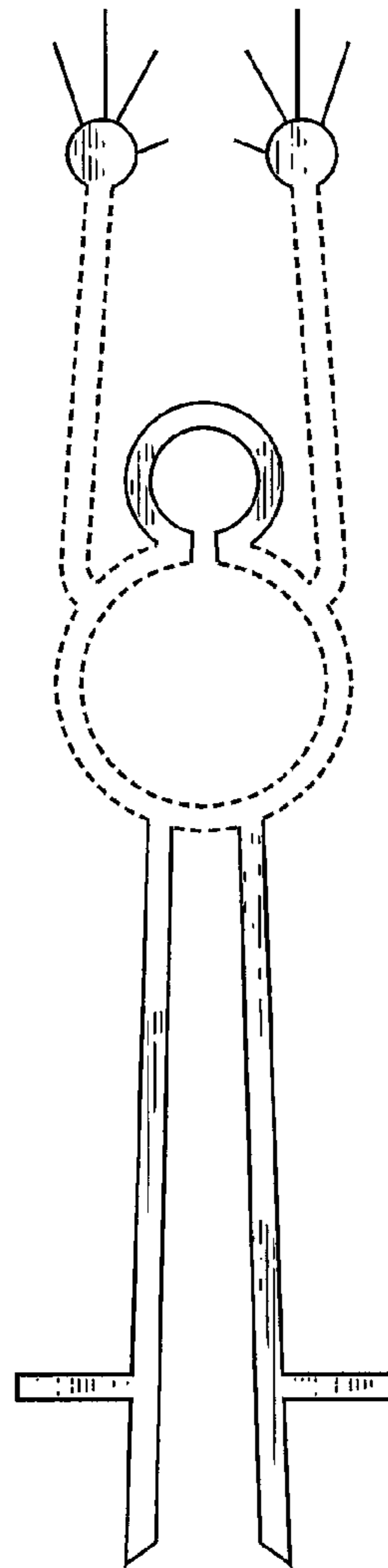
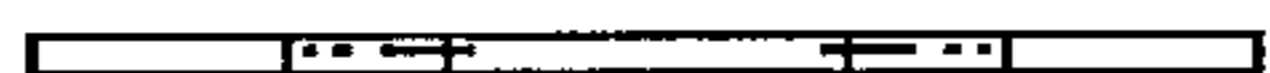
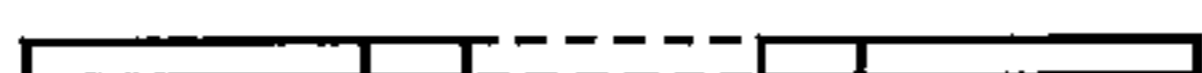
