(57) **CLAIM**

The ornamental design for a motorcycle inner primary cover,  
as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of the motorcycle inner  
primary cover of the present invention.

FIG. 2 is a first side view thereof.

FIG. 3 is a second side view thereof, the second side view  
being opposite the first side view.

FIG. 4 is a top view thereof.

FIG. 5 is a bottom view thereof.

FIG. 6 is a first end view thereof.

FIG. 7 is a second end view thereof, the second end view  
being opposite the first end view.

FIG. 8 is a perspective view of a motorcycle cylinder base  
cover for use in combination with the motorcycle inner pri-  
mary cover of FIG. 1.

FIG. 9 is a front side view thereof.

FIG. 10 is a rear side view thereof.

FIG. 11 is a top view thereof.

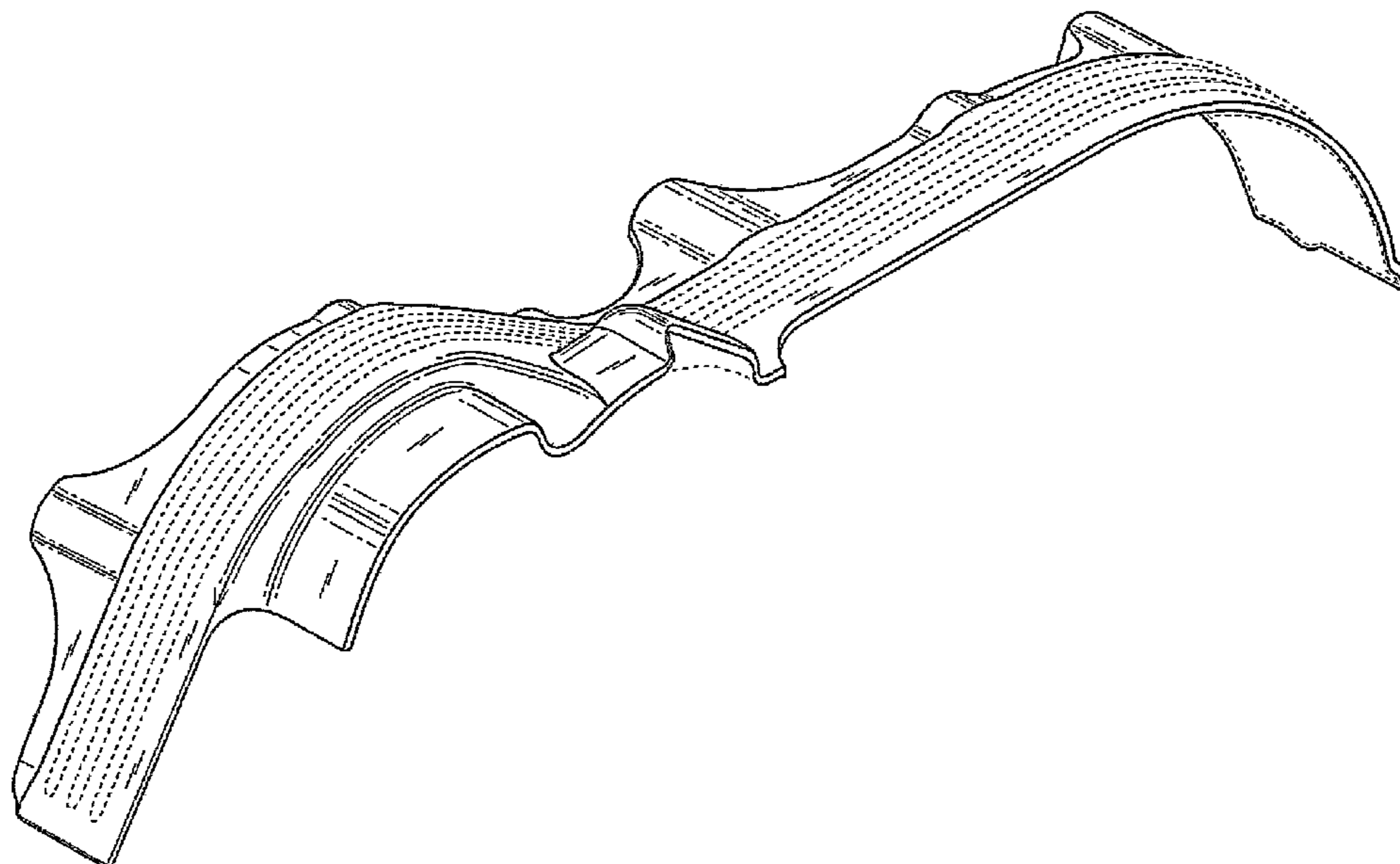
FIG. 12 is a bottom view thereof.

FIG. 13 is a first end view thereof; and,

FIG. 14 is a second end view thereof, the second end view  
being opposite the first end view.

The top surface portions and the bottom surface of the motor-

broken lines form no part of the claimed design.

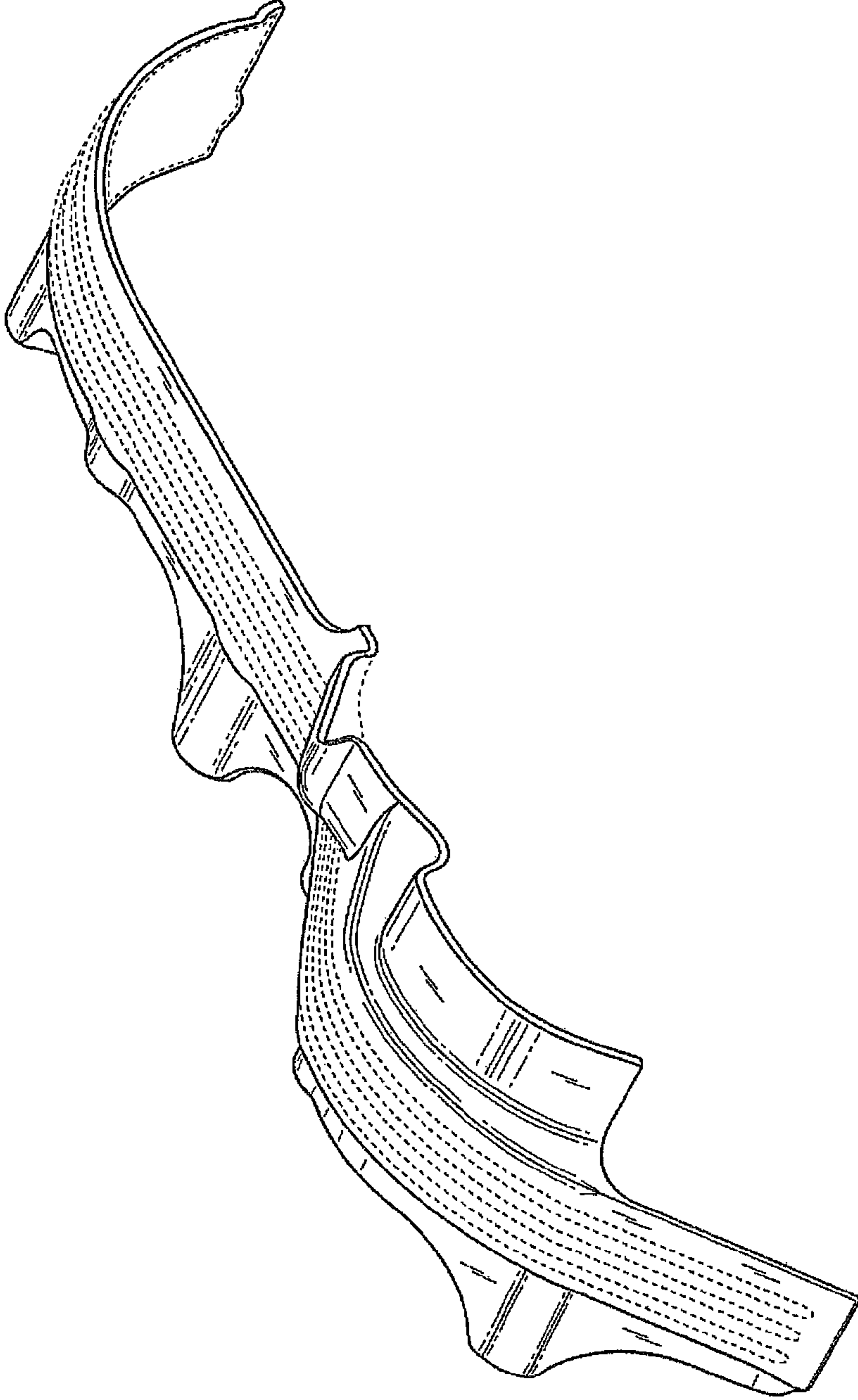

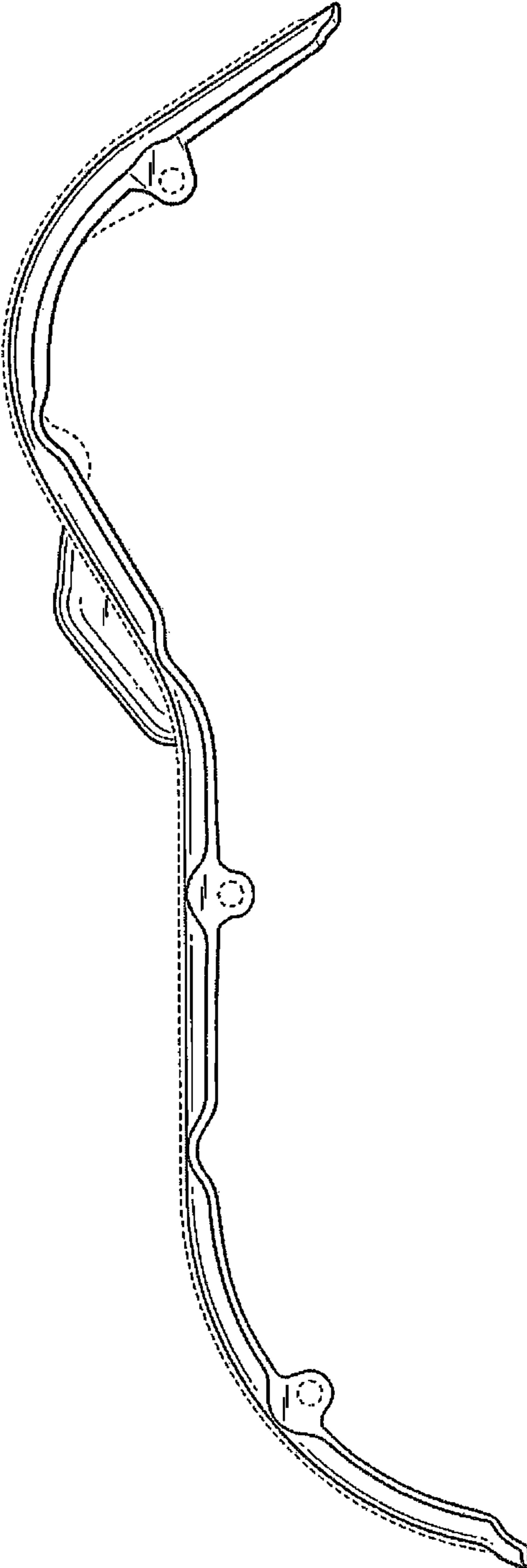

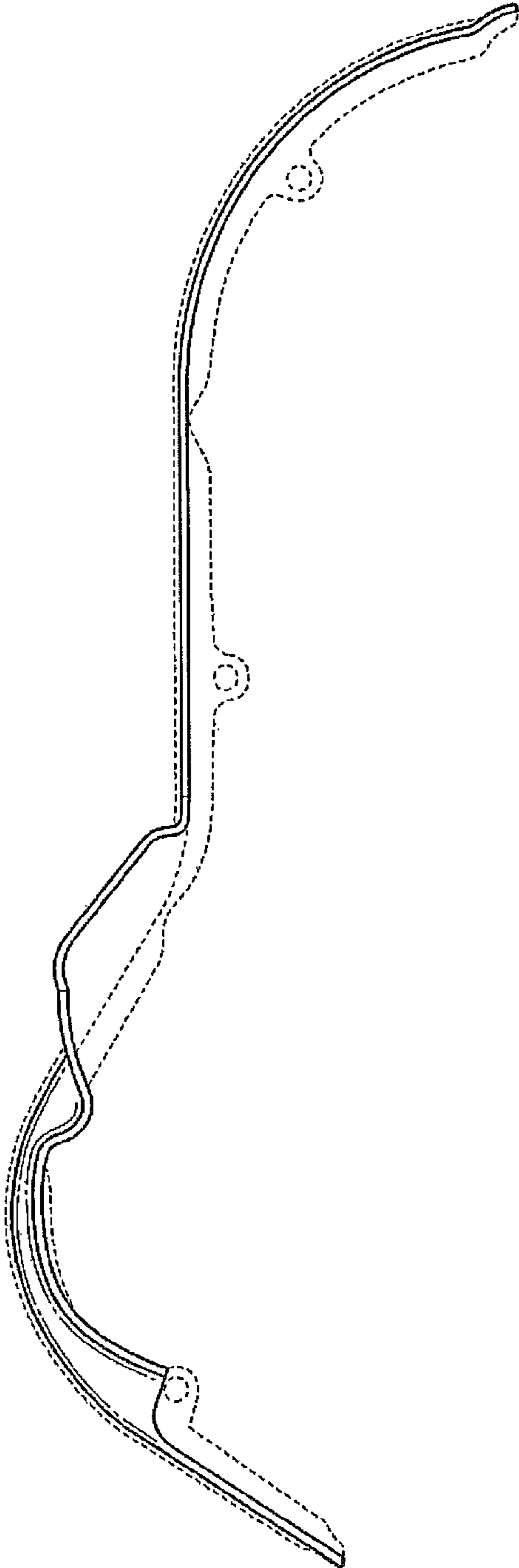

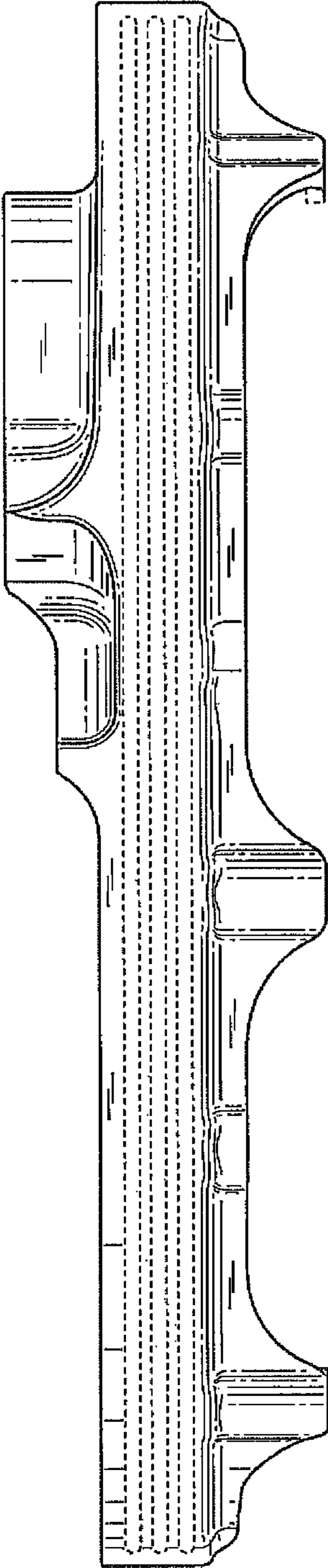

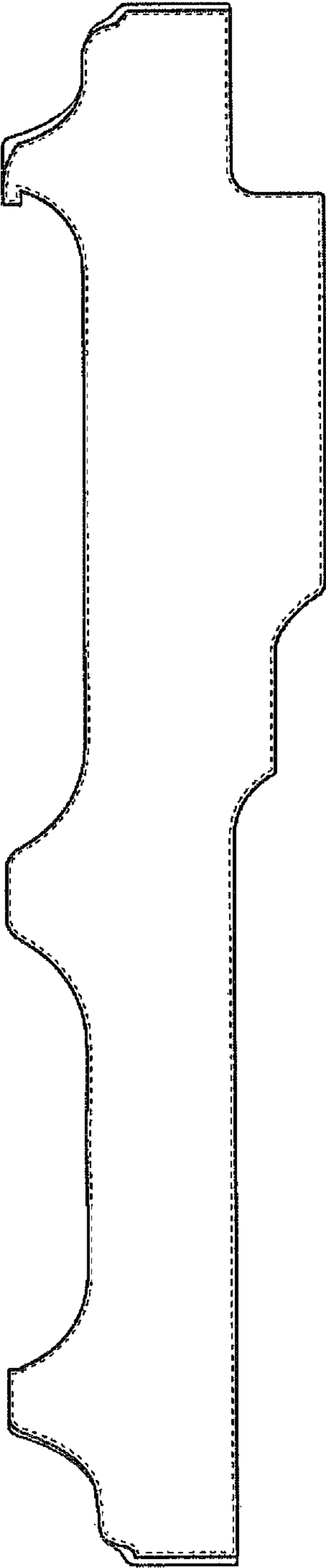

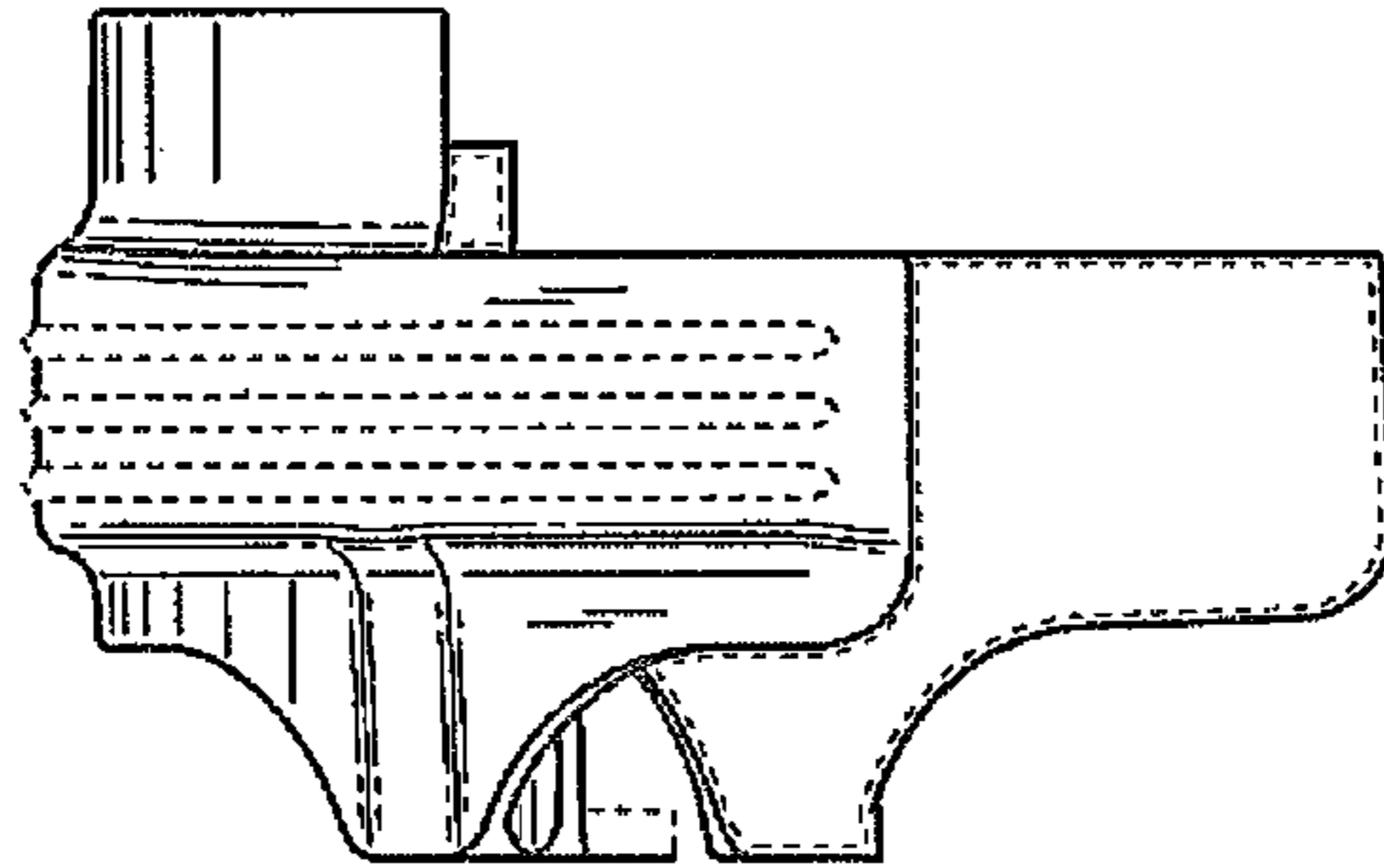

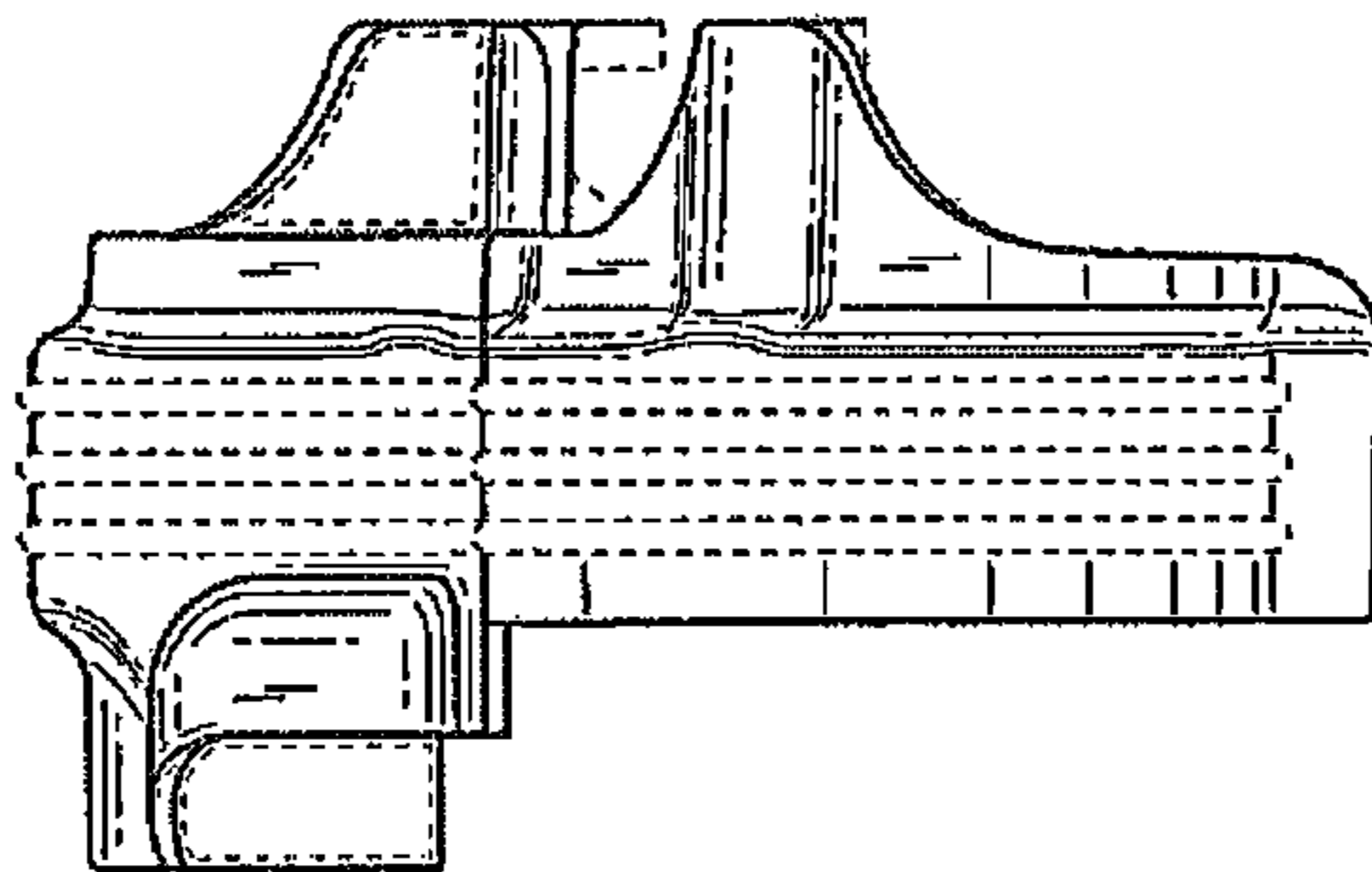

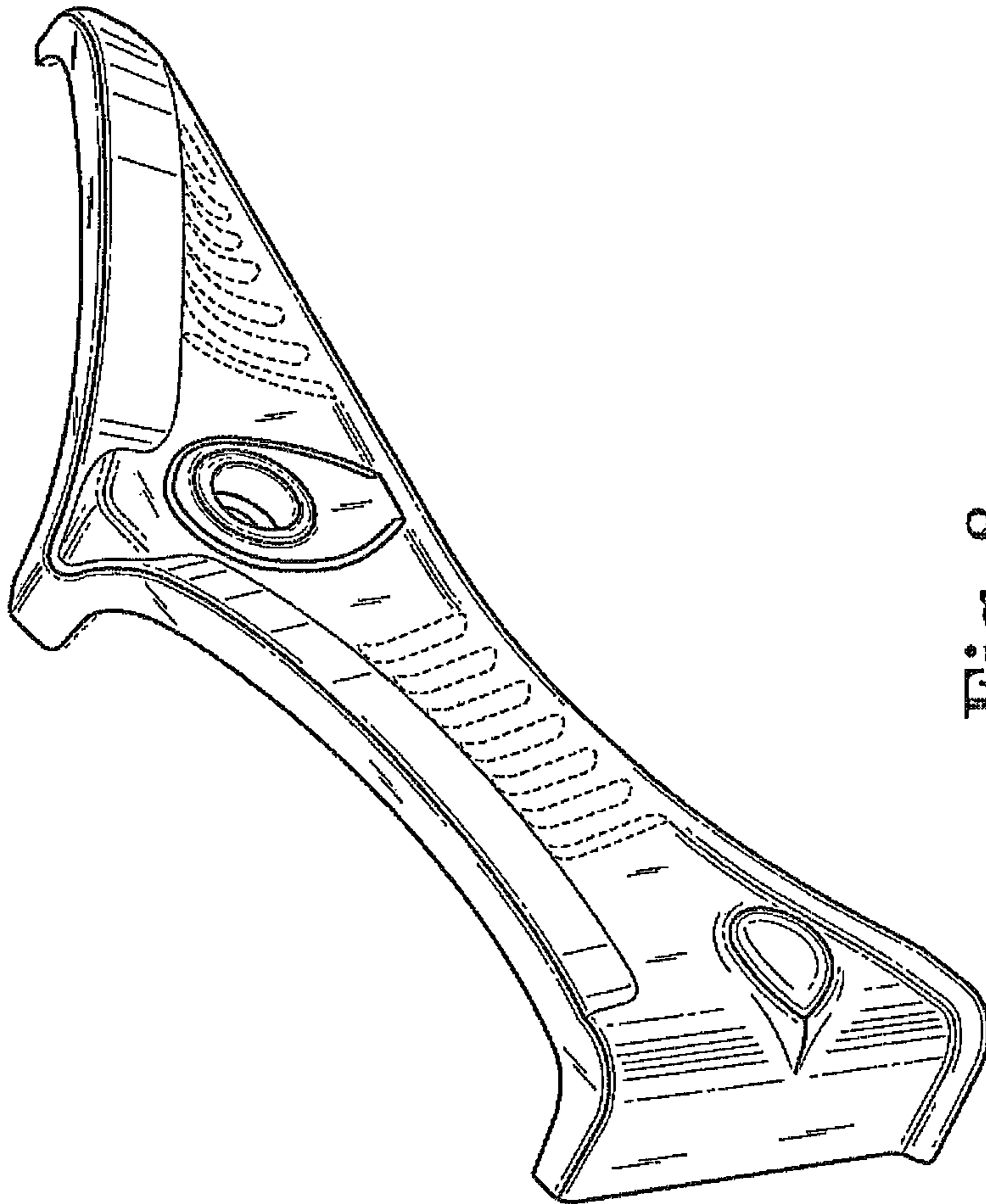

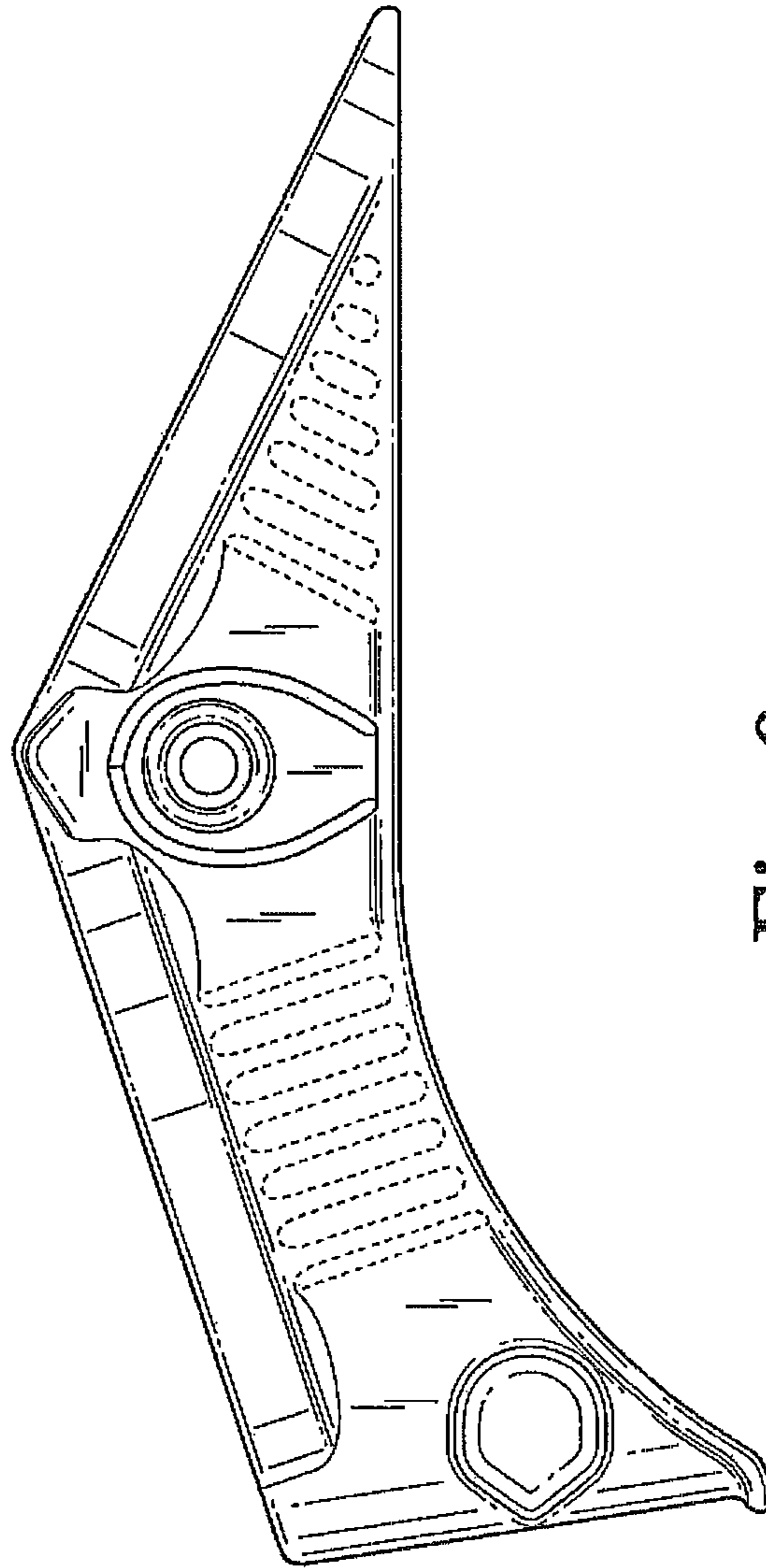

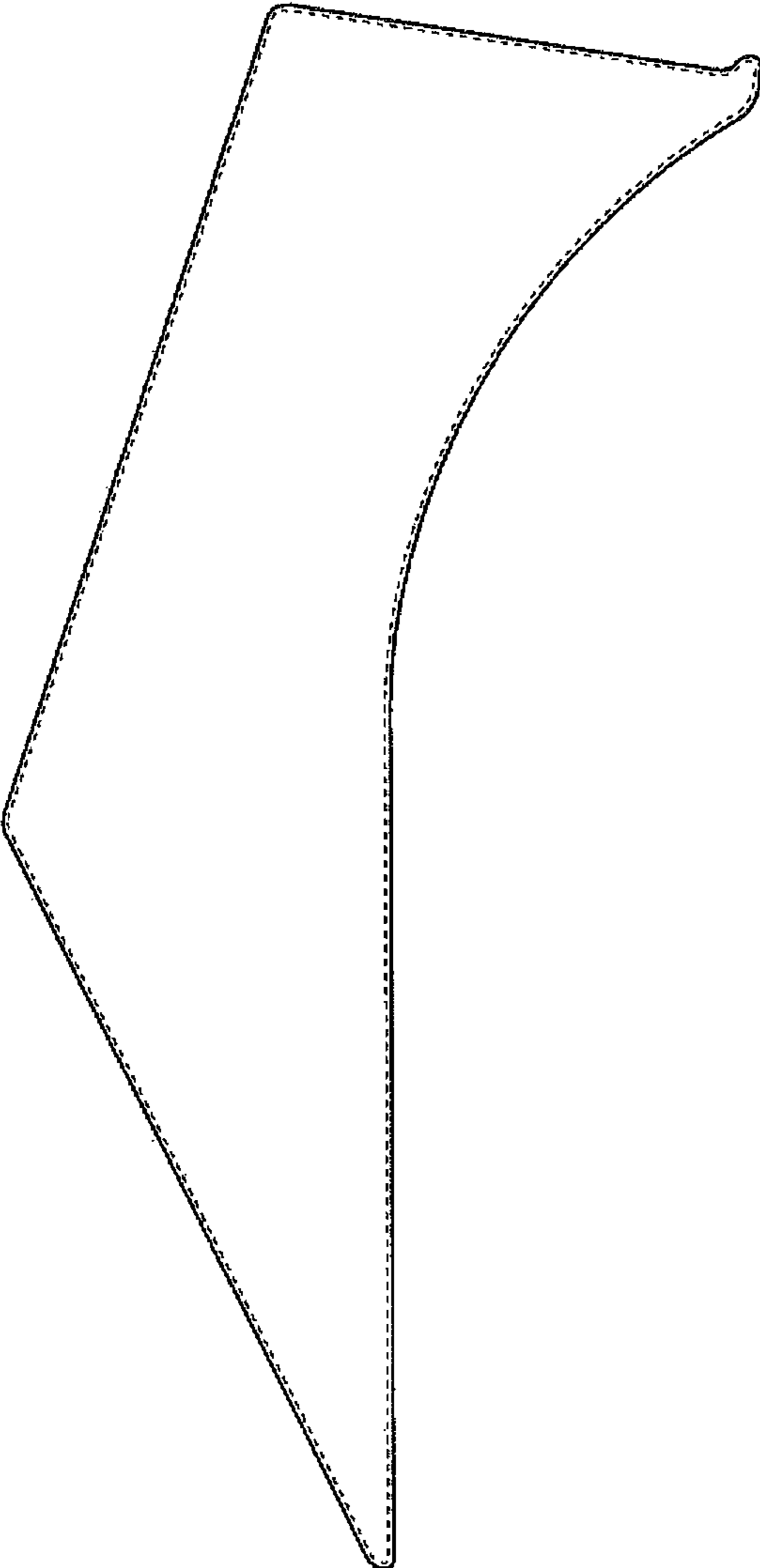

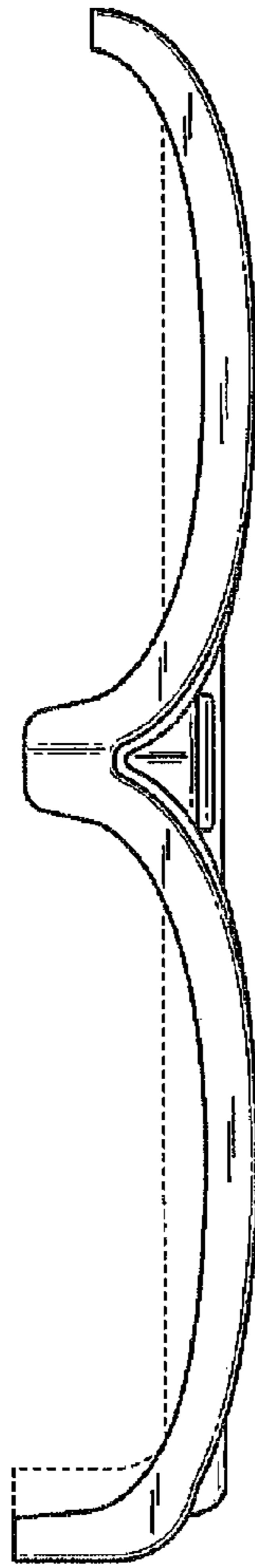

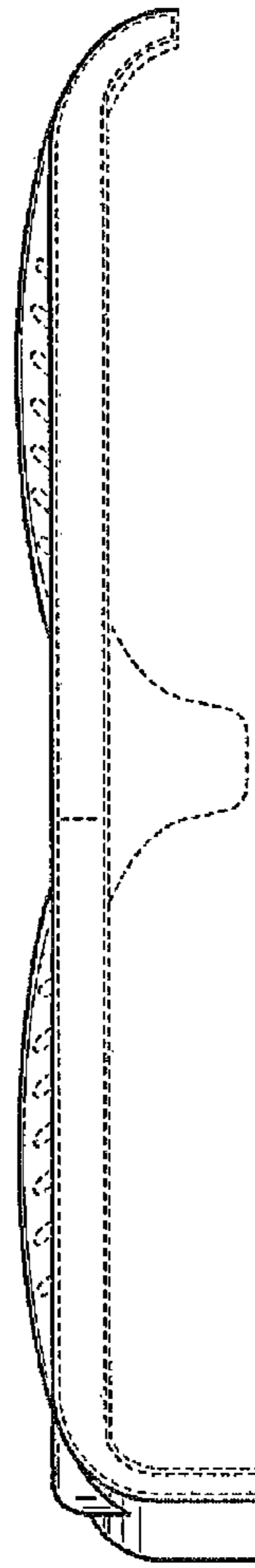

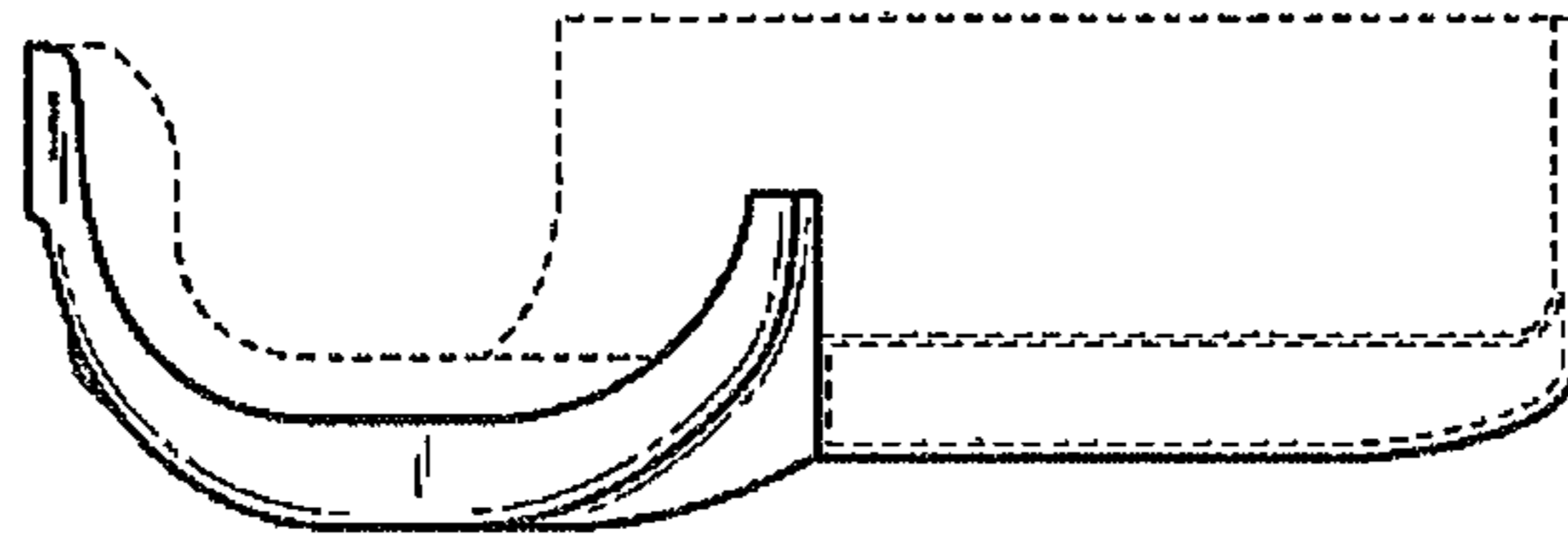

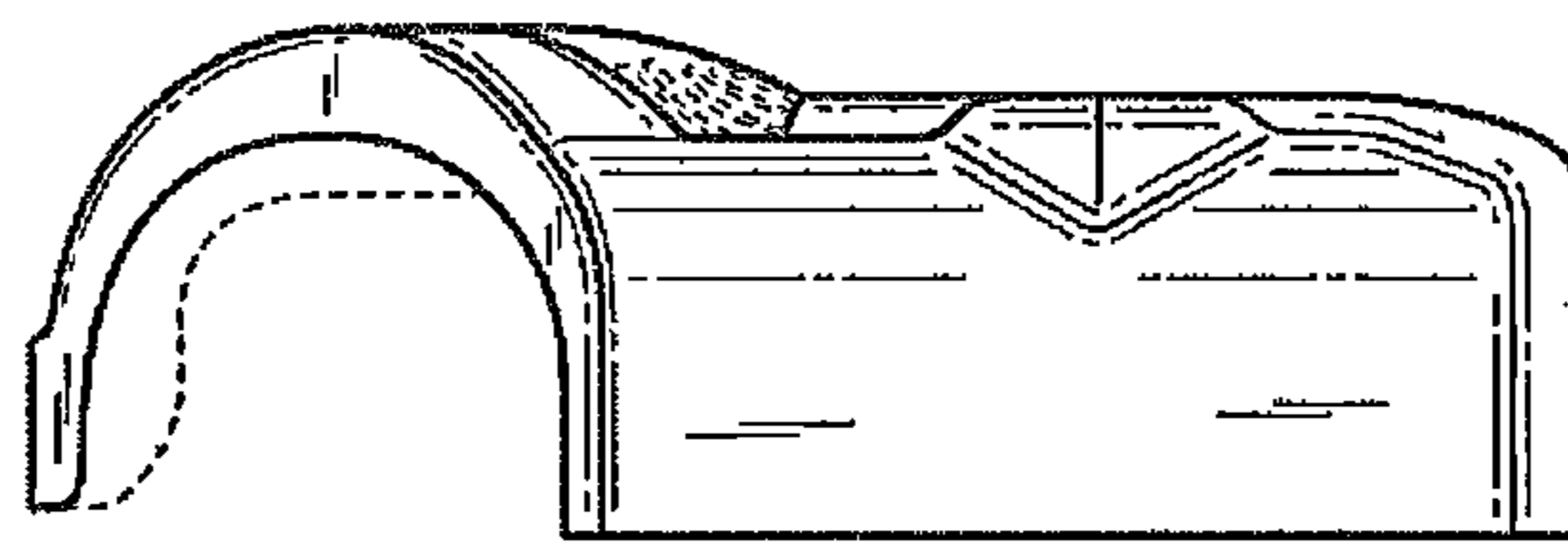
