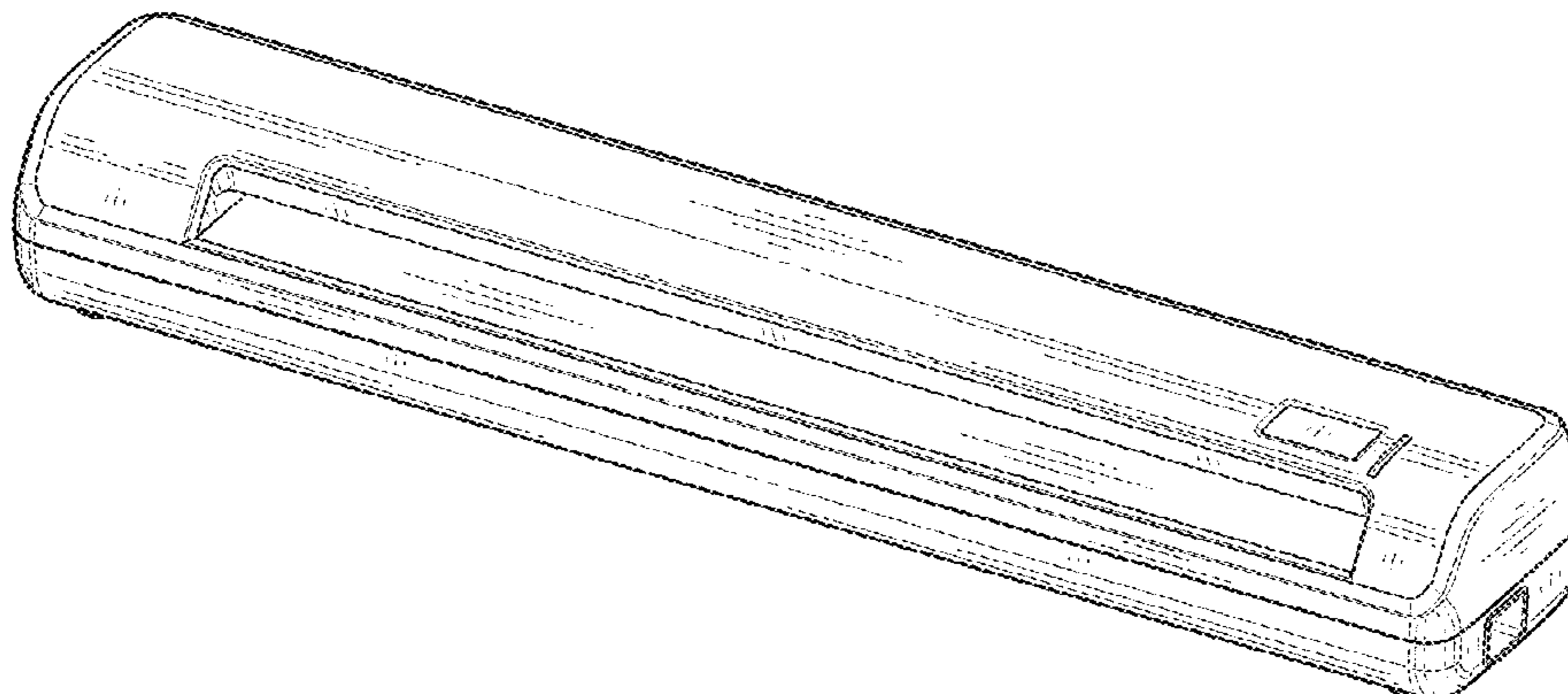
(57) **CLAIM**

The ornamental design for a scanner, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a scanner, as viewed from the top, front and right side, embodying our new design;  
FIG. 2 is a perspective view thereof, as viewed from the top, rear and left side;  
FIG. 3 is a front view thereof;  
FIG. 4 is a rear view thereof;  
FIG. 5 is a left side view thereof;  
FIG. 6 is a right side view thereof;  
FIG. 7 is a top view thereof; and,  
FIG. 8 is a bottom view thereof.  
The broken lines and portions contained within broken line shown within the square opening on the side of the scanner in FIGS. 1 and 6 are not claimed.

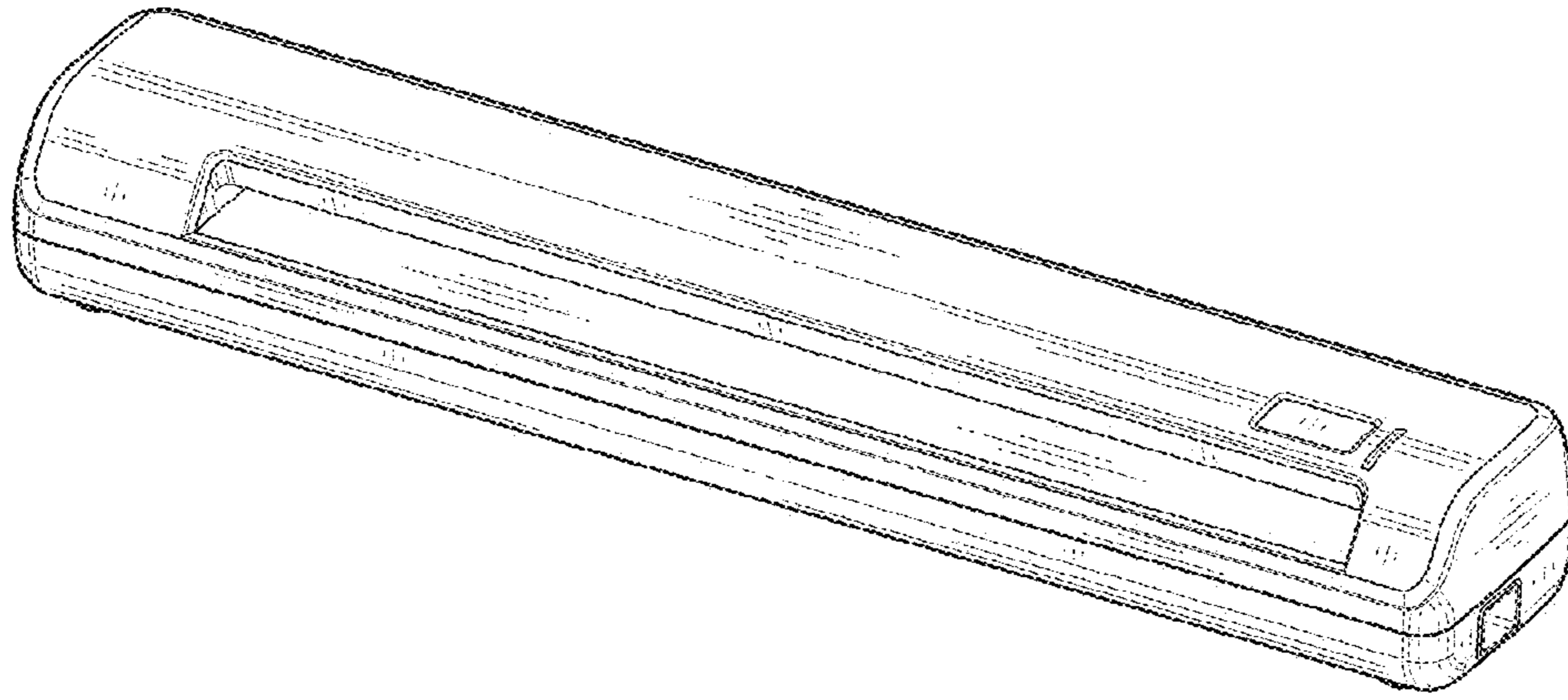

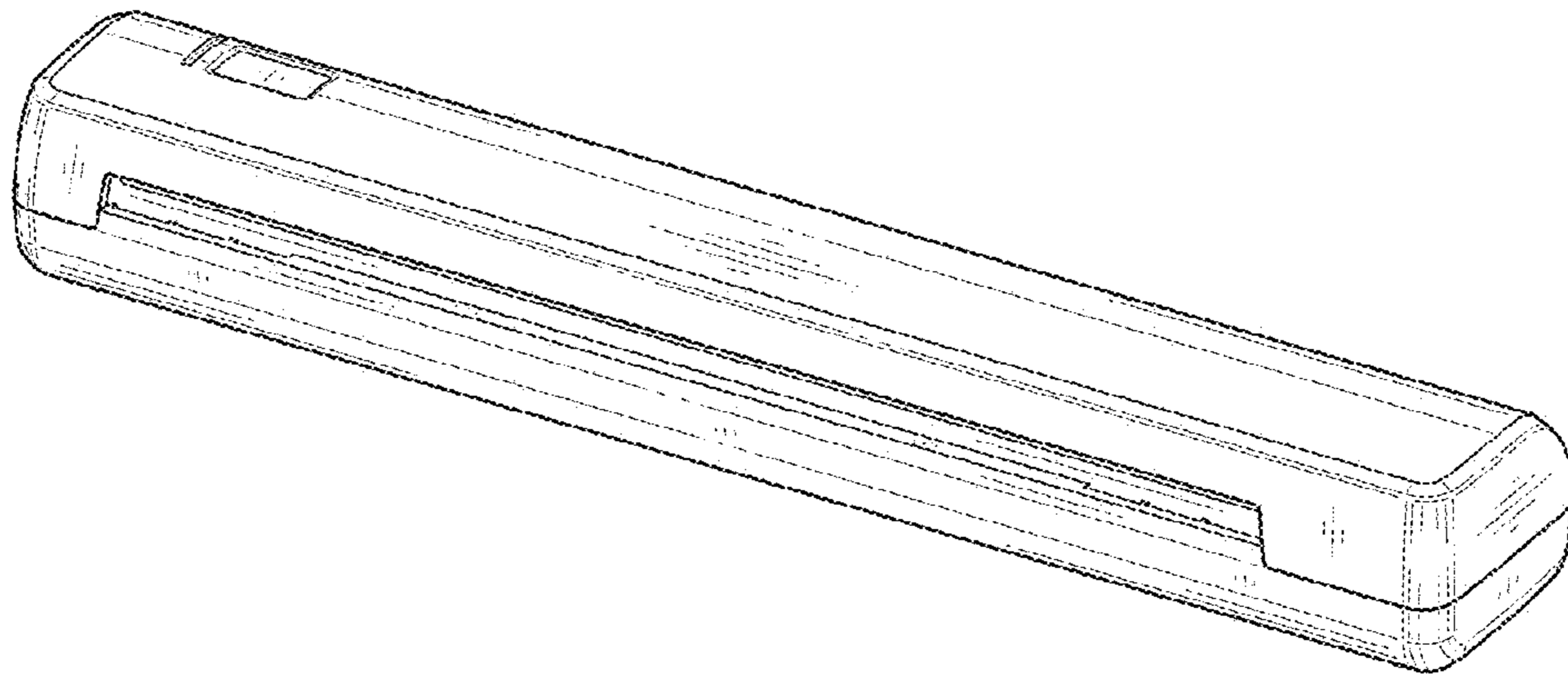

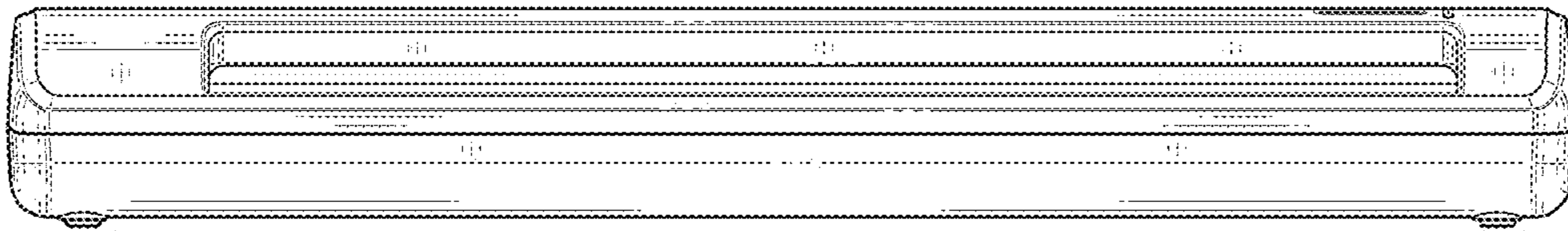

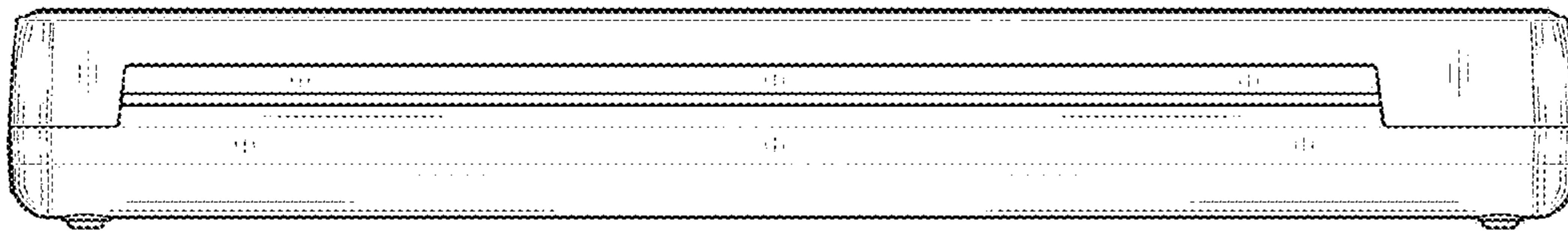

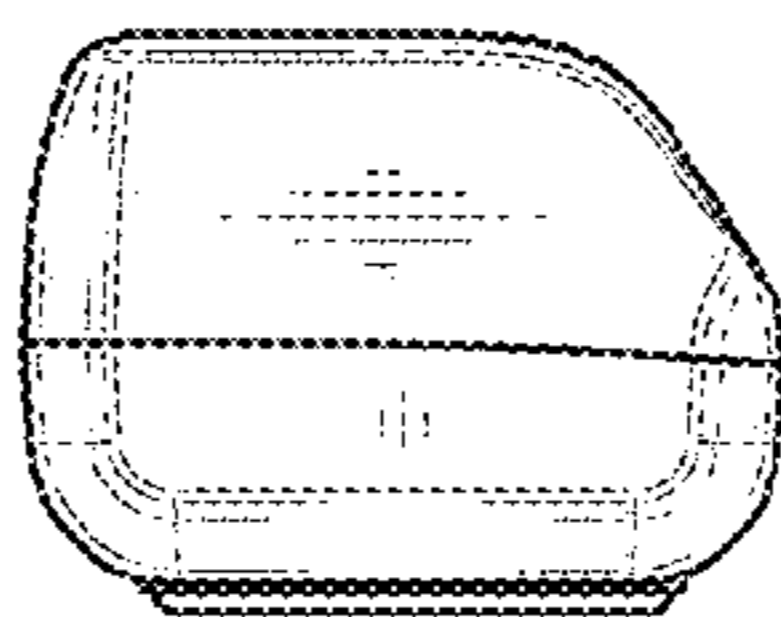

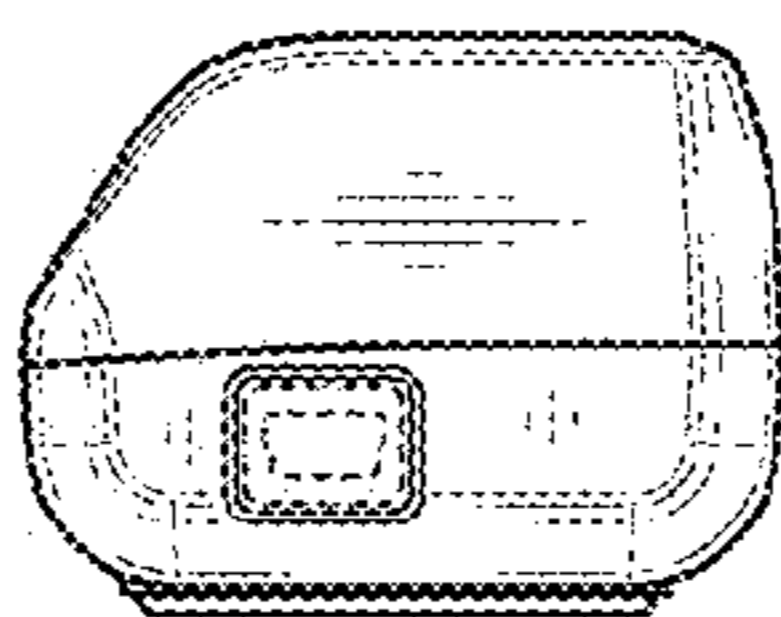

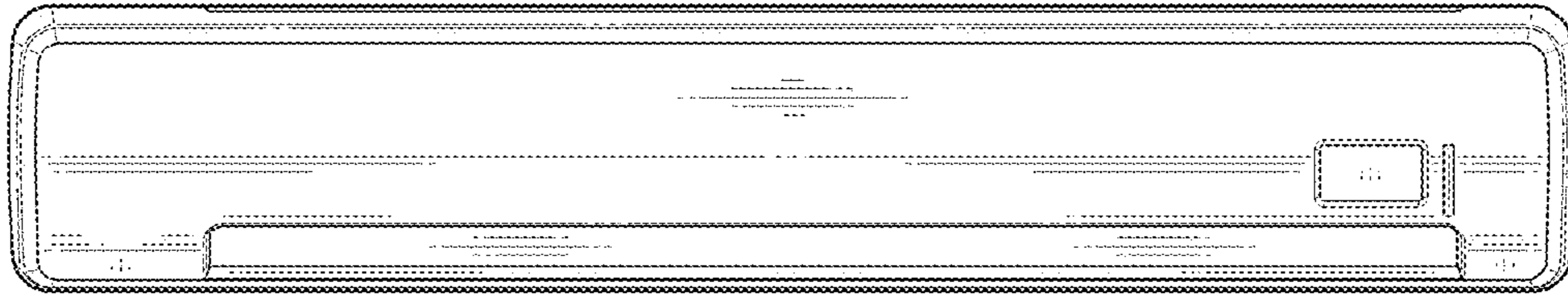

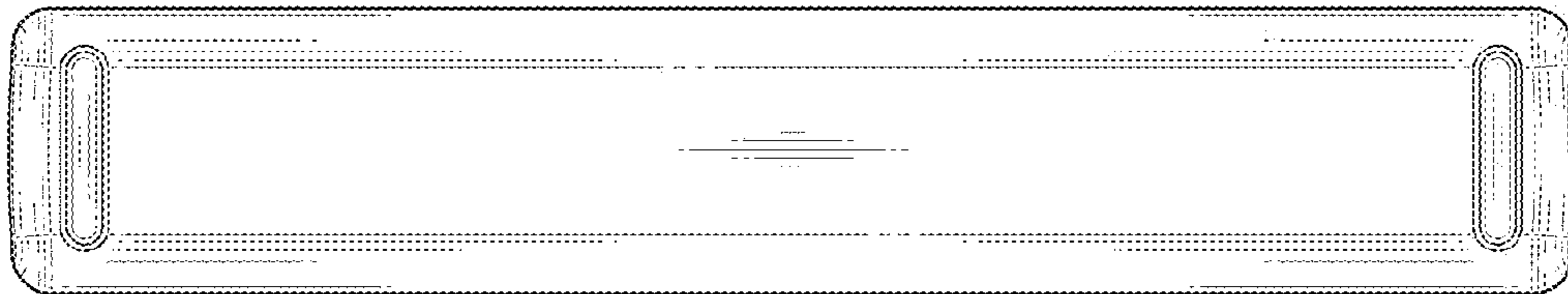
