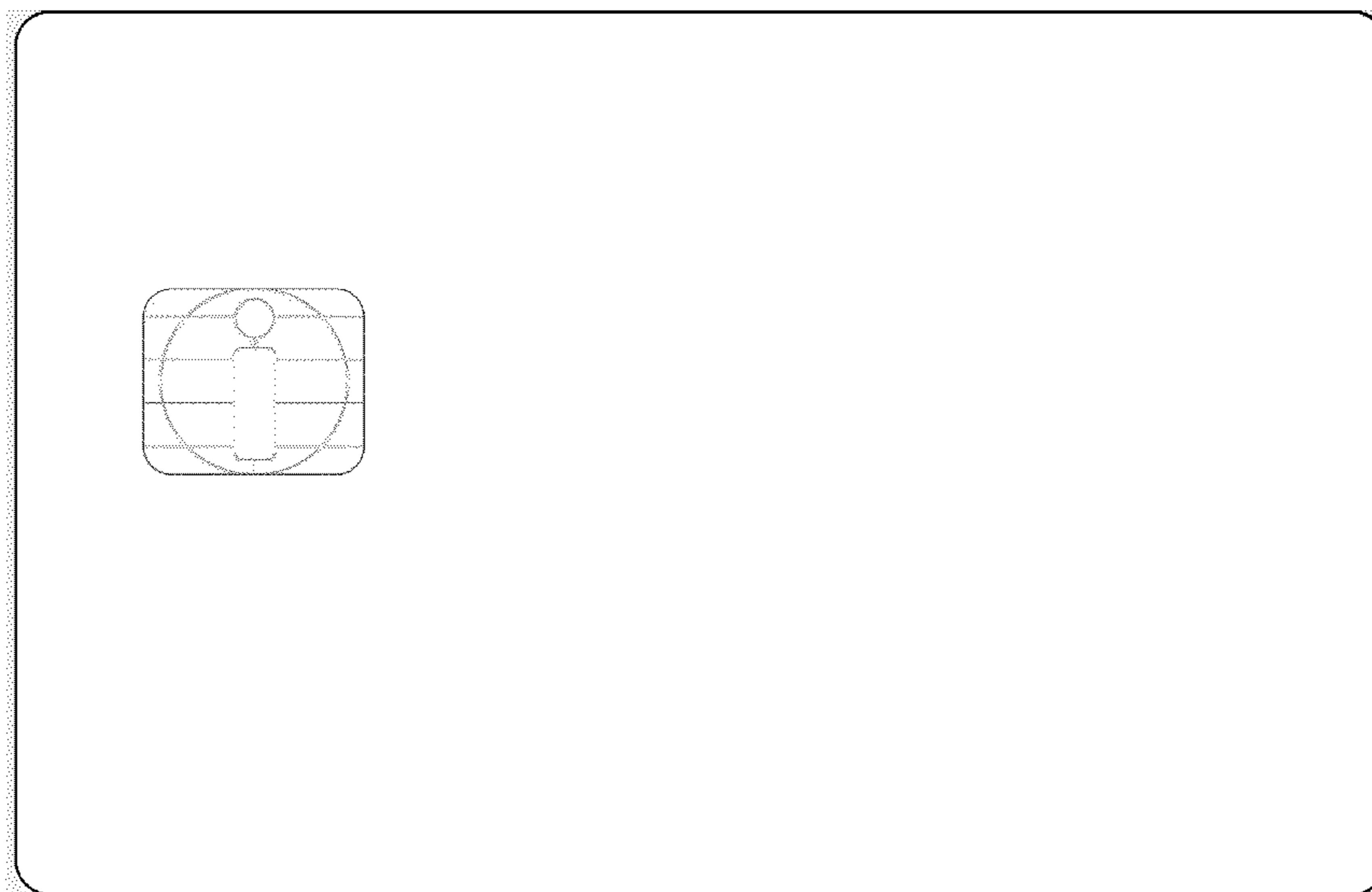
(57) **CLAIM**

The ornamental design for a smartcard with iChip contact pad, as shown and described herein.

DESCRIPTION

FIG. 1 is a front view of the smartcard with iChip contact pad. FIG. 2 is a side view of the smartcard with iChip contact pad; and, FIG. 3 is an end view of the smartcard with iChip contact pad. The back of the card is unornamented. The appearance of the back of the card is not claimed.

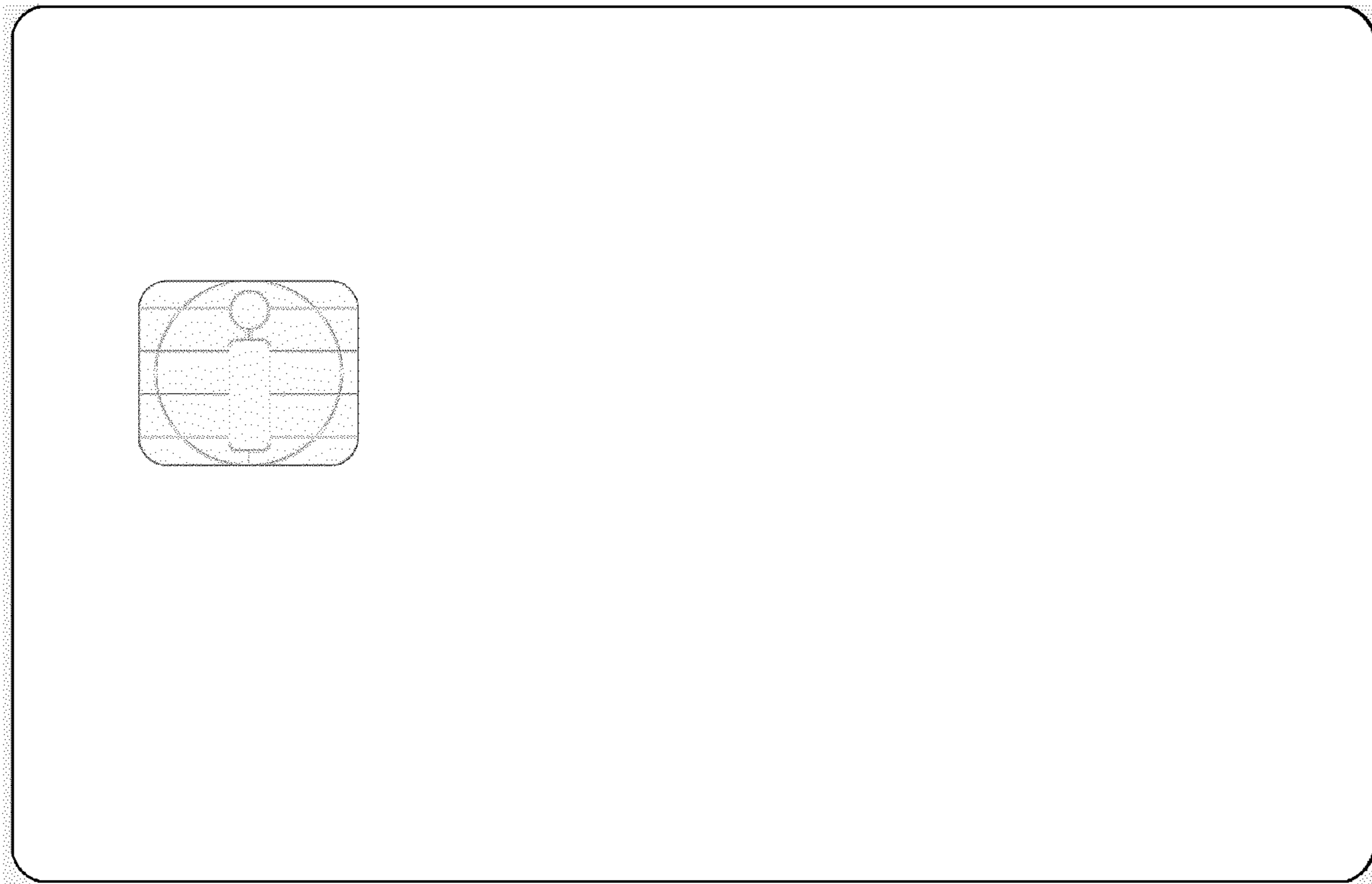
