(57) **CLAIM**

The ornamental design for a mobile terminal with a graphic user interface, as shown and described.

**DESCRIPTION**

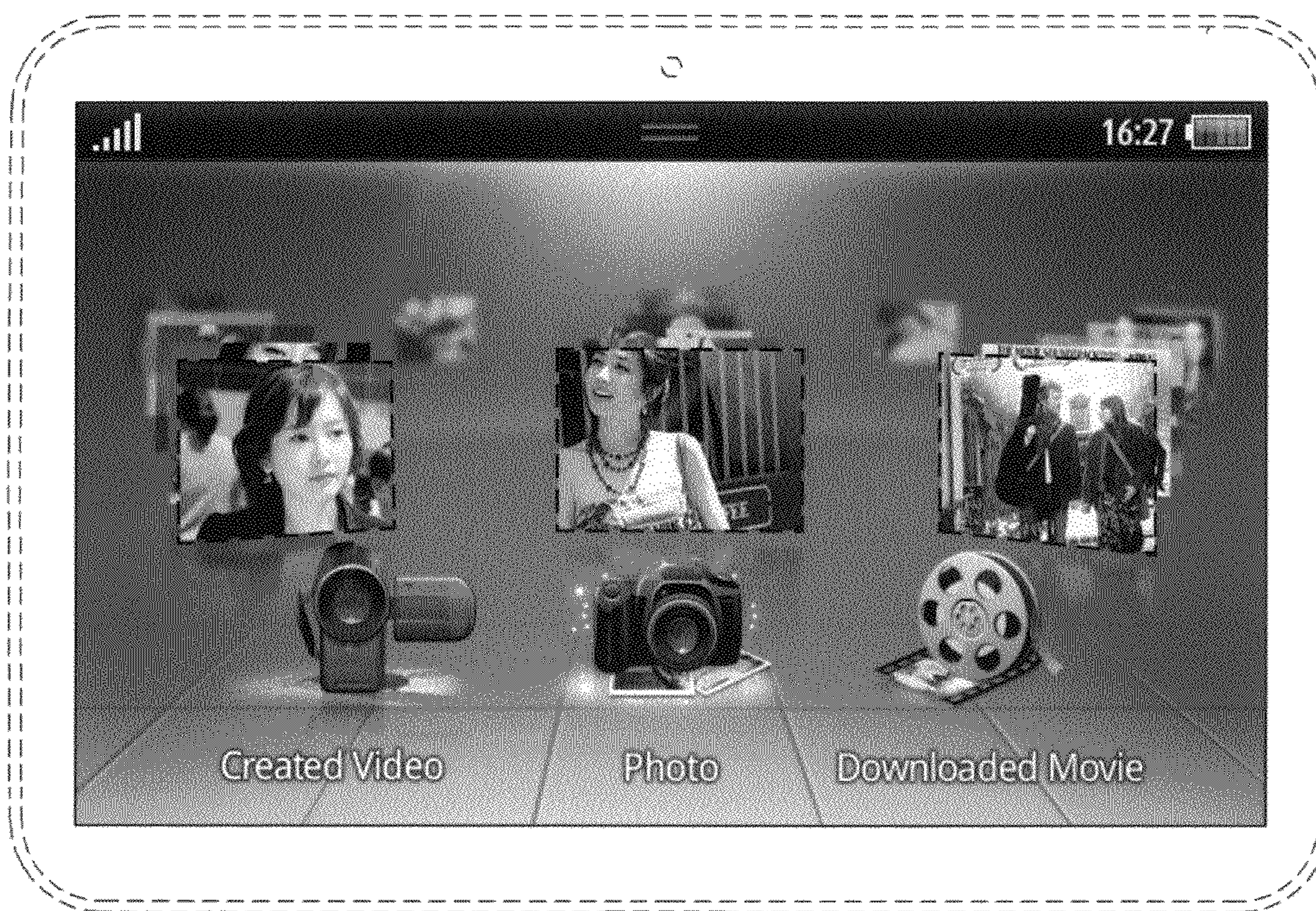

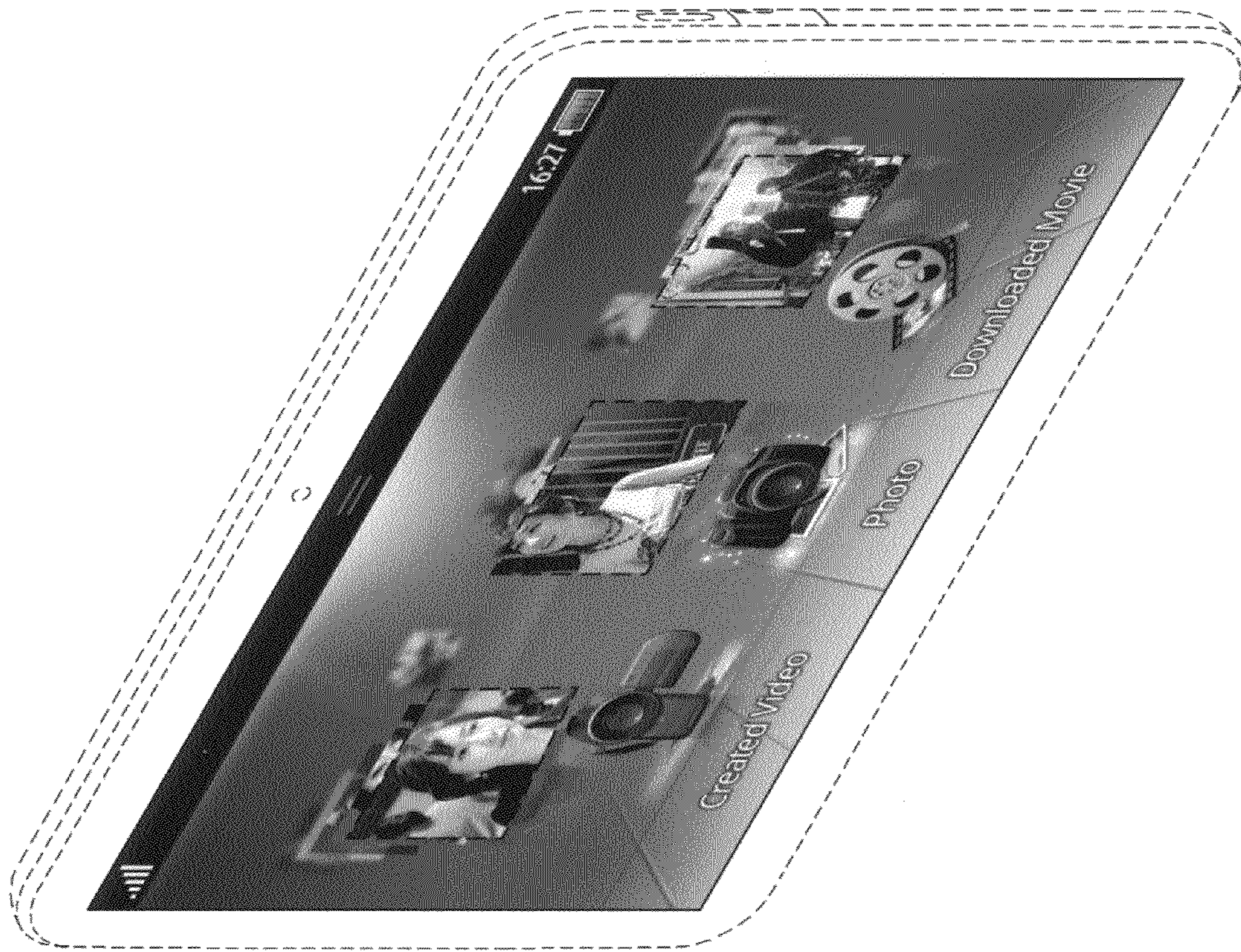
