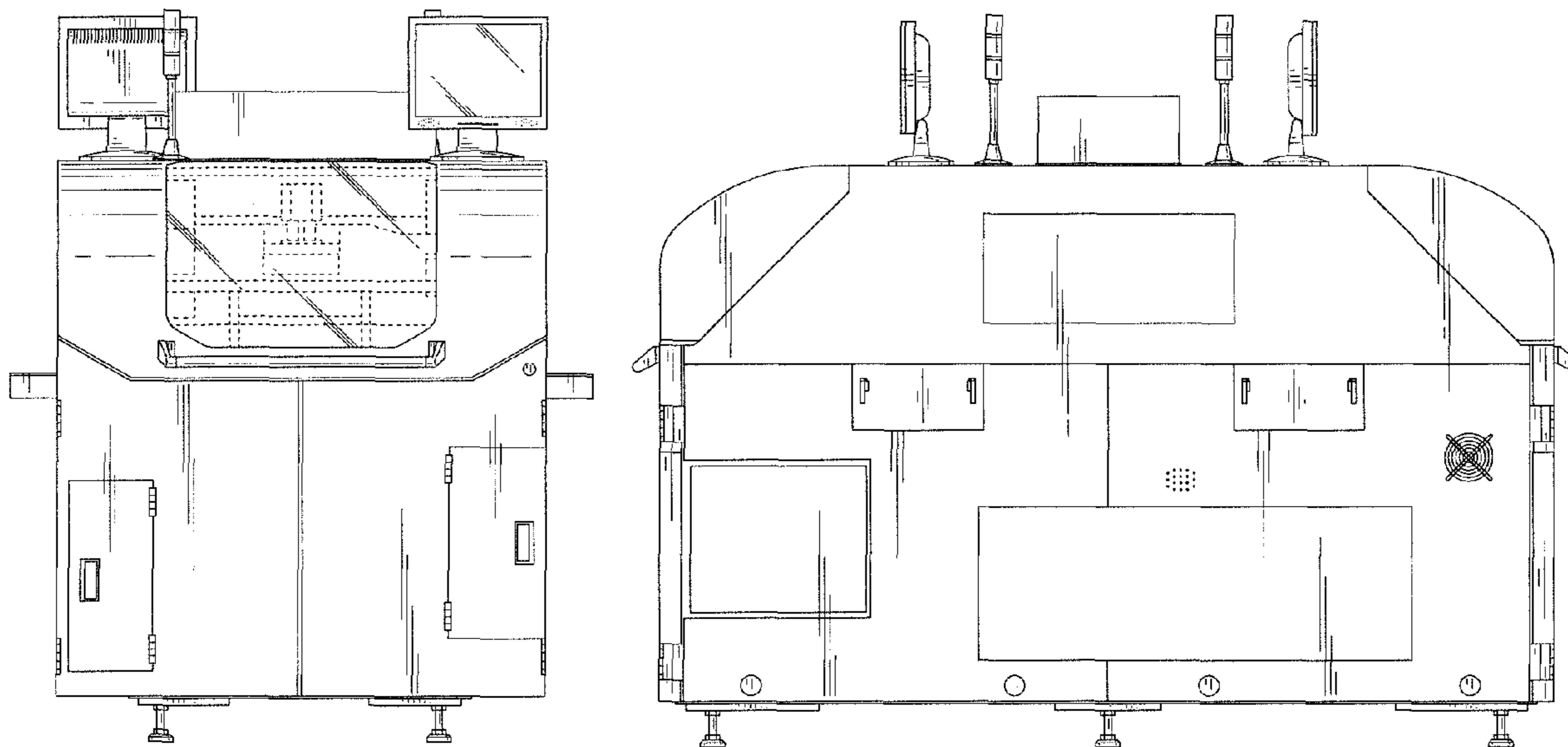
(57) **CLAIM**

We claim the ornamental design for a cream solder printer, as shown and described.

DESCRIPTION

FIG. 1 is a front, top and left side perspective view of an cream solder printer showing our new design;
FIG. 2 is a front side elevational view thereof;
FIG. 3 is a rear side elevational view thereof;
FIG. 4 is a right side elevational view thereof;
FIG. 5 is a left side elevational view thereof.;
FIG. 6 is a top plan view thereof;
FIG. 7 is a bottom plan view thereof; and,
FIG. 8 is a right side view in which the door was opened.

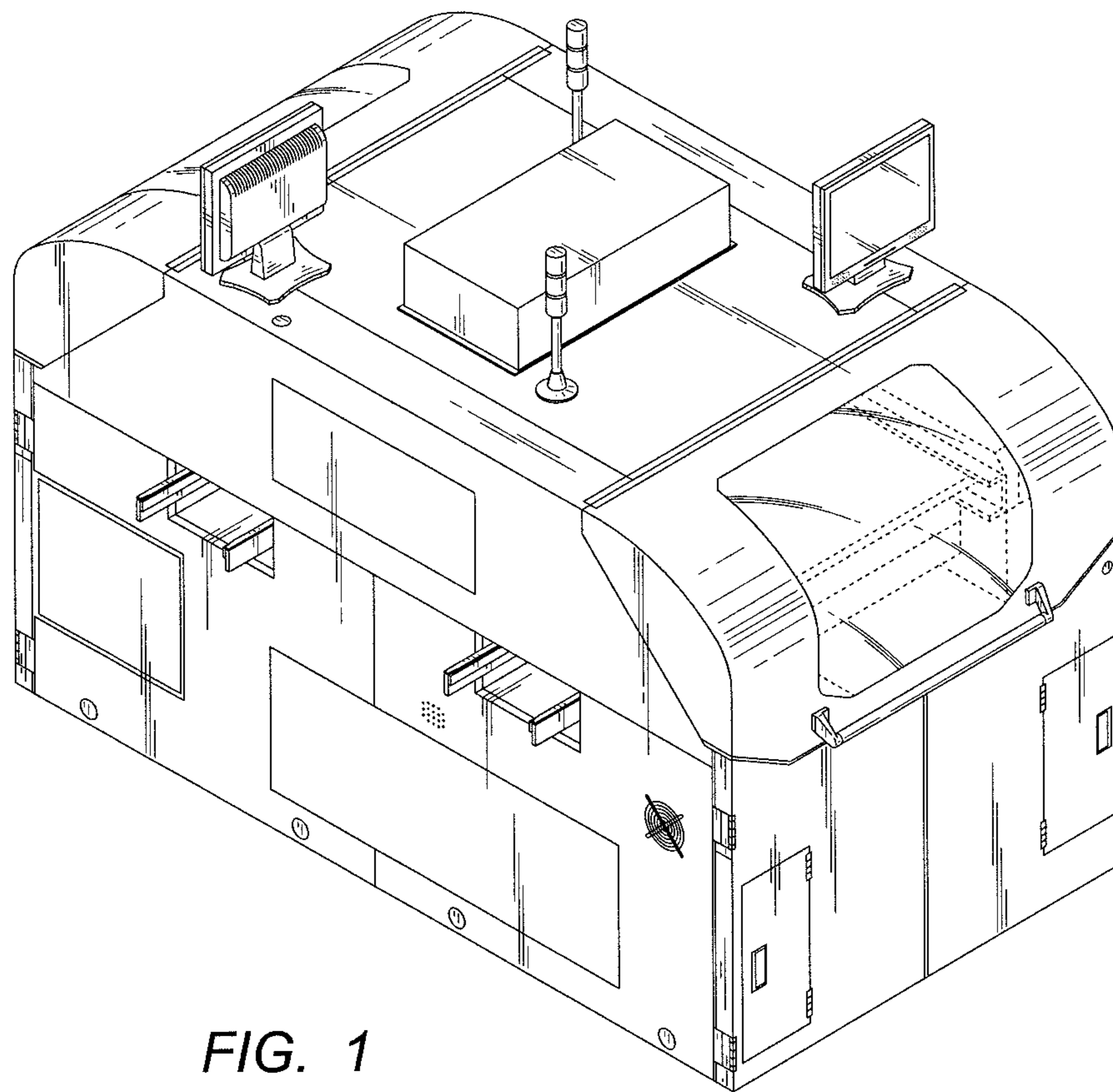

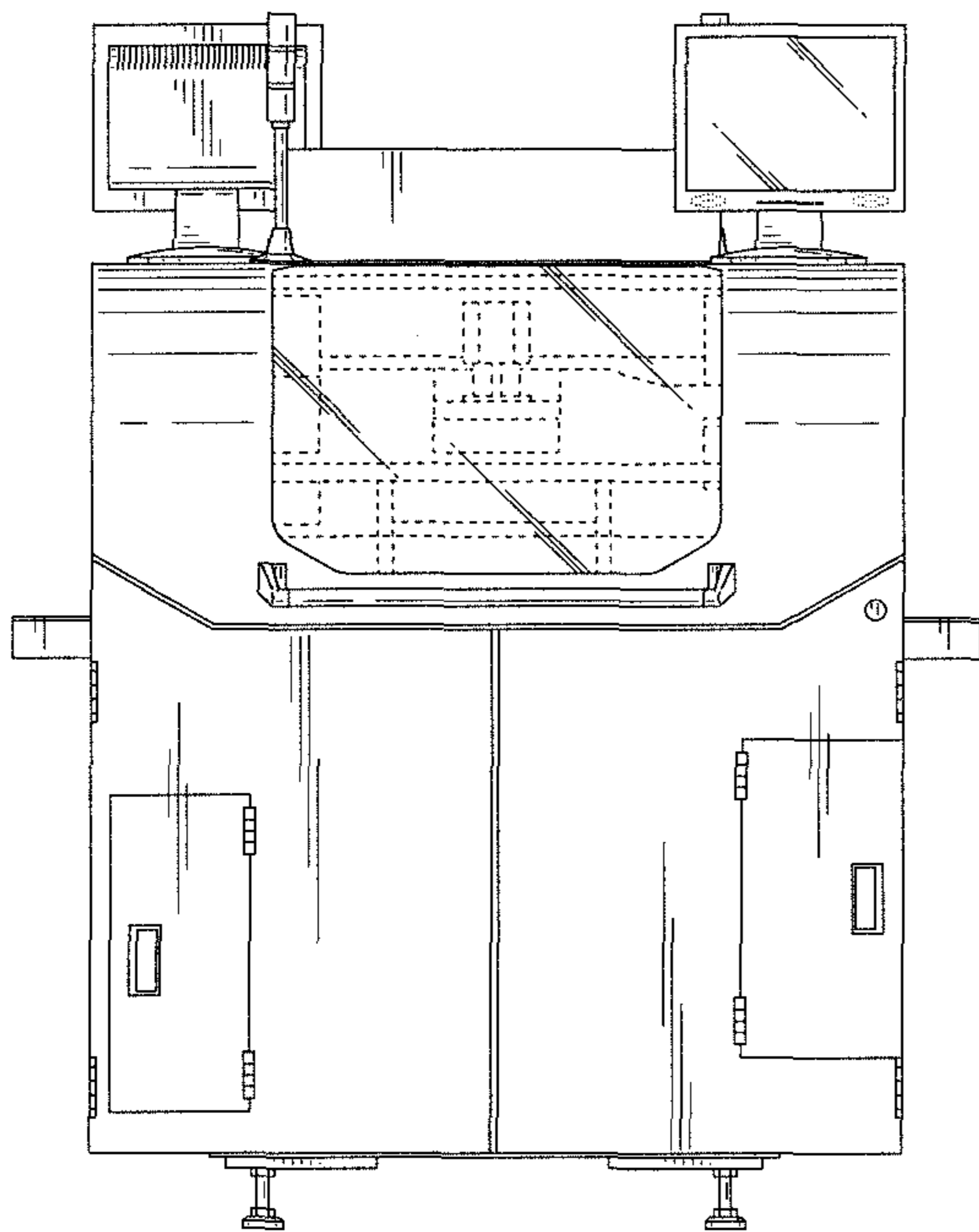

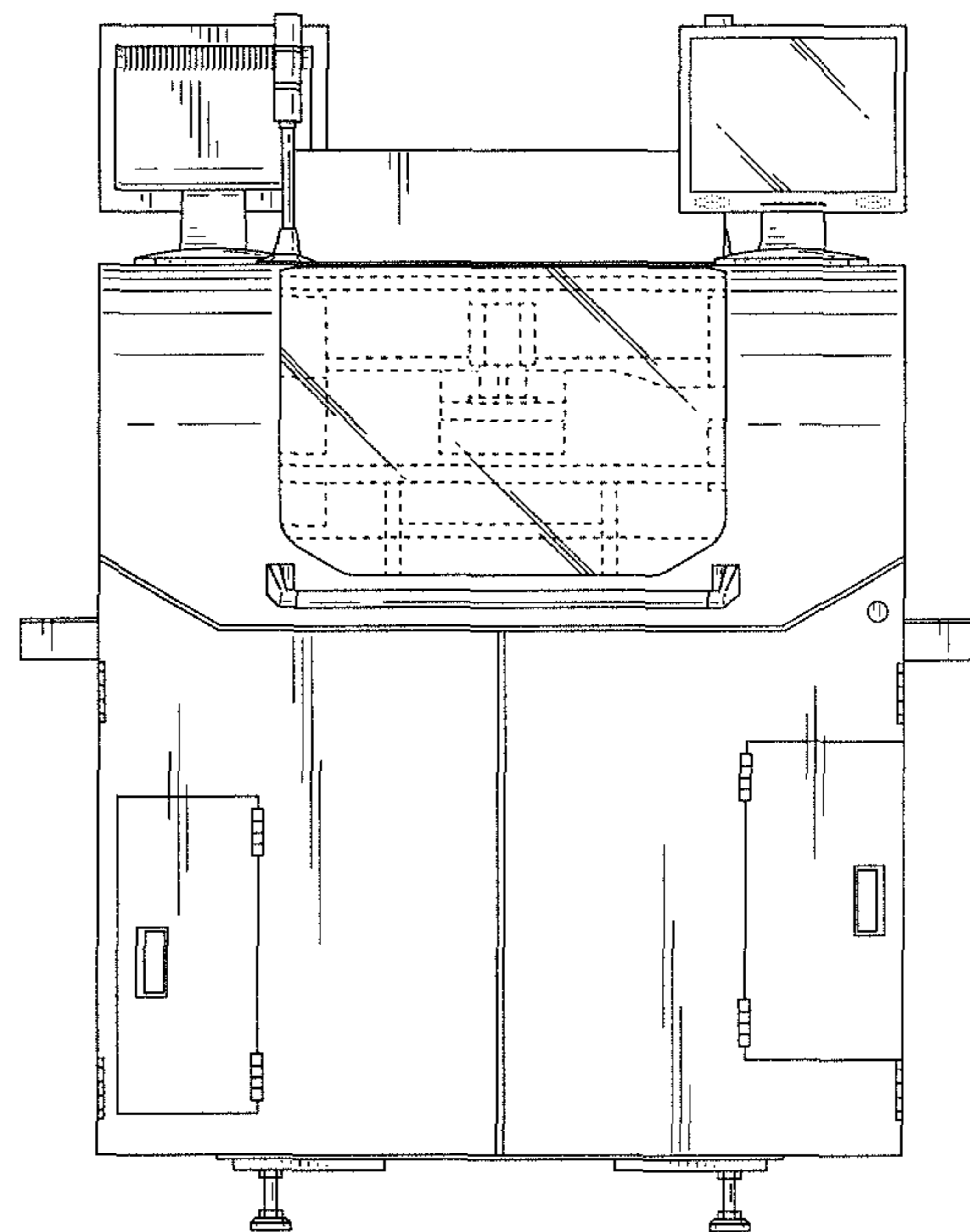

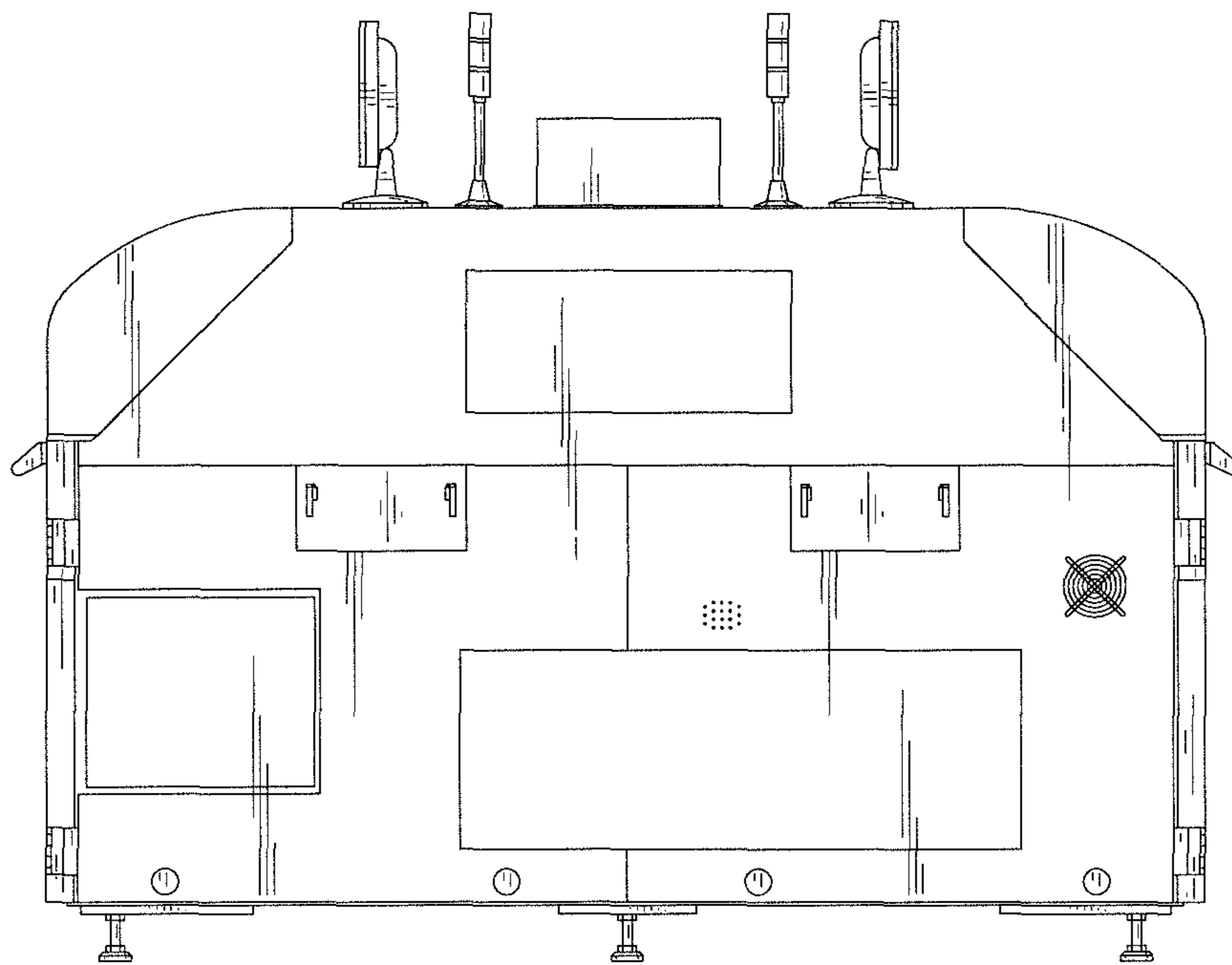

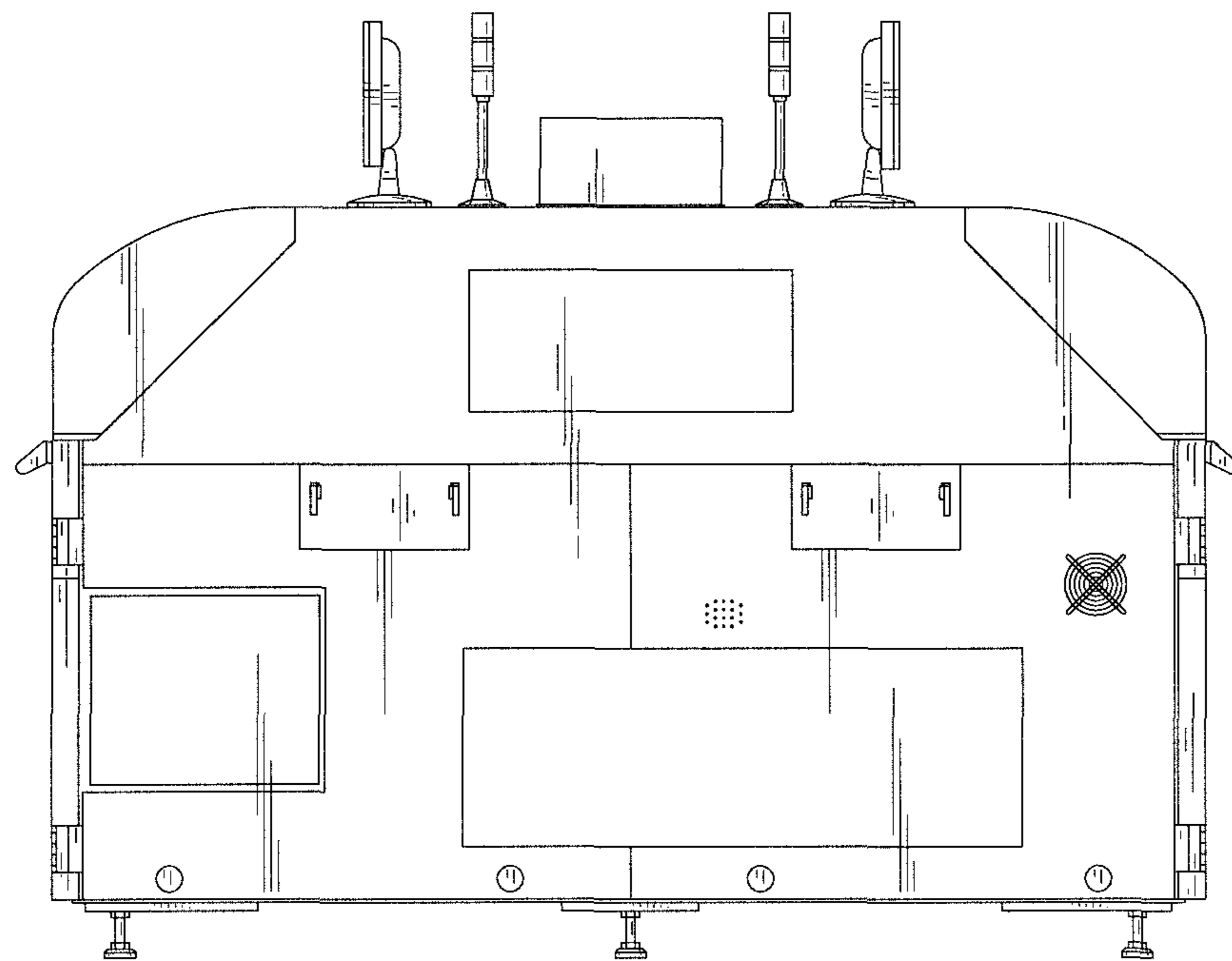

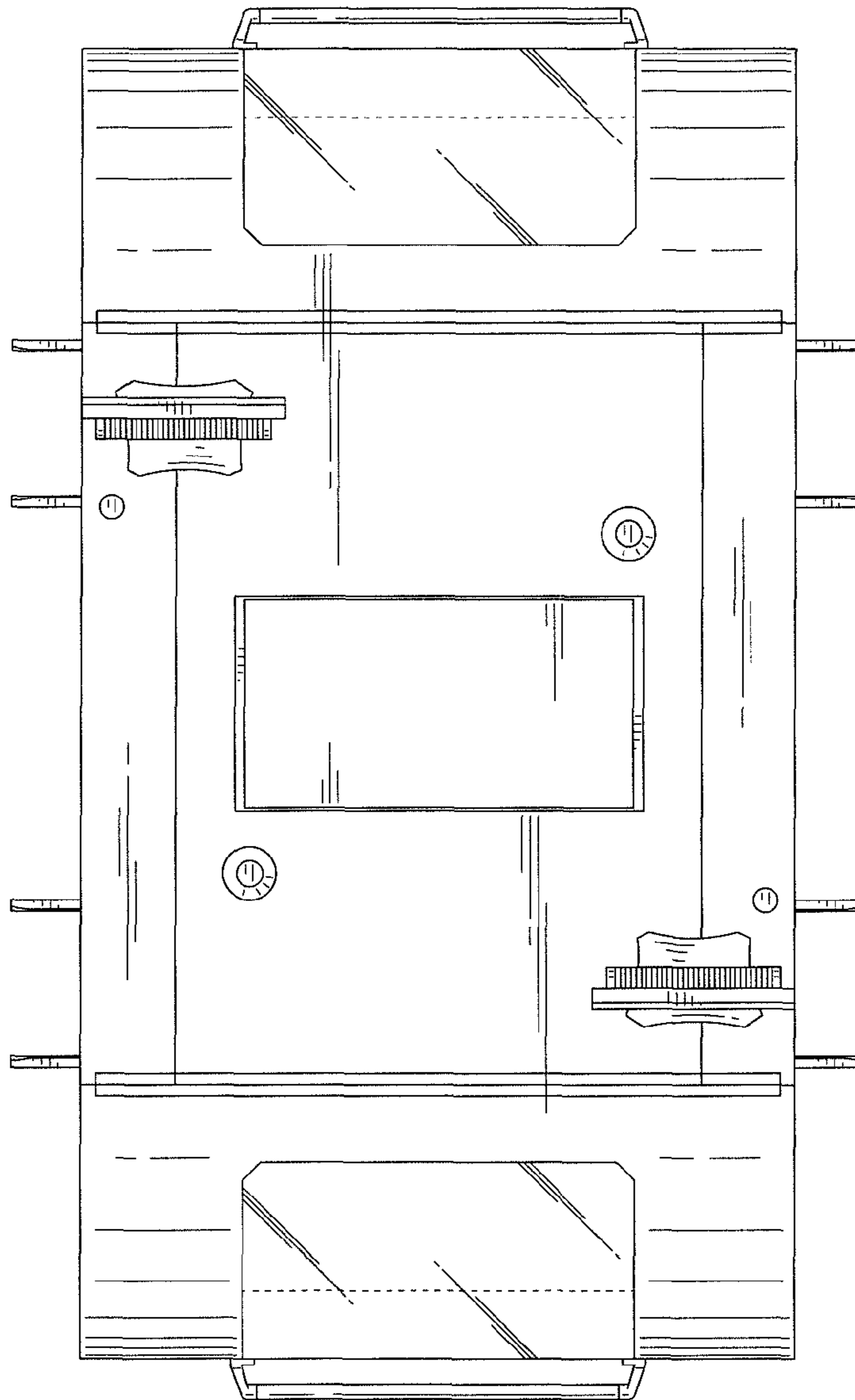

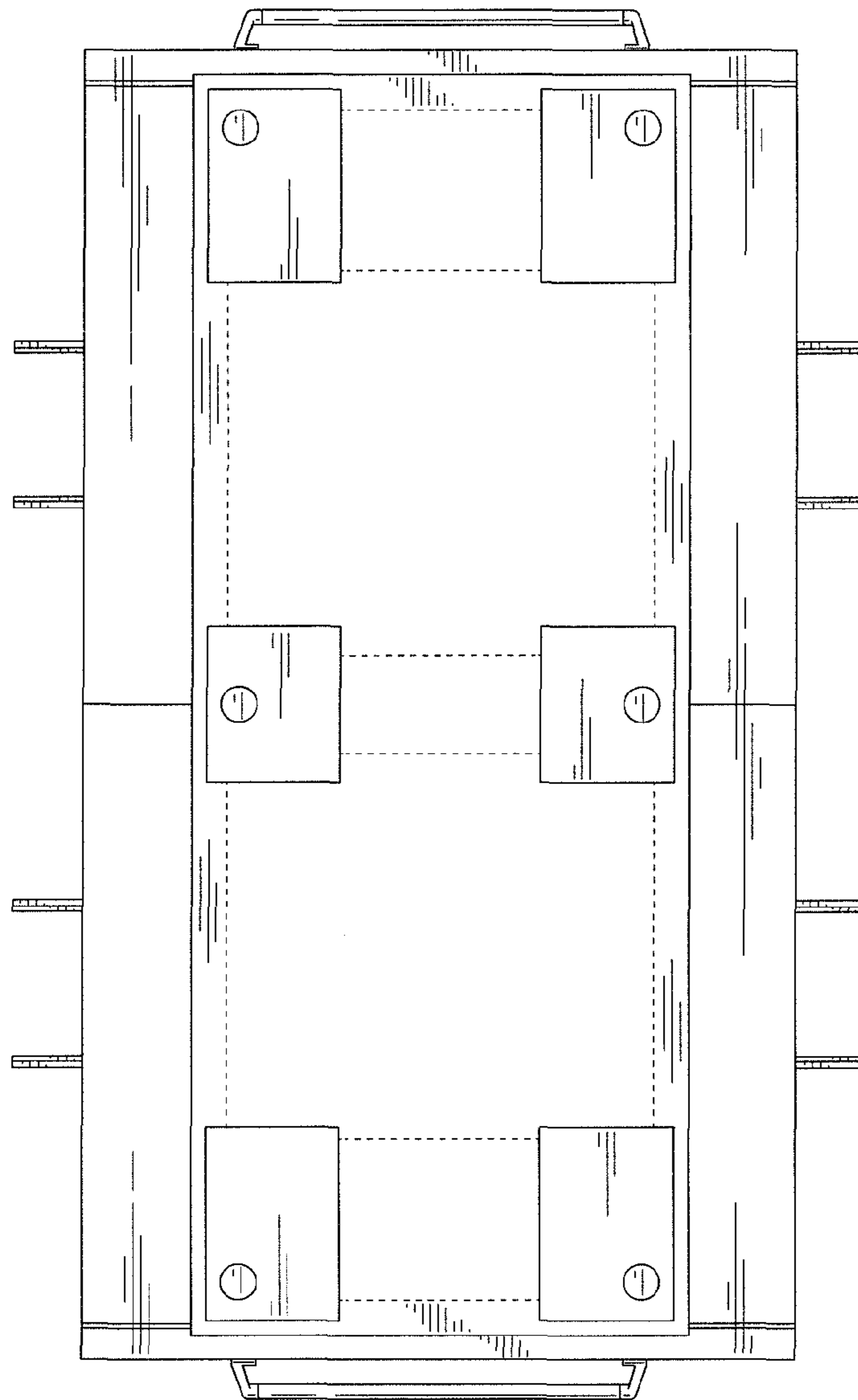

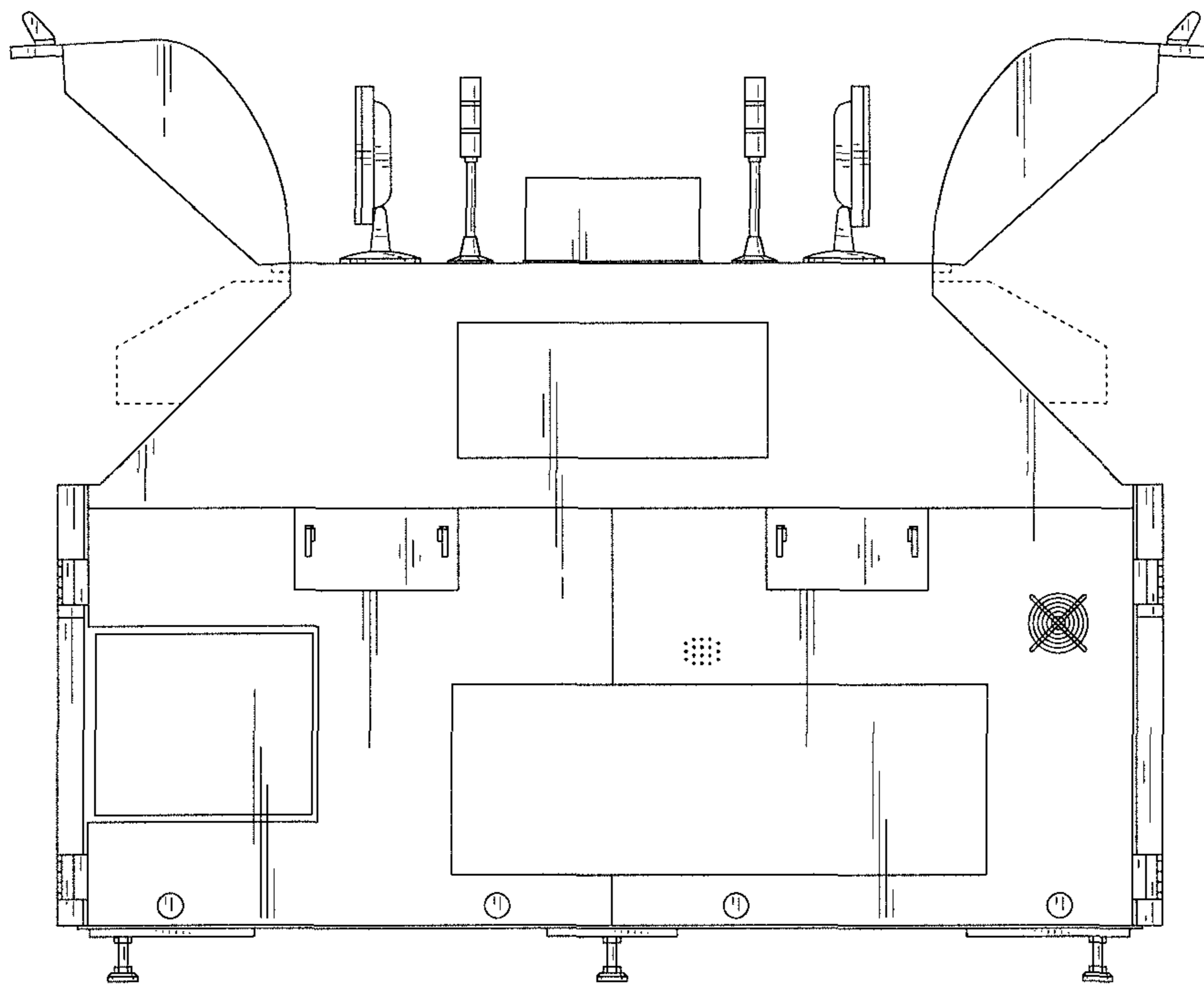
