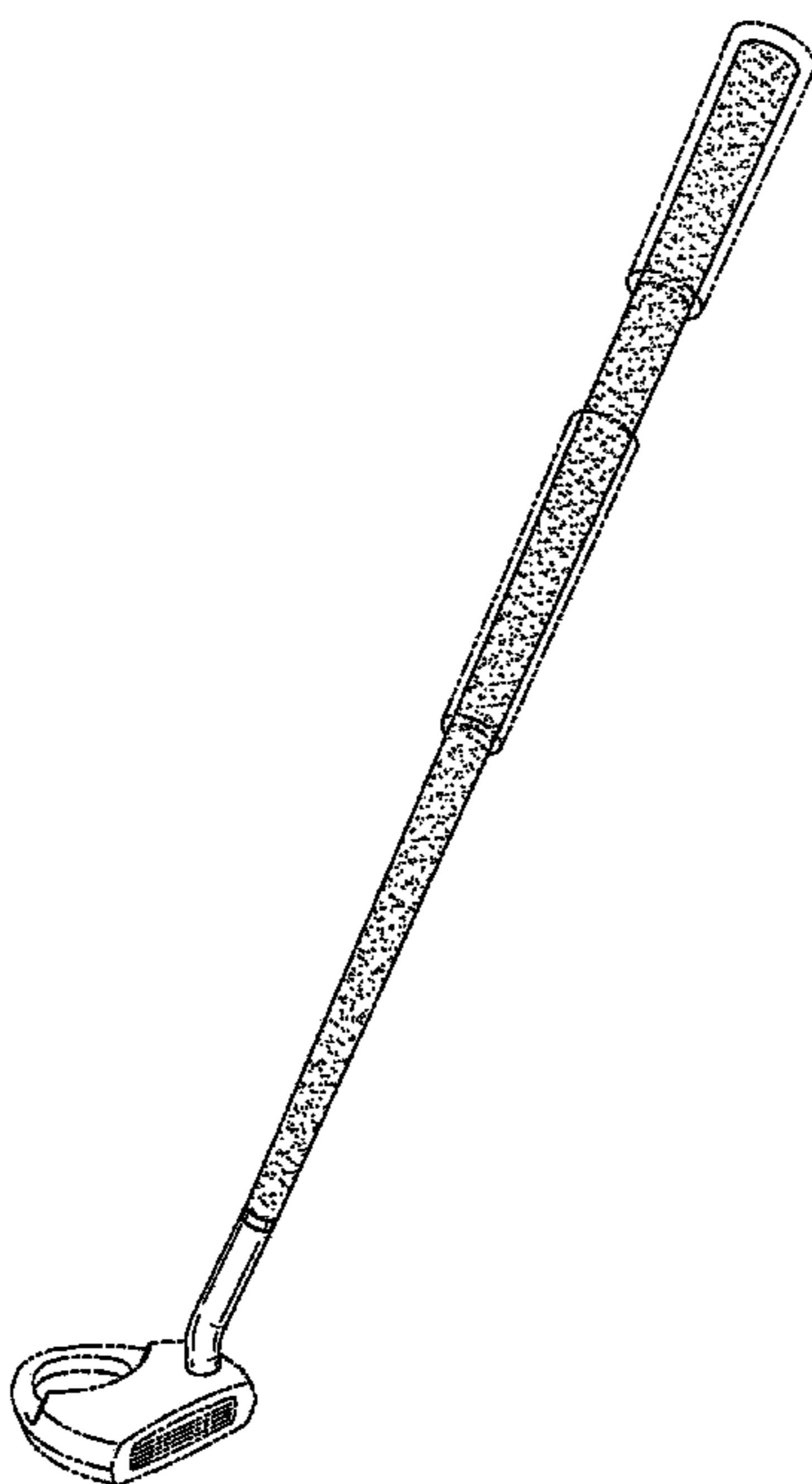
(57) **CLAIM**

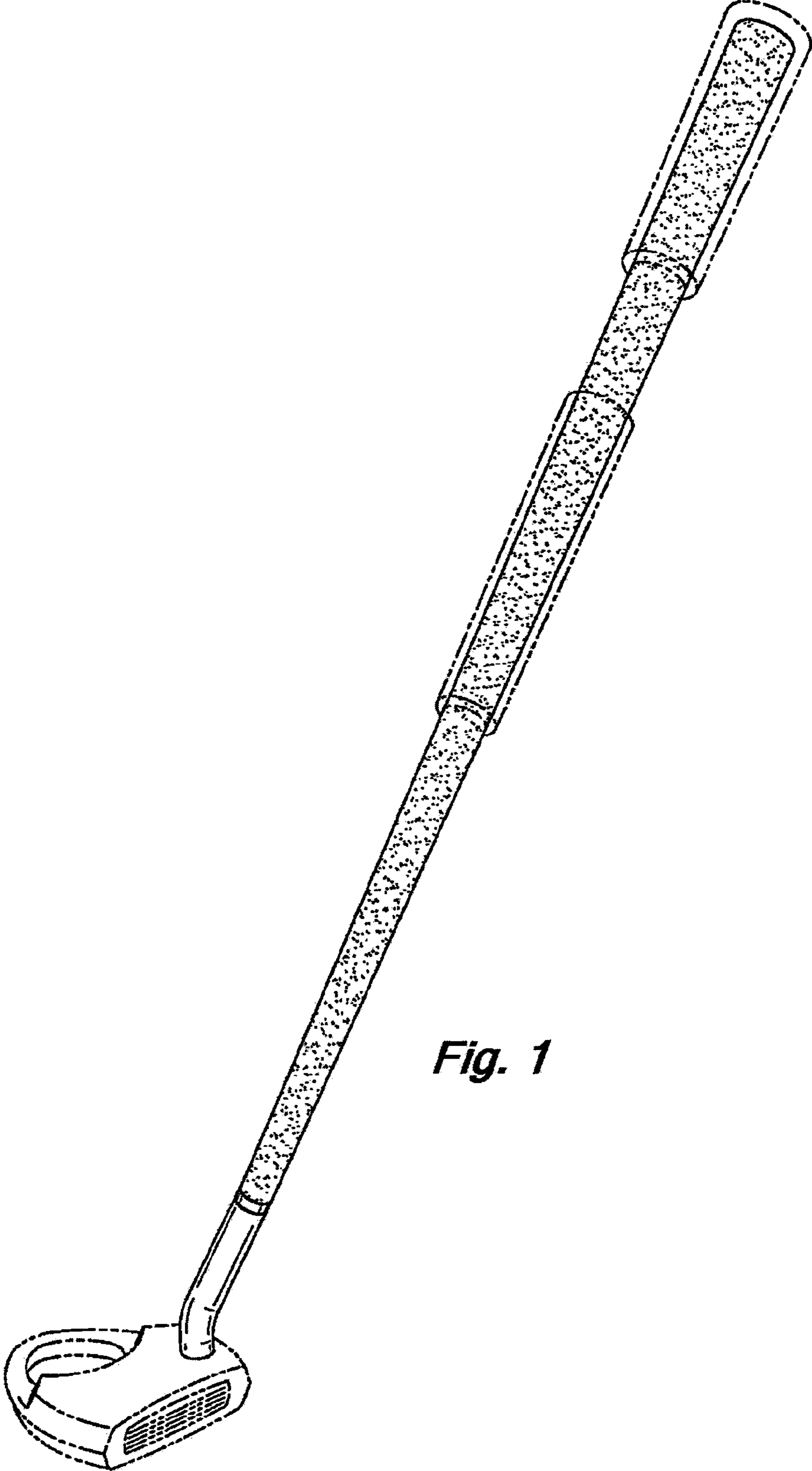
The ornamental design for a golf club shaft, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of an embodiment of a golf club shaft for a putter according to the present invention; FIG. 2 is a front view of the golf club shaft shown in FIG. 1; FIG. 3 is a rear view of the golf club shaft shown in FIG. 1; FIG. 4 is a top view of the golf club shaft shown in FIG. 1; FIG. 5 is a bottom view of the golf club shaft shown in FIG. 1; and, FIG. 6 is a side view of the golf club shaft shown in FIG. 1. The broken lines in the figures are for illustrative purposes only and form no part of the claimed design.

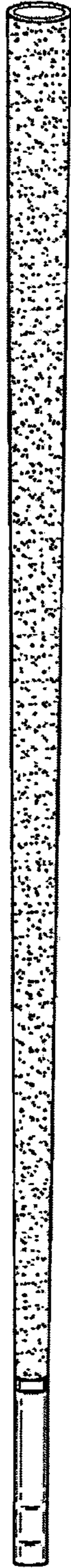

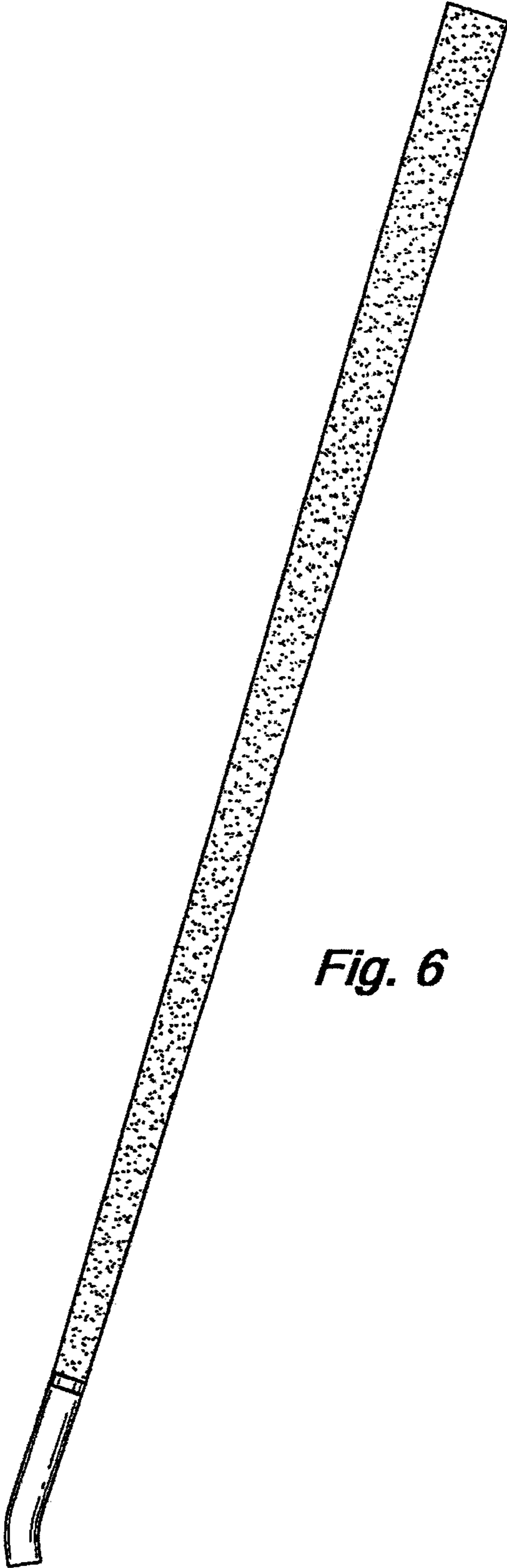
