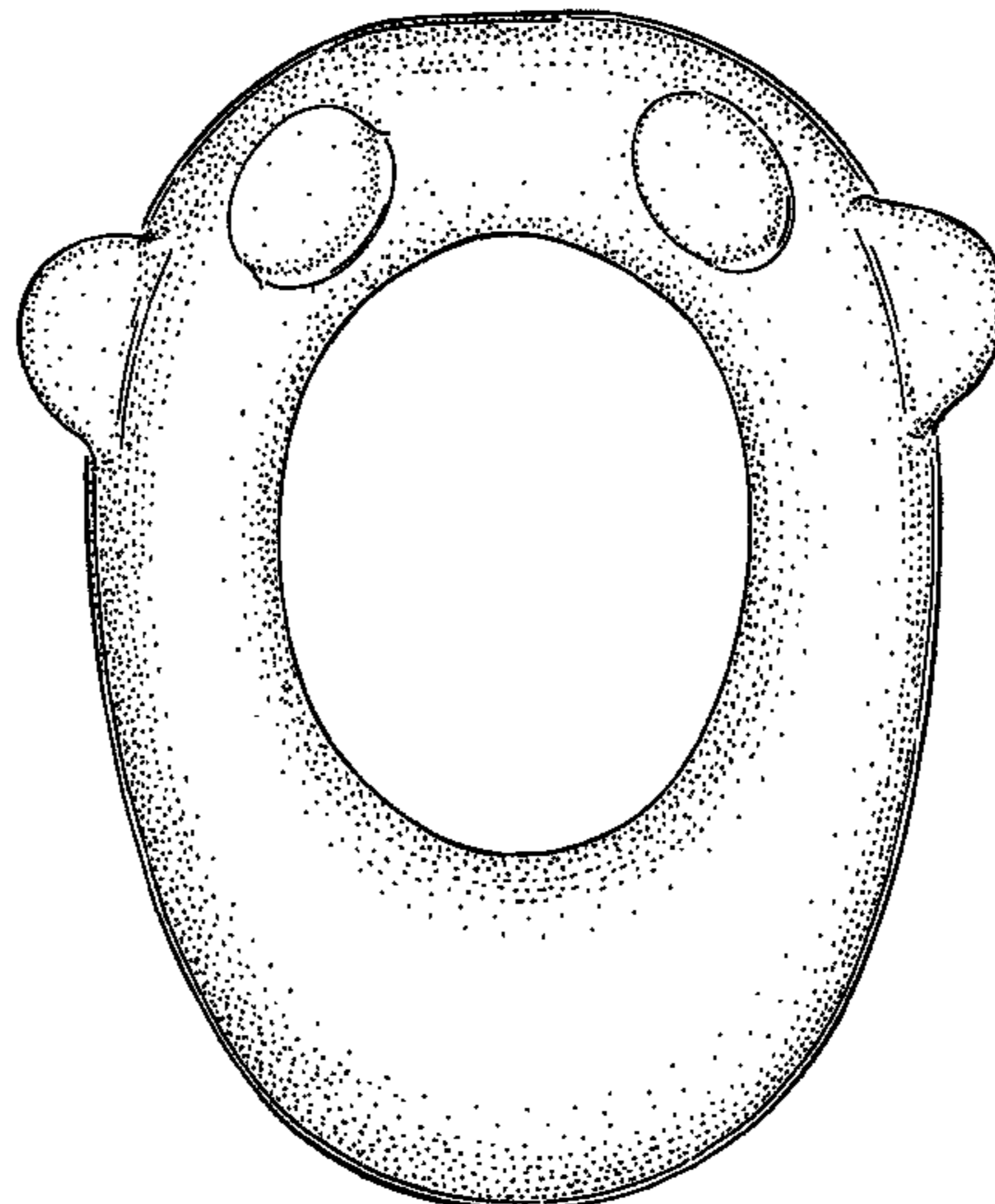
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a top plan view of an orthotic insert showing my new design;  
 FIG. 2 is an enlarged left side view of the orthotic insert shown in FIG. 1, the right side being a mirror image thereof; and,  
 FIG. 3 is a further enlarged left side perspective view of the orthotic insert shown in FIG. 1.

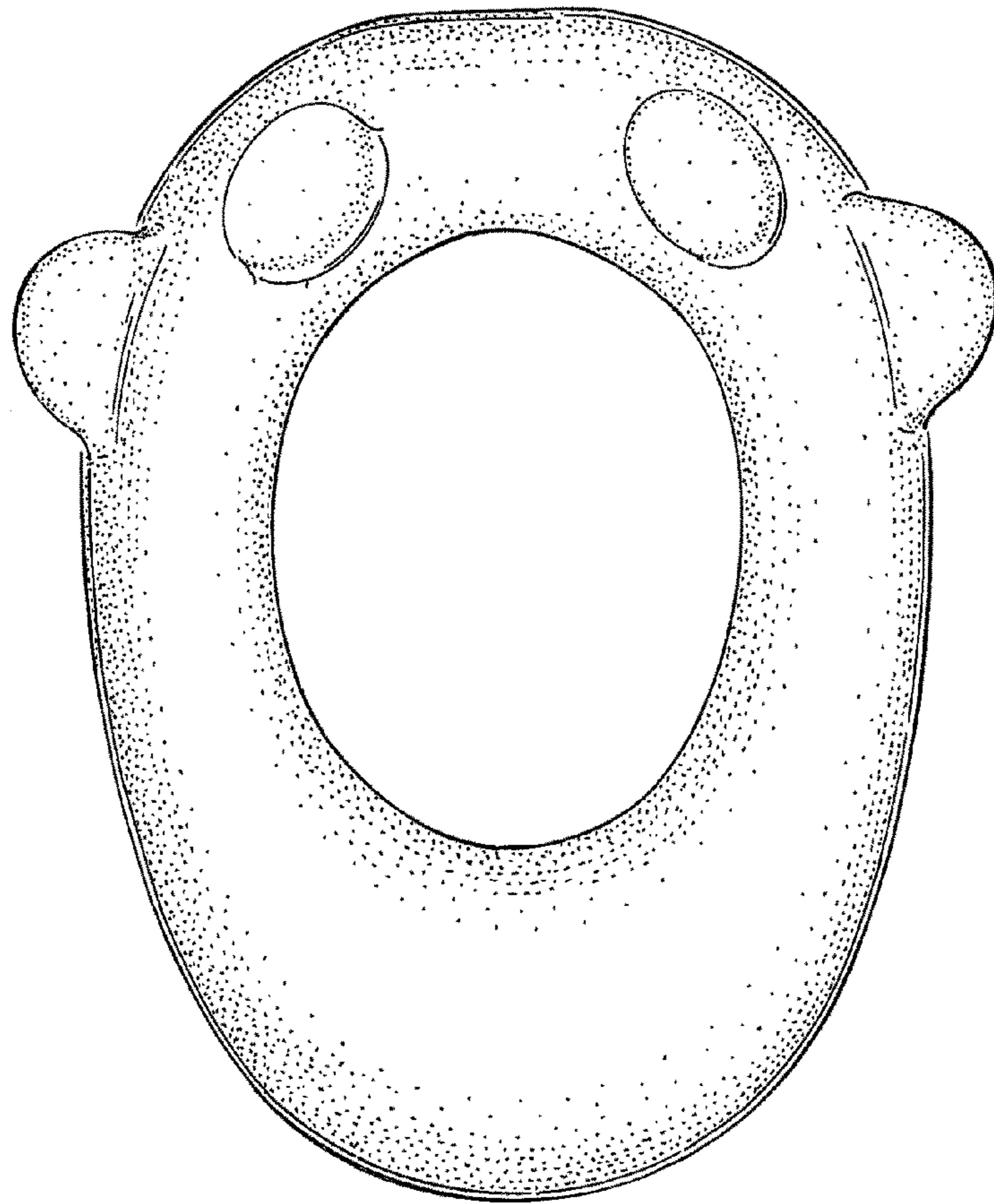
