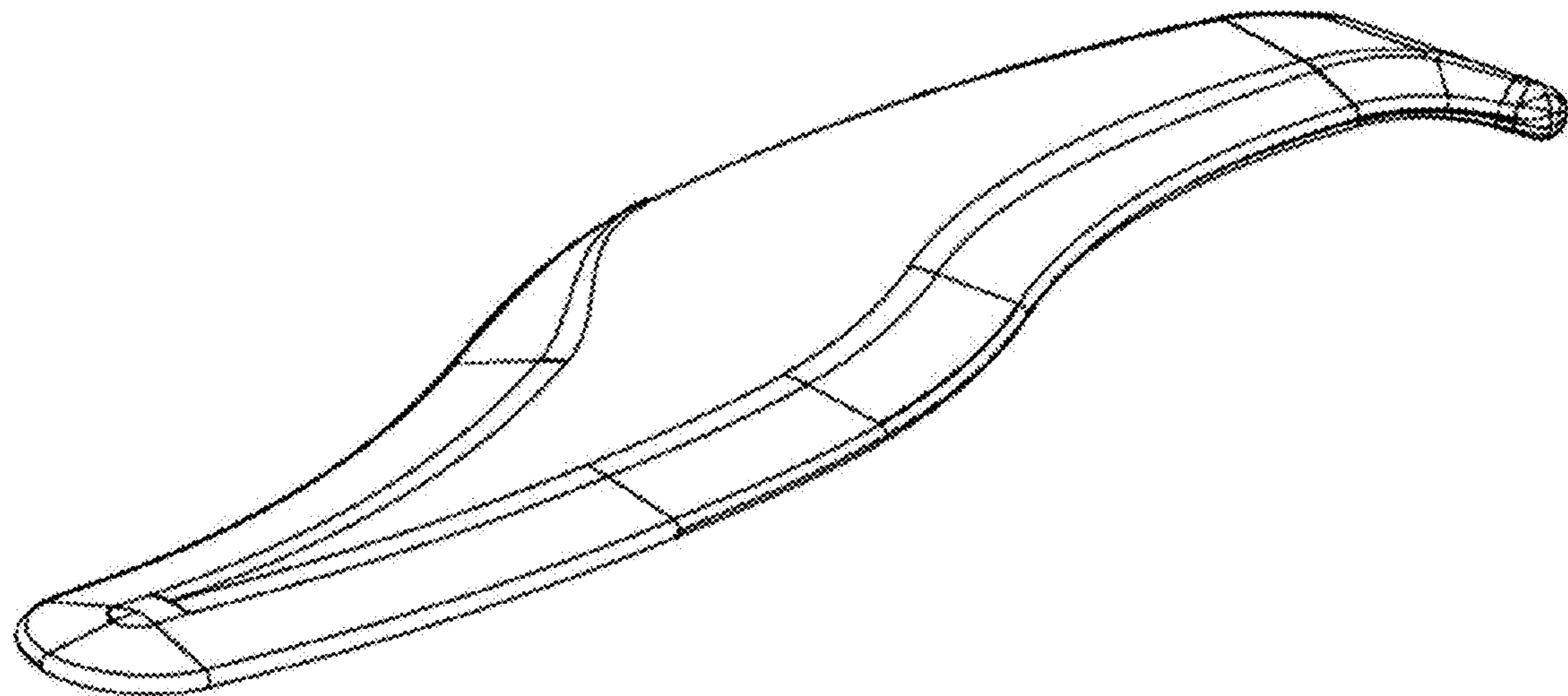

(57) **CLAIM**  
I claim the ornamental design for a massage tool, as shown.

**DESCRIPTION**

FIG. 1 is a perspective view of a massage tool;  
FIG. 2 is an enlarged front elevation view of the massage tool of FIG. 1;  
FIG. 3 is an enlarged rear elevation view of the massage tool of FIG. 1;  
FIG. 4 is a reduced left elevation view of the massage tool of FIG. 1;  
FIG. 5 is a reduced right elevation view of the massage tool of FIG. 1;  
FIG. 6 is a top plan view of the massage tool of FIG. 1; and,  
FIG. 7 is a bottom plan view of the massage tool of FIG. 1.

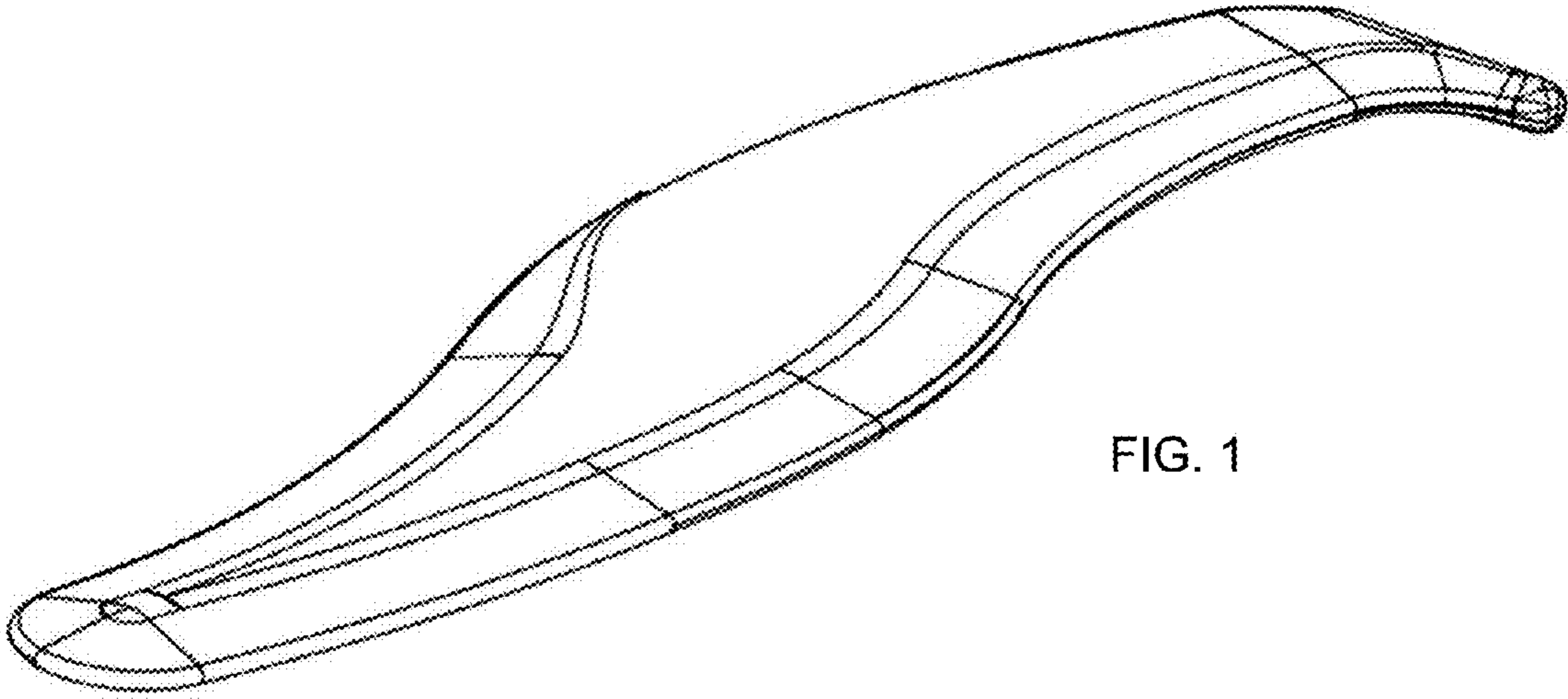

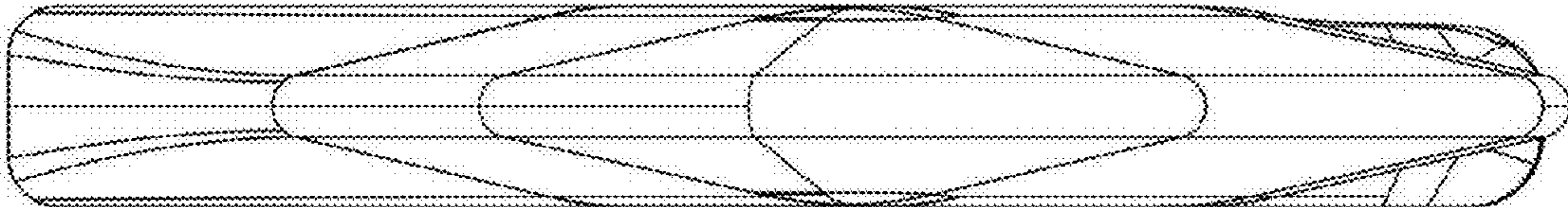

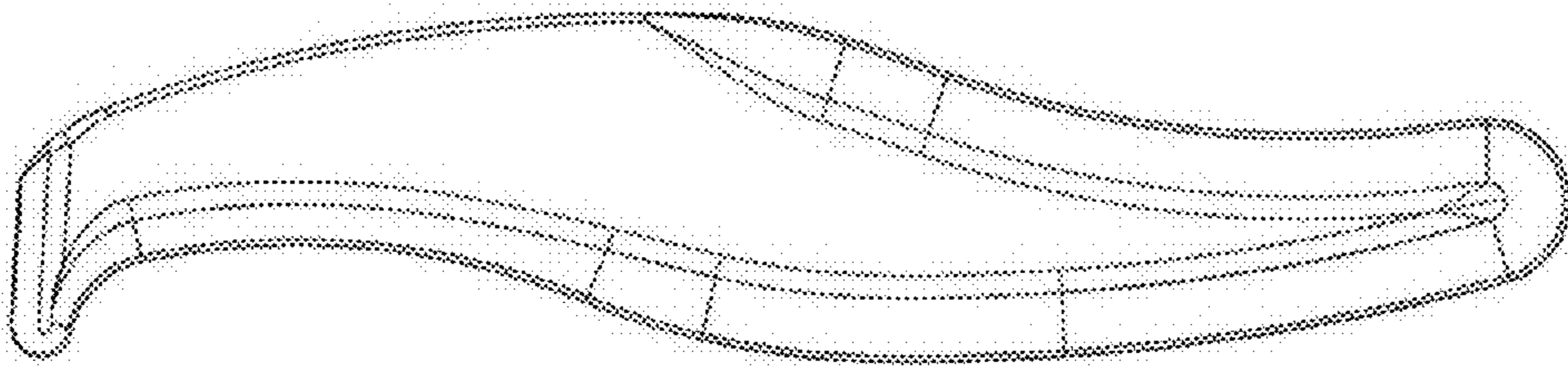

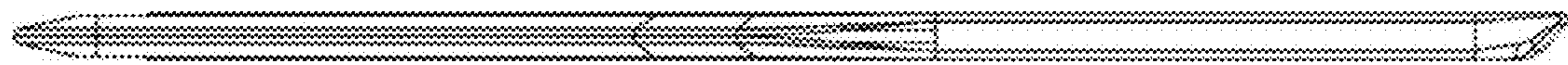

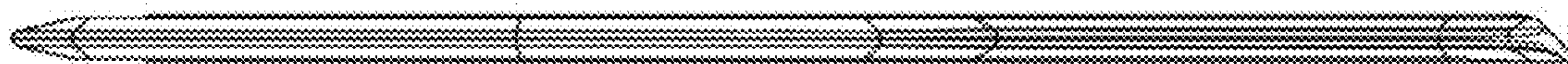
