(57) **CLAIM**

The ornamental design for a blackout mask cover with hole,  
as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a blackout mask cover with hole  
showing my new design, the rear view being a mirror image  
thereof;

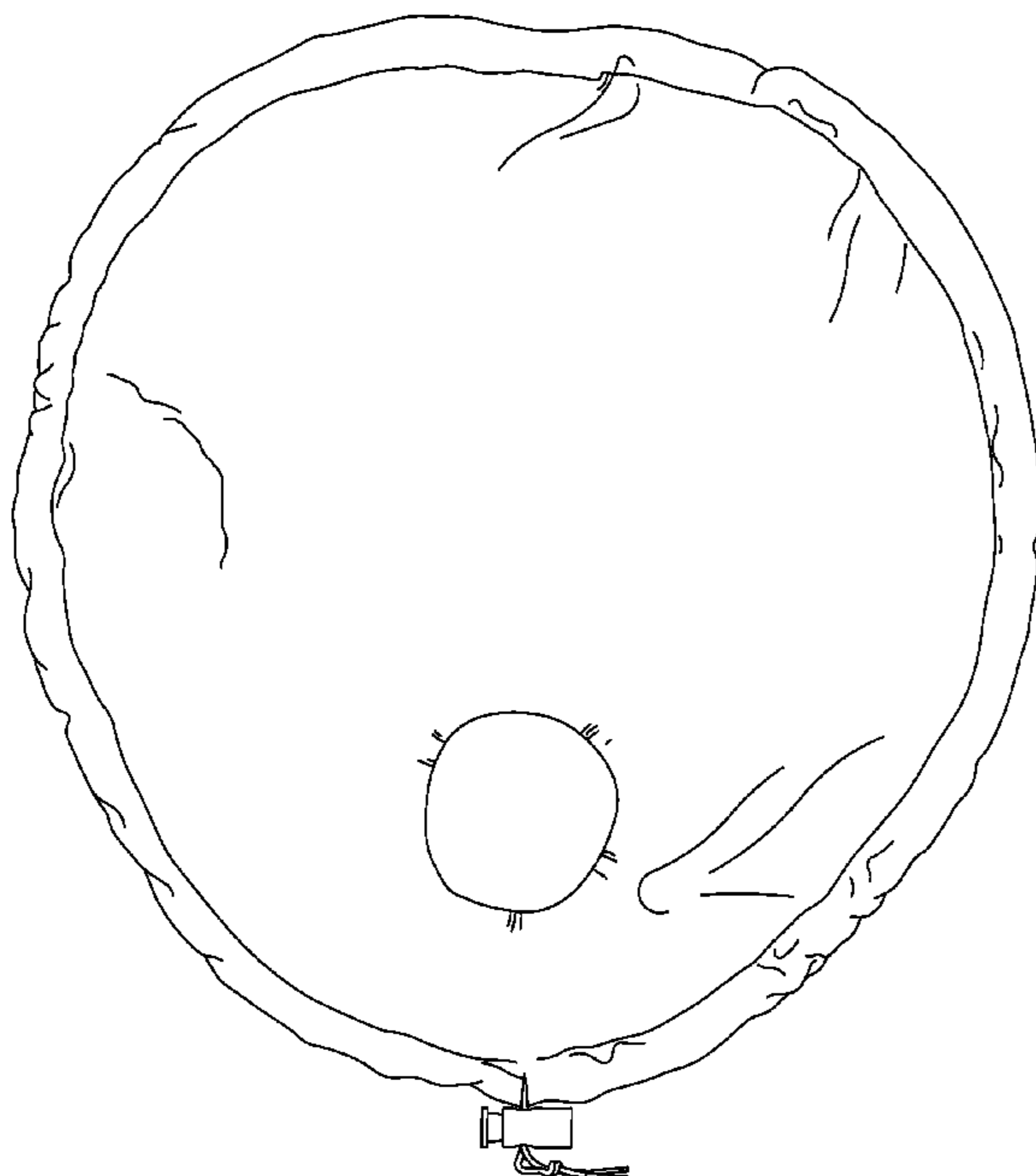
FIG. 2 is a right side view of the blackout mask cover with  
hole, the left side view being a mirror image thereof;

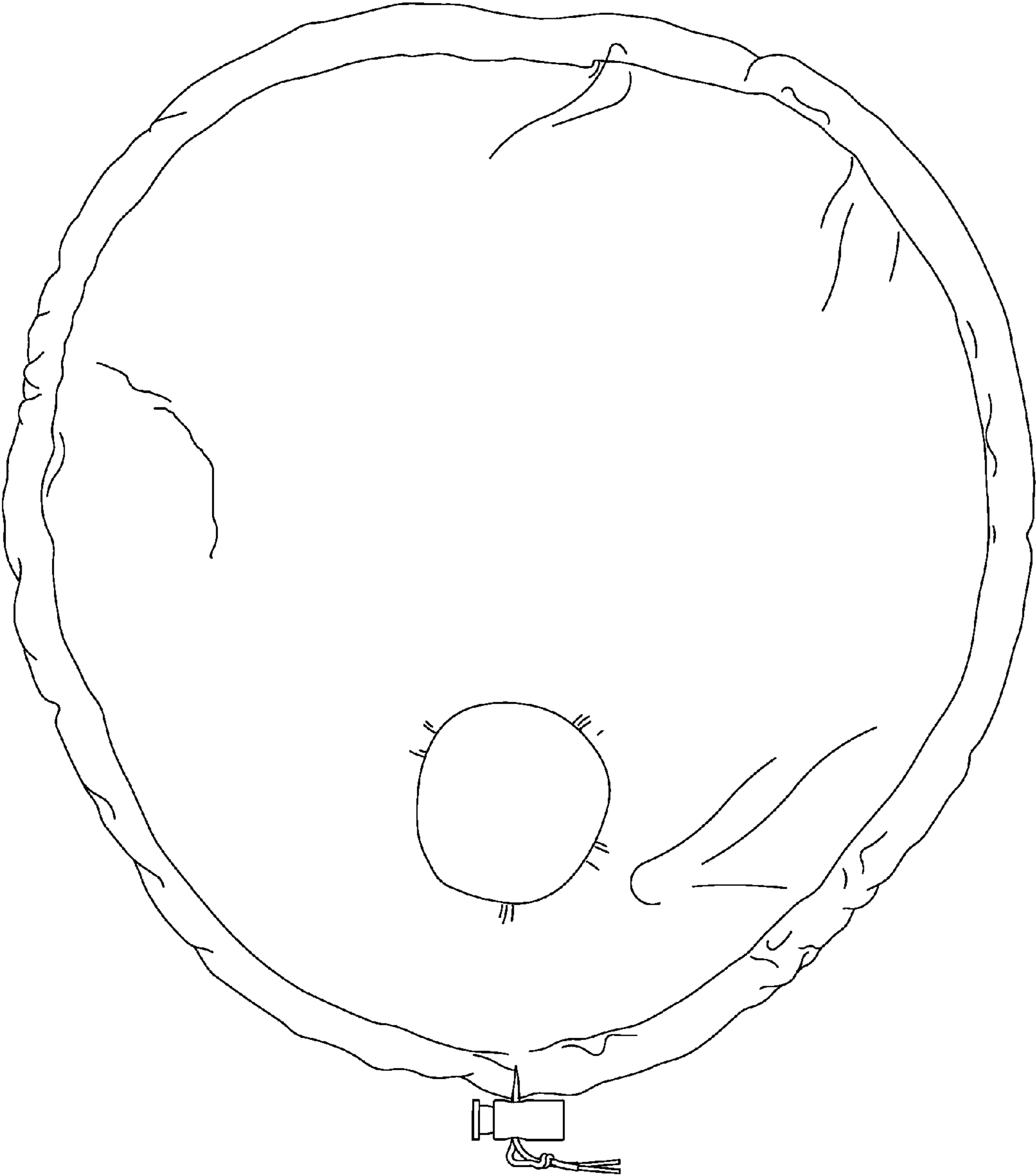
FIG. 3 is a top view of the blackout mask cover with hole;

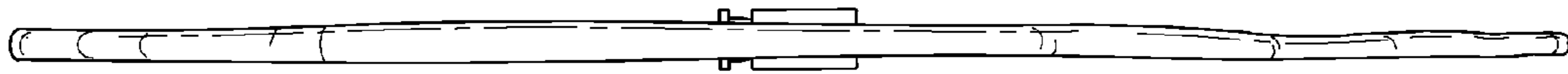
