(57) **CLAIM**

The ornamental design for a brassiere with interior pockets, as shown and described.

DESCRIPTION

FIG. 1 is a rear perspective view of a brassiere with interior pockets, showing our new design;

FIG. 2 is a further rear perspective view of the design shown in FIG. 1, showing more fully the hook-and-loop fastened pocket thereof;

FIG. 3 is a further rear perspective view of the design shown in FIG. 1, showing more fully the zipper-fastened pocket thereof;

FIG. 4 is a front elevation view of the design of FIGS. 1-3;

FIG. 5 is a rear elevation view thereof;

FIG. 6 is a left side elevation view thereof, with a right side view being a mirror image;

FIG. 7 is a top plan view thereof; and,

FIG. 8 is a bottom plan view thereof.

The broken line showing of brassiere straps is for the purpose of illustrating environmental structure and forms no part of the claimed design.

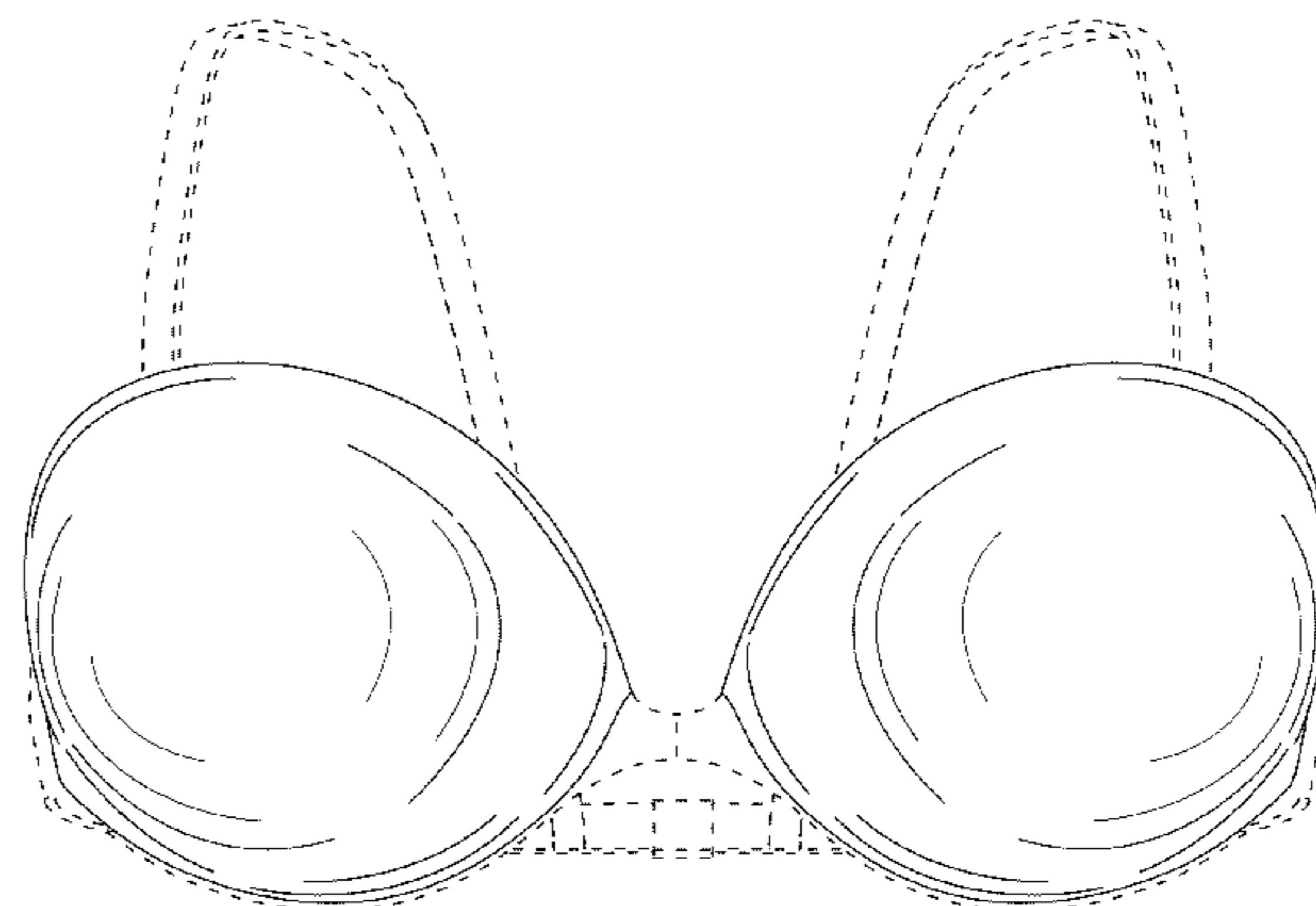

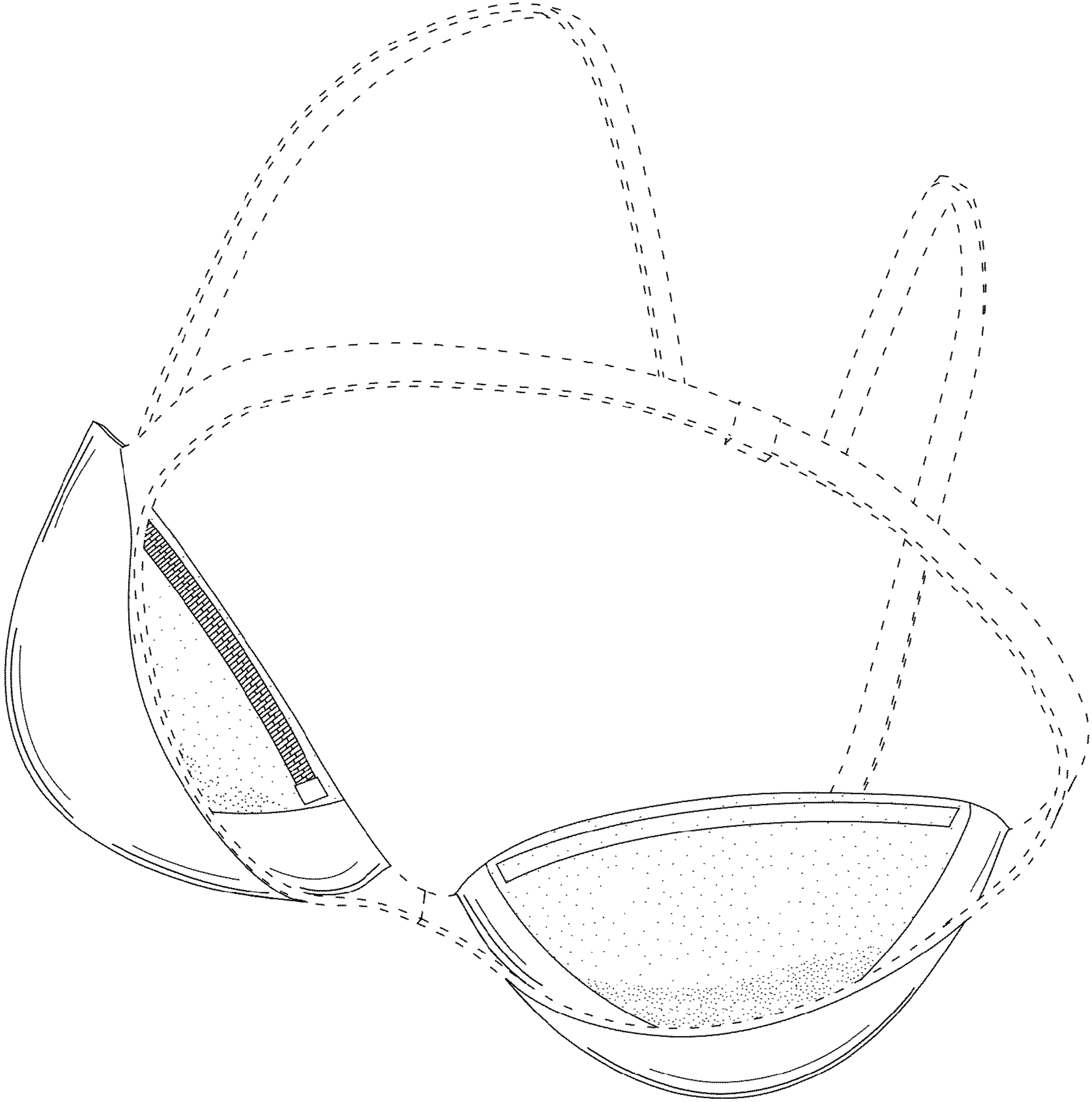

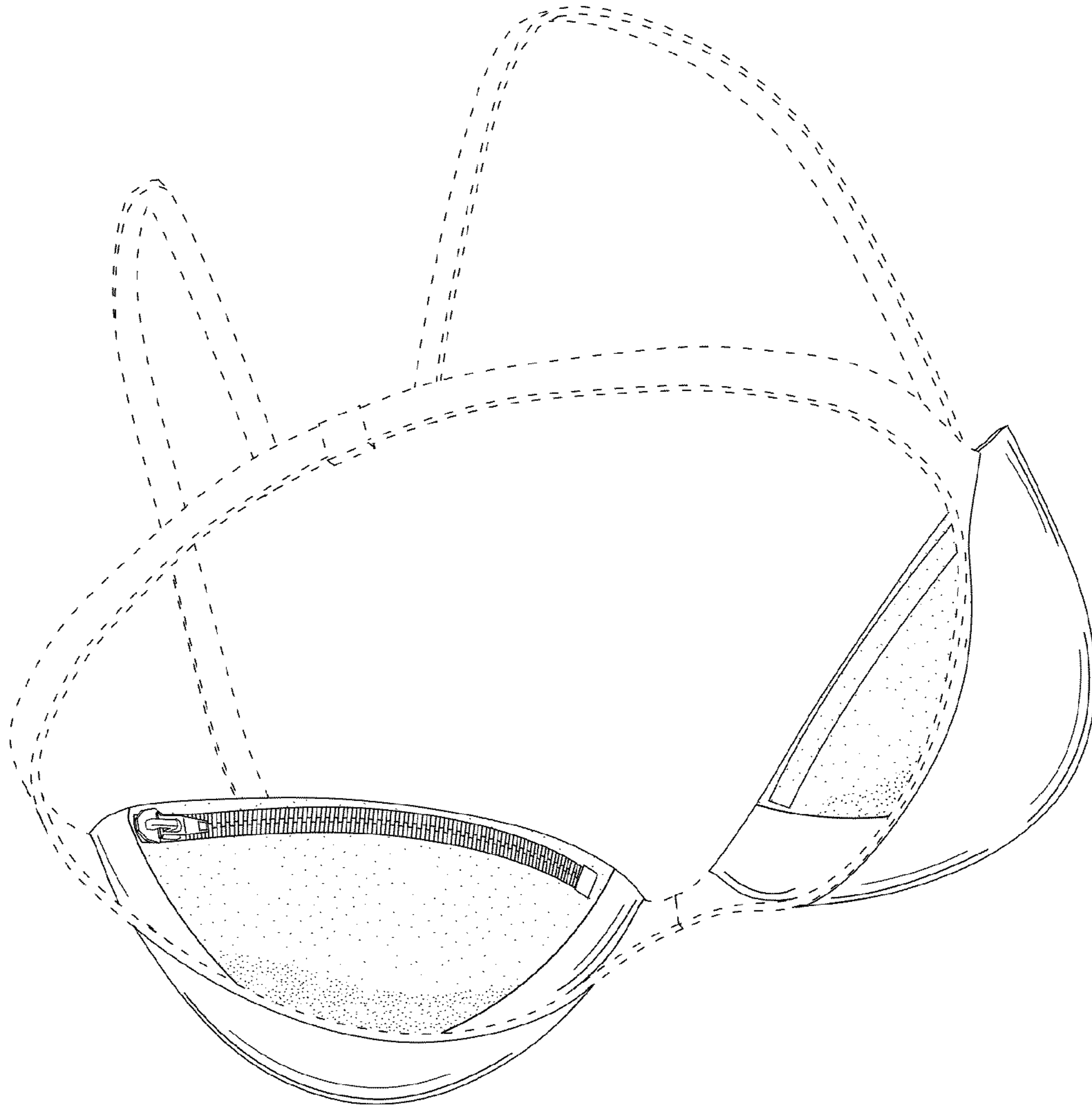

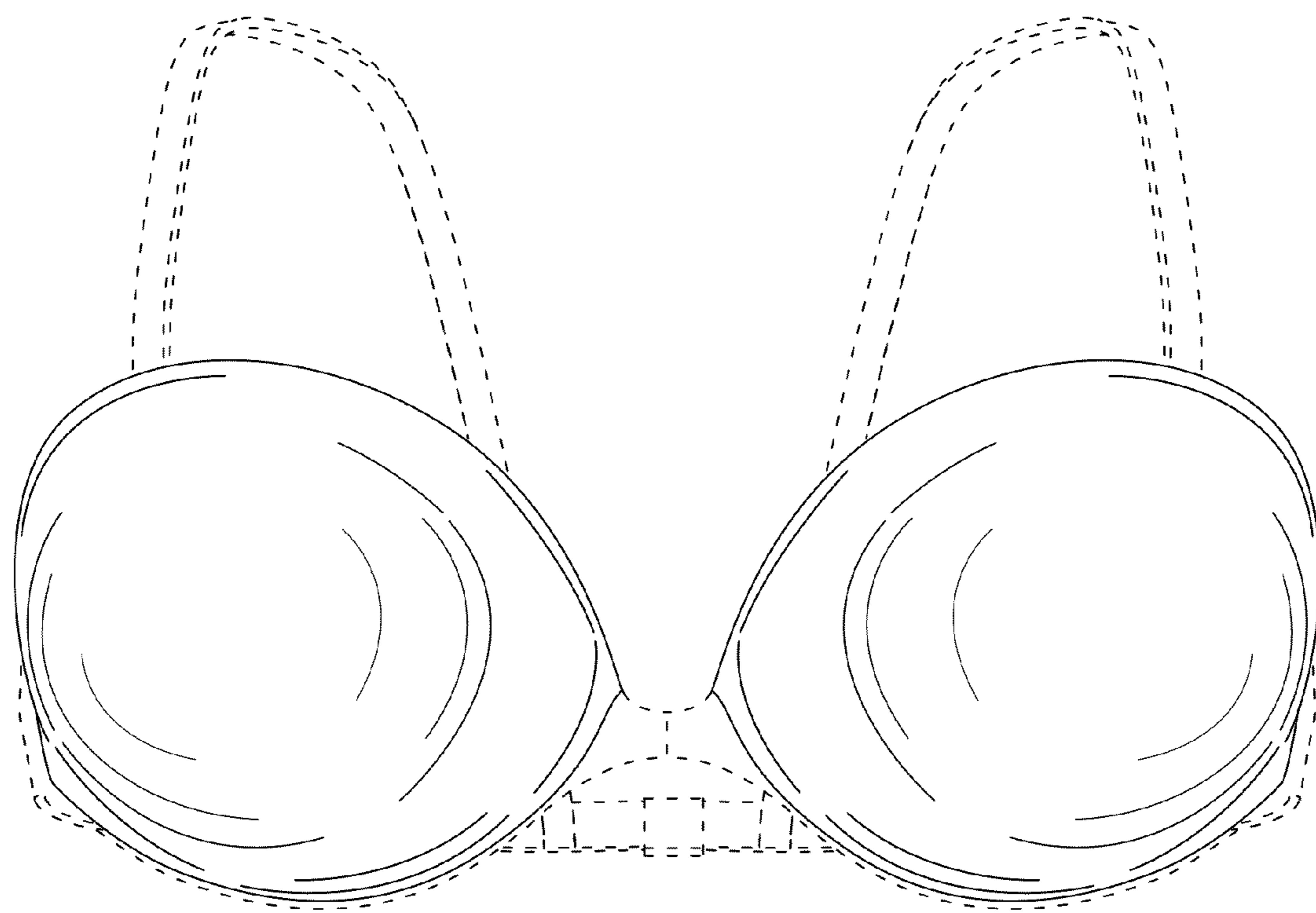

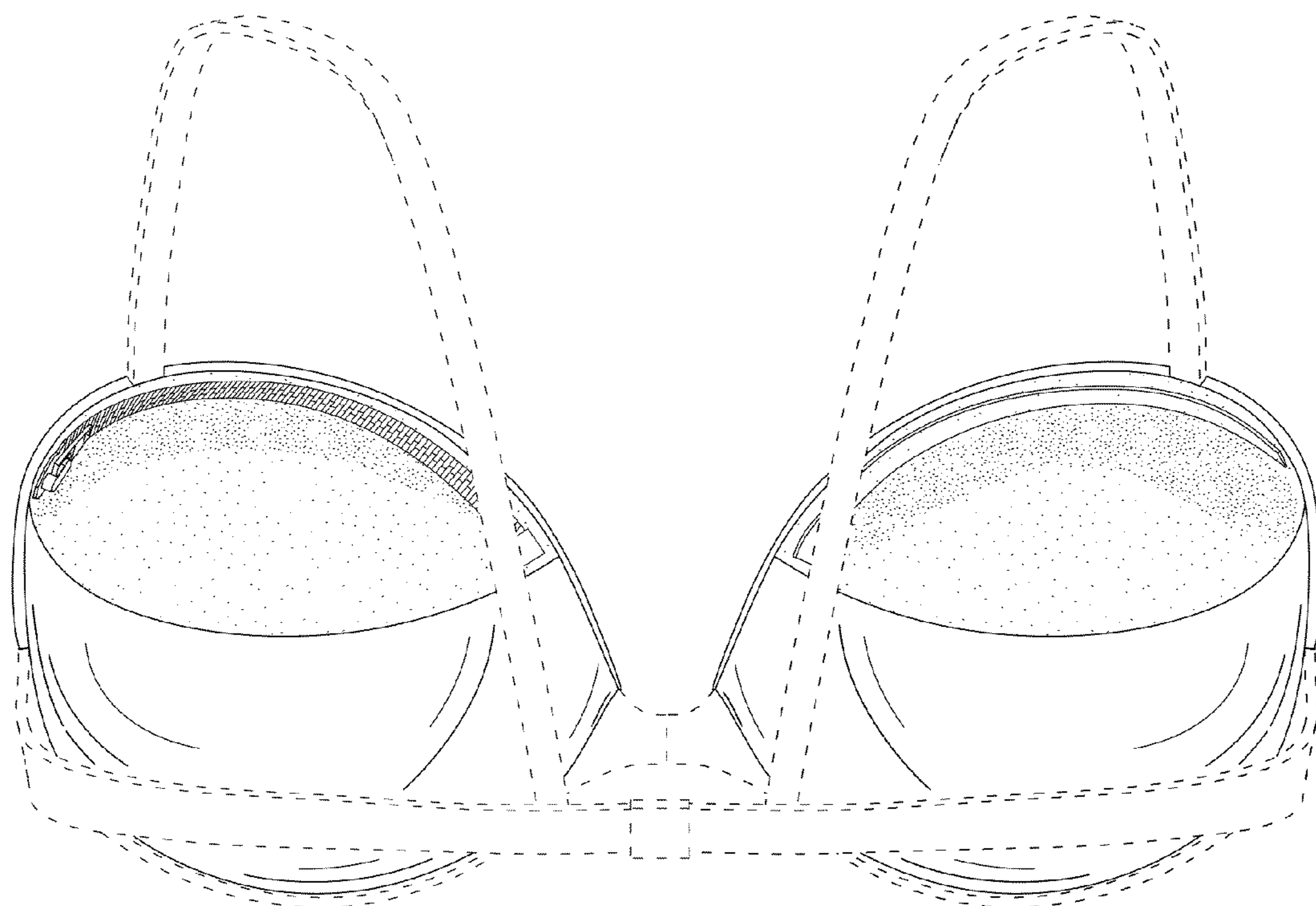

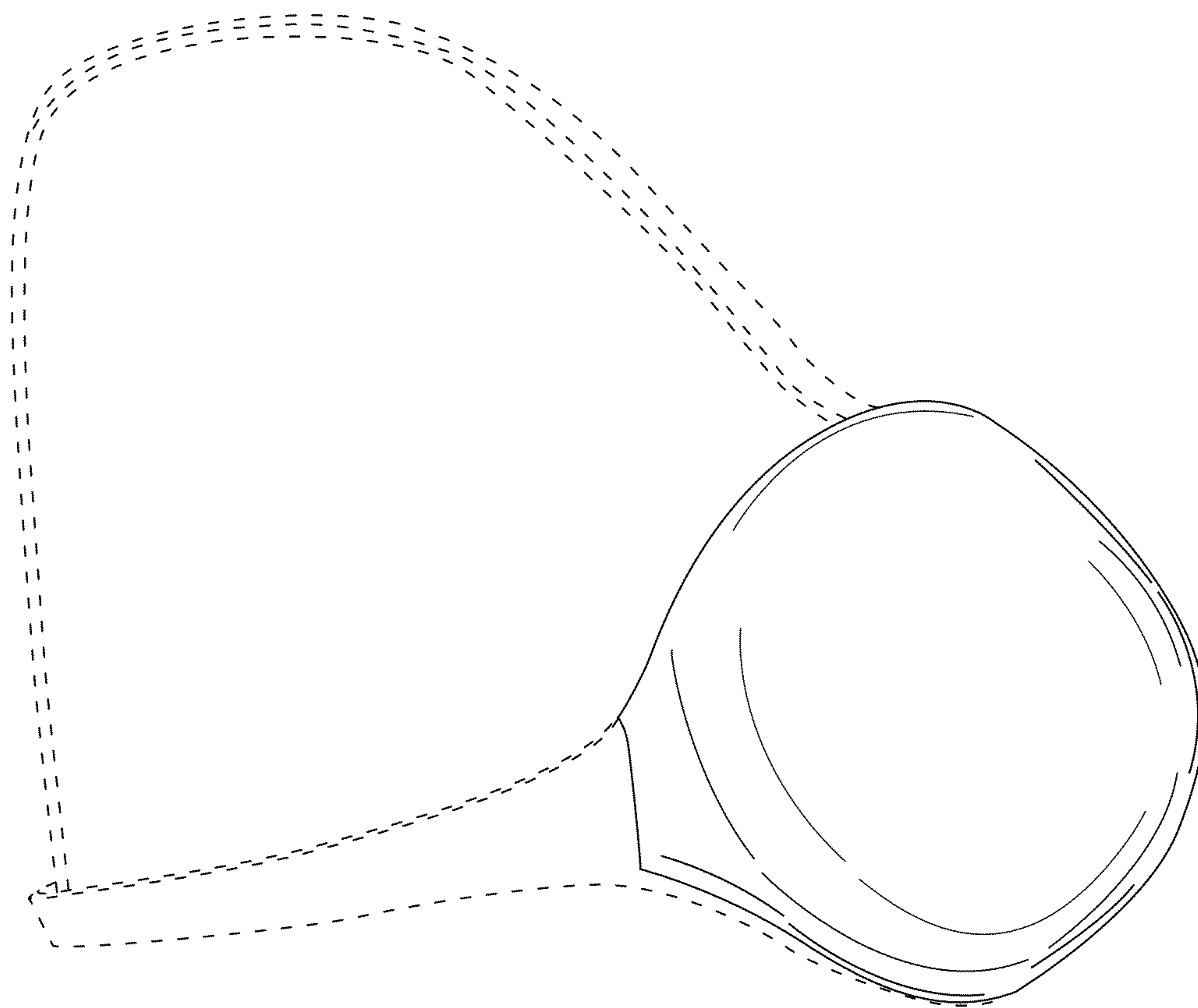

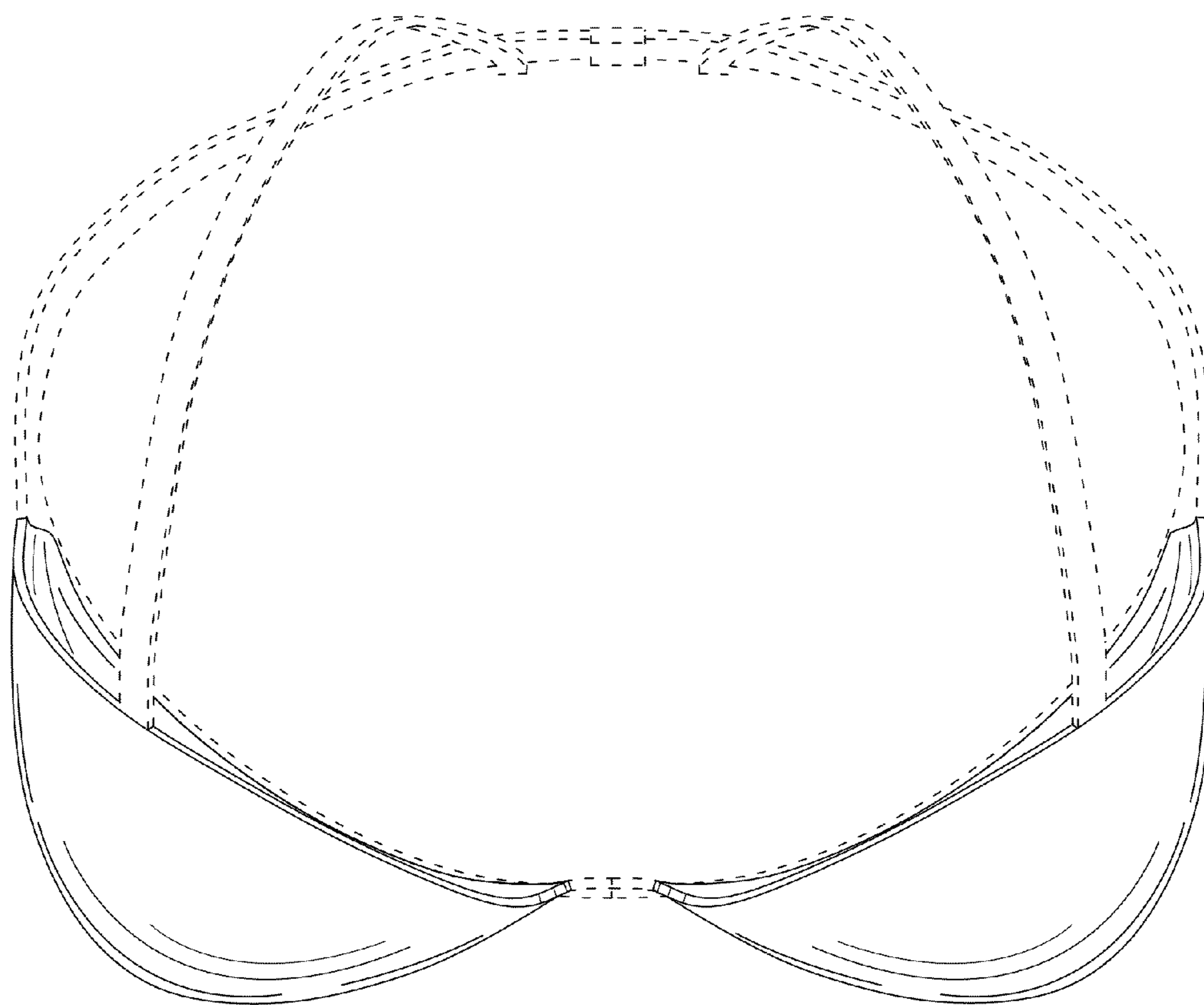

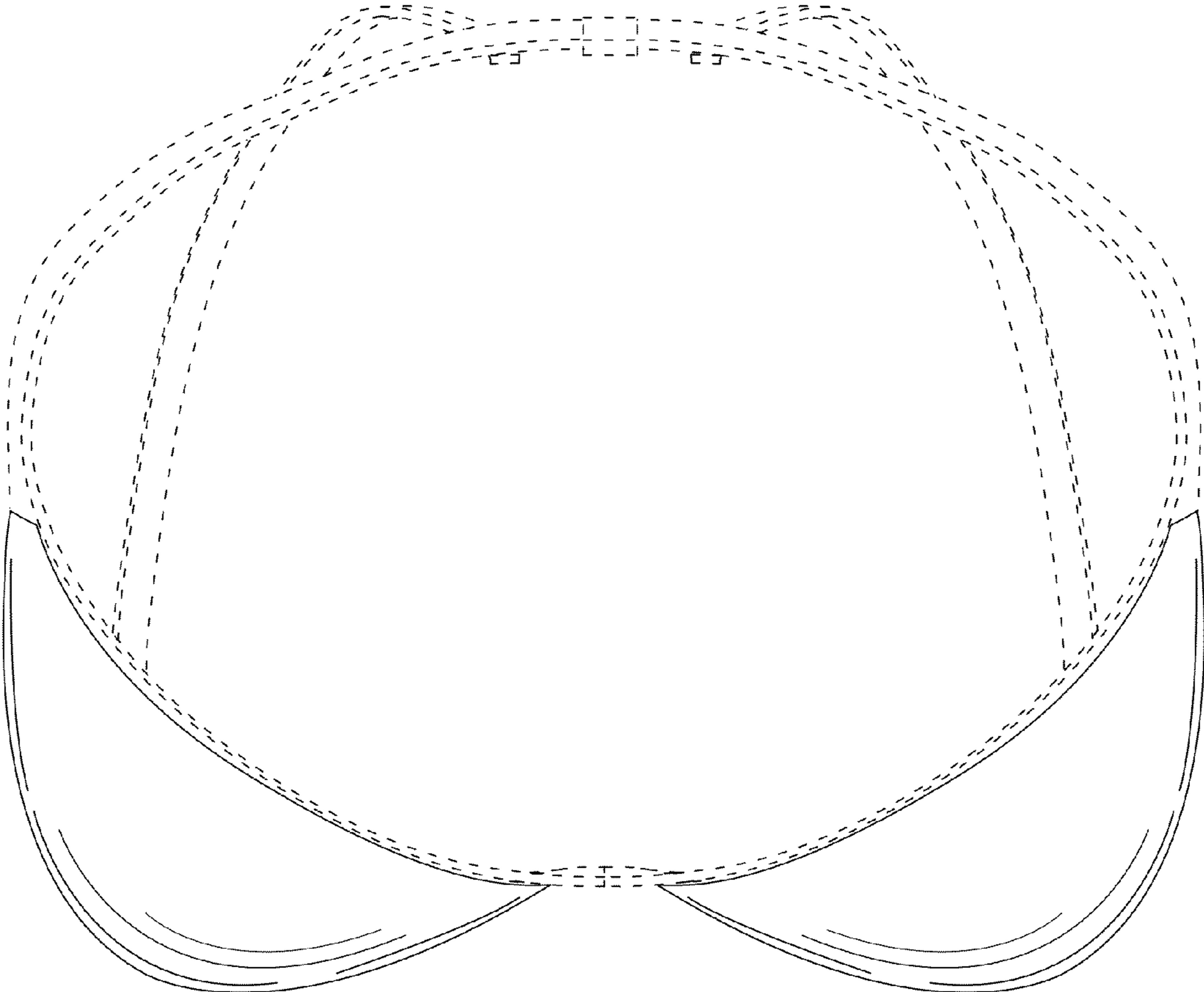
