DESCRIPTION

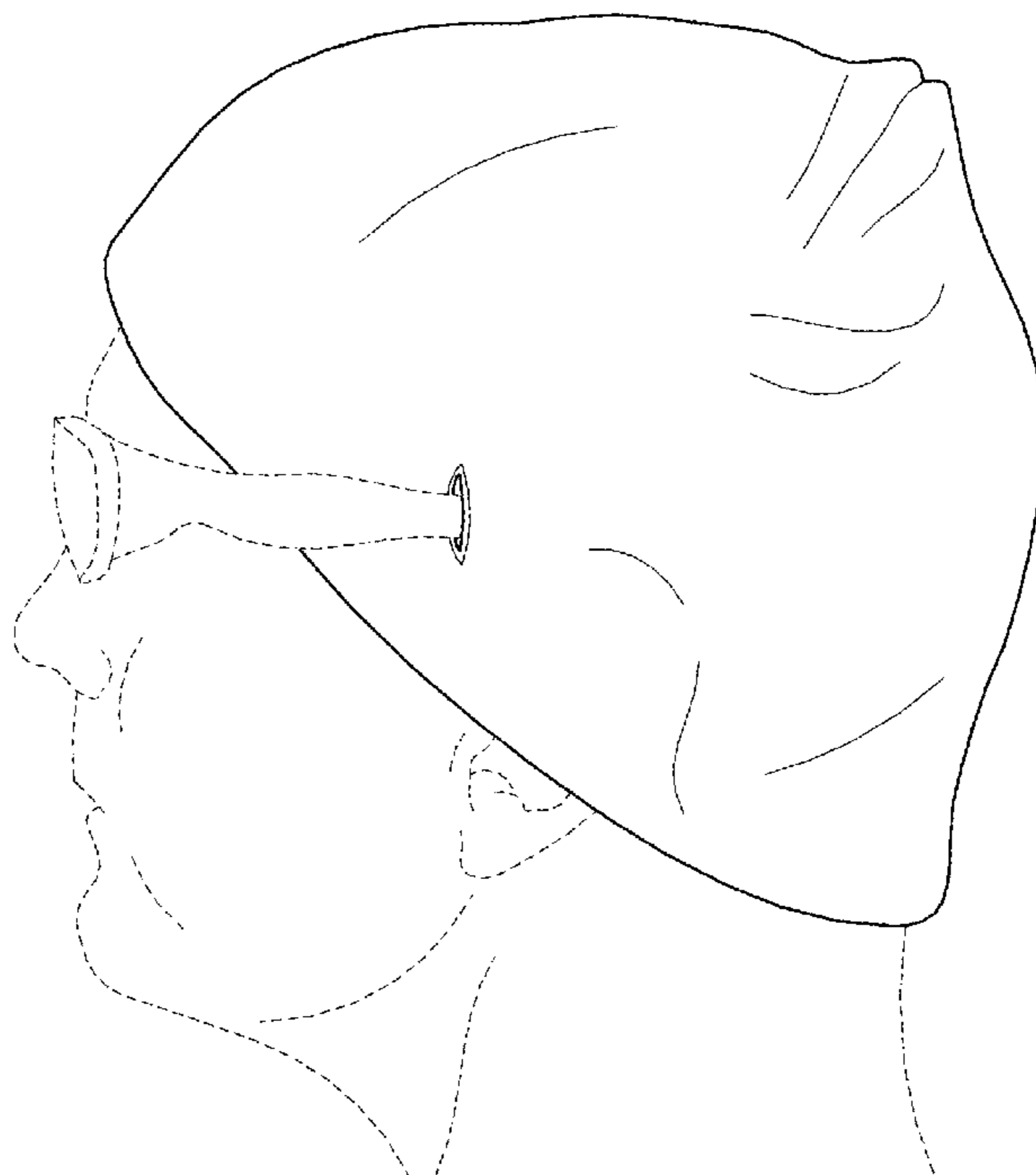
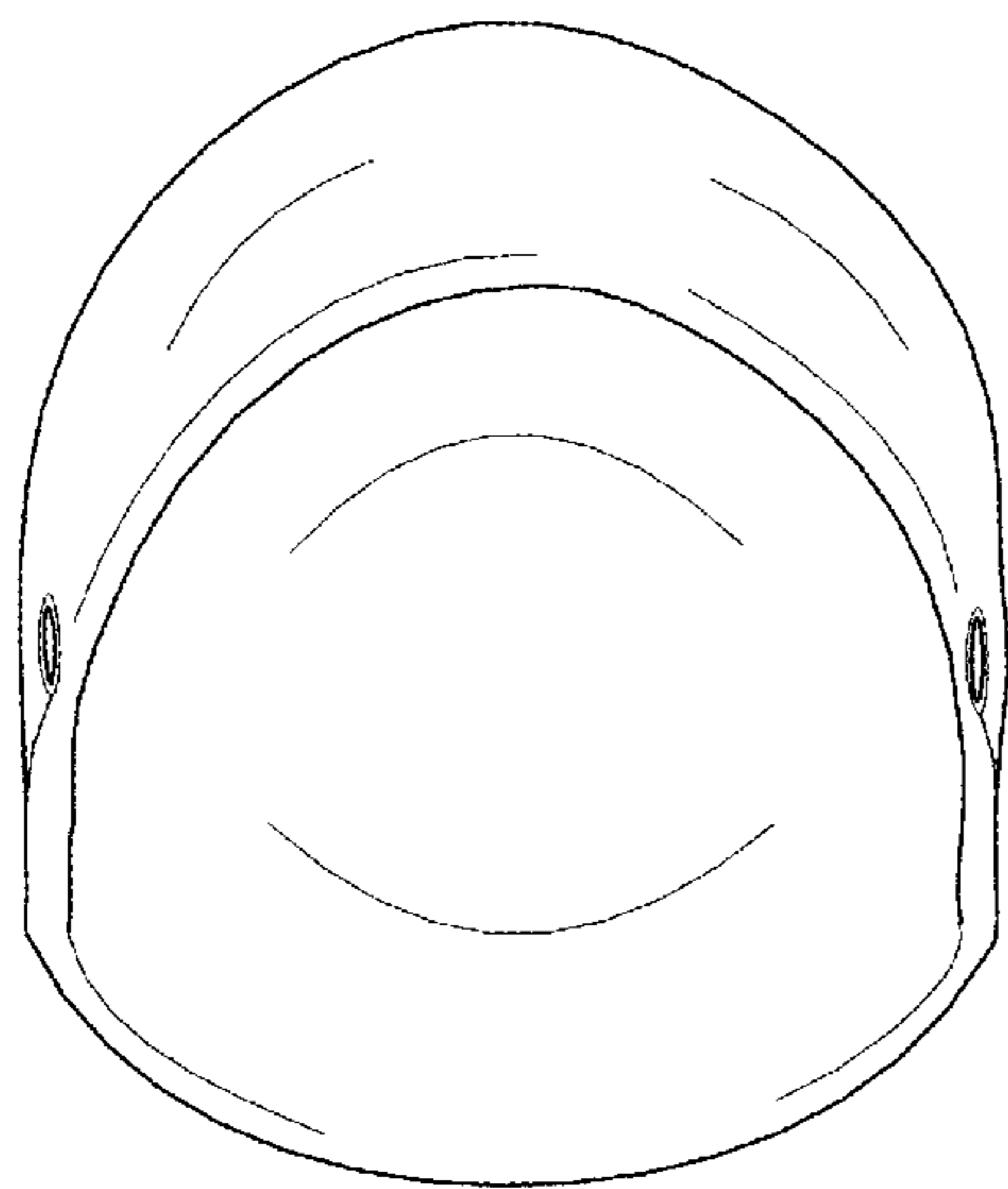

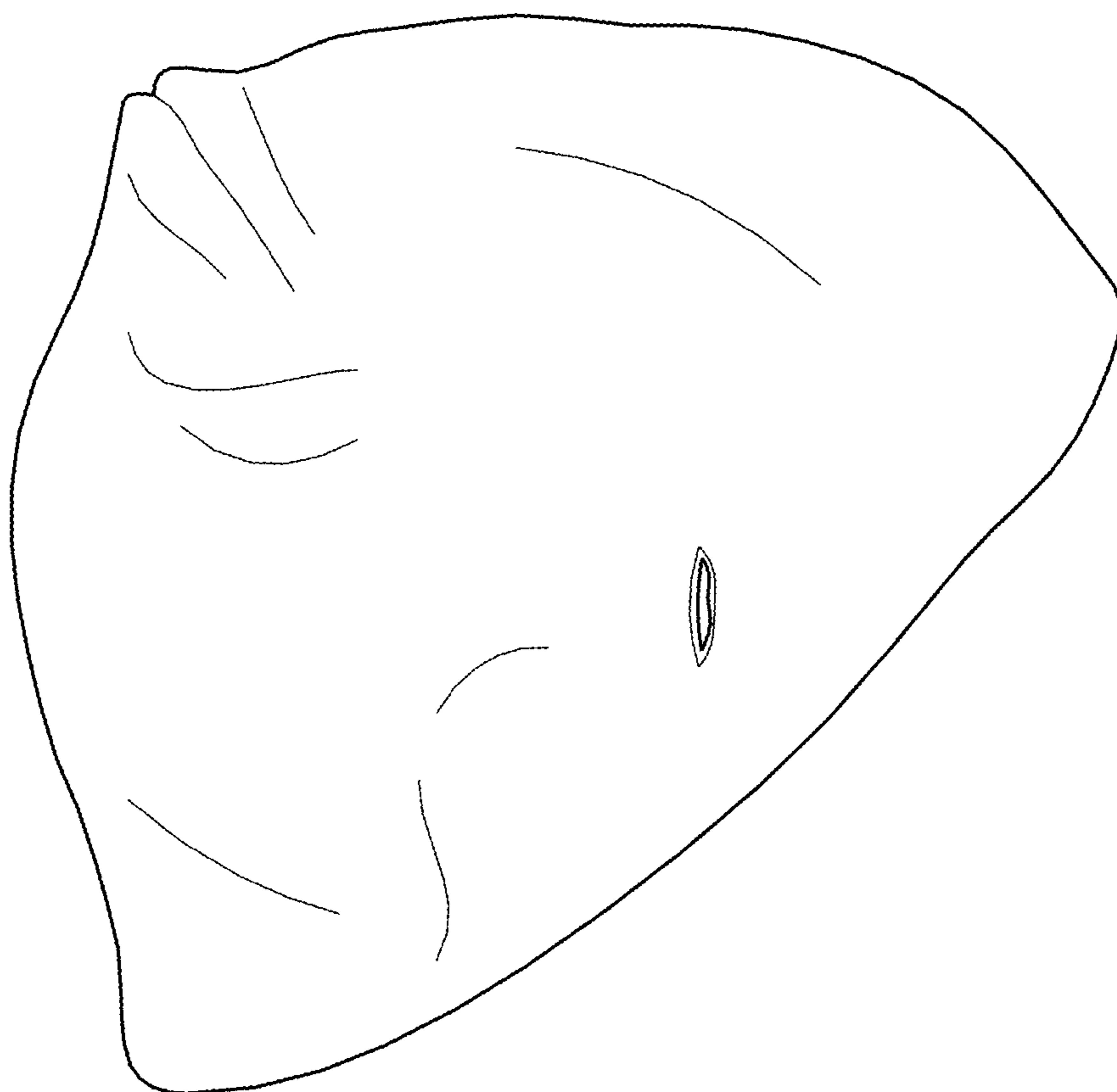

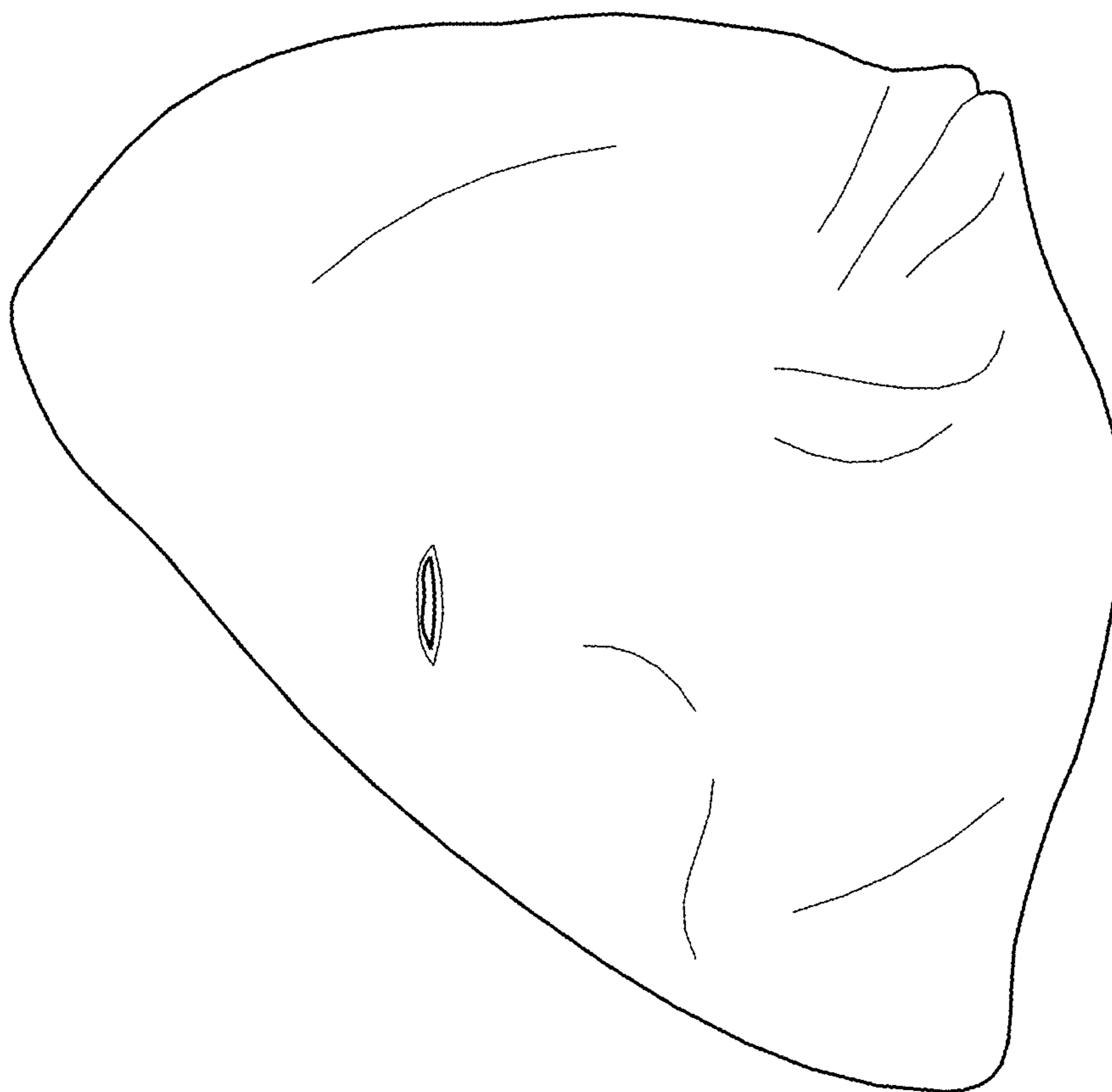

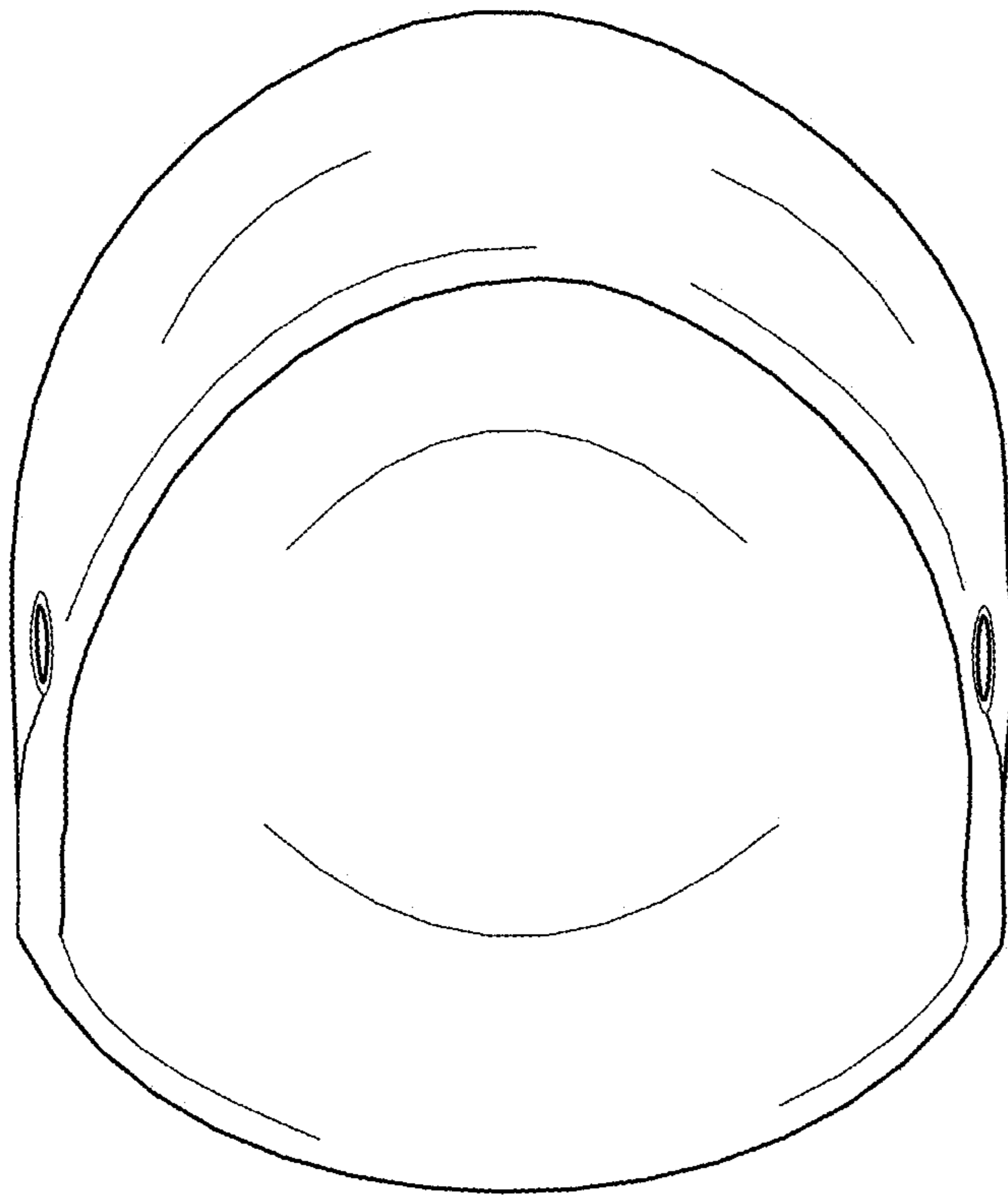

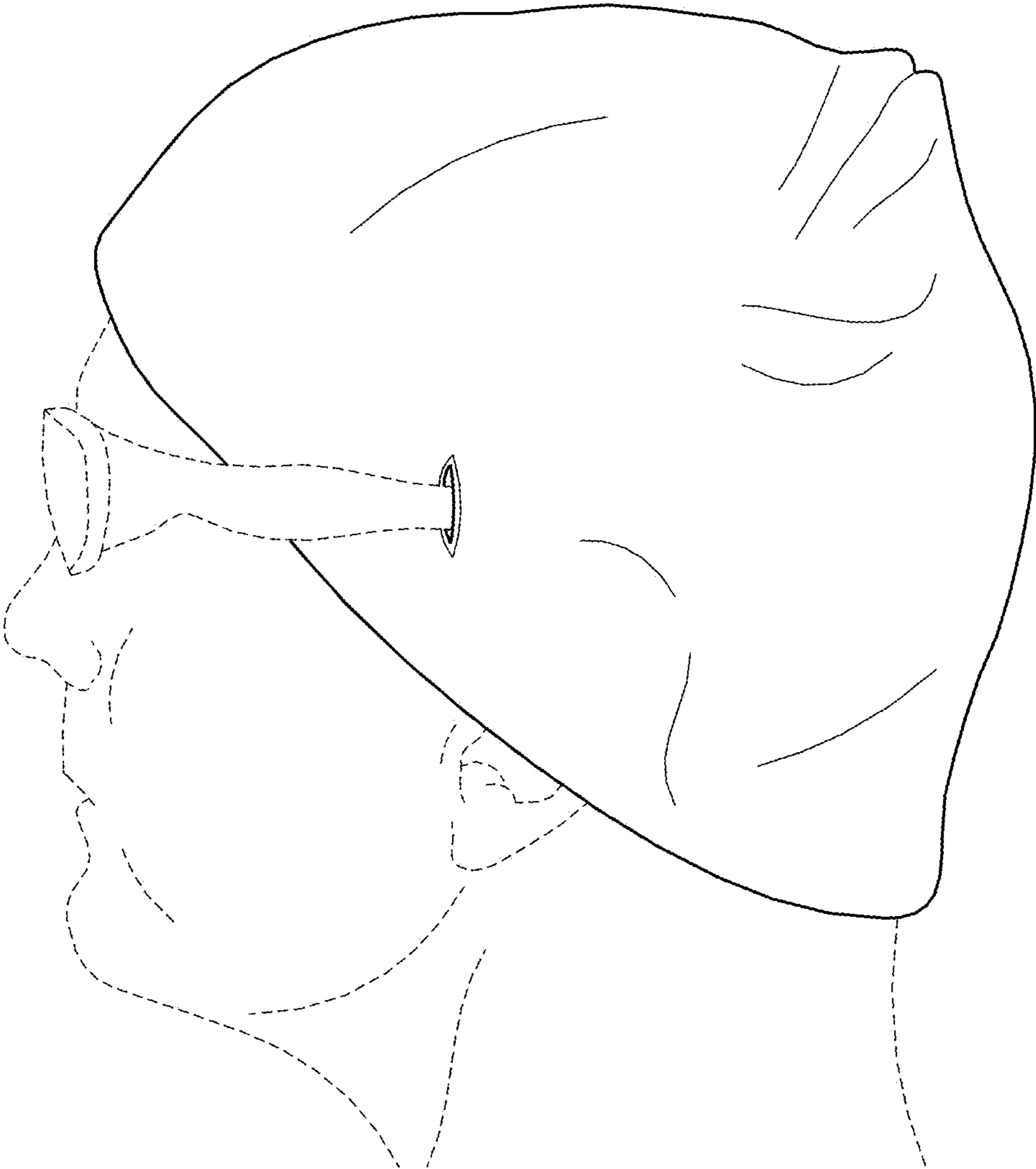

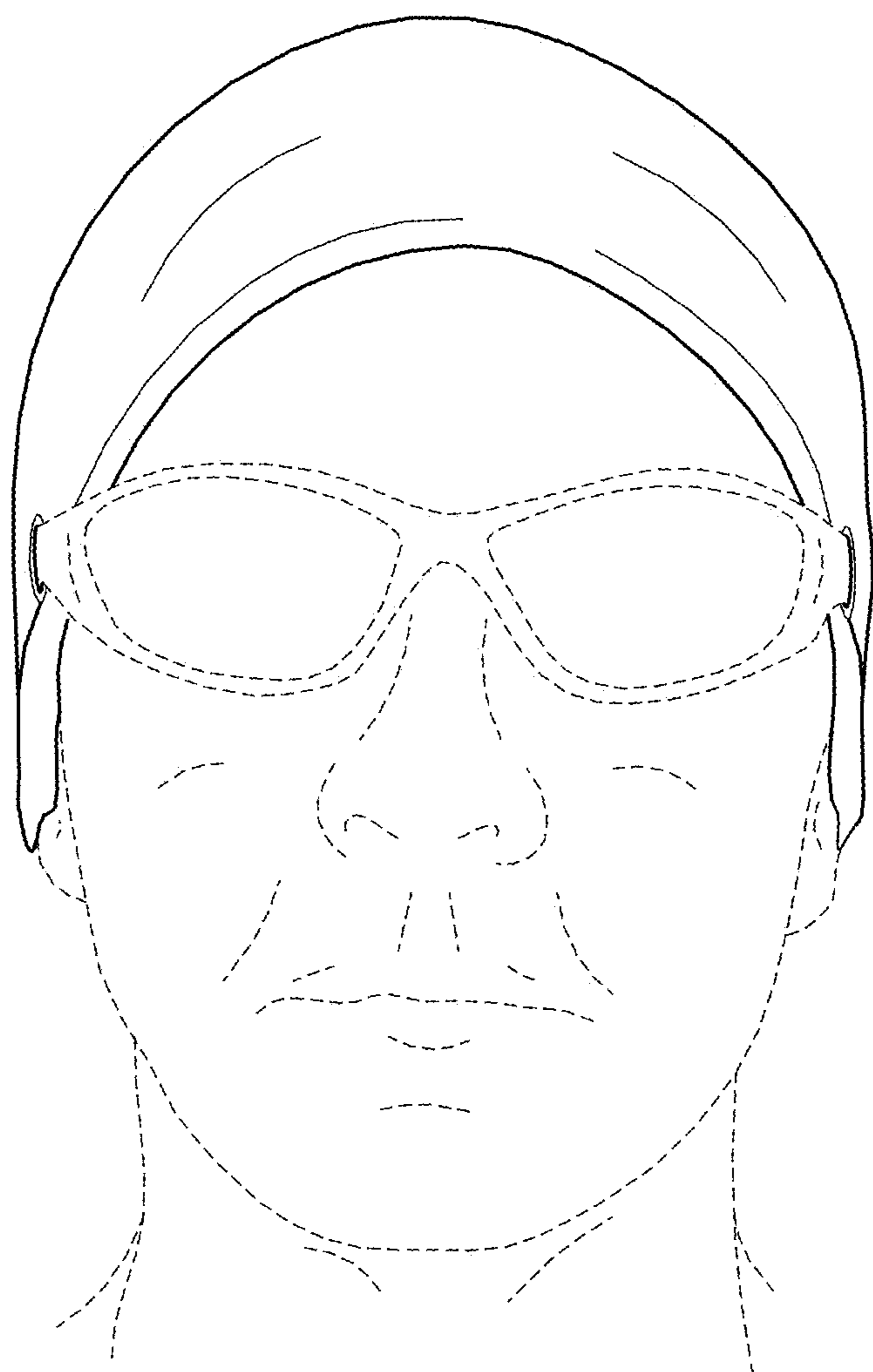
