(57) **CLAIM**

We claim the ornamental design for a combination carrying pack and blanket and pillow, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a combination carrying pack and blanket and pillow, showing the new design in an extended blanket and pillow configuration; FIG. 2 is a rear elevational view thereof, illustrated in a carrying pack configuration; FIG. 3 is a front elevational view of FIG. 2; FIG. 4 is a left-side elevational view of FIG. 2; FIG. 5 is a right-side elevational view of FIG. 2; FIG. 6 is a top plan view of FIG. 2; FIG. 7 is a bottom plan view of FIG. 2; FIG. 8 is a rear elevational view thereof, illustrated in the extended blanket and pillow configuration; FIG. 9 is a front elevational view of FIG. 8; FIG. 10 is a left-side elevational view of FIG. 8; FIG. 11 is a right-side elevational view of FIG. 8; FIG. 12 is a top plan view of FIG. 8; and, FIG. 13 is a bottom plan view of FIG. 8.

The broken lines showing a child in FIG. 1 are included for the purpose of illustrating the invention in use, and form no part of the claimed design. The broken lines showing a plush bear's head in FIGS. 1, 3-7, 9-13, and a plush bear's tail in FIGS. 8-11 and 13 are environmental matter, and form no part of the claimed design.

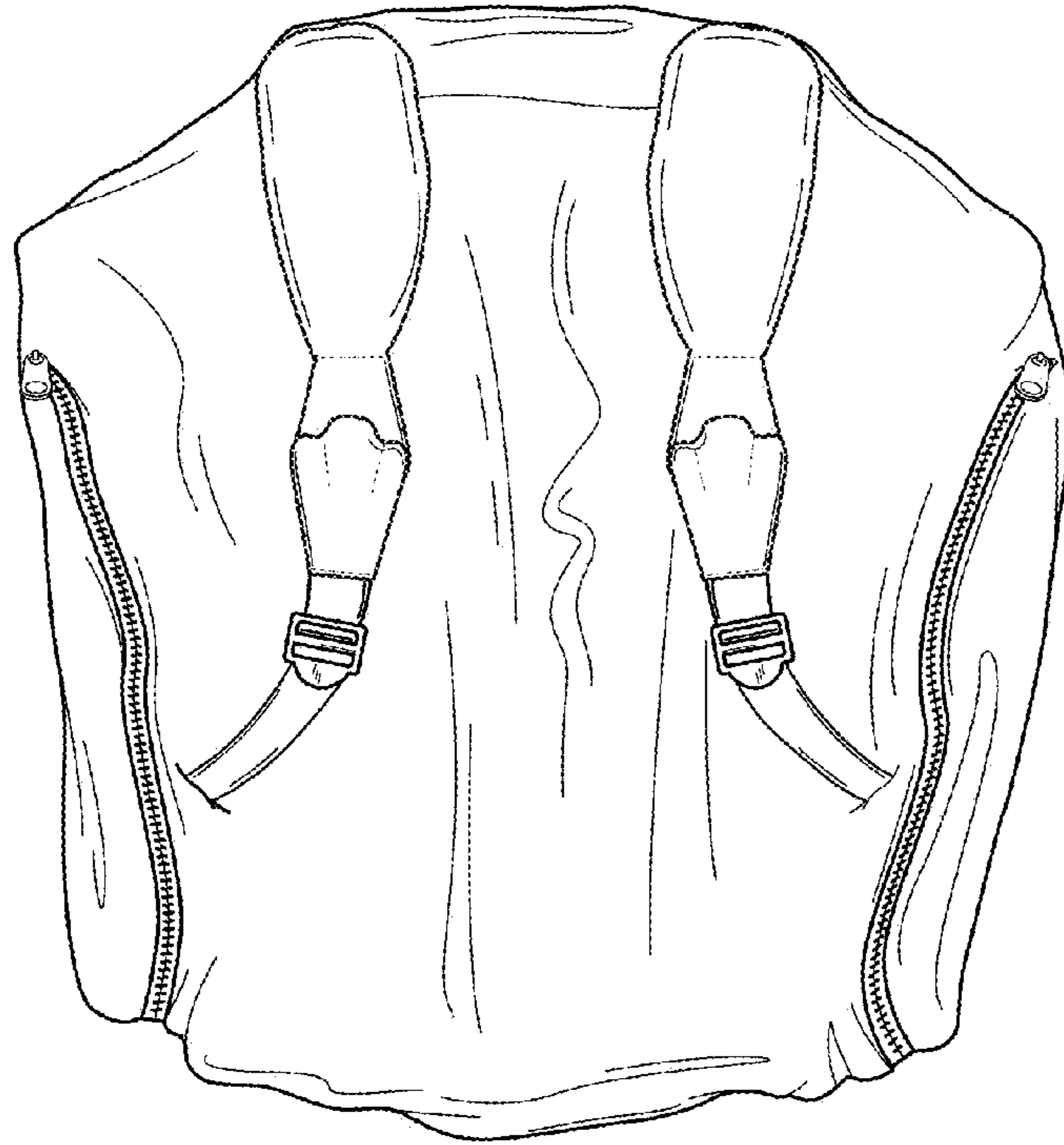

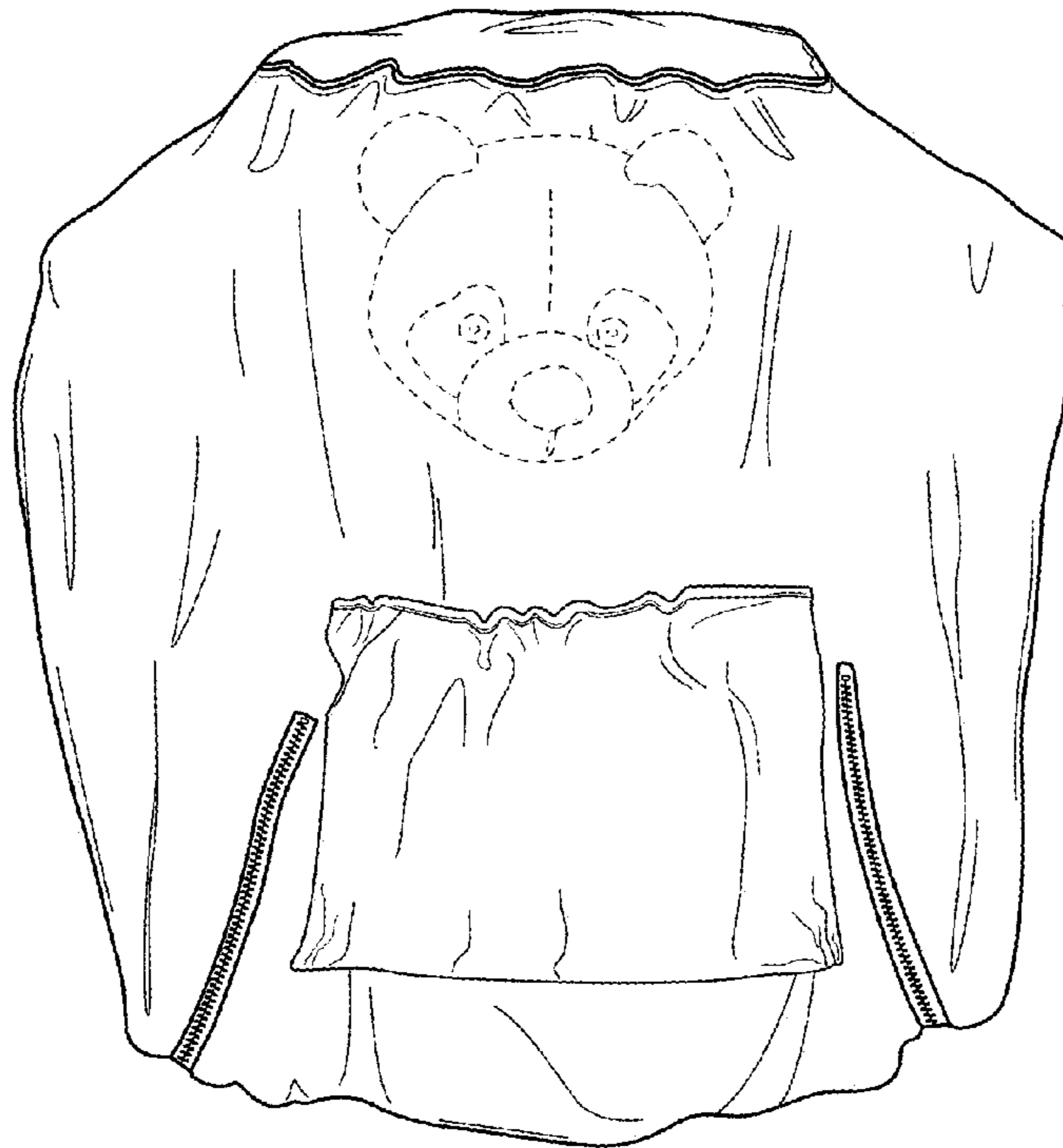

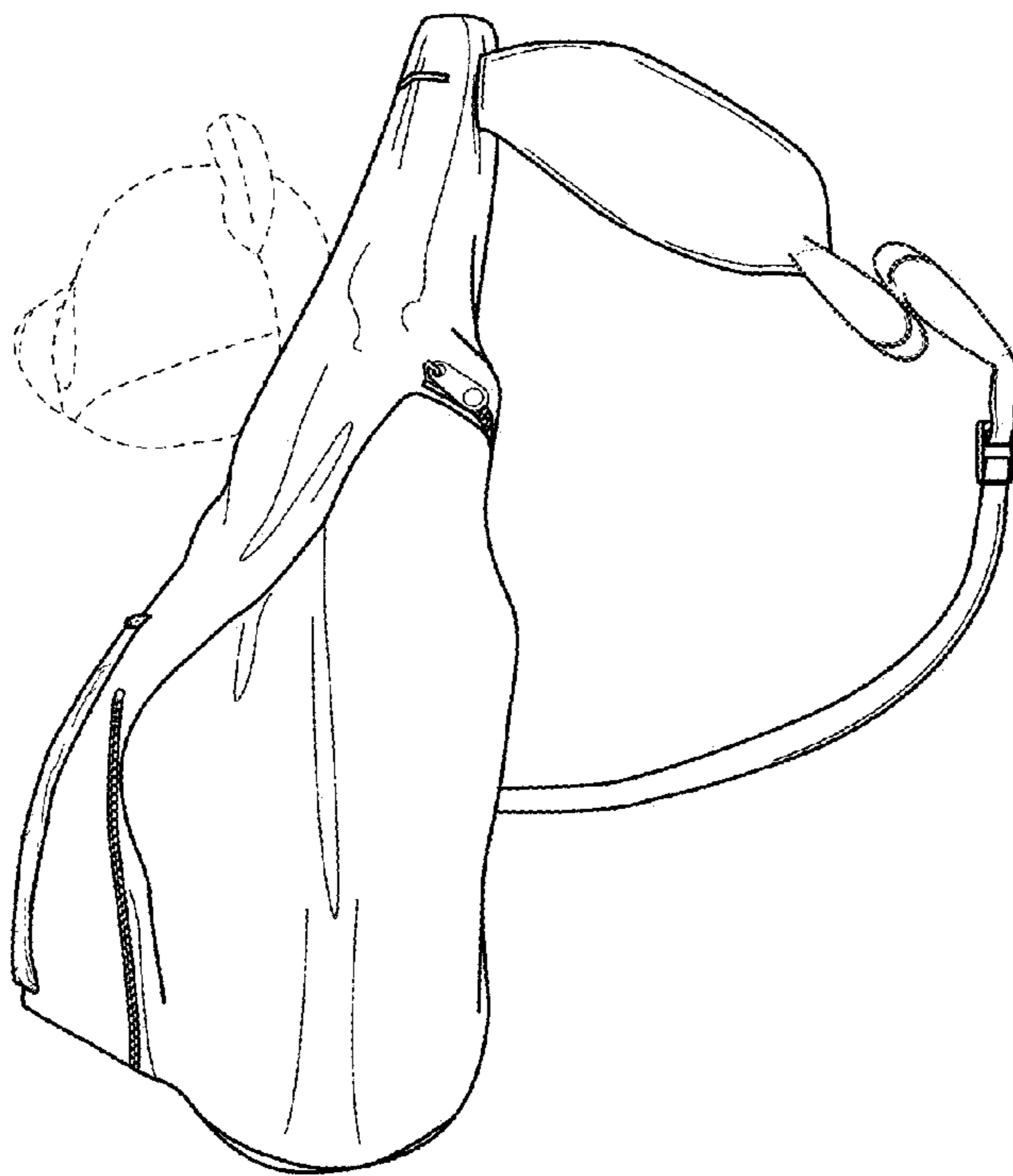

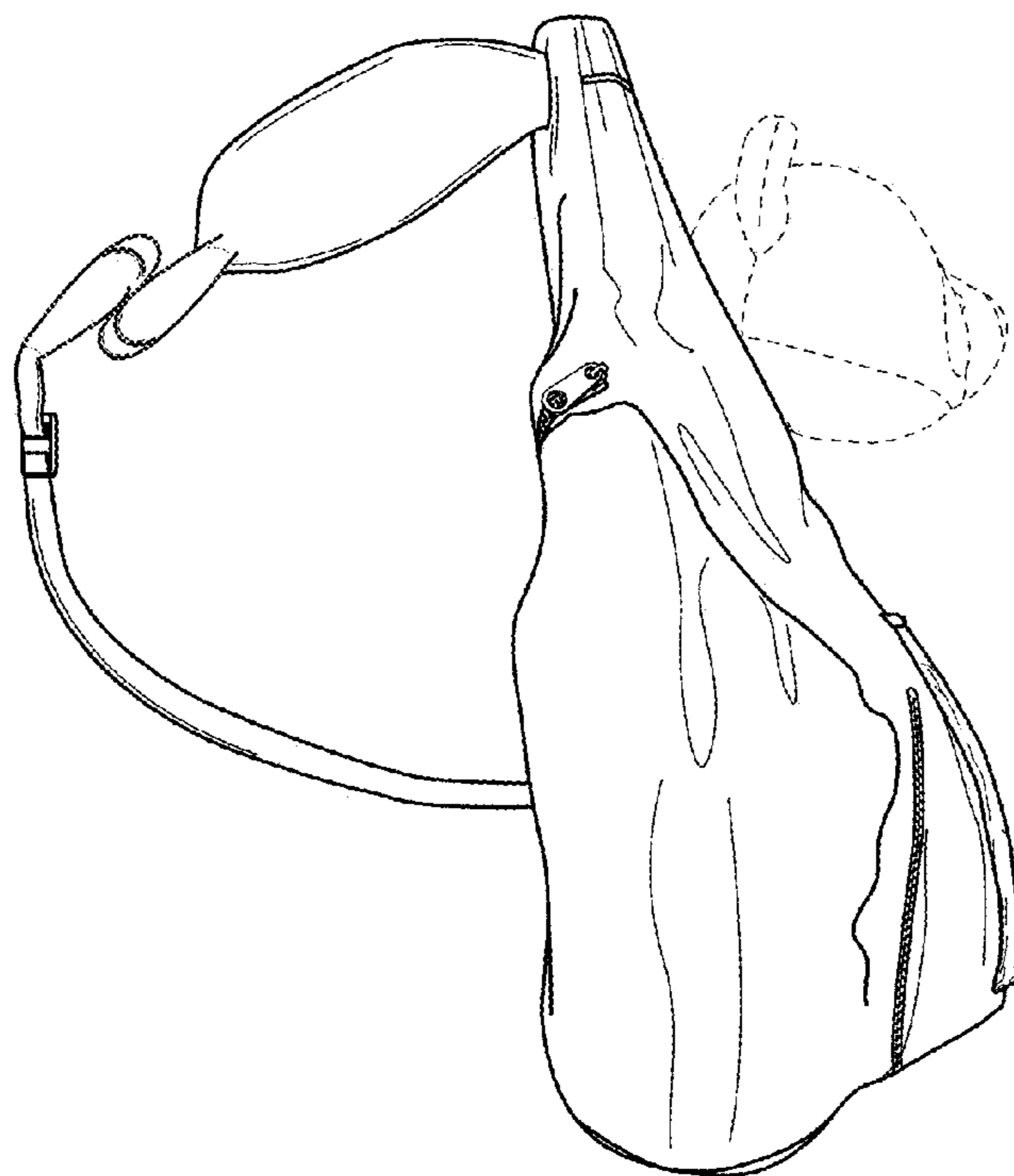

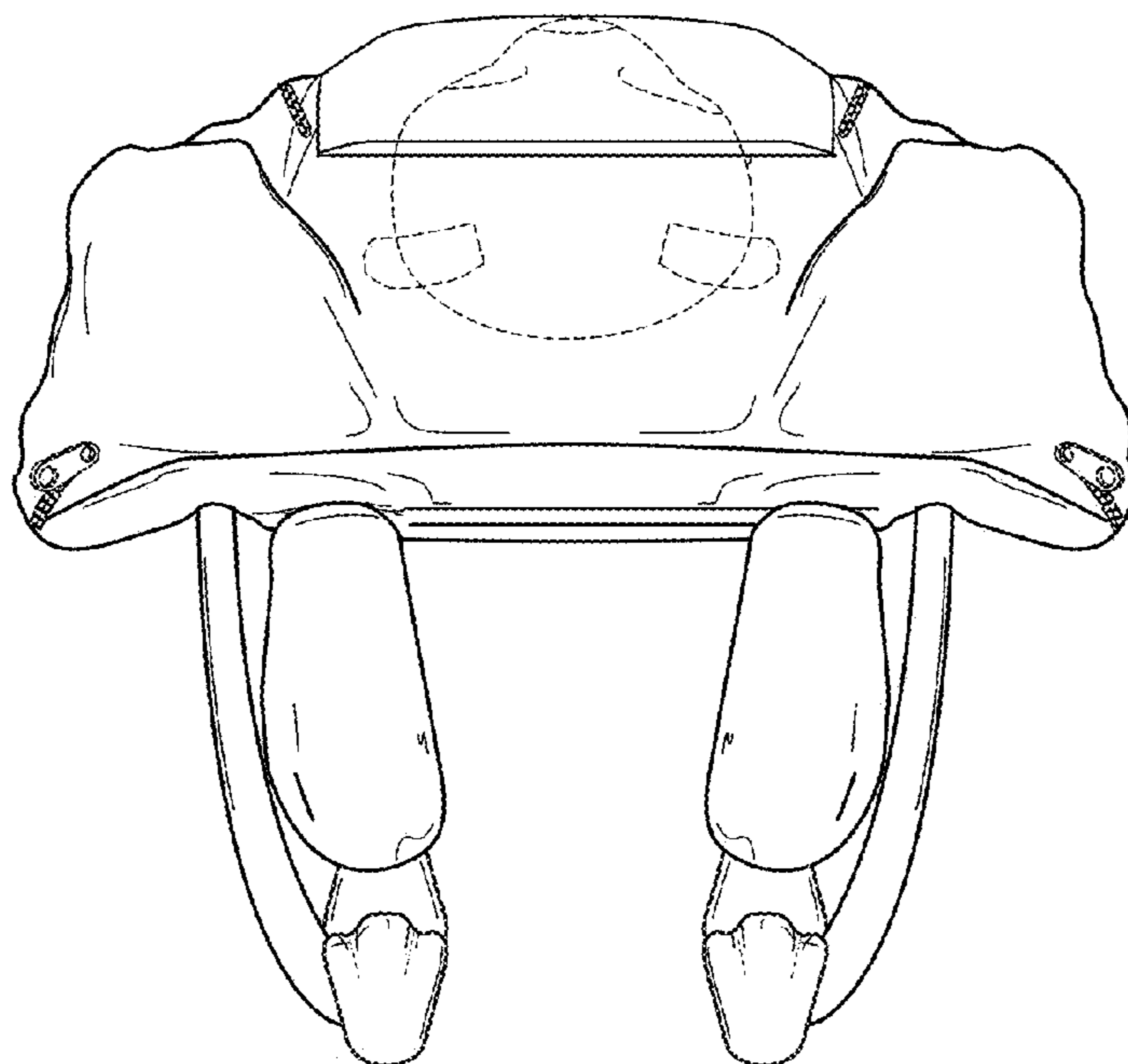

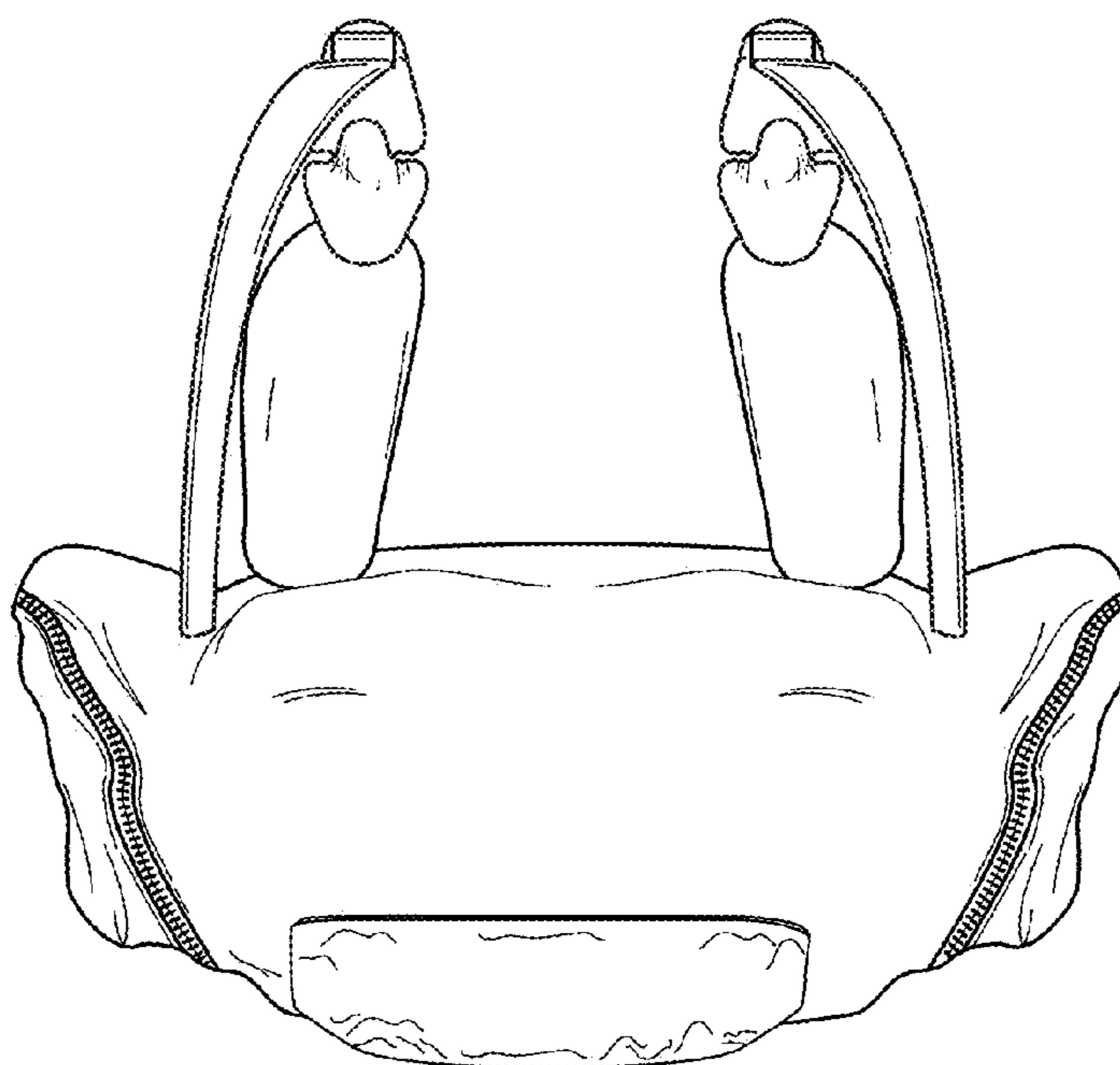

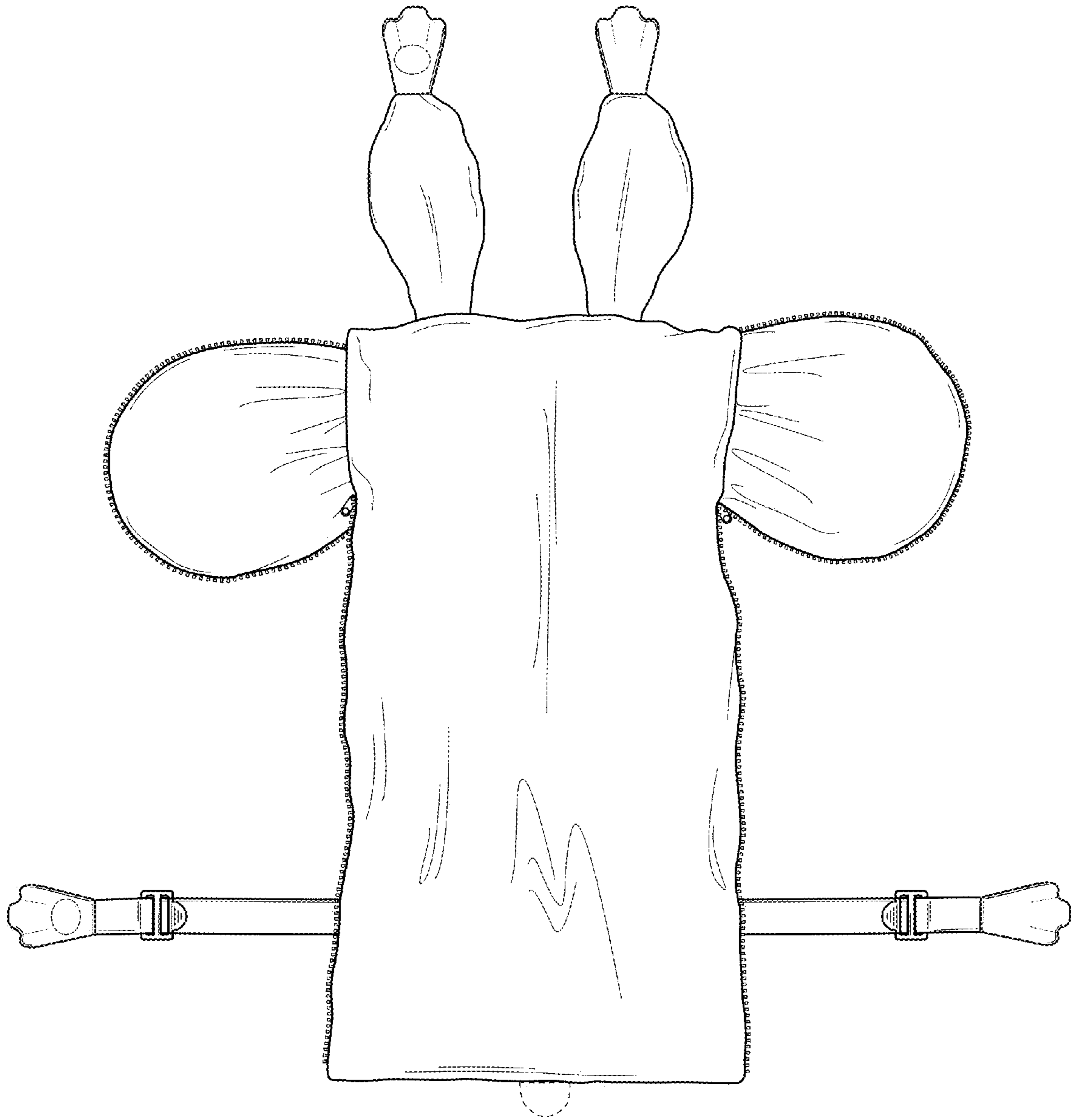

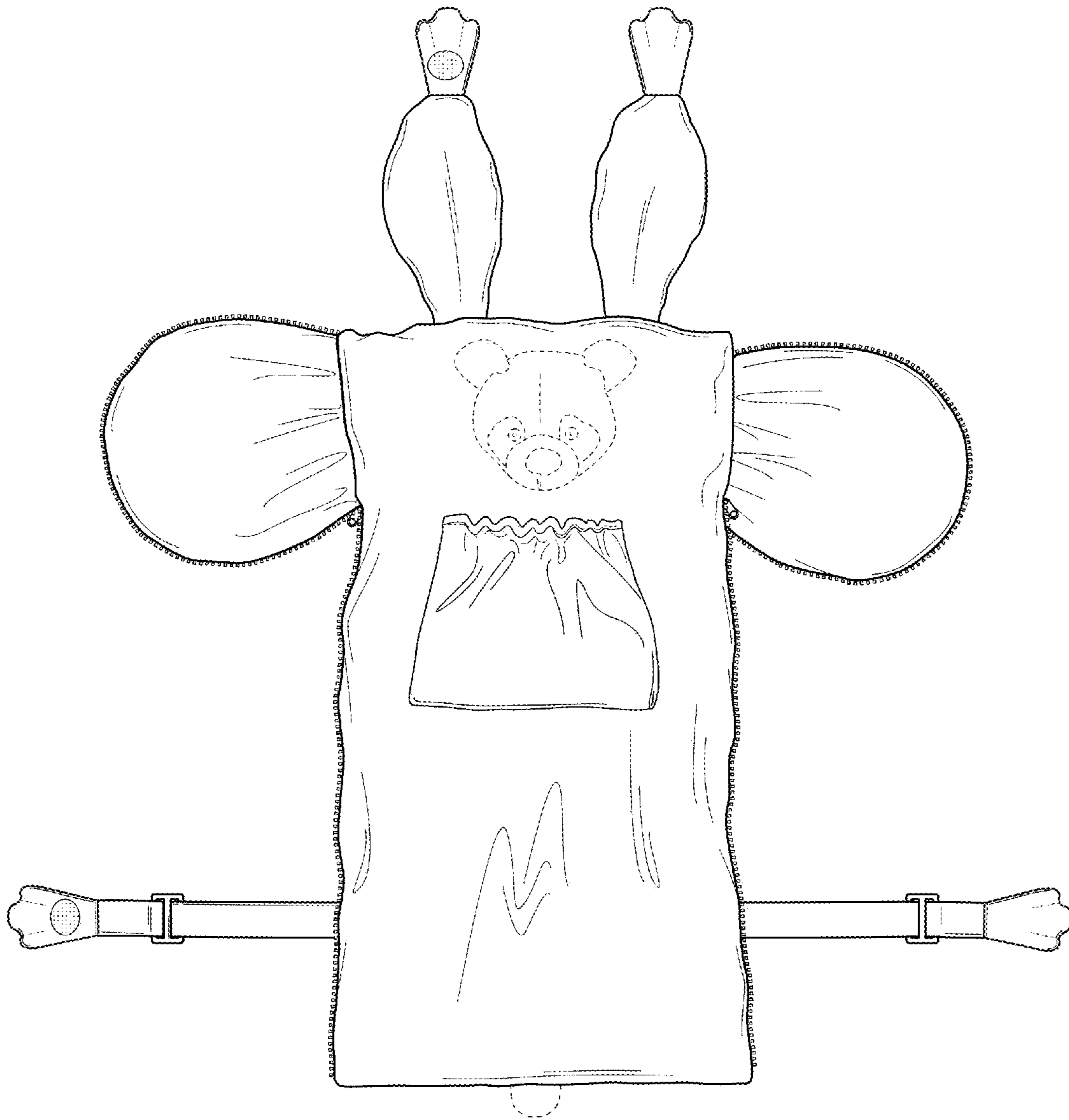

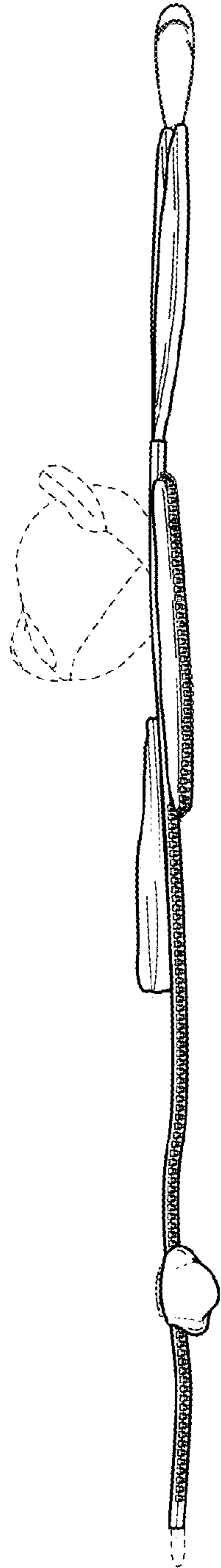

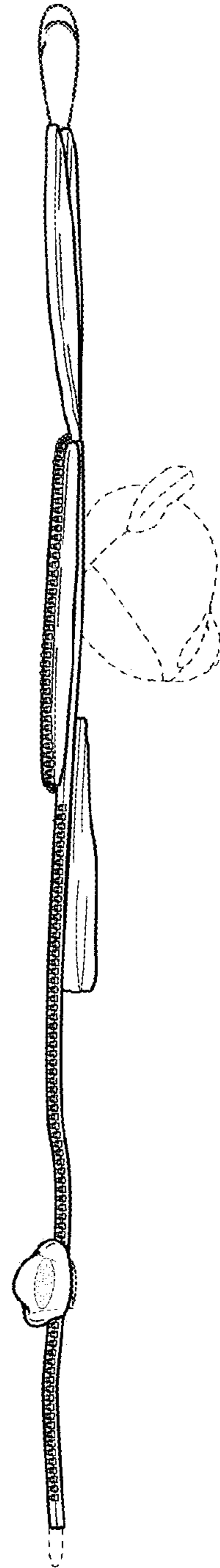

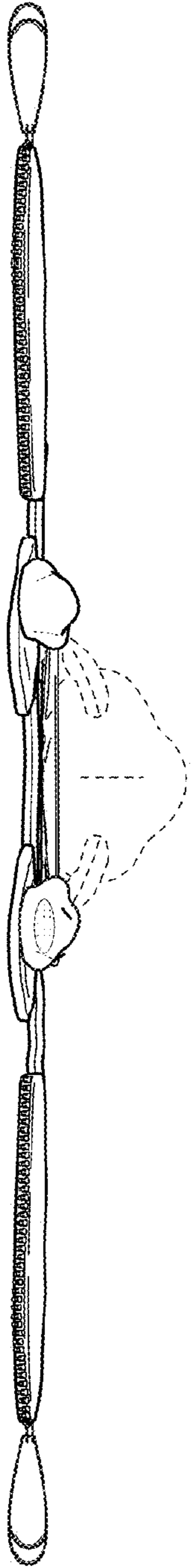

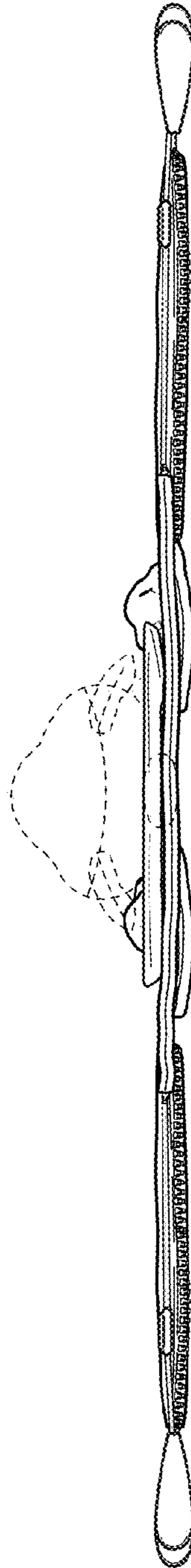
