DESCRIPTION

FIG. 1 is front perspective view of an exemplary seat; FIG. 2 is a front view of the seat of FIG. 1; FIG. 3 is a rear view of the seat of FIG. 1; FIG. 4 is a left side view of the seat of FIG. 1; FIG. 5 is a right side view of the seat of FIG. 1; FIG. 6 is a top view of the seat of FIG. 1; FIG. 7 is a bottom view of the seat of FIG. 1; and, FIG. 8 is a rear perspective view of the seat of FIG. 1. 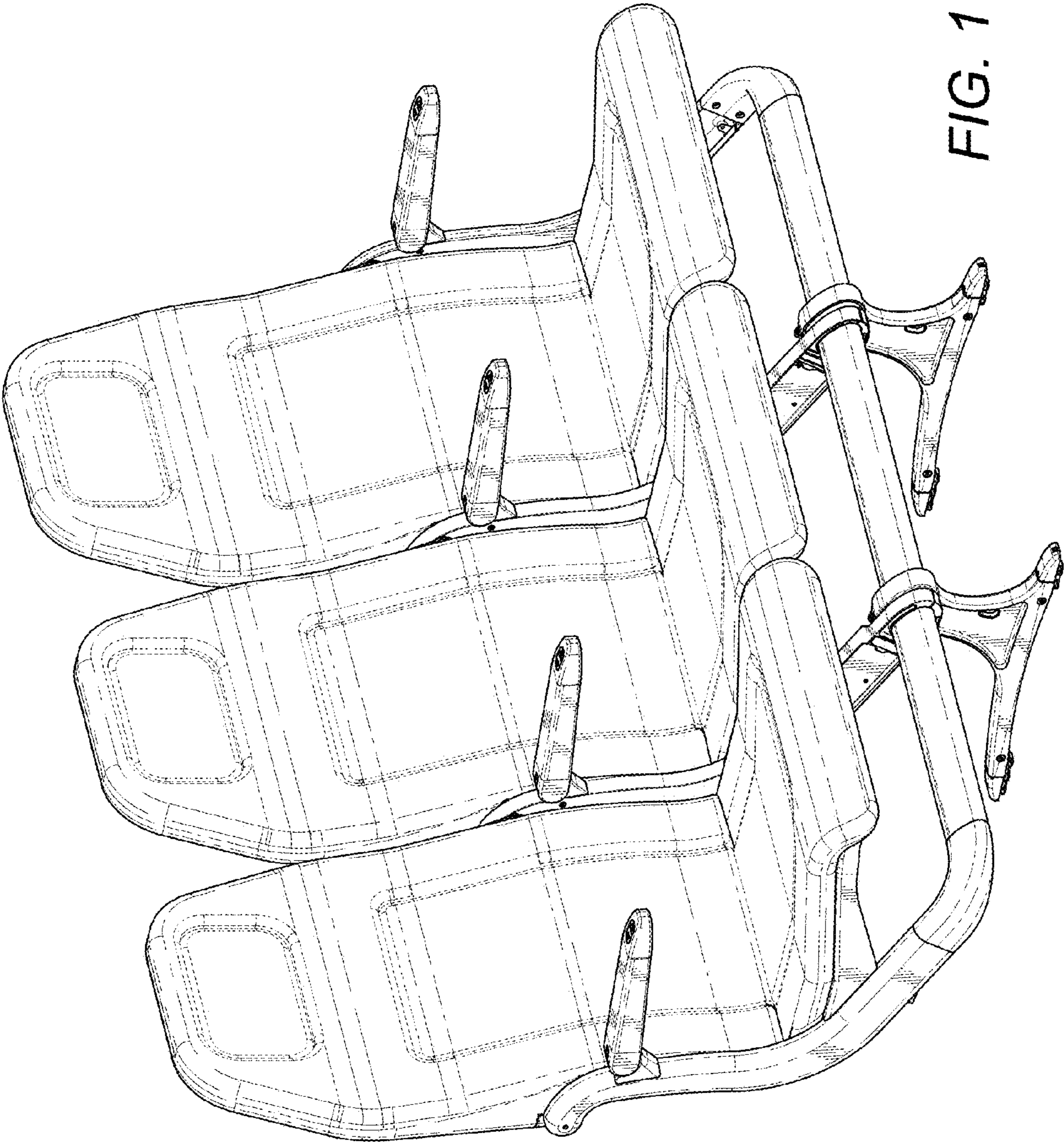

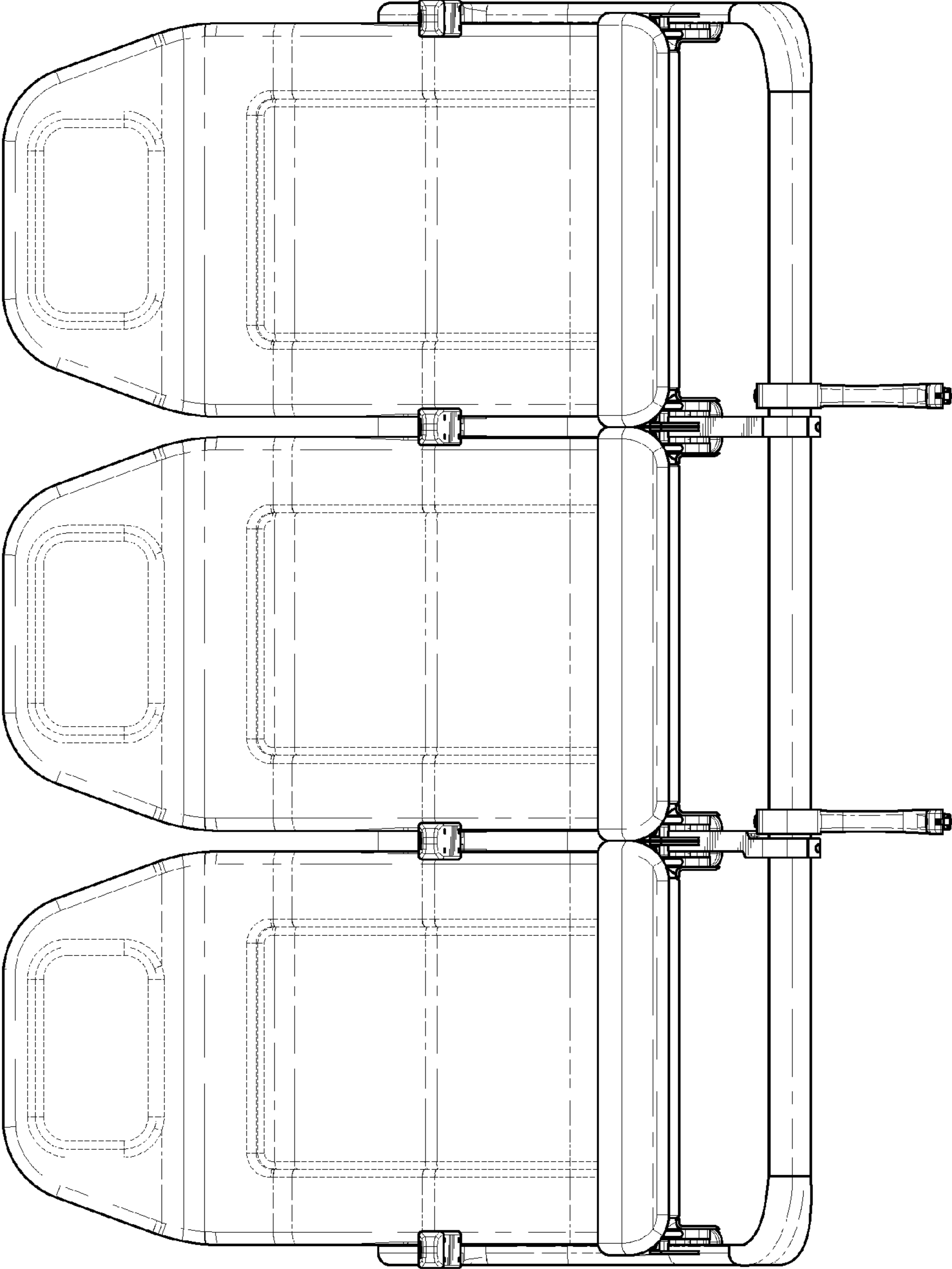

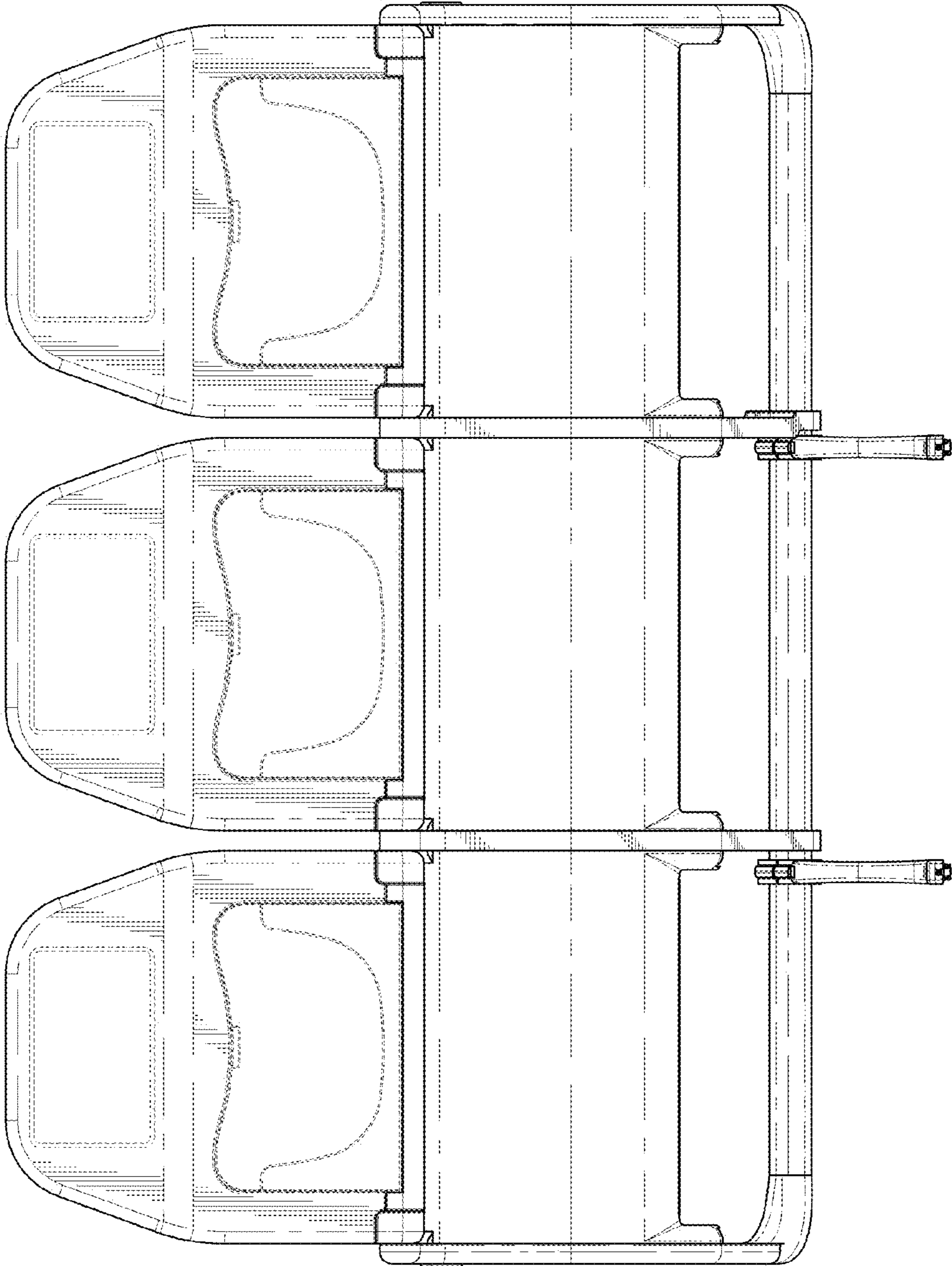

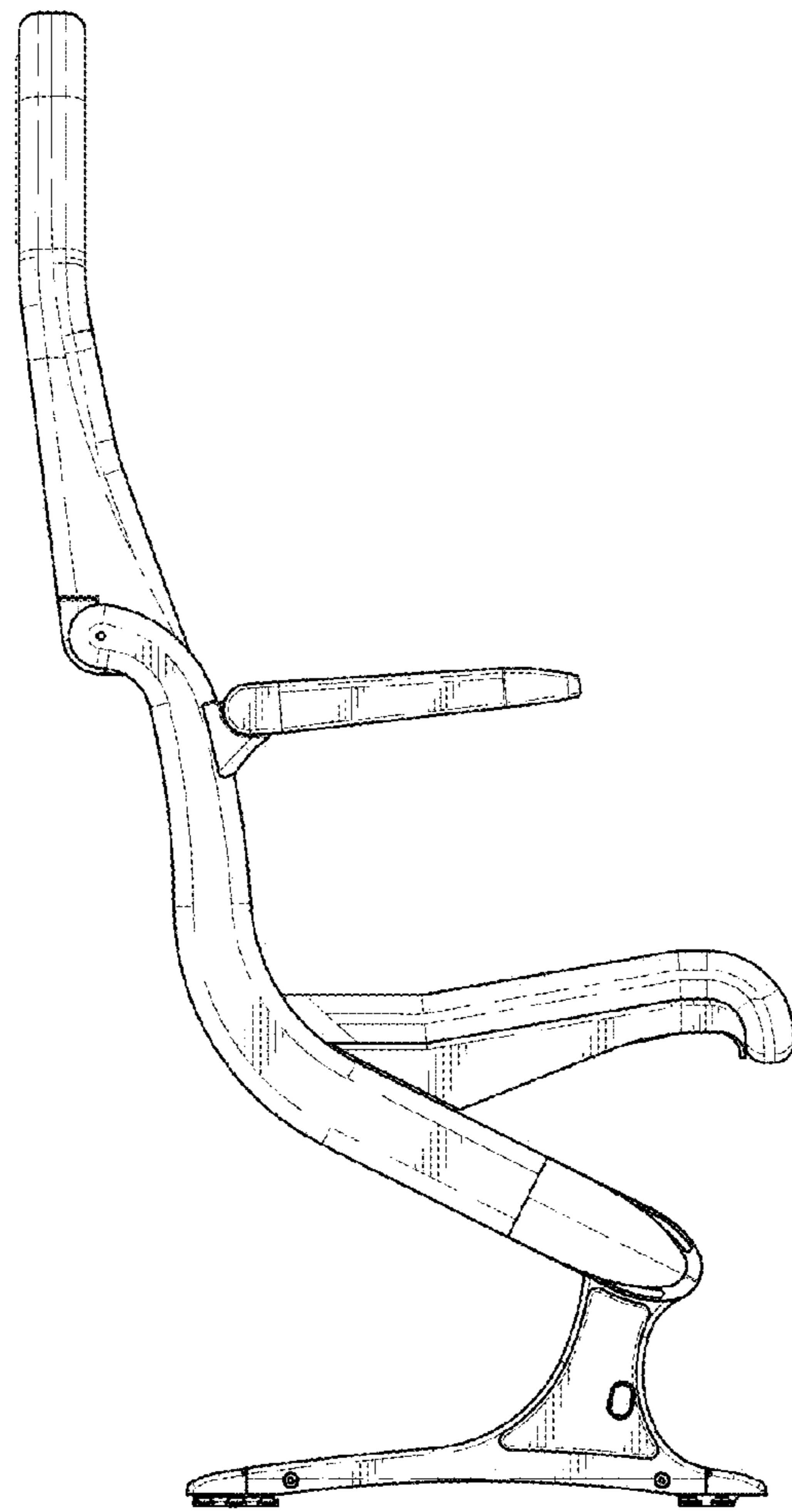

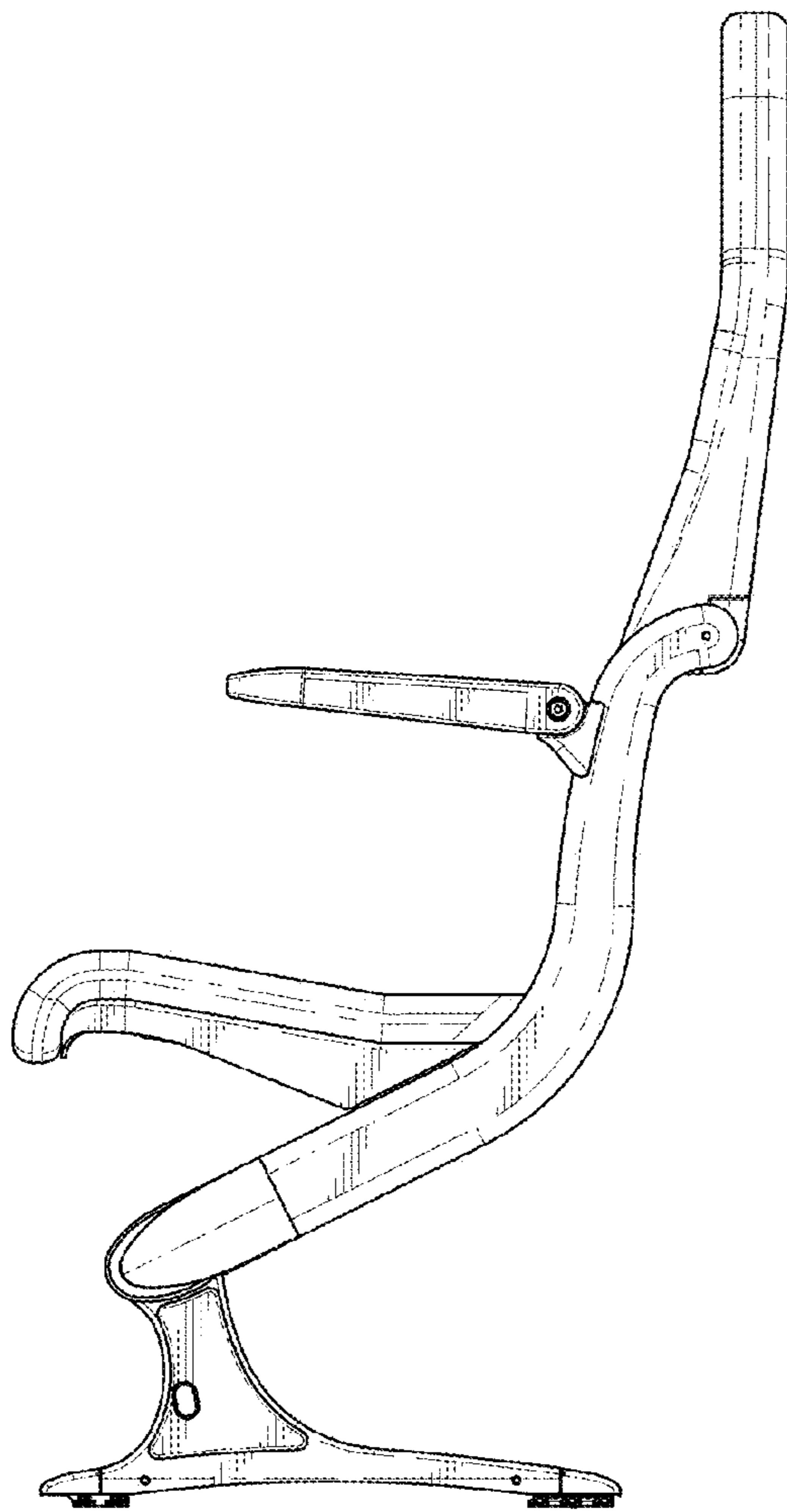

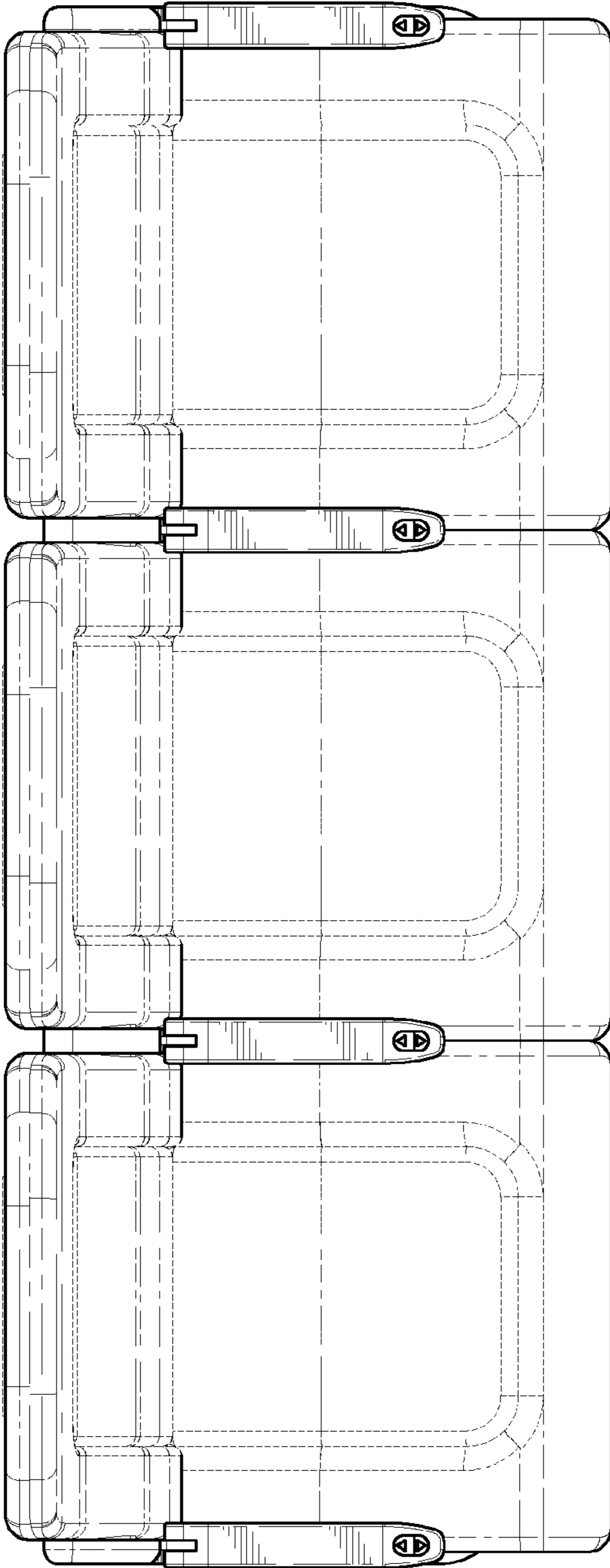

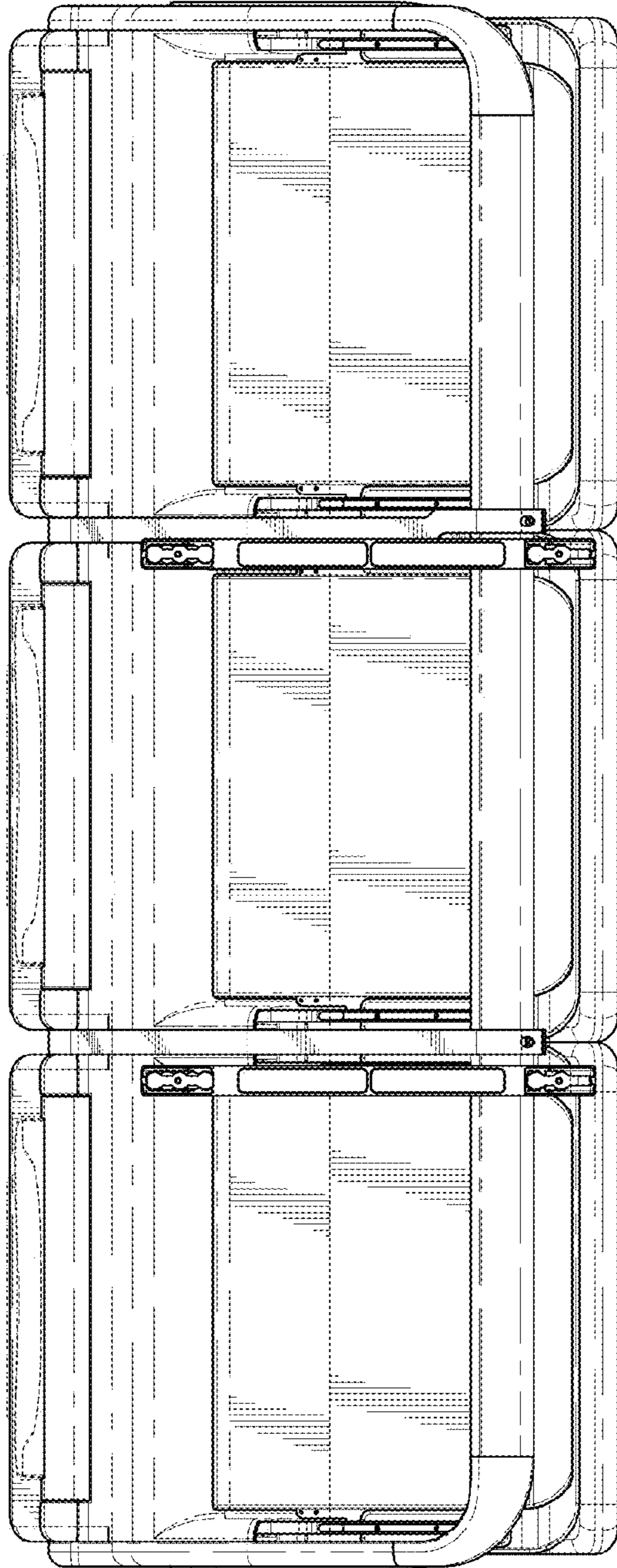

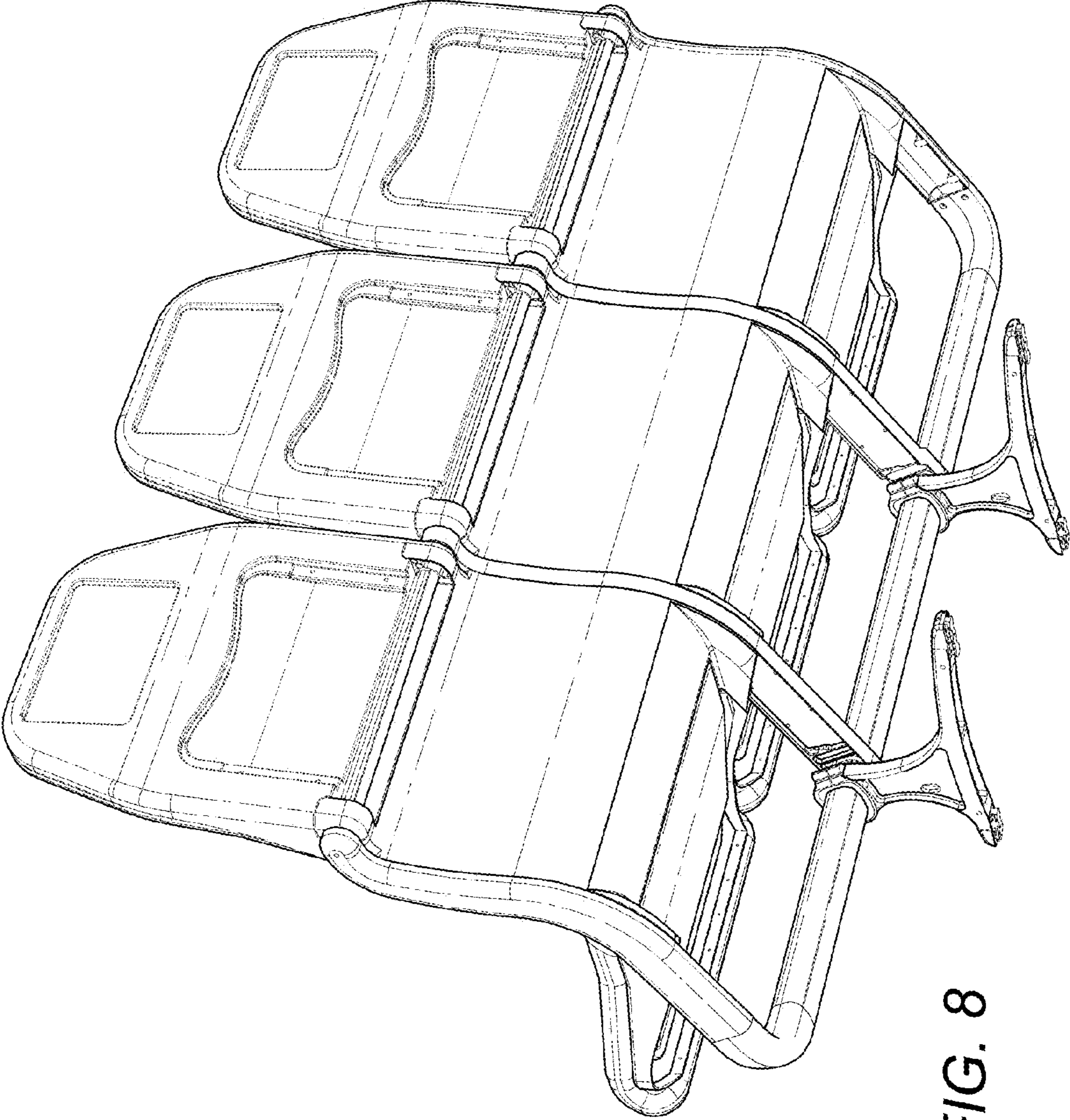
