(57) **CLAIM**

The ornamental design for a pillow puppet, as shown and described.

**DESCRIPTION**

FIG. 1 shows a front left perspective view of my claimed design showing arms hanging downward comprising hollow sleeves;

FIG. 2 shows a front view of my claimed design;

FIG. 3 shows a rear view thereof showing openings at the top of the sleeves to allow insertion of arms;

FIG. 4 shows a right side view thereof;

FIG. 5 shows a left side view thereof;

FIG. 6 shows a top view thereof; and,

FIG. 7 shows a bottom view thereof.

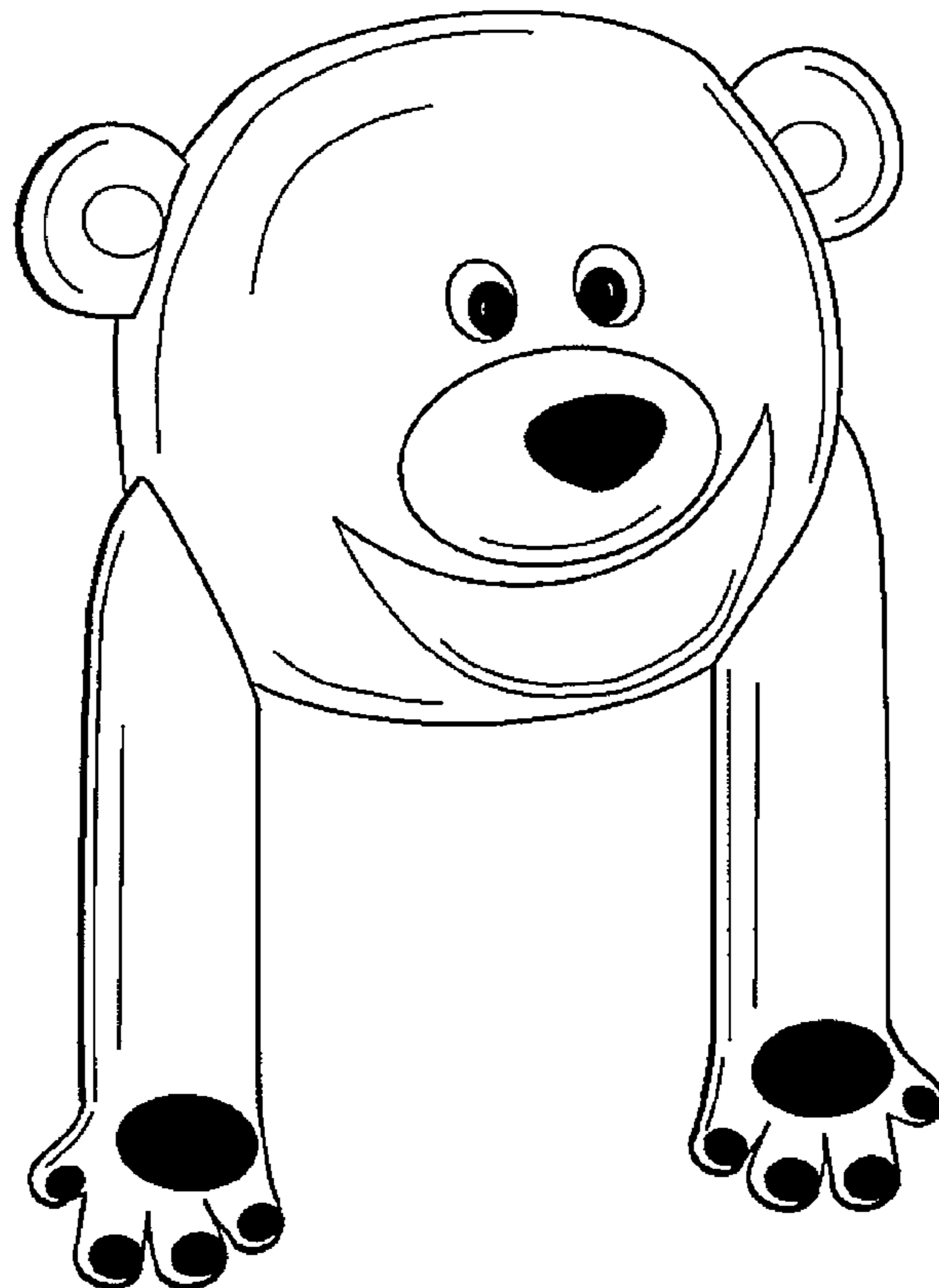

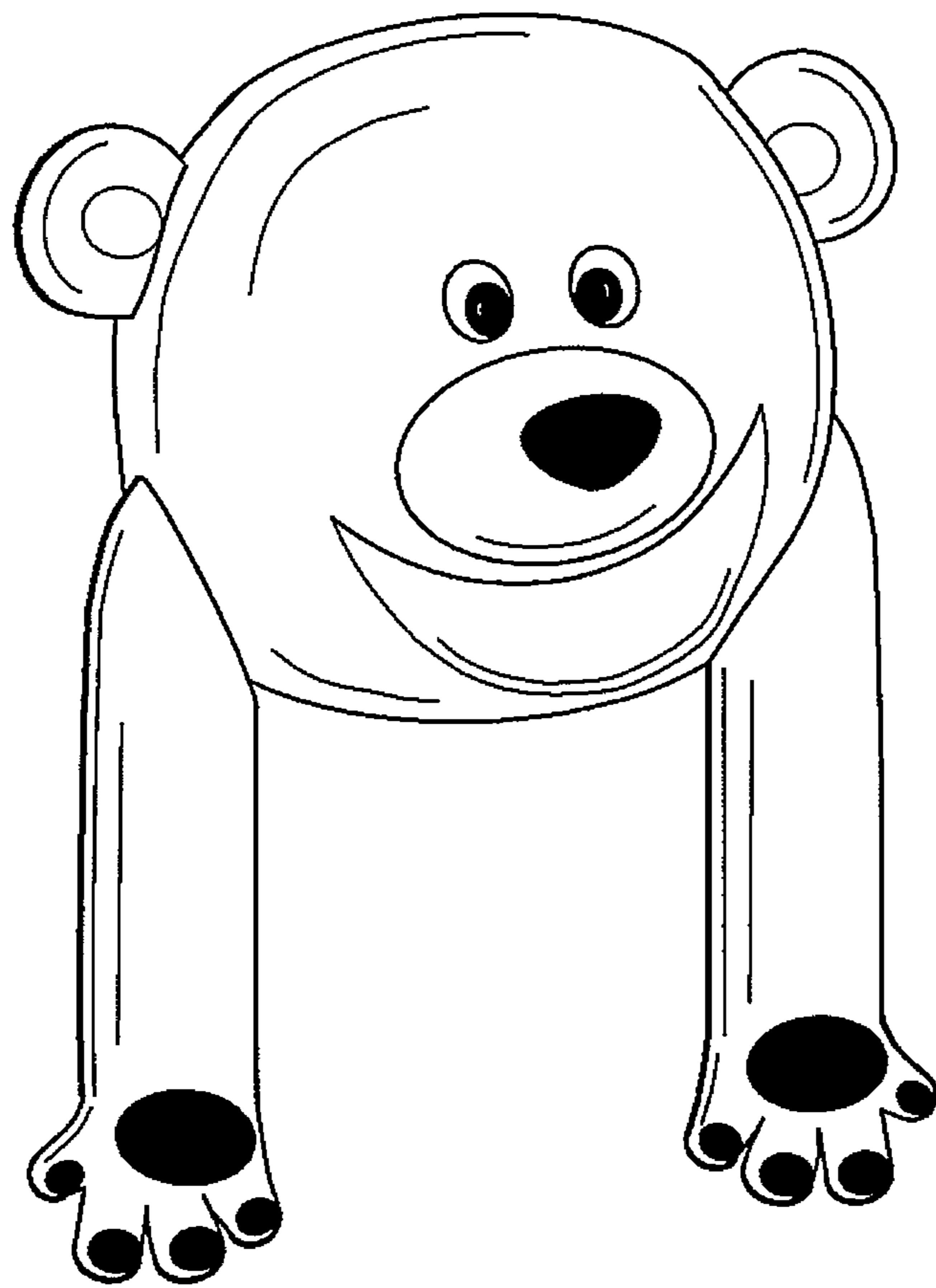

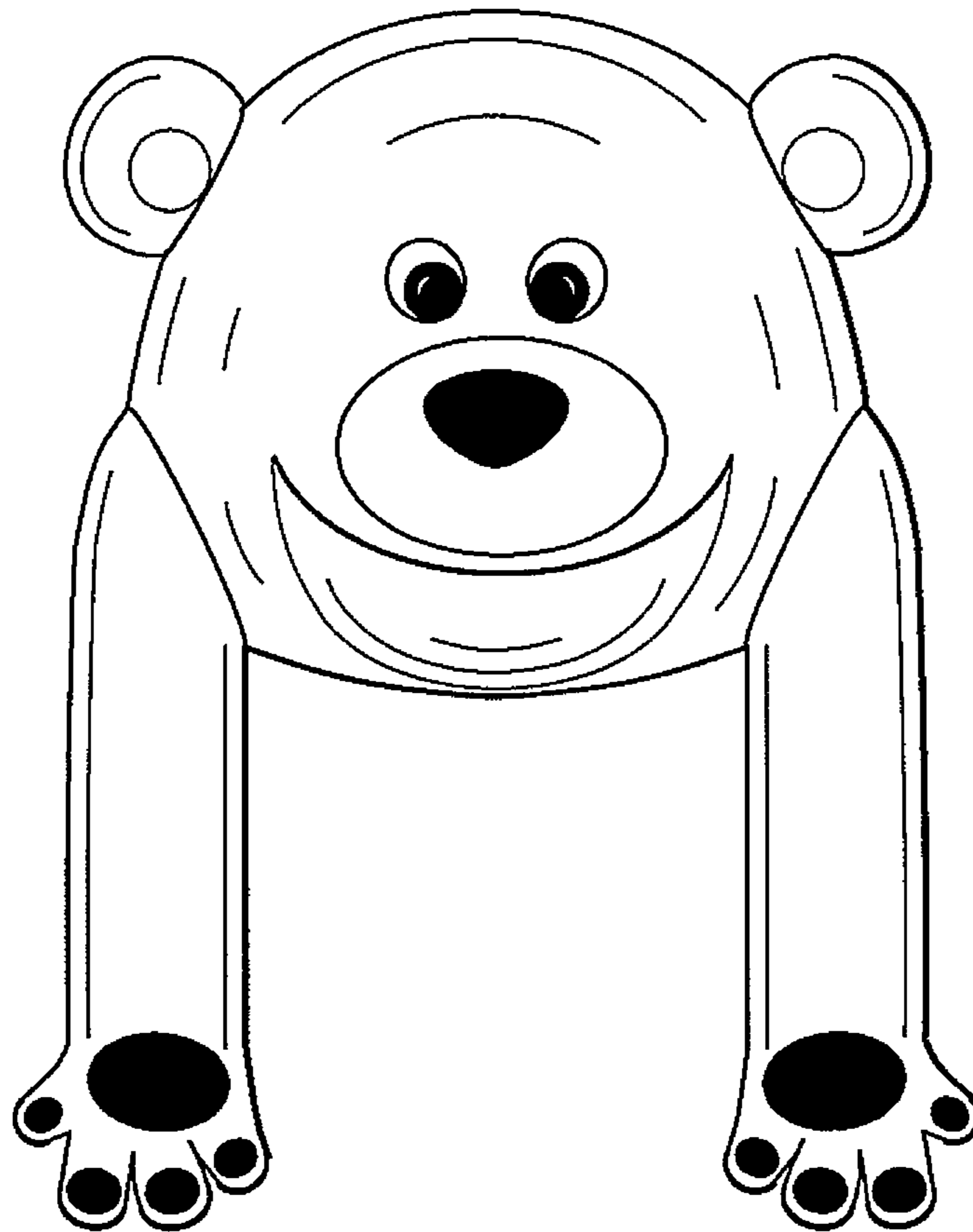

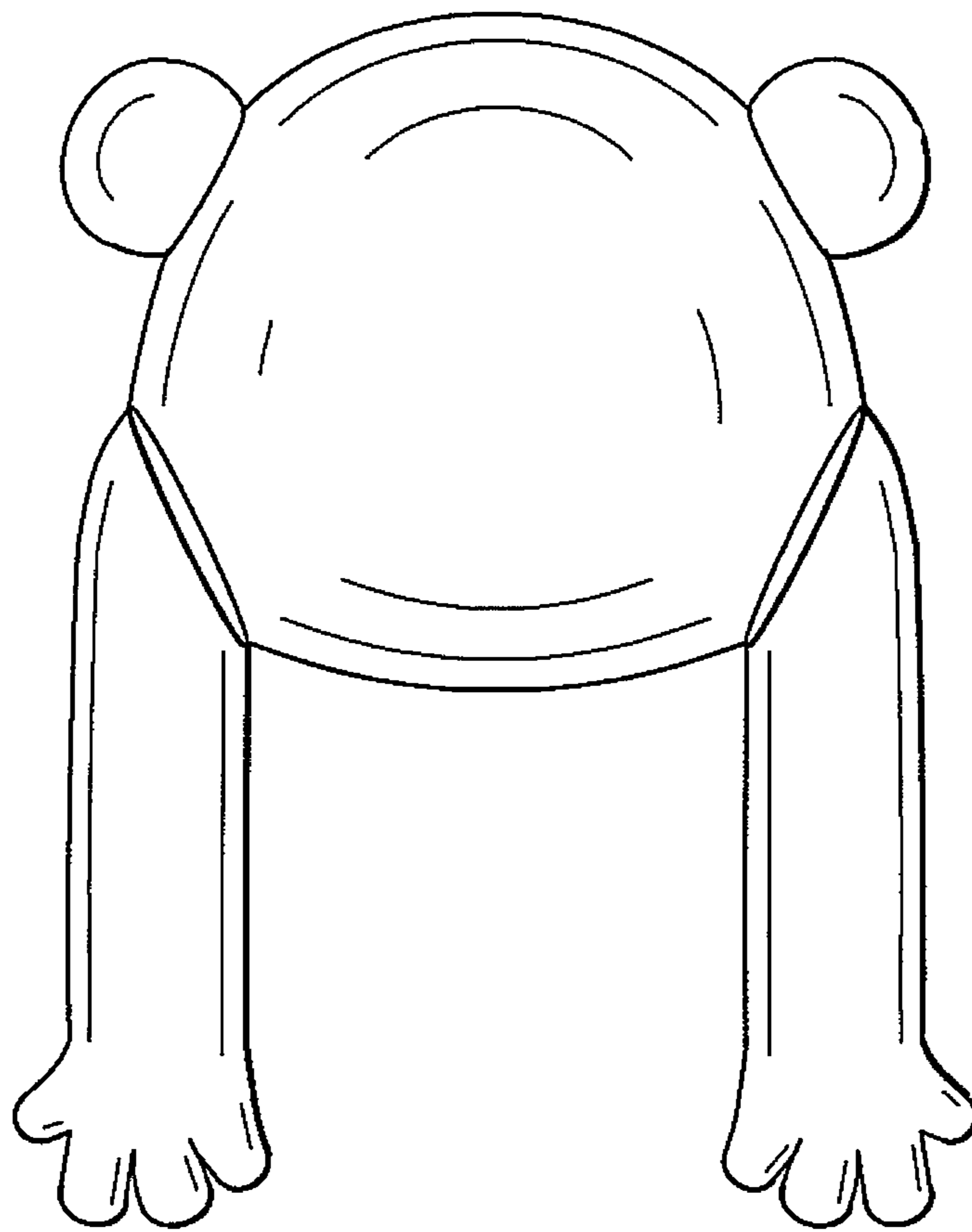

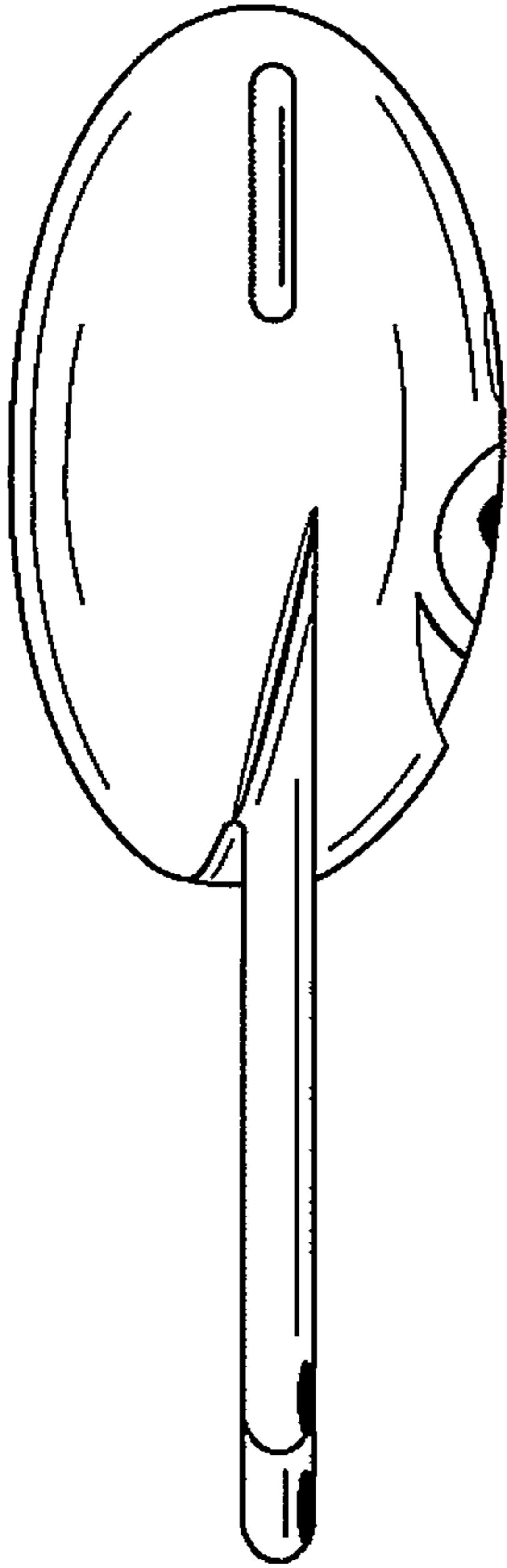

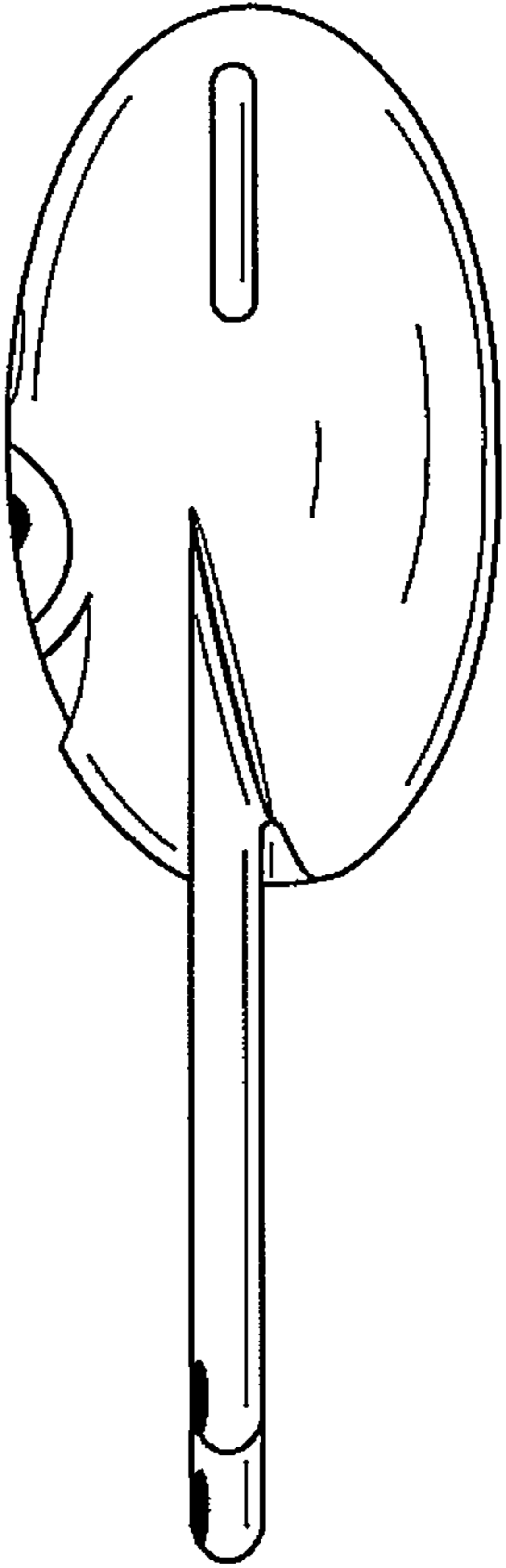

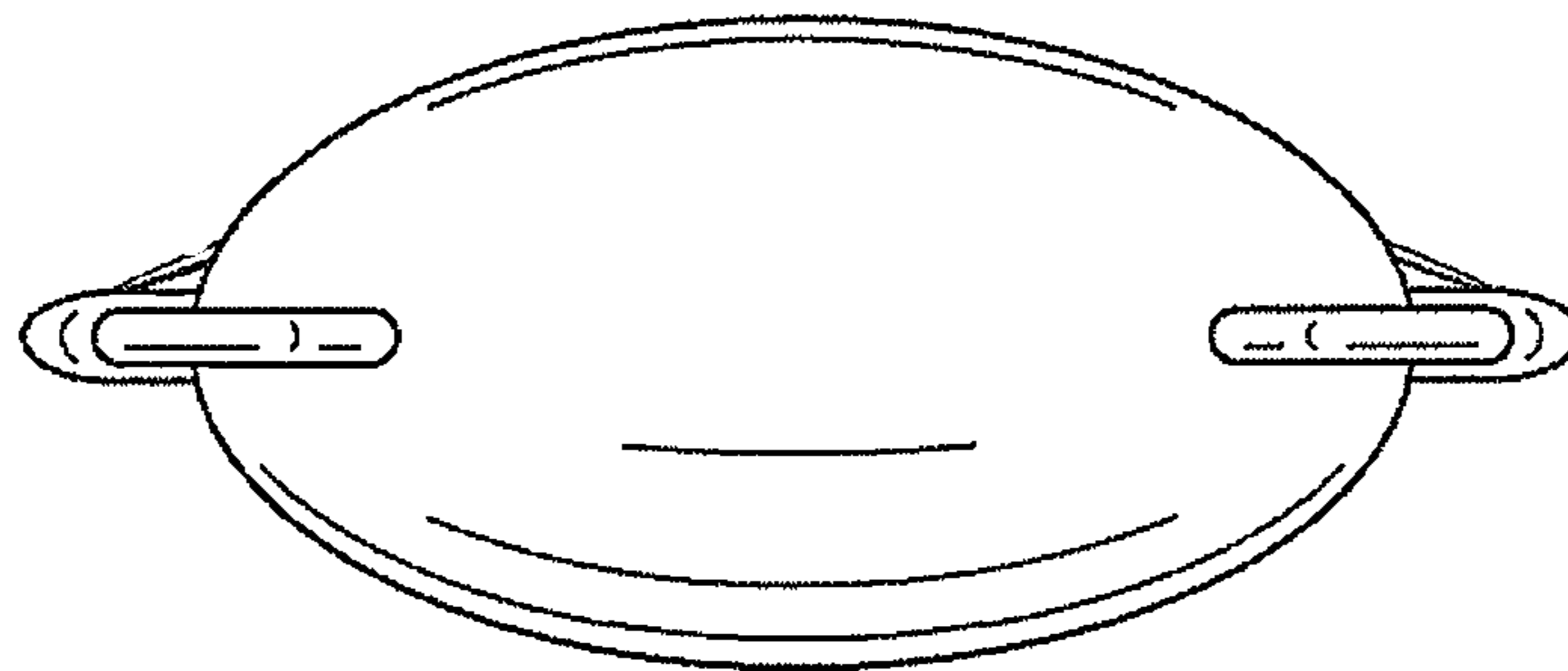
