DESCRIPTION

FIG. 1 is a perspective view of a three-section server showing my new design;

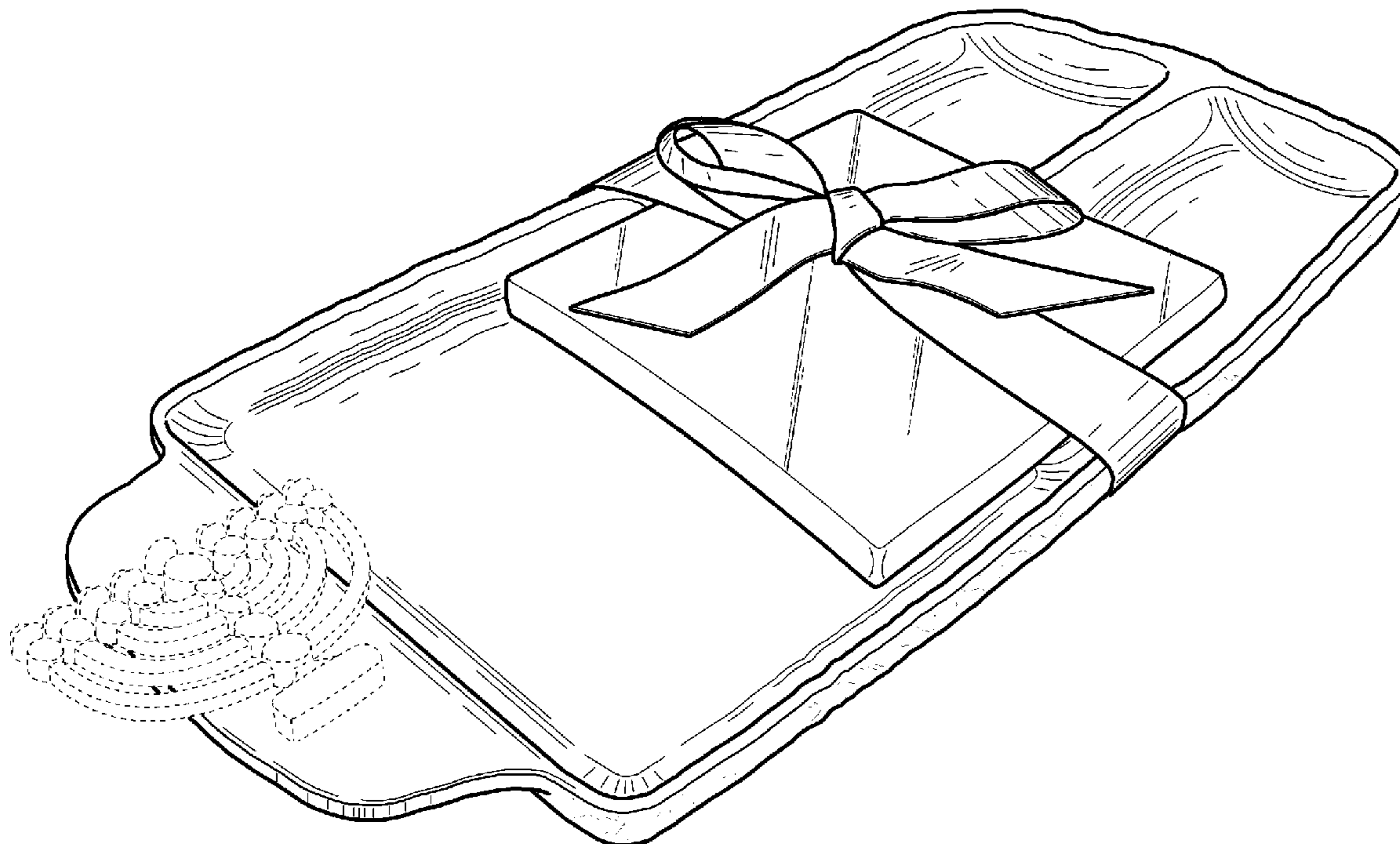

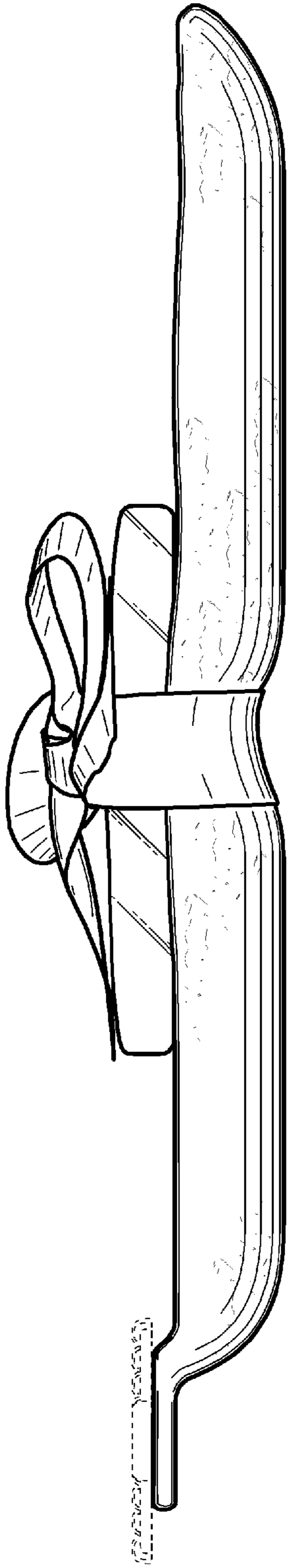

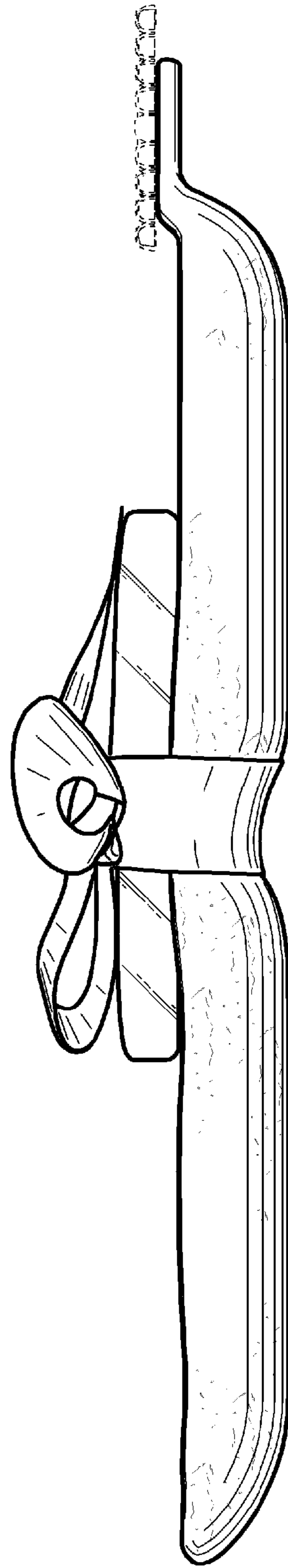

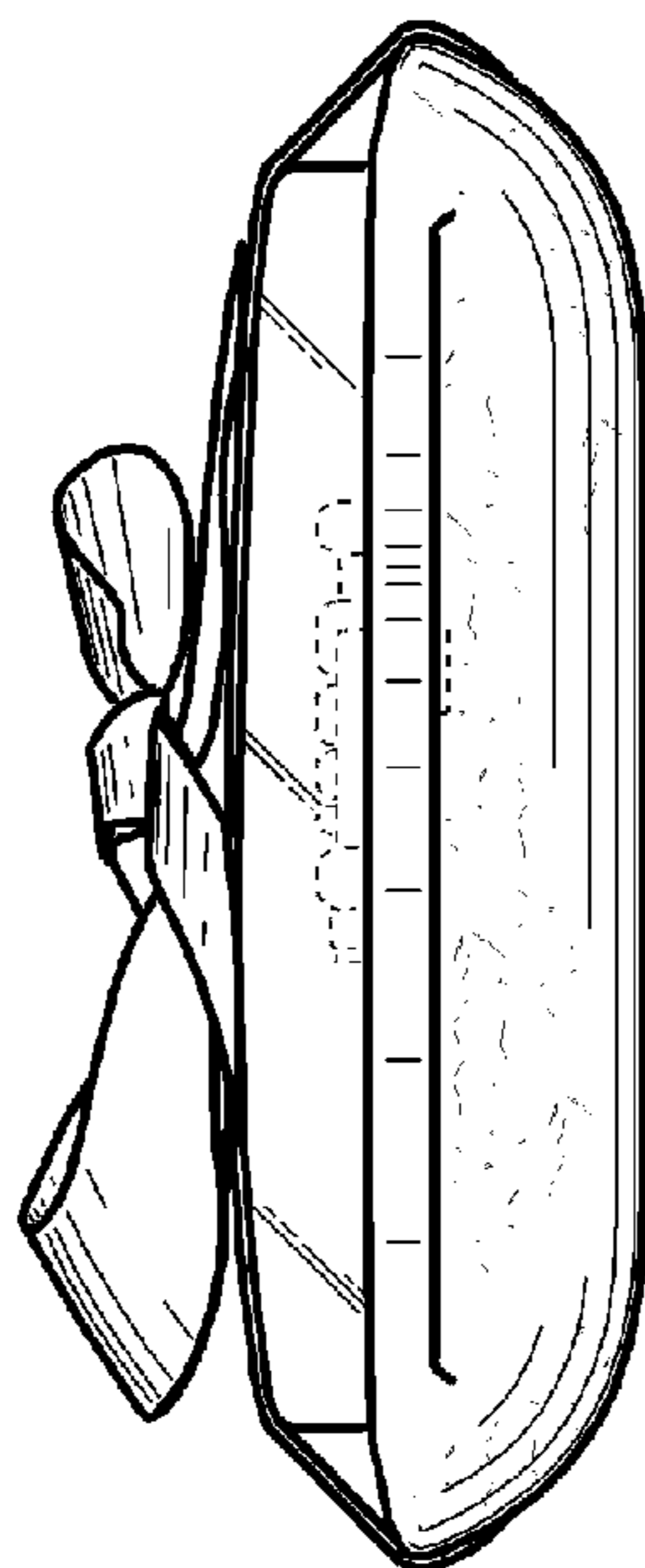

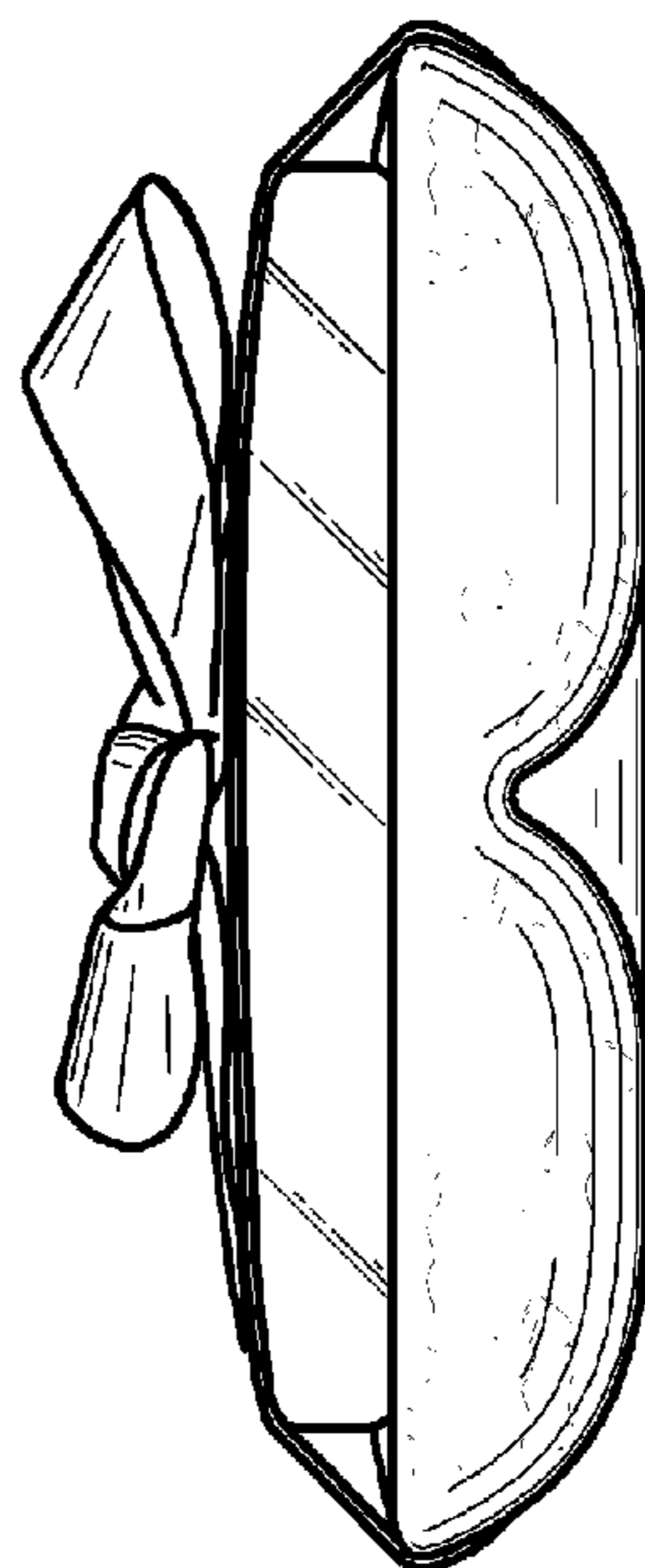

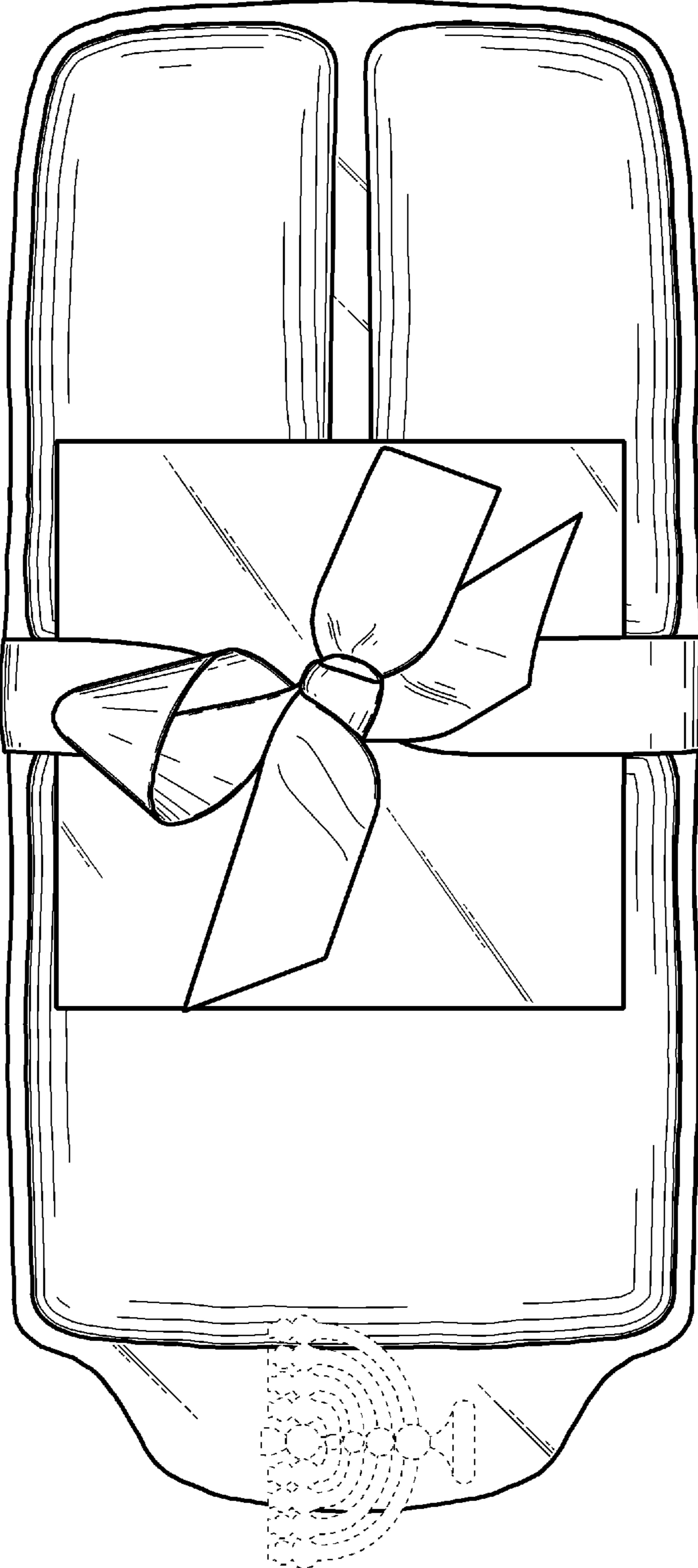

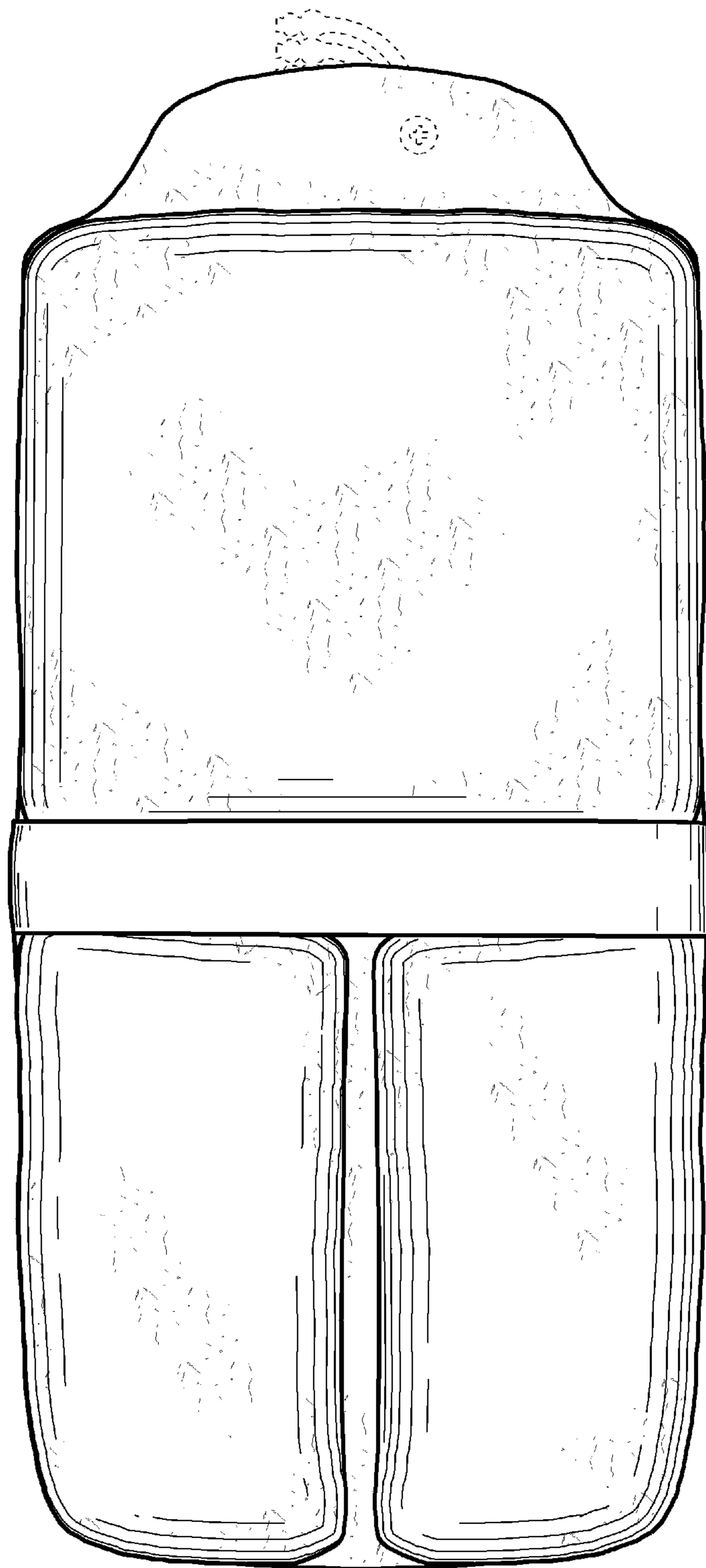
