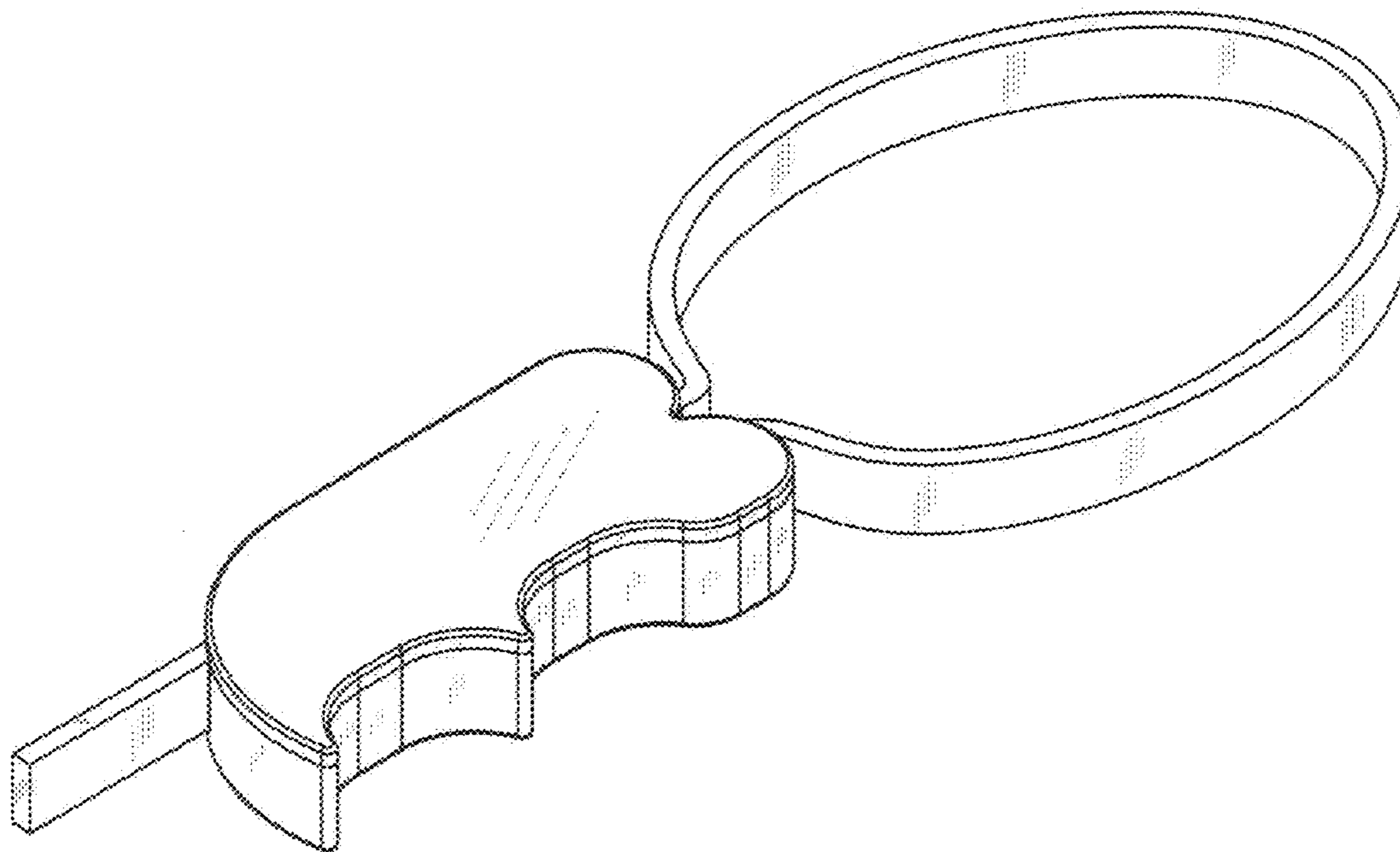
FIG. 1 is a front isometric view depicting an embodiment of a new design for a strap wrench device;

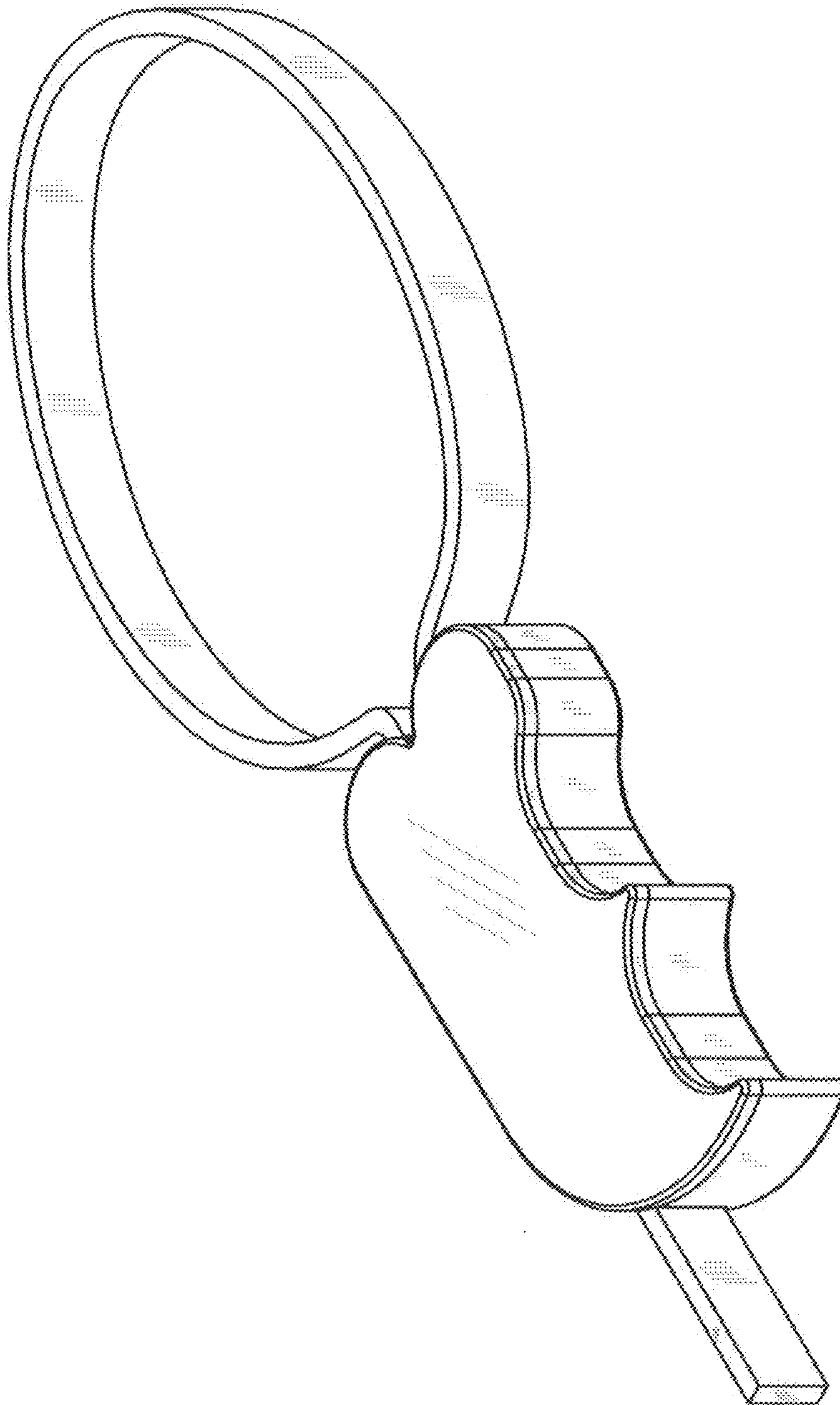

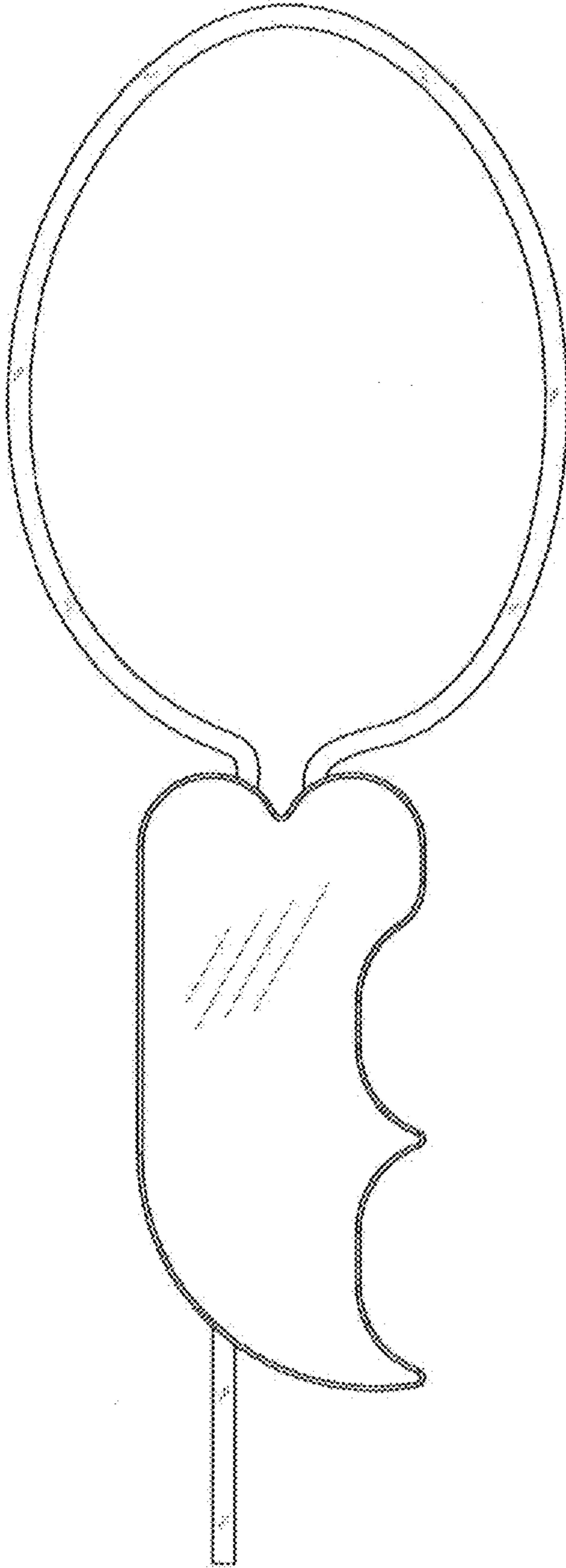

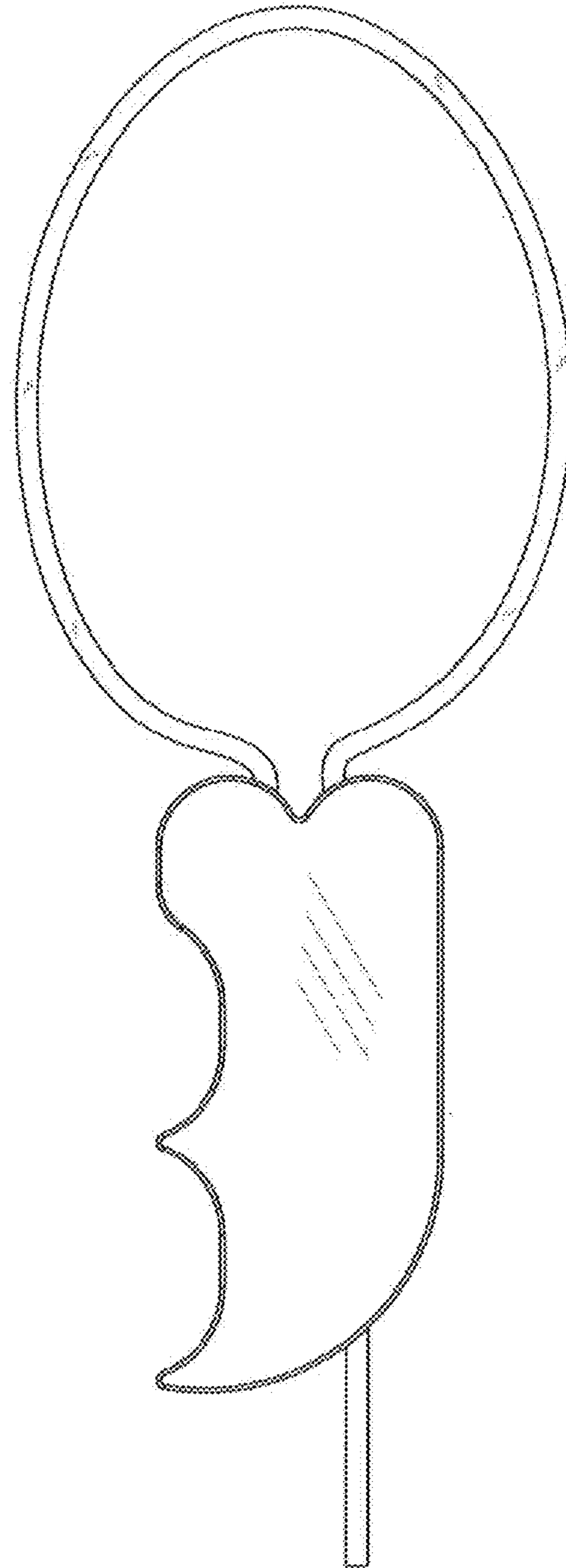

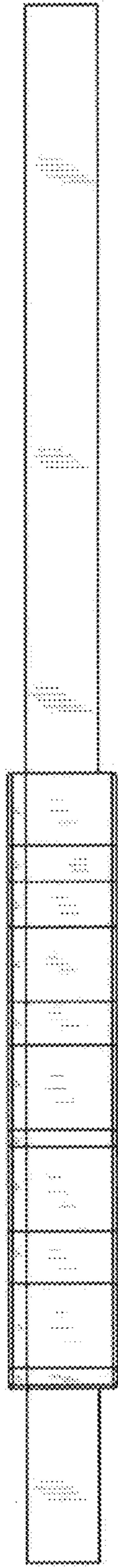

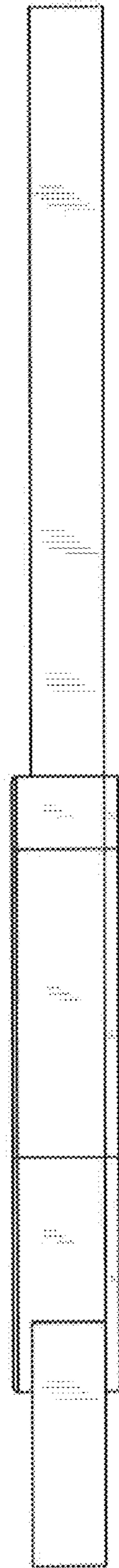

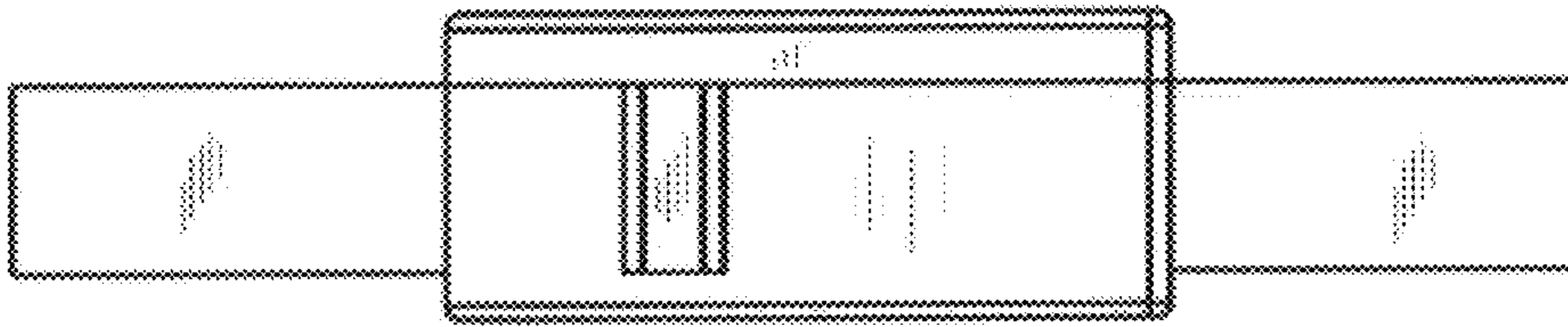

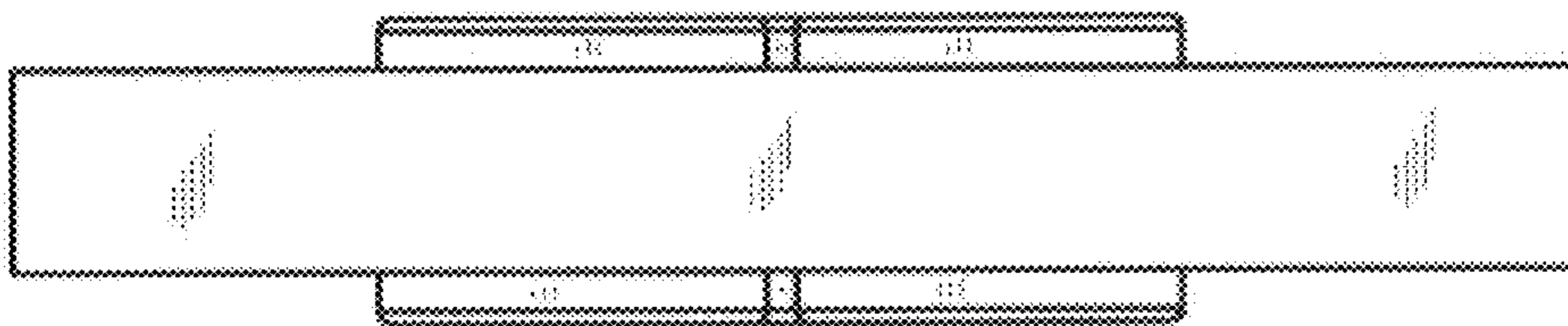
