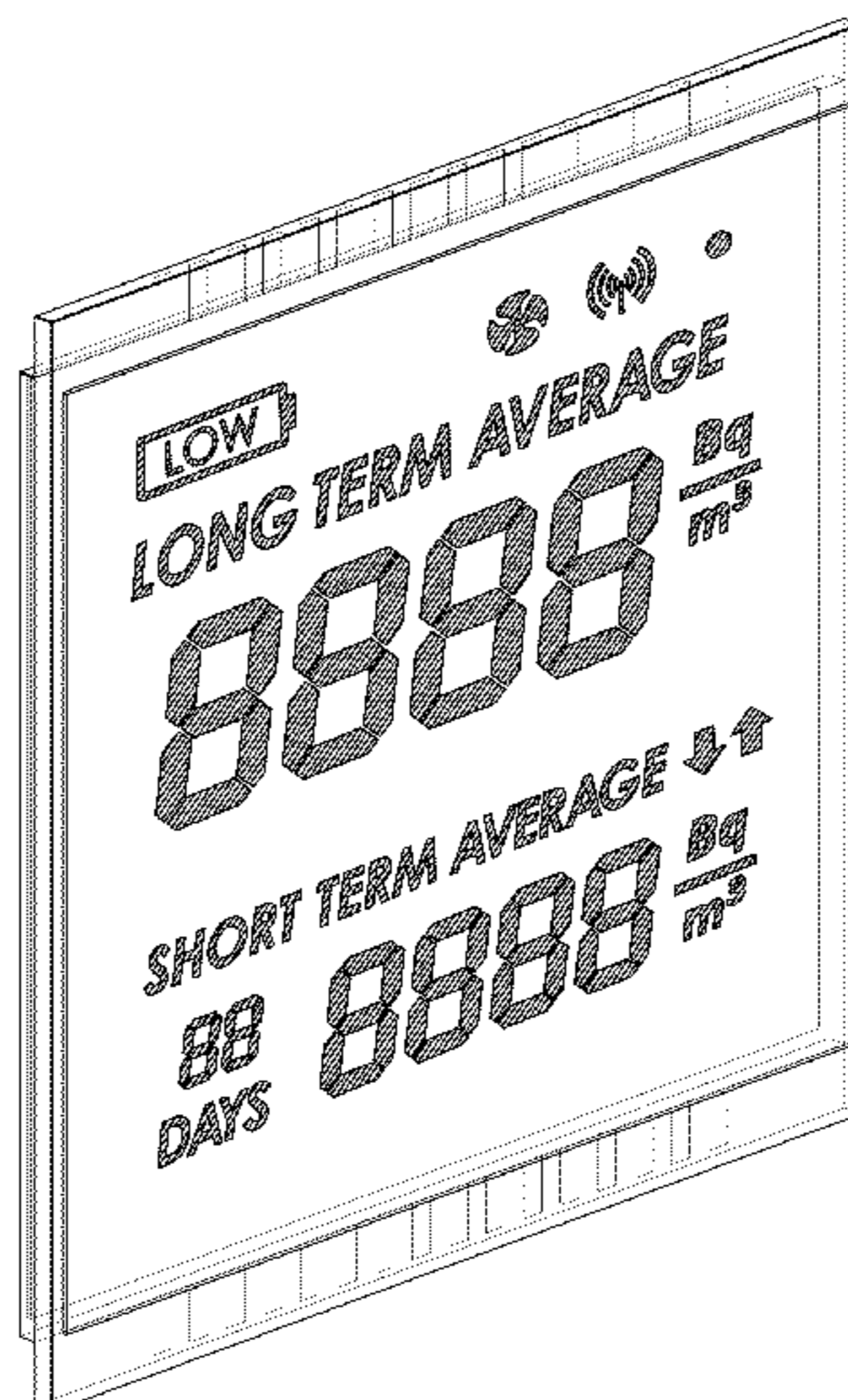
(57) **CLAIM**

The ornamental design for a display panel for a radon gas monitor, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a display panel for a radon gas monitor, showing our new design;  
FIG. 2 is a front elevation view thereof;  
FIG. 3 is a side elevation view thereof taken from the left of FIG. 2;  
FIG. 4 is a side elevation view thereof taken from the right of FIG. 2;  
FIG. 5 is top plan view thereof;  
FIG. 6 is a bottom plan view thereof;  
FIG. 7 is a perspective view of another embodiment thereof;  
FIG. 8 is a front elevation view thereof;  
FIG. 9 is a side elevation view thereof taken from the left of FIG. 8;  
FIG. 10 is a side elevation view thereof taken from the right of FIG. 8;  
FIG. 11 is top plan view thereof;  
FIG. 12 is a bottom plan view thereof;  
FIG. 13 is a front elevation view of another embodiment thereof; and,  
FIG. 14 is a side elevation view thereof taken from the right of FIG. 13, the opposite side being a mirror image thereof.

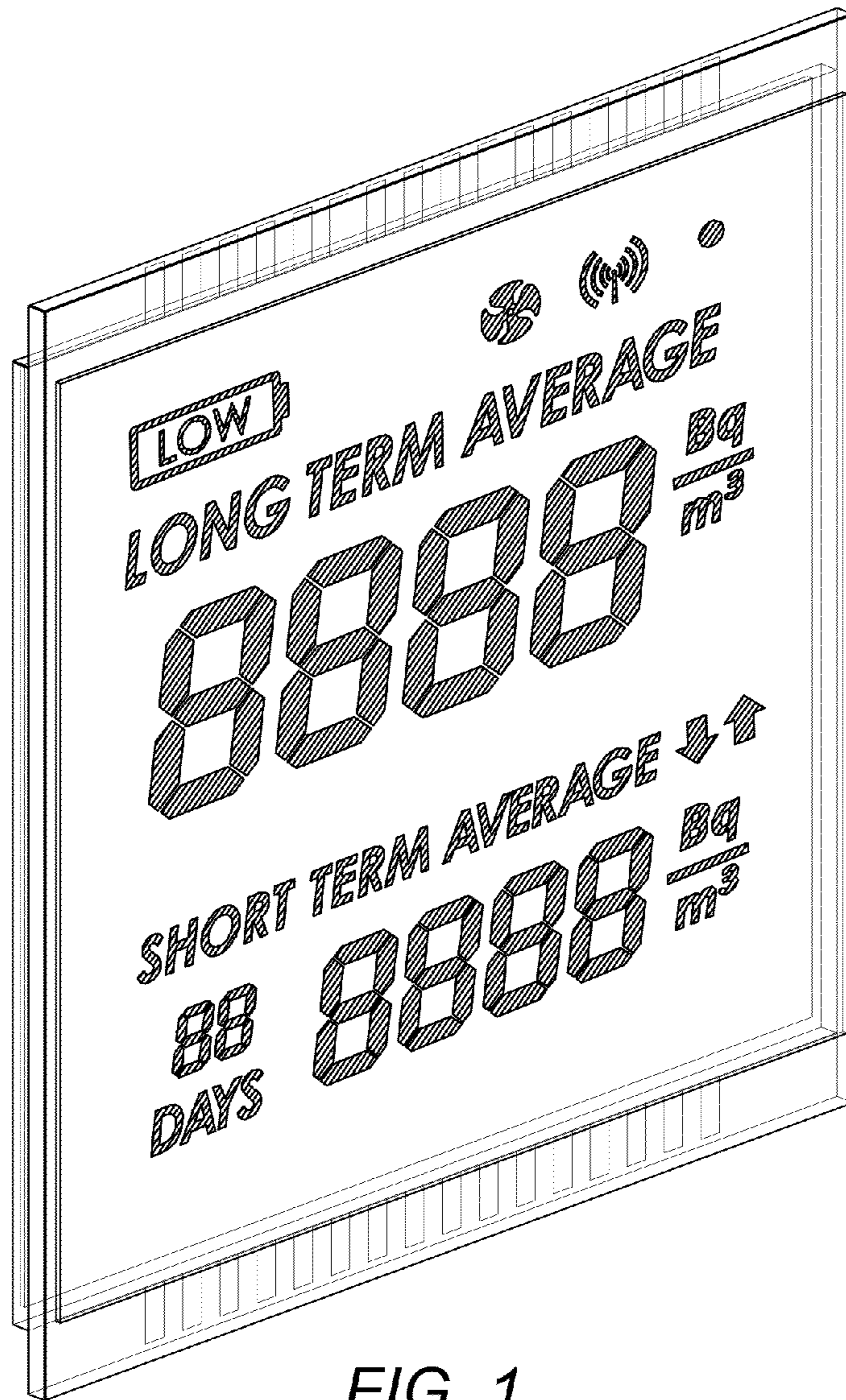

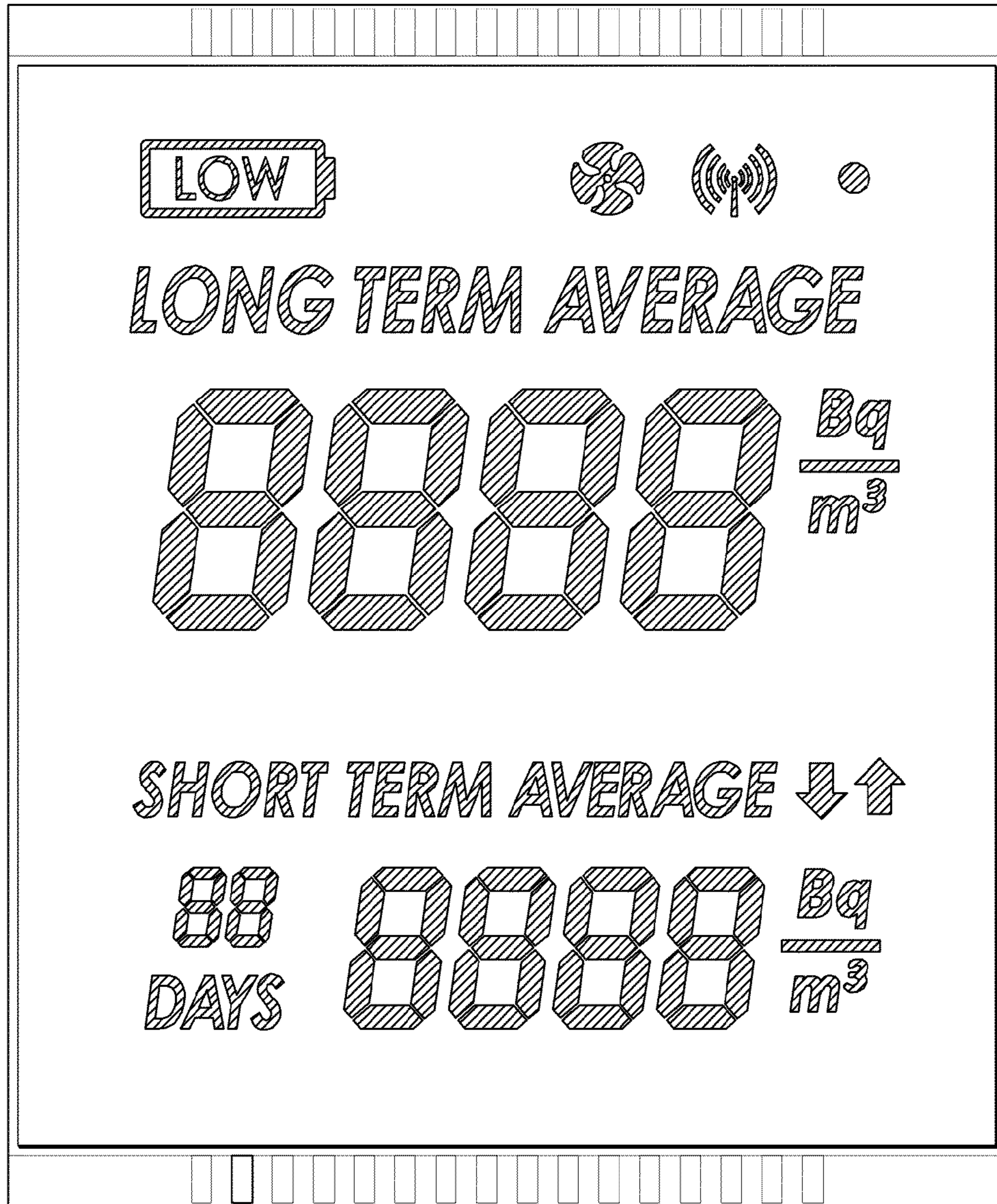

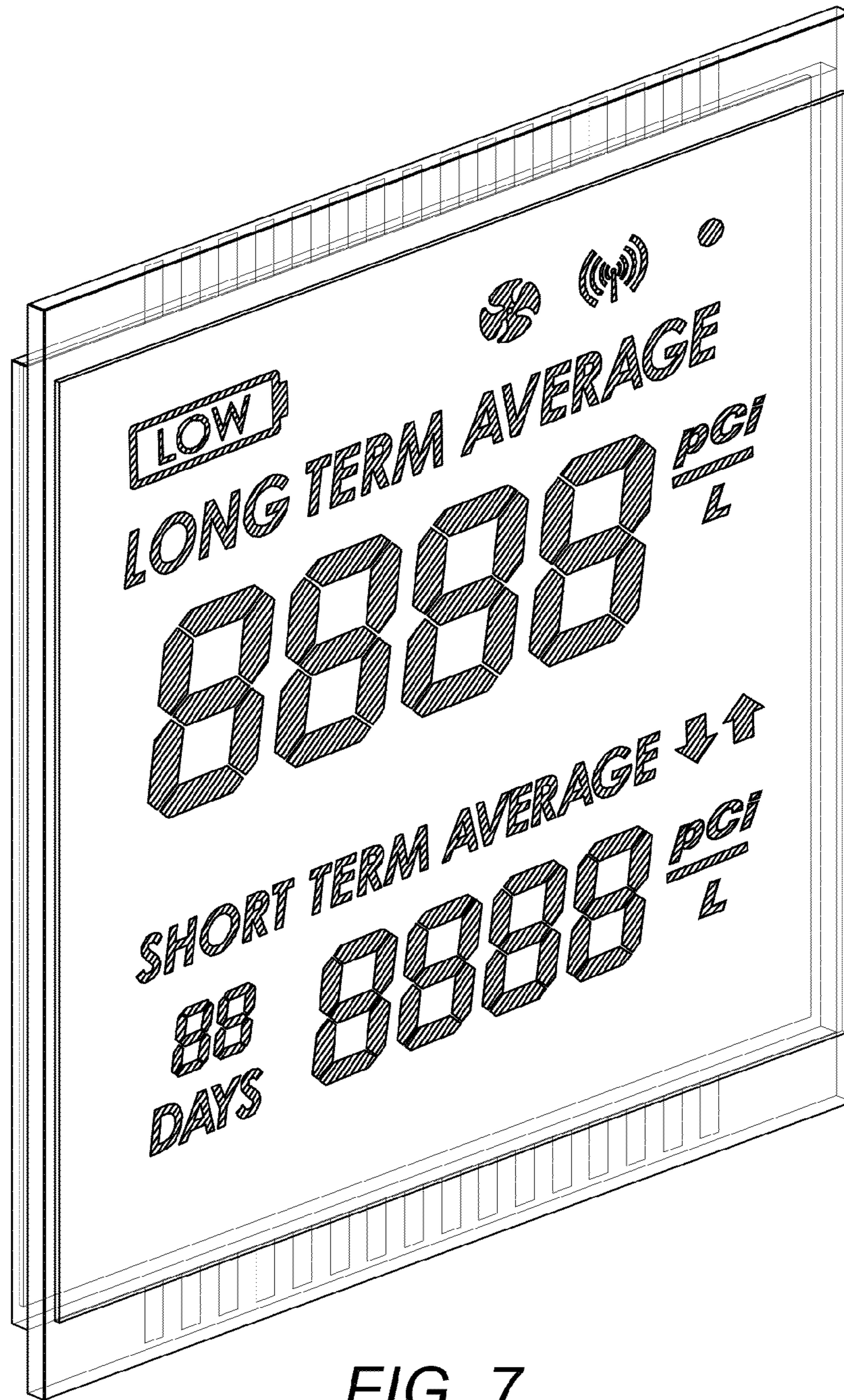

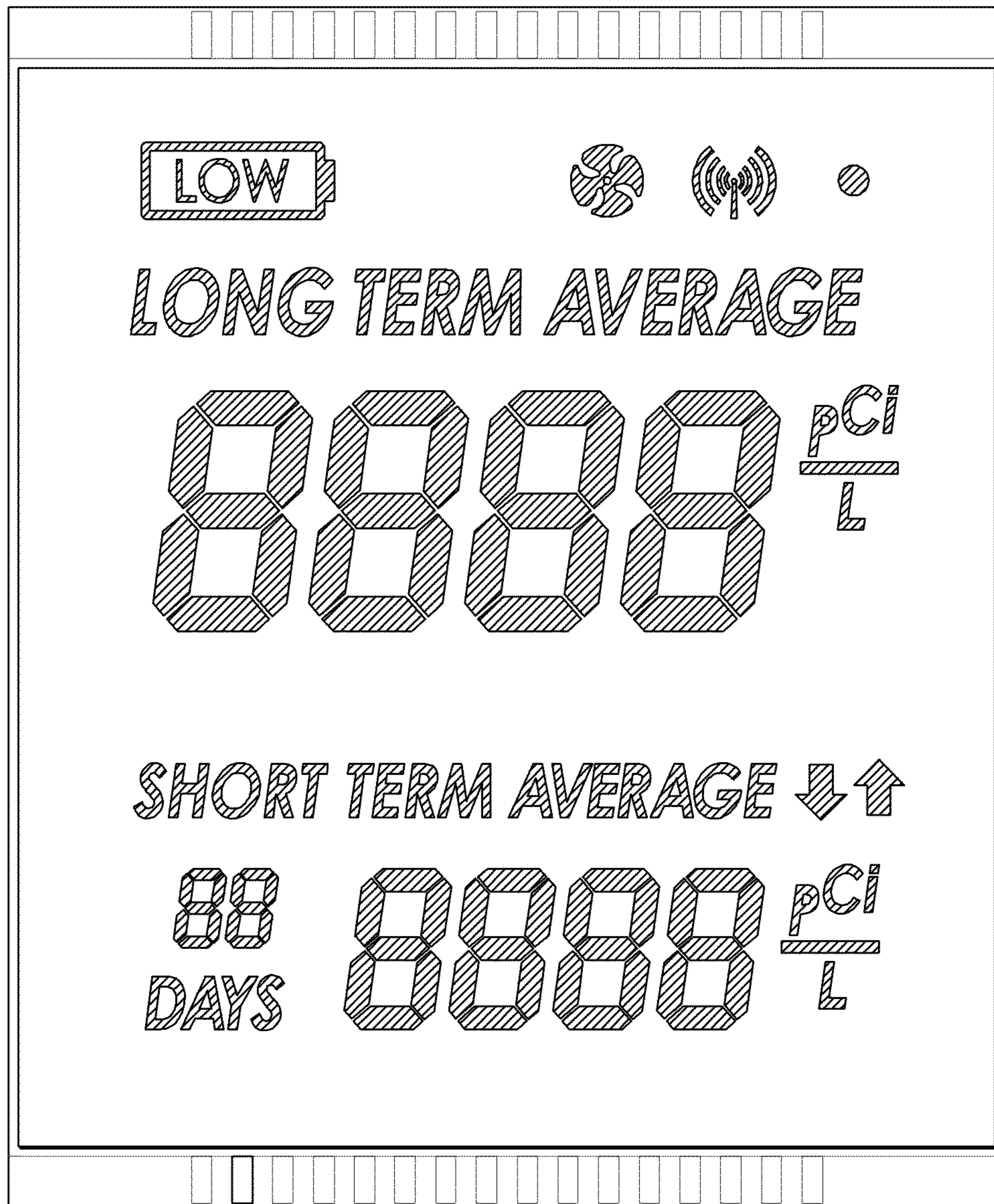
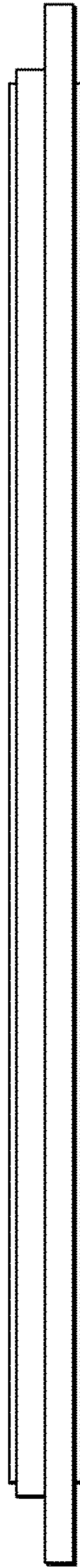

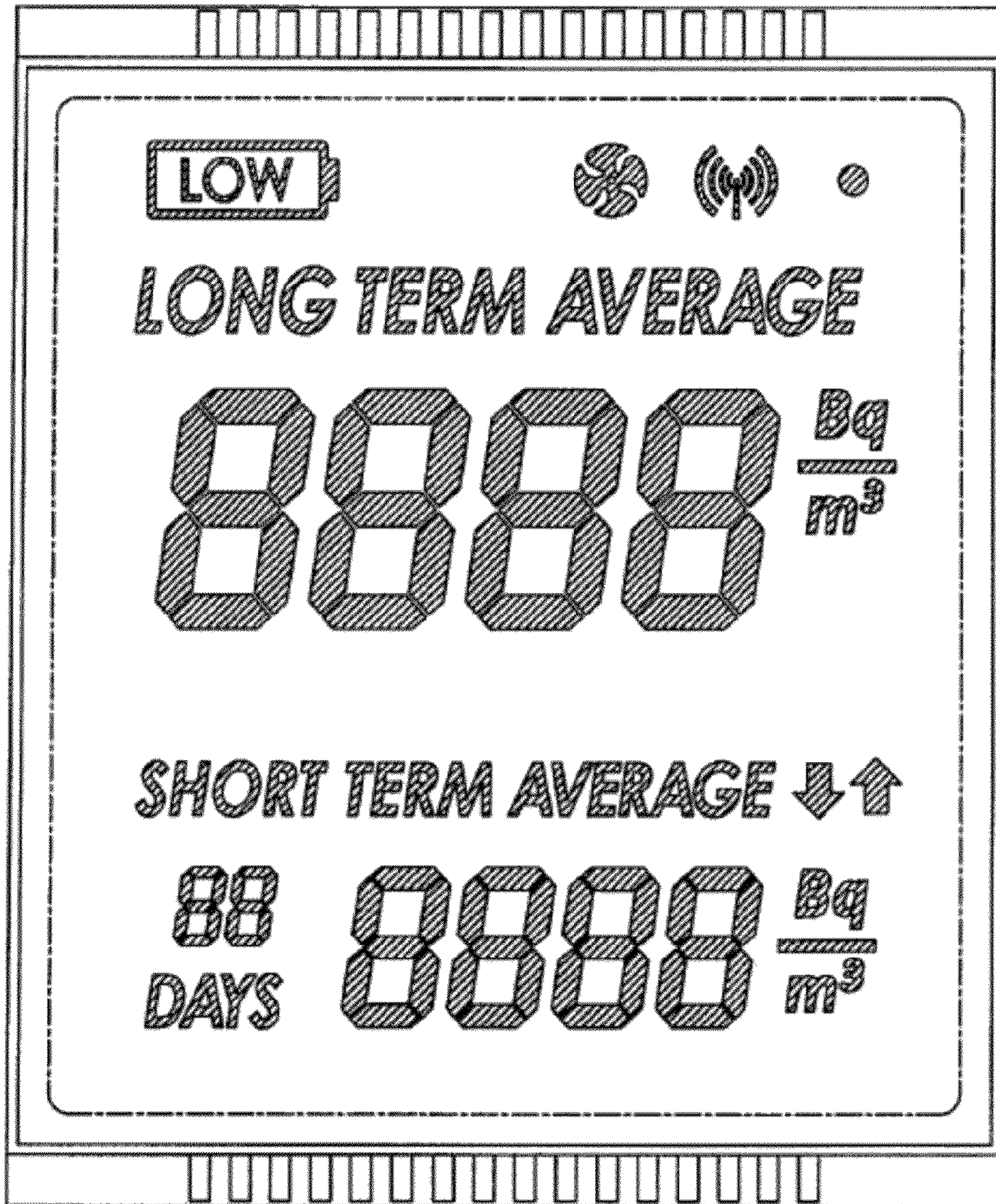

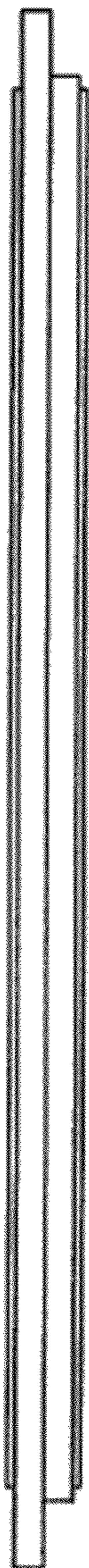
