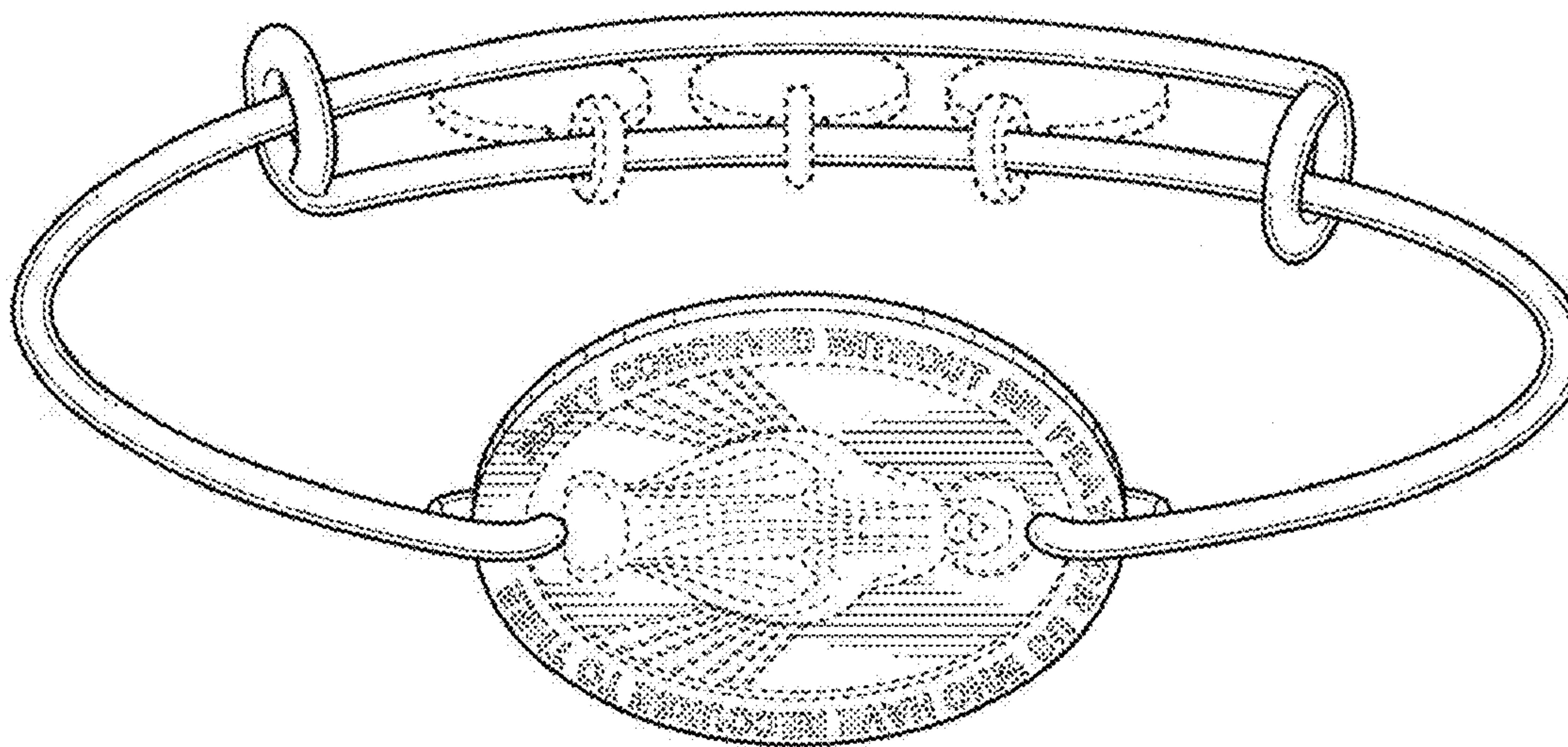

DESCRIPTION

FIG. 1 is a perspective view of a bracelet, showing my new design;

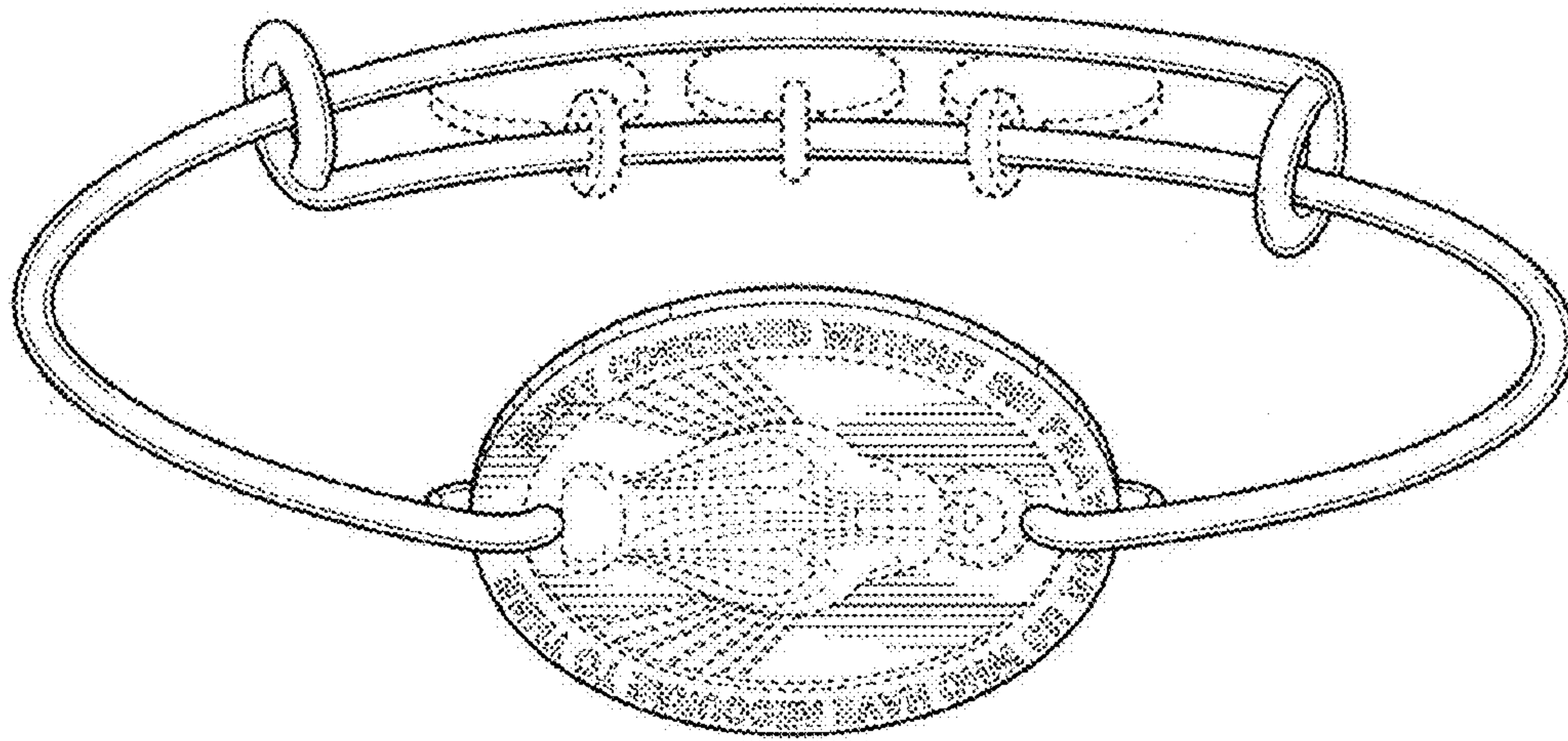

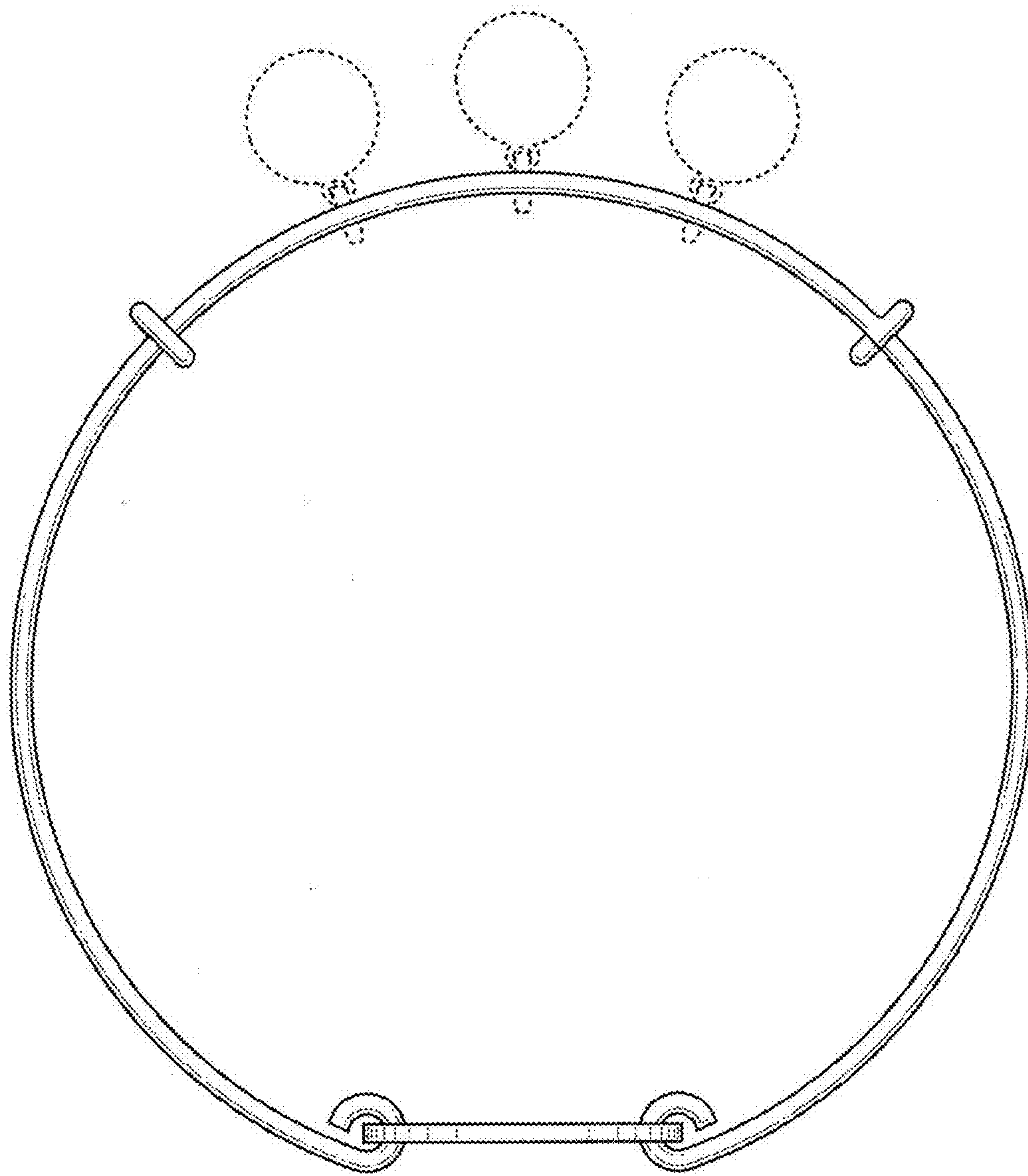

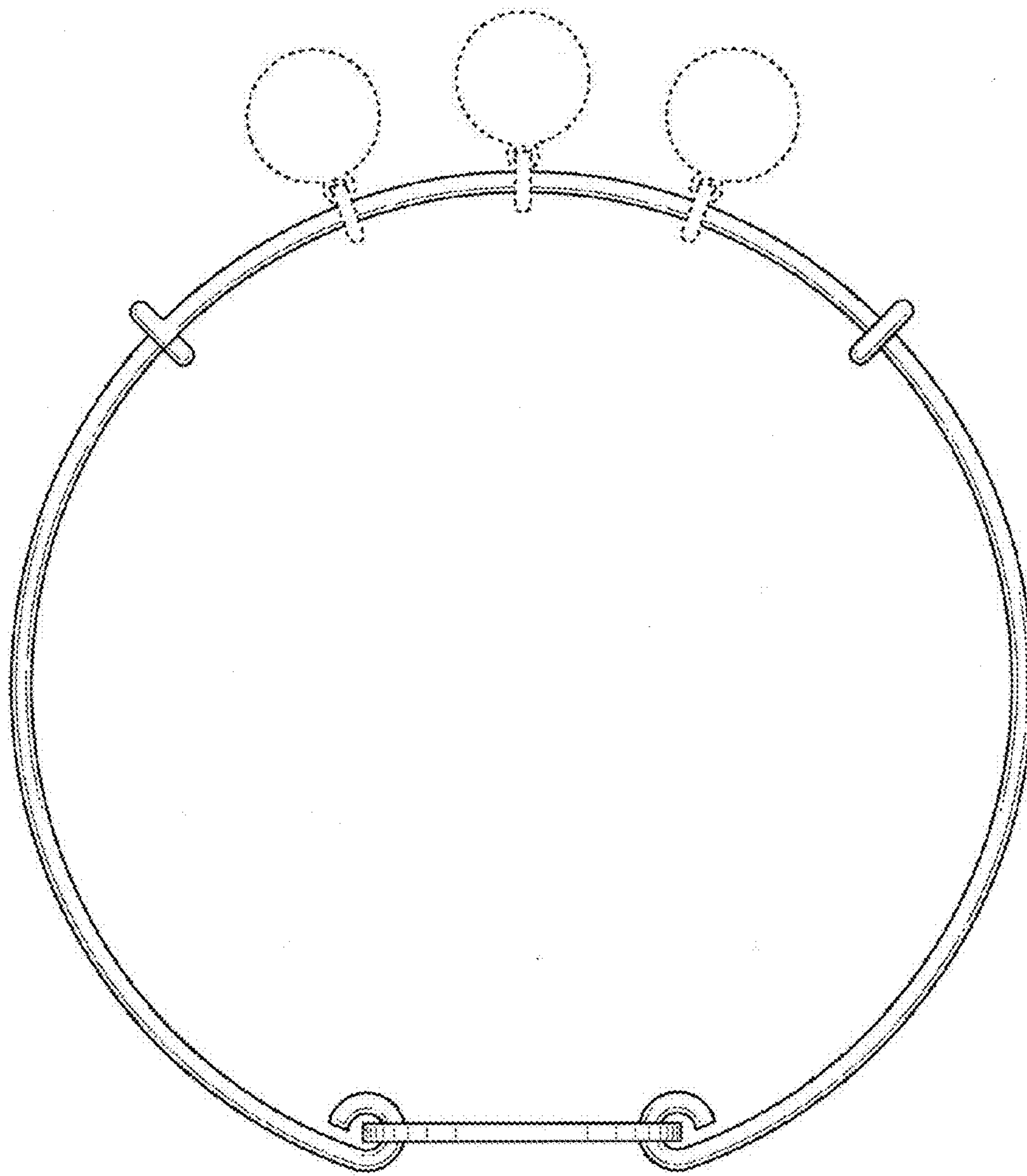

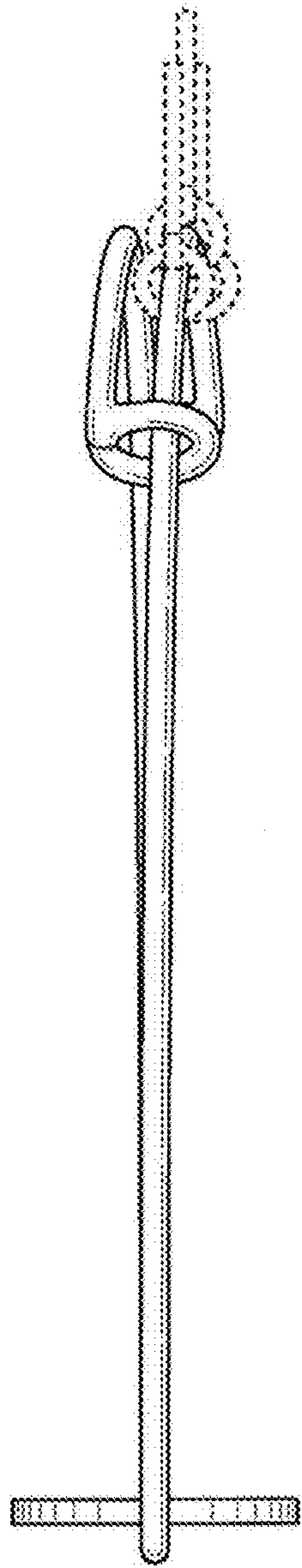

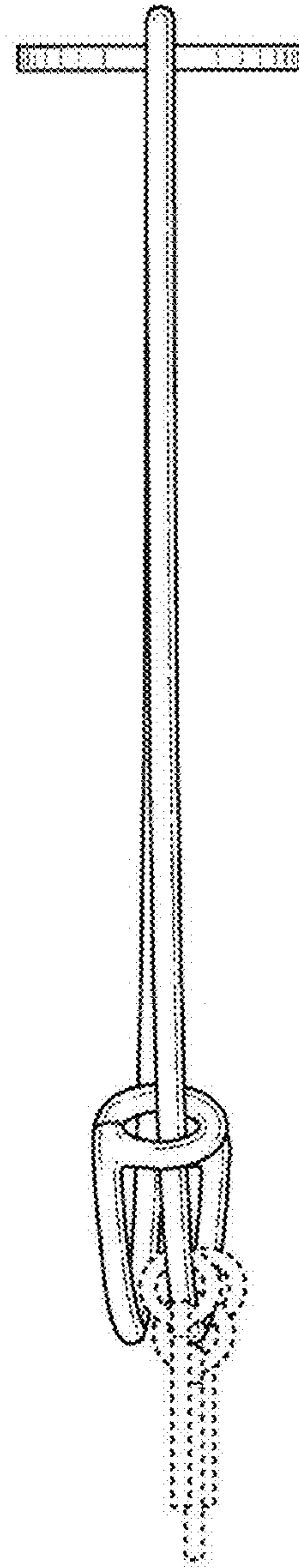

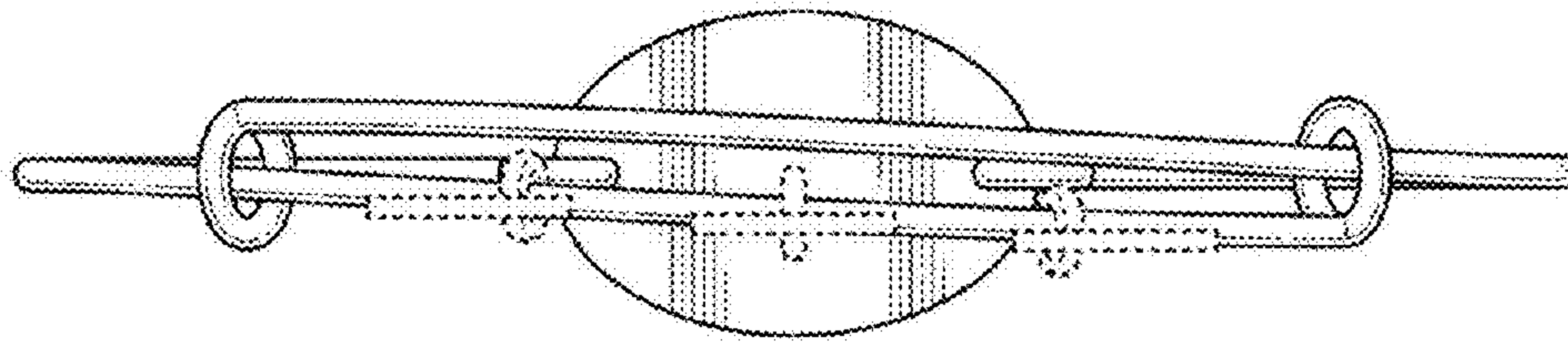

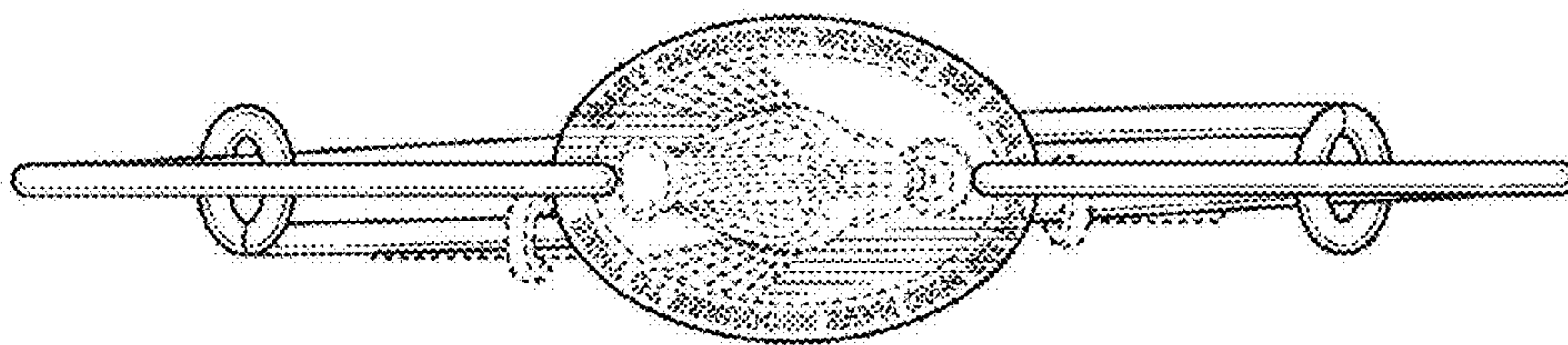
