DESCRIPTION

FIG. 1 is a top plan view of a vehicle exterior;
FIG. 2 is front elevational view of the vehicle exterior;
FIG. 3 is rear elevational view of the vehicle exterior;
FIG. 4 is a left side elevational view of the vehicle exterior;
FIG. 5 is a right side elevational view of the vehicle exterior;
FIG. 6 is a front-top-left side perspective view of the vehicle exterior; and,

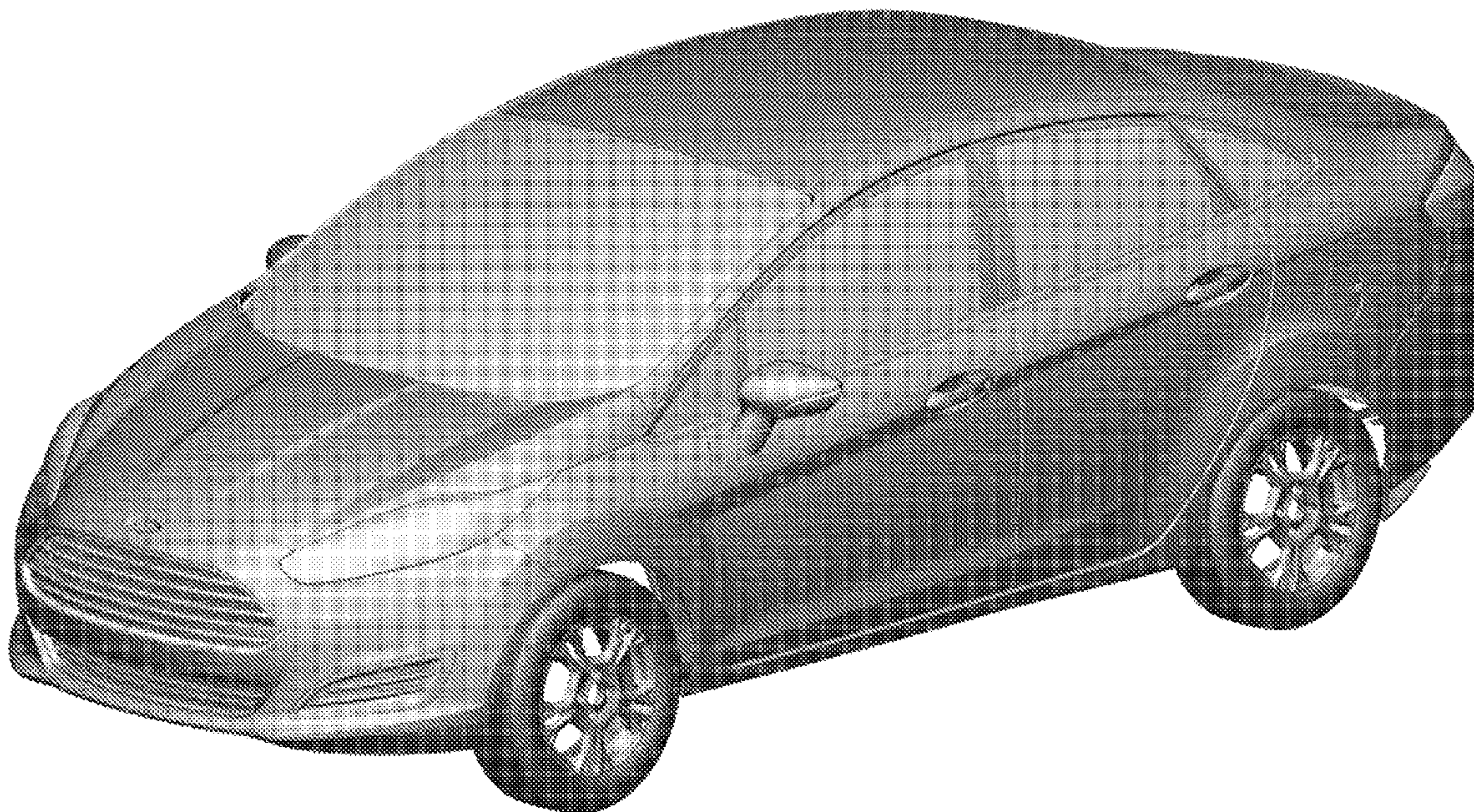

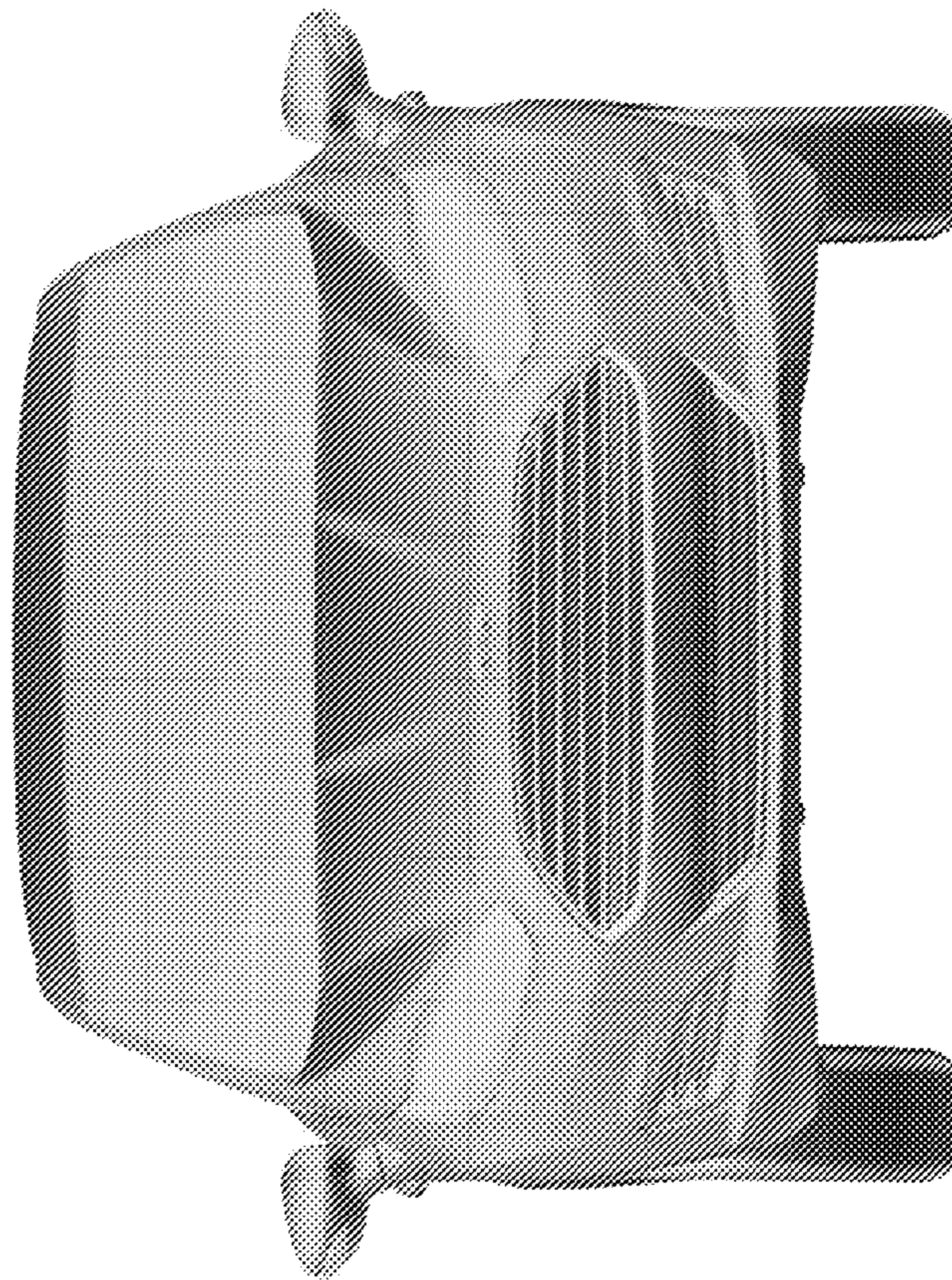

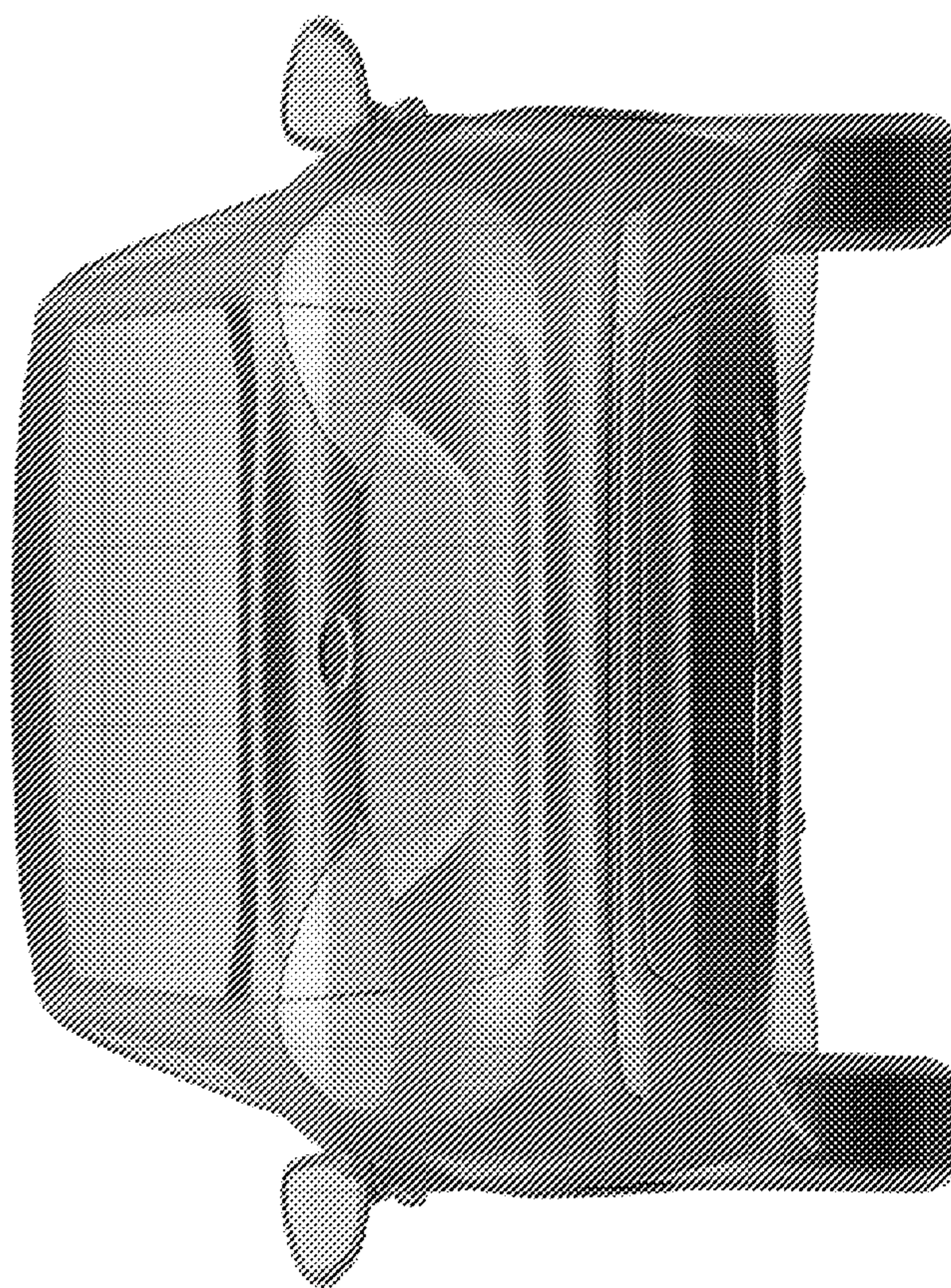

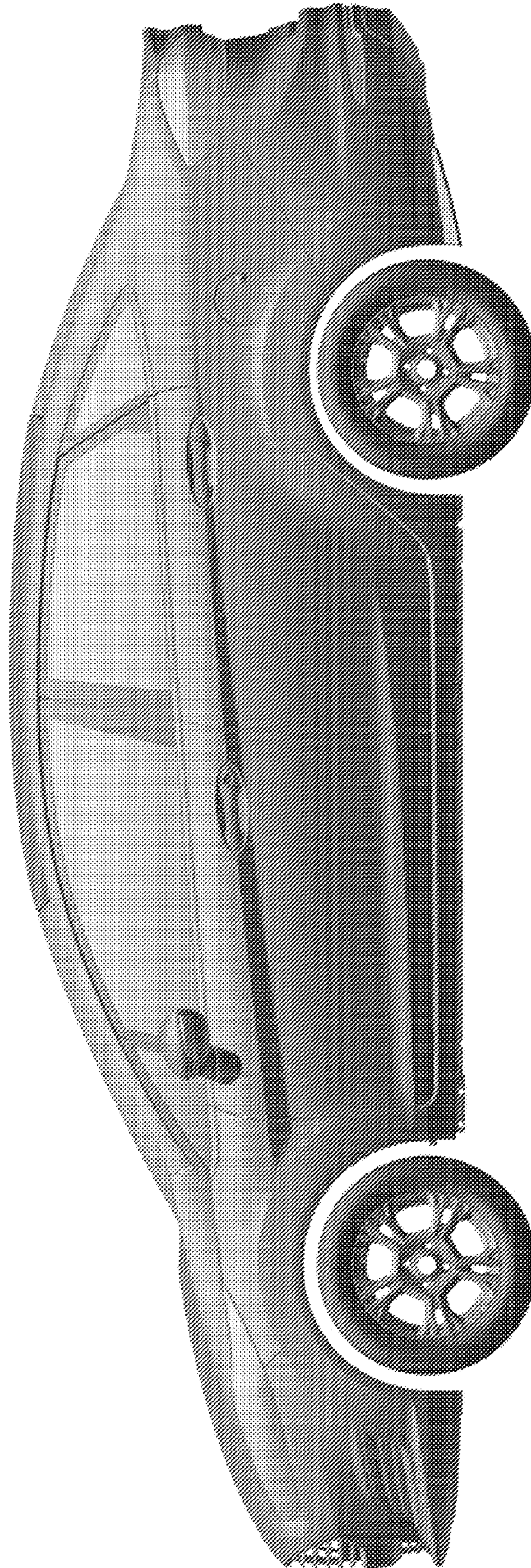

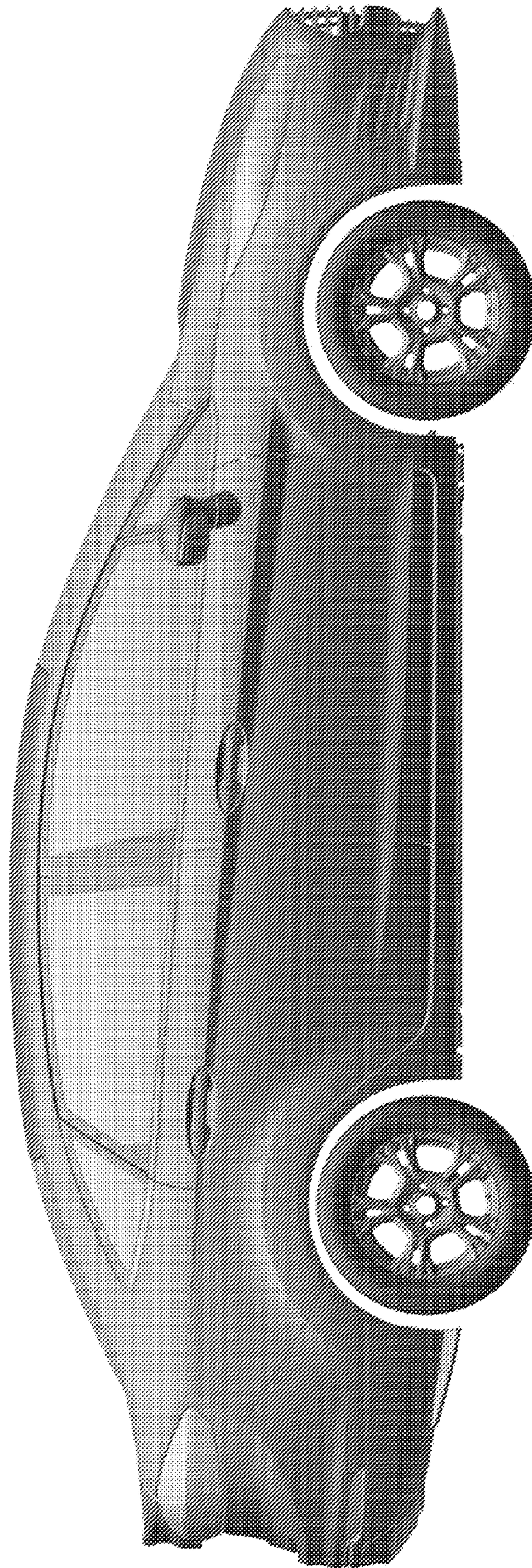

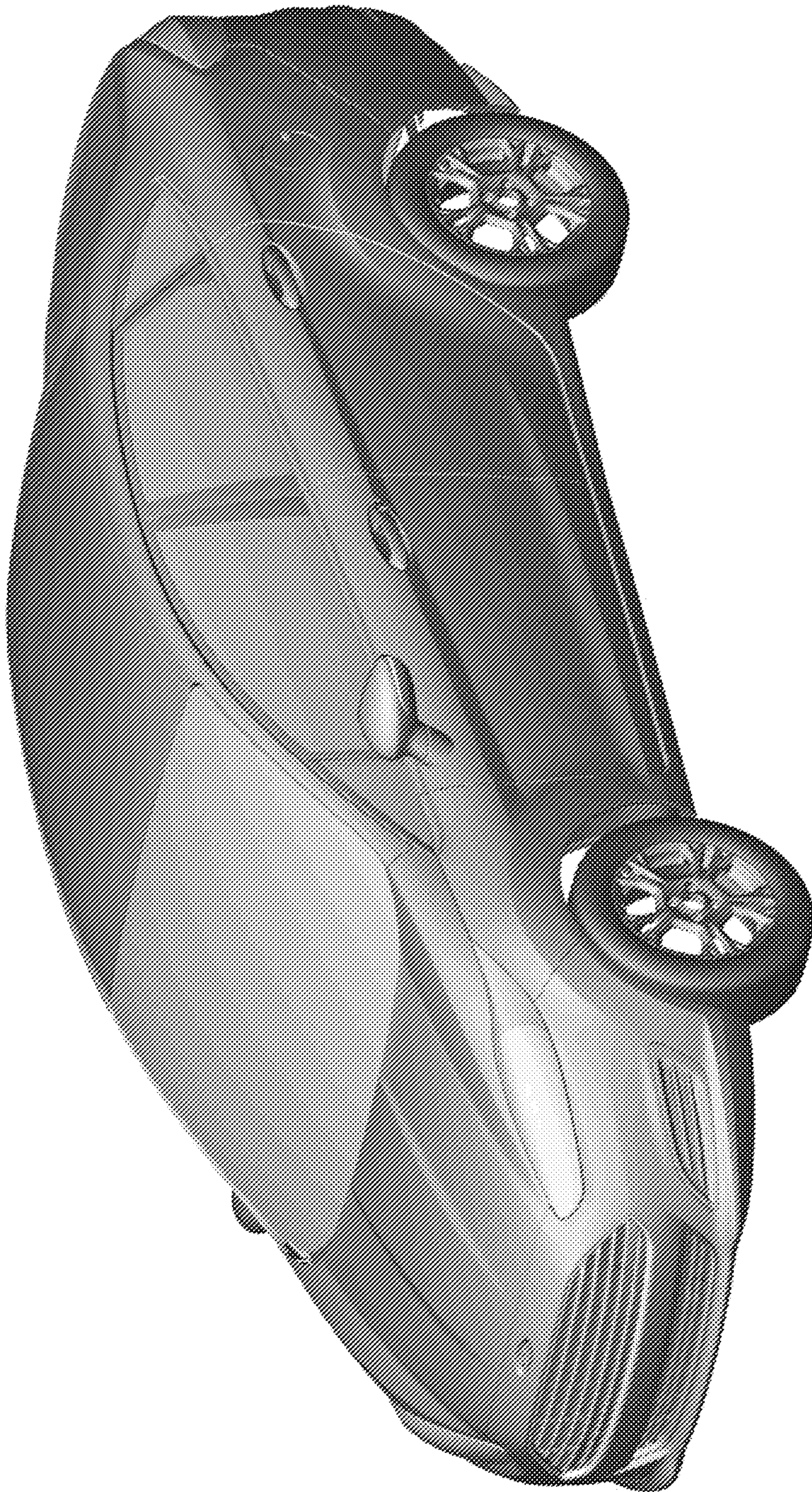

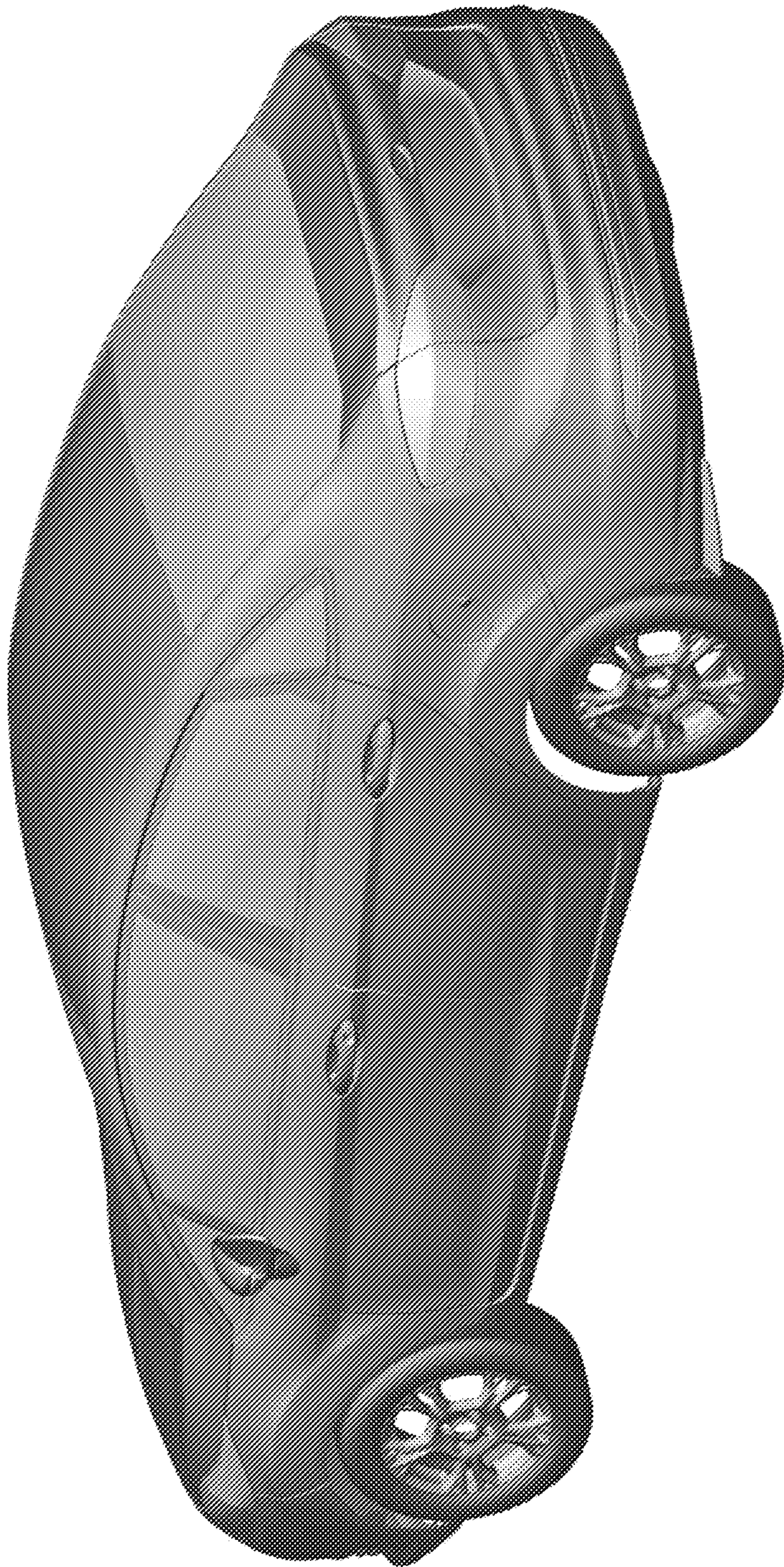
