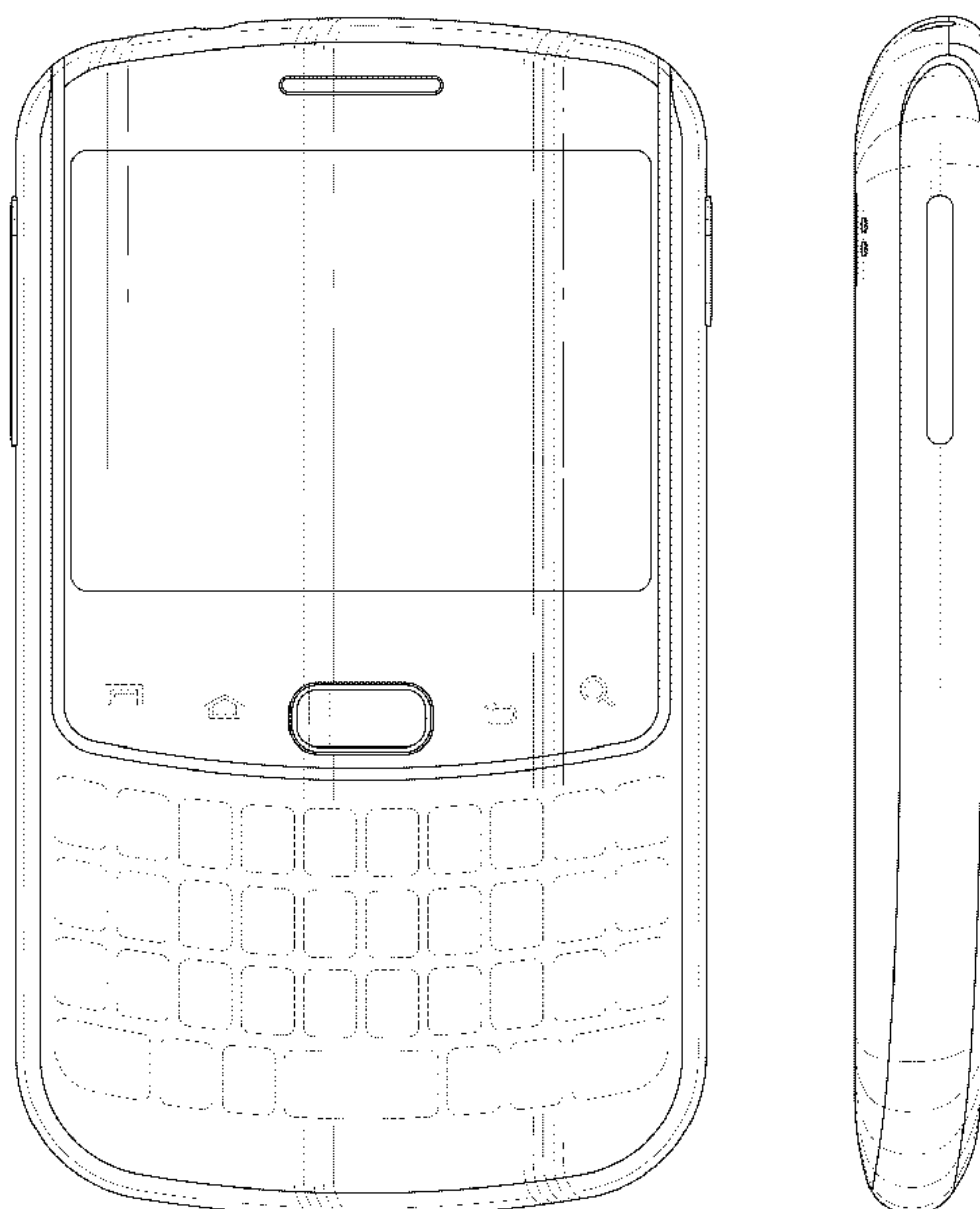
(57) **CLAIM**

The ornamental design for a mobile terminal, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a mobile terminal; FIG. 2 is a front view of the mobile terminal of FIG. 1; FIG. 3 is a rear view of the mobile terminal of FIG. 1; FIG. 4 is a left-side view of the mobile terminal of FIG. 1; FIG. 5 is a right-side view of the mobile terminal of FIG. 1; FIG. 6 is a top plan view of the mobile terminal of FIG. 1; and, FIG. 7 is a bottom plan view of the mobile terminal of FIG. 1. The broken lines showing the keys, which are immediately adjacent to the shaded areas and define consistently unshaded regions, represent the bounds of the claim, while the broken lines showing icons are directed to environment superimposed on a claimed surface and are for illustrative purposes only; the broken lines form no part of the claimed design.

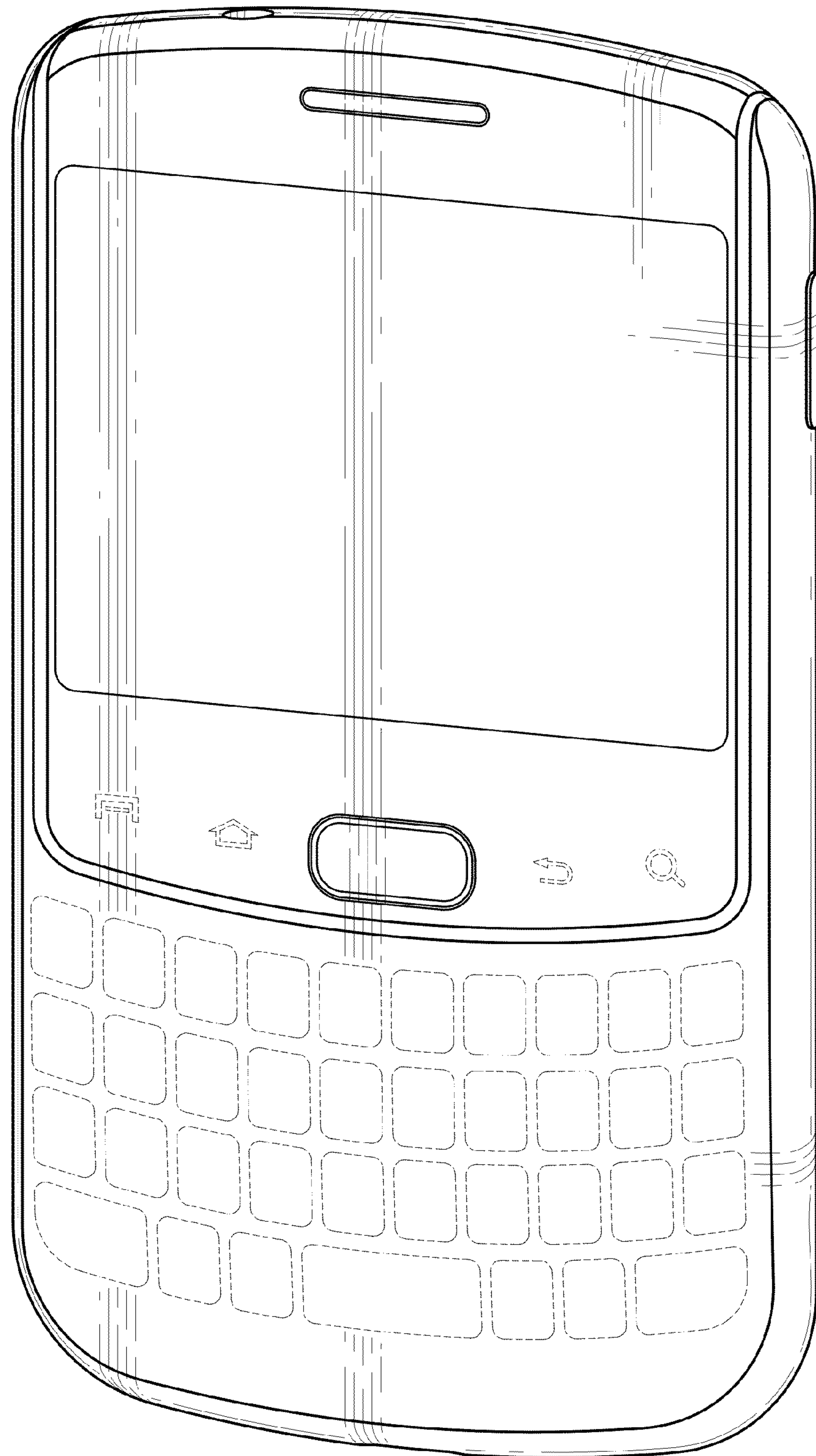

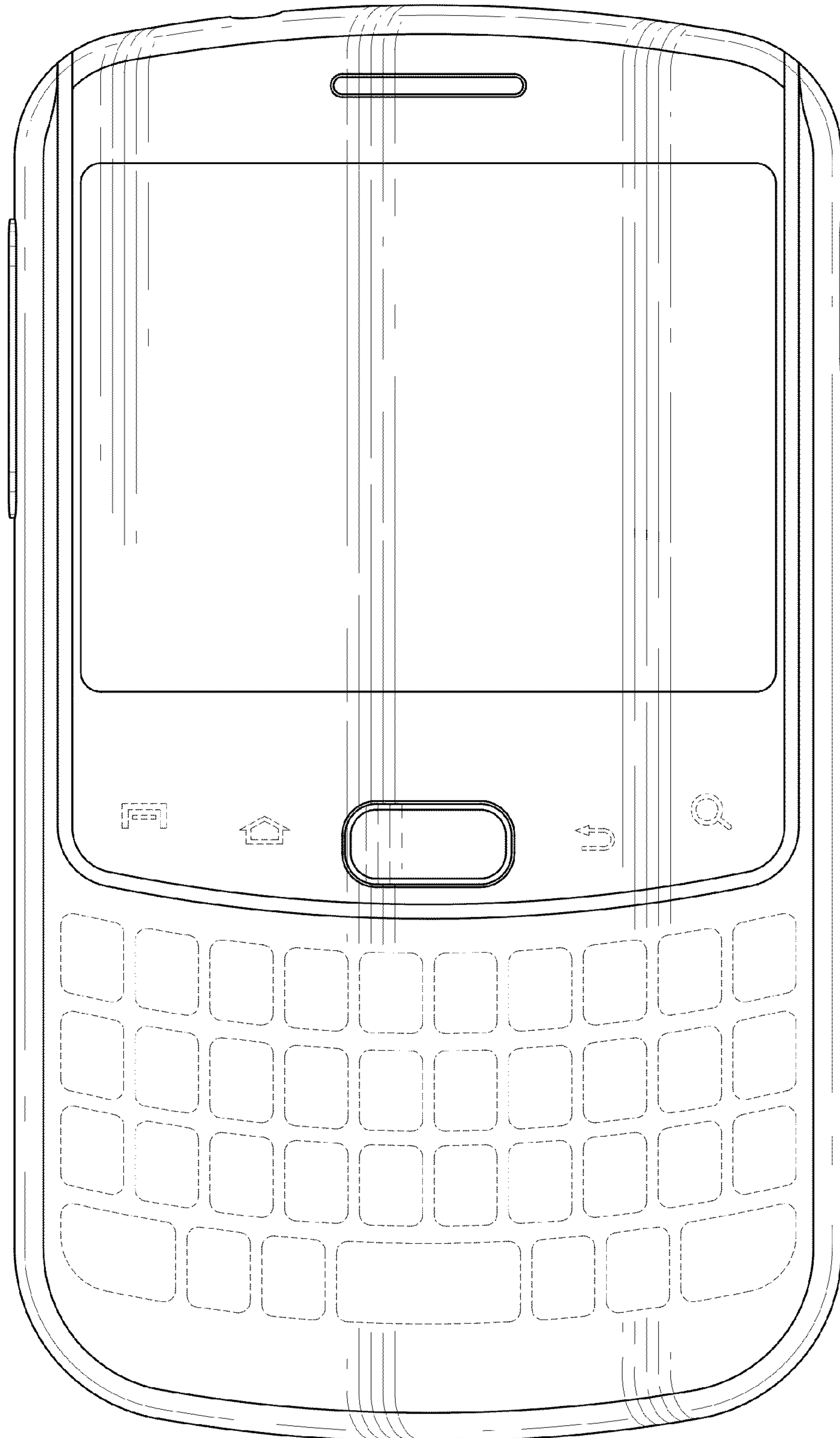

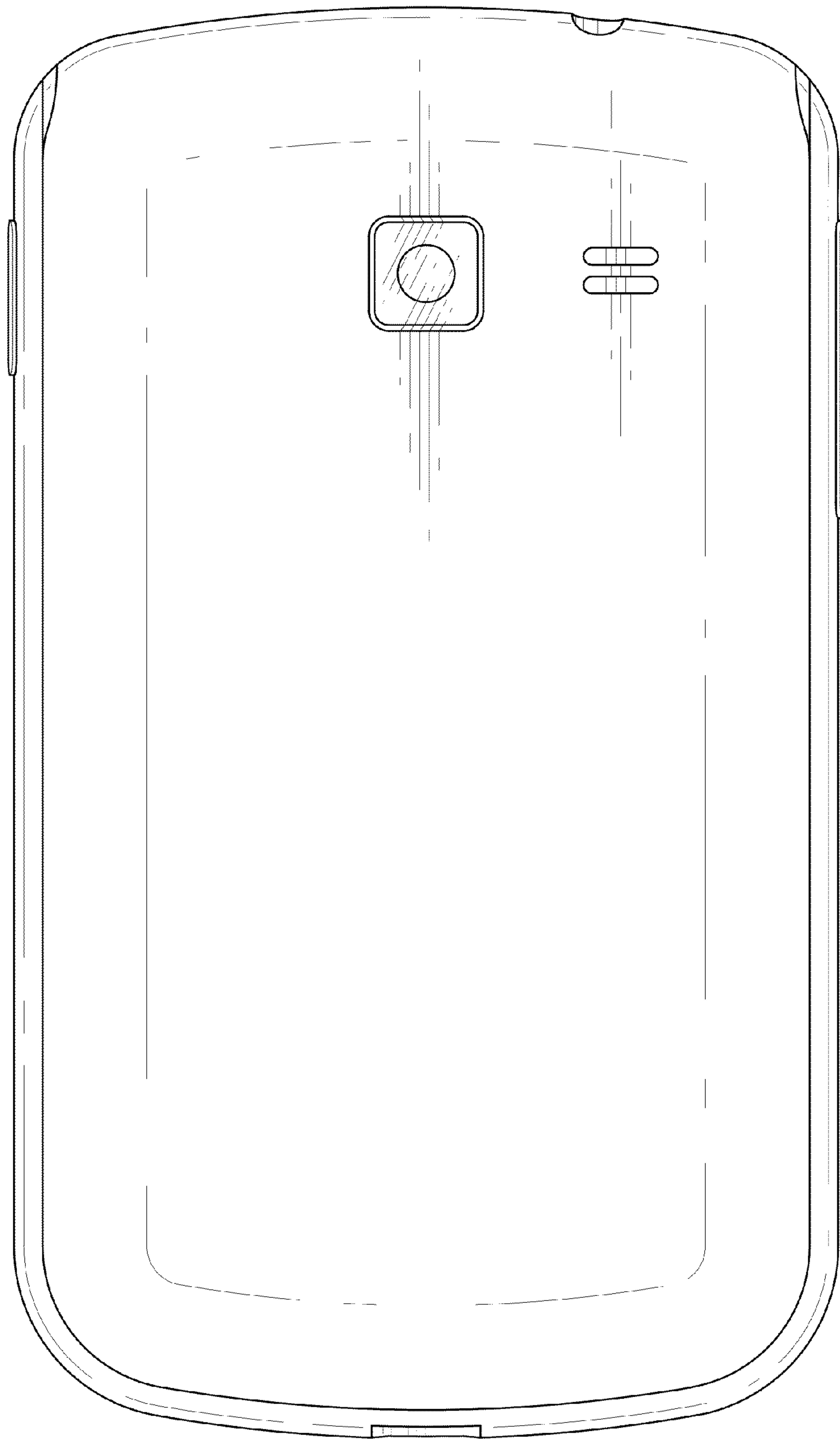

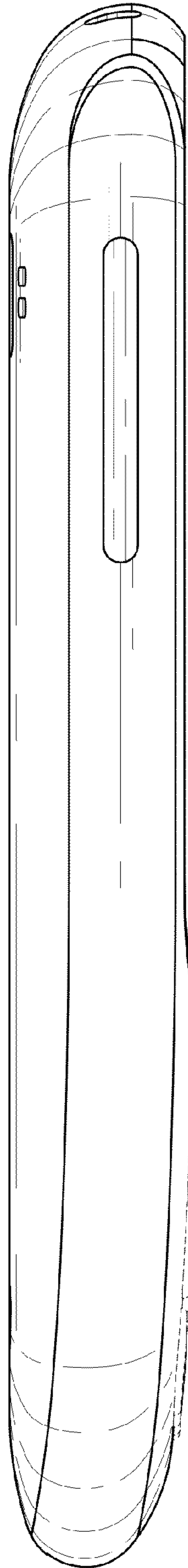

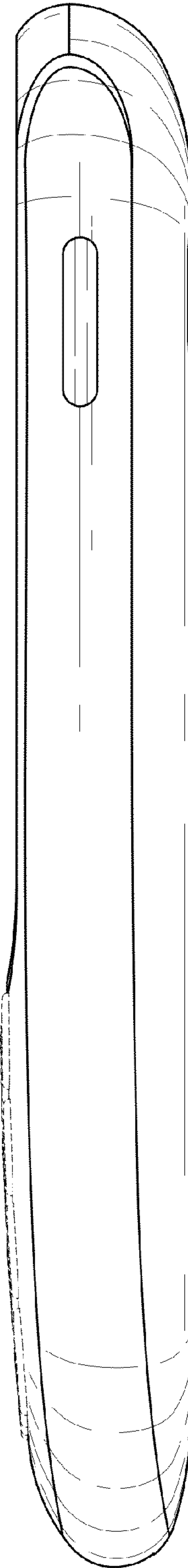

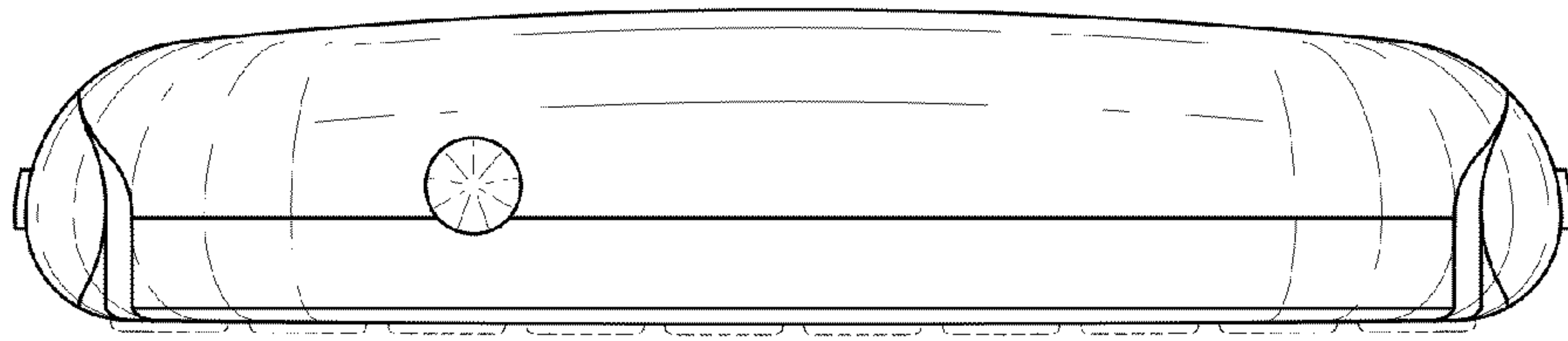
