DESCRIPTION

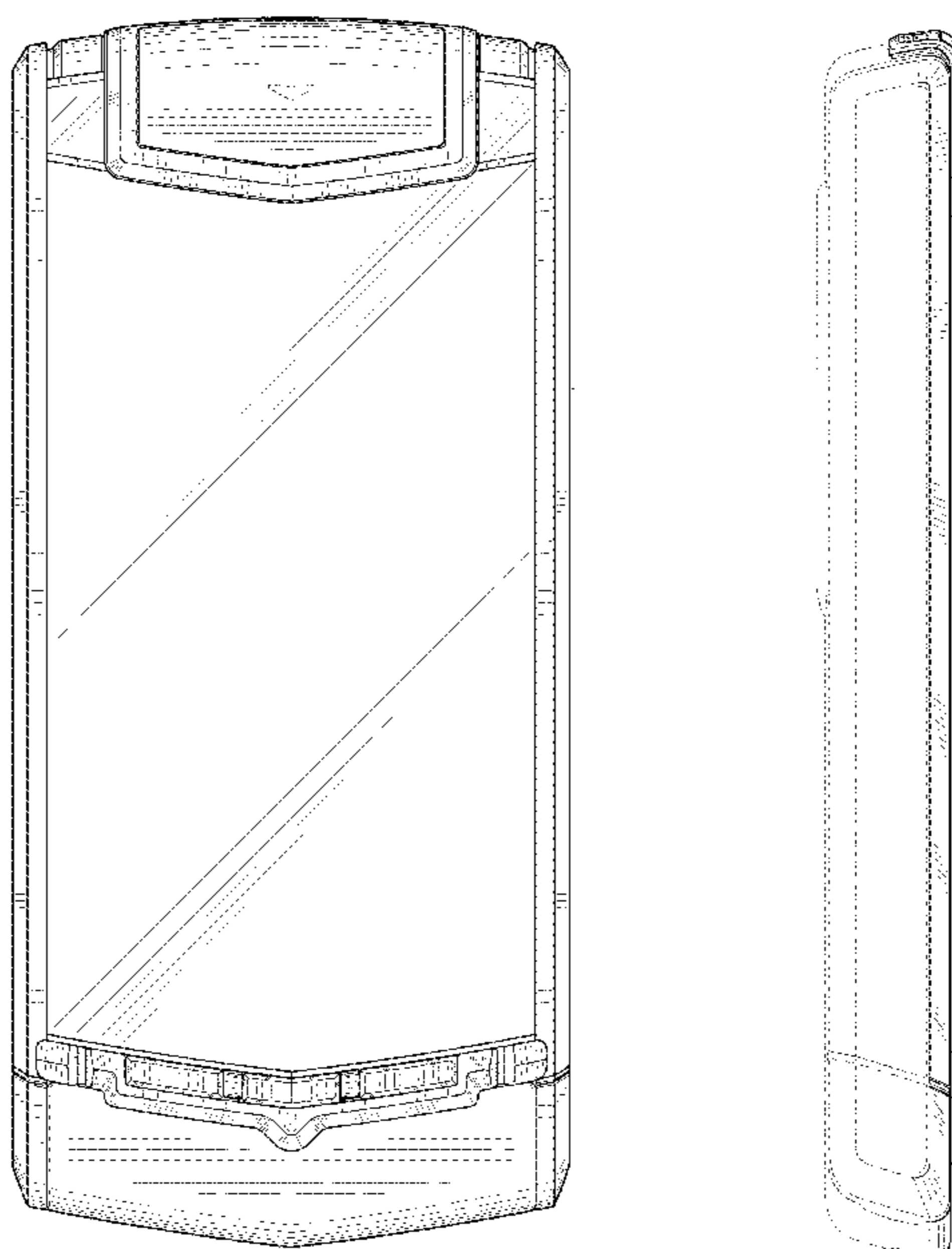
FIG. 1 is a perspective view of a handset front cover showing our new design;

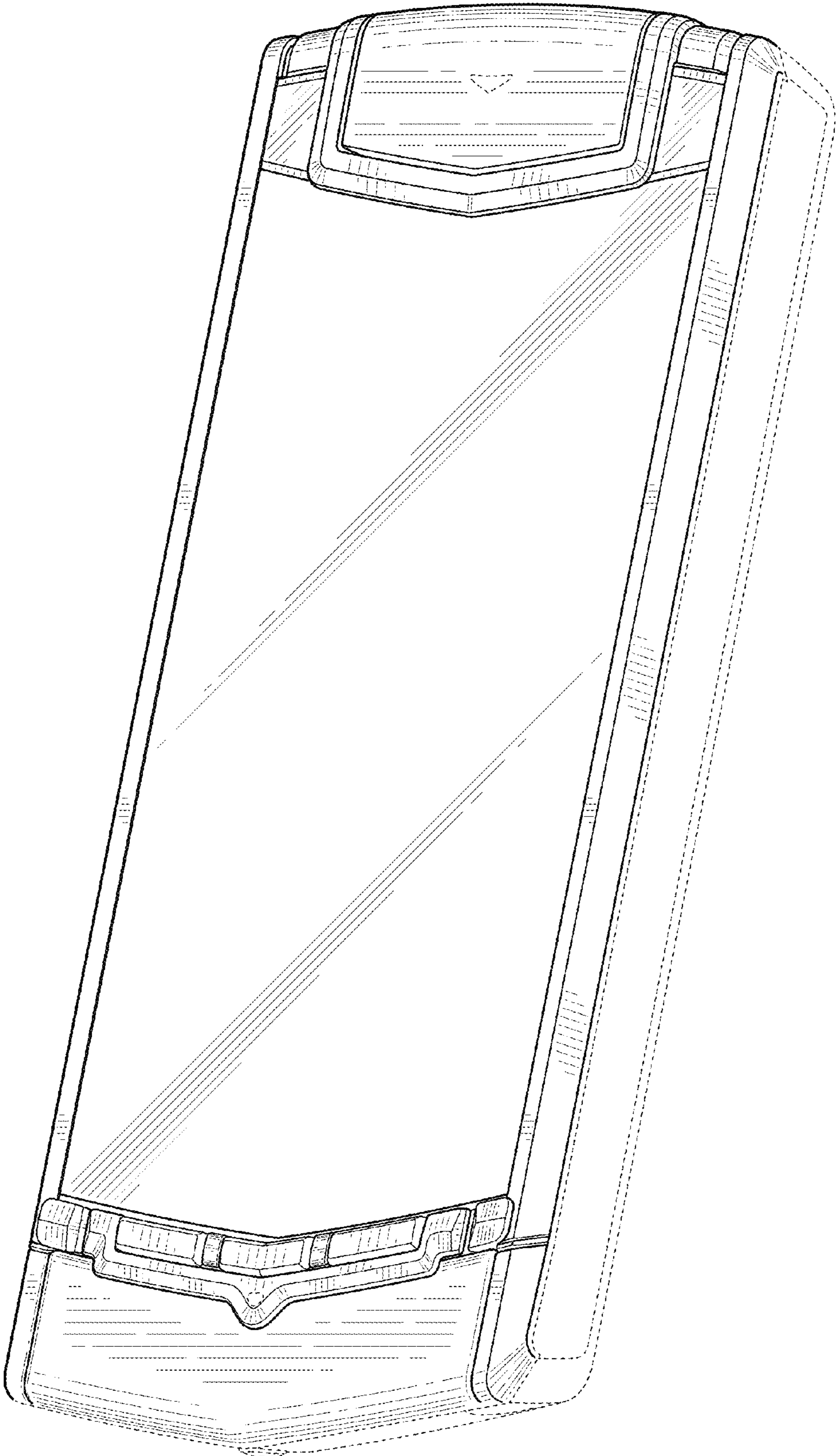

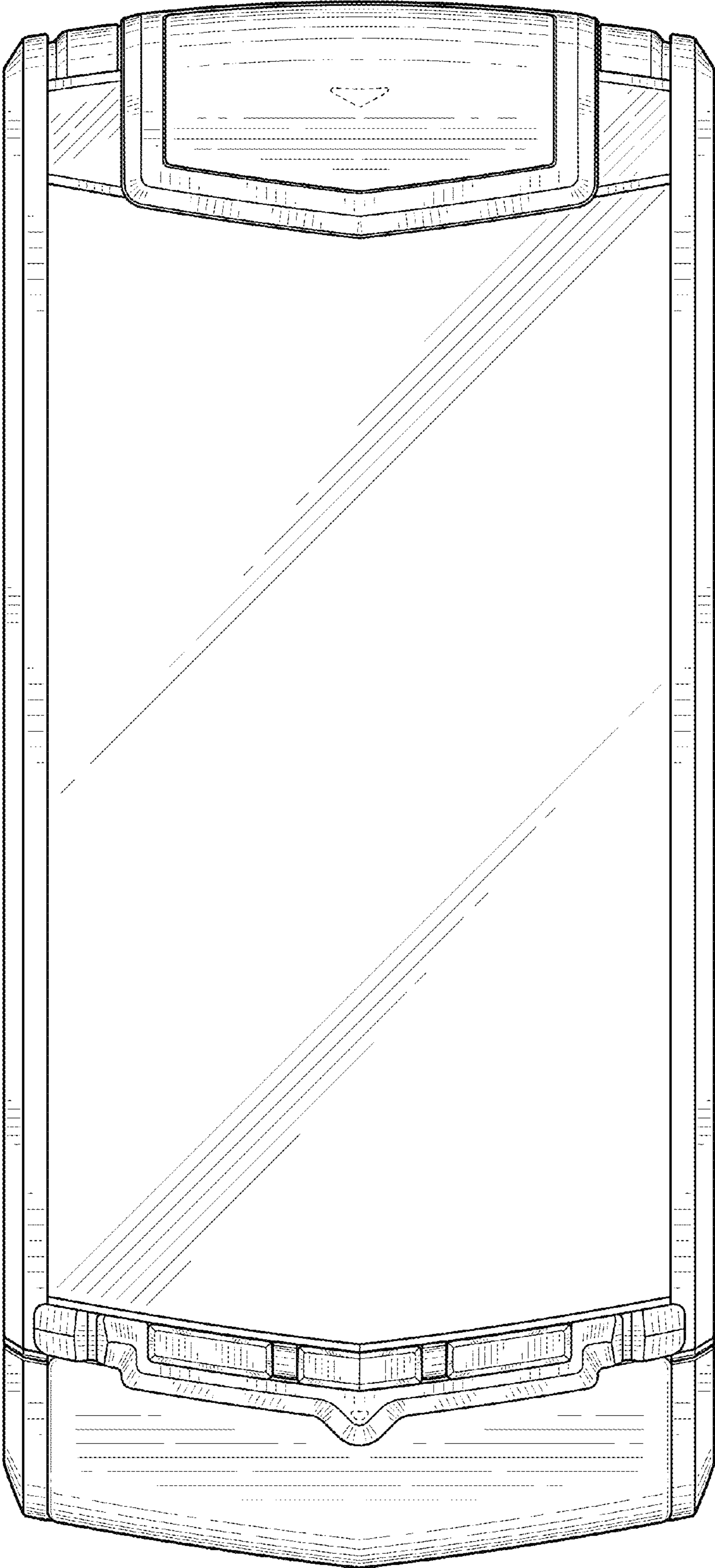

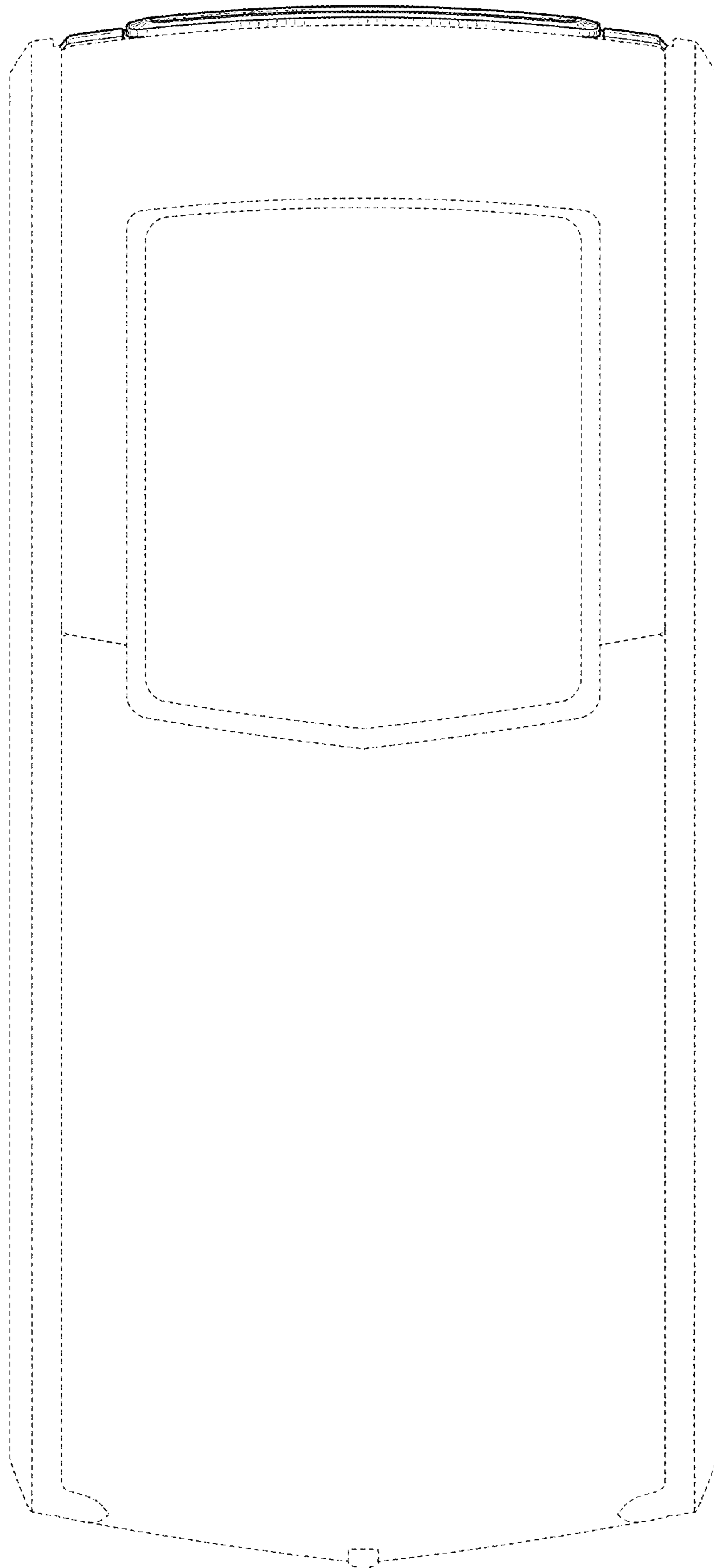

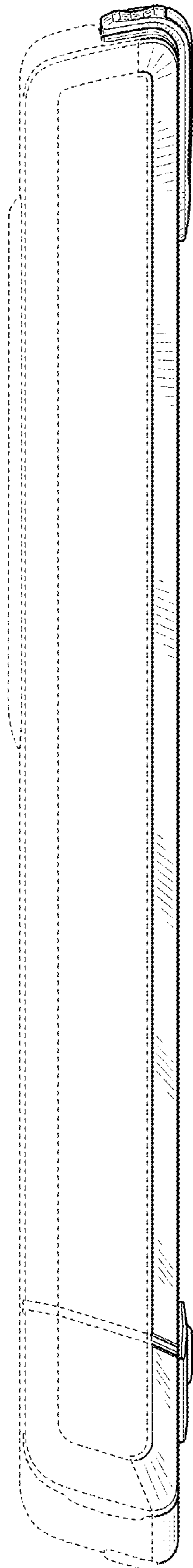

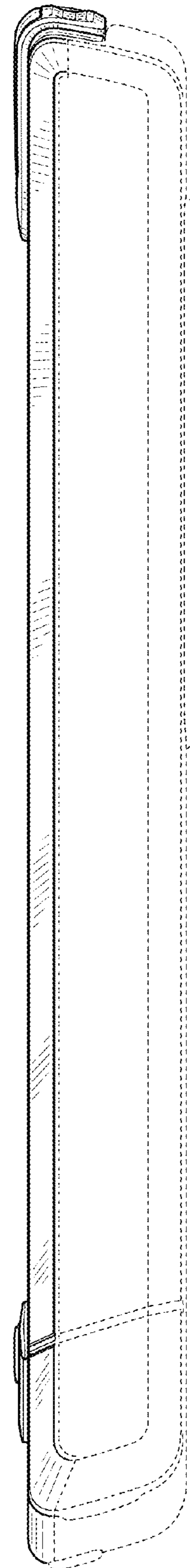

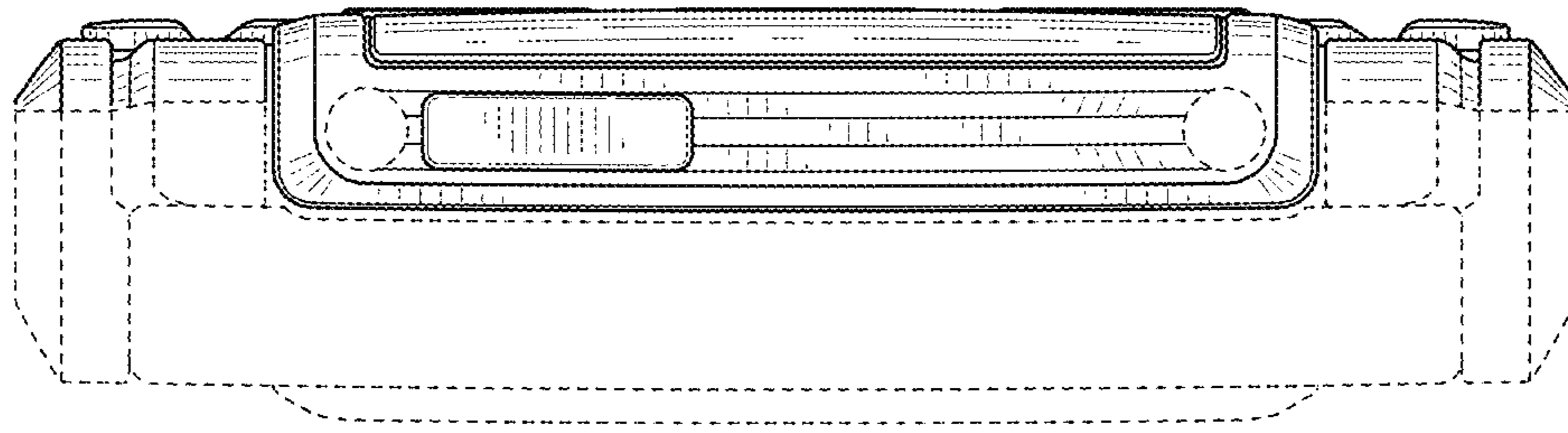

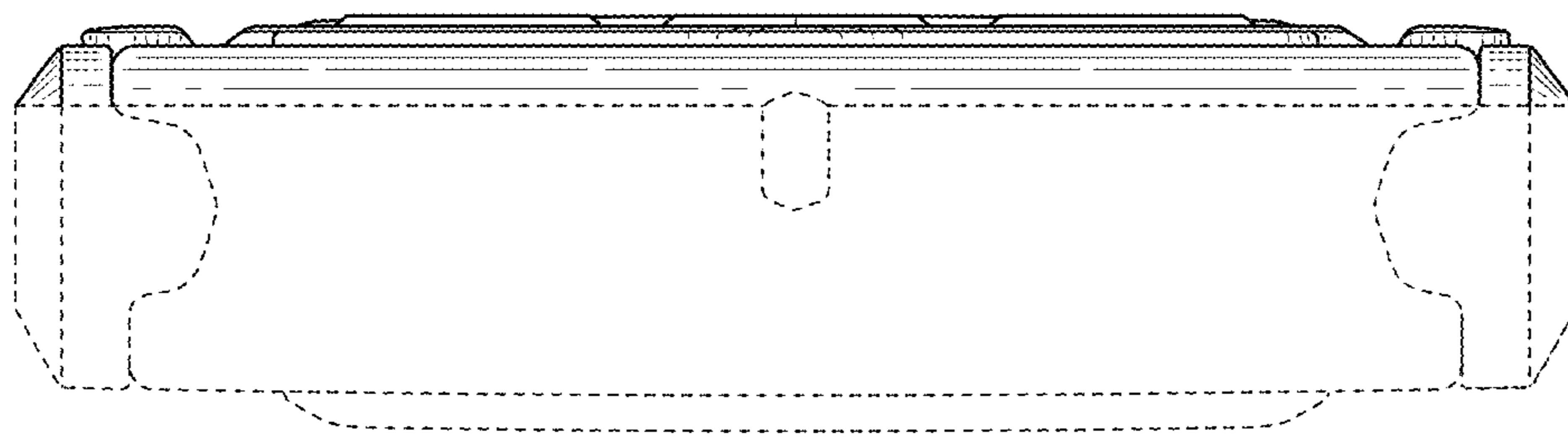
