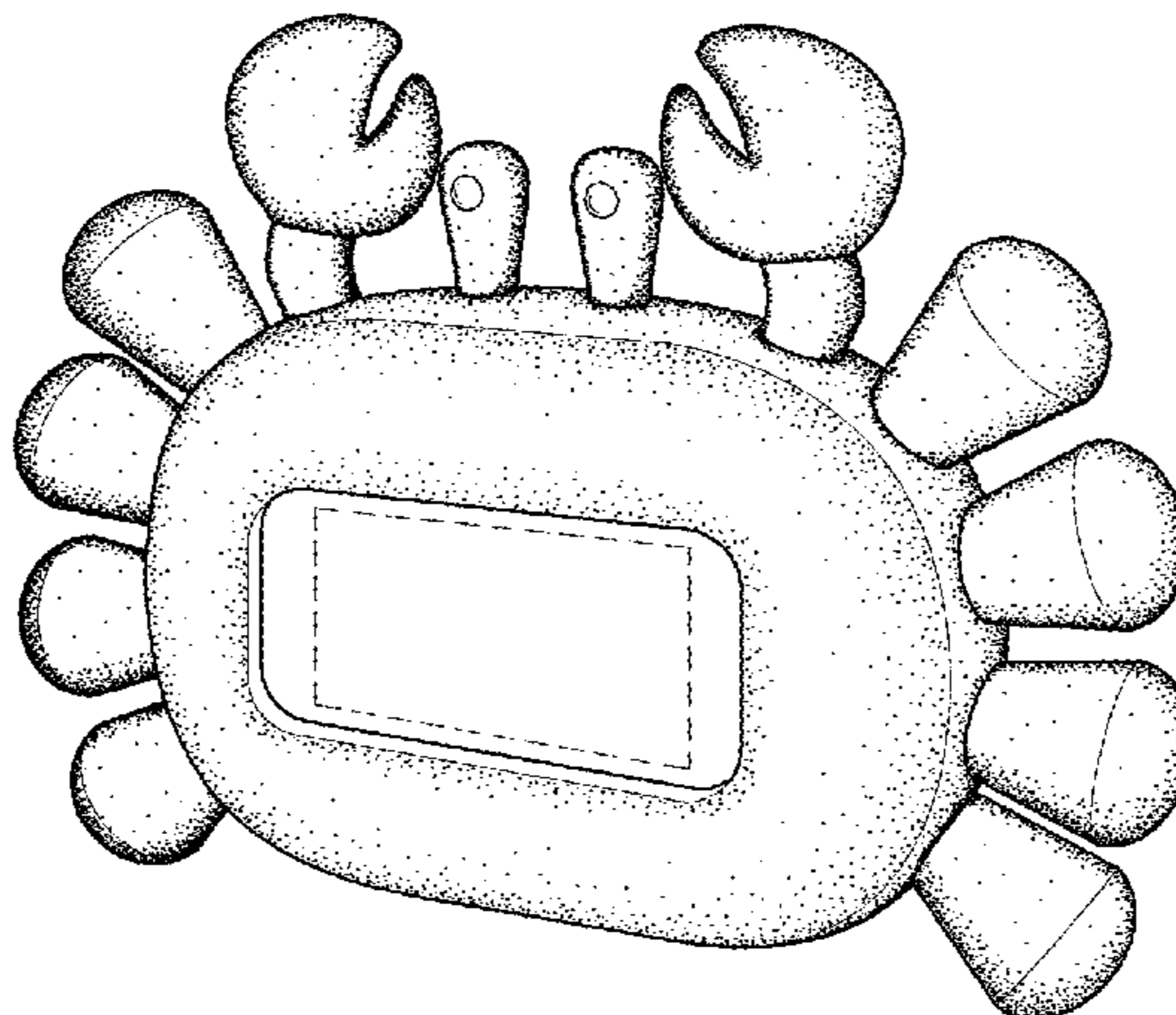

(57) **CLAIM**
The ornamental design for protective cover, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a protective cover showing the new design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a rear elevational view thereof;
FIG. 4 is a left side elevational view thereof;
FIG. 5 is a right side elevational view thereof;
FIG. 6 is a top plan view thereof;
FIG. 7 is a bottom plan view thereof; and,
FIG. 8 is a front perspective view thereof showing the protective cover in a state of use with an unclaimed display device within the protective cover.
In FIG. 8, the central unshaded surface and the broken lines on the central unshaded surface together depict the front surface of a display device that forms no part of the claimed design.

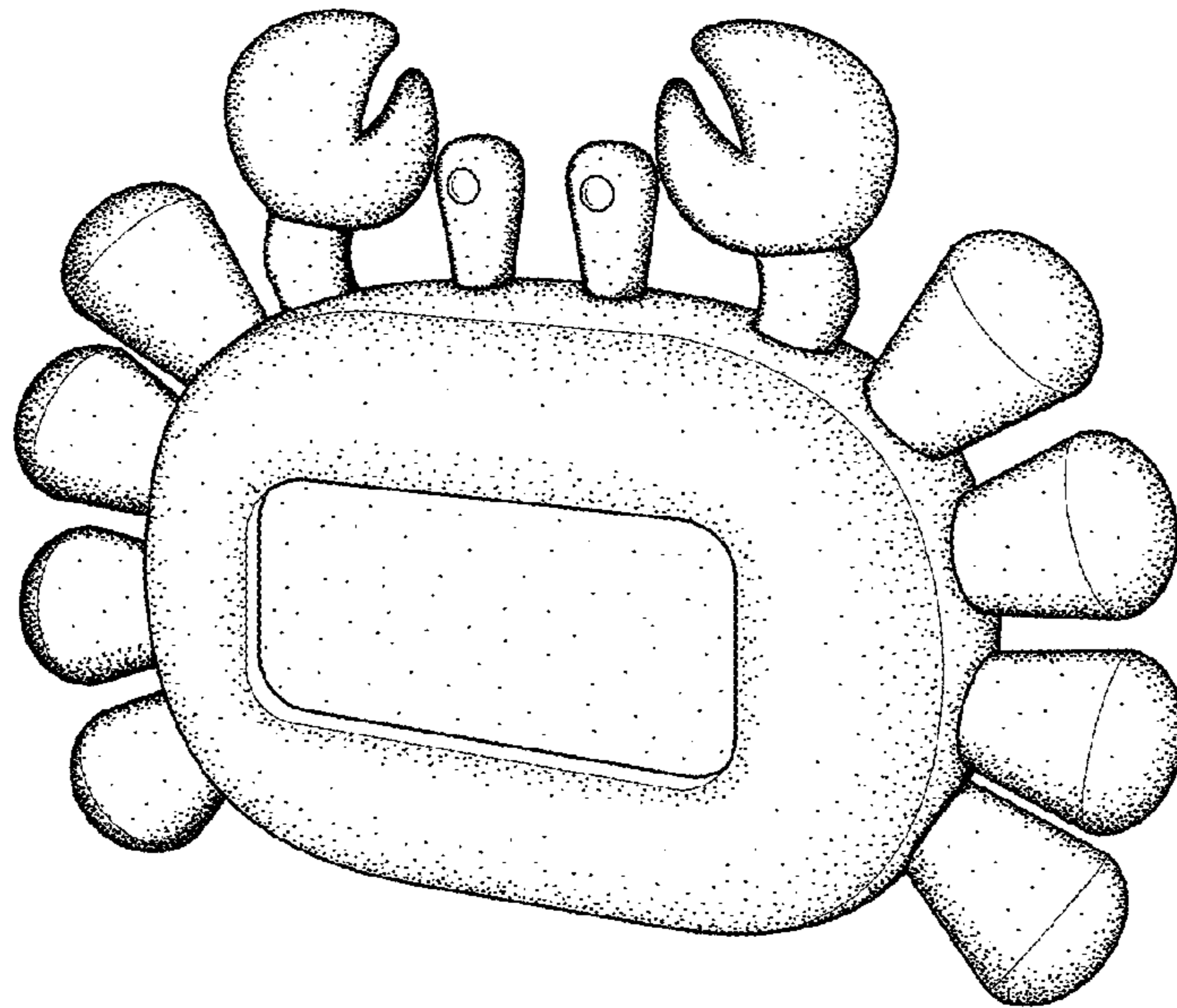

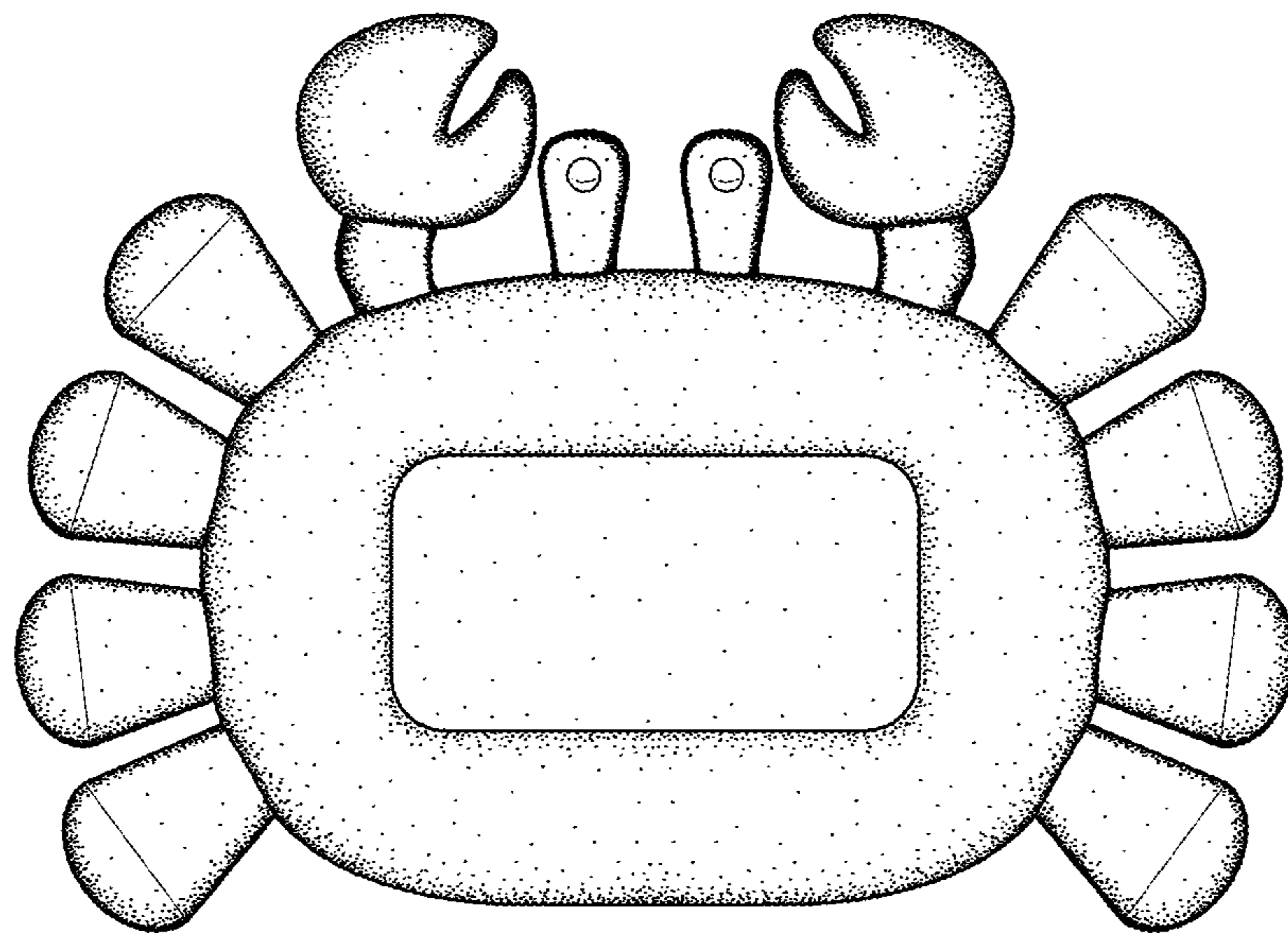

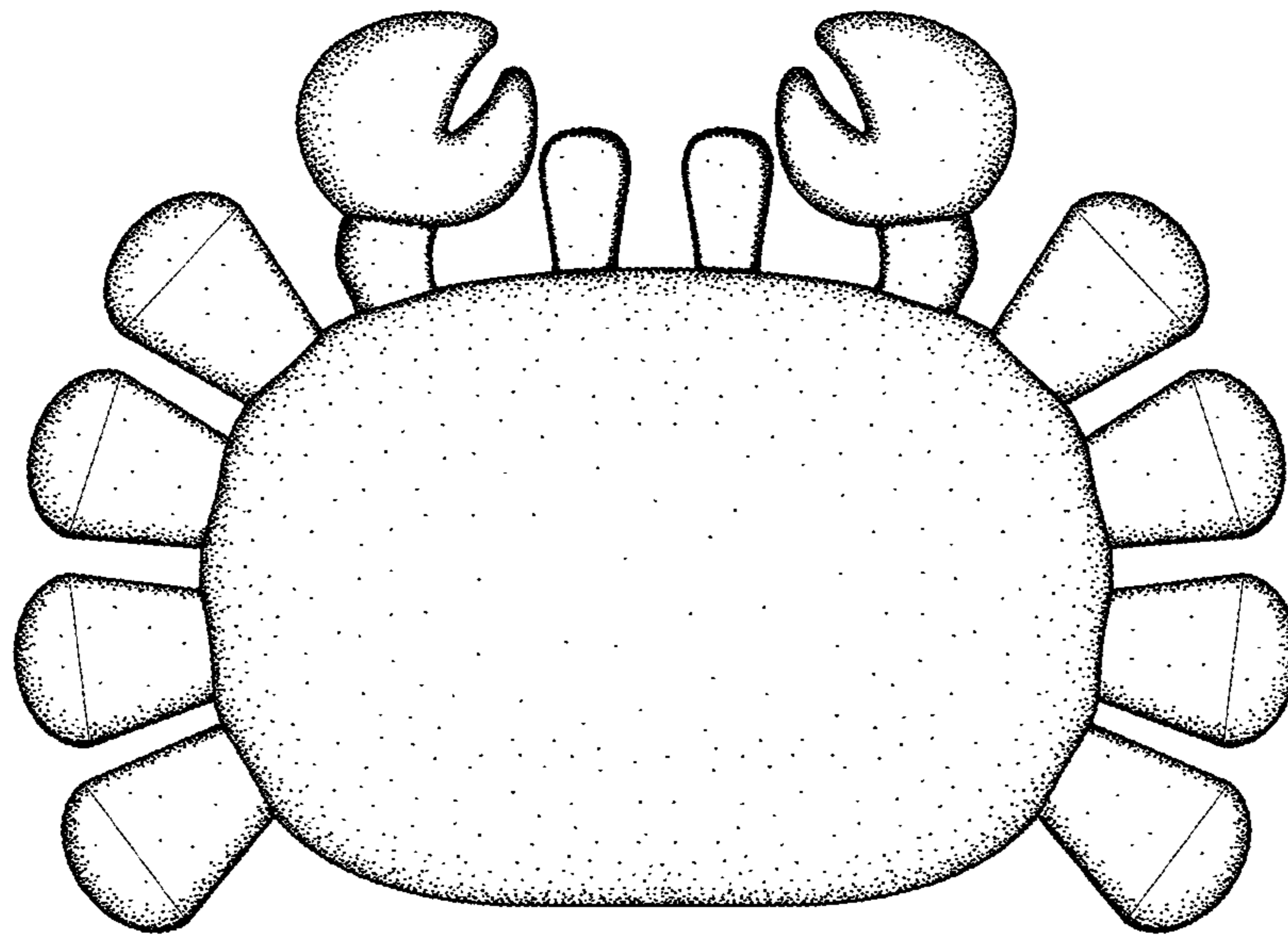

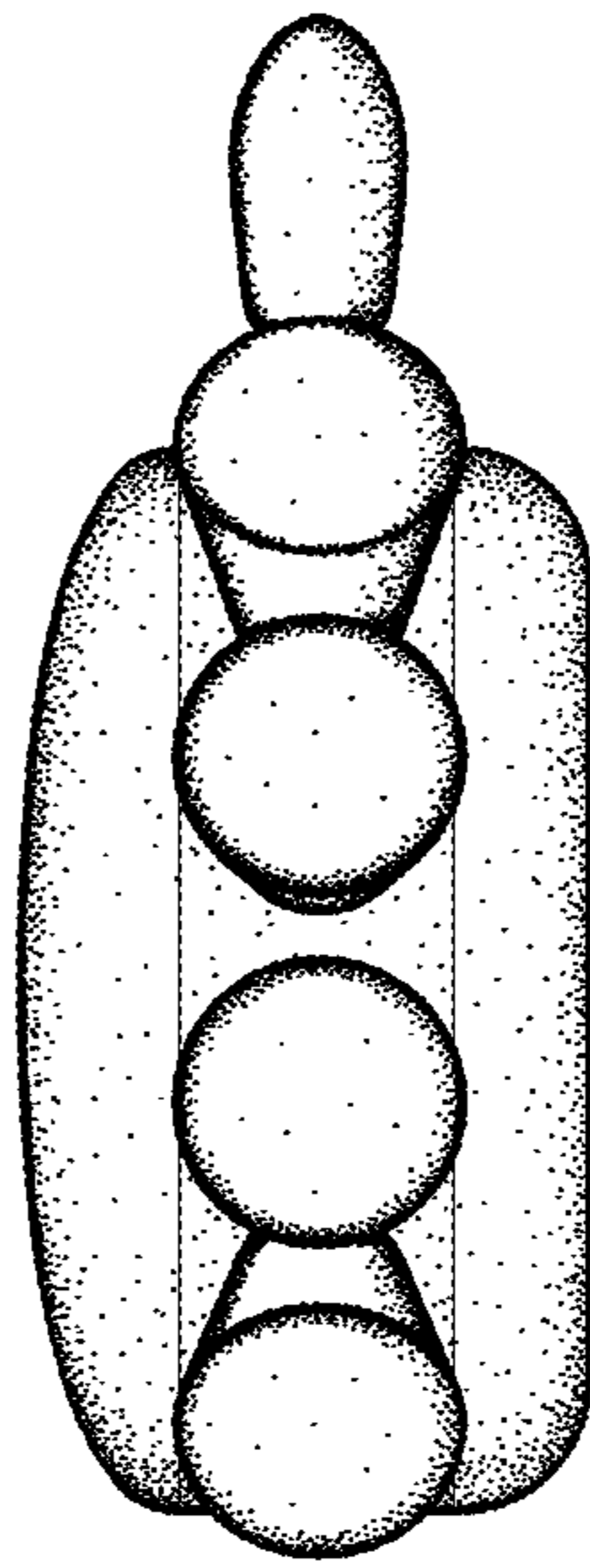

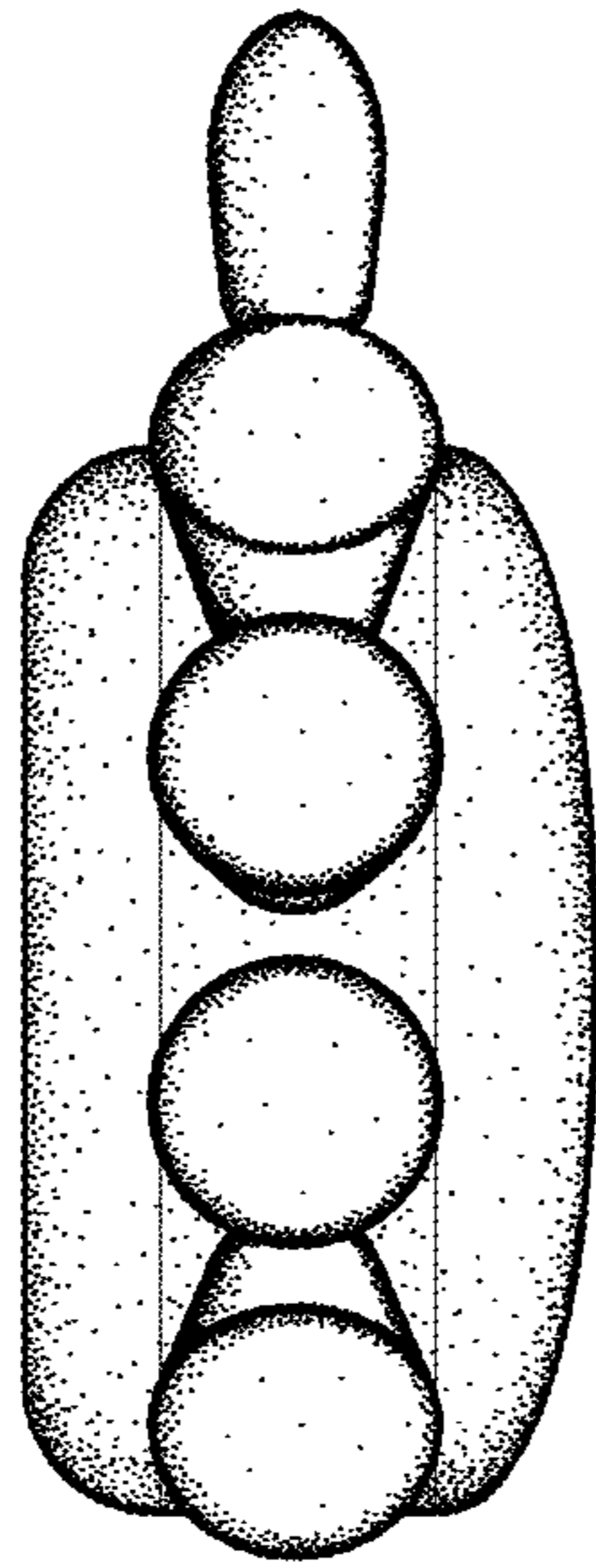

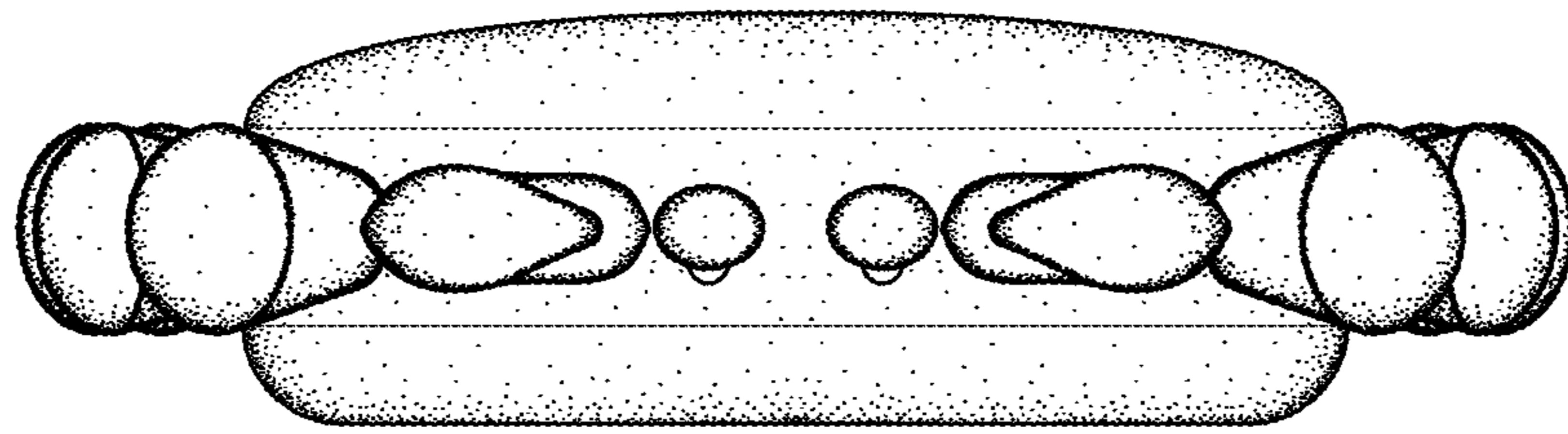

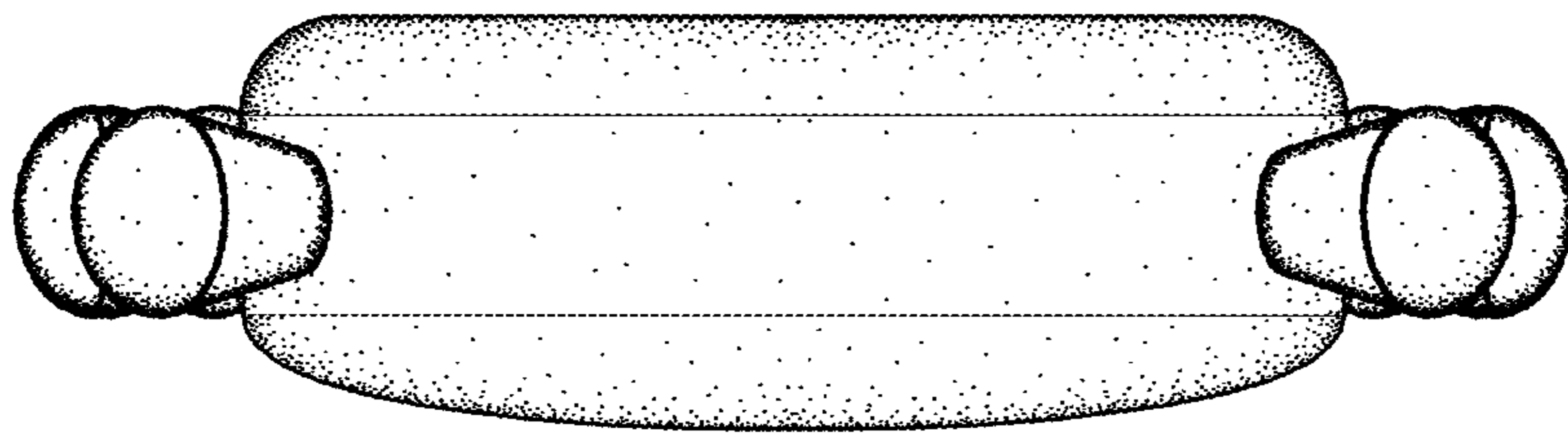

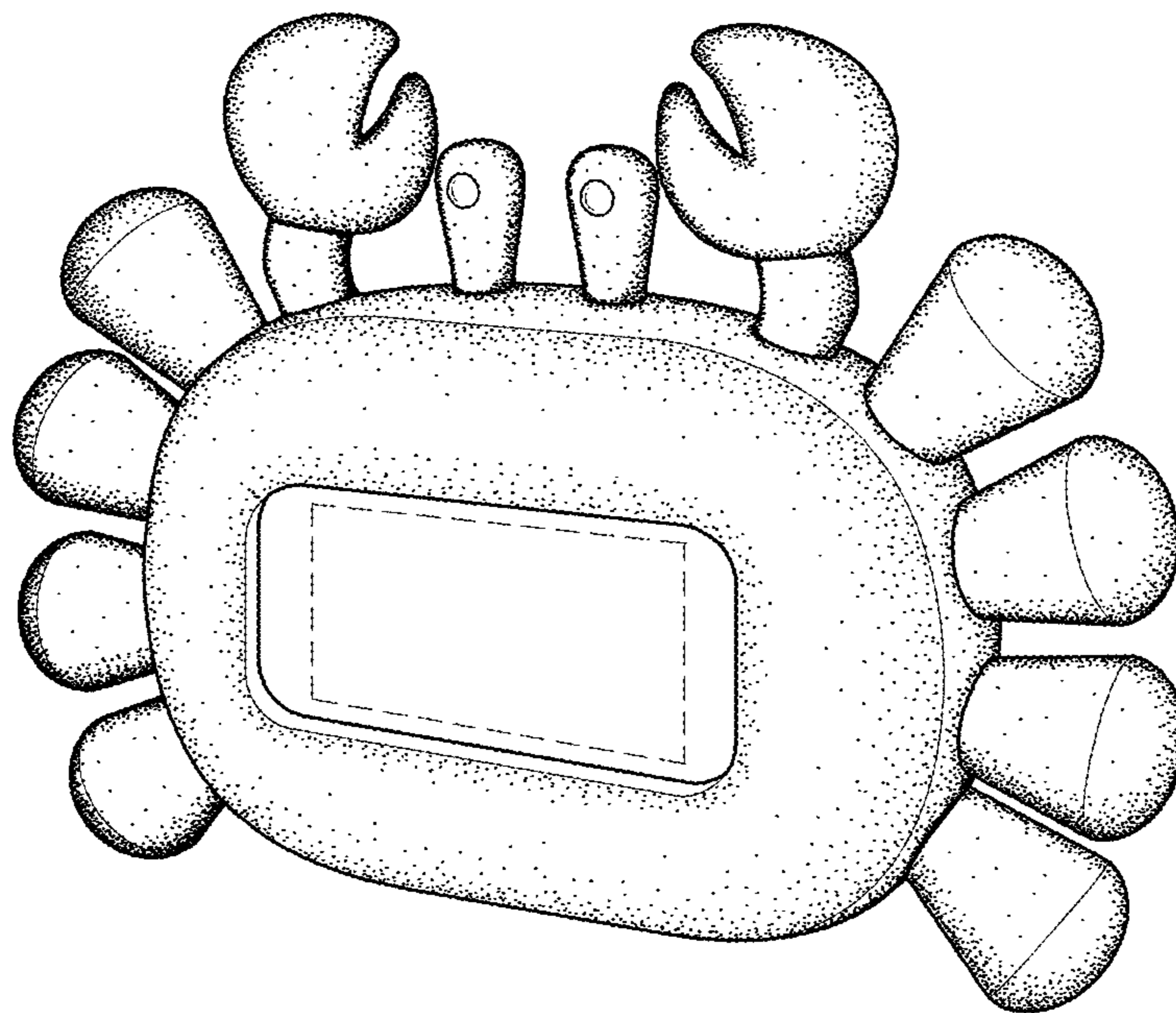
