(57) **CLAIM**

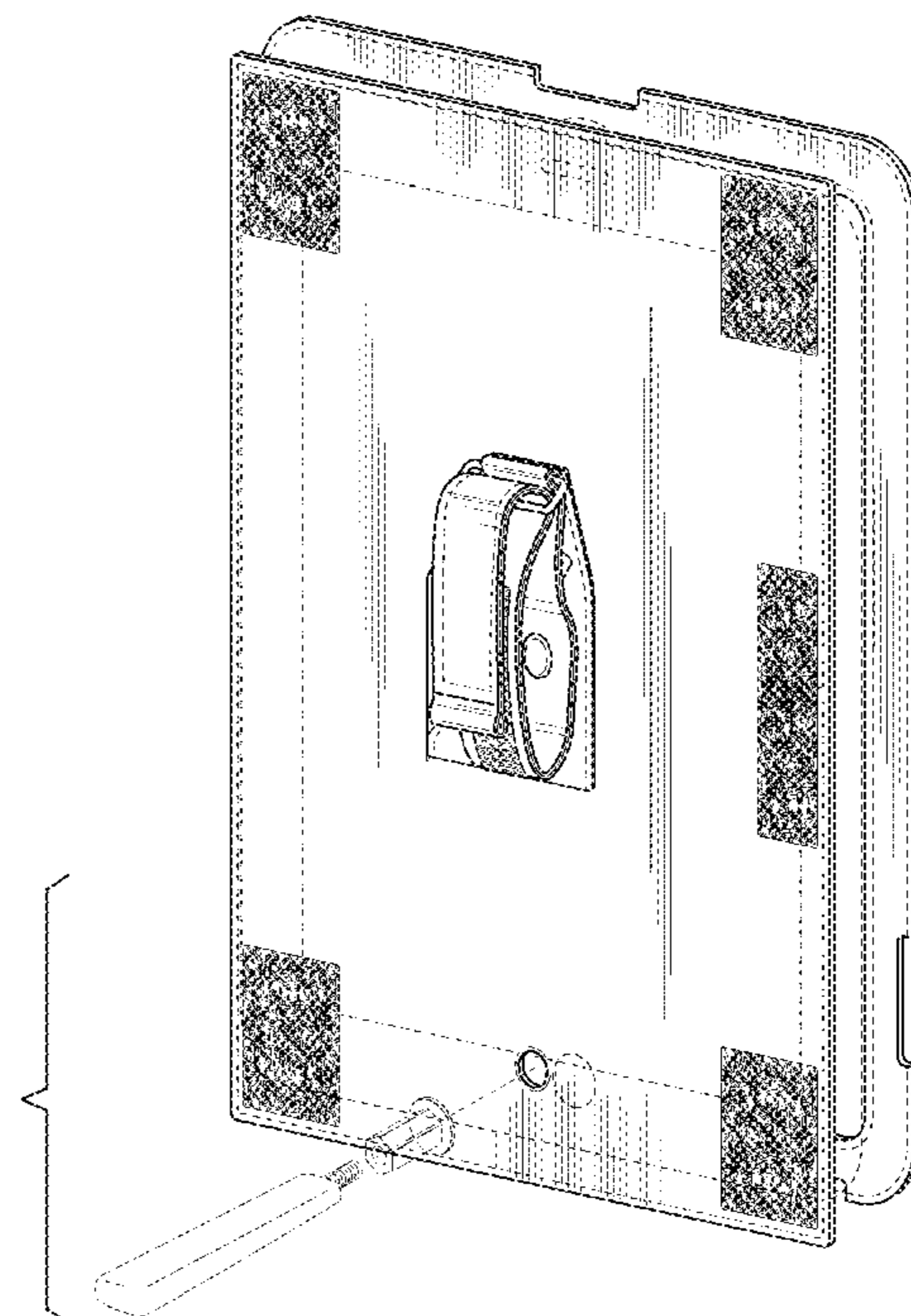
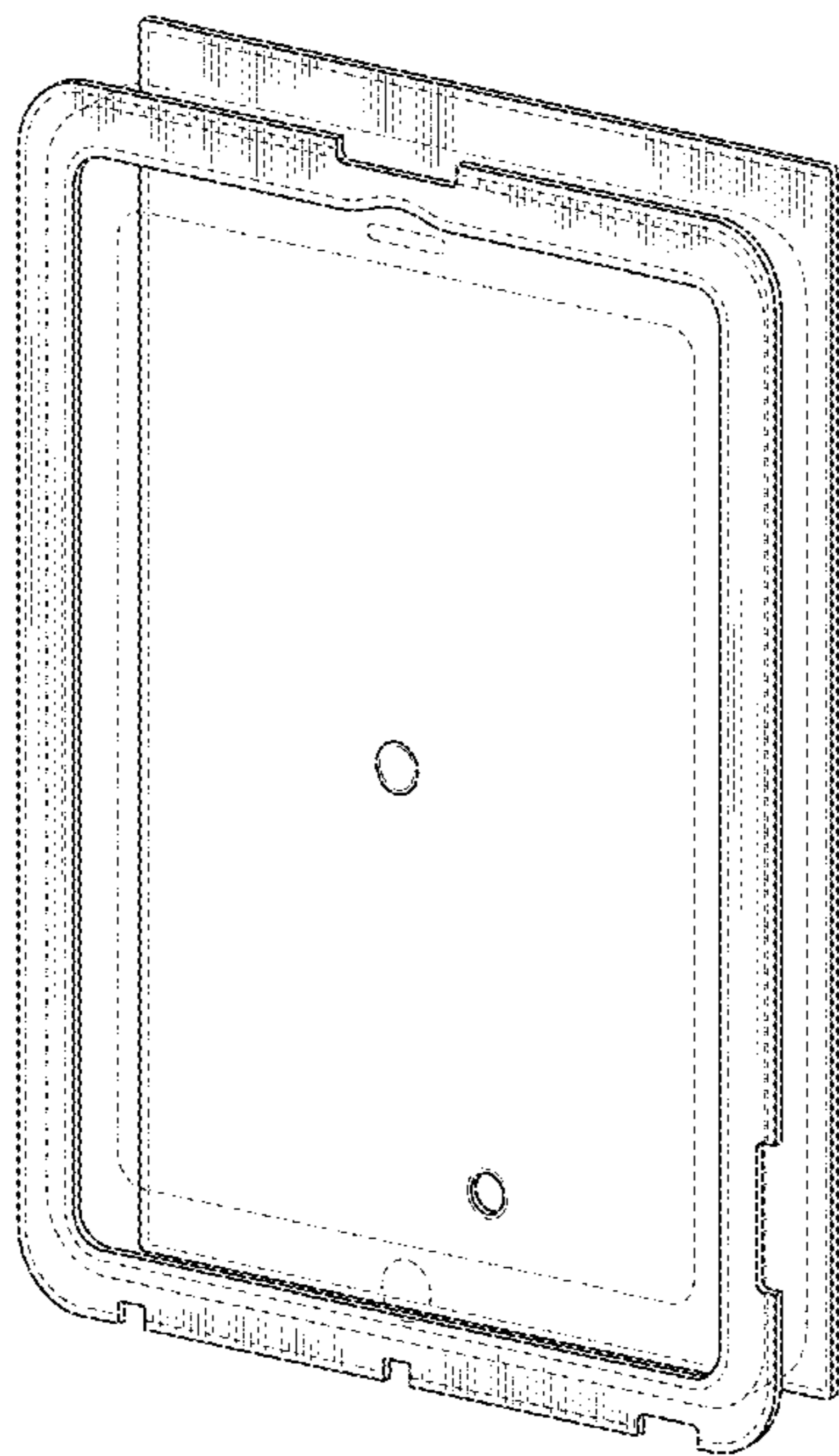
I claim the ornamental design for an electronics device holder, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of an electronics device holder, showing my new design;  
FIG. 2 is a rear perspective view thereof;  
FIG. 3 is a front elevational view thereof;  
FIG. 4 is a rear elevational view thereof;  
FIG. 5 is a left-side elevational view thereof;  
FIG. 6 is a right-side elevational view thereof;  
FIG. 7 is a top plan view thereof; and,  
FIG. 8 is a bottom plan view thereof.

The broken lines showing a portable electronic device in FIGS. 1 and 2, an optional stand in FIG. 2, an arced material border in FIG. 4, and web connecting material between the front and rear panels in FIGS. 5-8 depict environmental matter and form no part of the claimed design. The remaining broken lines represent stitching, and are part of the claimed design.

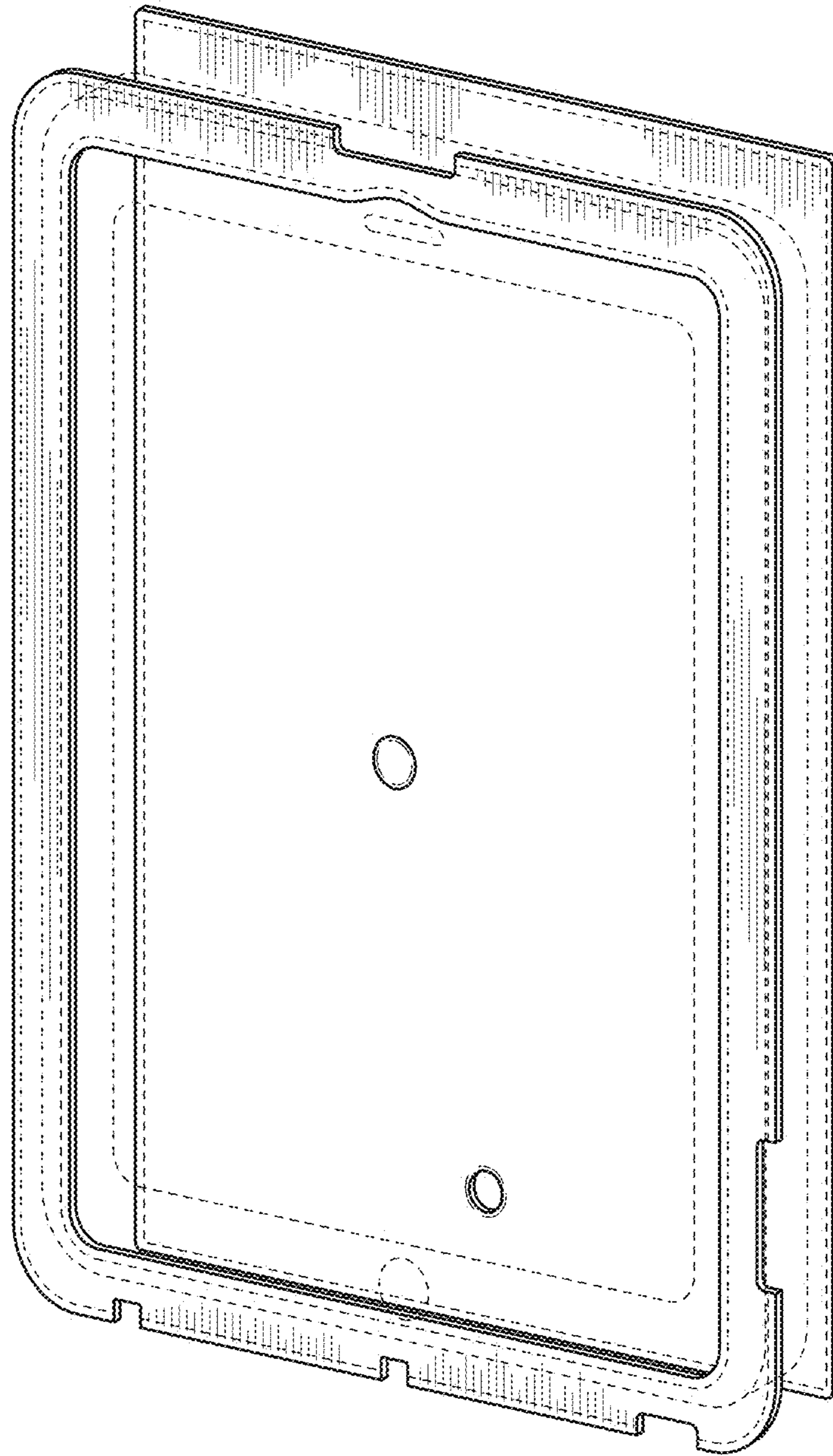

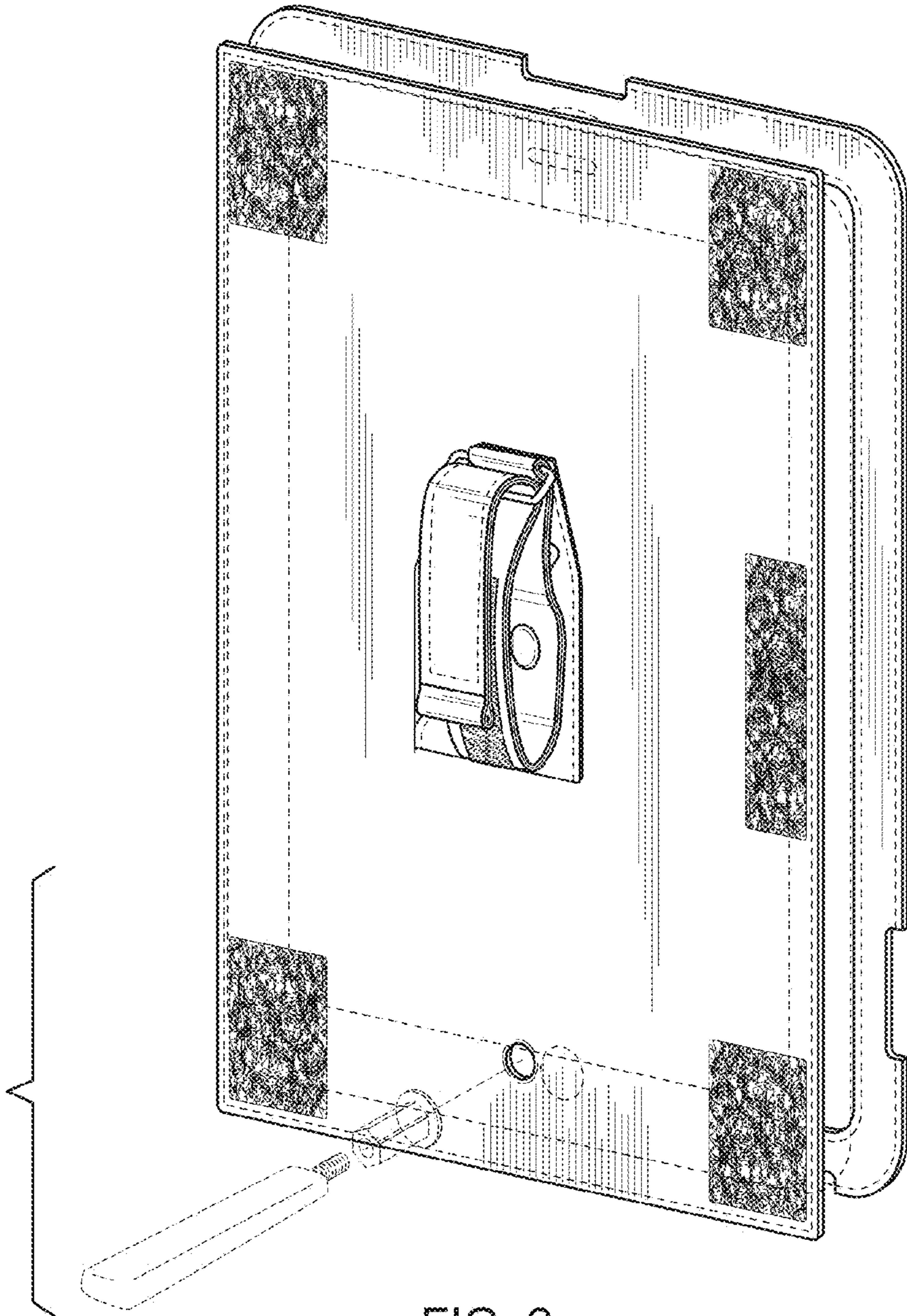

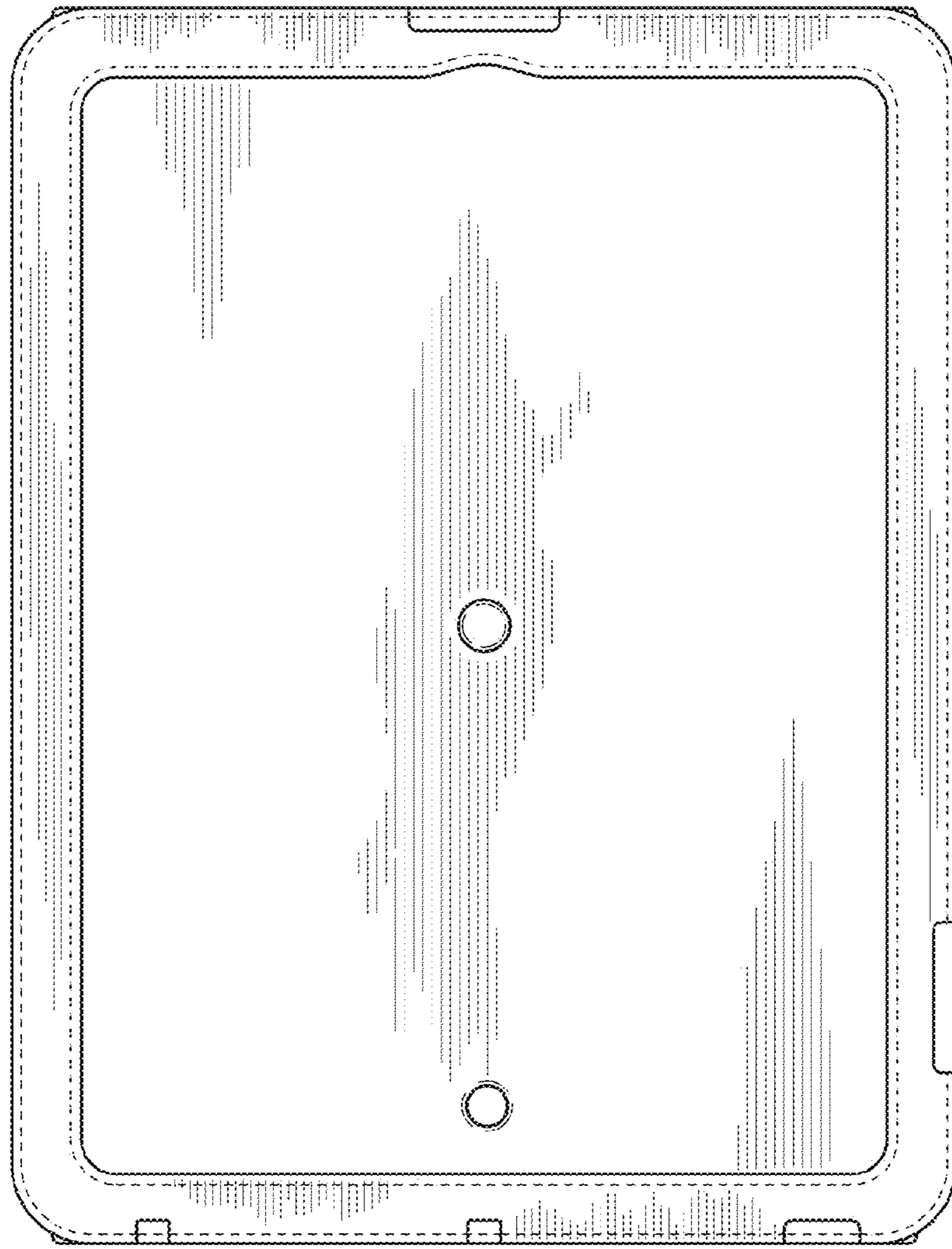

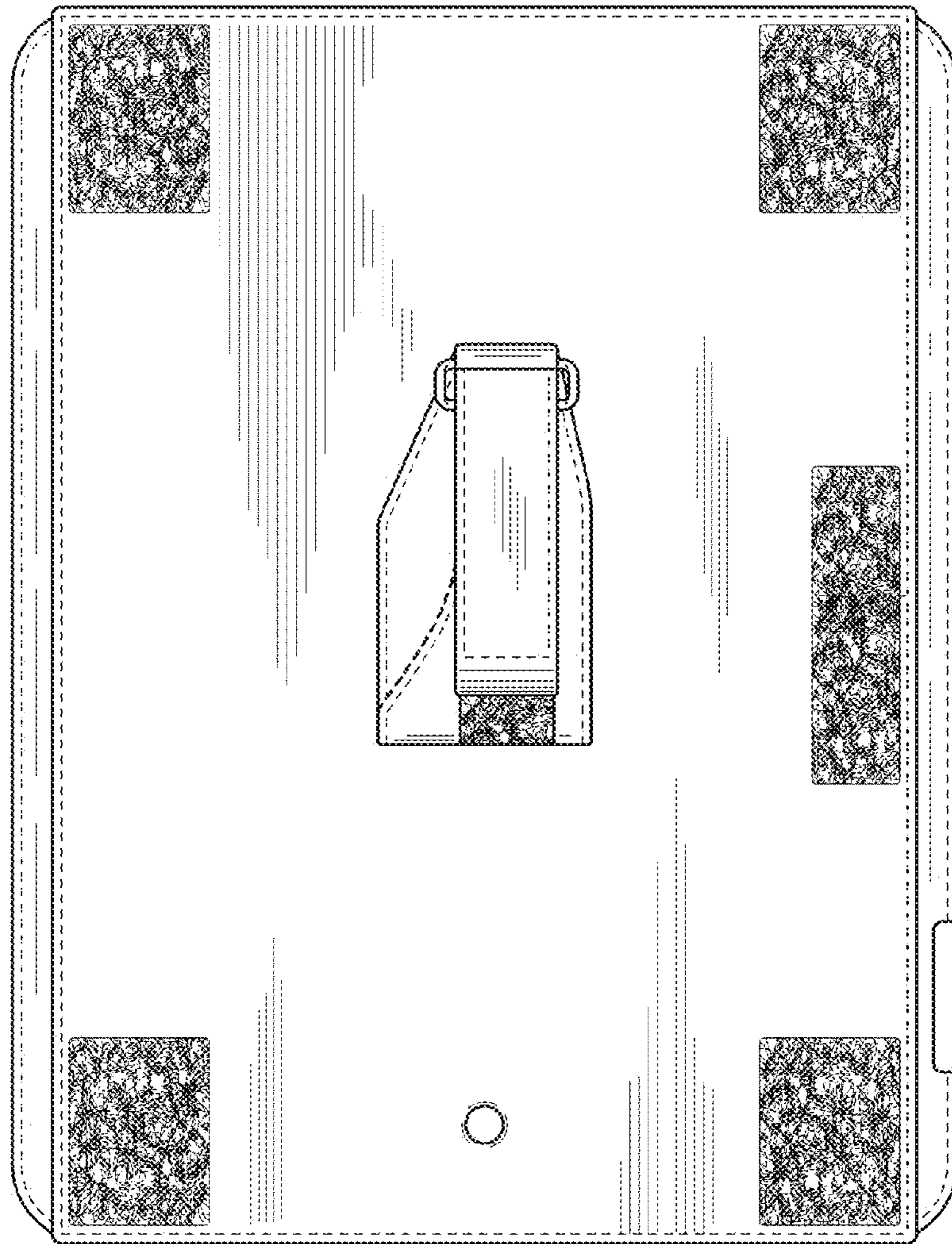

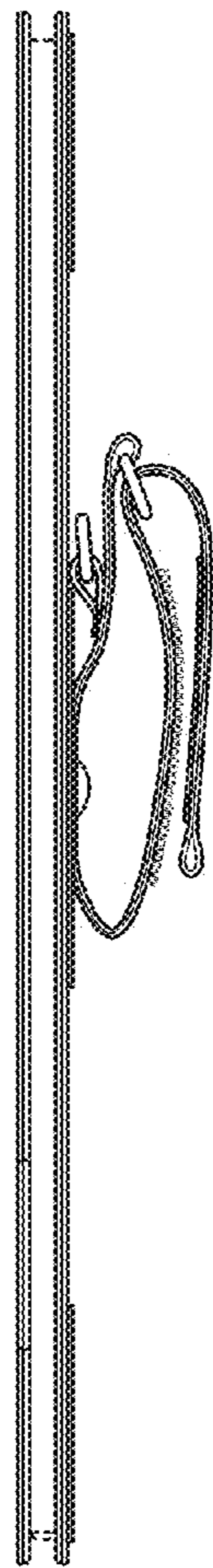

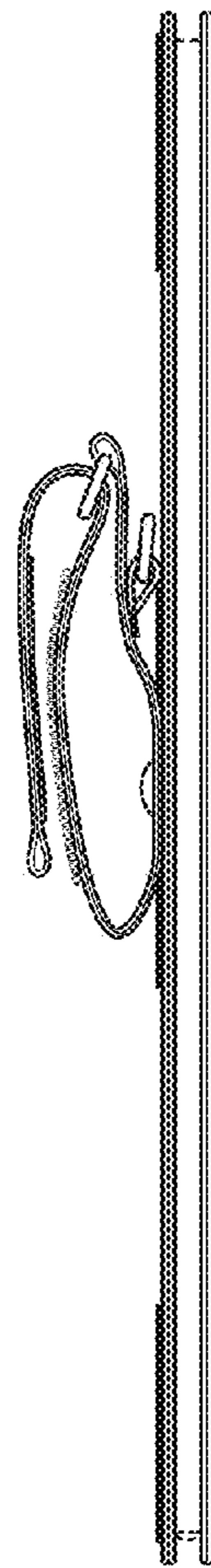

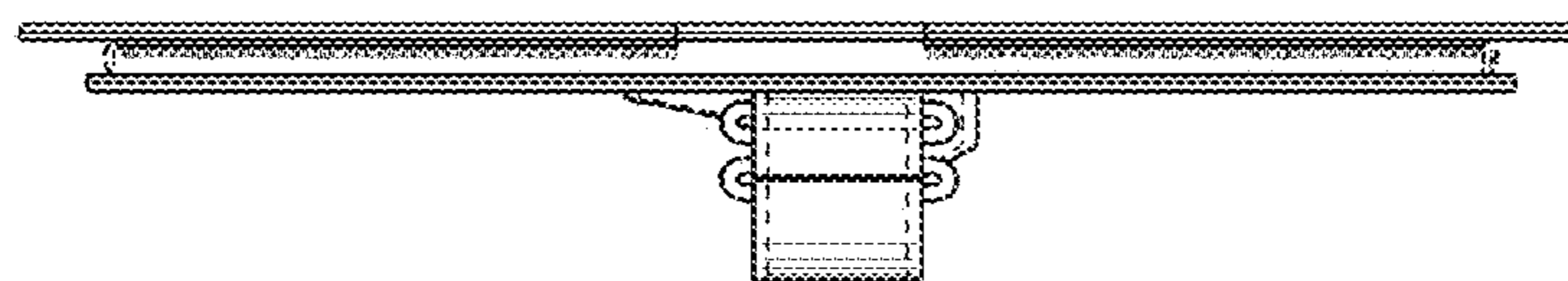

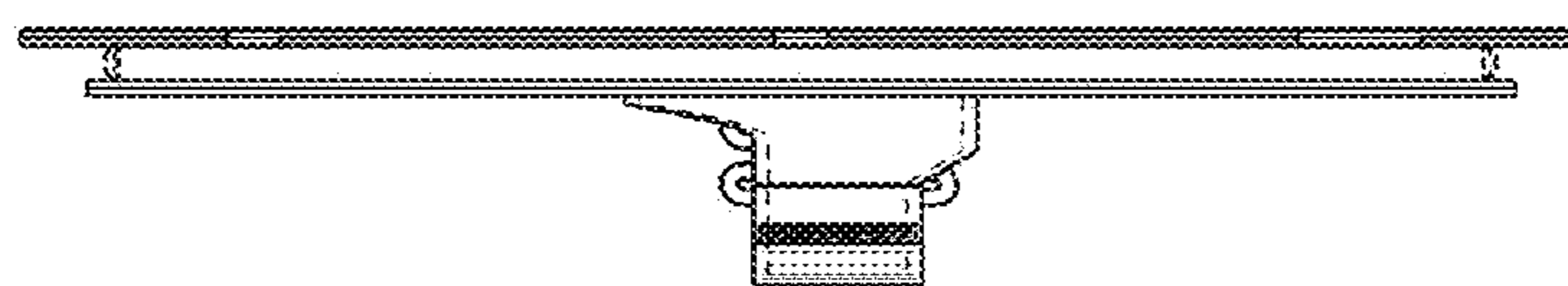
