FIG. 8 is a front view thereof;

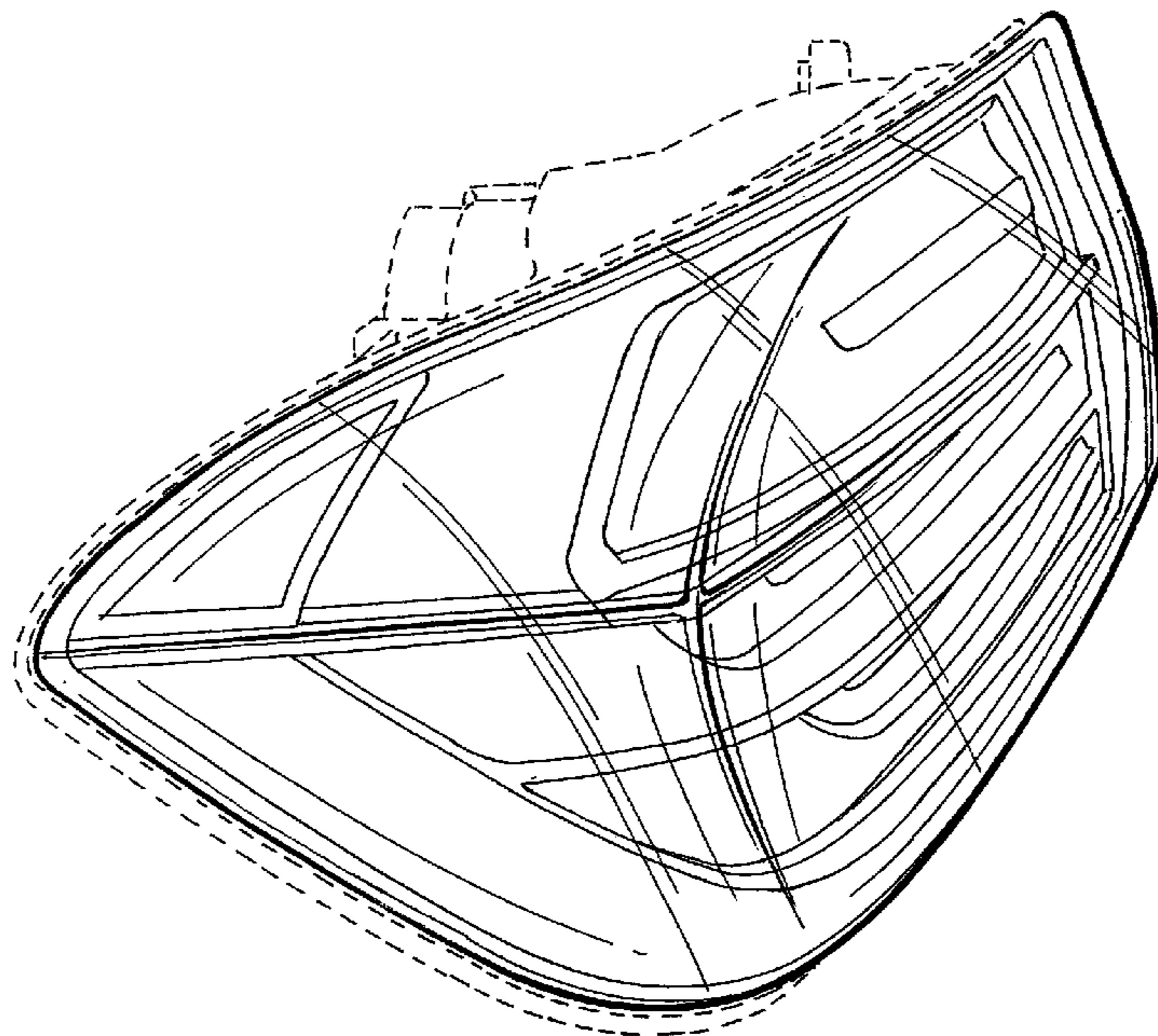
FIG. 9 is a right side view thereof; and,

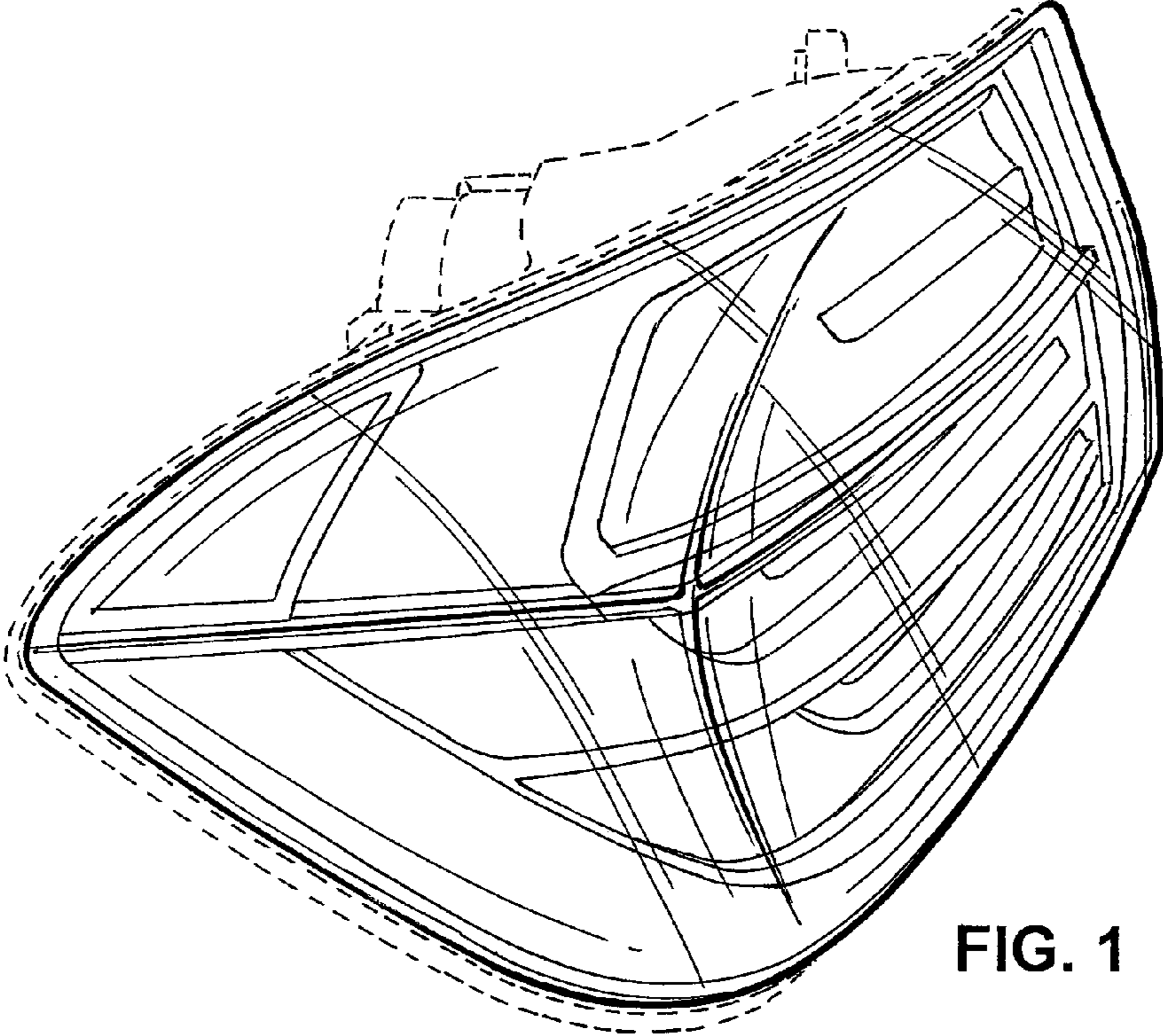

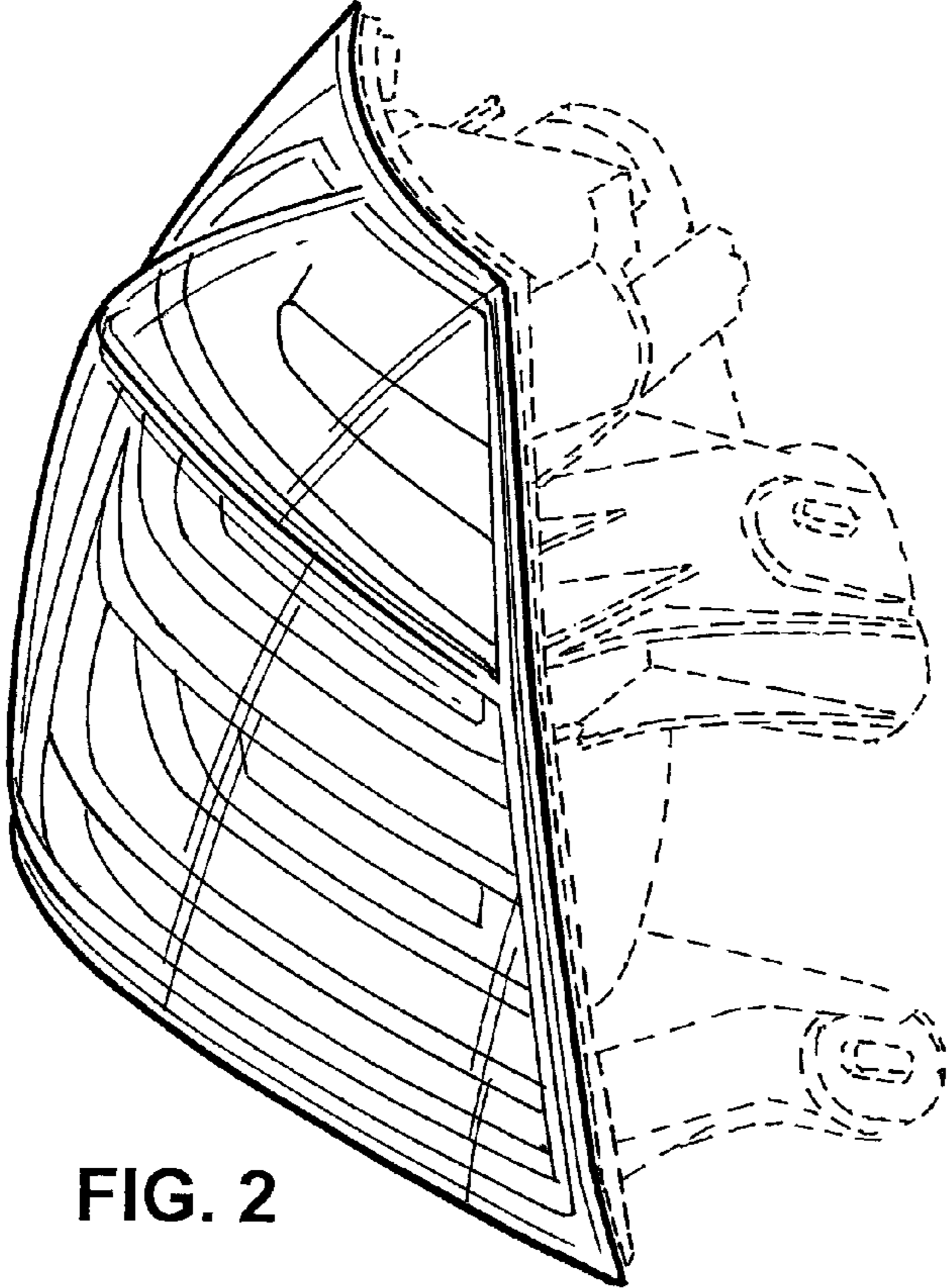

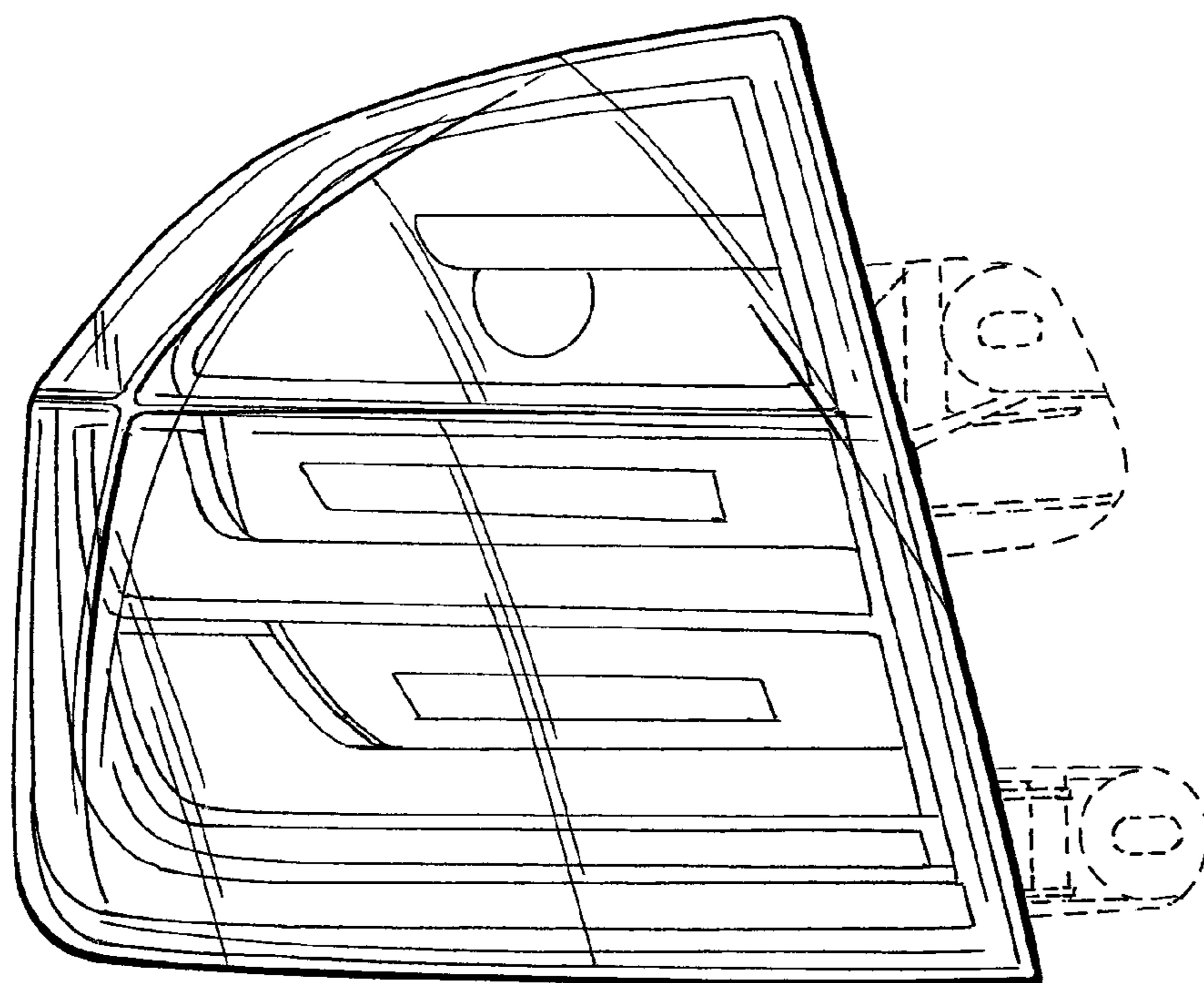

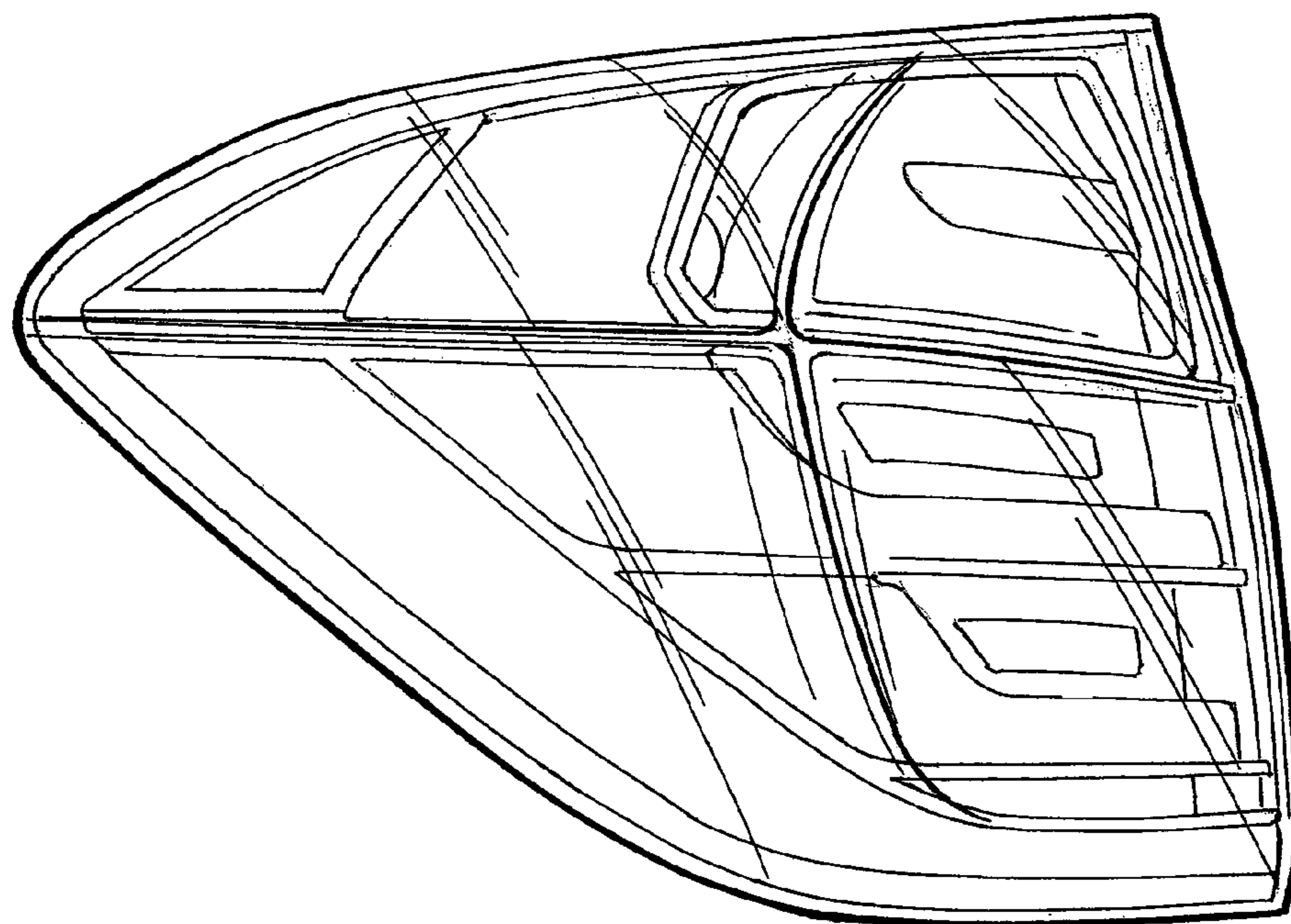

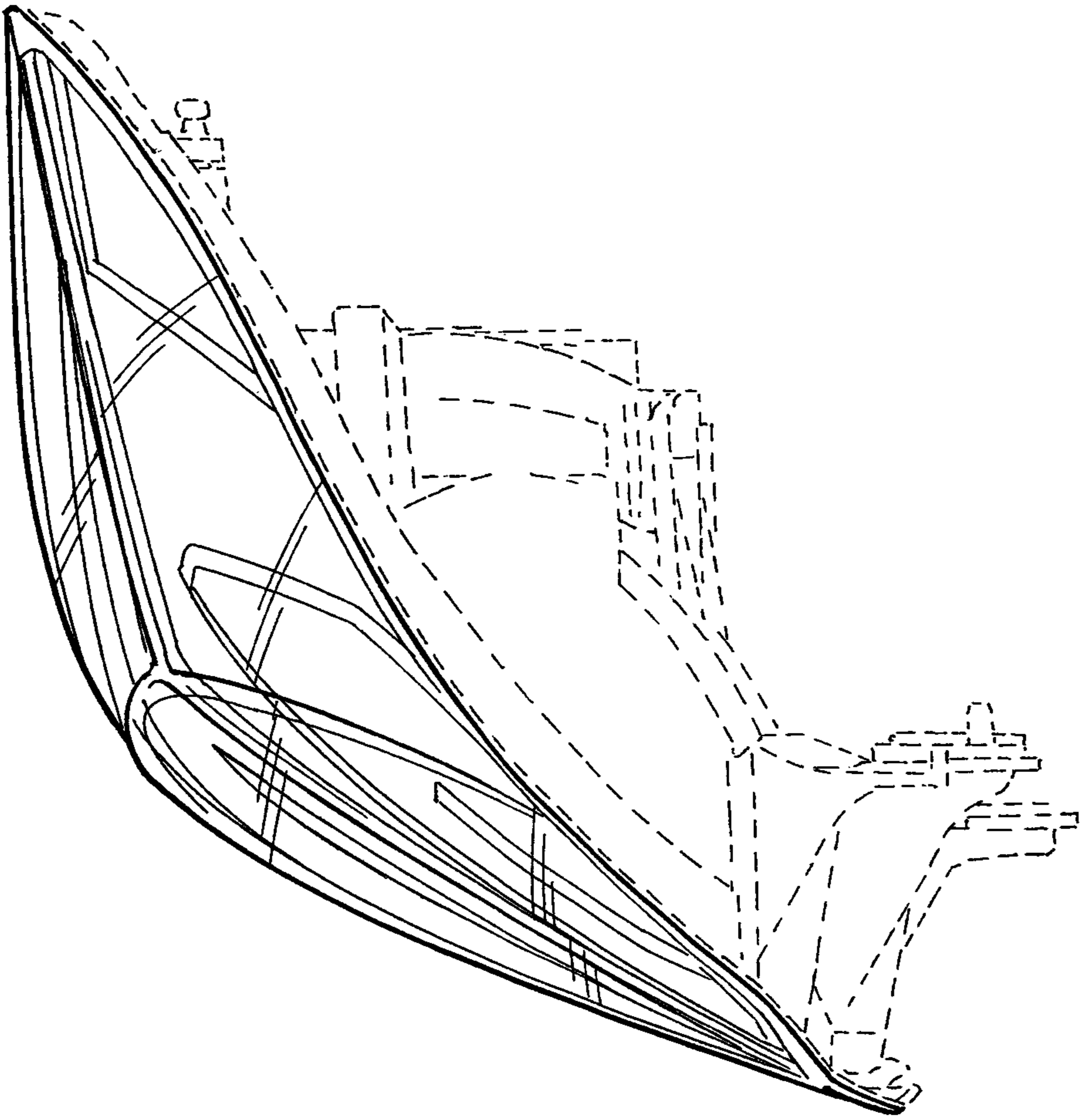

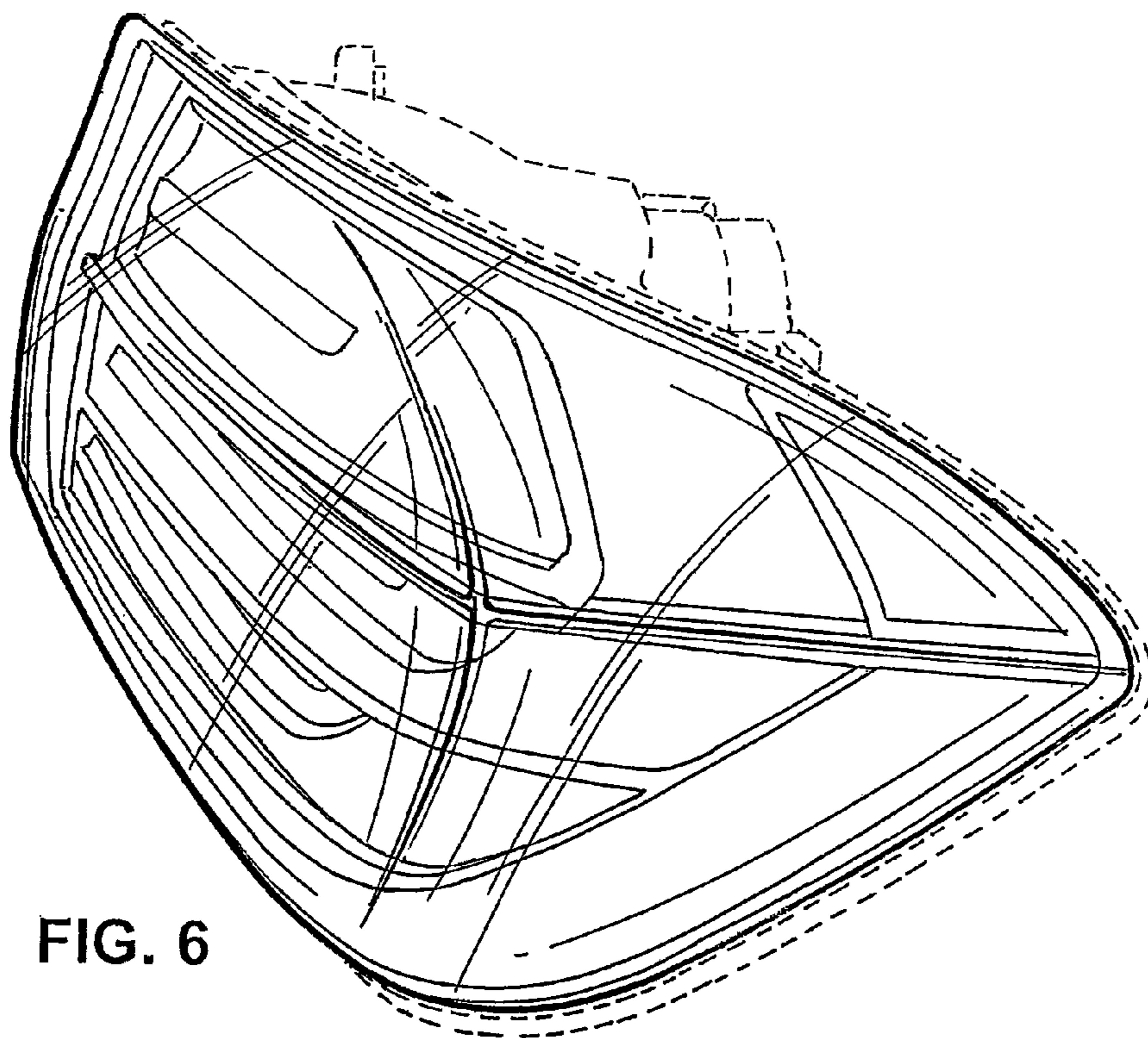

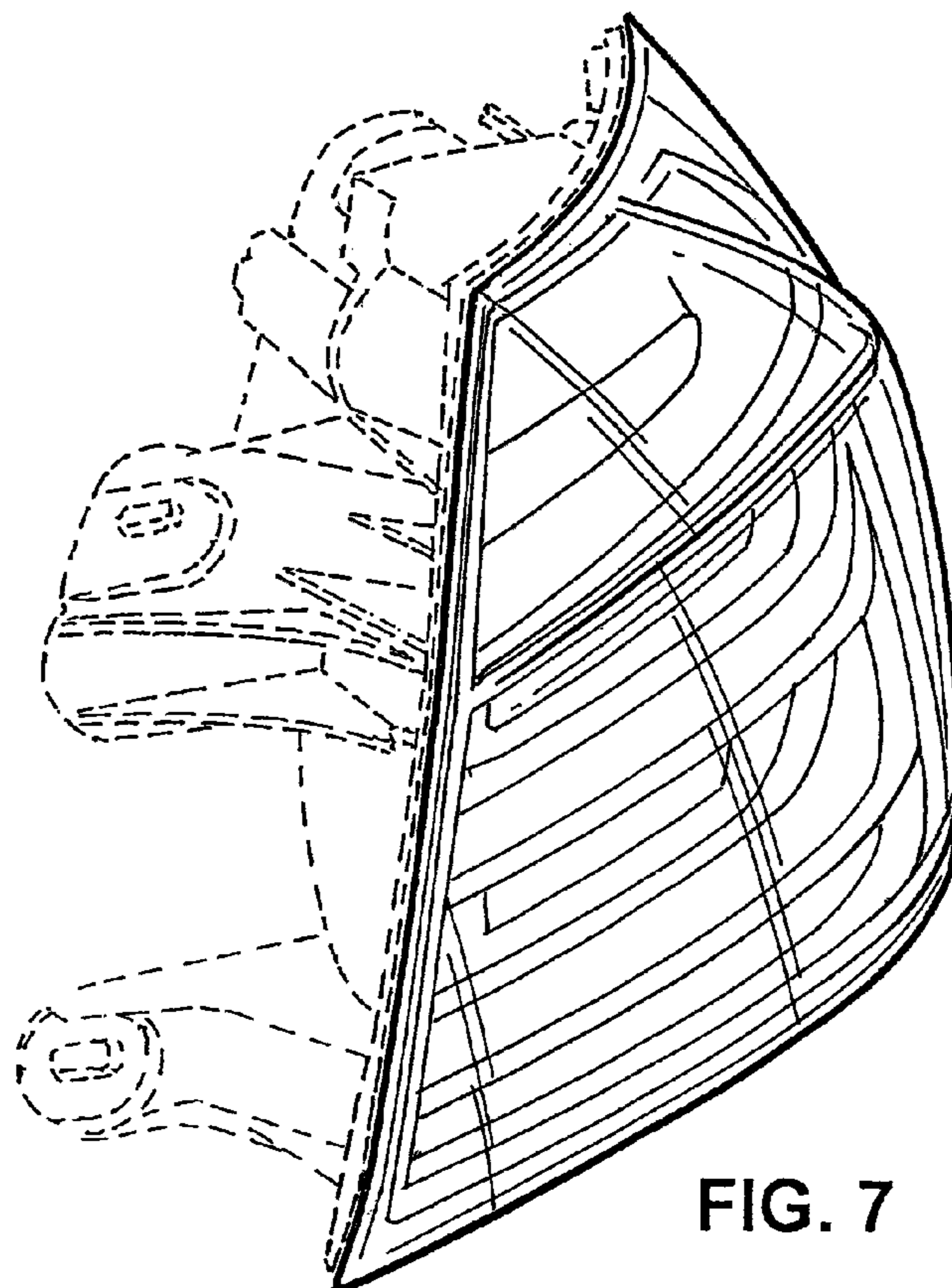

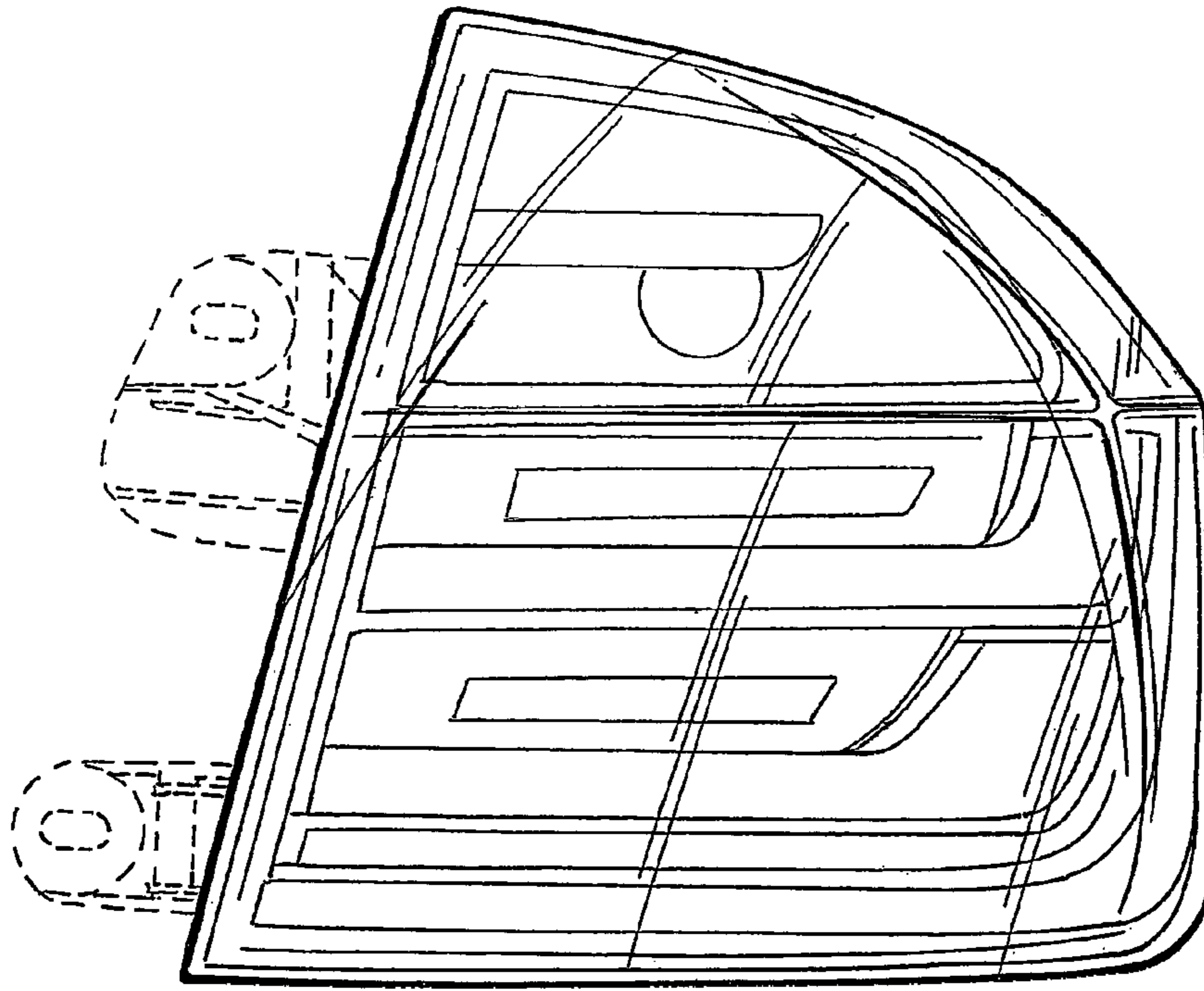

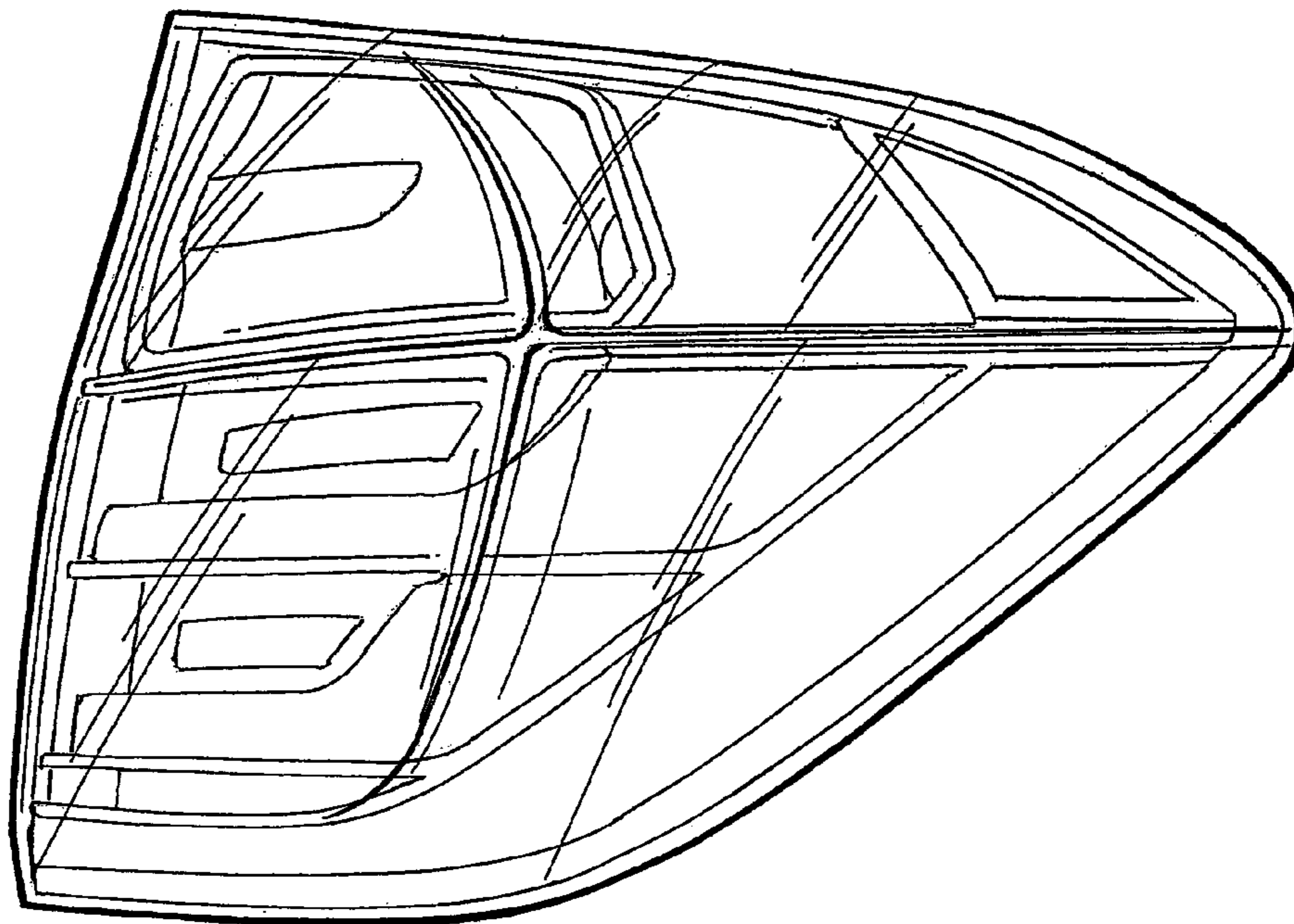

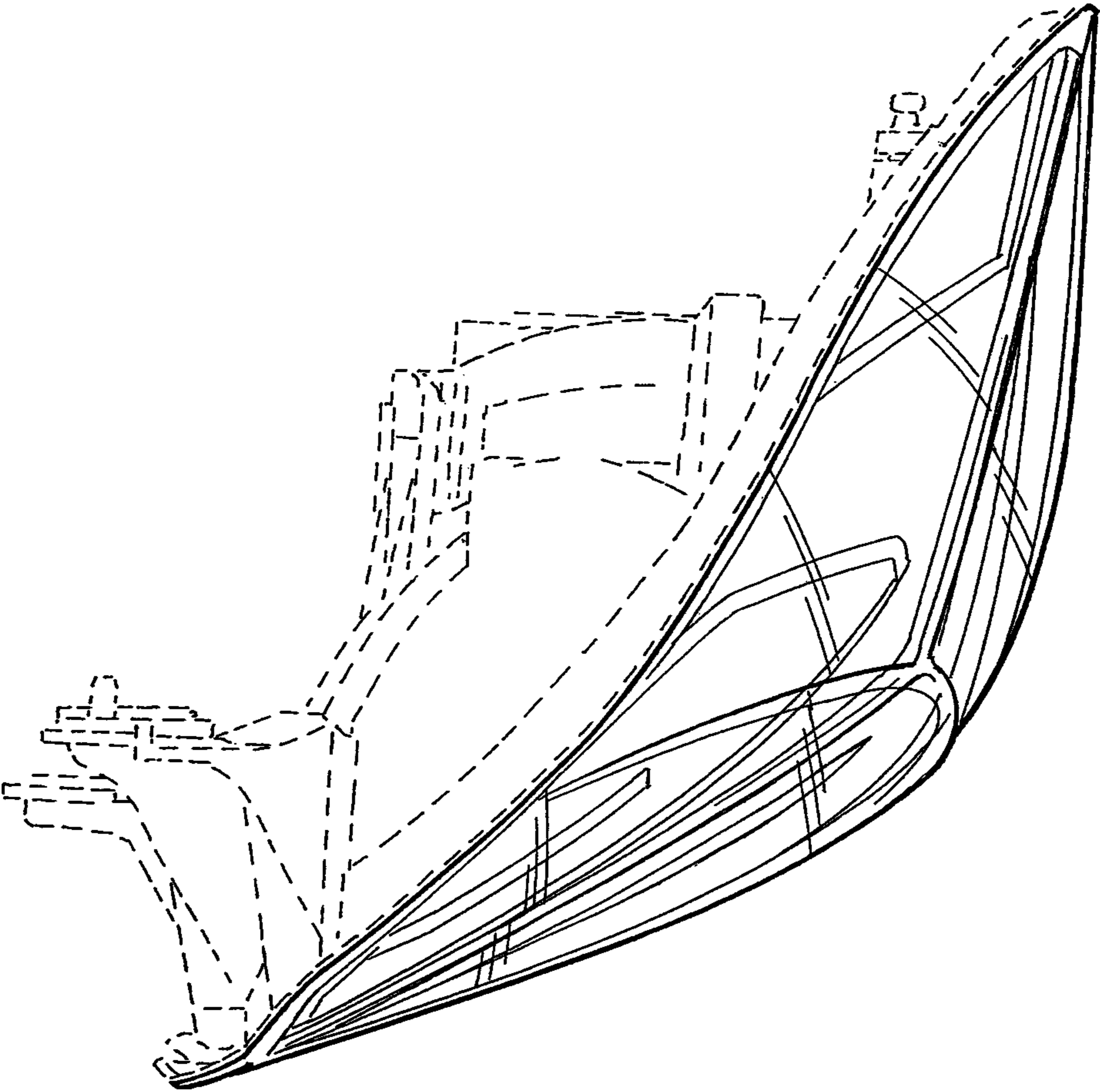
