The ornamental design for an animal watering device, as shown and described.

**DESCRIPTION**

FIG. 1 is a top view of the animal watering device, showing my new design;  
 FIG. 2 is a lateral side view of the animal watering device, the opposite side being a mirror image of the side shown;  
 FIG. 3 is a frontal side view of the animal watering device;  
 FIG. 4 is a back side view of the animal watering device;  
 FIG. 5 is a bottom view of the animal watering device; and,  
 FIG. 6 is a top perspective view of the animal watering device.

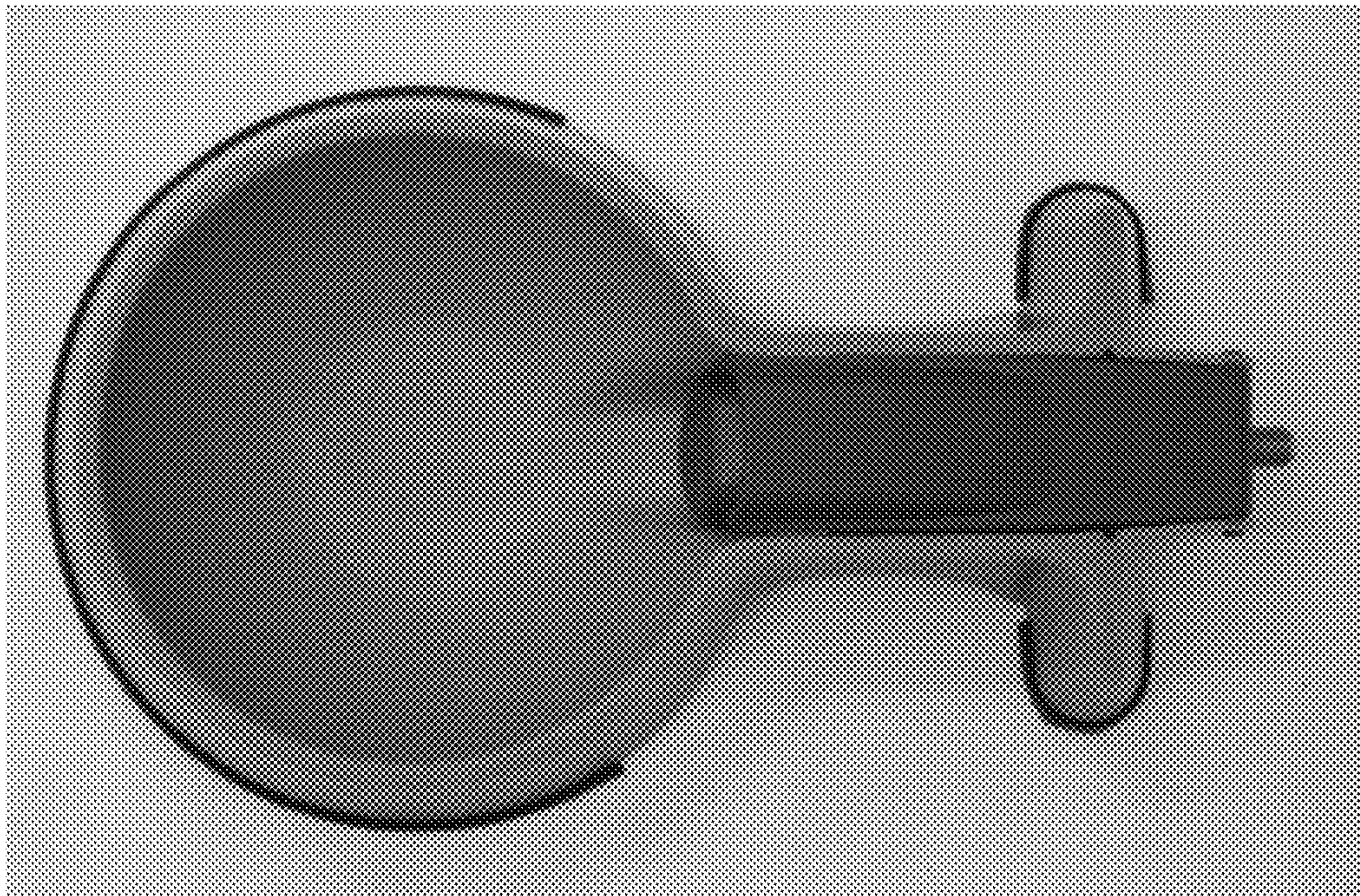

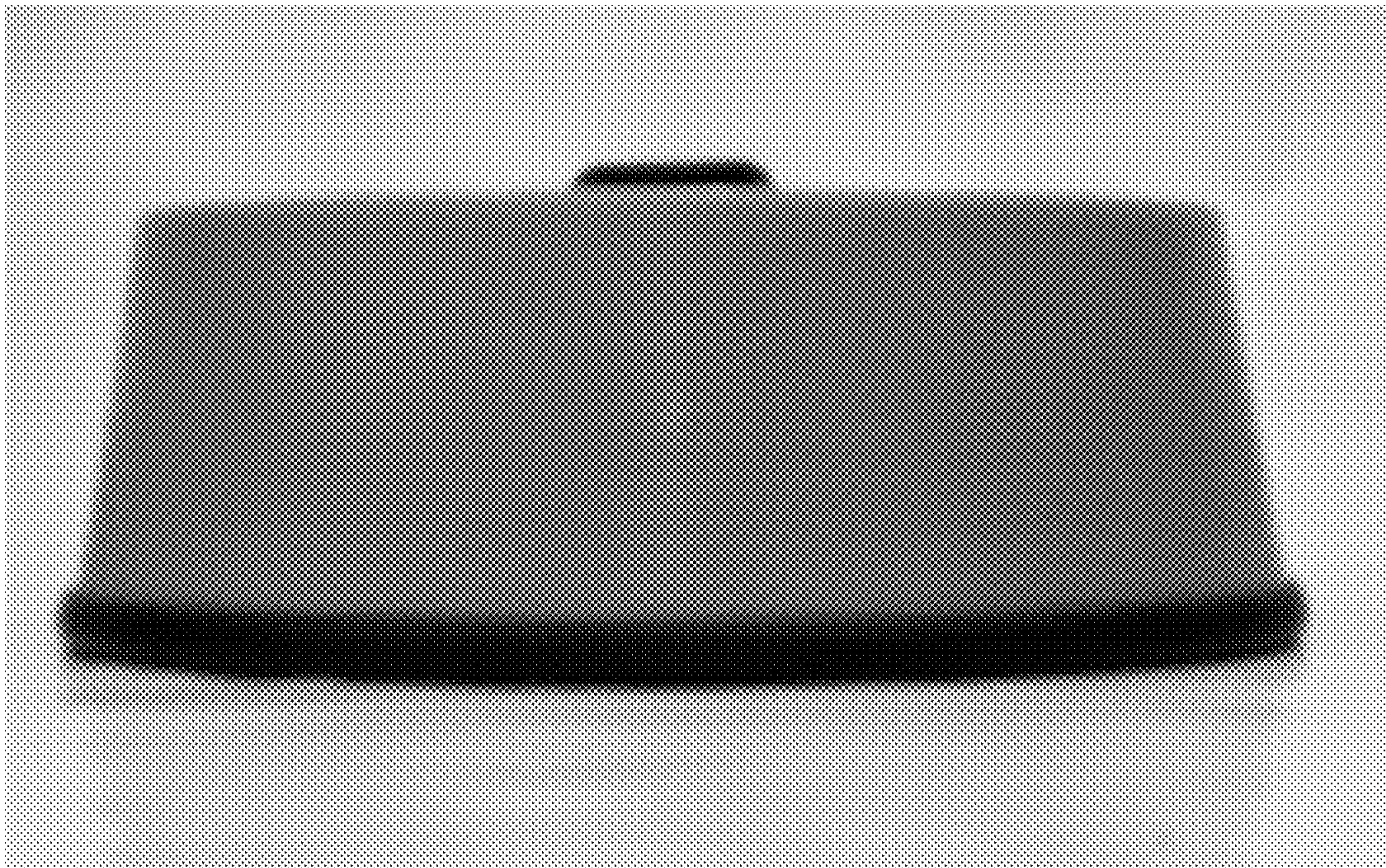

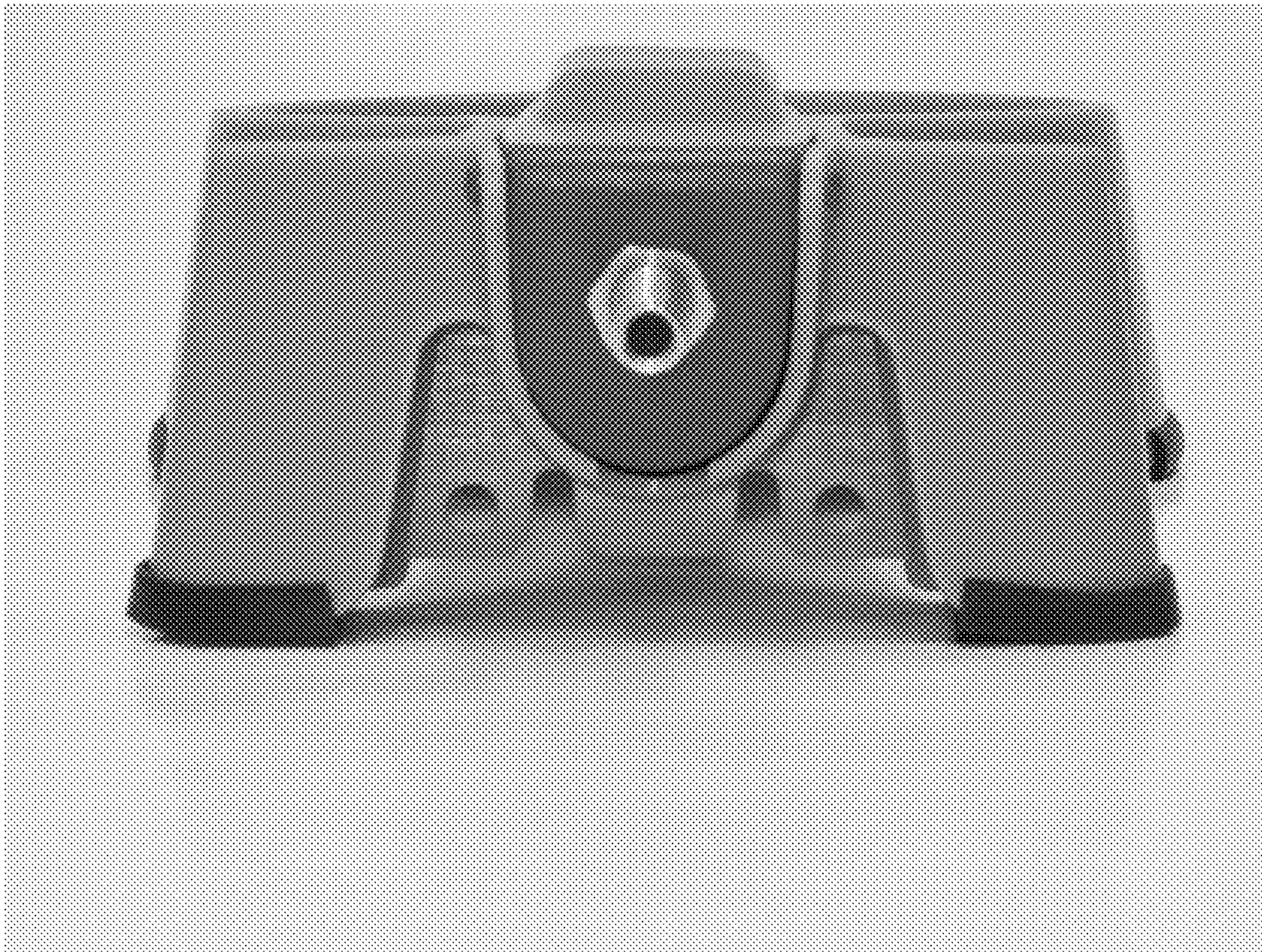

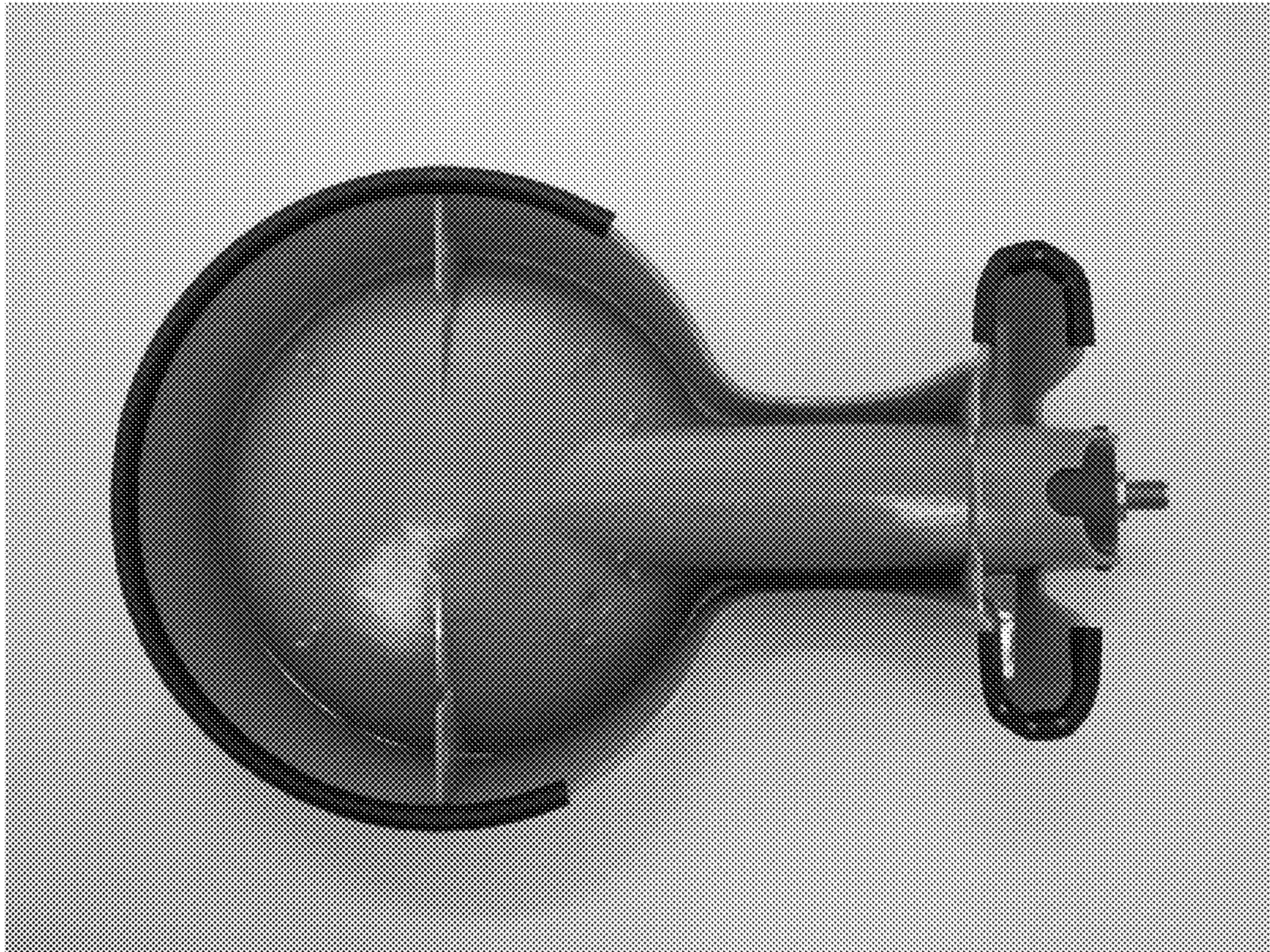
