(57) **CLAIM**

The ornamental design for a disposable domesticated cat tray, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a disposable domesticated cat tray showing my new design;
 FIG. 2 is another perspective view thereof showing the cover in FIG. 1, removed;
 FIG. 3 is top plan view of FIG. 2;
 FIG. 4 is a bottom plan view thereof;
 FIG. 5 is a front view thereof; and,
 FIG. 6 is a left side view thereof.

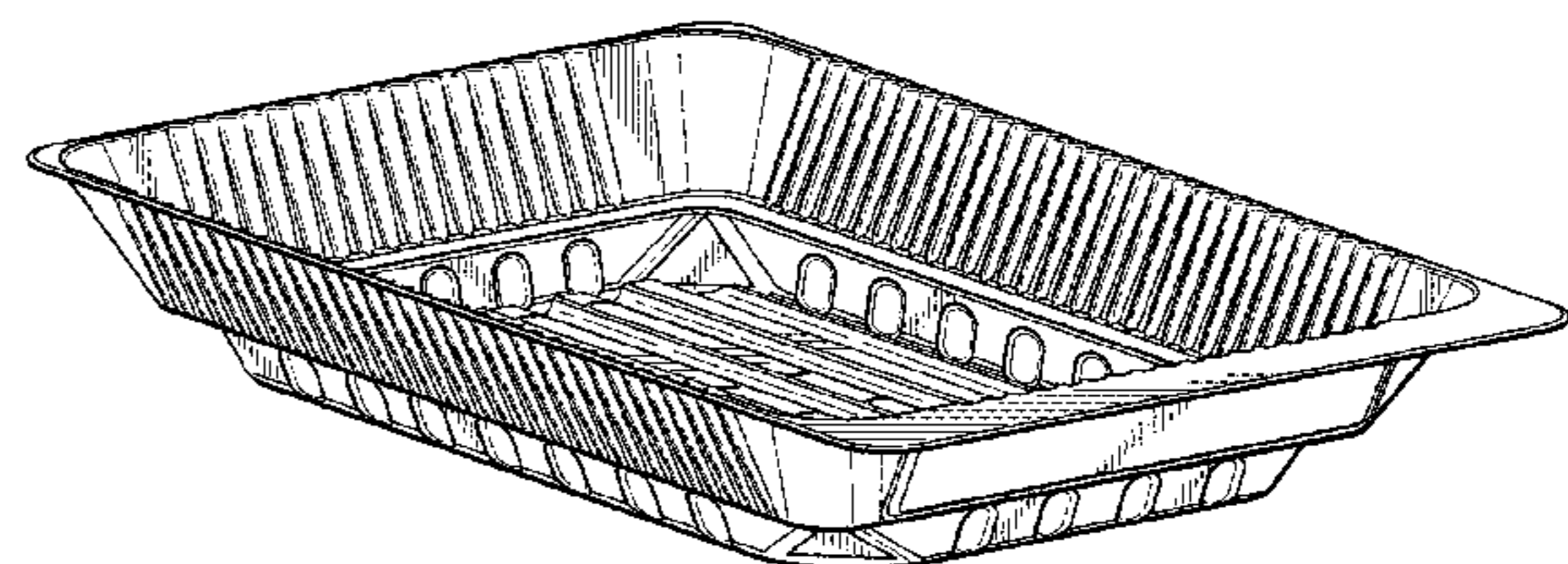
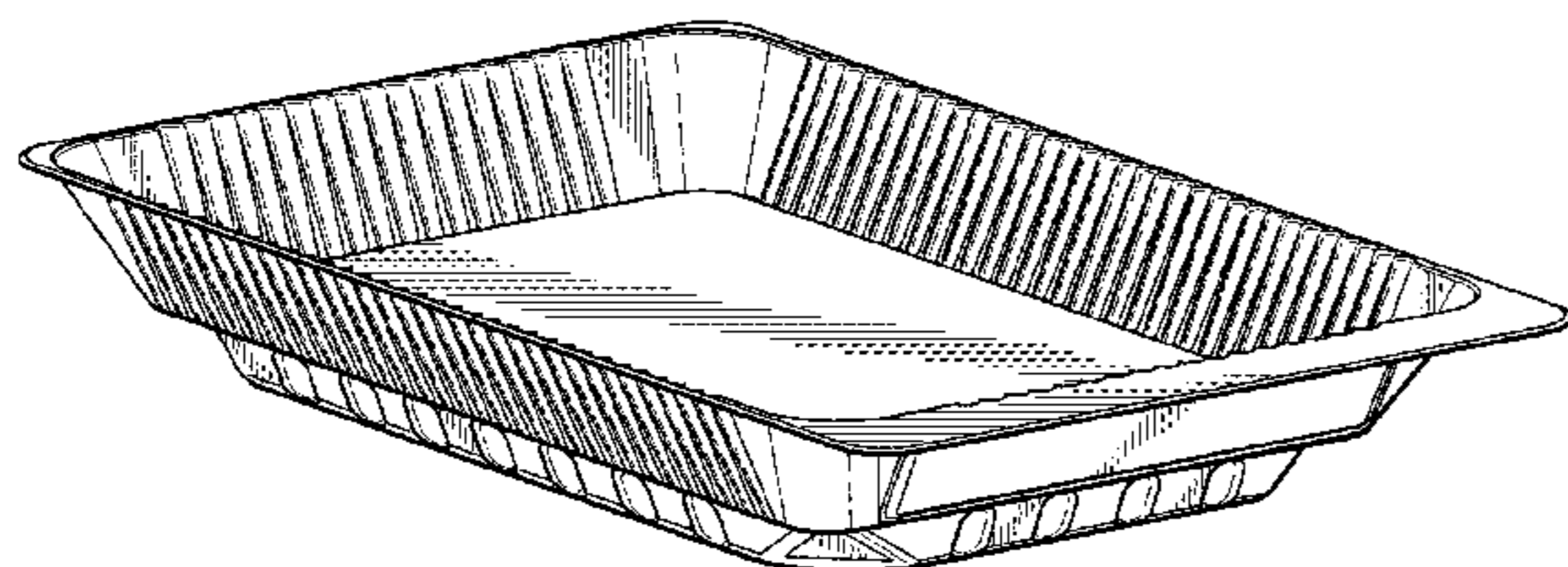

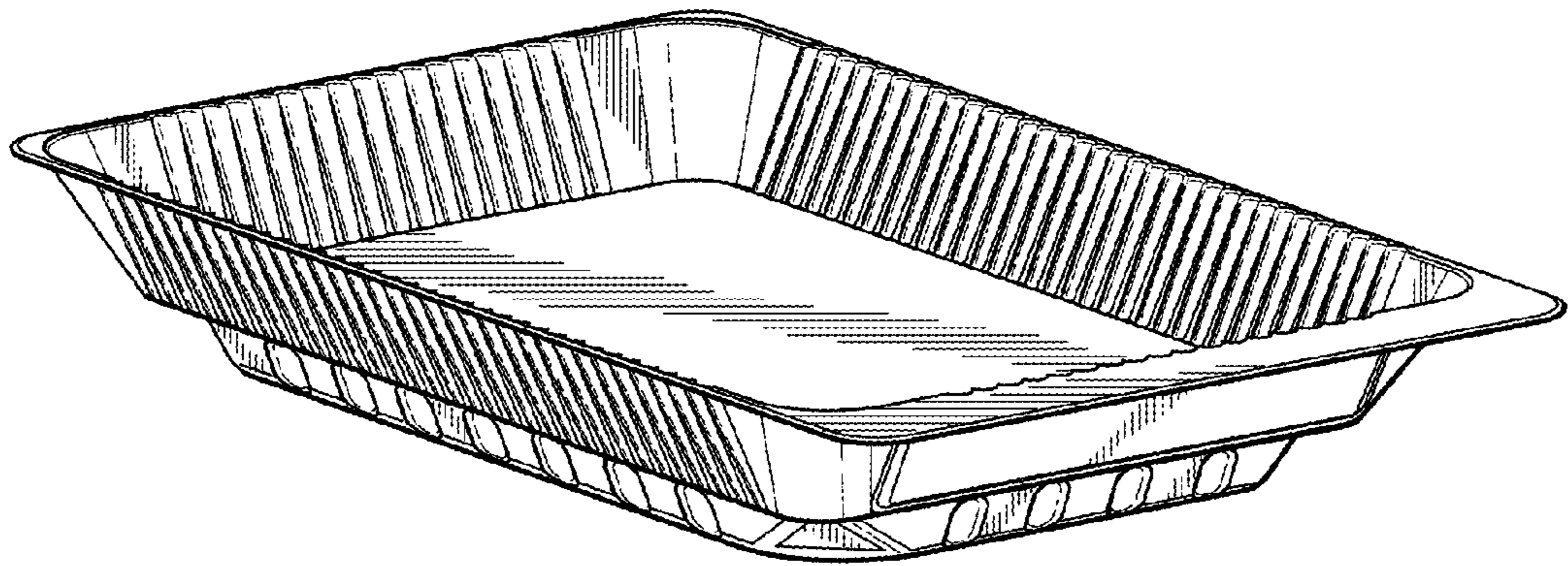

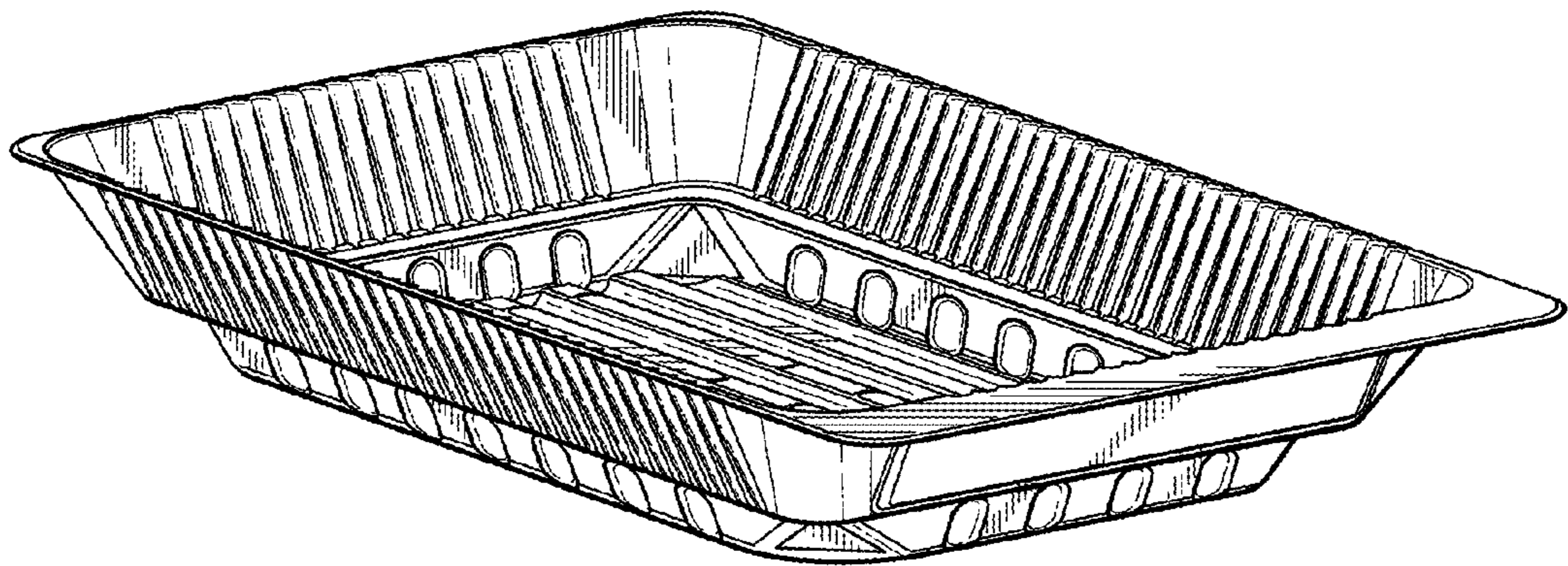

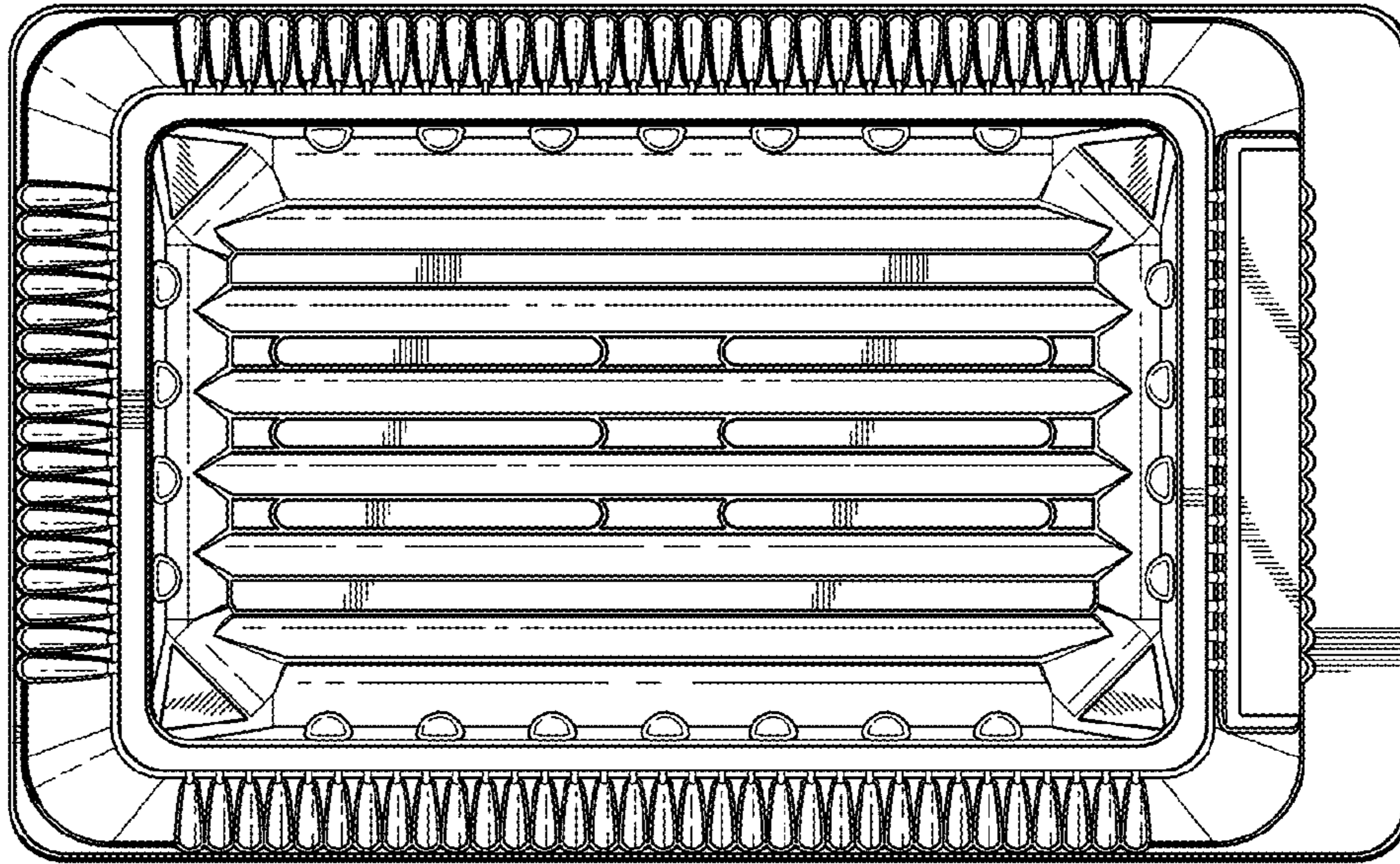

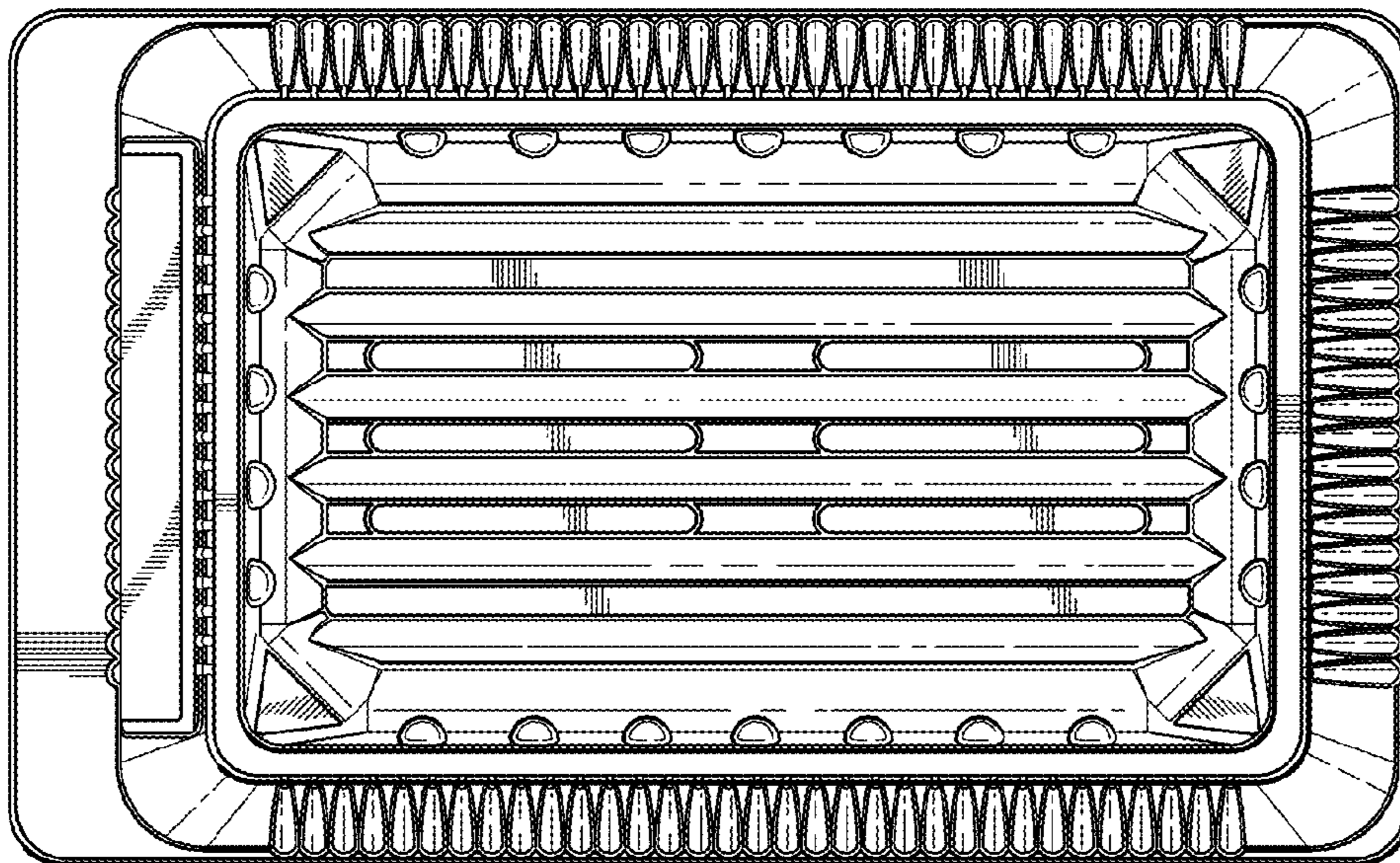

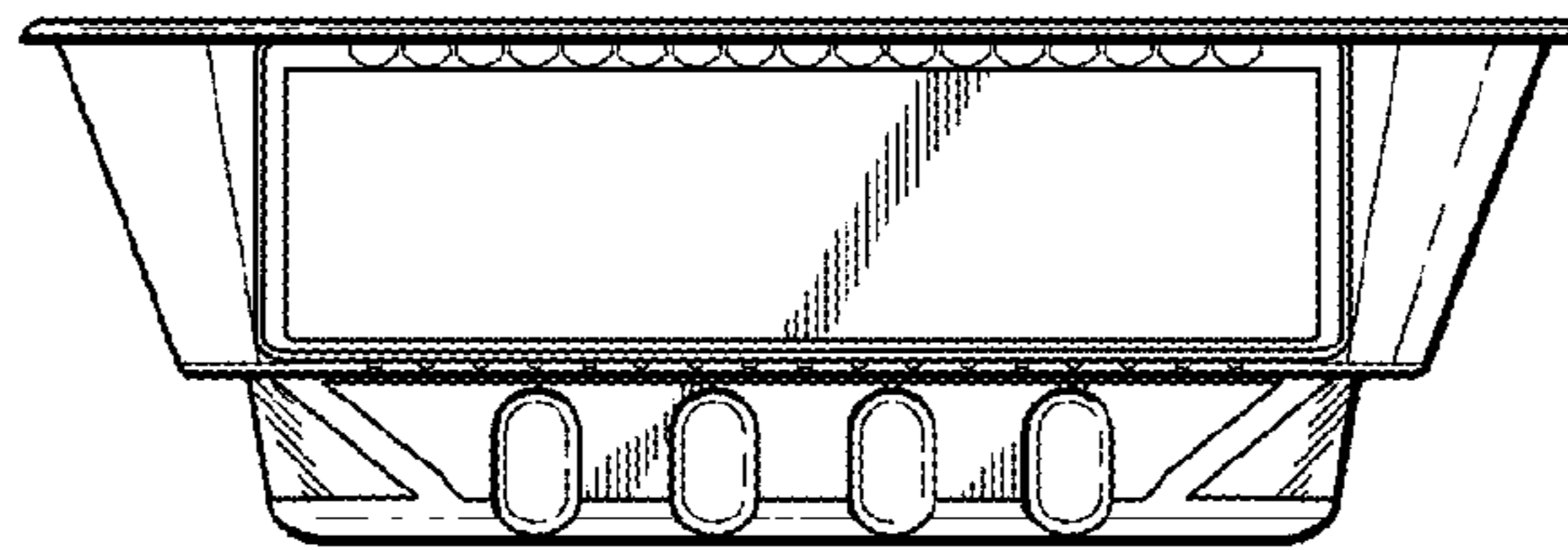
