The ornamental design for a rosary, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevation view of a rosary showing my new design.

FIG. 2 is a right side elevation view thereof.

FIG. 3 is a left side elevation view thereof.

FIG. 4 is a top plan view thereof.

FIG. 5 is a bottom plan view thereof; and,

FIG. 6 is another front elevation view of the rosary in a used condition with a handheld object.

The broken lines shown in the drawings represent portions of the rosary in FIG. 6 that form no part of the claimed design.

All surfaces not shown form no part of the claimed design.

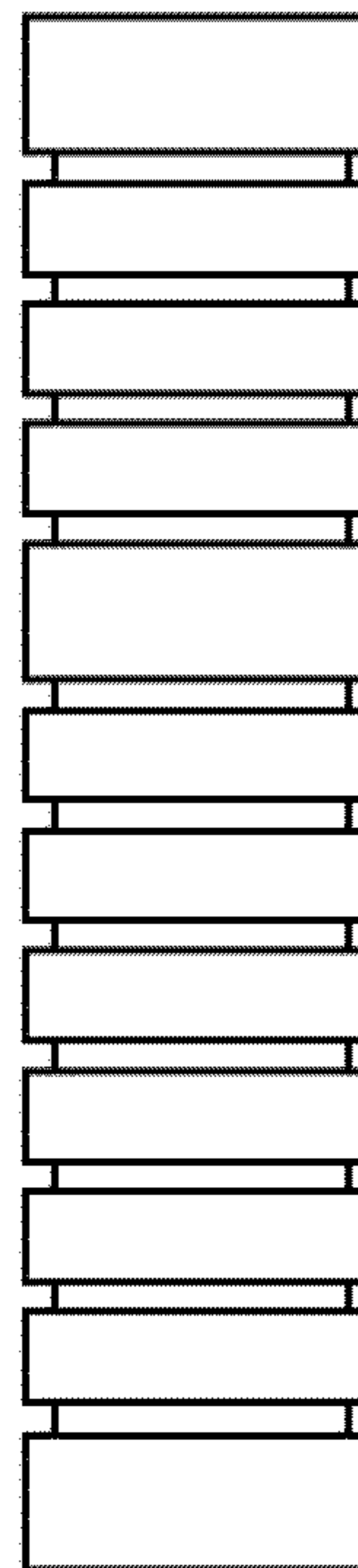
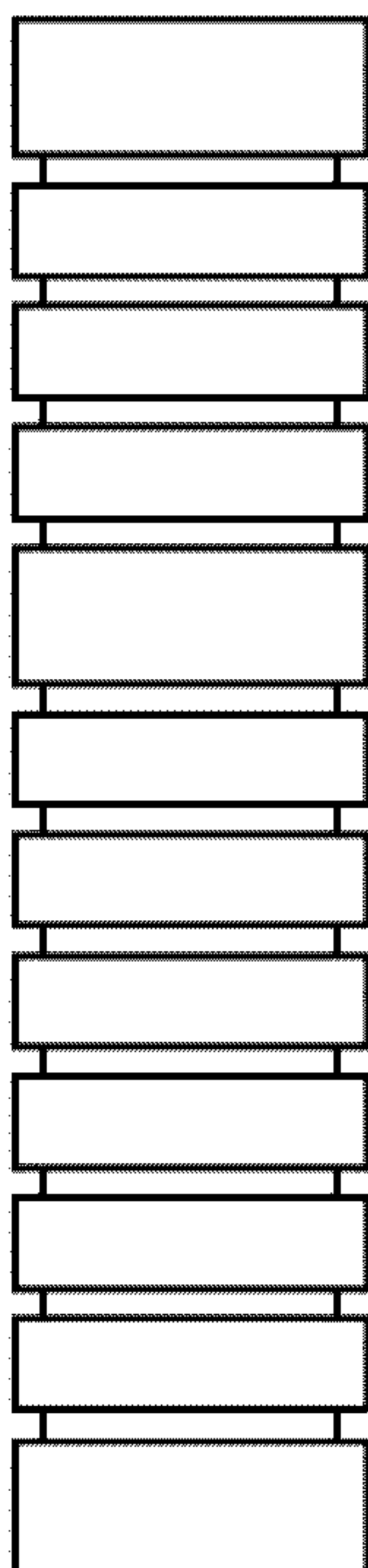

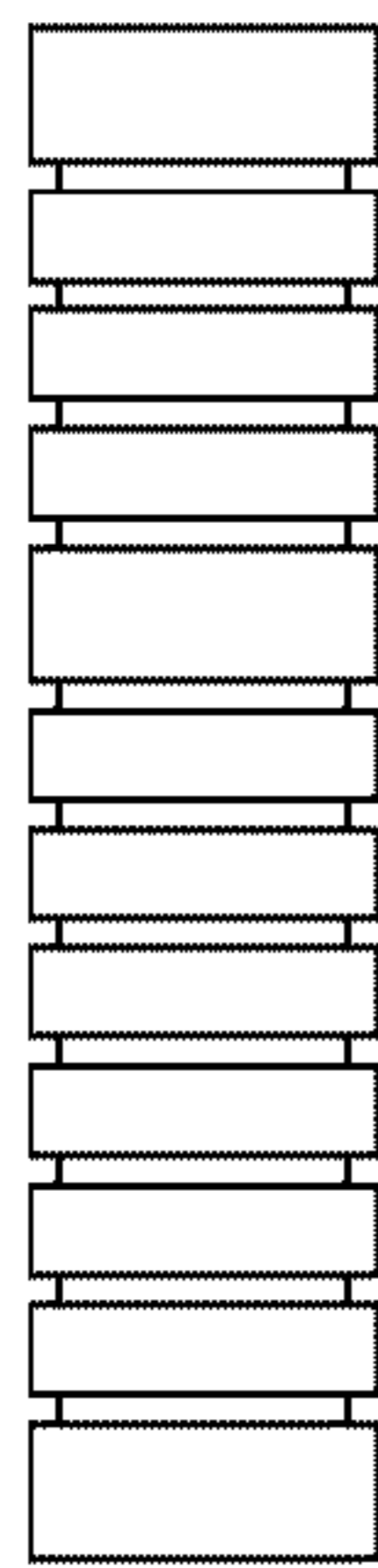

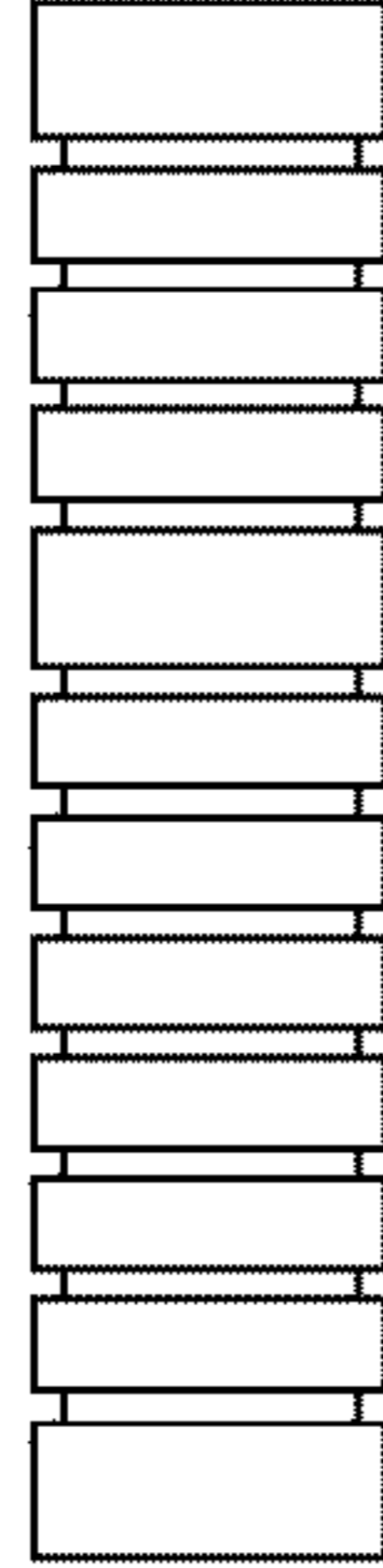

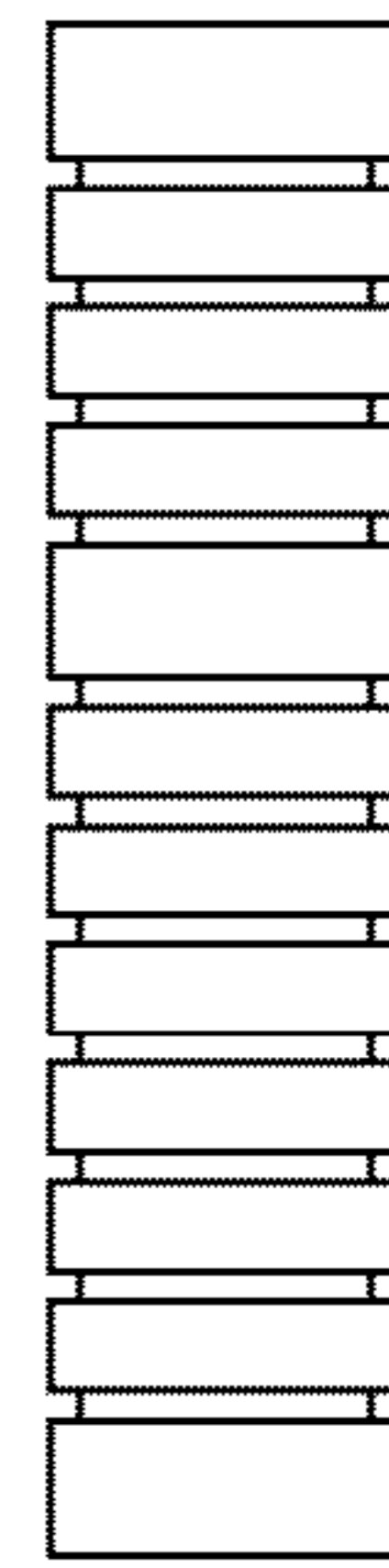

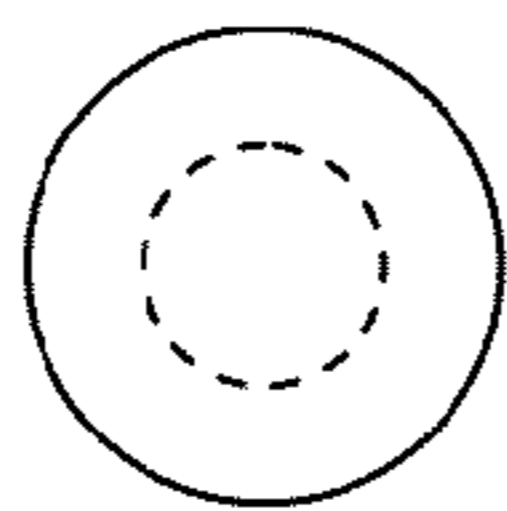

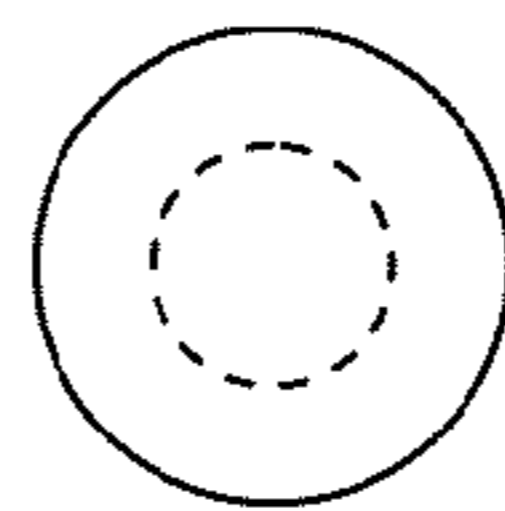
