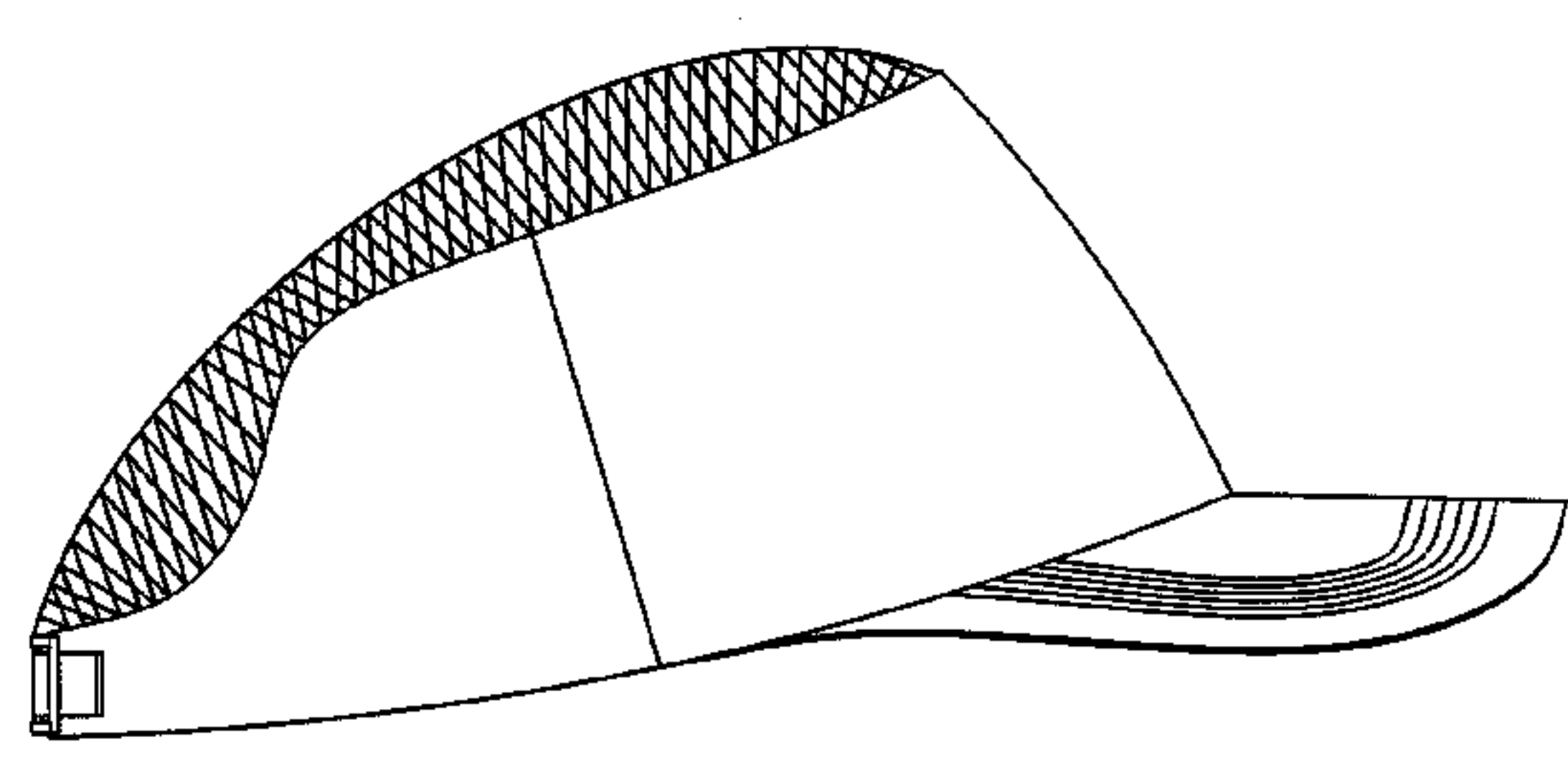
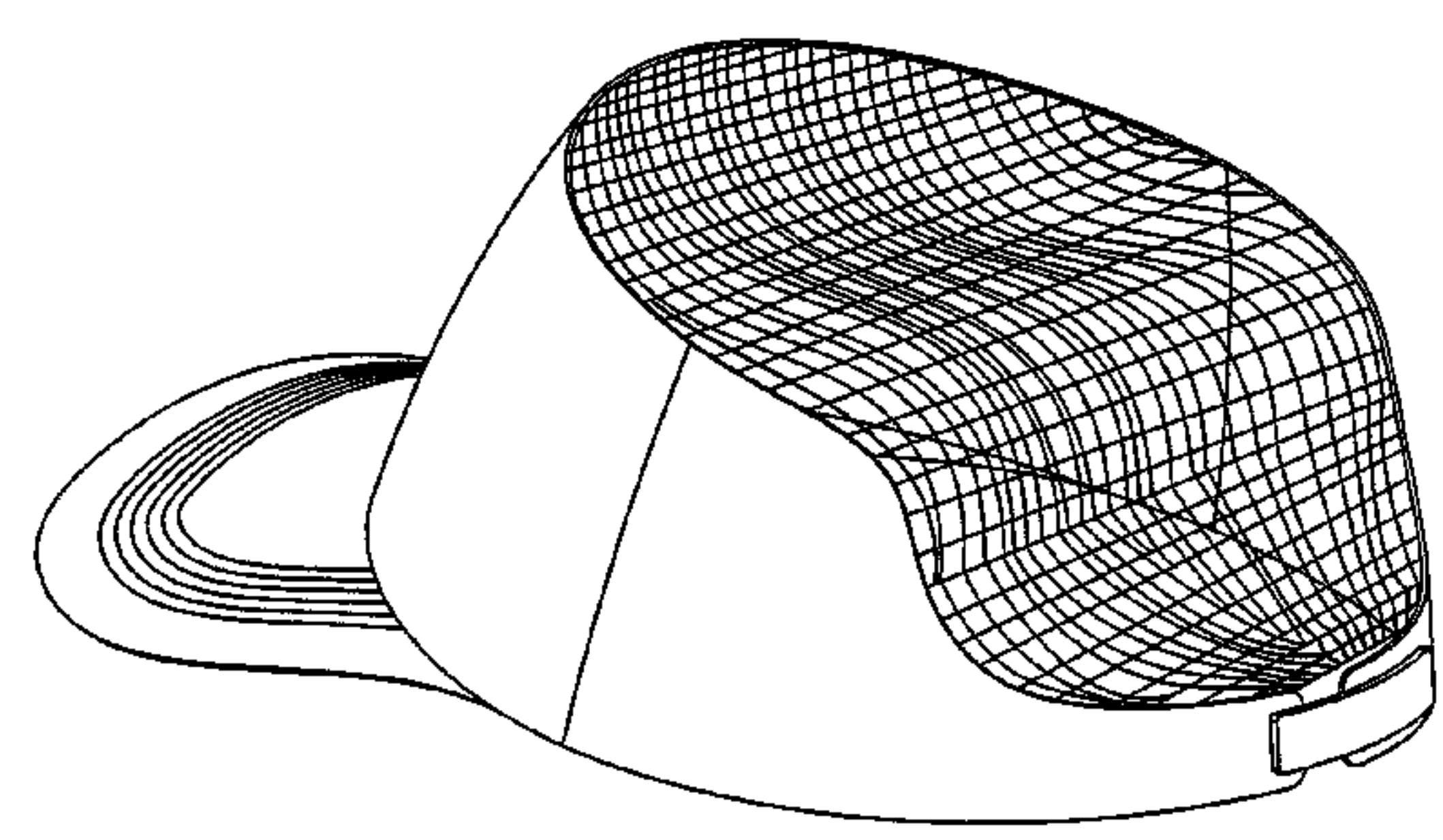

DESCRIPTION

FIG. 1 is a side rear, perspective view of the cap with a net material, showing my new design;

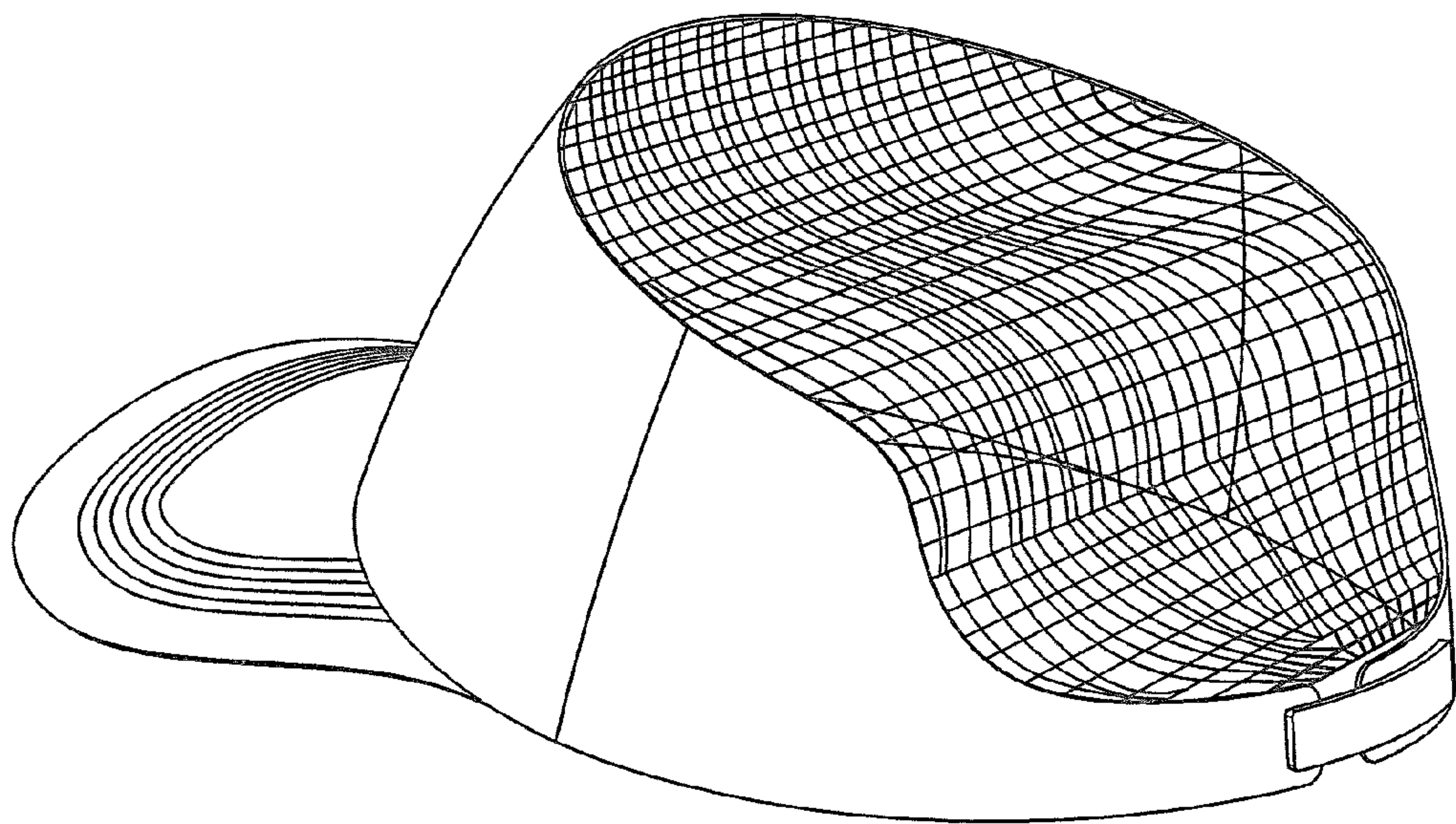

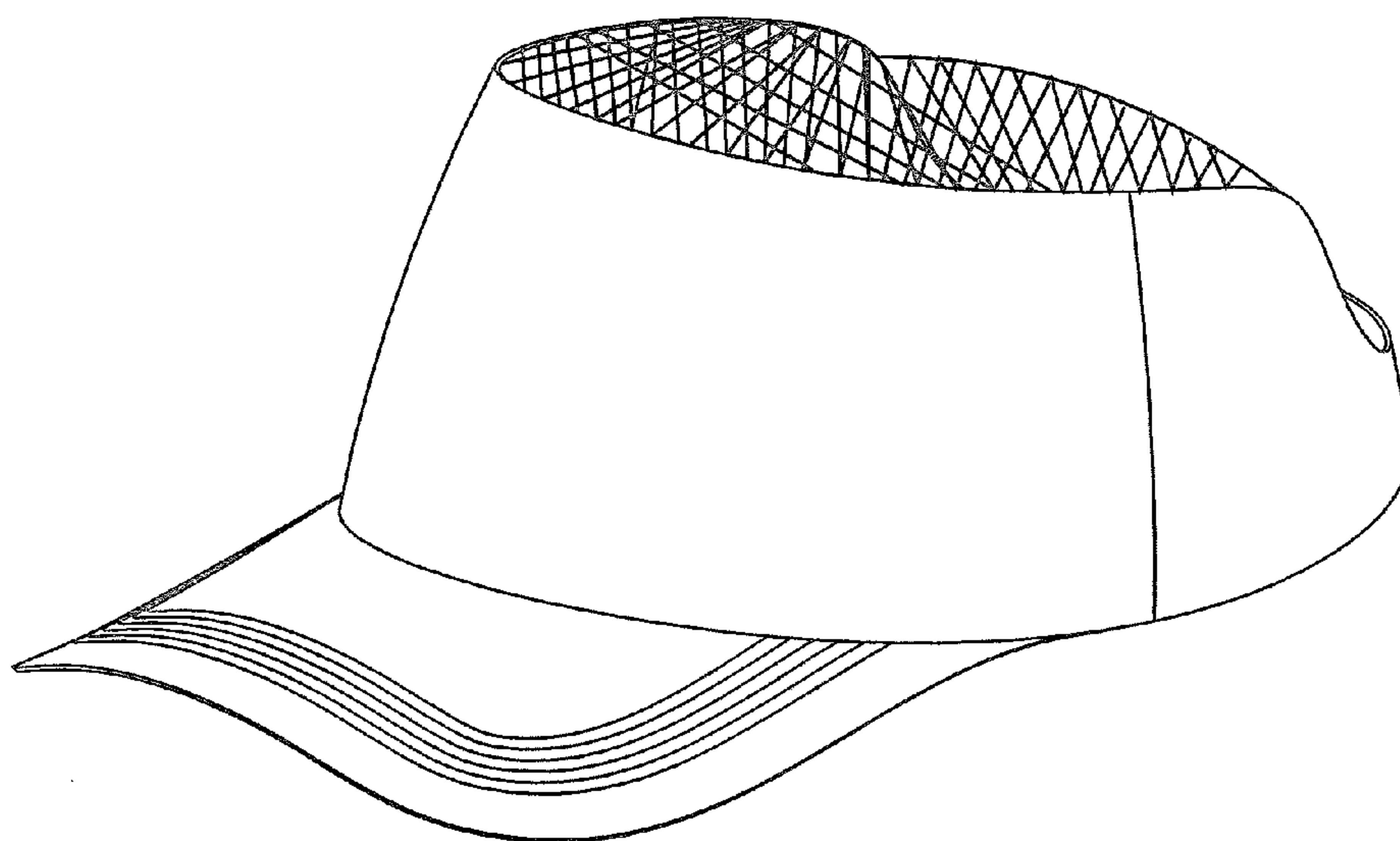

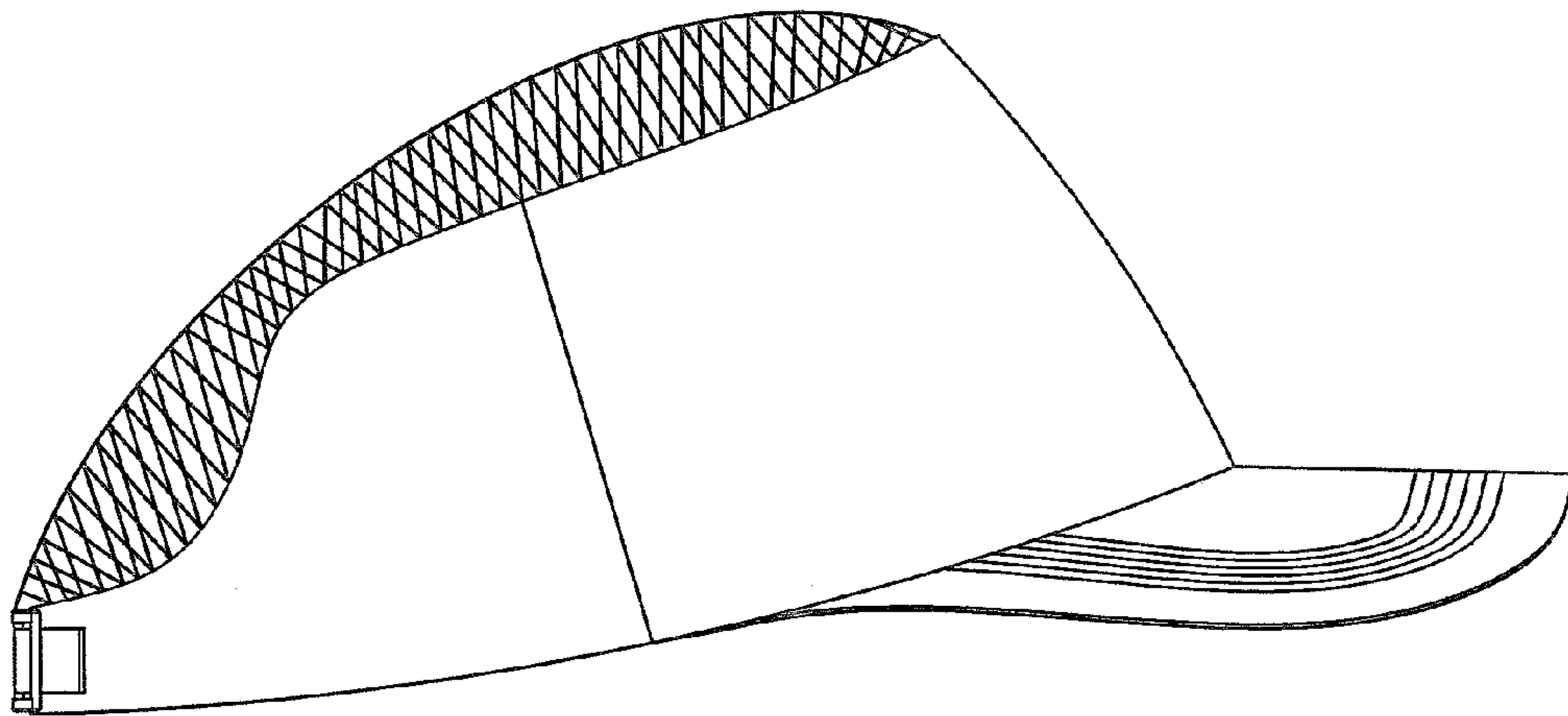

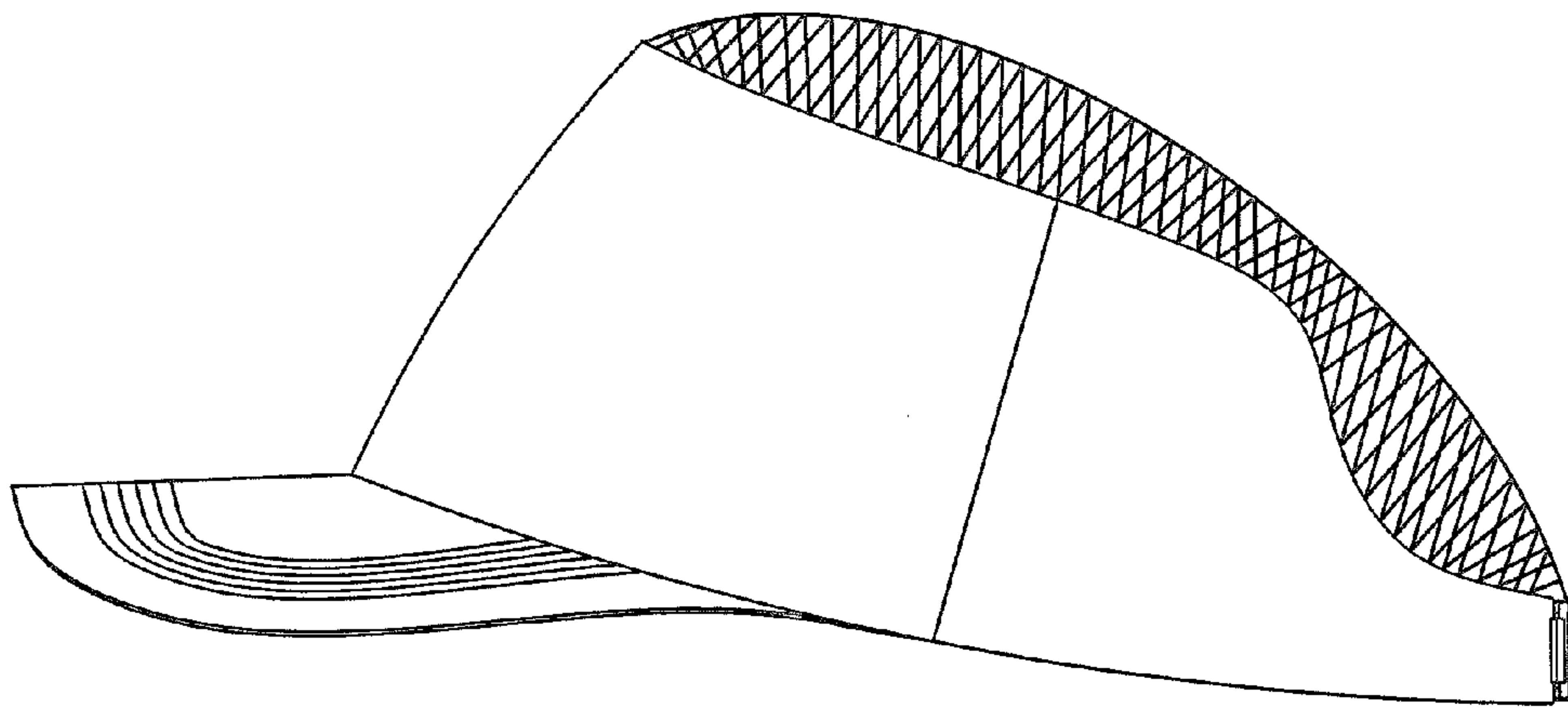

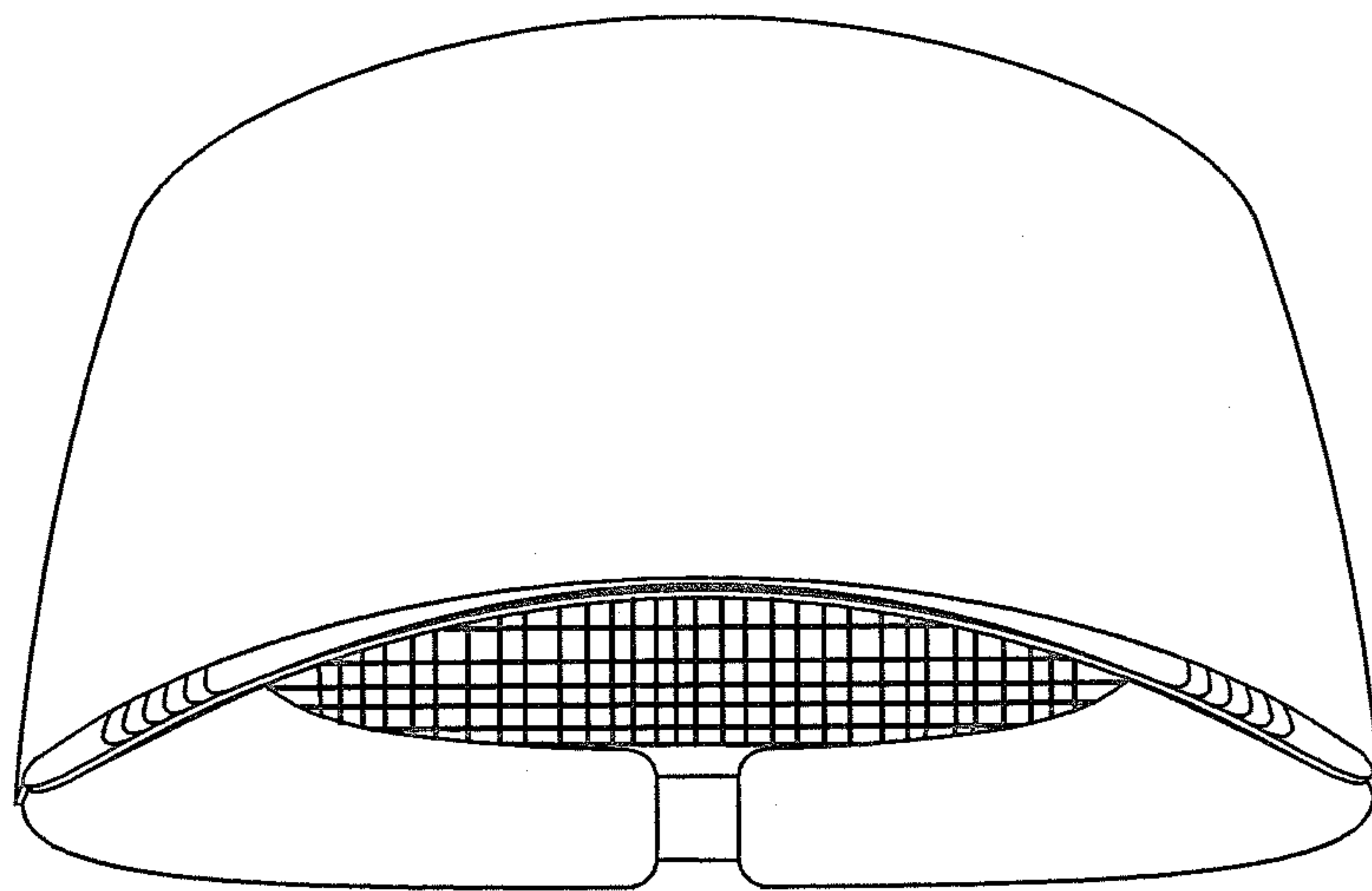

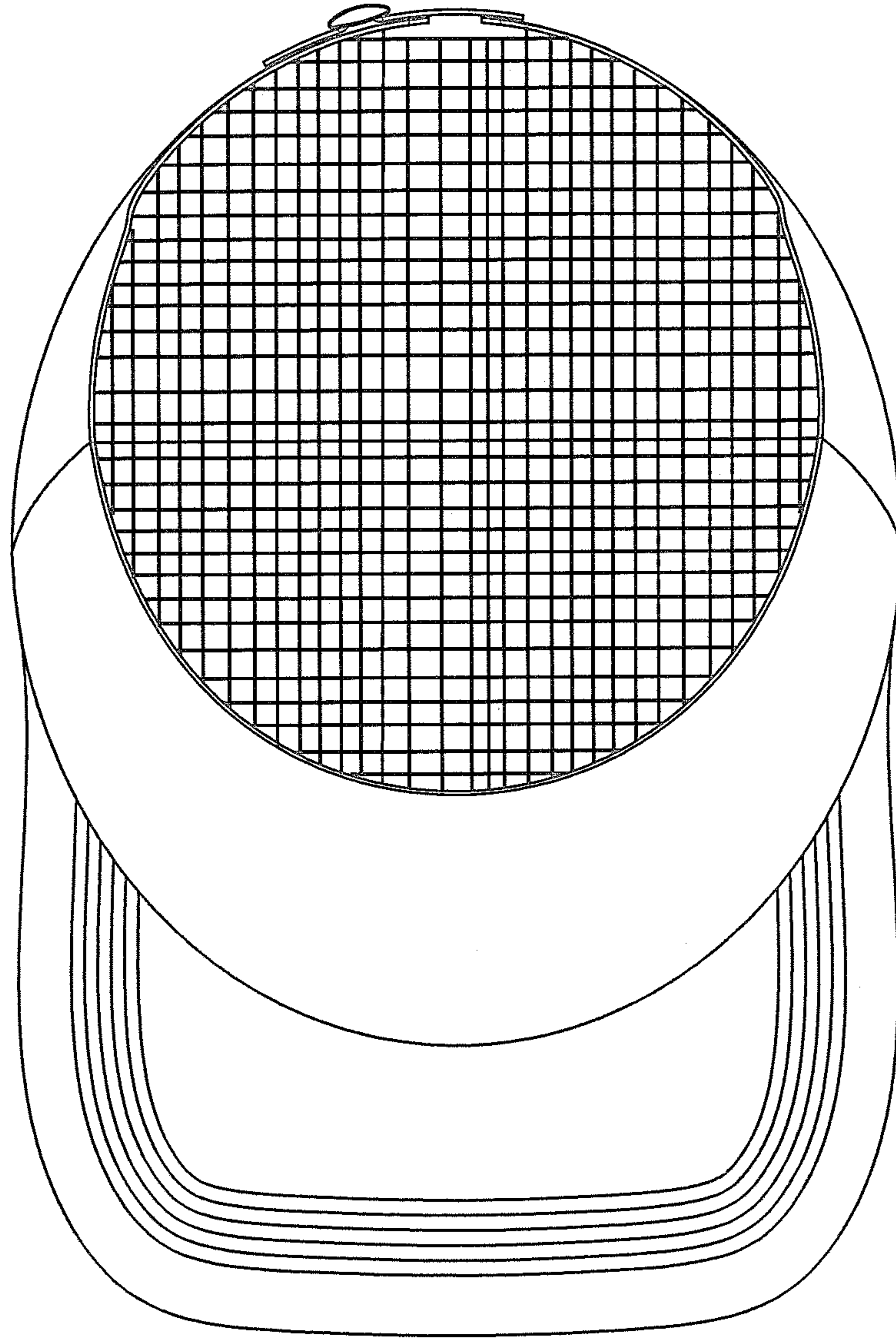

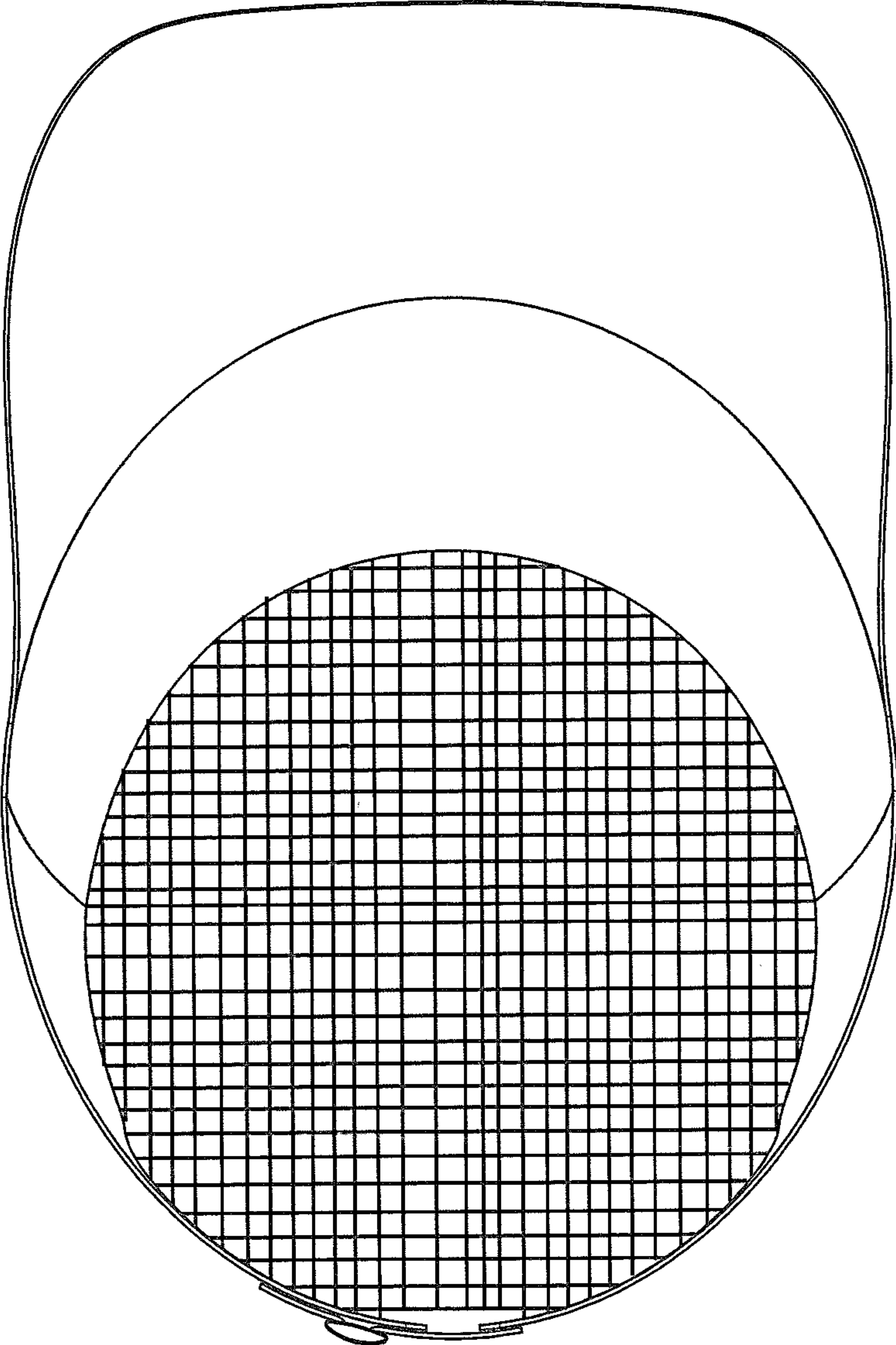

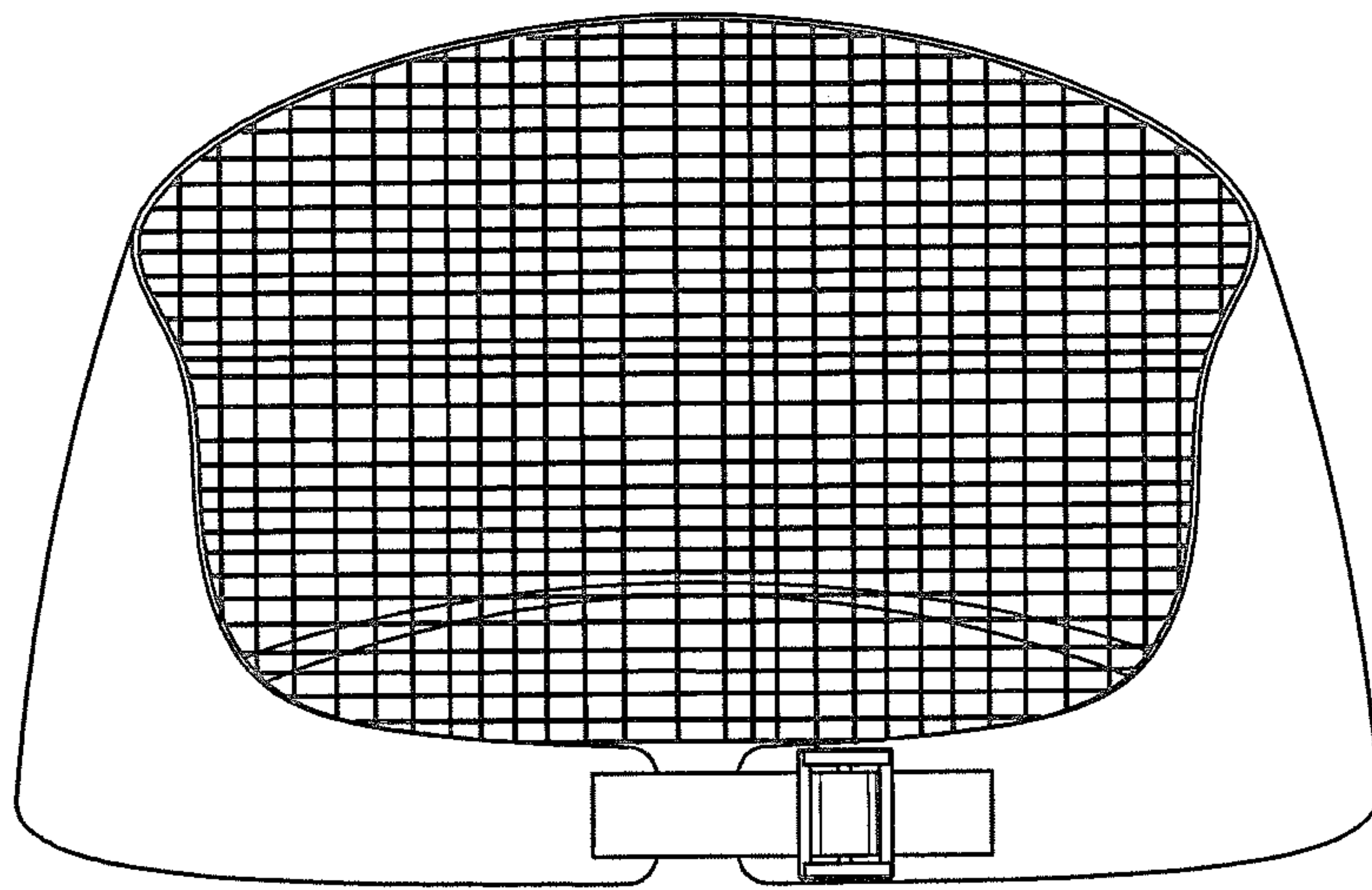
