DESCRIPTION

FIG. 1 is a perspective view of a shoe, showing my new design;

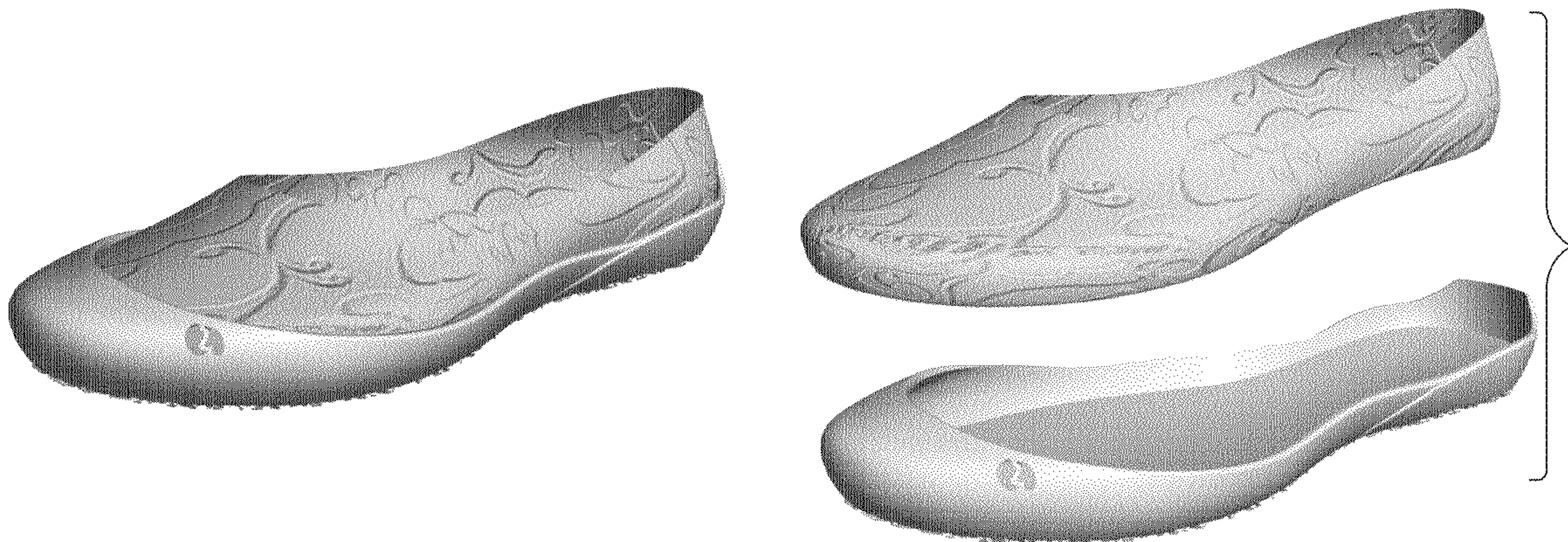

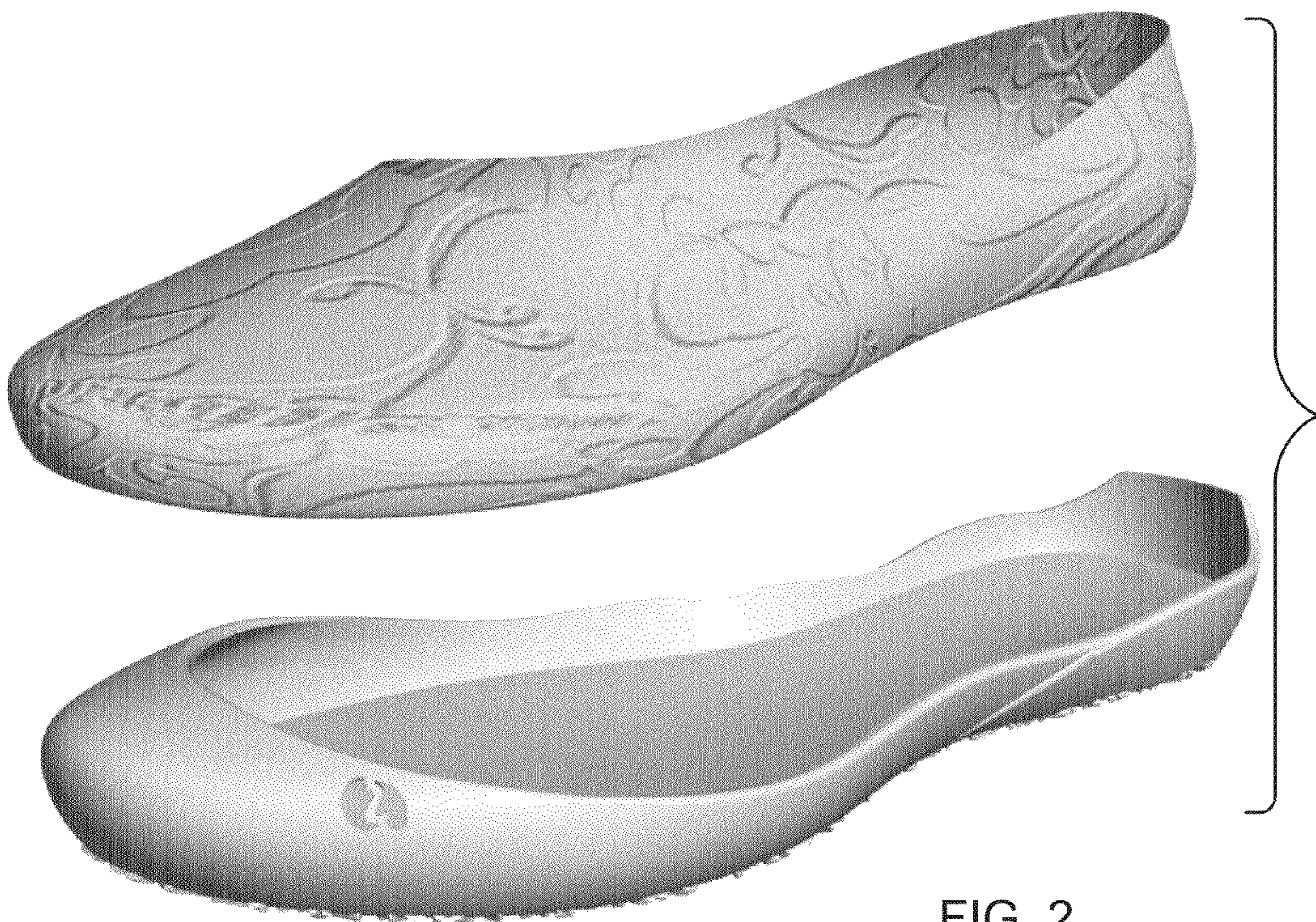

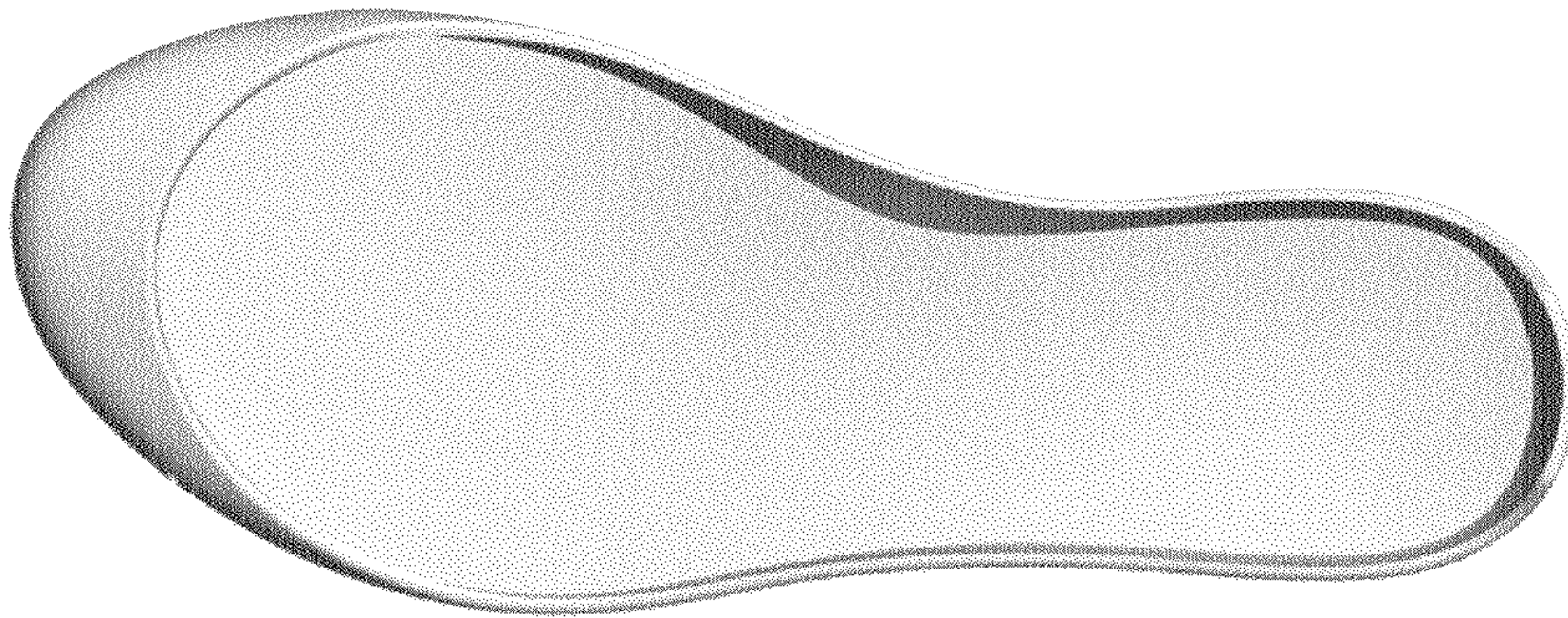
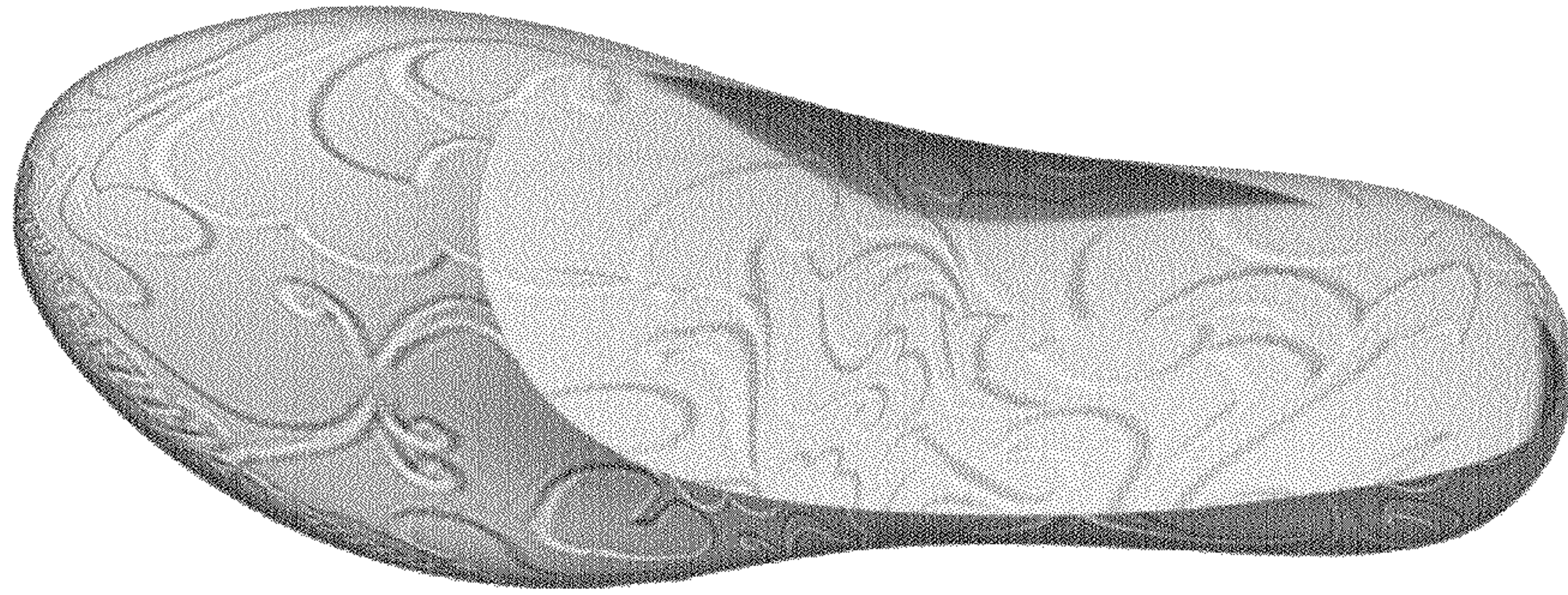

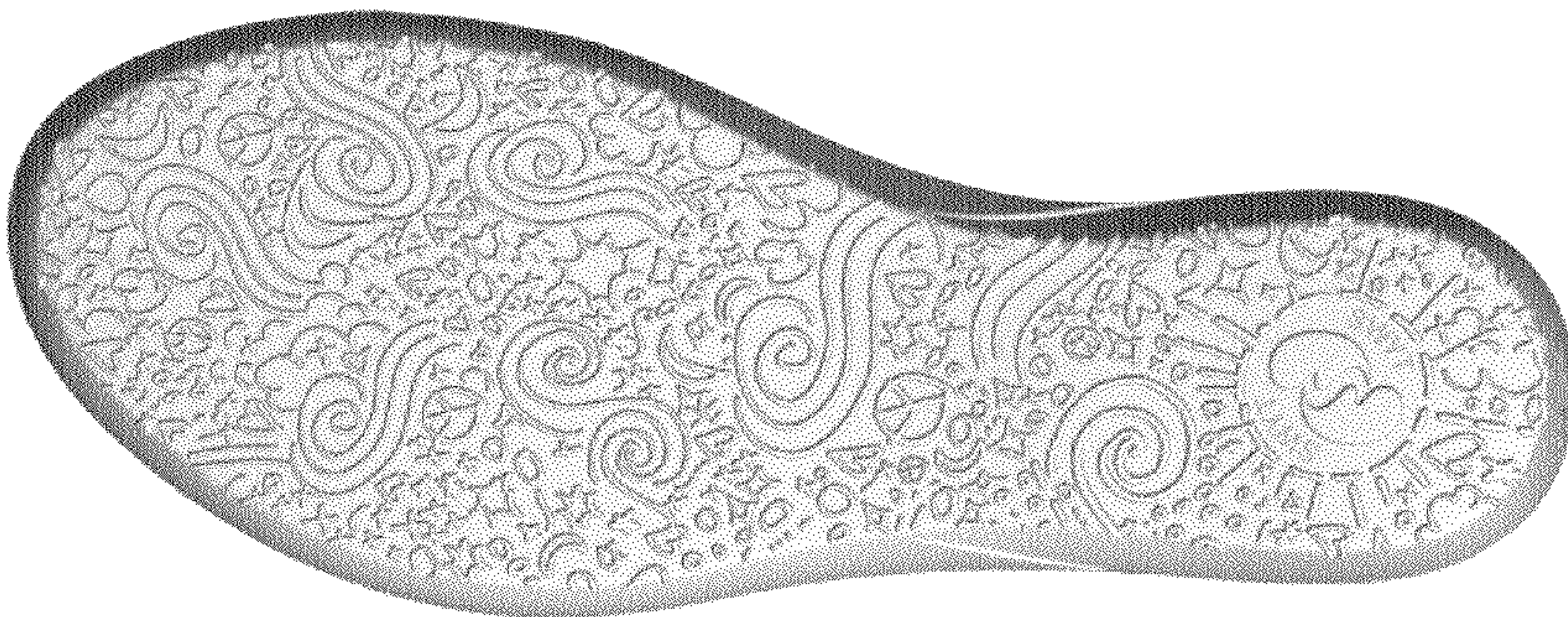
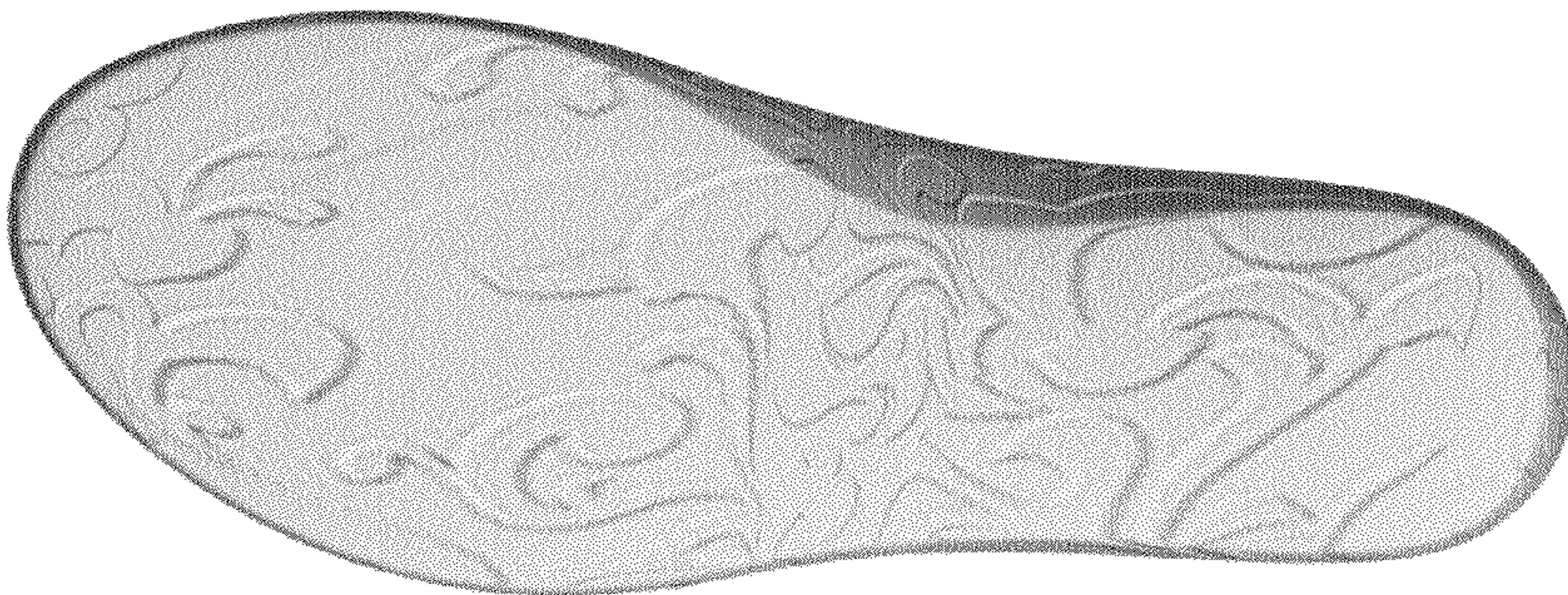

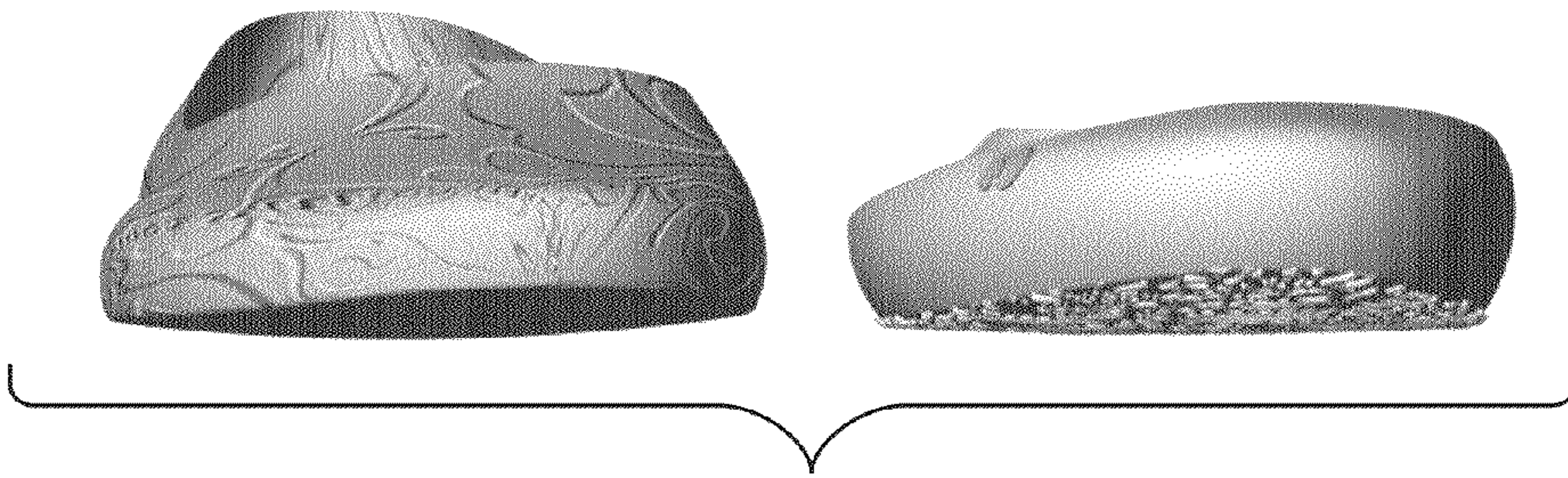

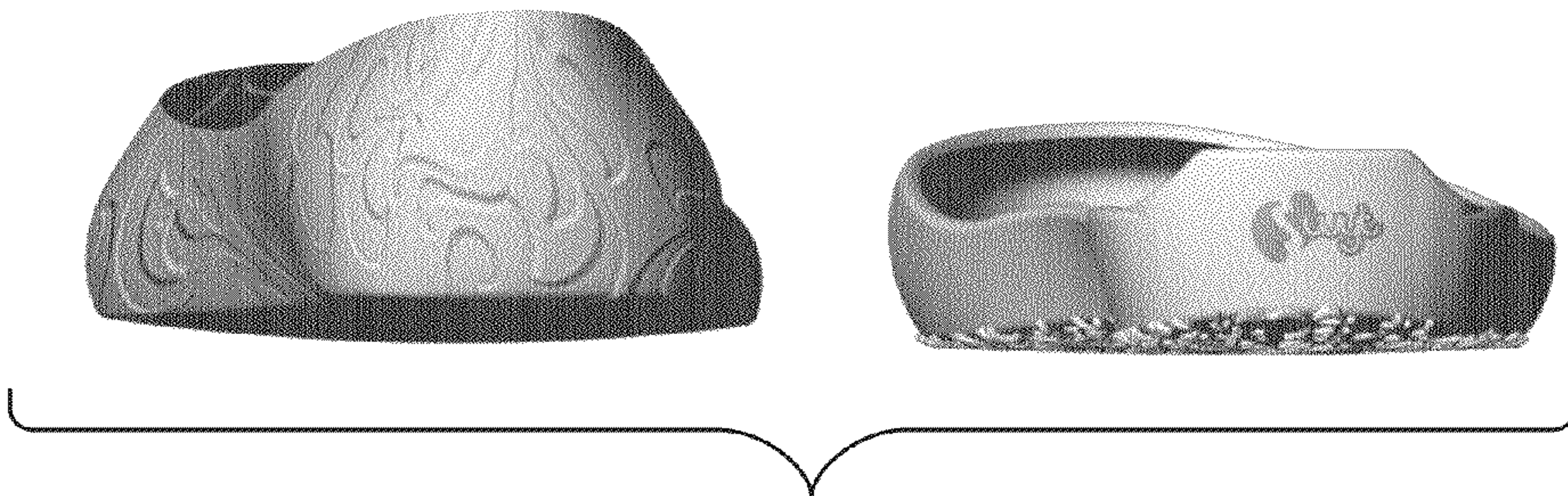

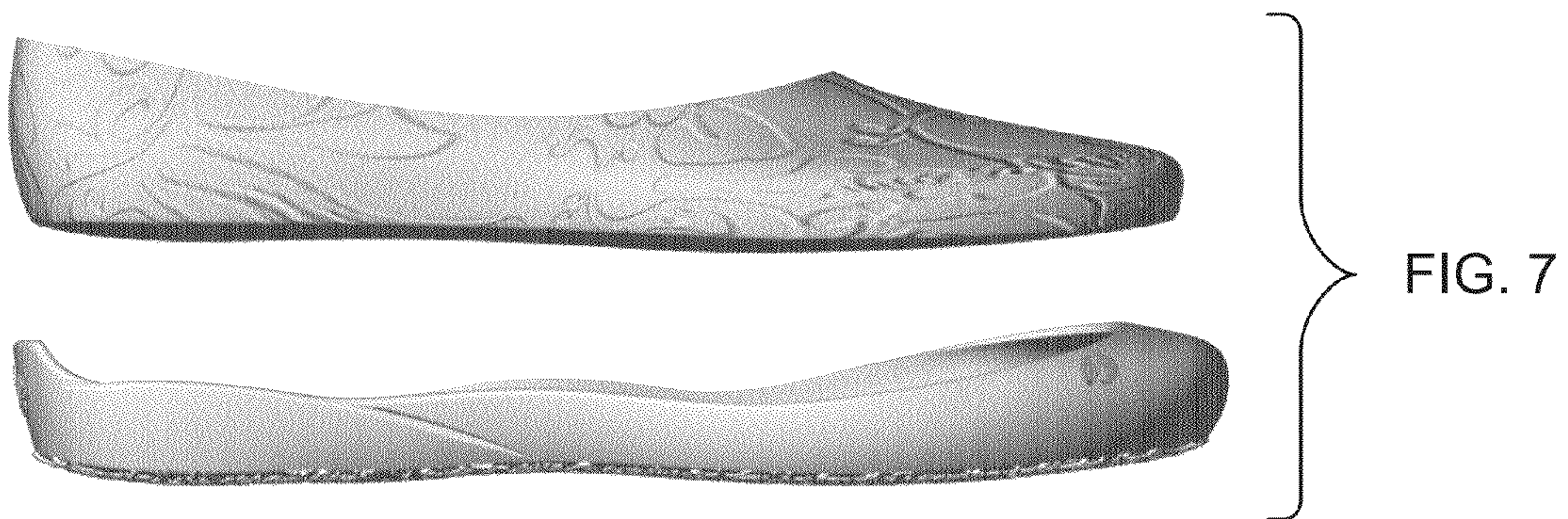
