**DESCRIPTION**

FIG. 18 is a front plan view of the third embodiment thereof;

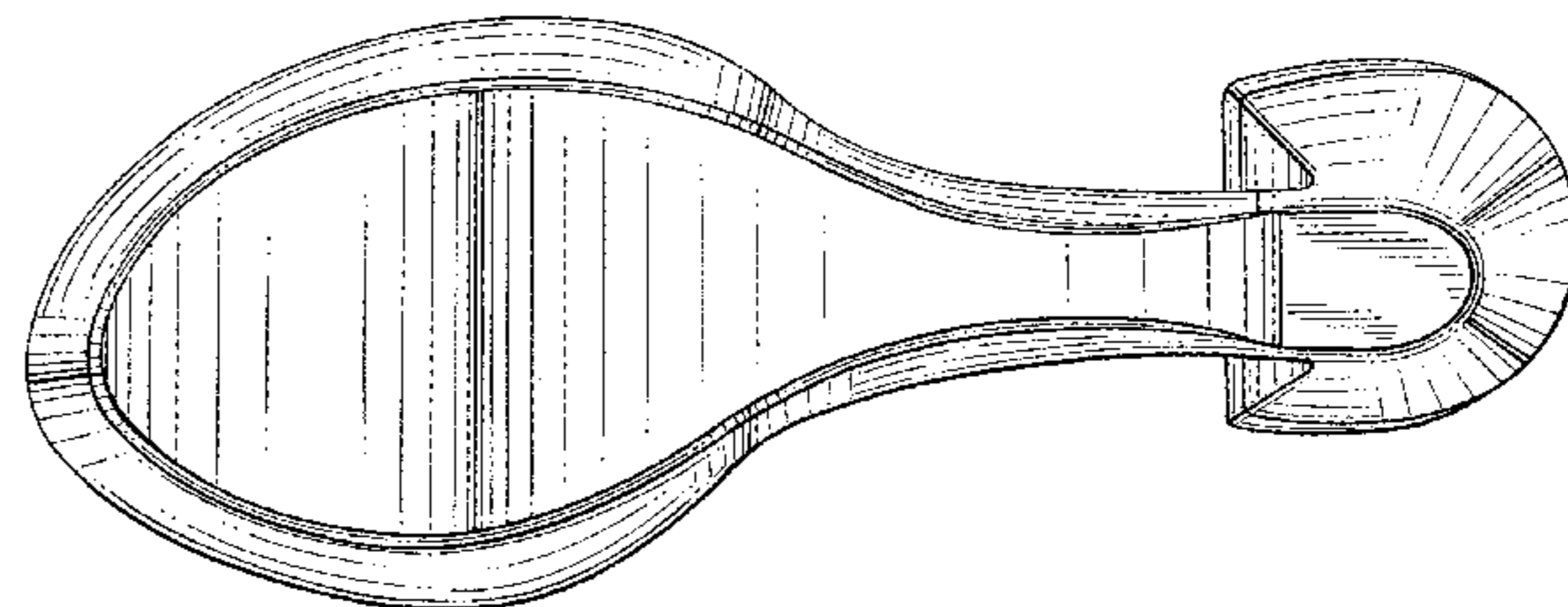
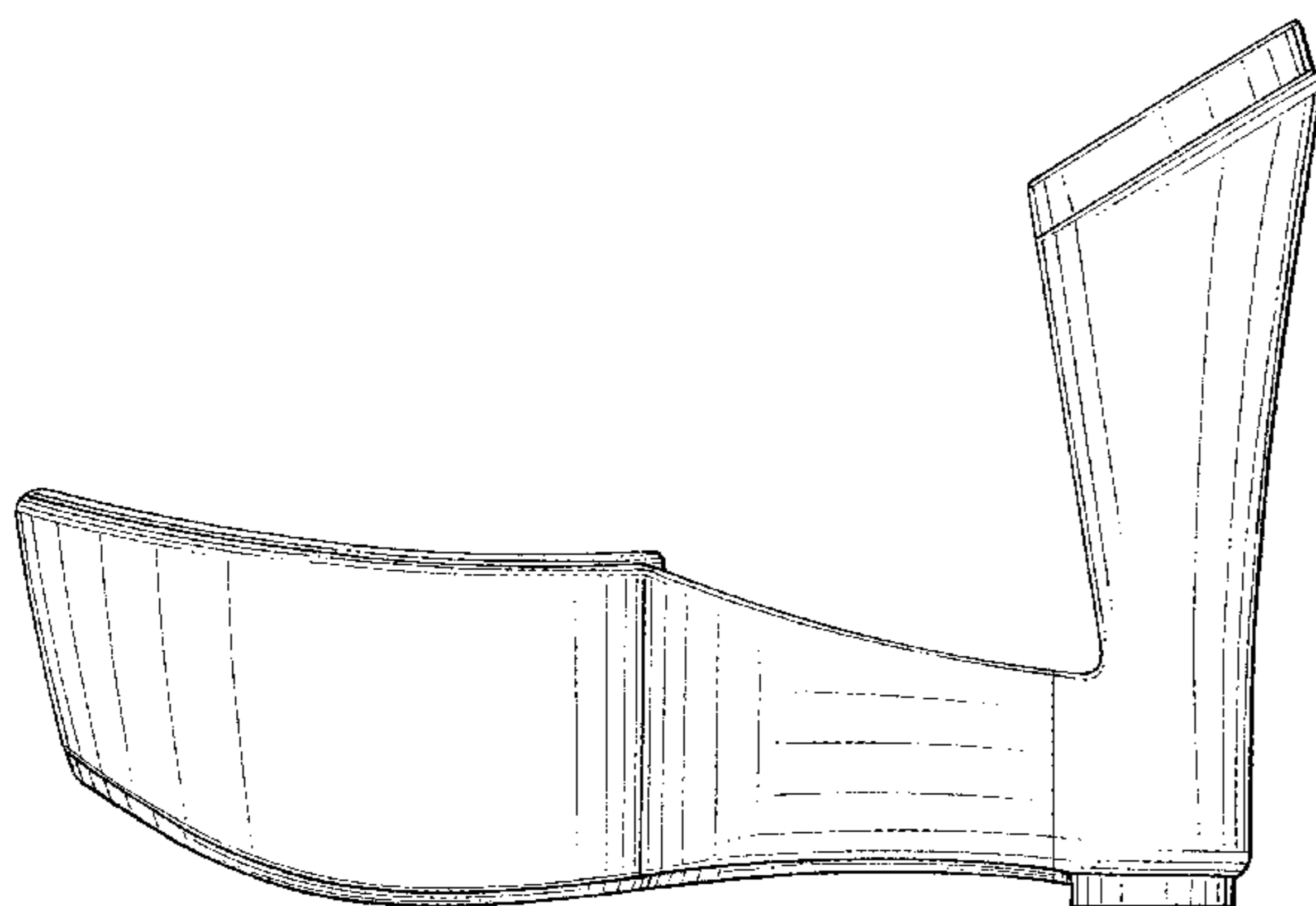
FIG. 19 is a right side view of the third embodiment thereof; and

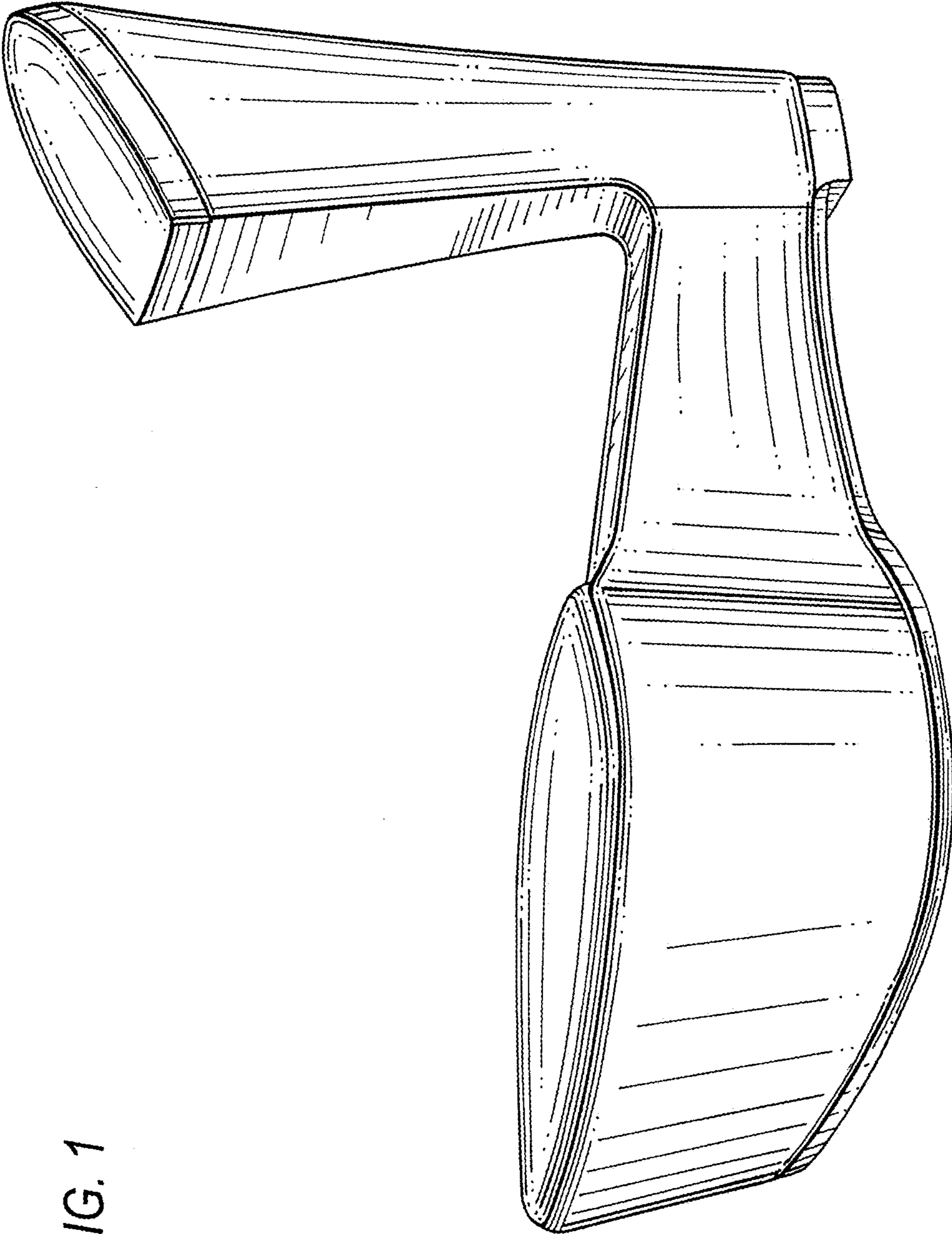
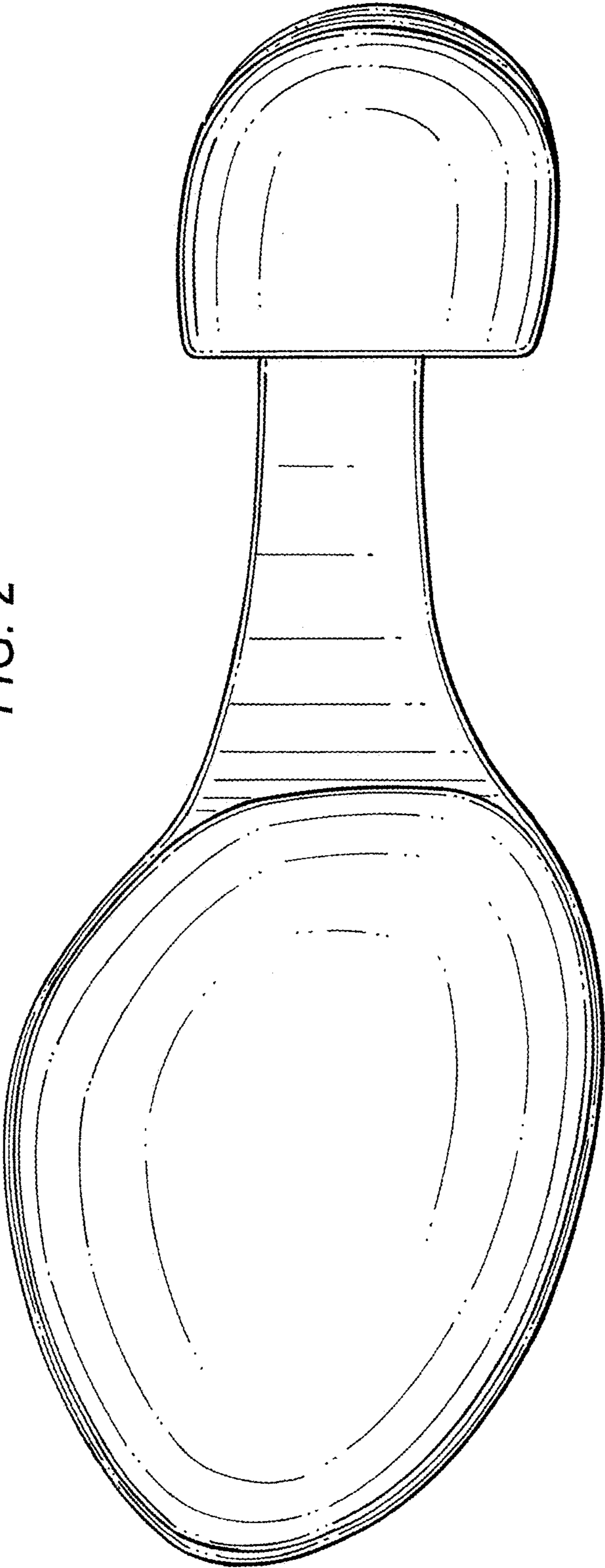

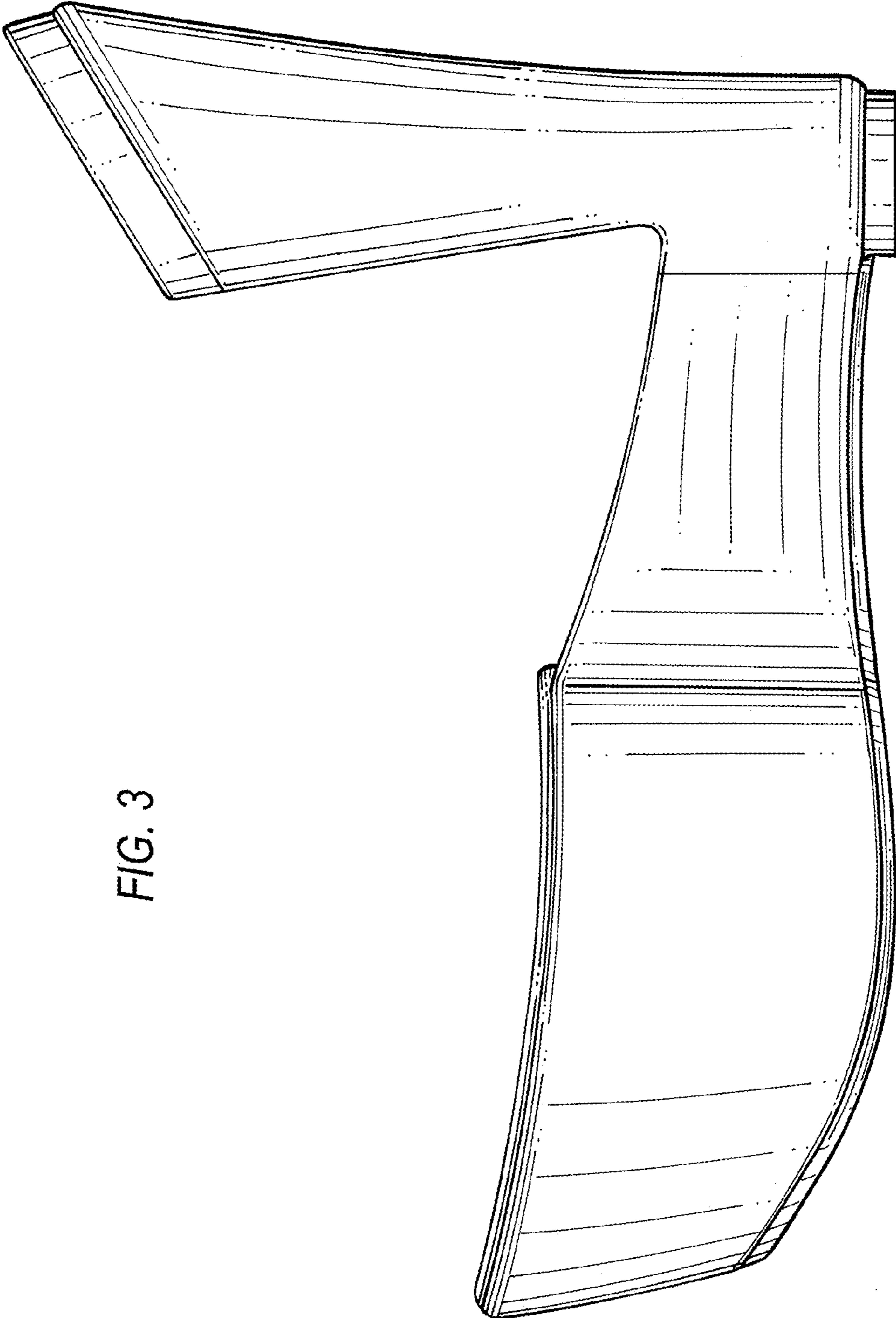

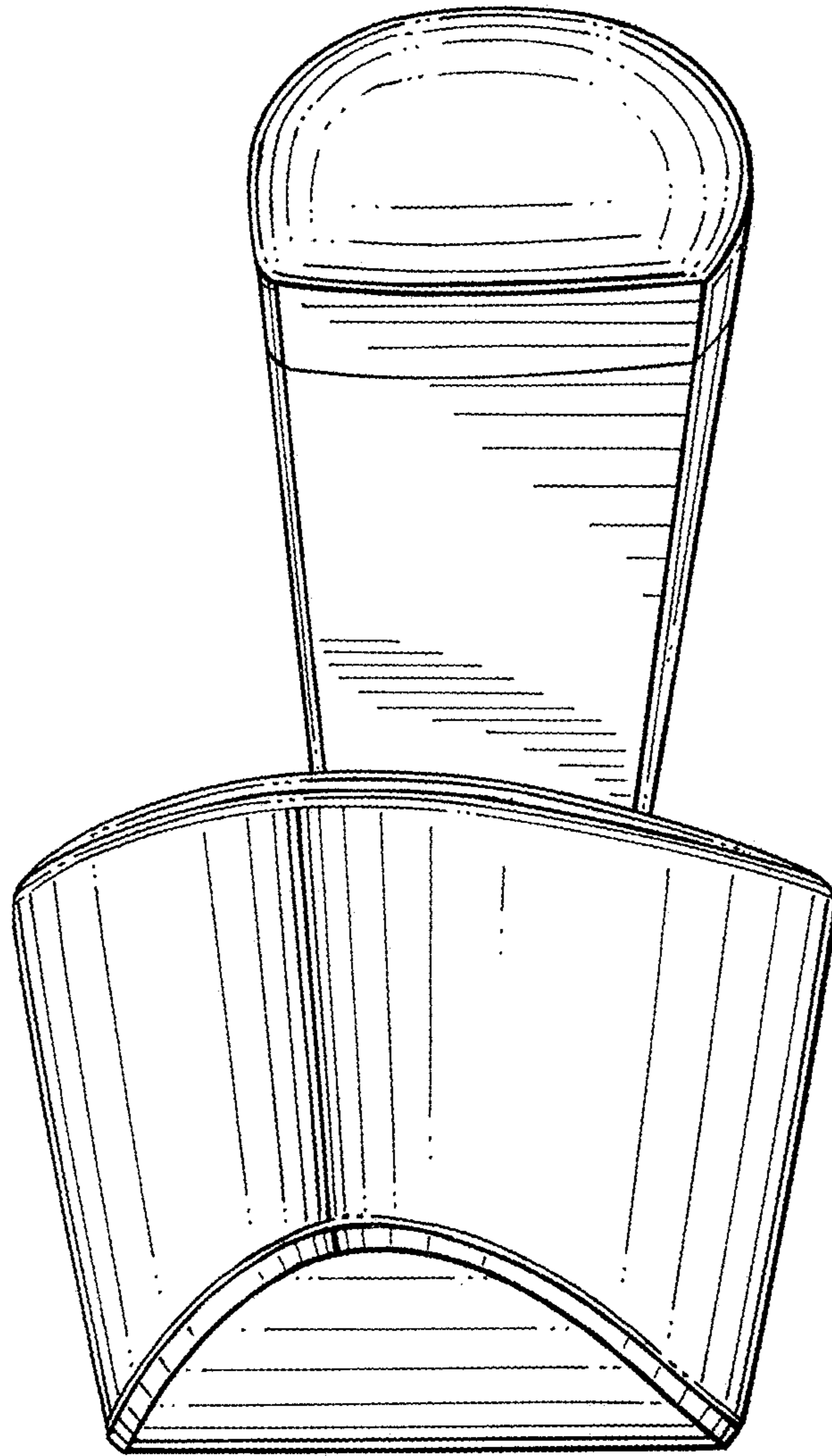
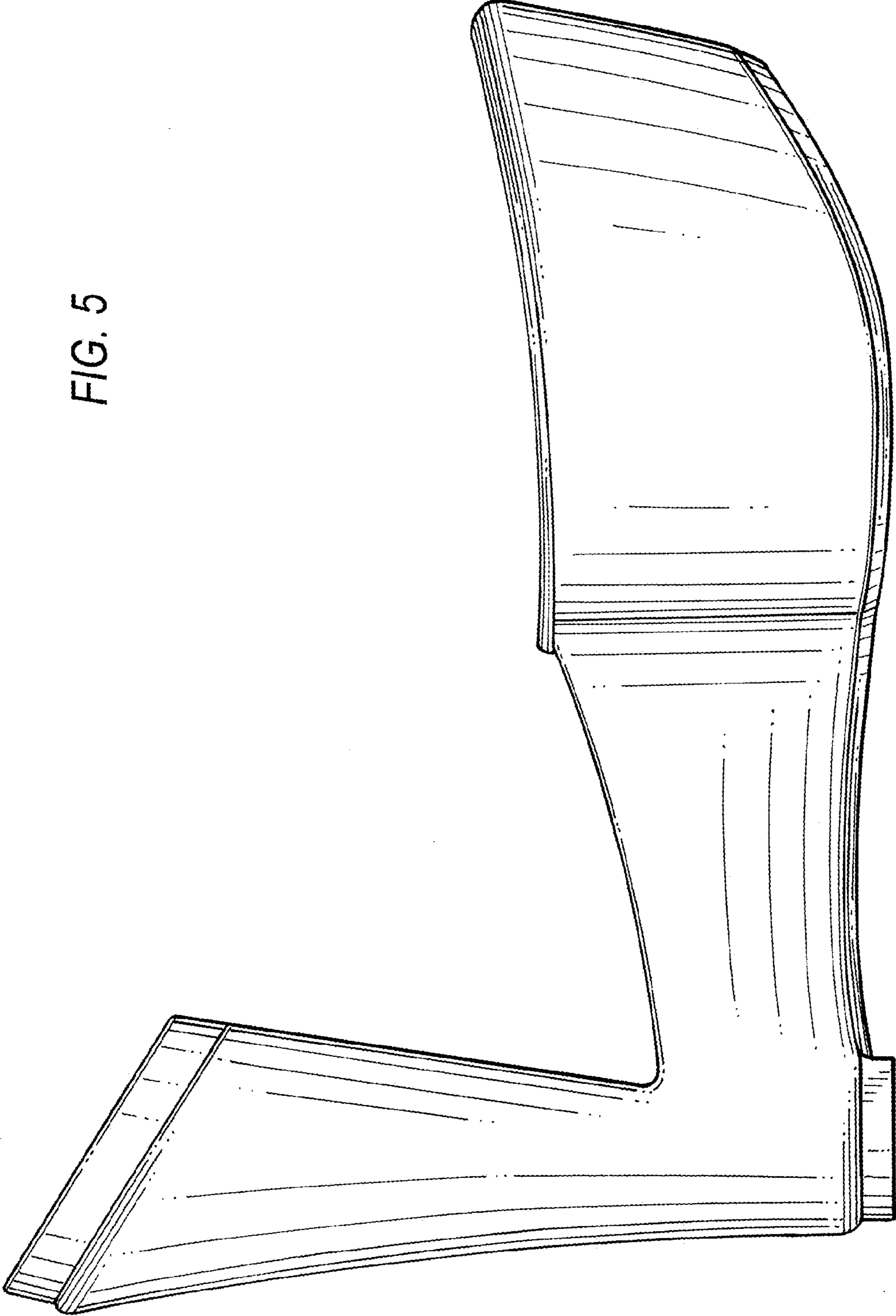

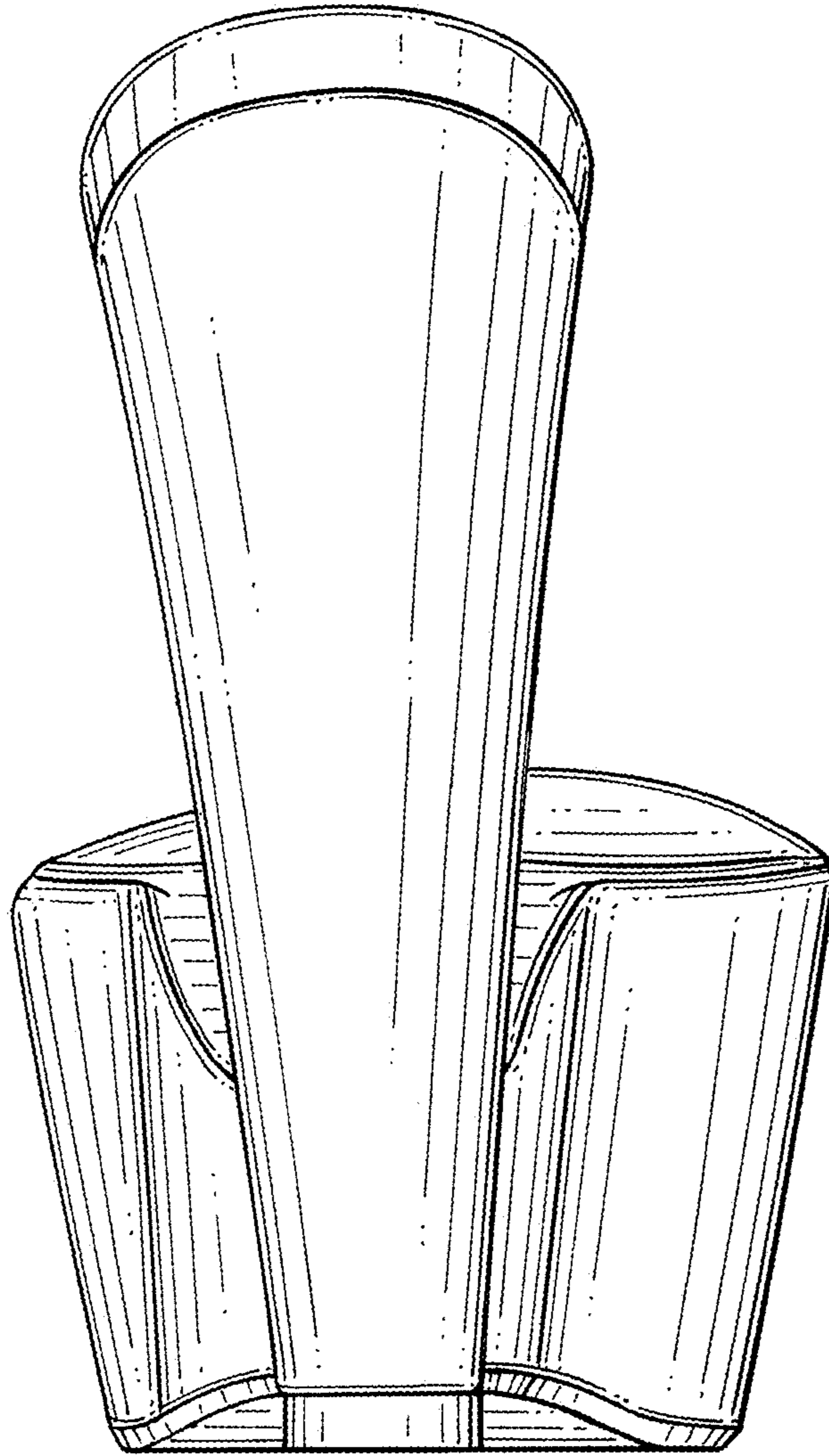

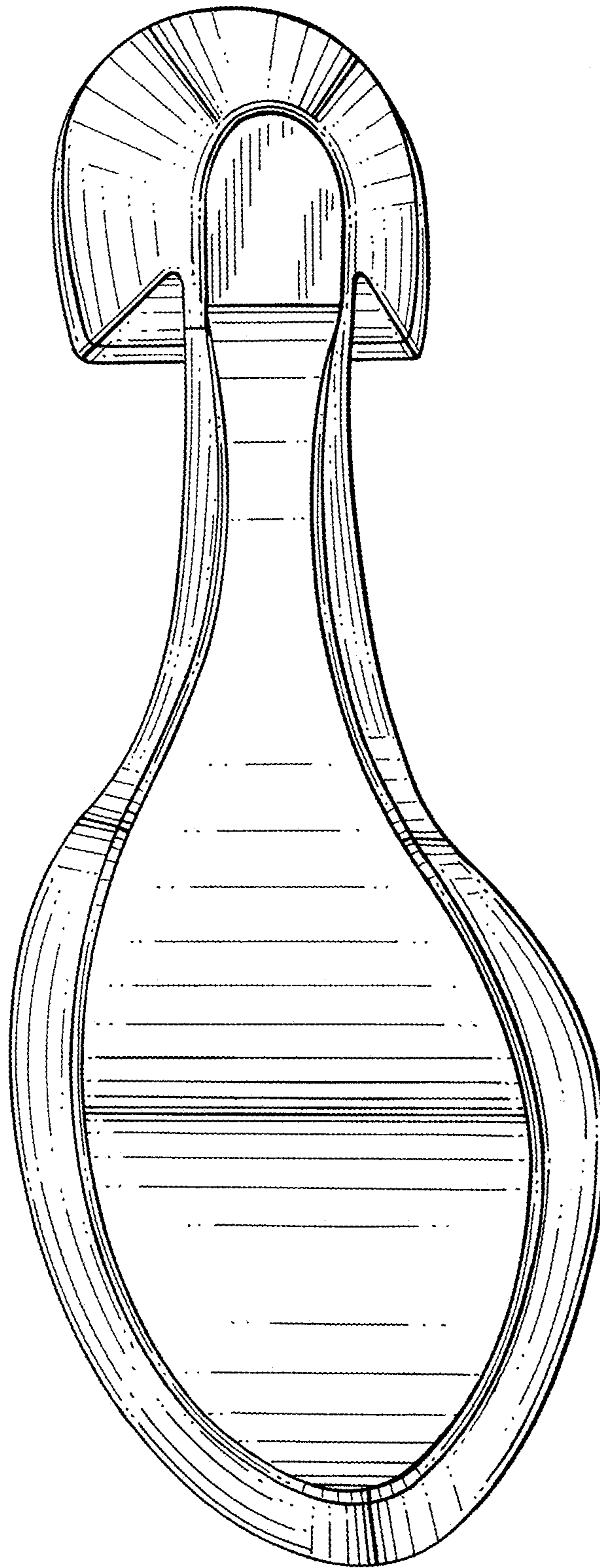

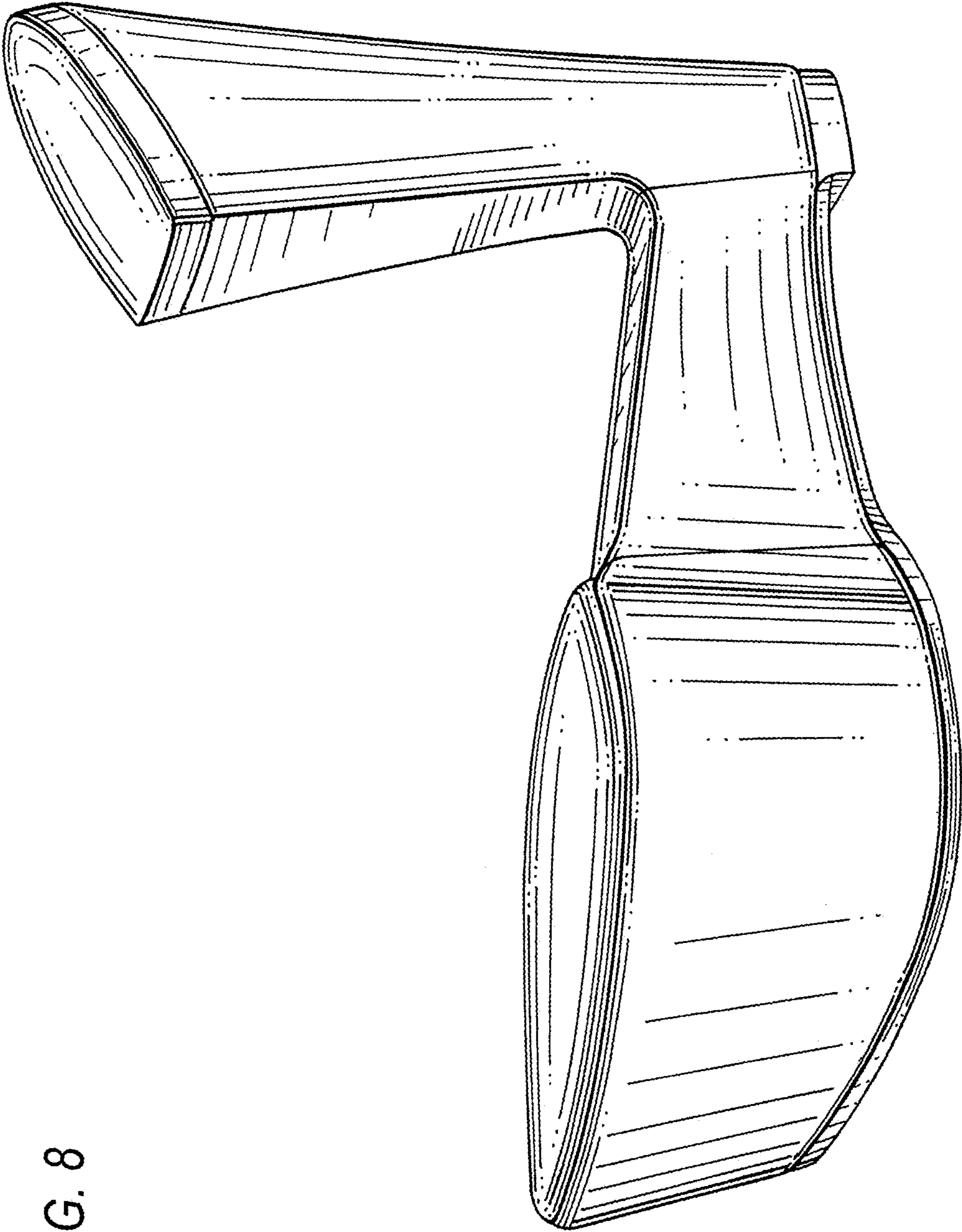
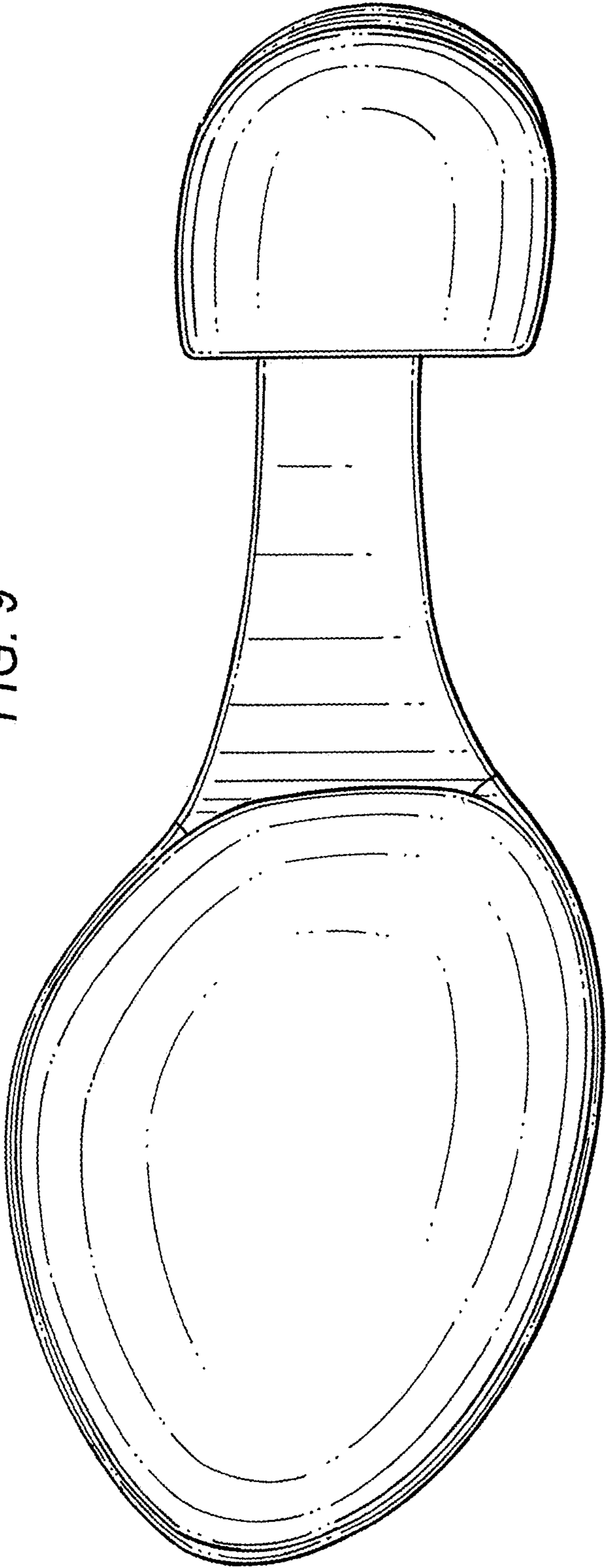

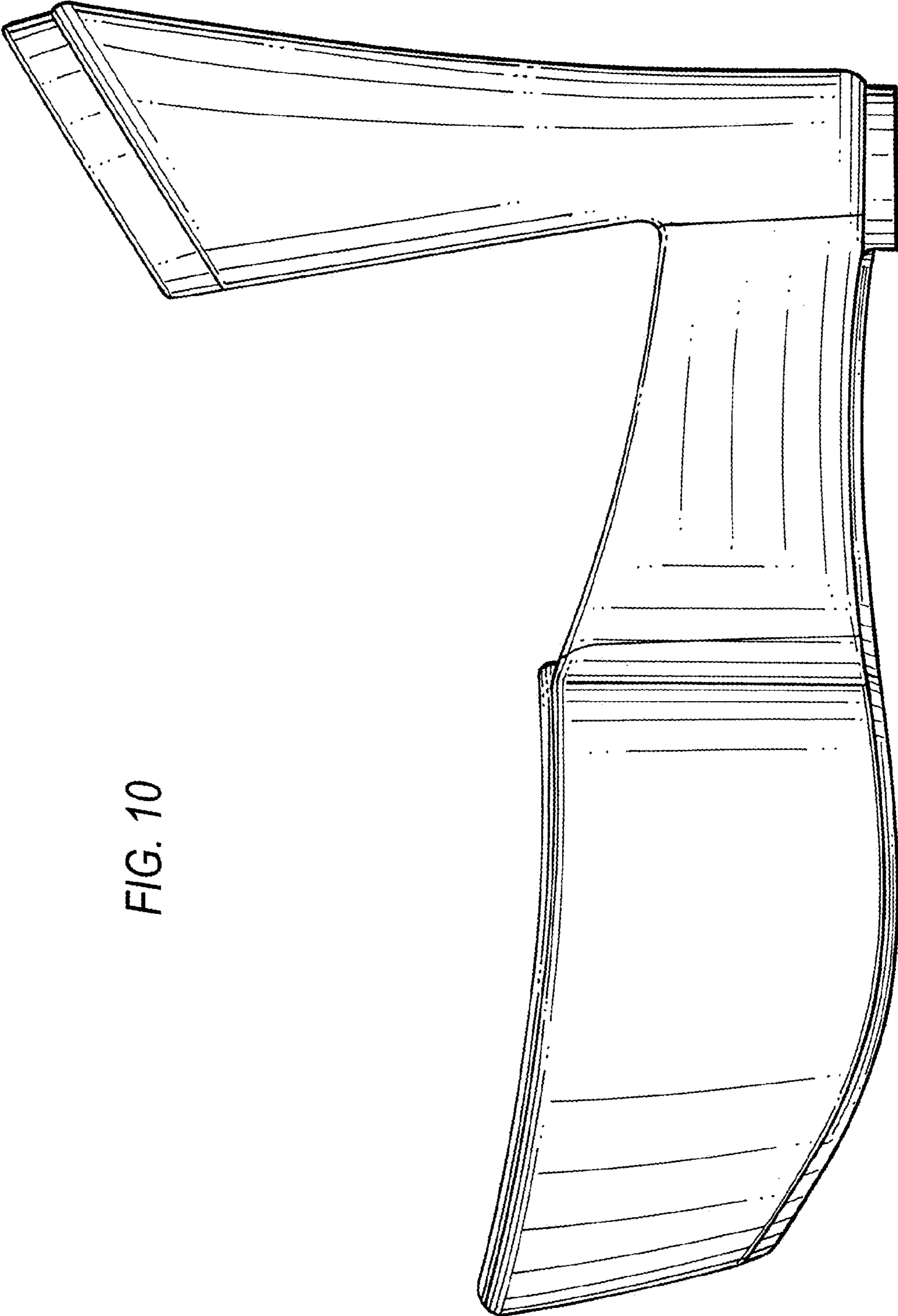

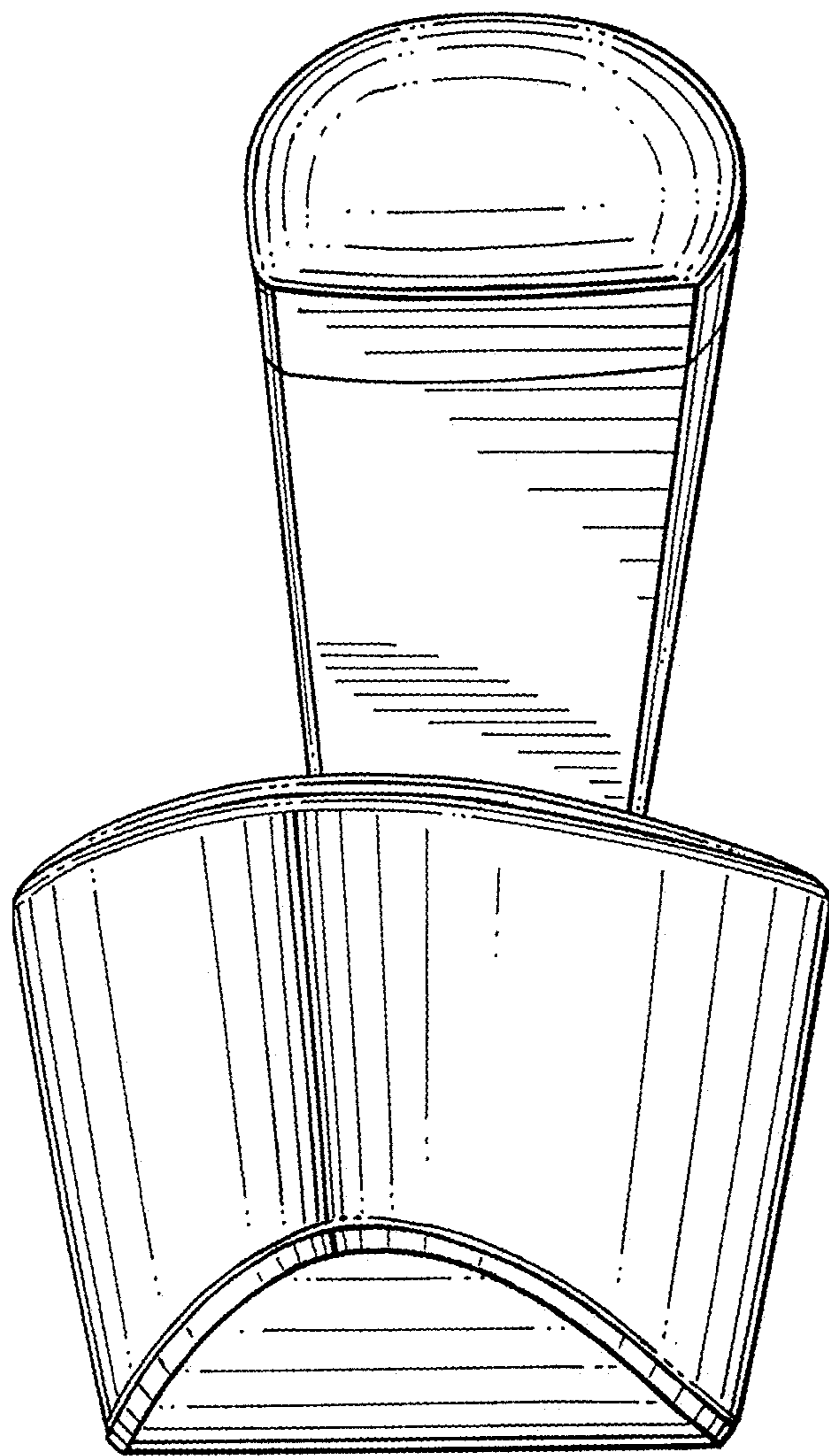
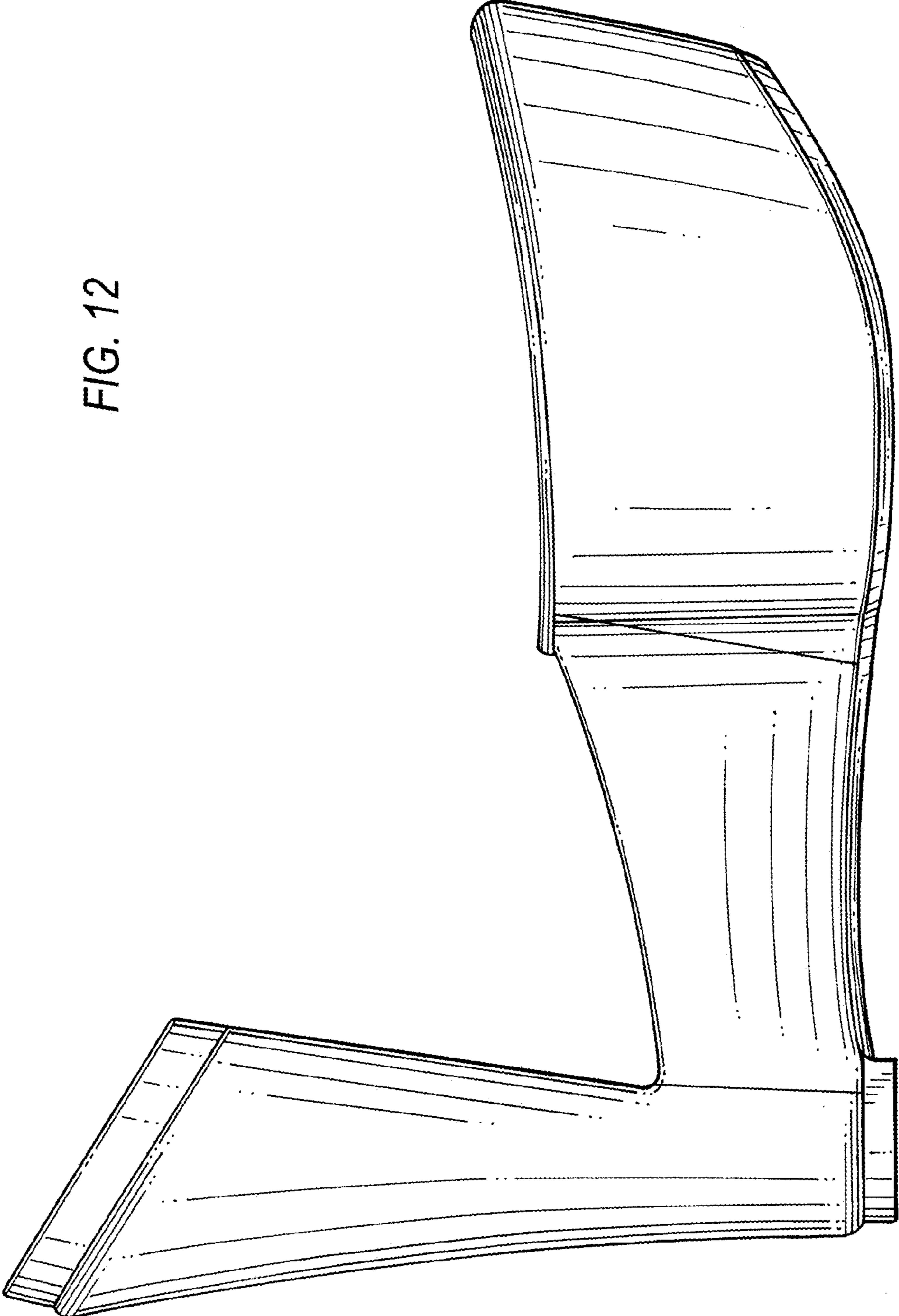

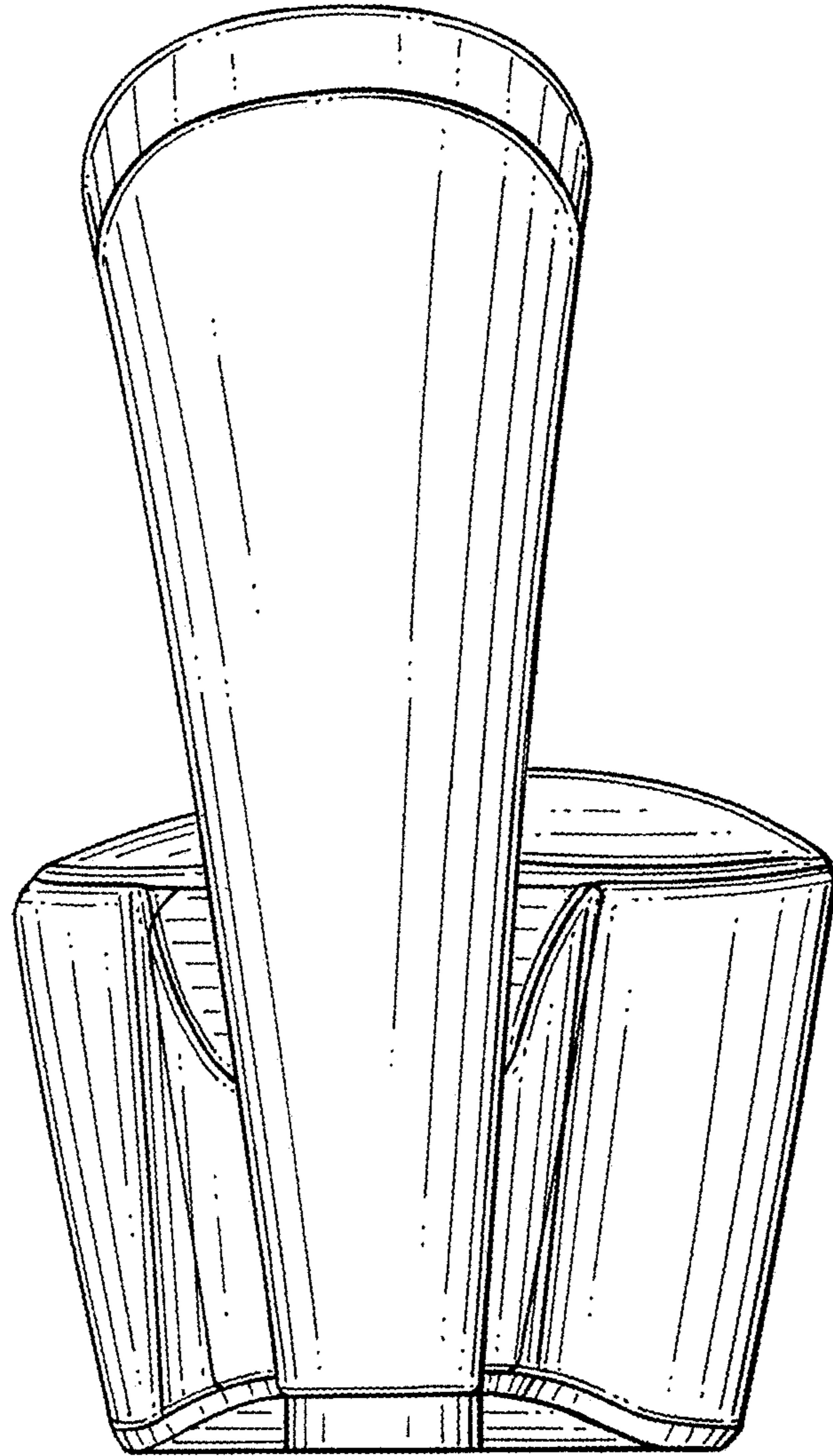

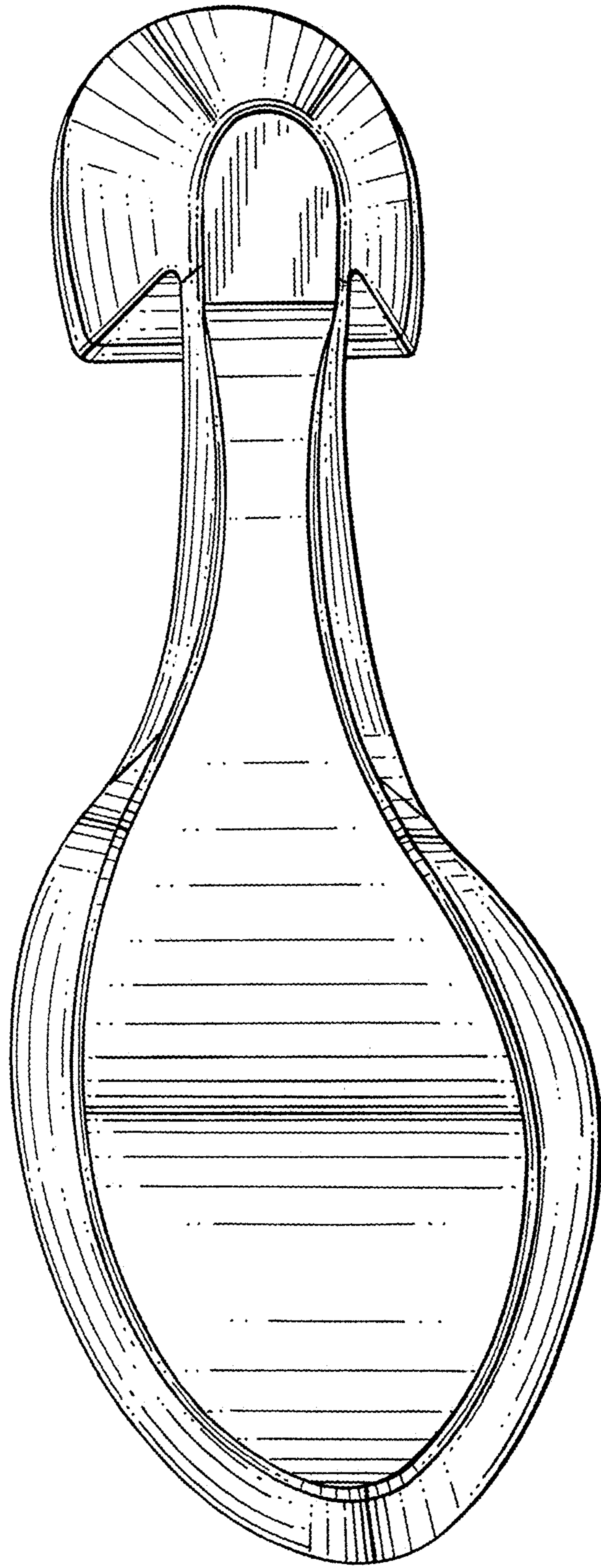

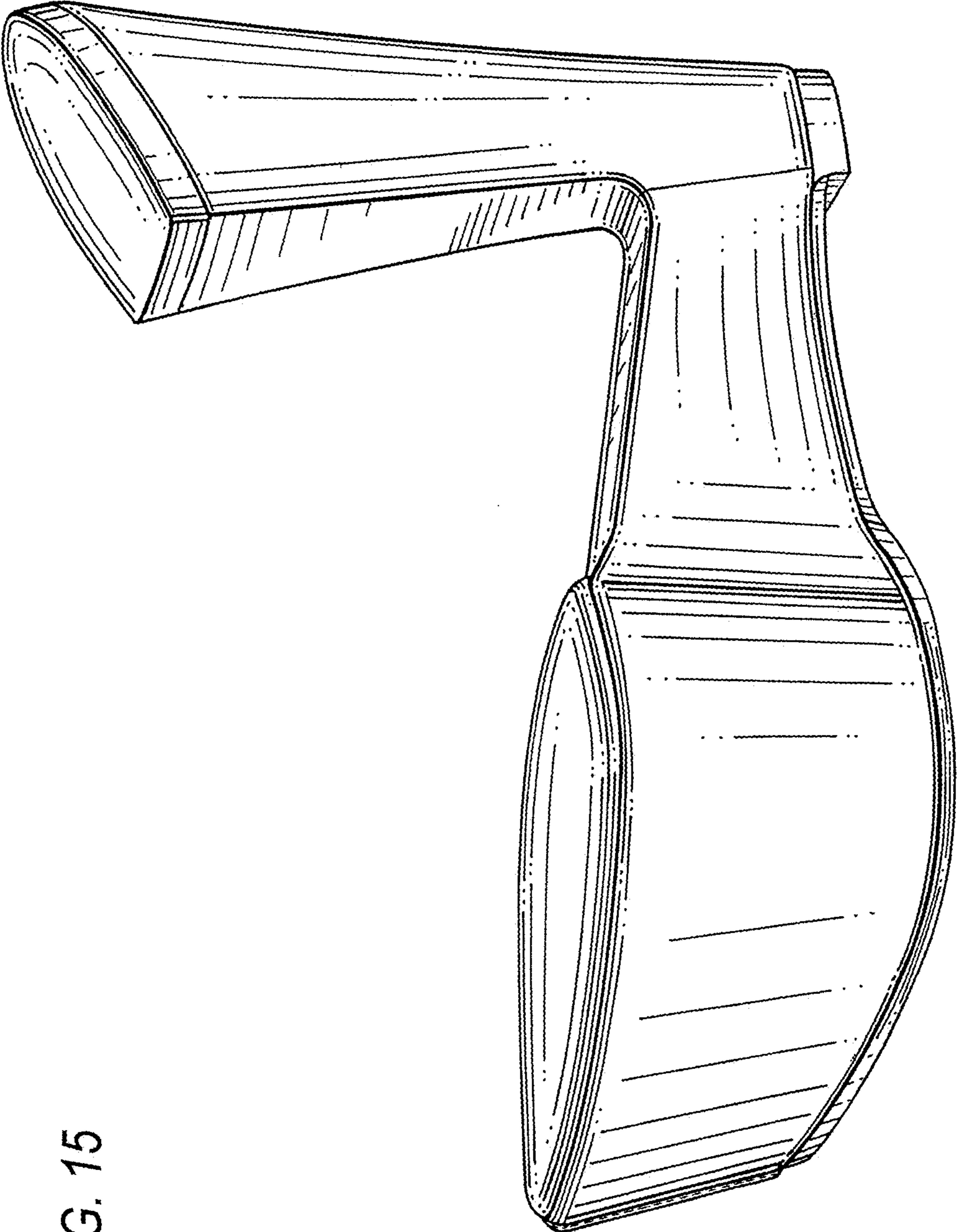
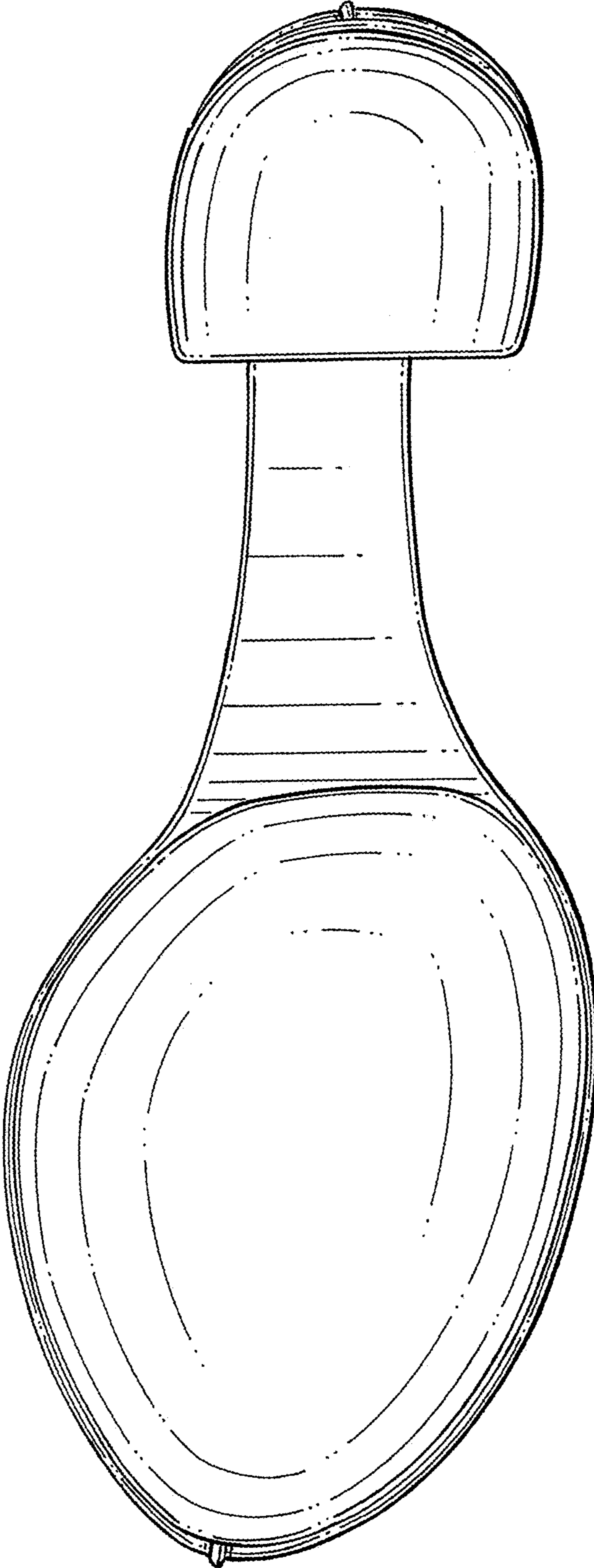

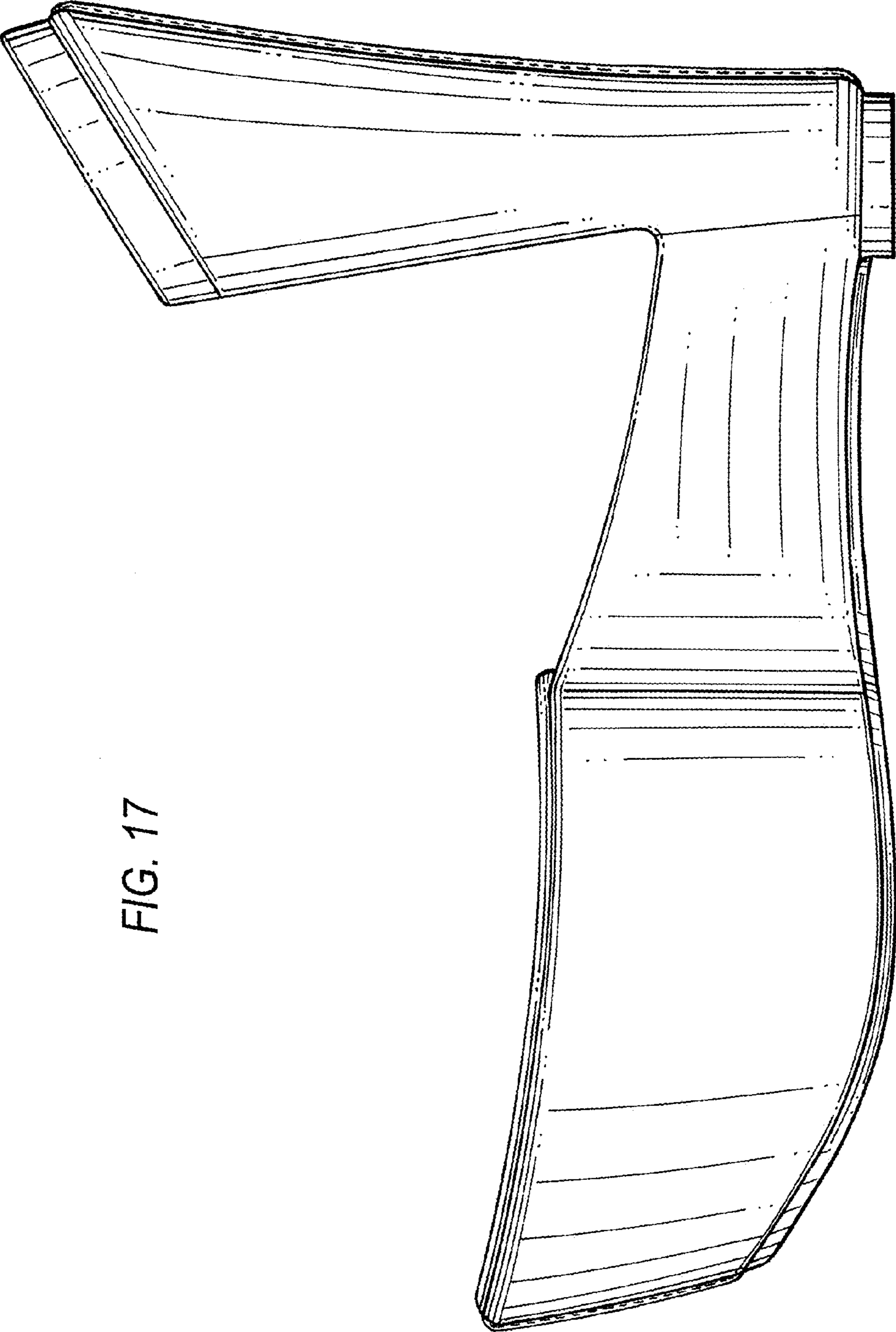

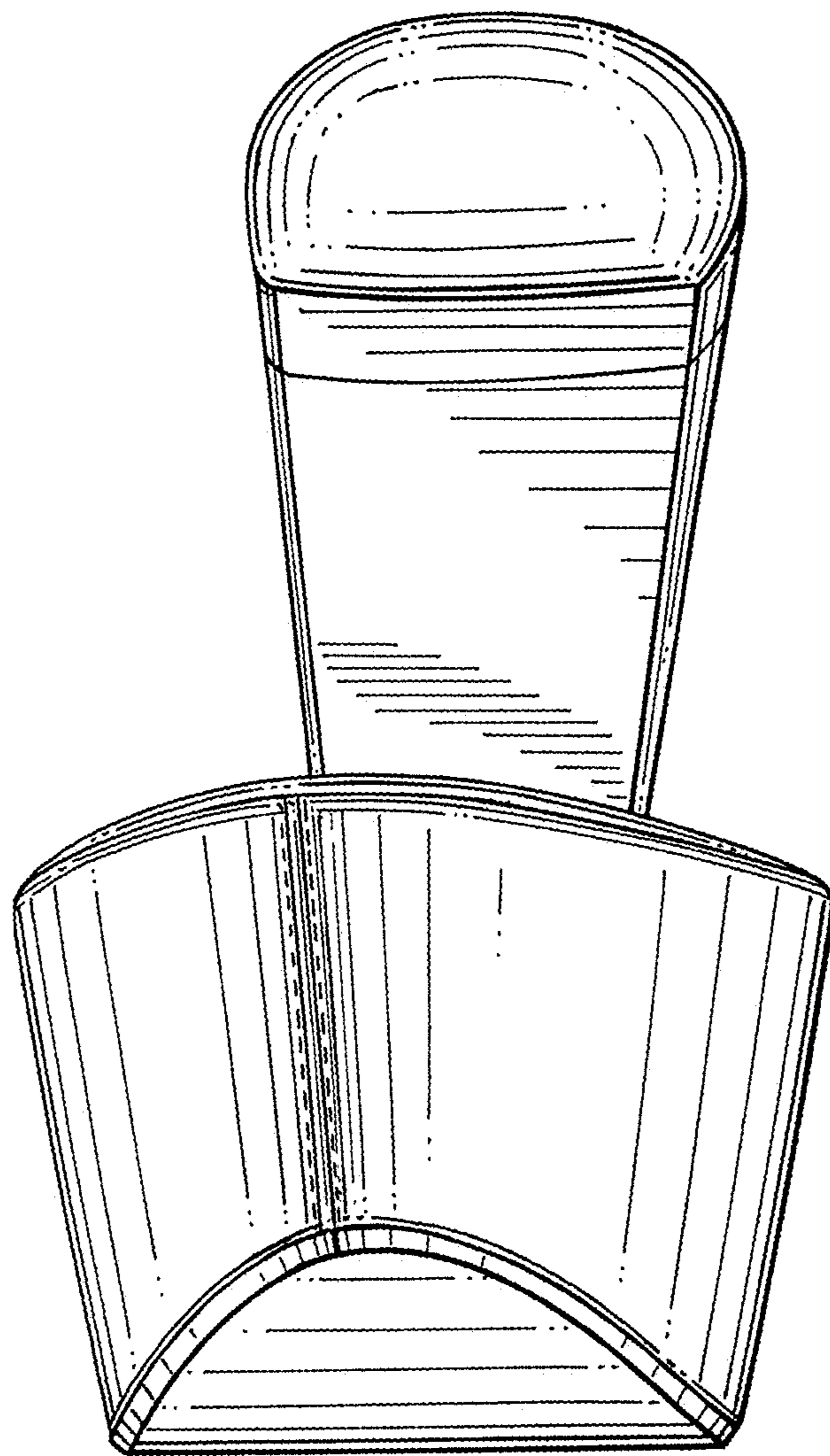
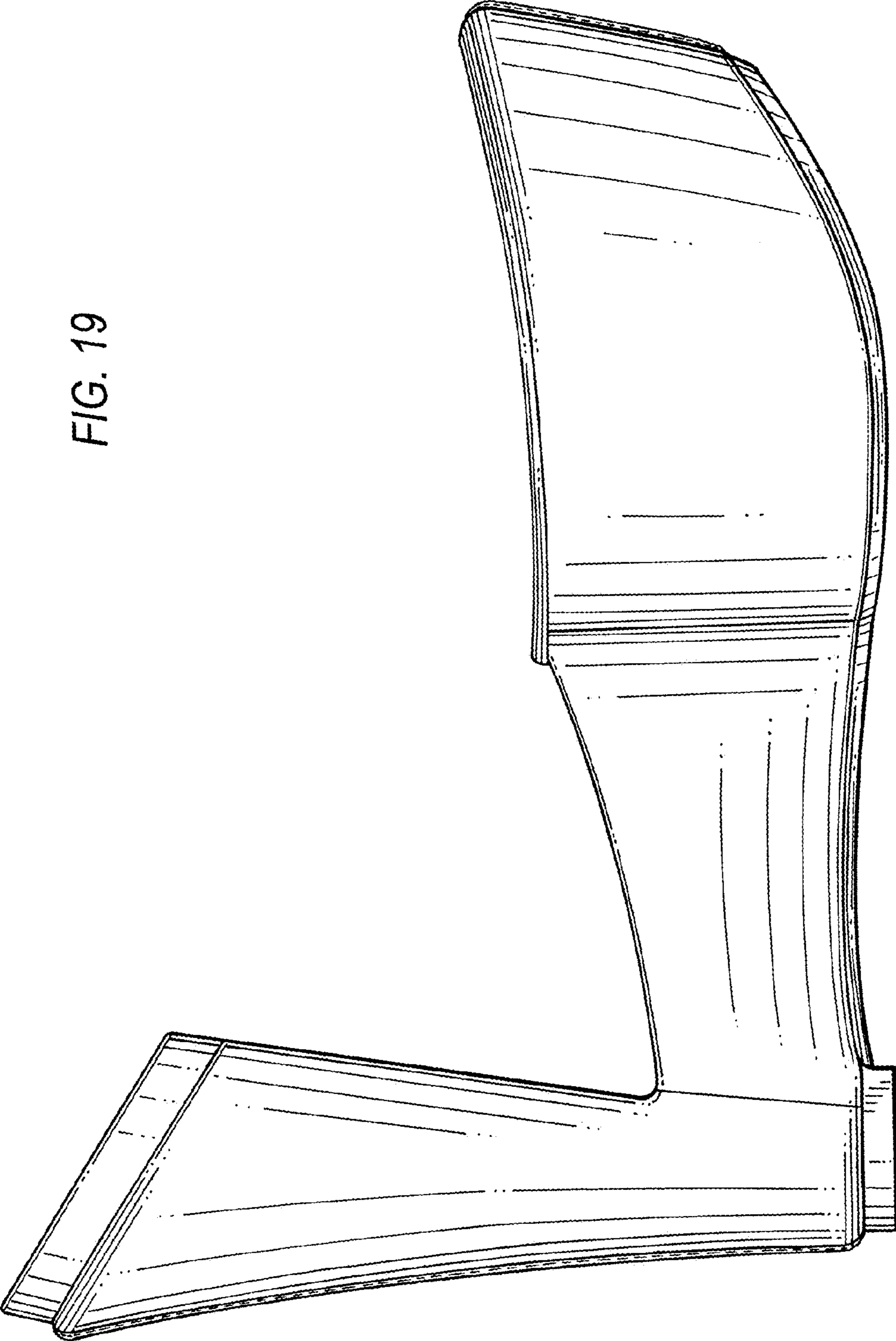

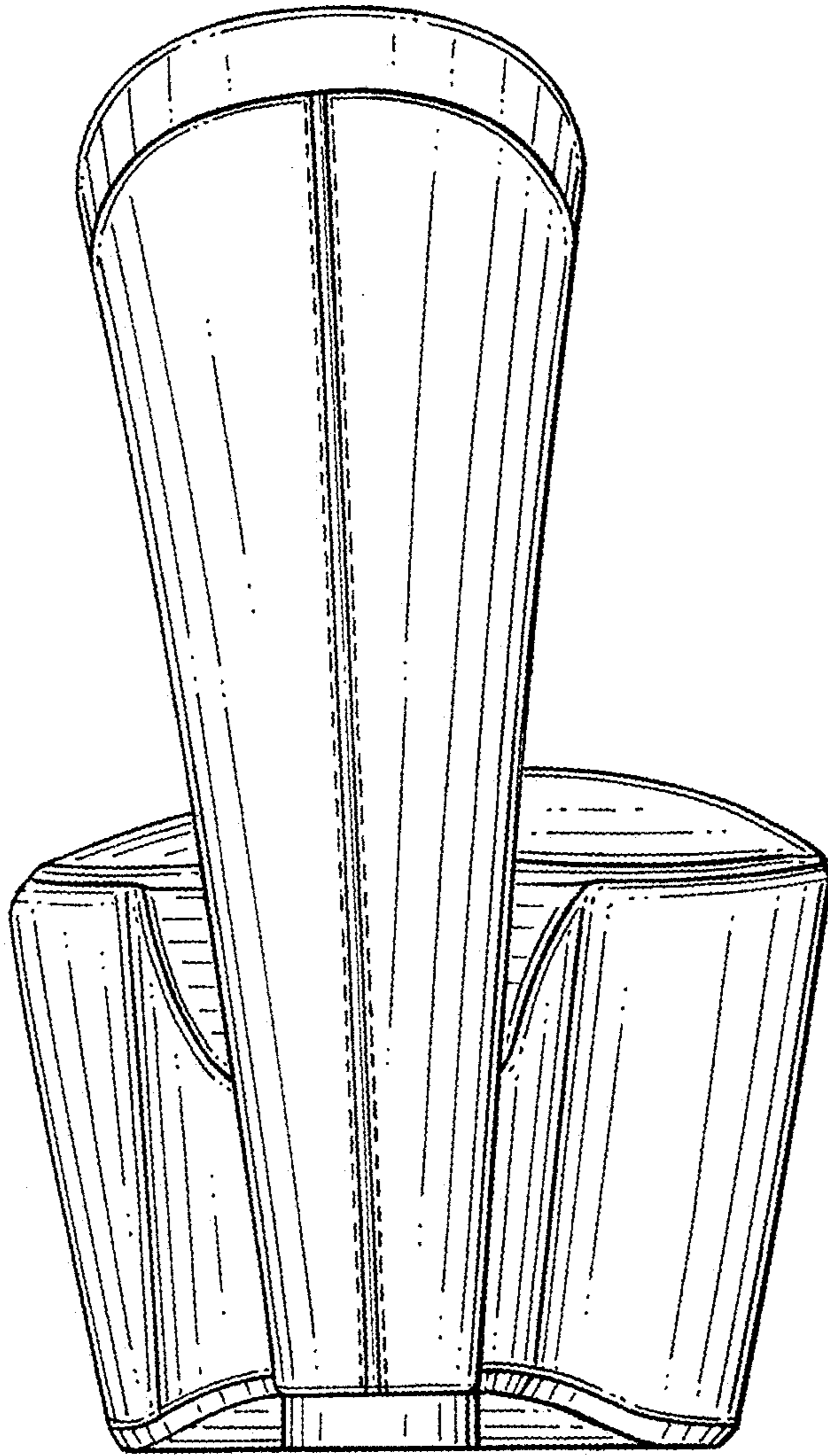

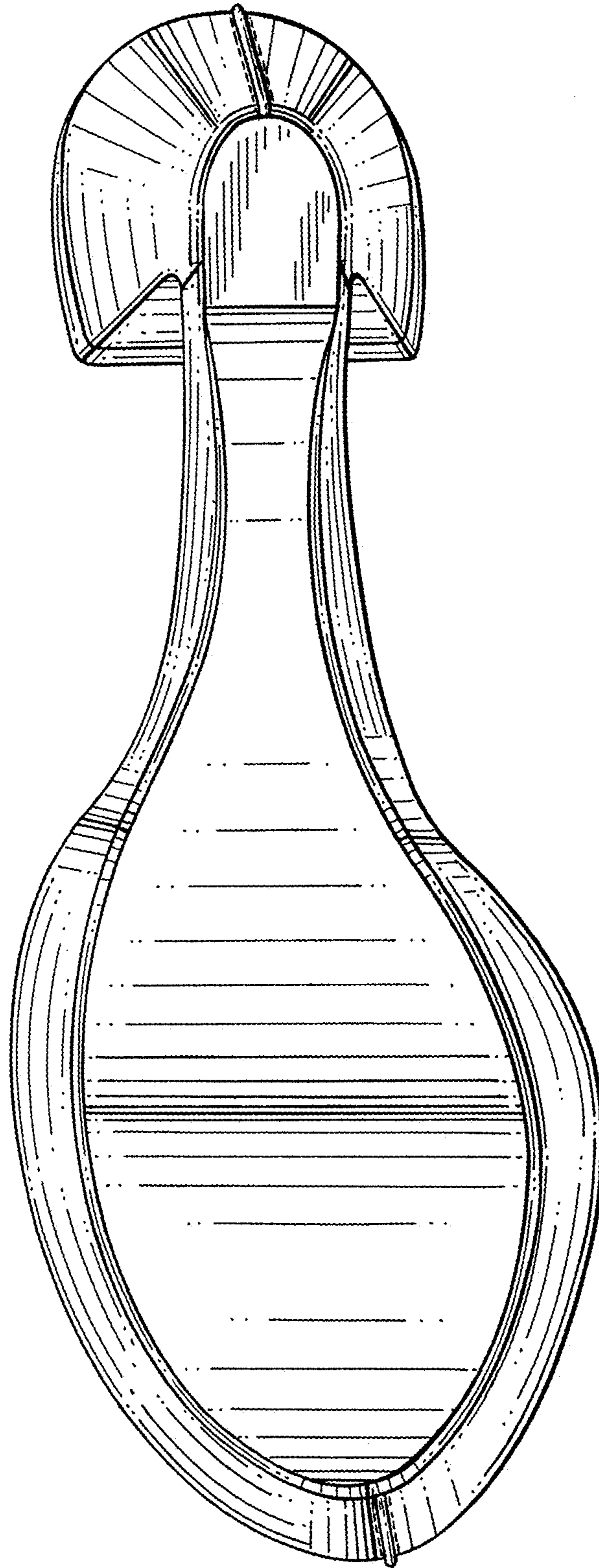
