(57) **CLAIM**

An ornamental design for a sole assembly for a split-sole shoe, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of an embodiment of our new design of a sole assembly for a split-sole shoe illustrated in conjunction with a disclaimed shoe;

FIG. 4 is a top view of the design of FIG. 1;

FIG. 5 is a bottom view of the design of FIG. 1;

FIG. 9 is a perspective view of another embodiment of our new design of a sole assembly for a split-sole shoe illustrated in conjunction with a disclaimed shoe, where the blue portions are indicated using the USPTO convention of horizontal lines for blue;

FIG. 11 is a second side view of the design of FIG. 9;

FIG. 12 is a top view of the design of FIG. 9;

FIG. 13 is a bottom view of the design of FIG. 9;

FIG. 14 is a front view of the design of FIG. 9;

FIG. 15 is a back view of the design of FIG. 9;

FIG. 16 is another perspective view of the design of FIG. 9, the perspective view illustrating this embodiment when the disclaimed shoe is placed in a folded configuration;

FIG. 17 is a perspective view of yet another embodiment of our new design of a sole assembly for a split-sole shoe illustrated in conjunction with a disclaimed shoe, where the blue portions are indicated using a checkered pattern to indicate any blue color within the range of Pantone PMS 3242-3278, PMS 2904-2995, and 7453C-7472C, specifically including Pantone 7466C;

FIG. 18 is a first side view of the design of FIG. 17;

FIG. 19 is a second side view of the design of FIG. 17;

FIG. 20 is a top view of the design of FIG. 17;

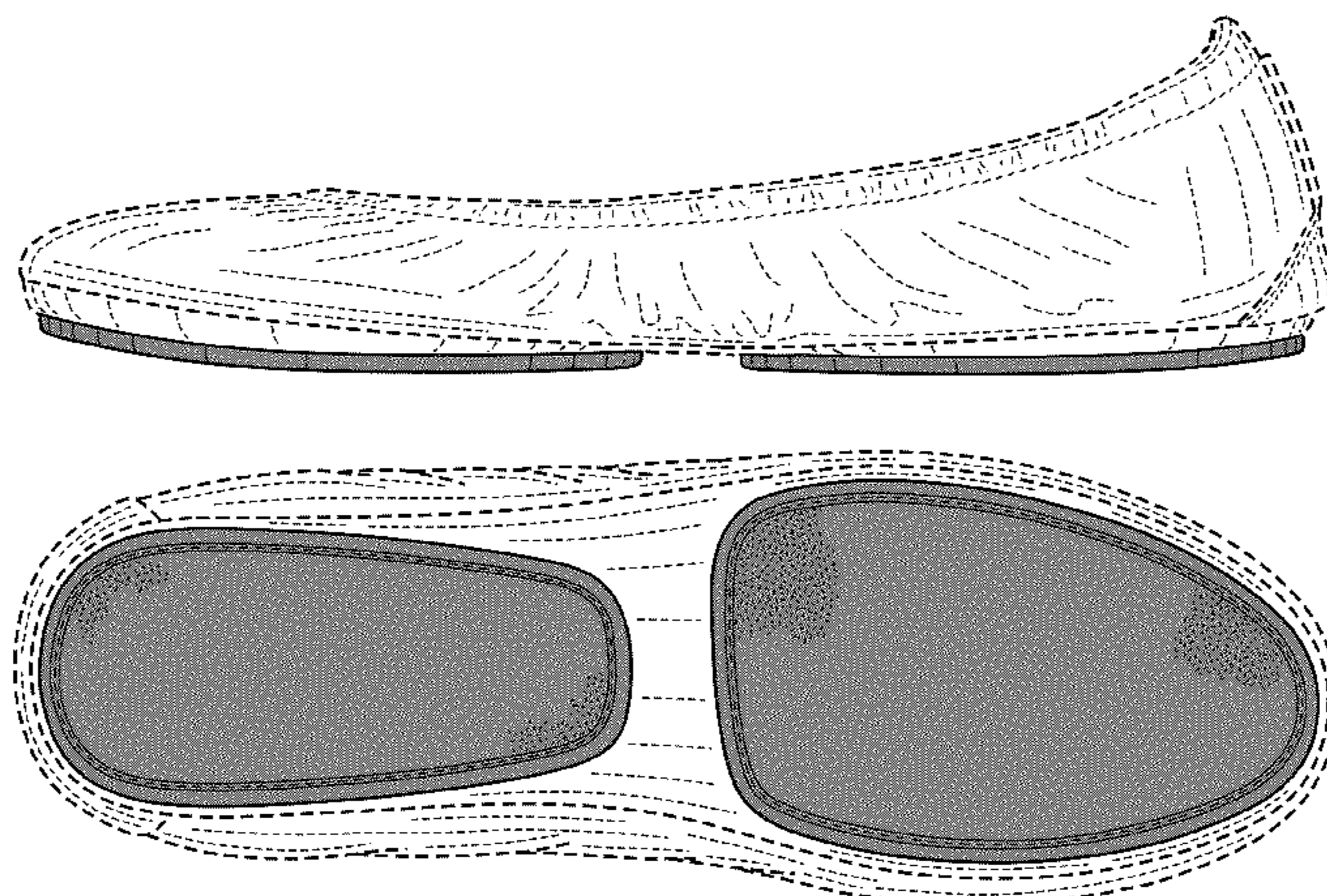
FIG. 21 is a bottom view of the design of FIG. 17; FIG. 22 is a front view of the design of FIG. 17;

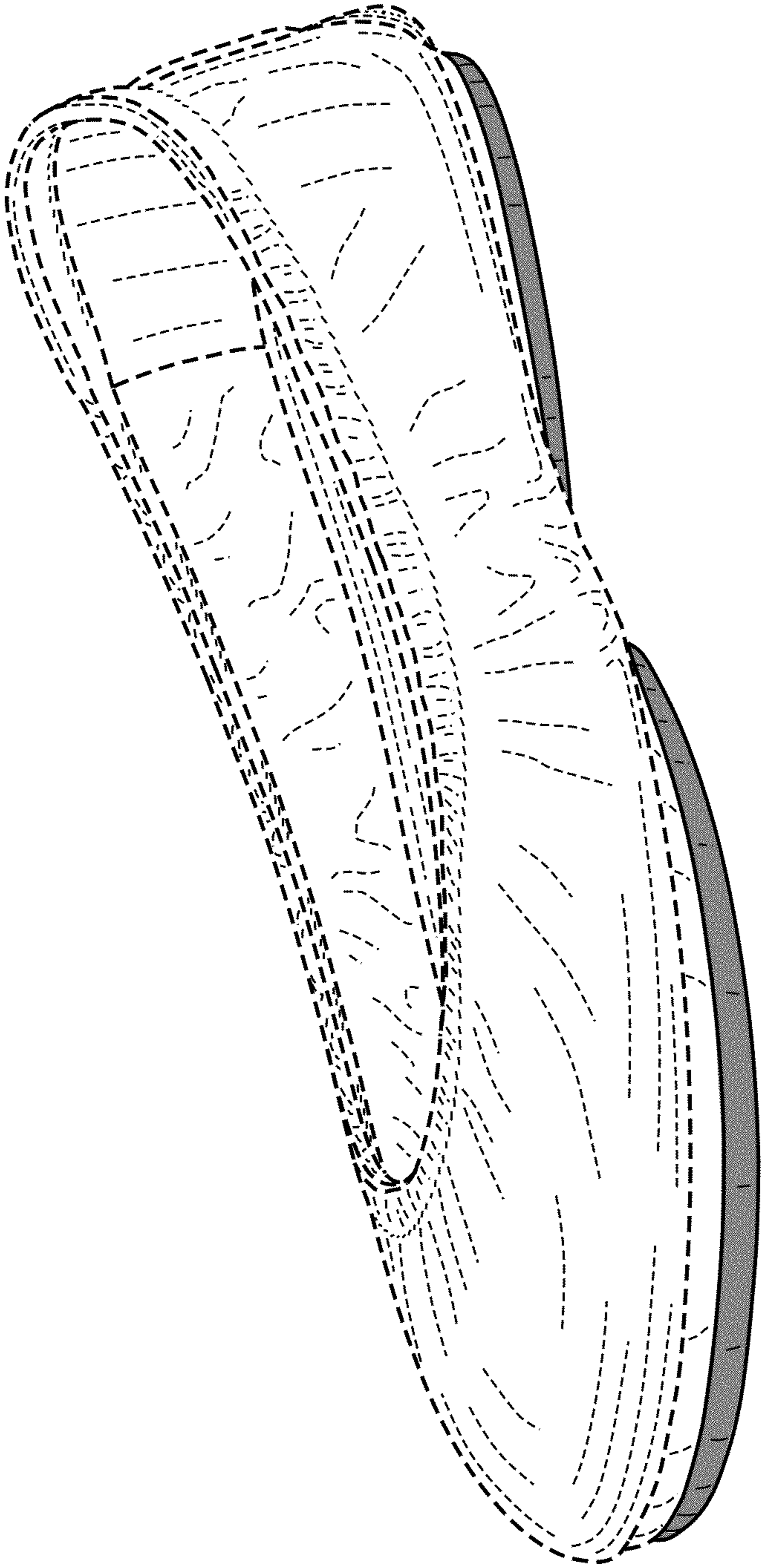

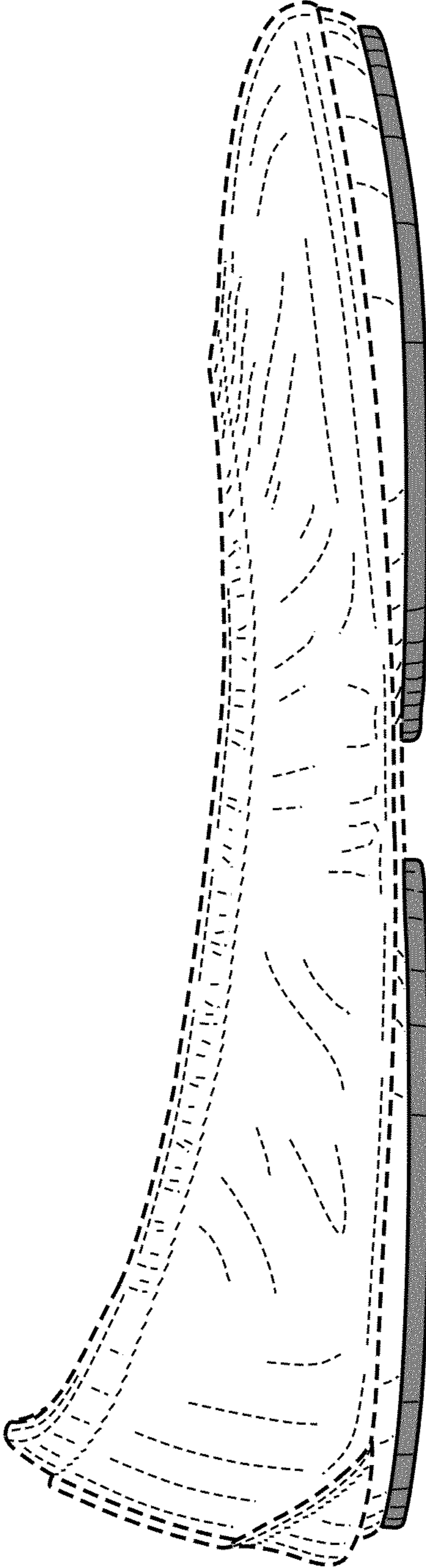

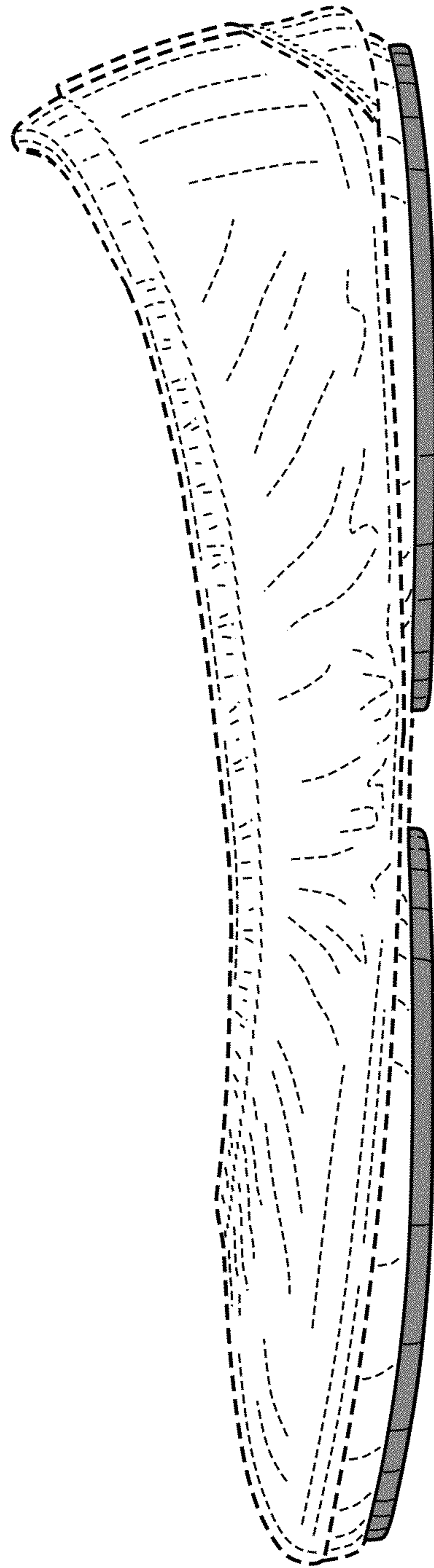

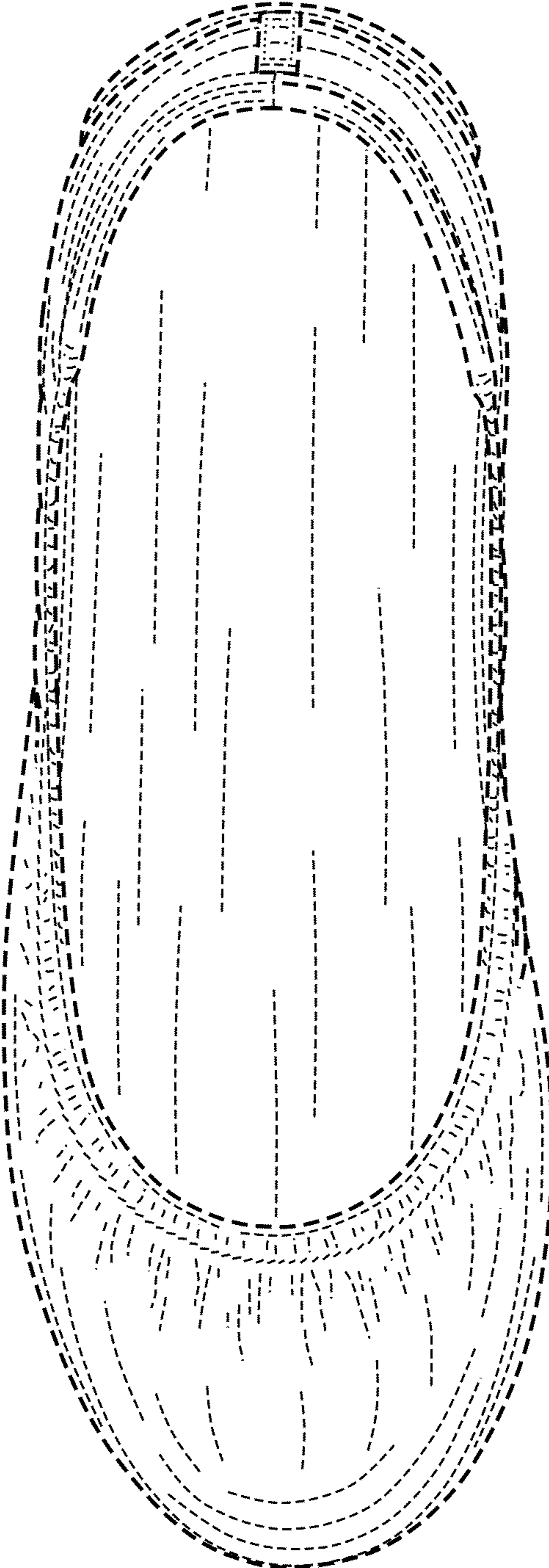

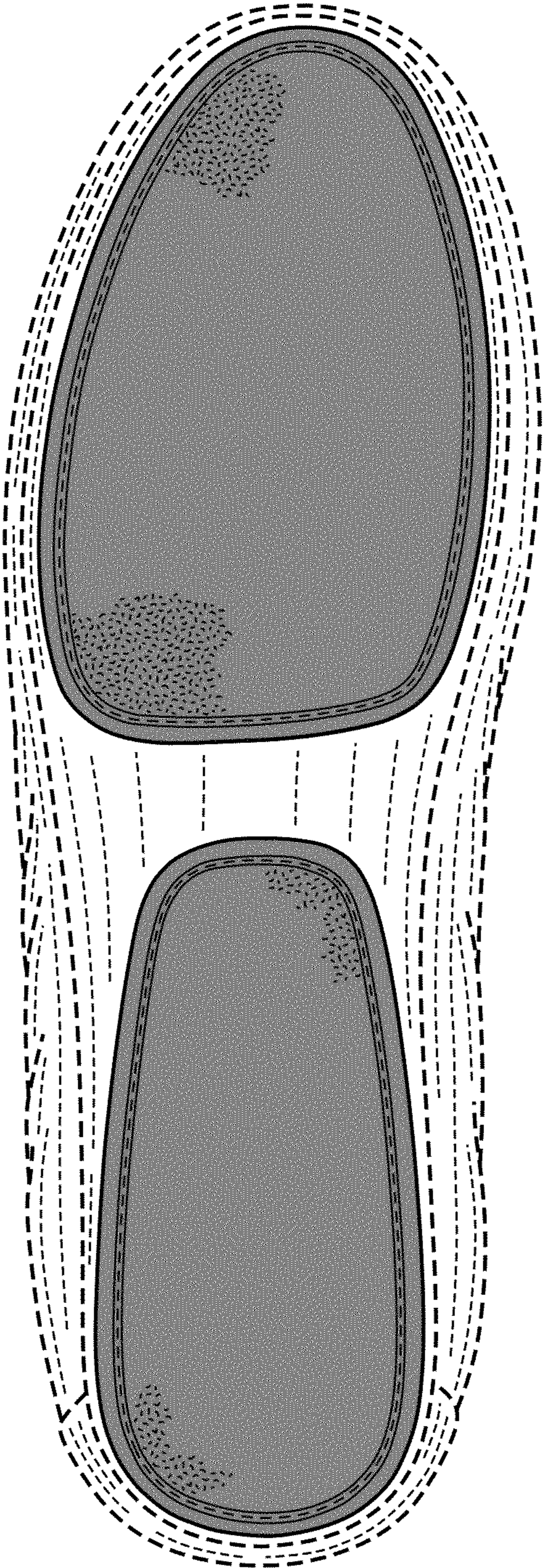

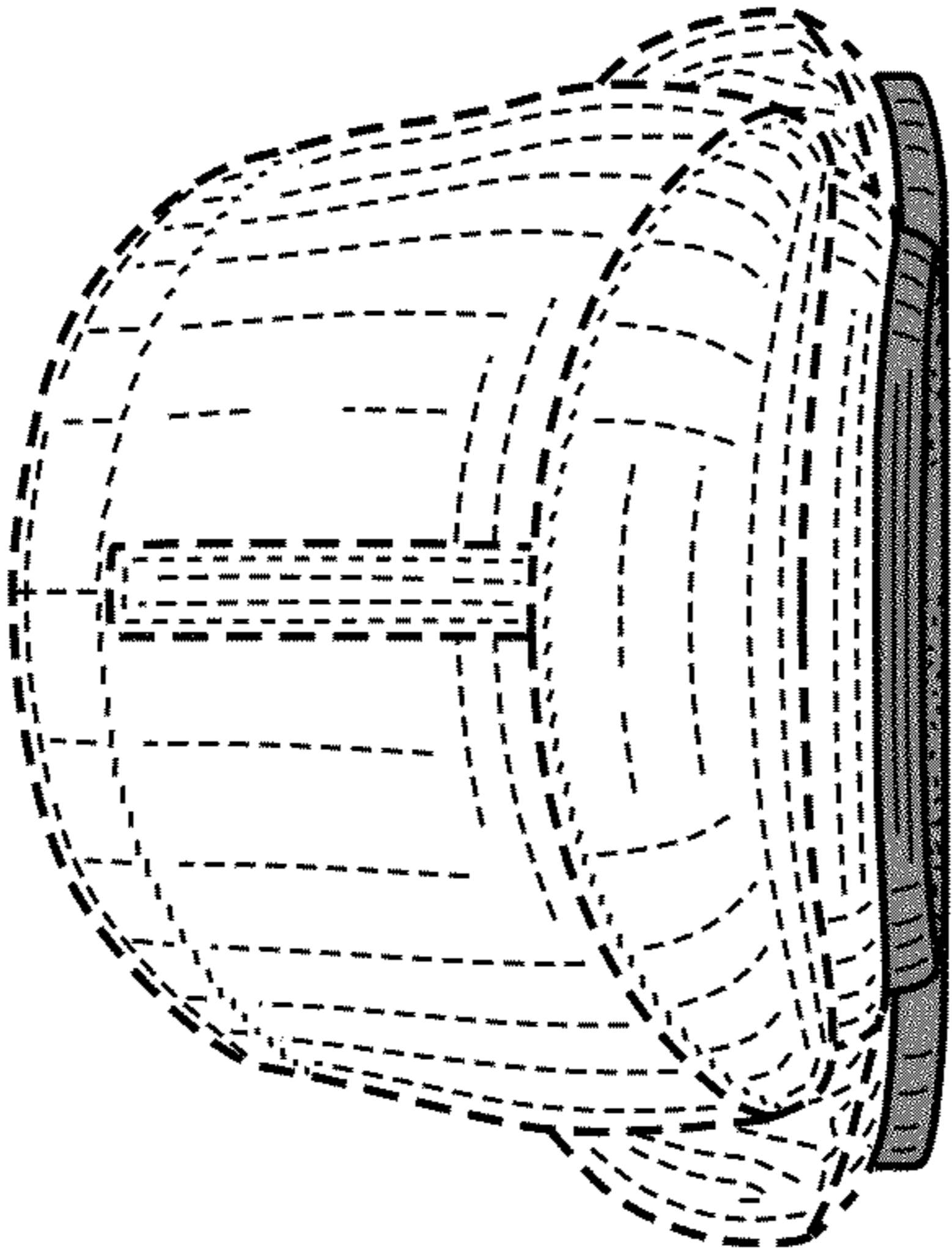

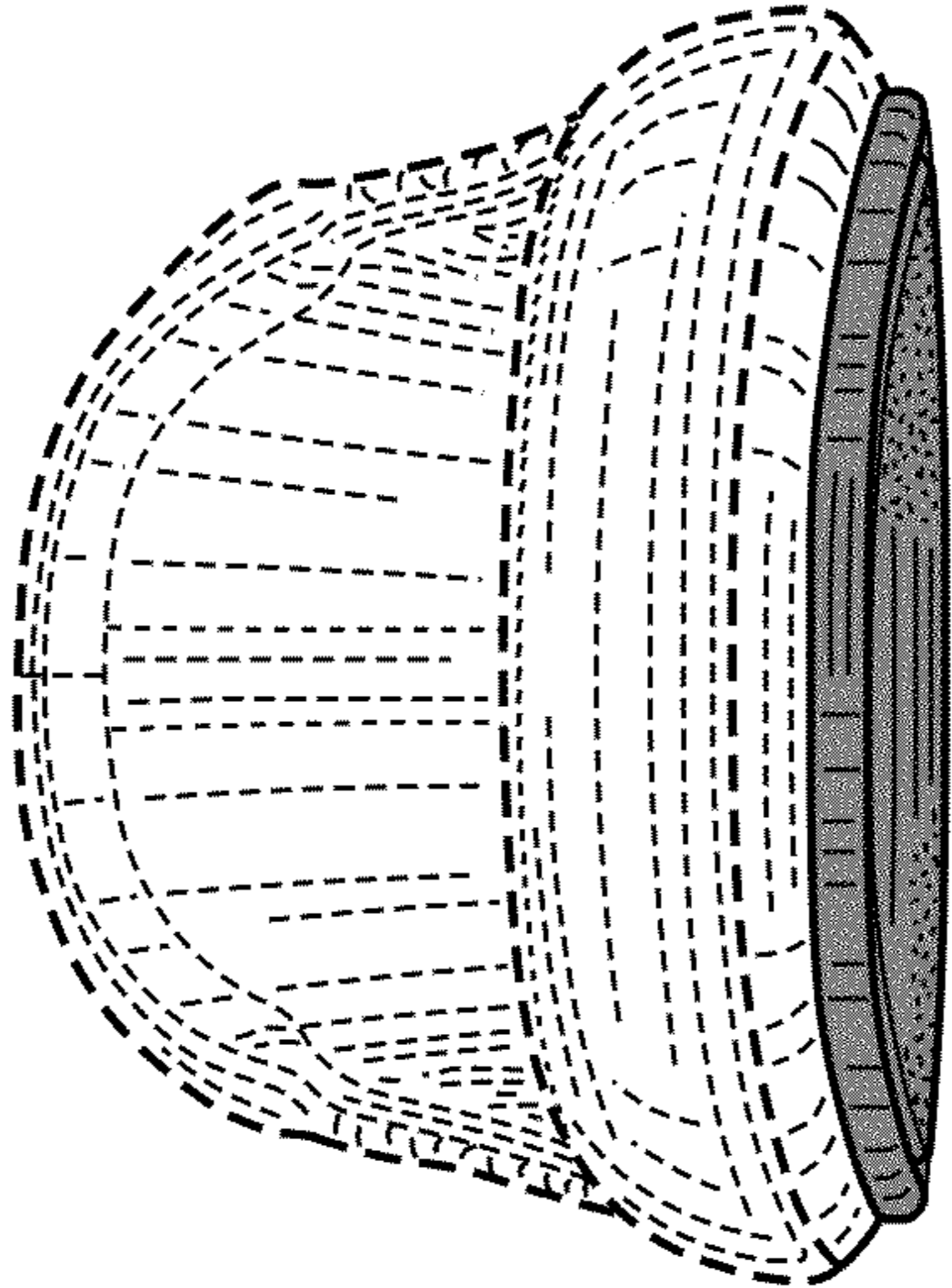

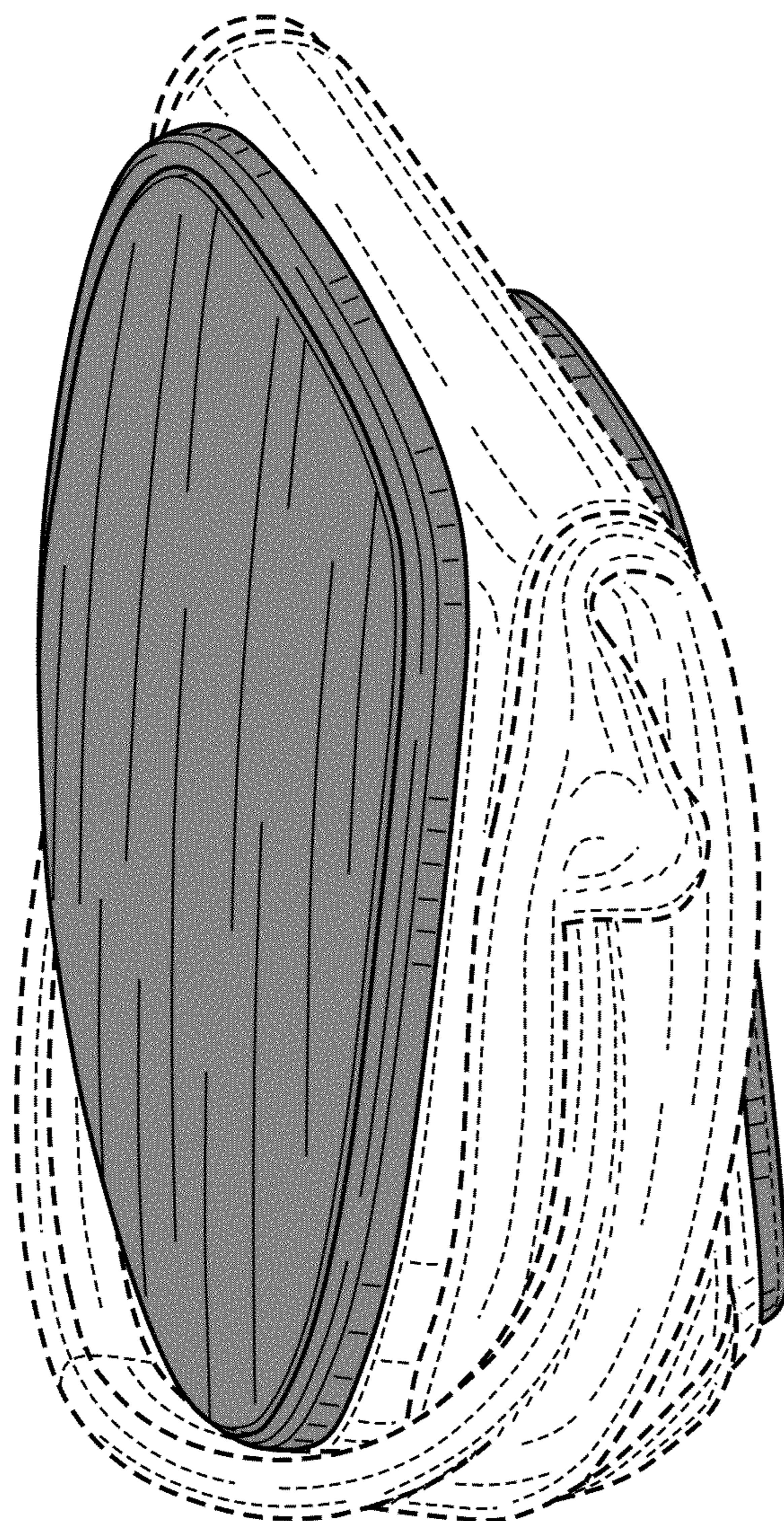

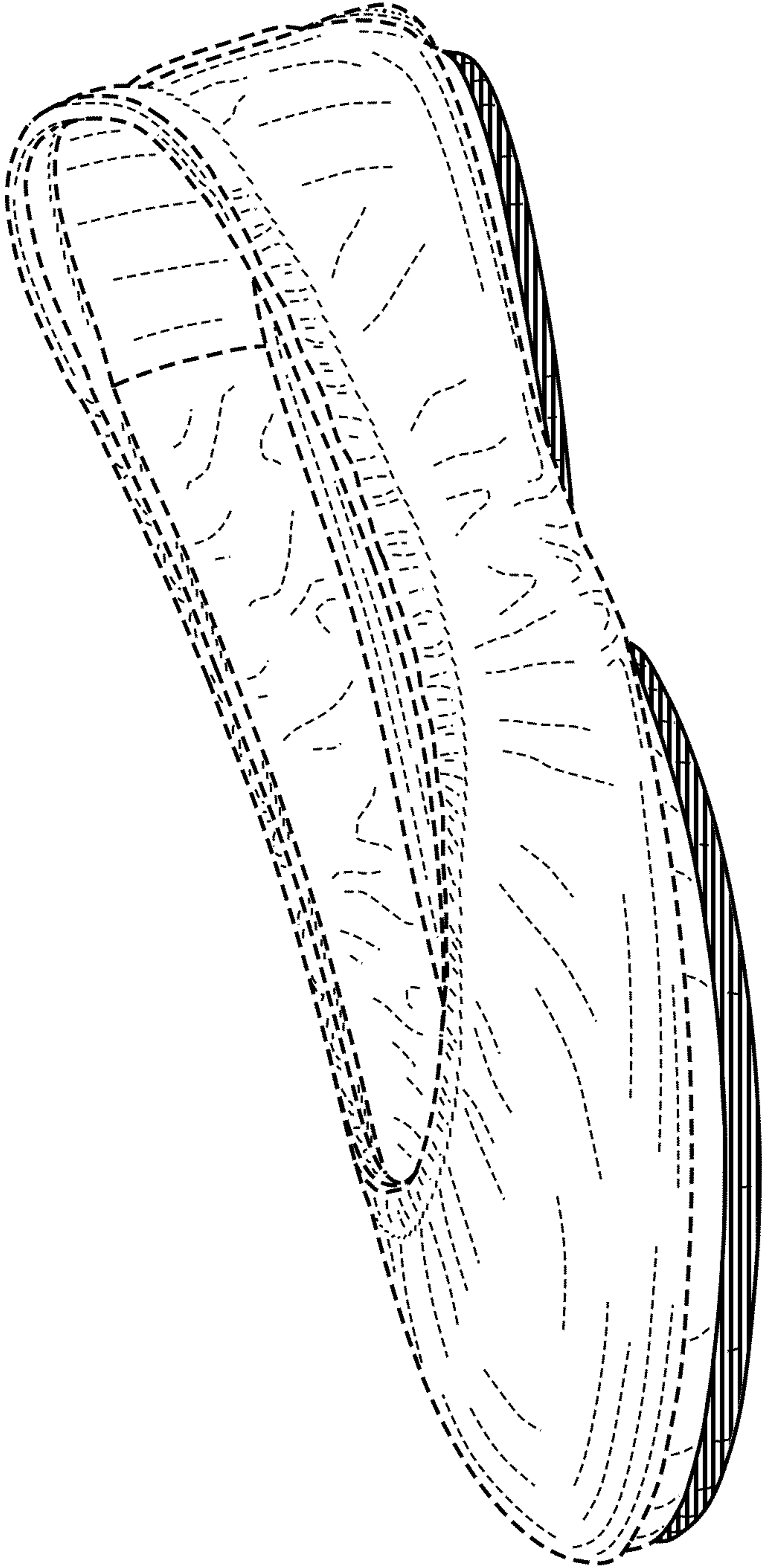

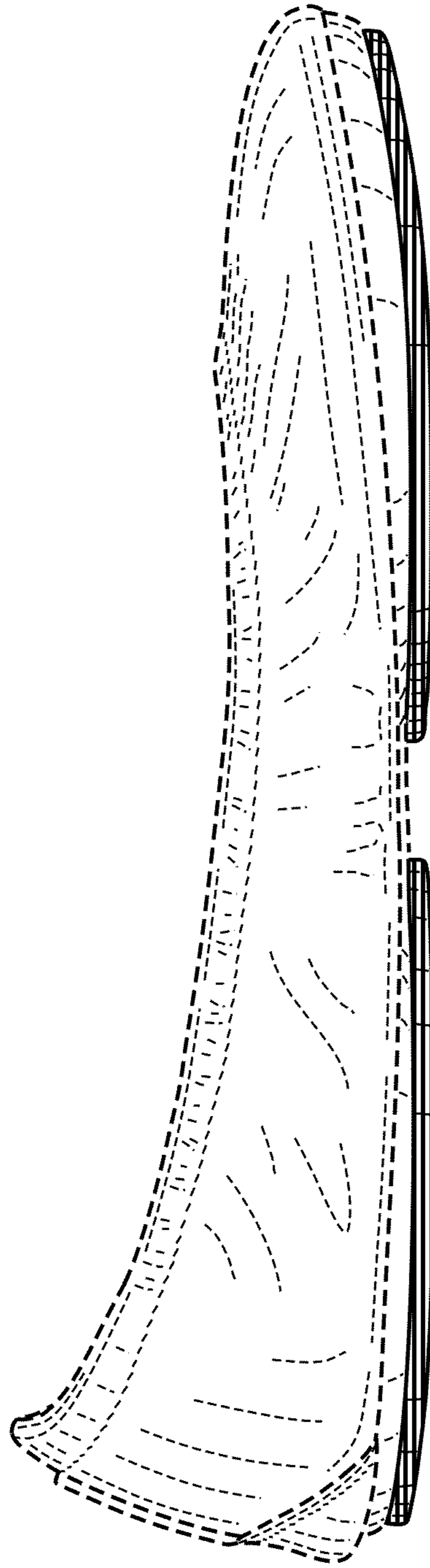

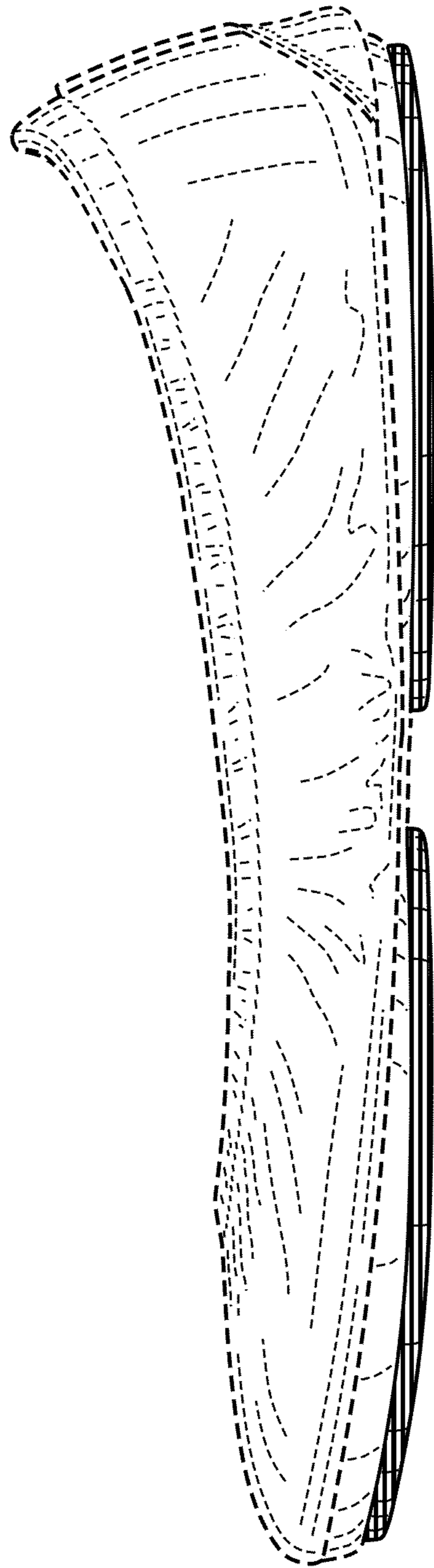

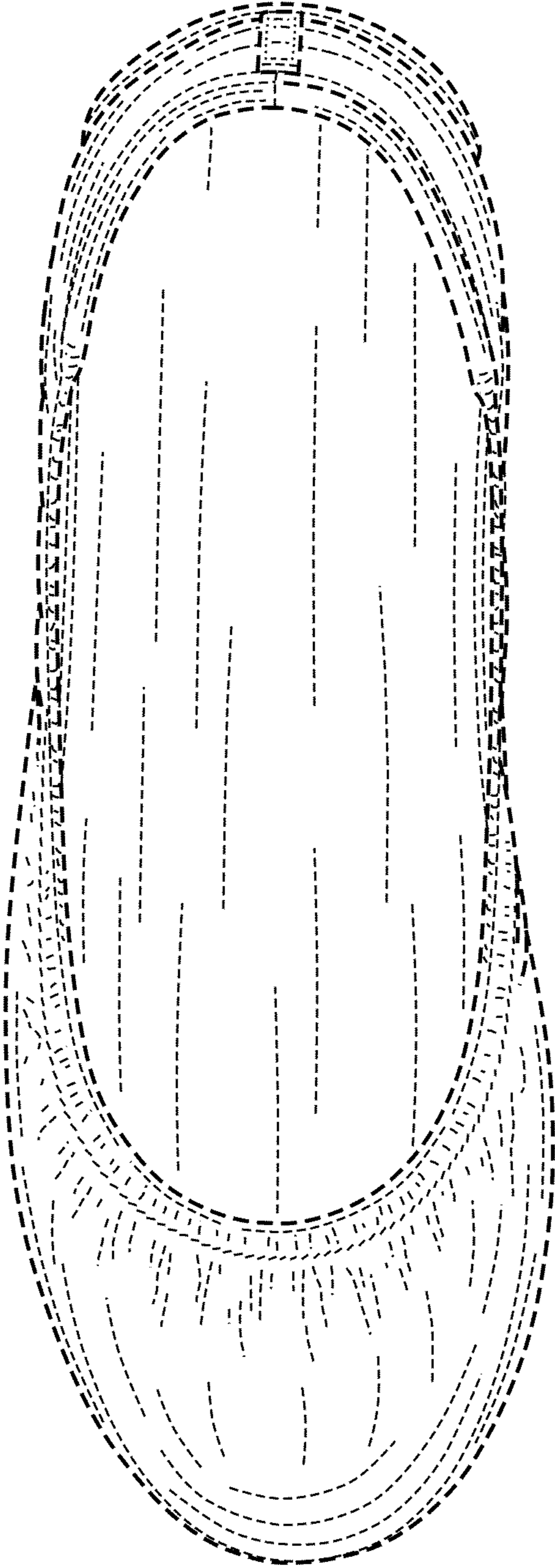

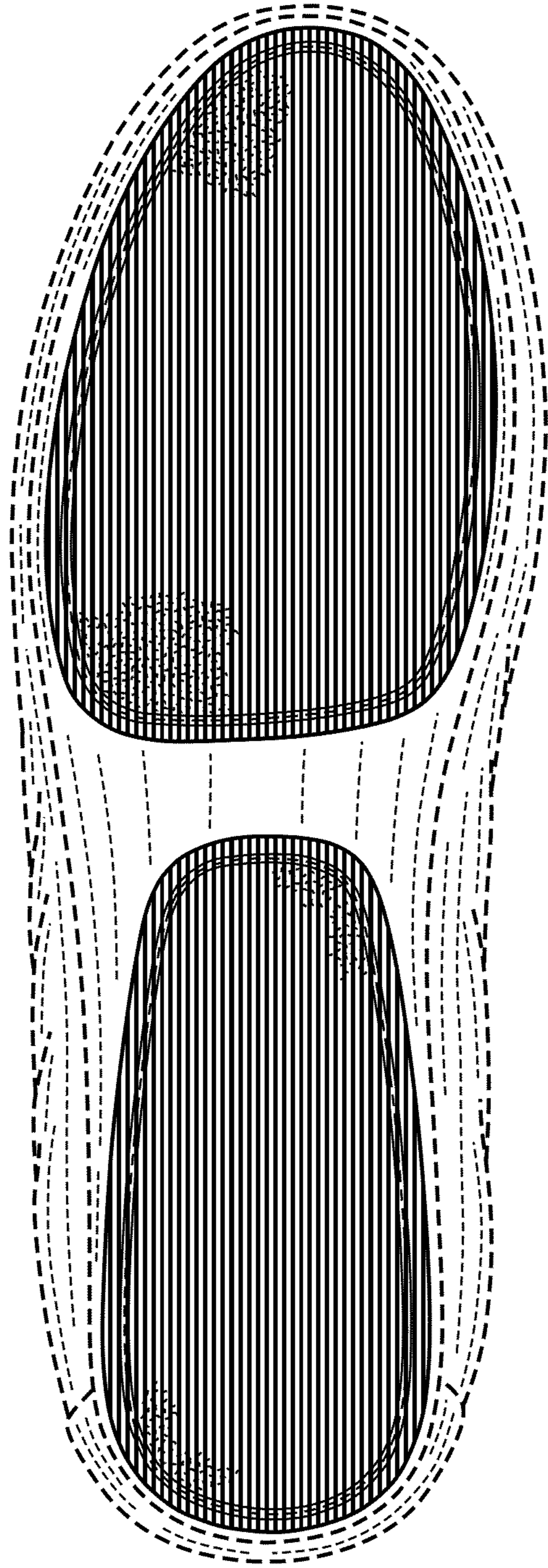

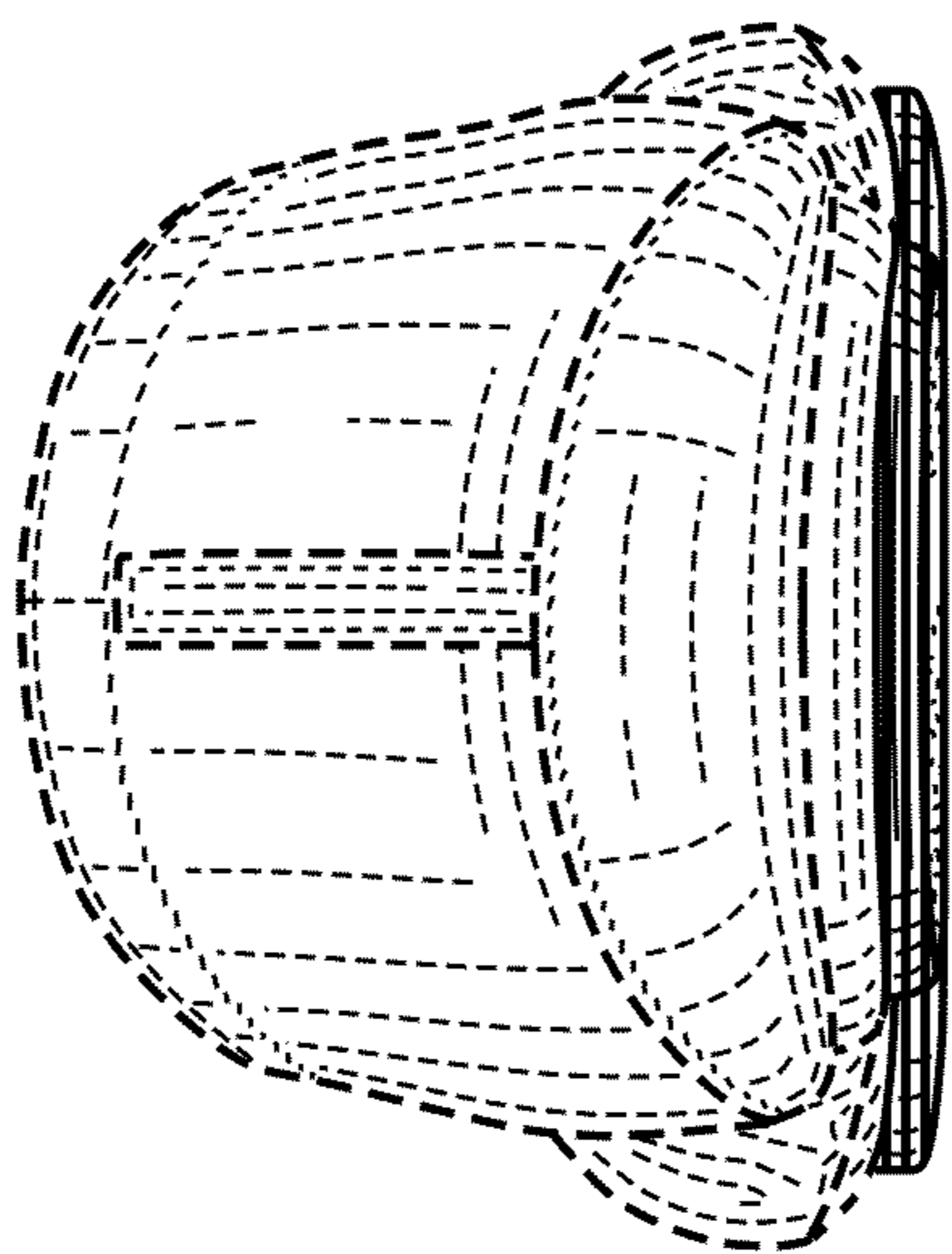

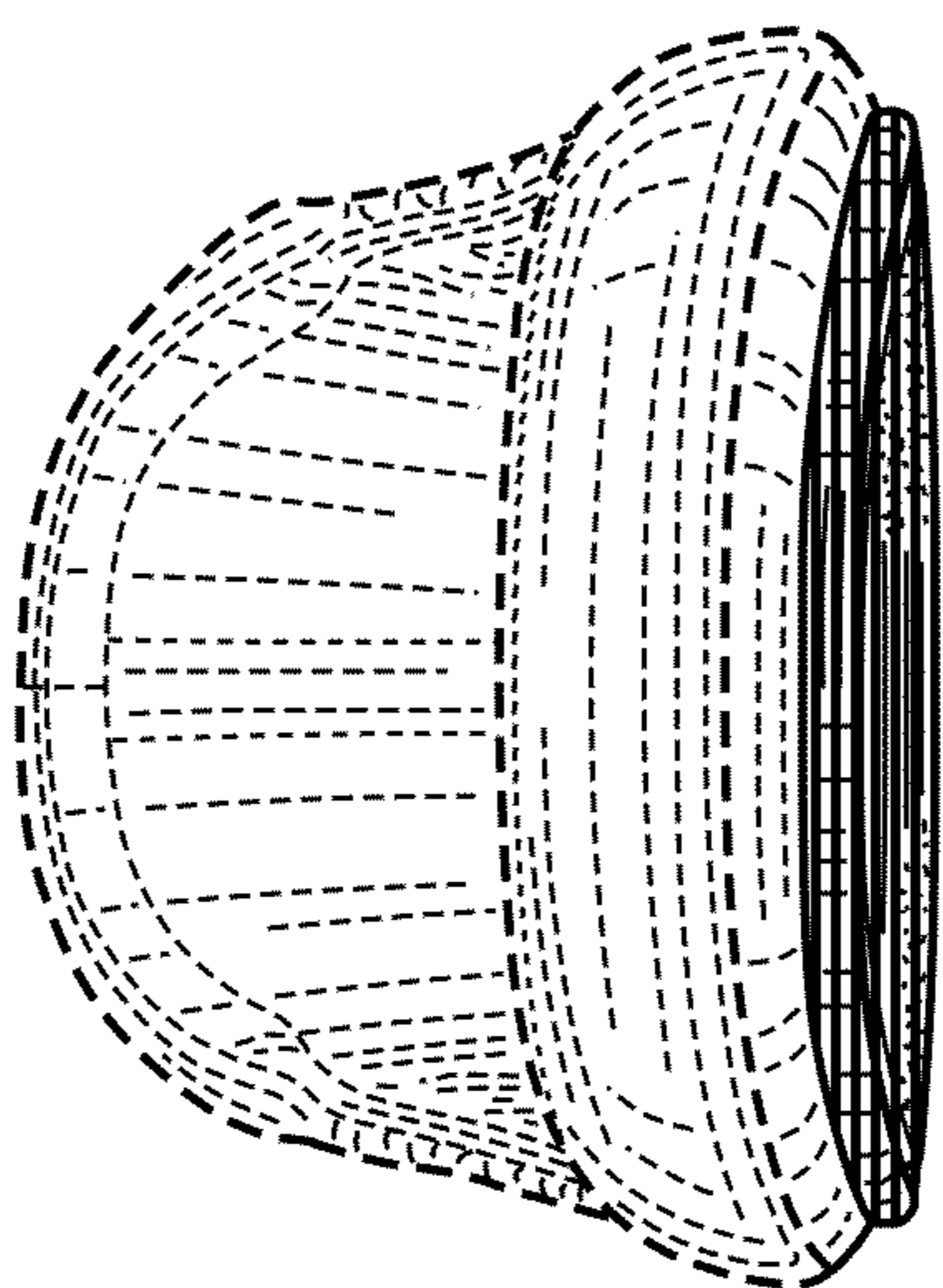

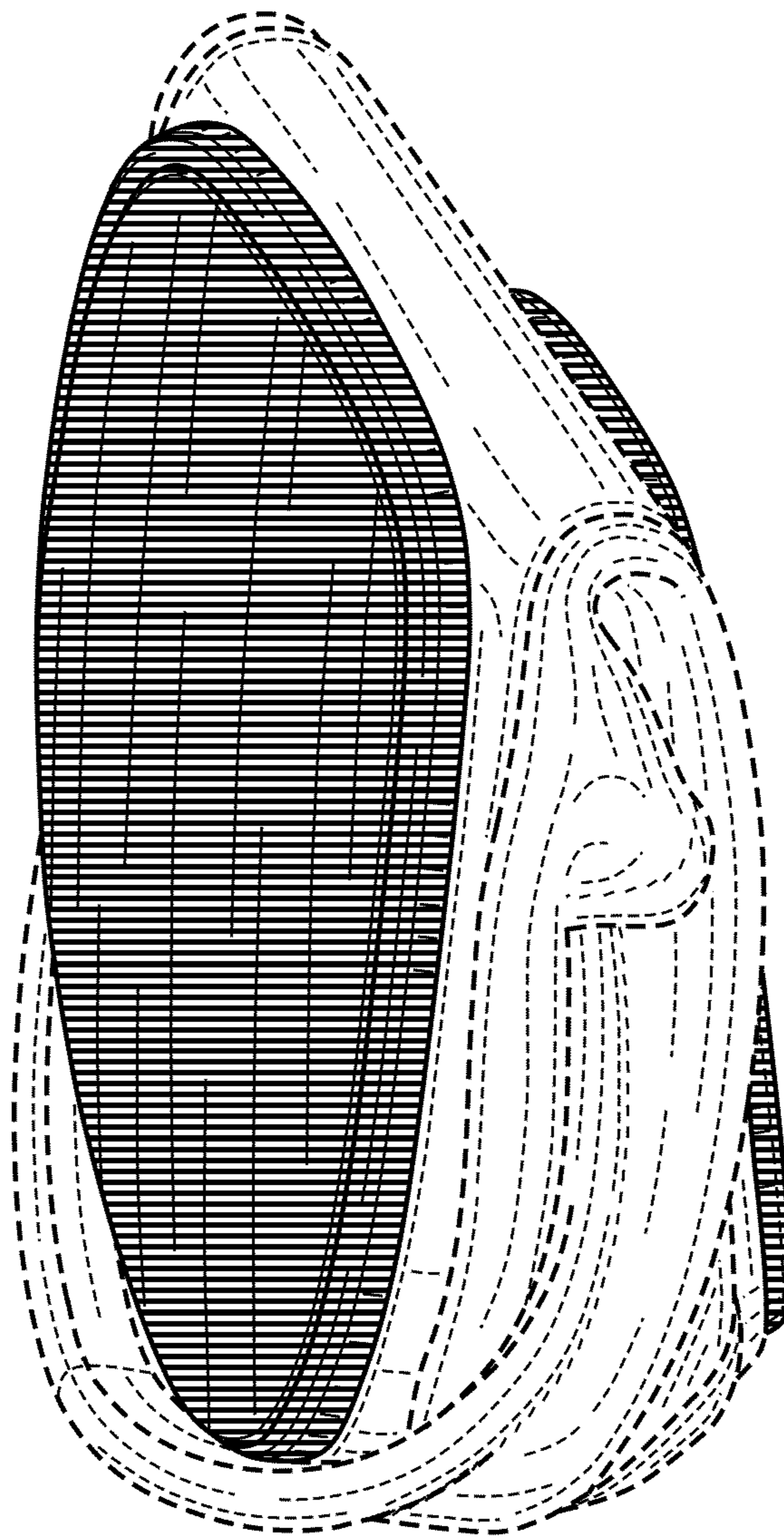

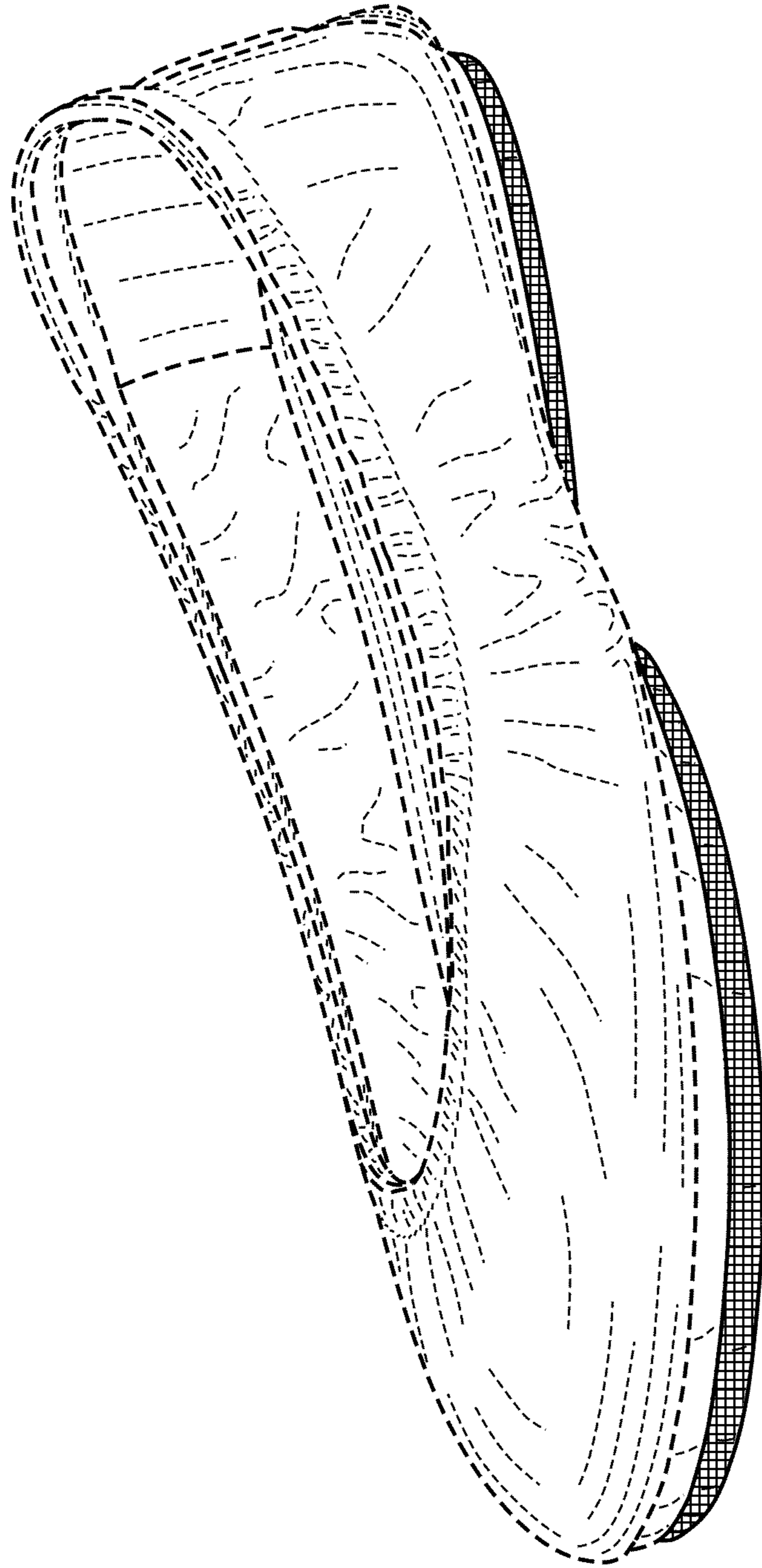

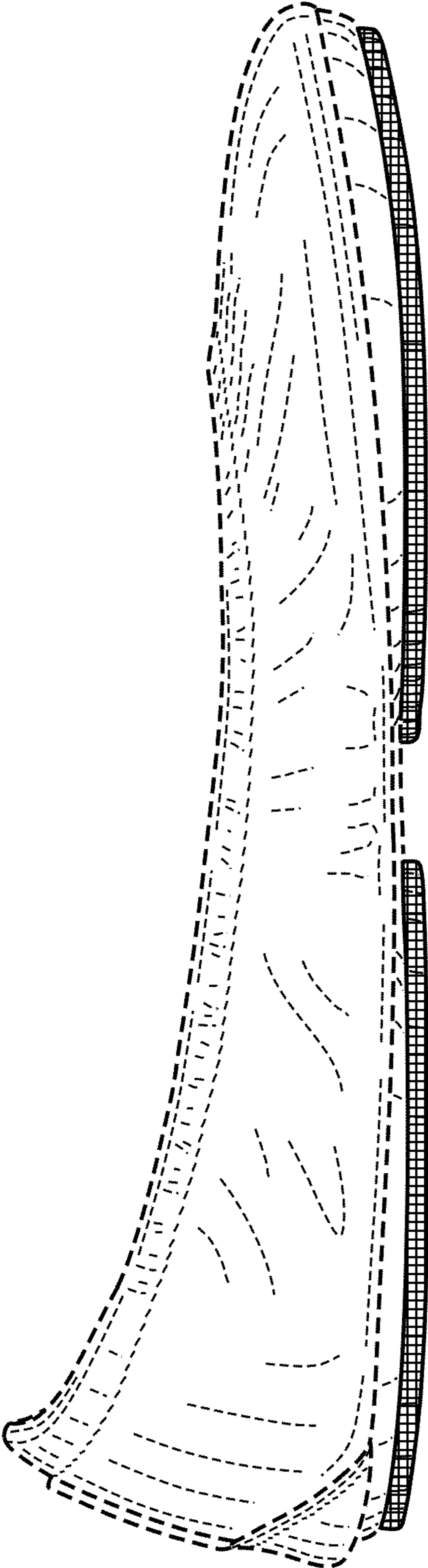

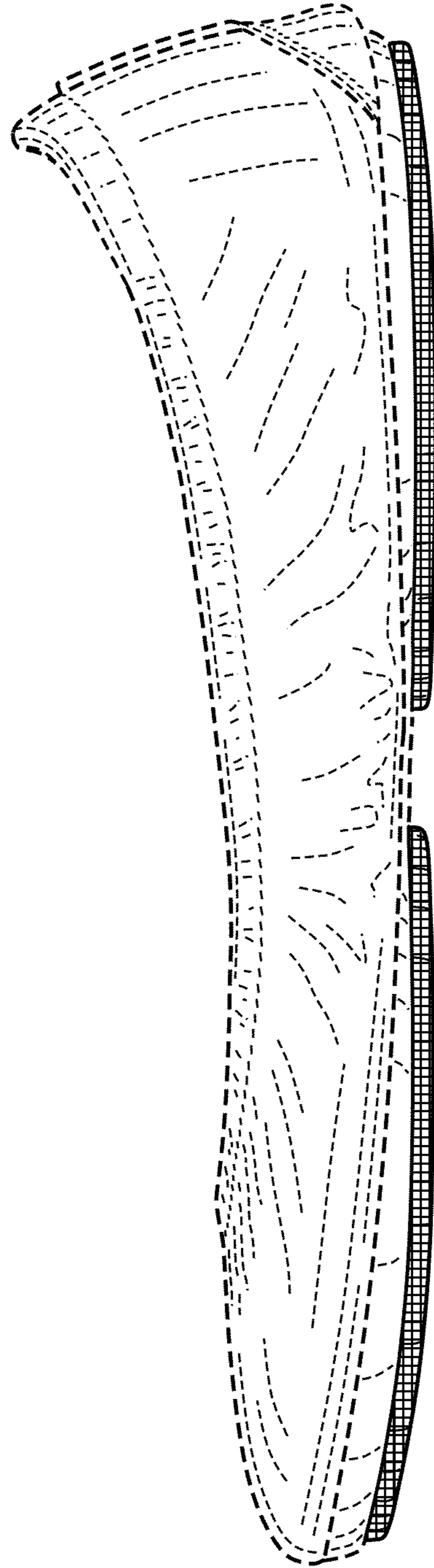

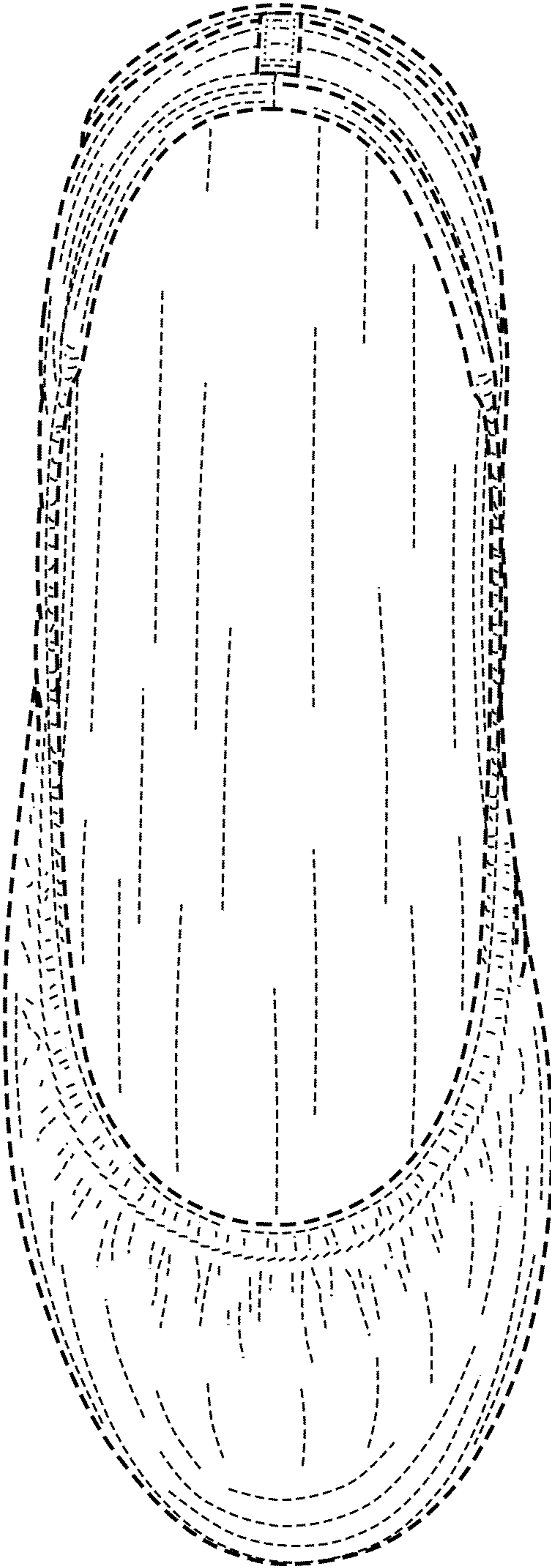

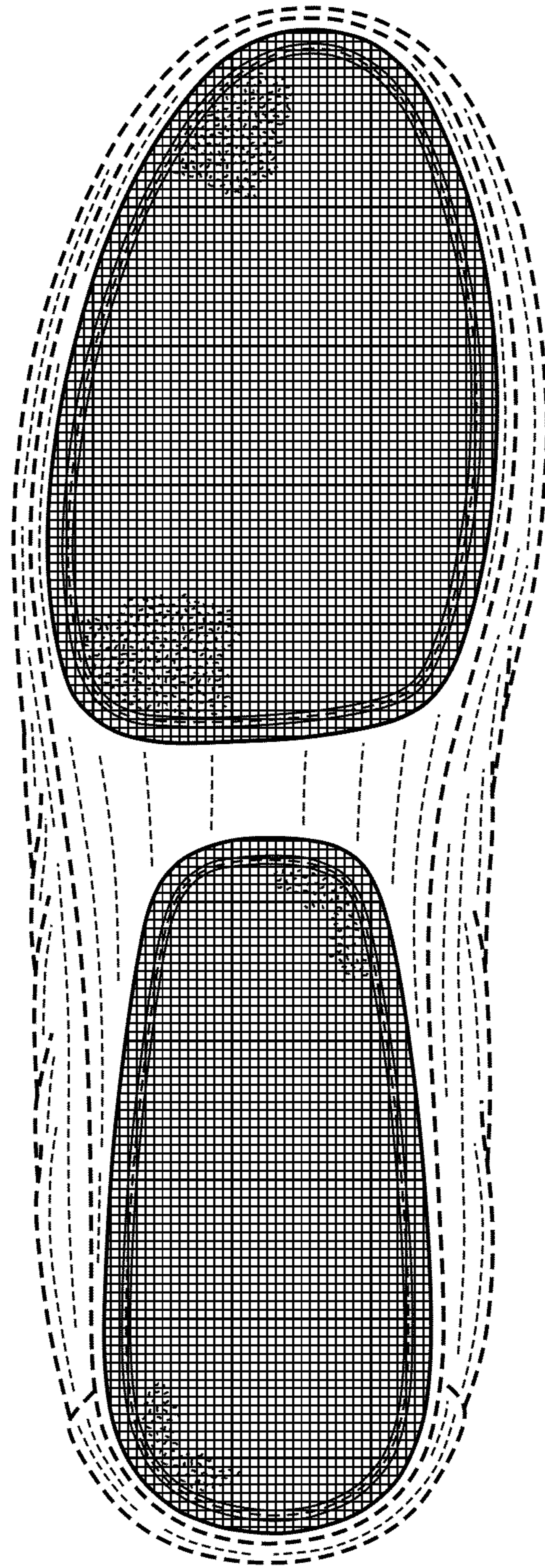

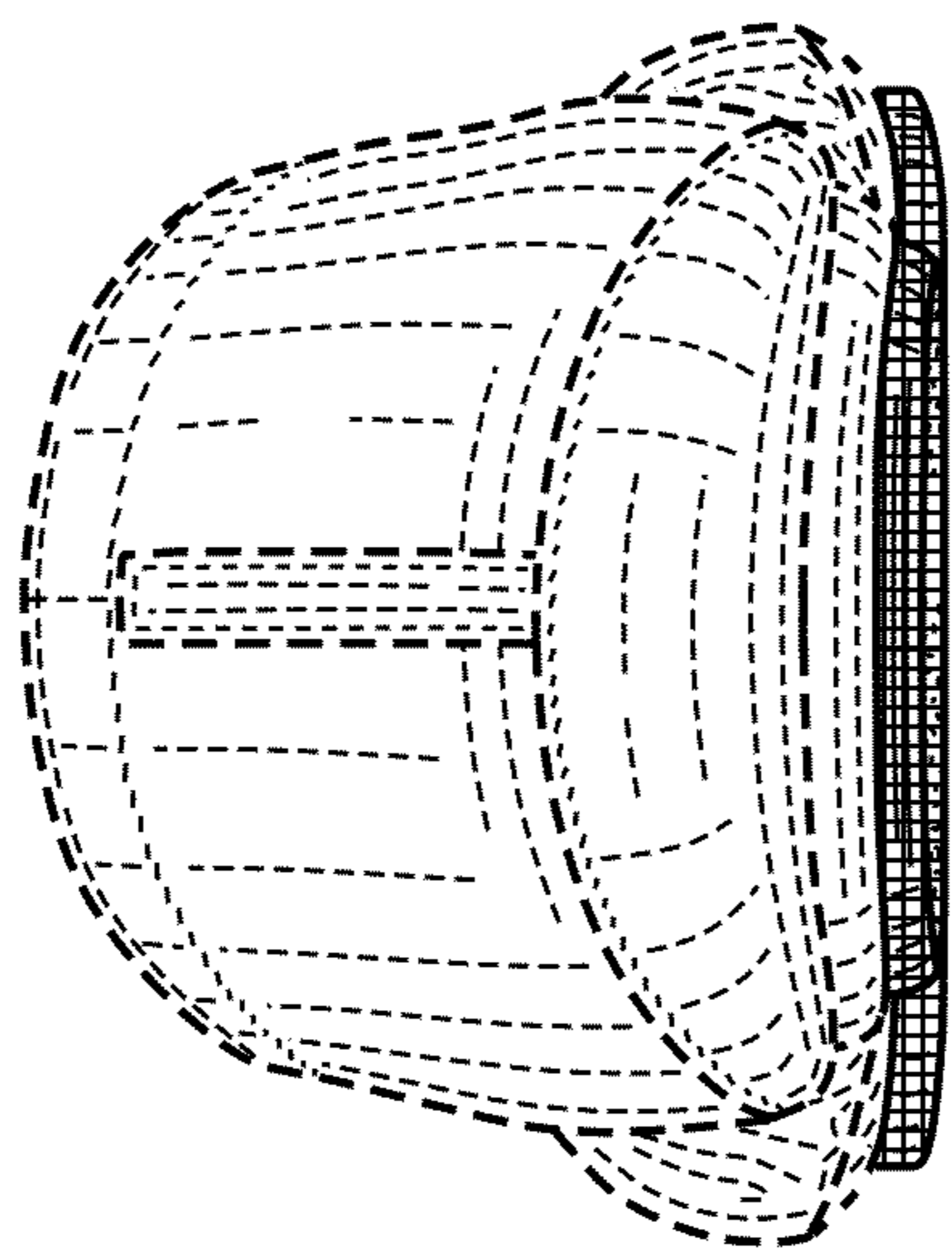

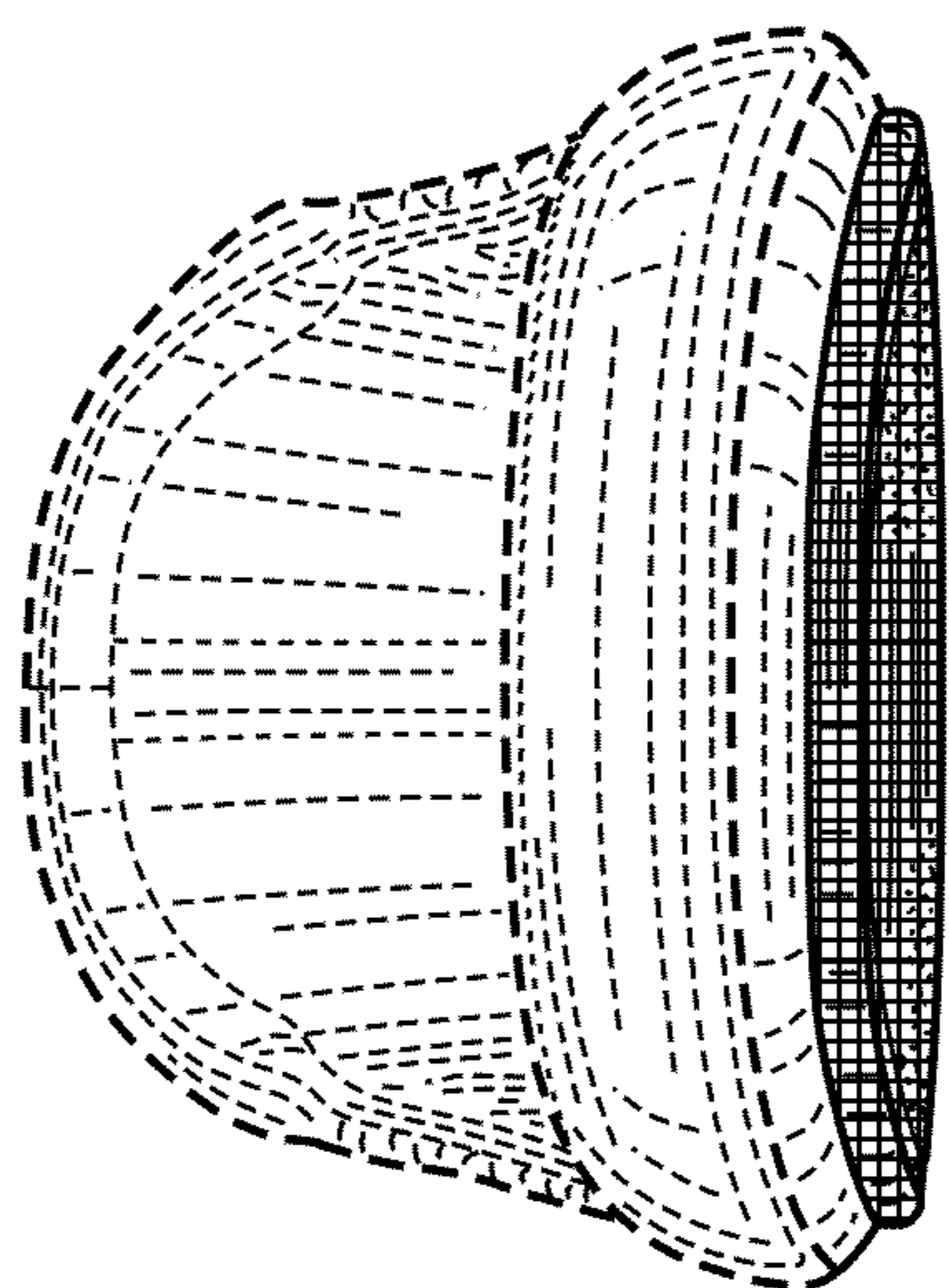

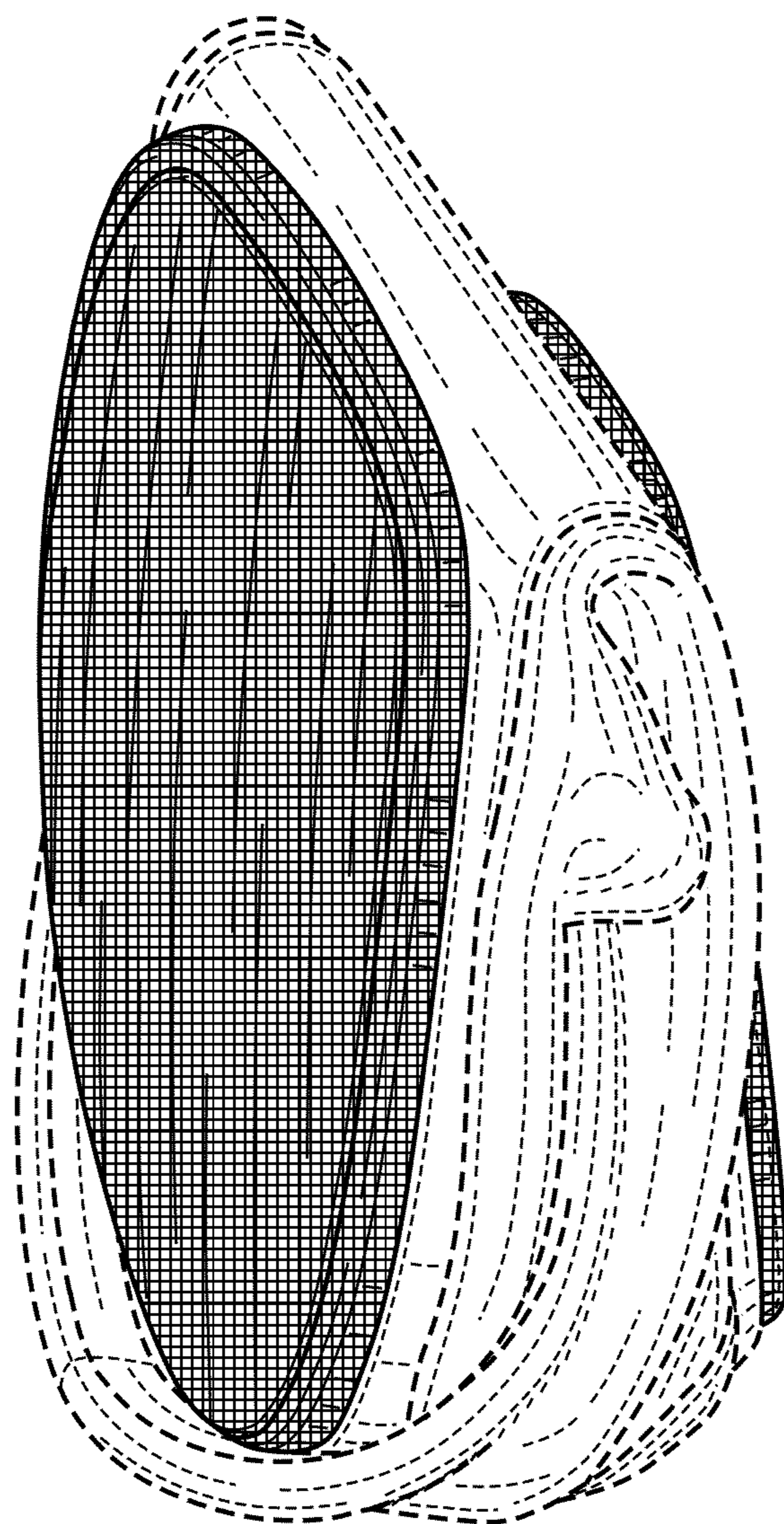
