The ornamental design for a boot upper, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a boot upper;
 FIG. 2 is a side, lateral view;
 FIG. 3 is a side medial view;
 FIG. 4 is a front view;
 FIG. 5 is a rear view; and,
 FIG. 6 is a top view.

The dashed lines in FIGS. 1-6 illustrate stitching and form a part of the claimed design.

The phantom lines in FIGS. 1-6 illustrate environment and form no part of the claimed design.

The phantom lines are on the outsole at the bottom of the boot upper.

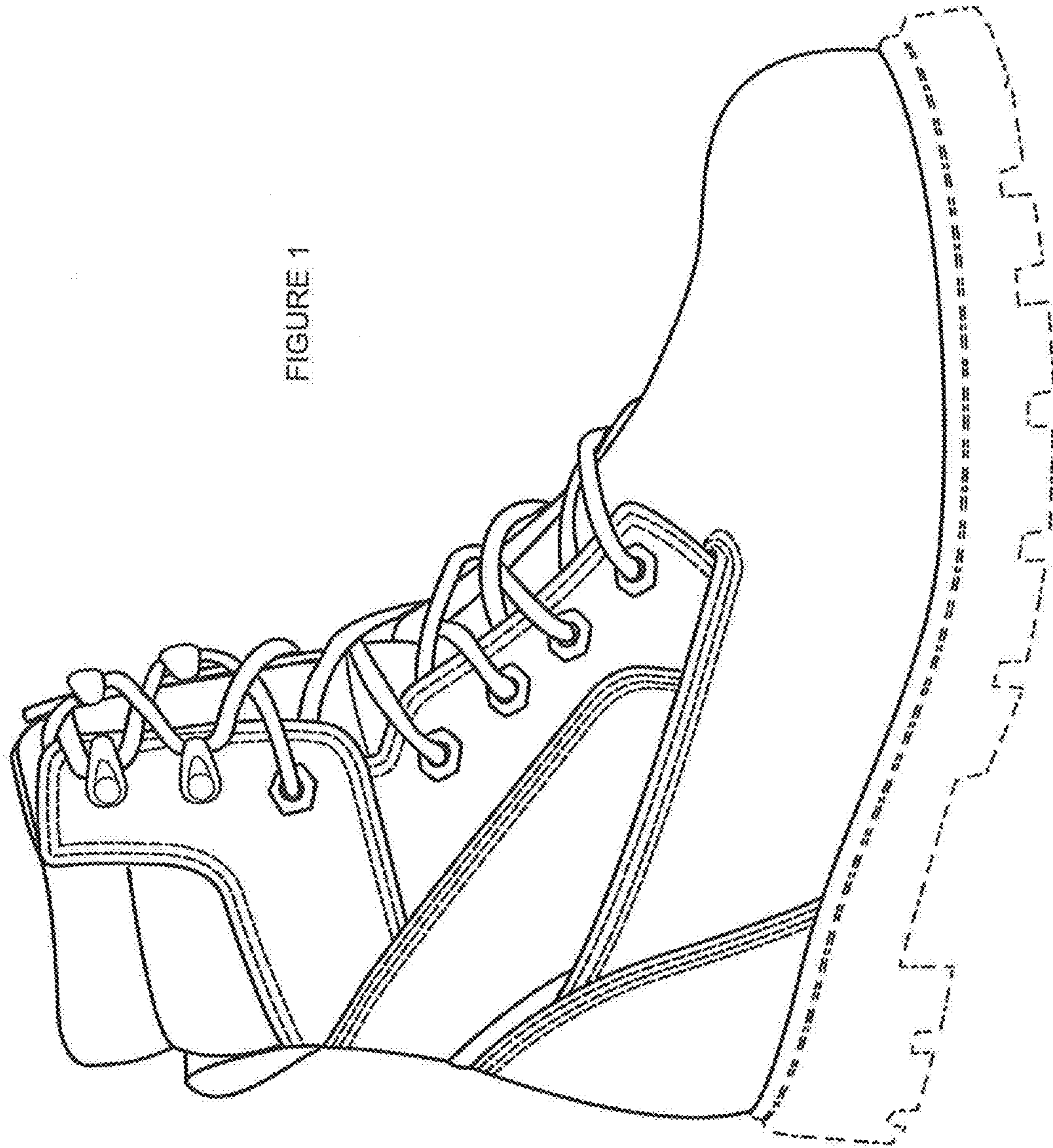

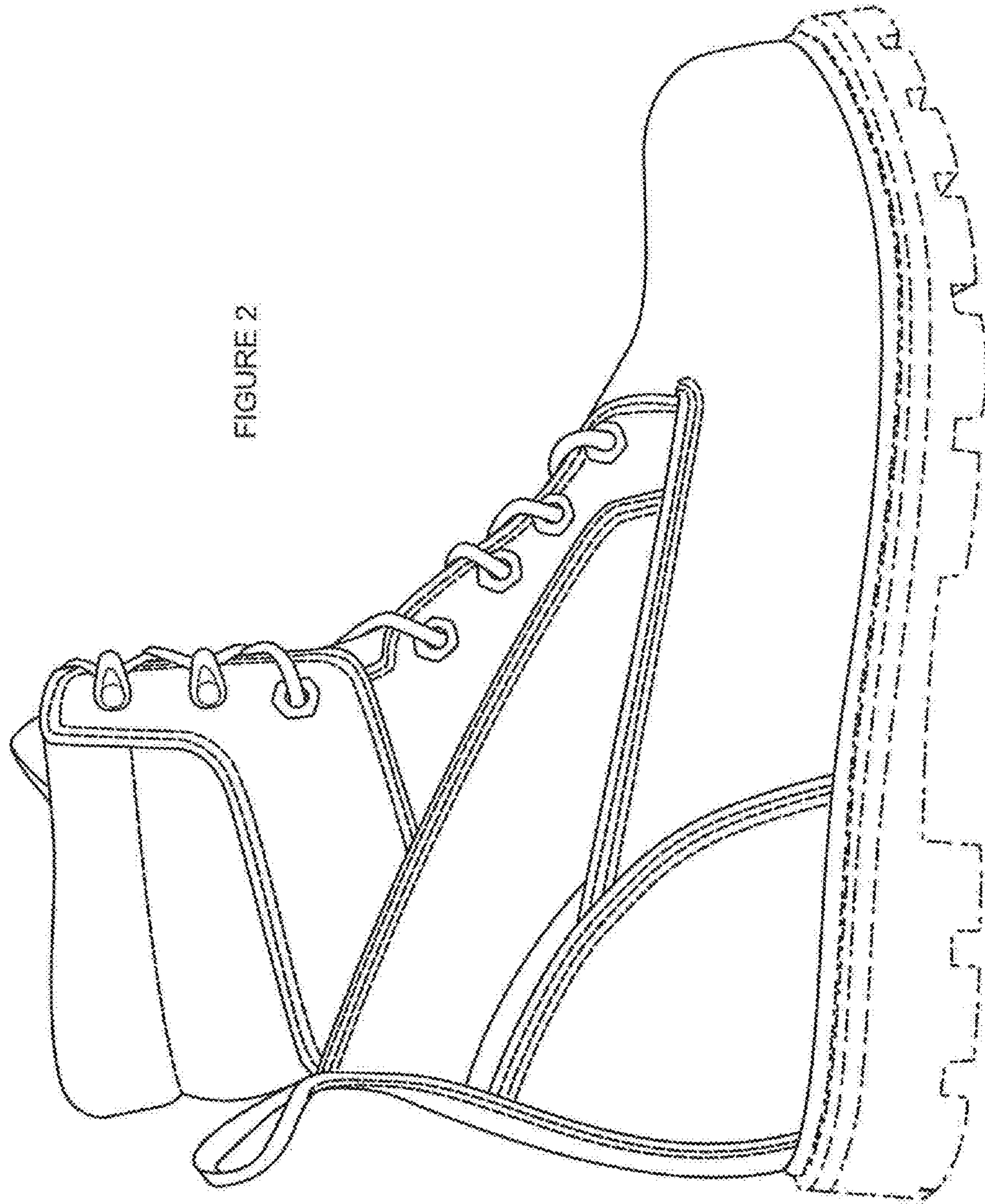

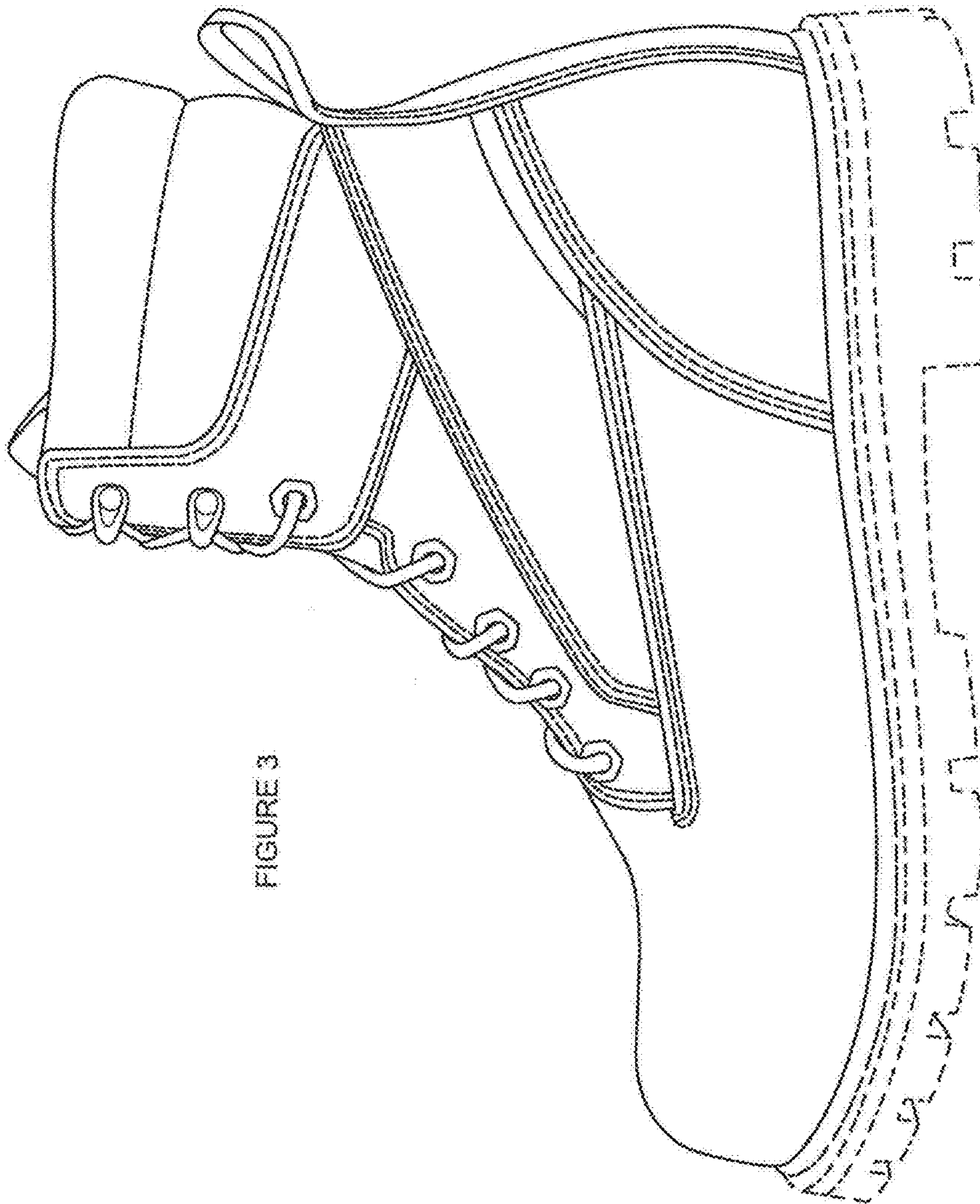

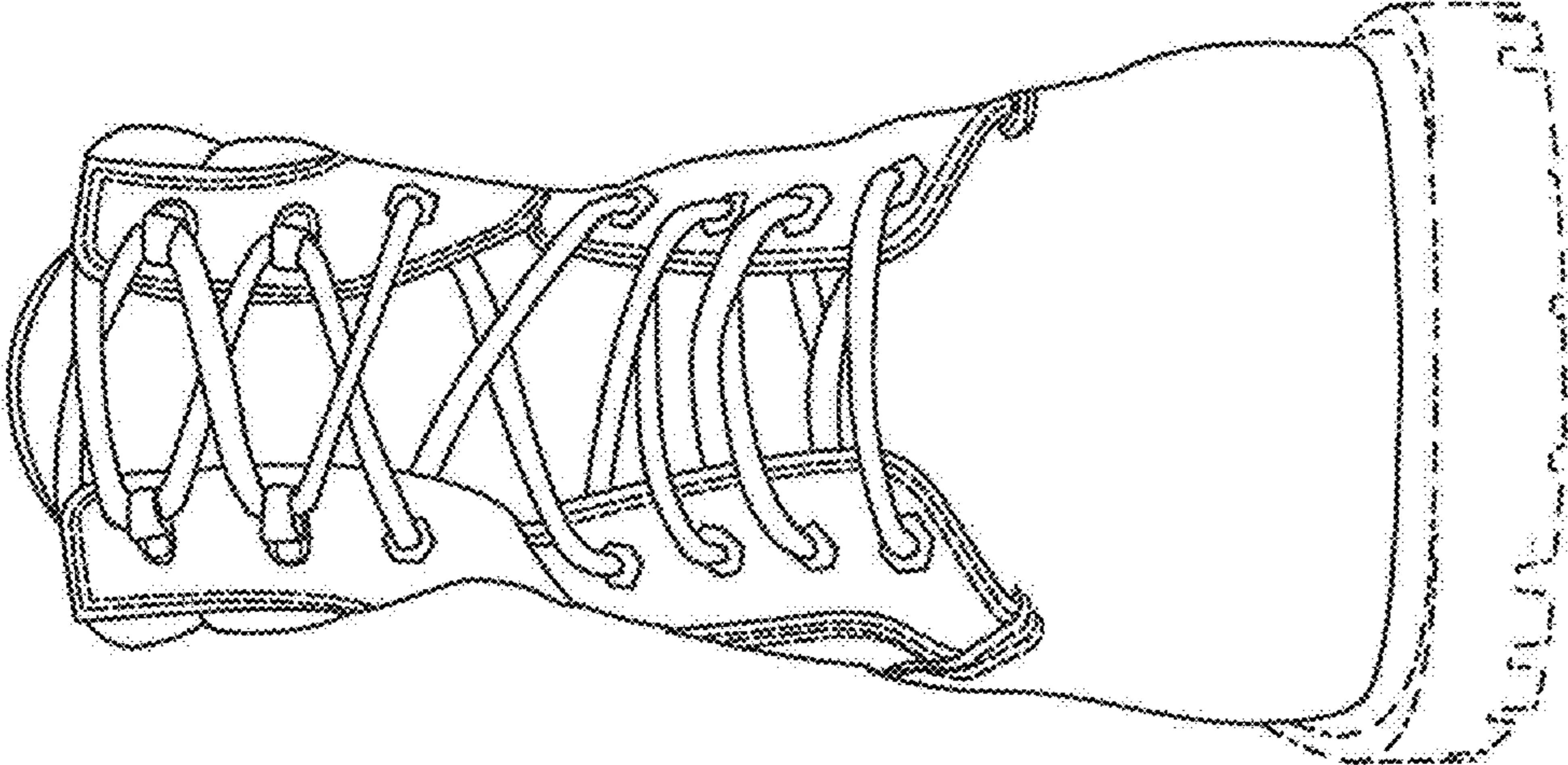

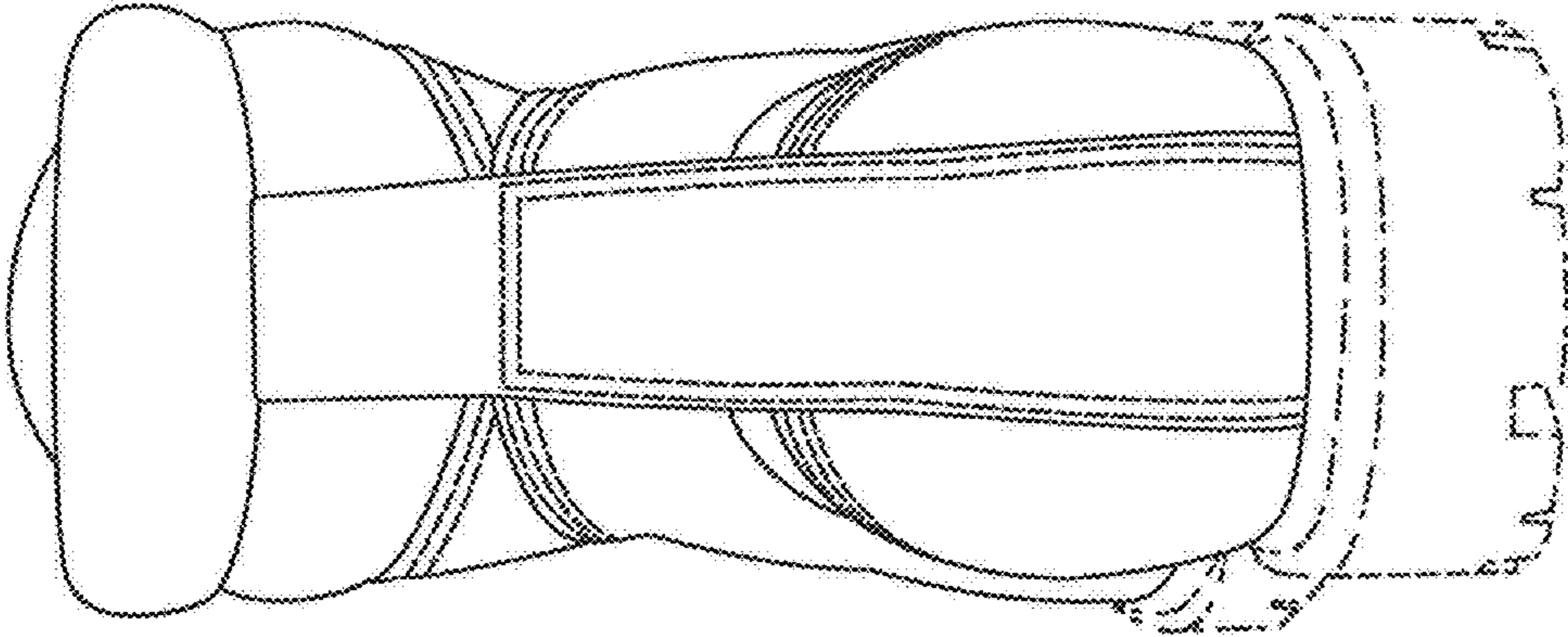
