The ornamental design for a dining chair, as shown and described.

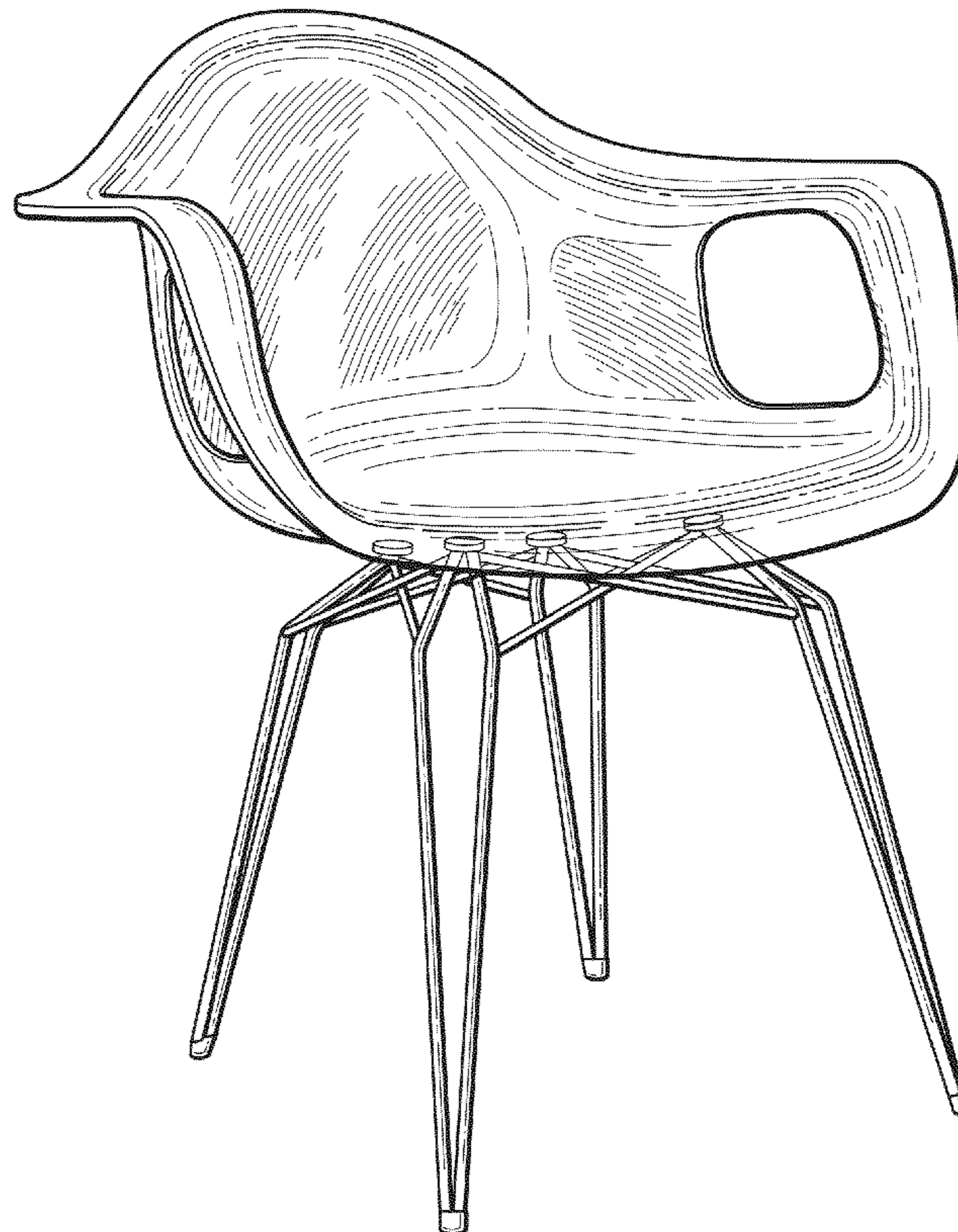
**DESCRIPTION**

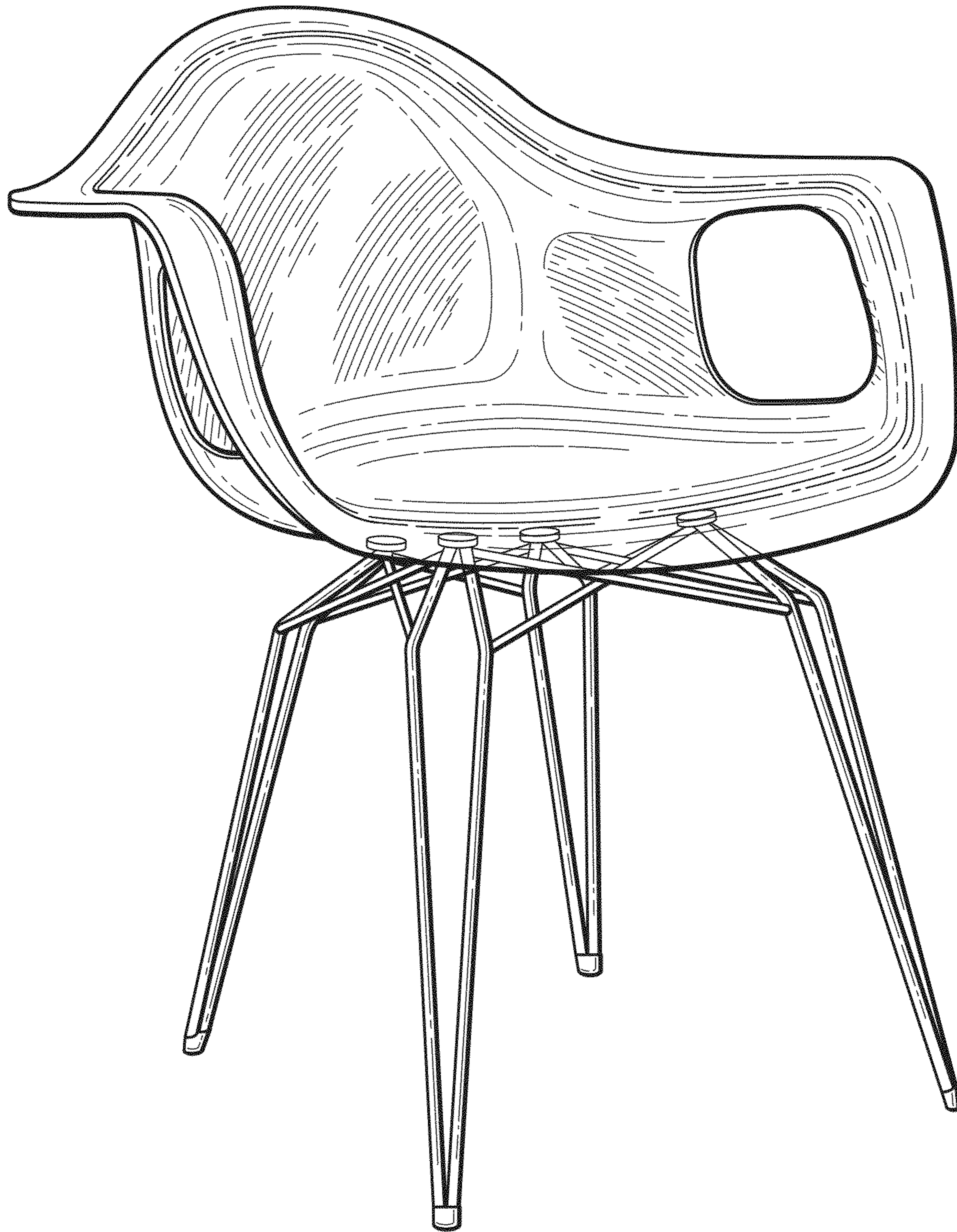

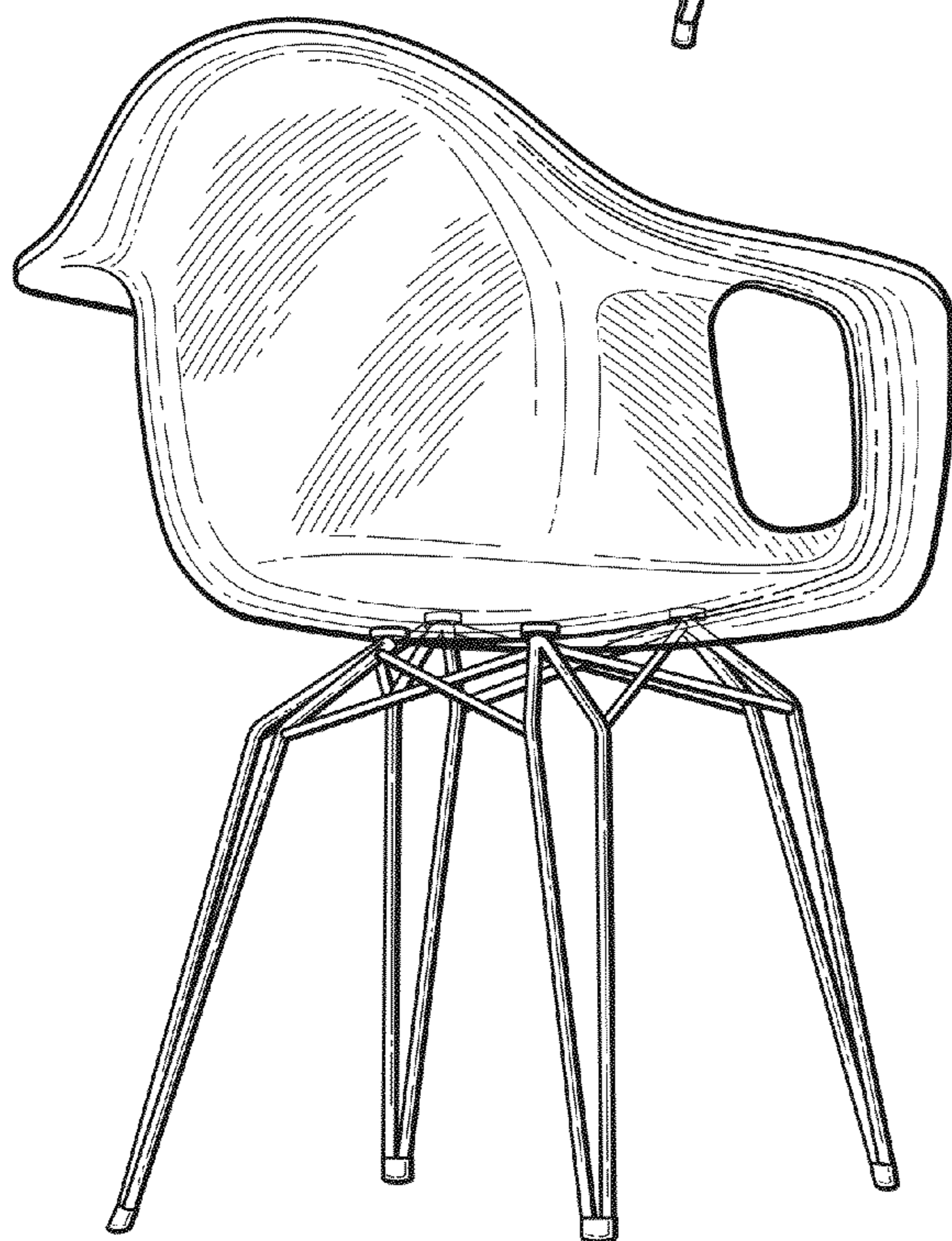
