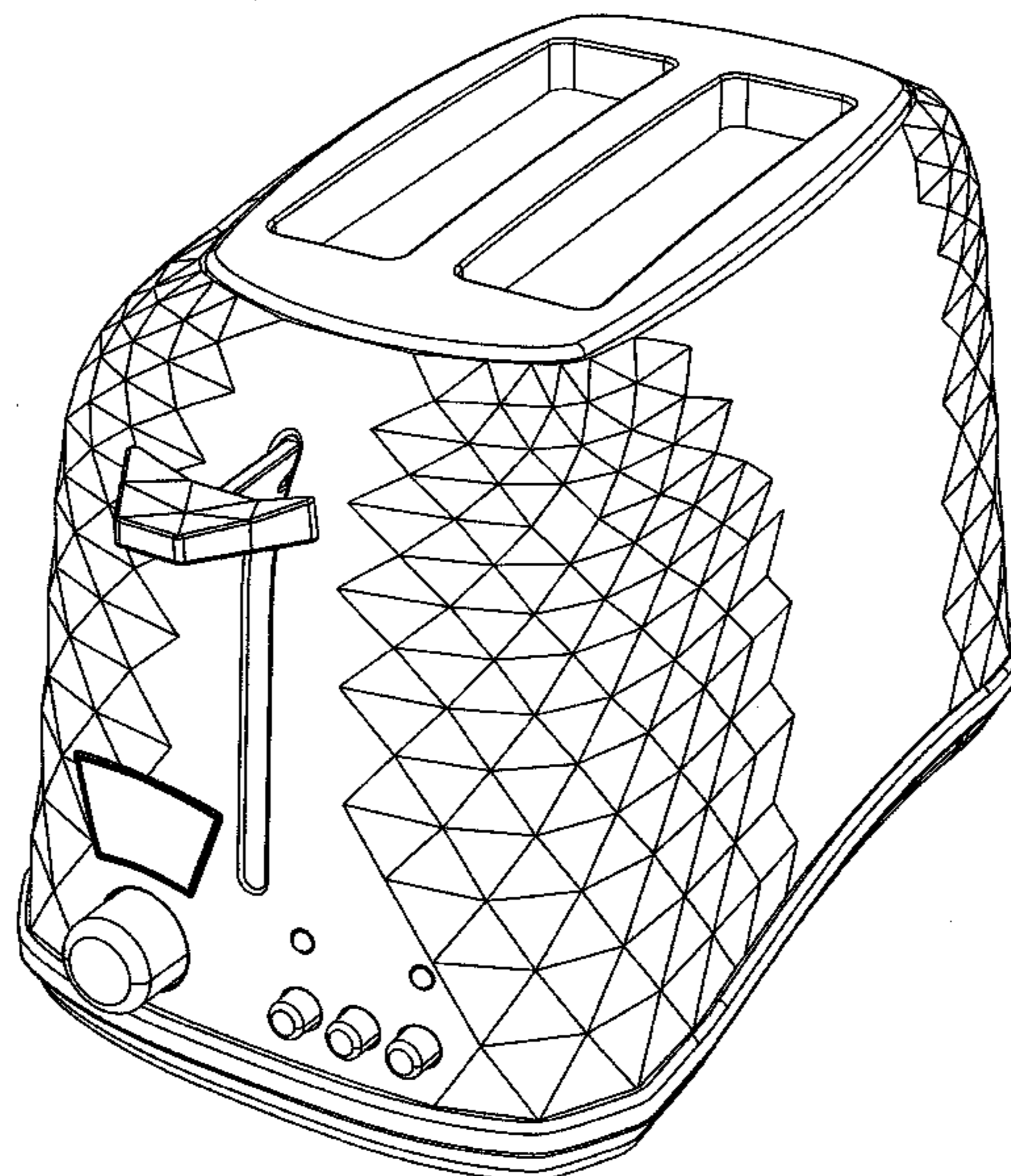
(57) **CLAIM**

The ornamental design for a toaster, as shown and described.

**DESCRIPTION**

FIGS. 1A and 1B are each a top perspective view of the toaster;  
FIGS. 2A and 2B are each a front elevational view of the toaster;  
FIGS. 3A and 3B are each a rear elevational view of the toaster;  
FIGS. 4A and 4B are each a right side elevational view of the toaster;  
FIGS. 5A and 5B are each a left side elevational view of the toaster;  
FIGS. 6A and 6B are each a top plan view of the toaster; and,  
FIGS. 7A and 7B are each a bottom plan view of the toaster.

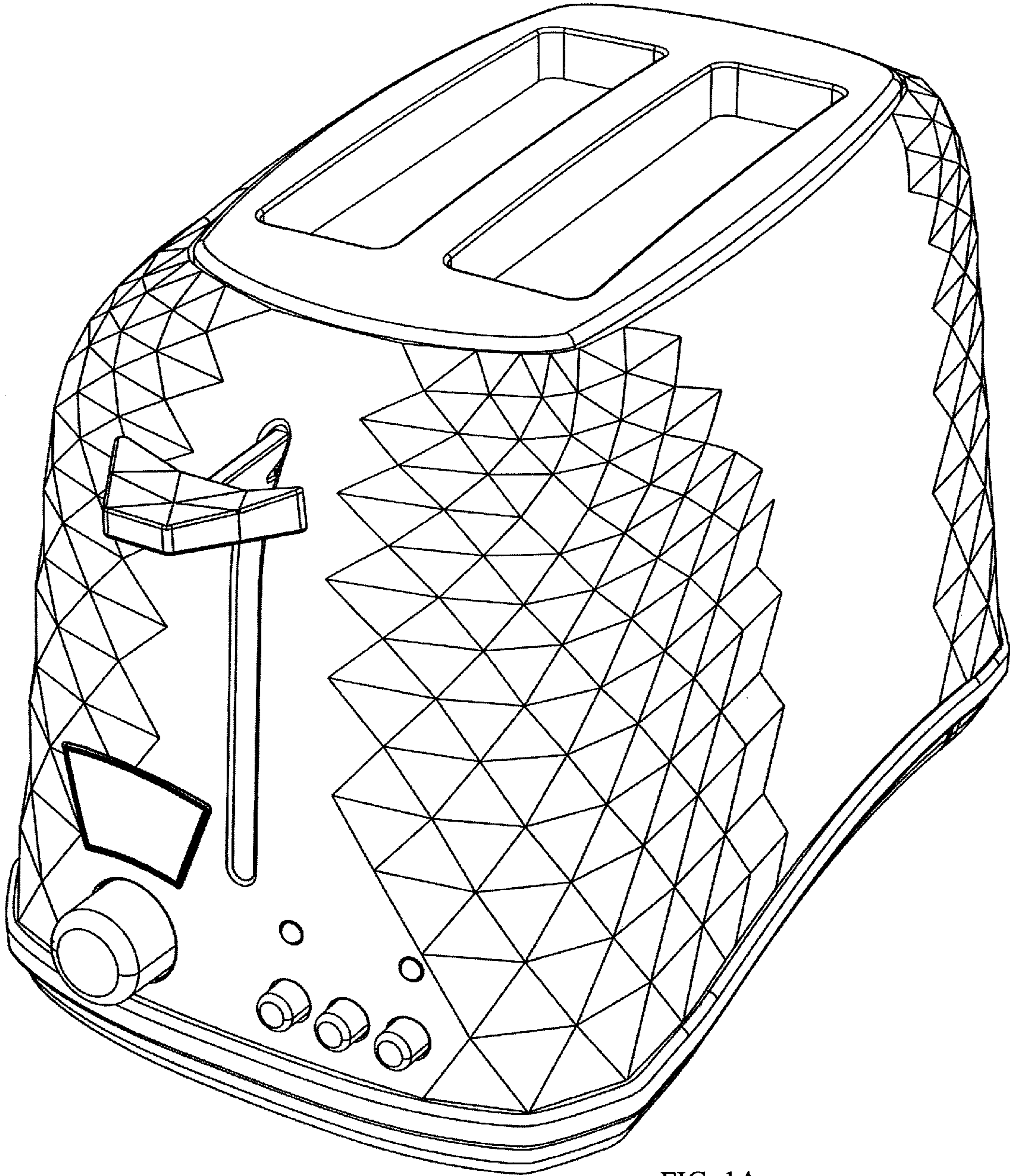

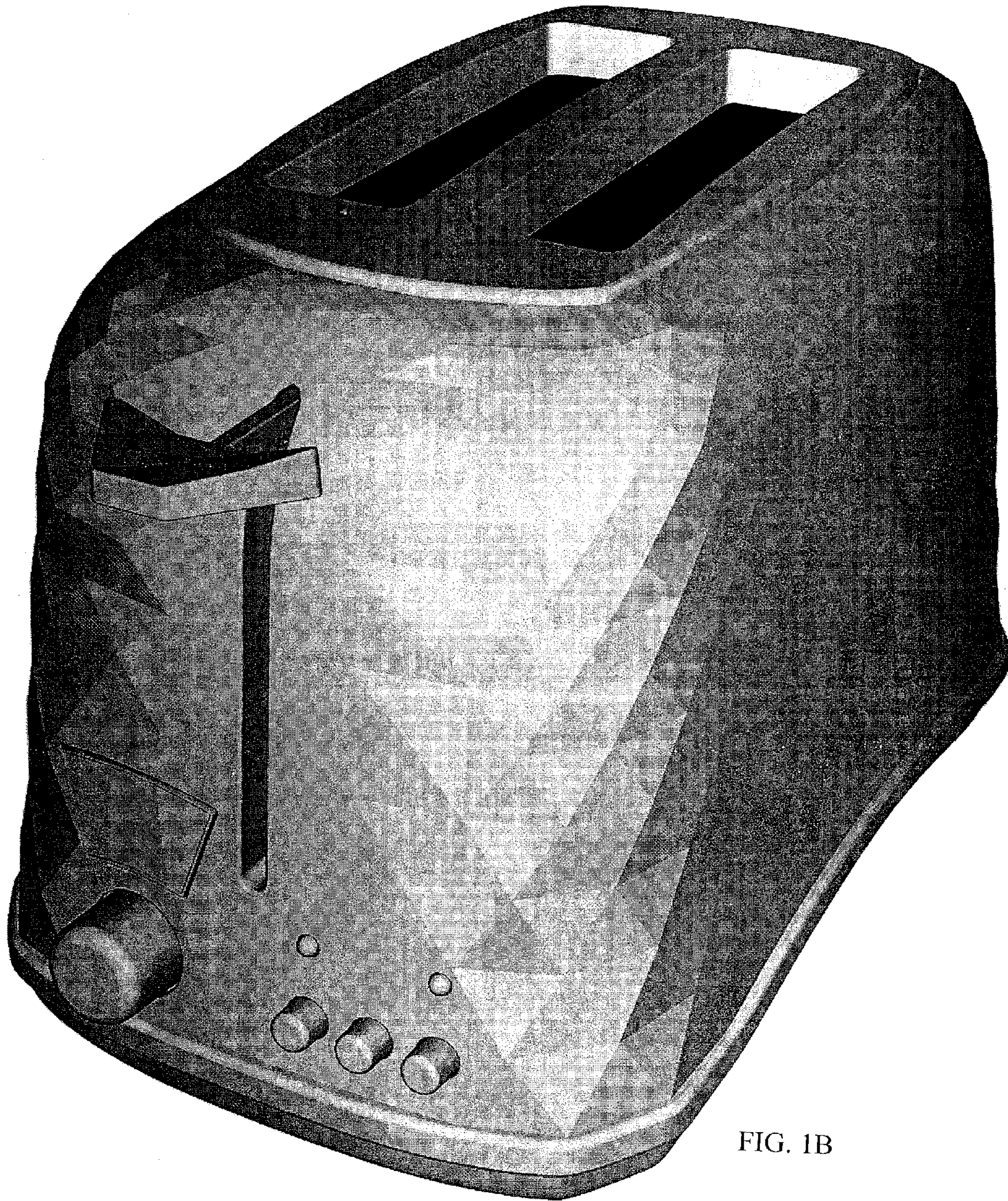

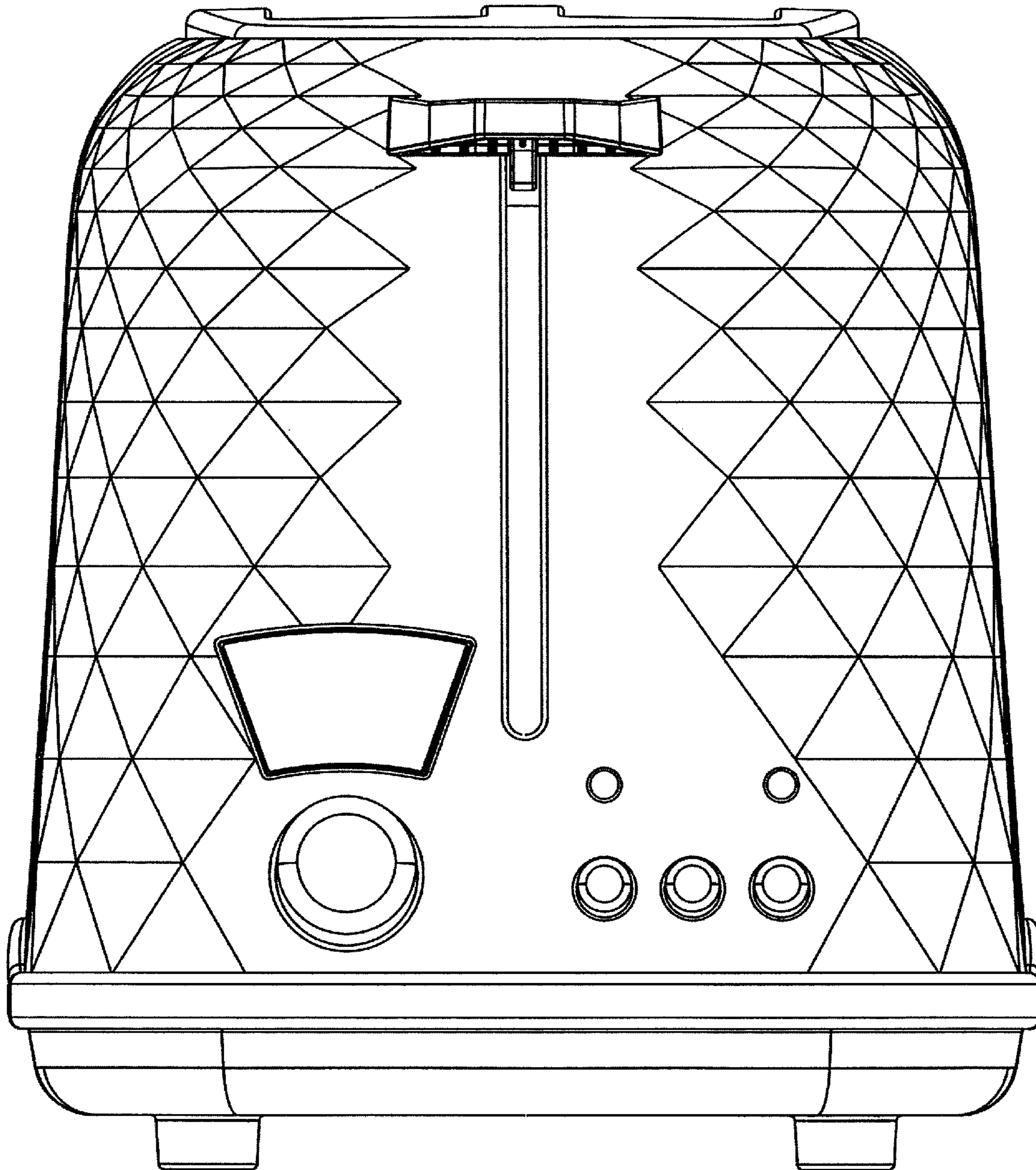

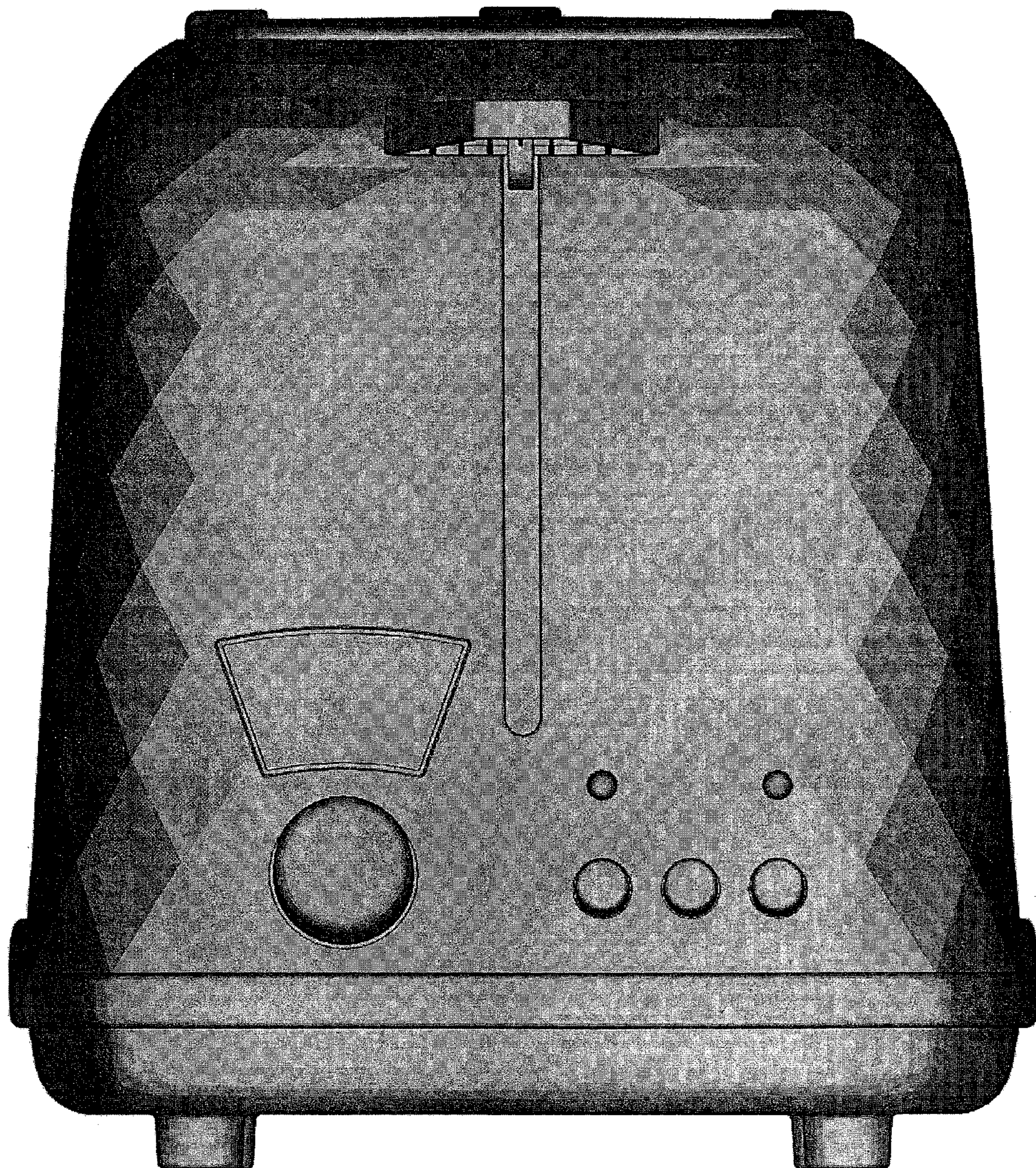

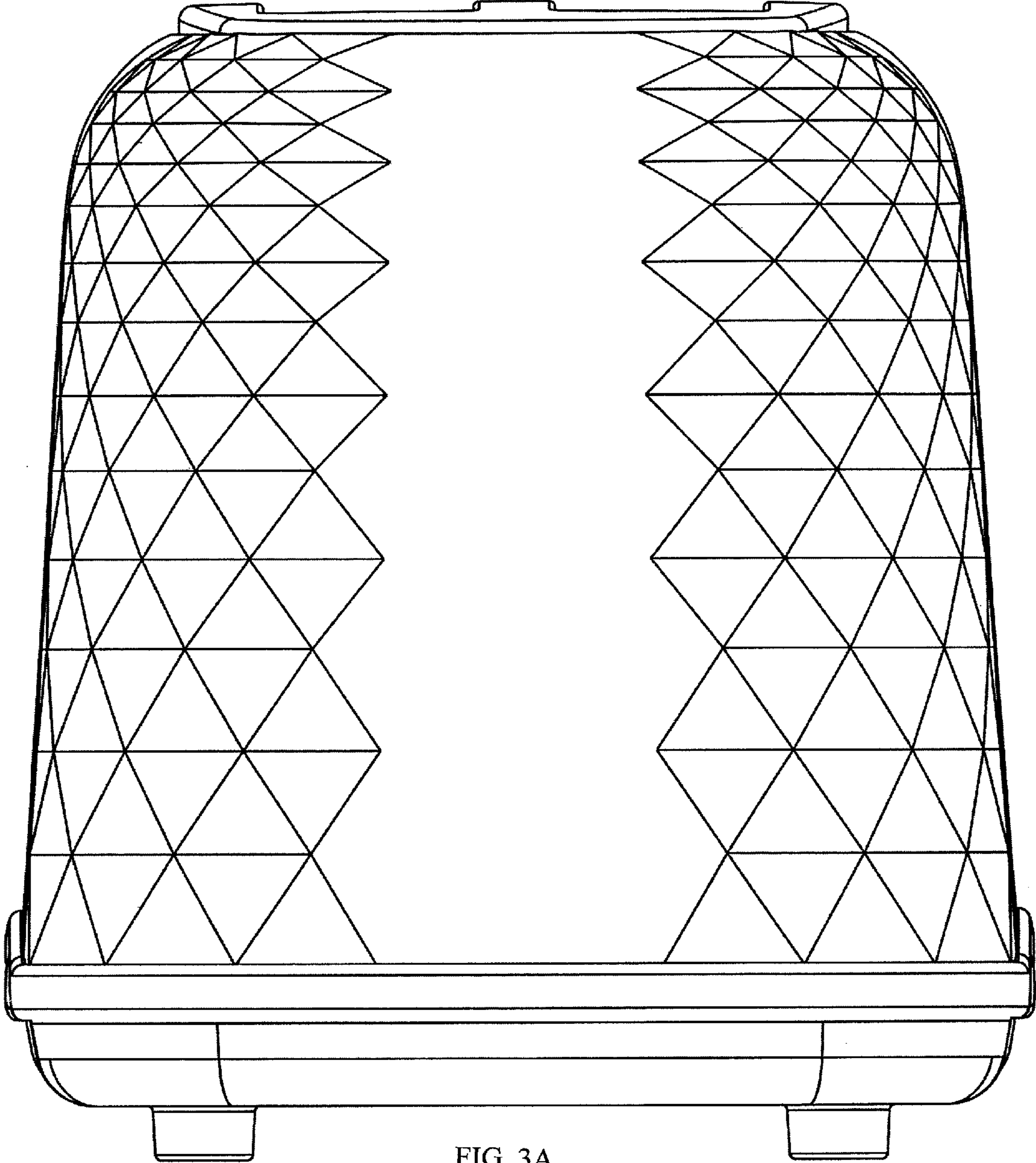

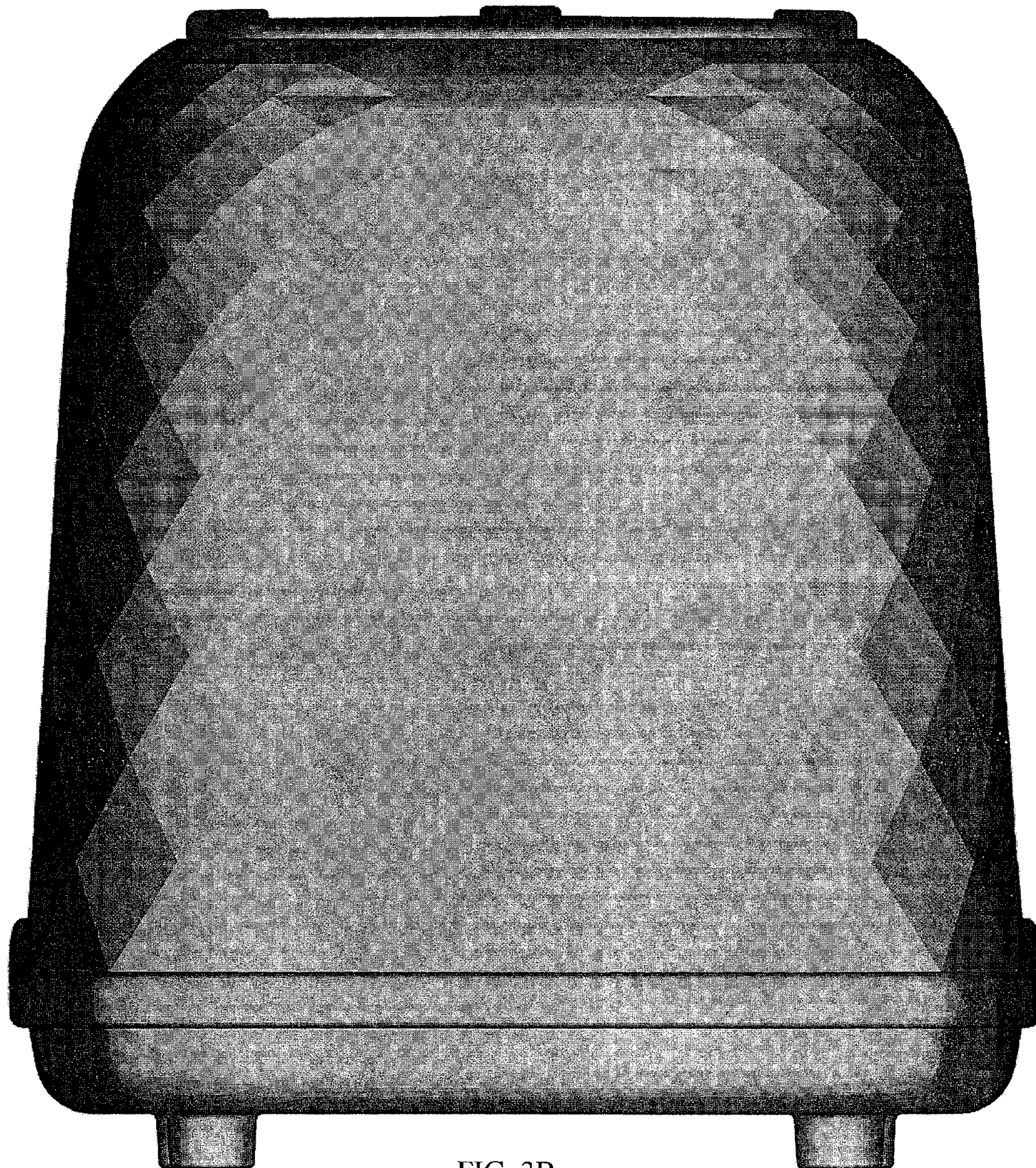

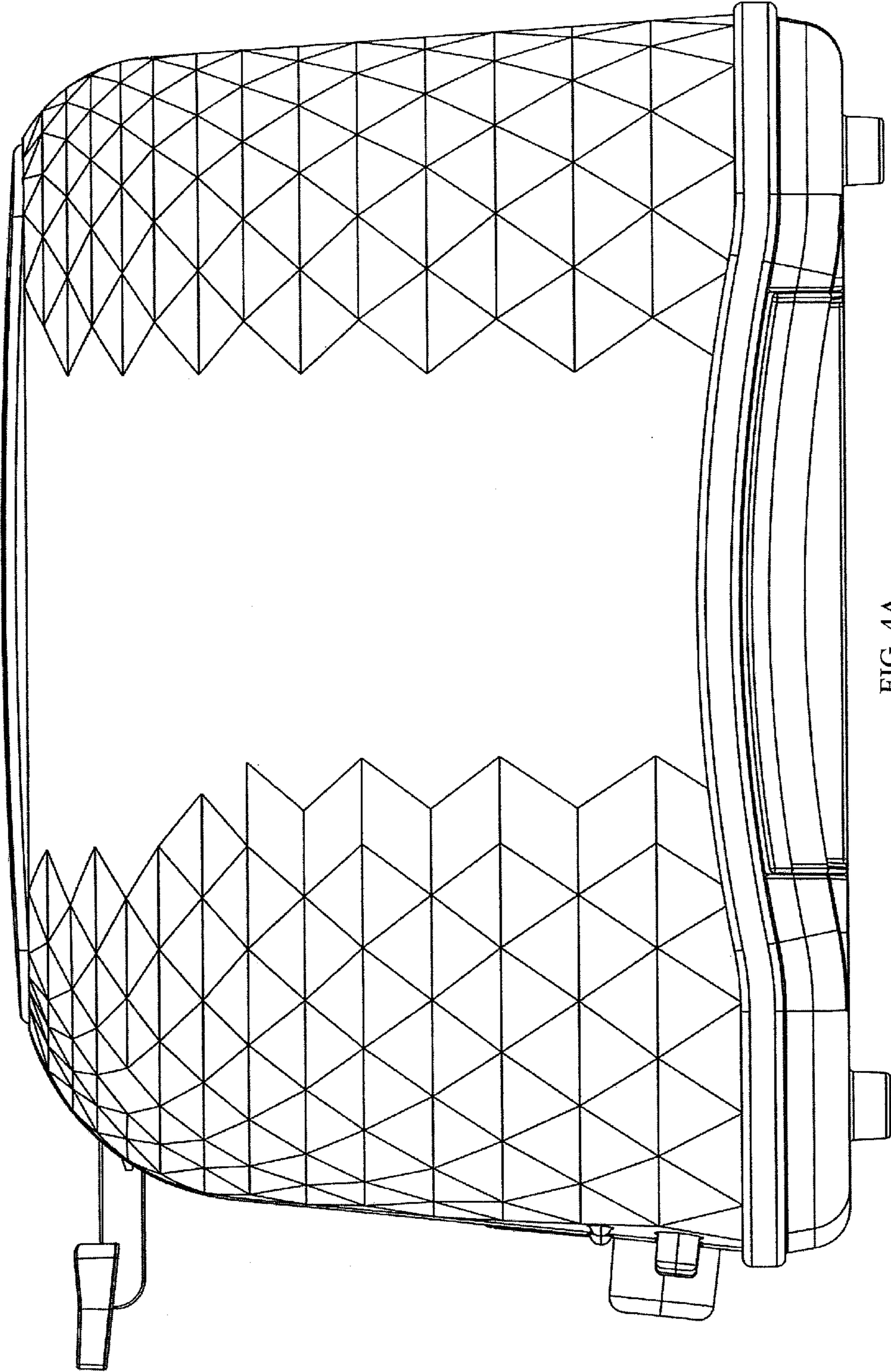

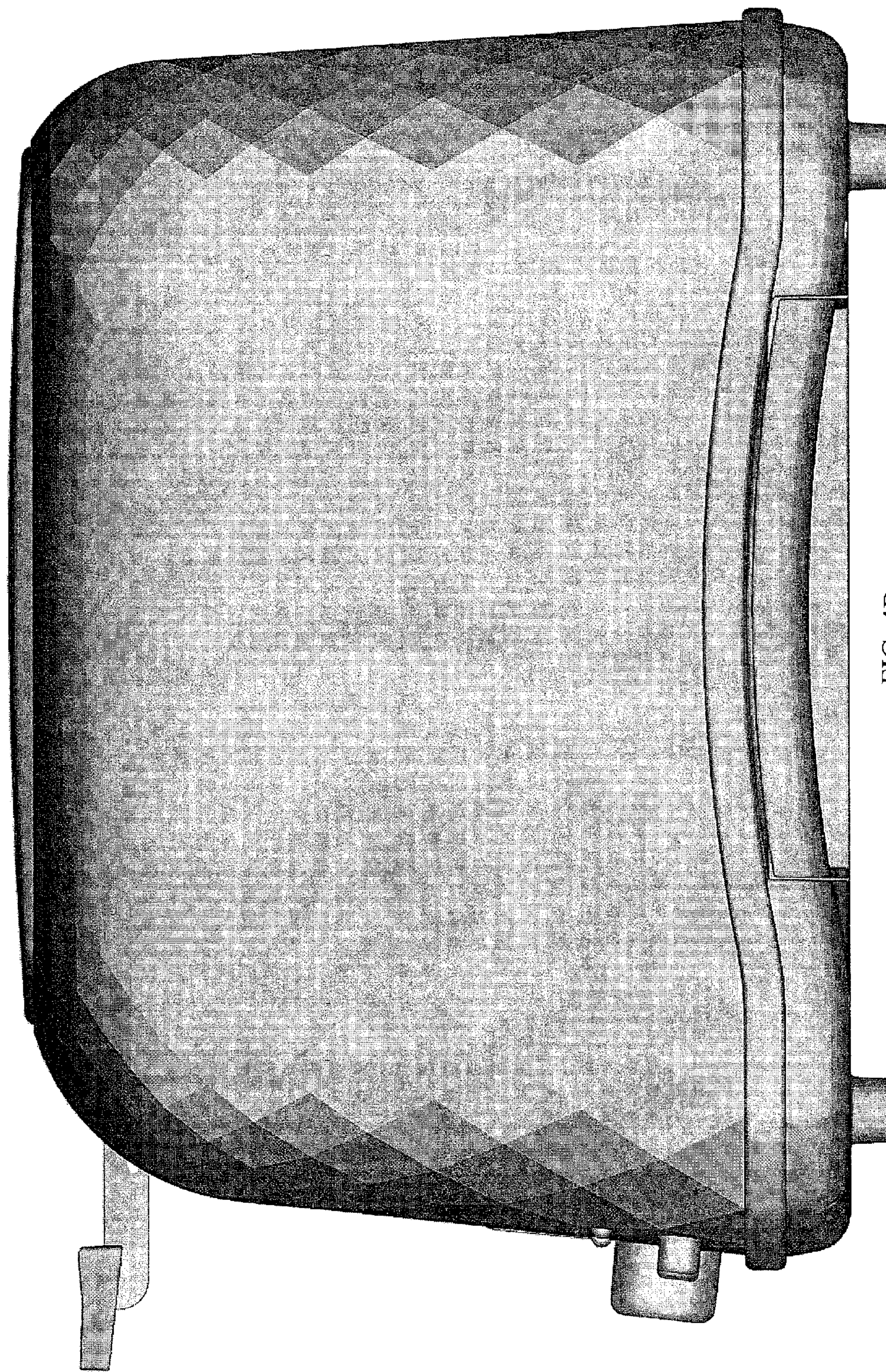

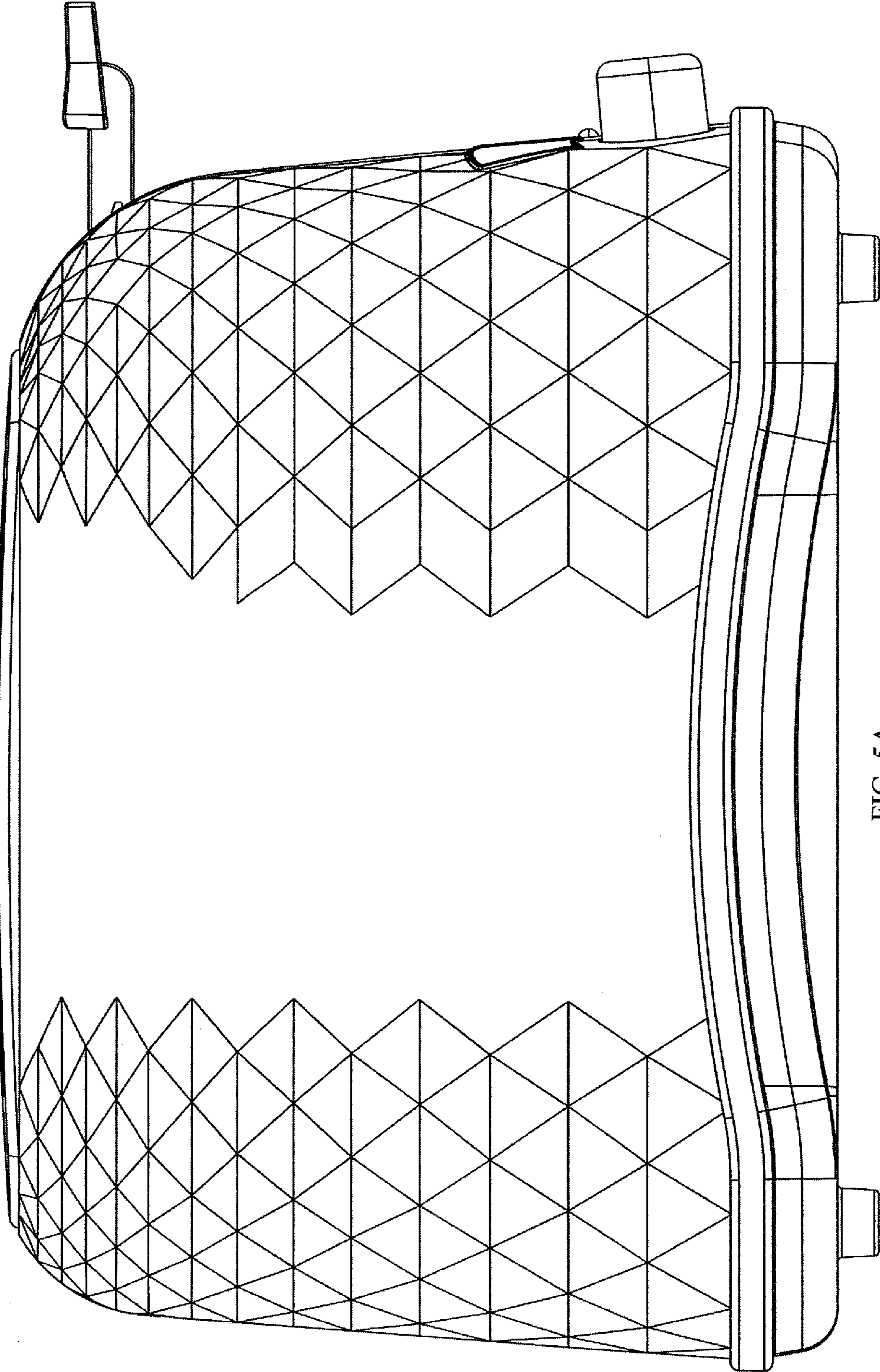

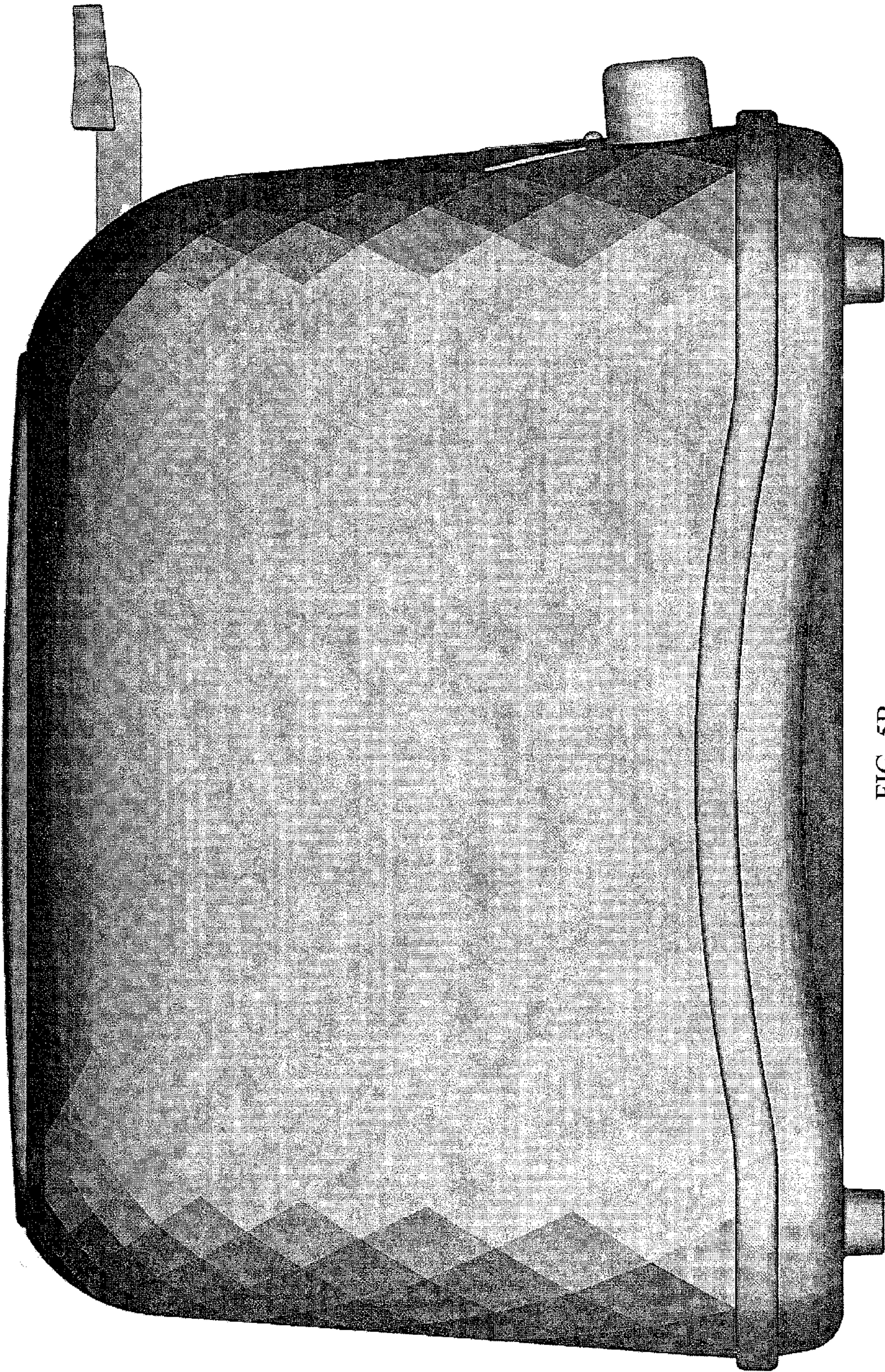

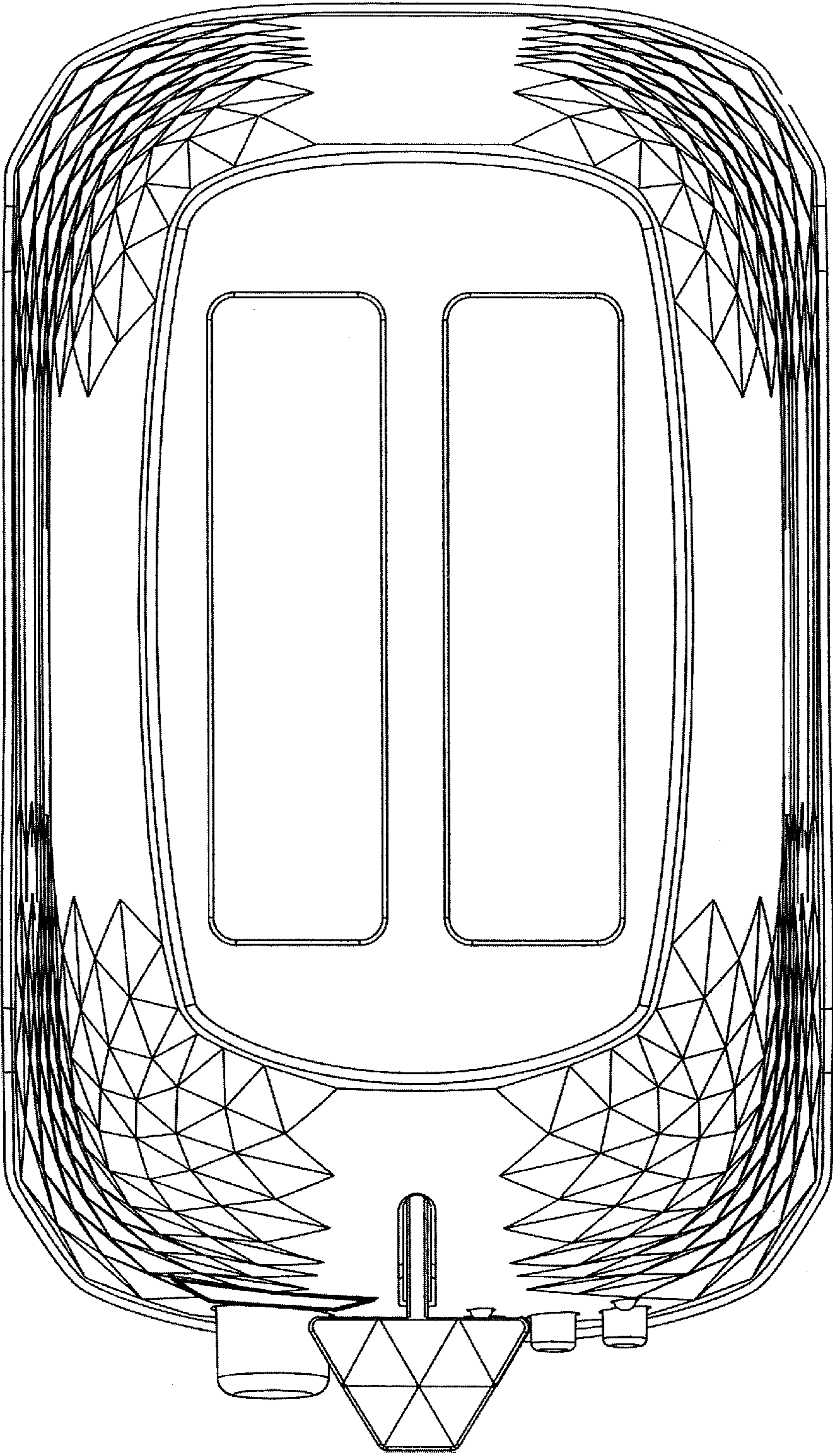

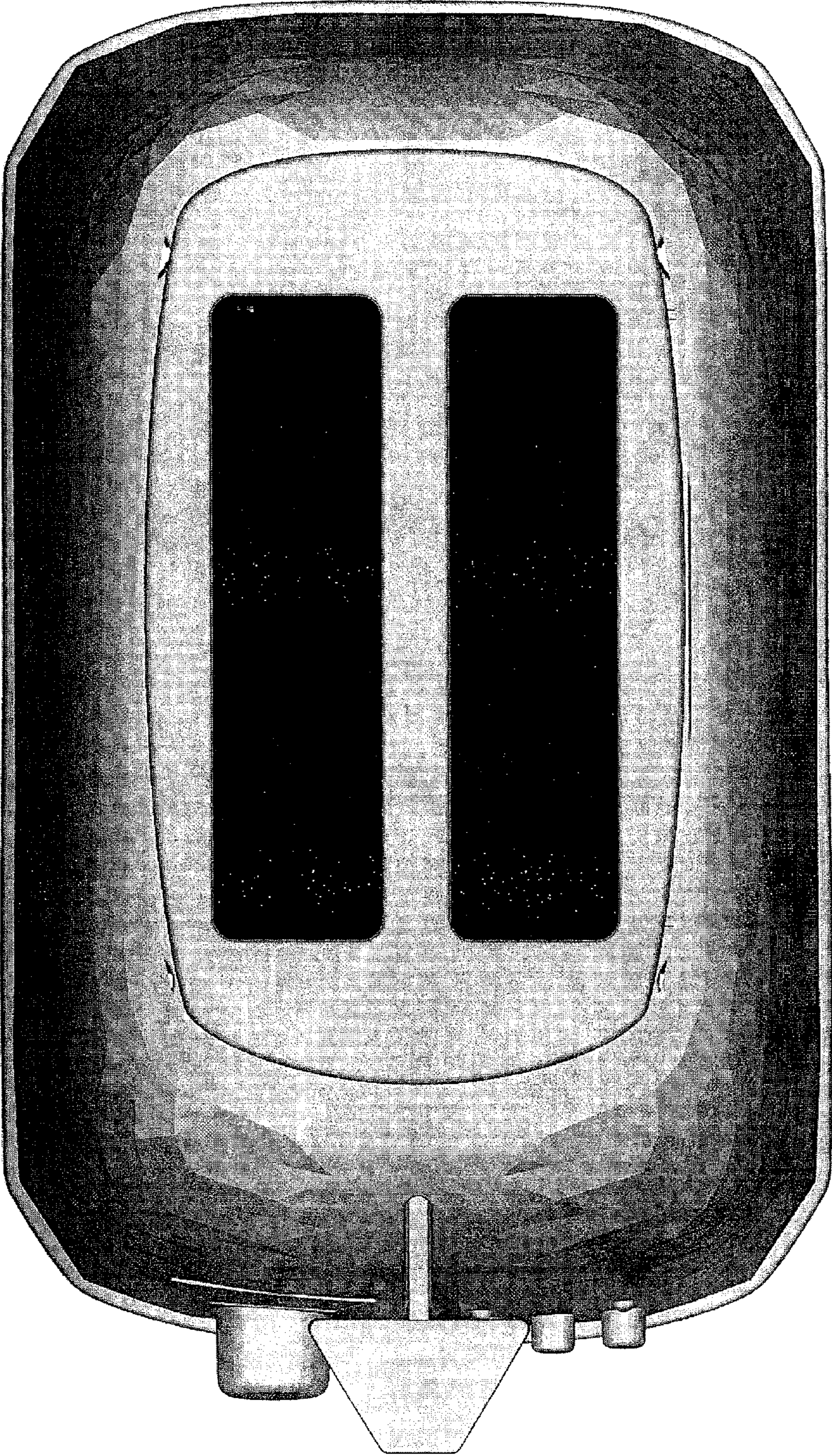

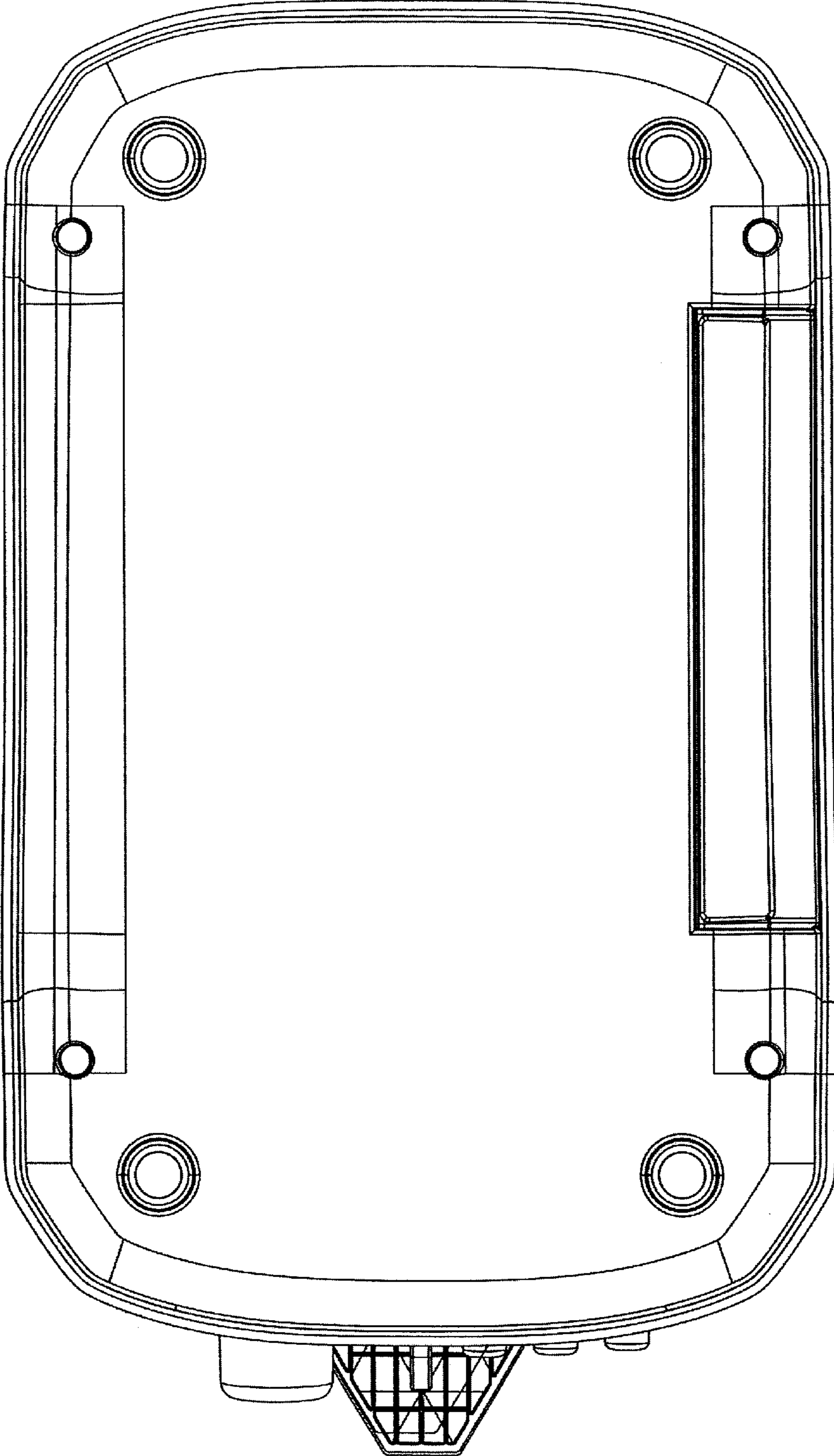

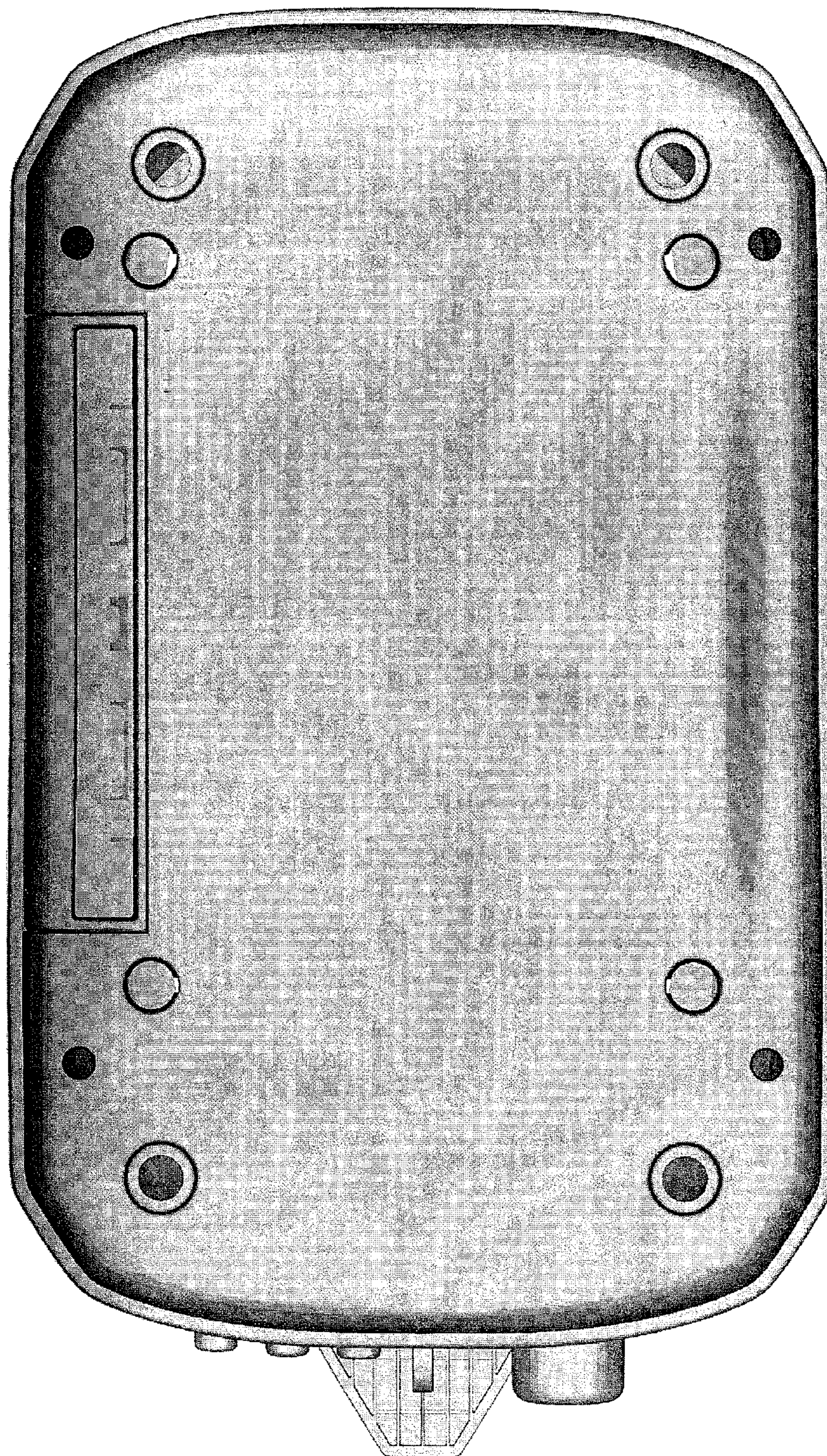
