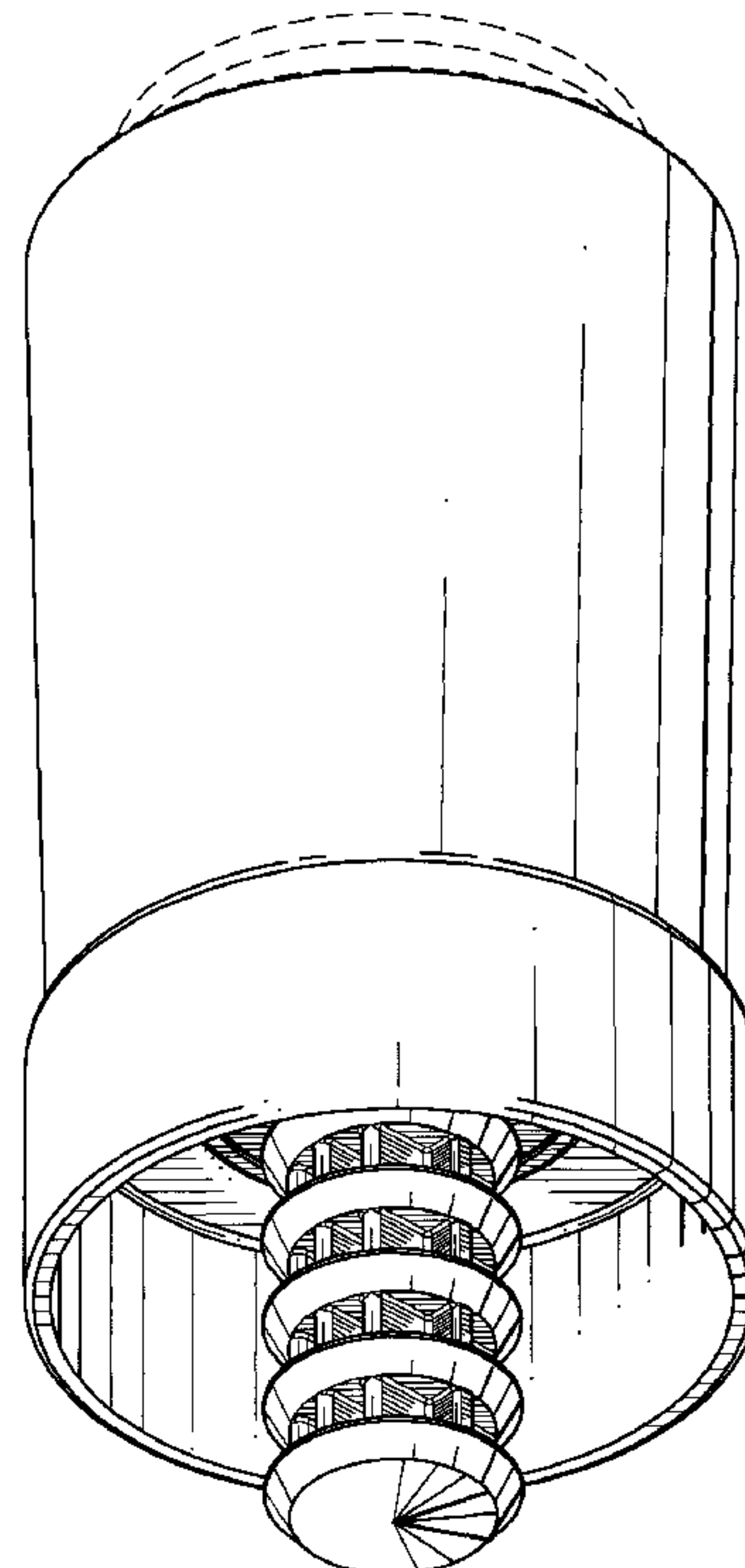
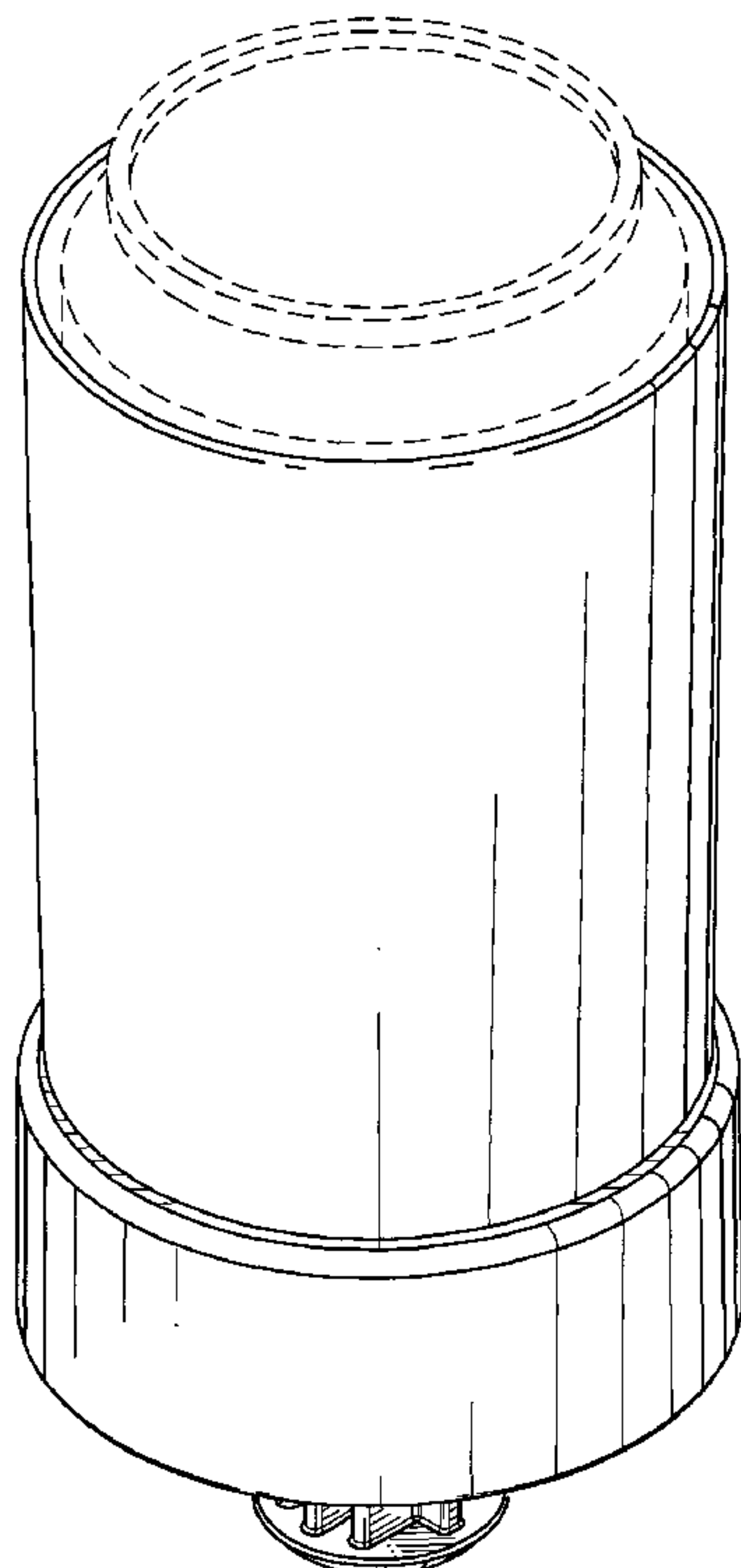
FIG. 1 is a perspective view of the combined noodle cap and beverage holder;

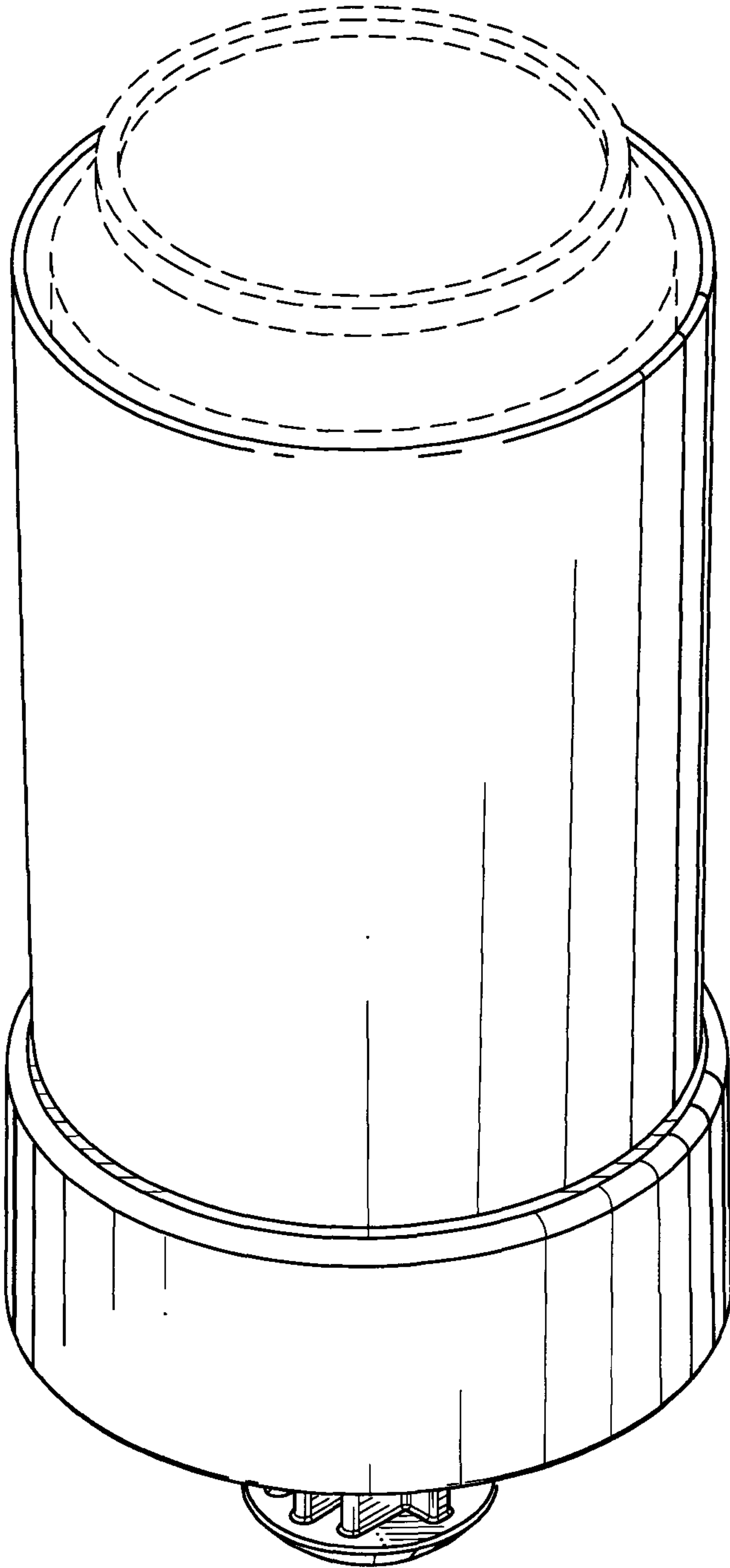

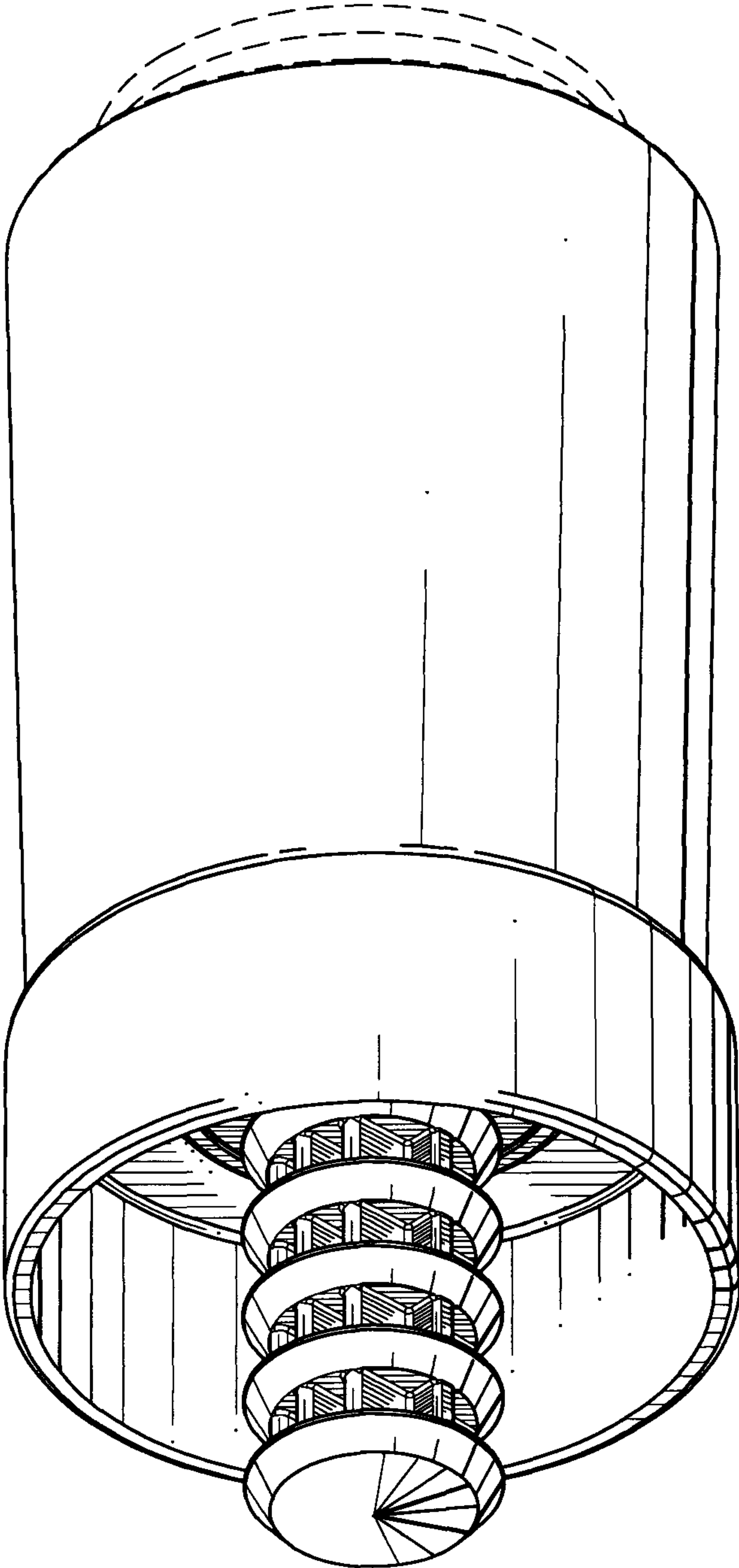

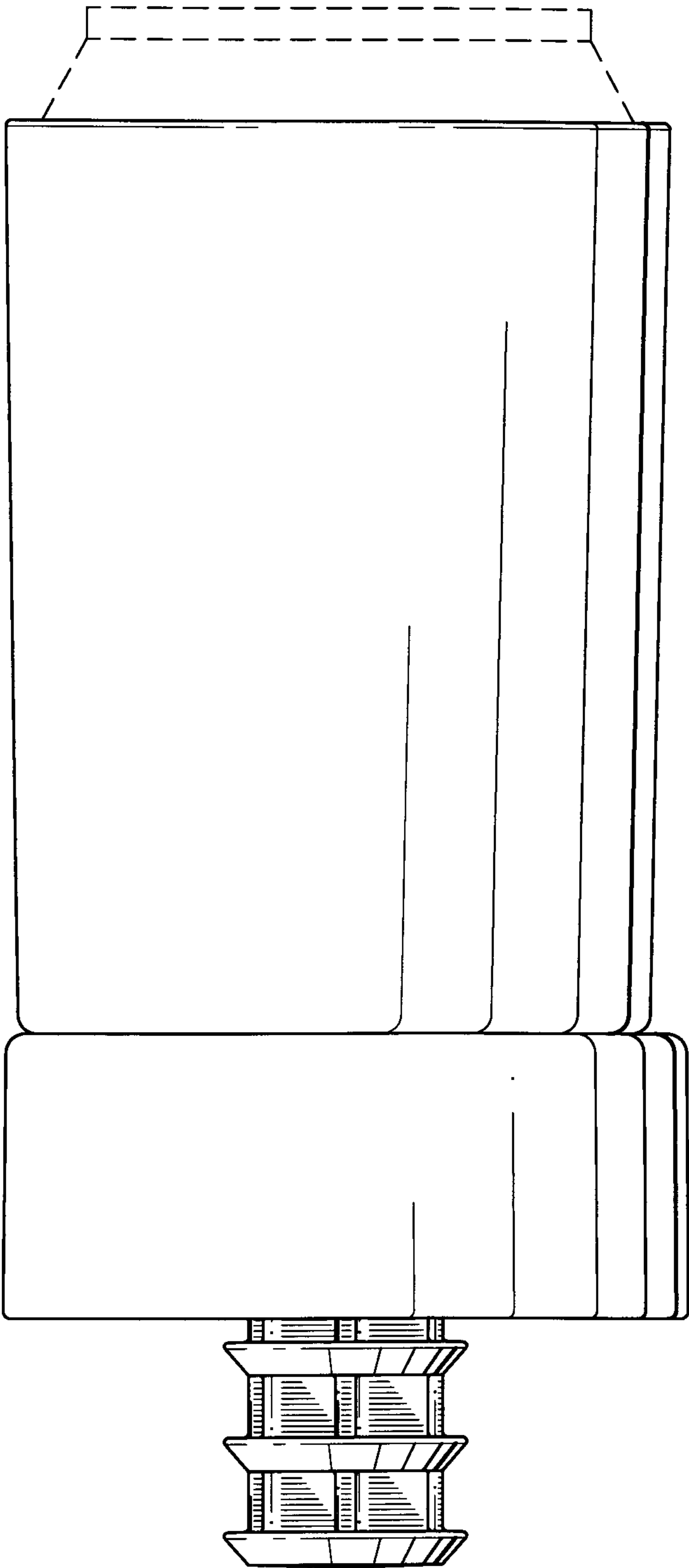

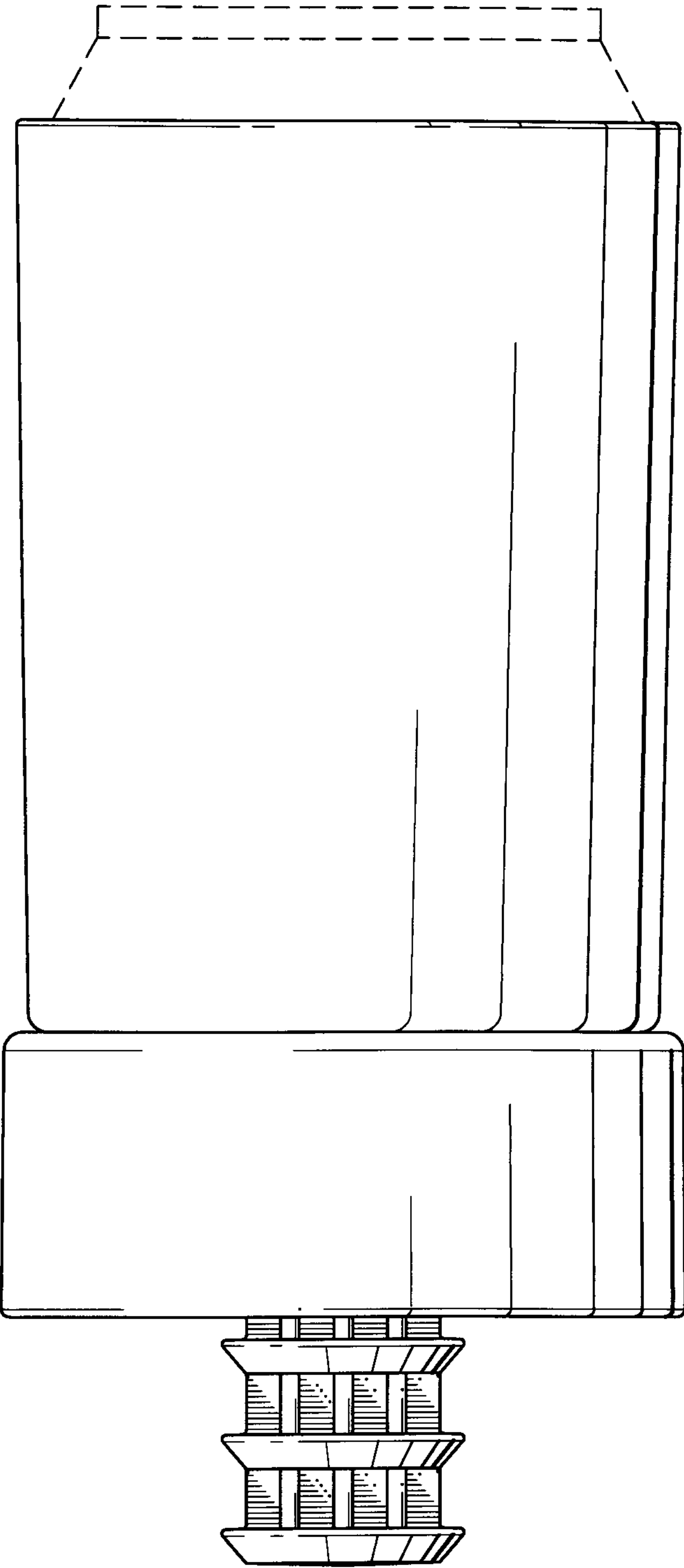

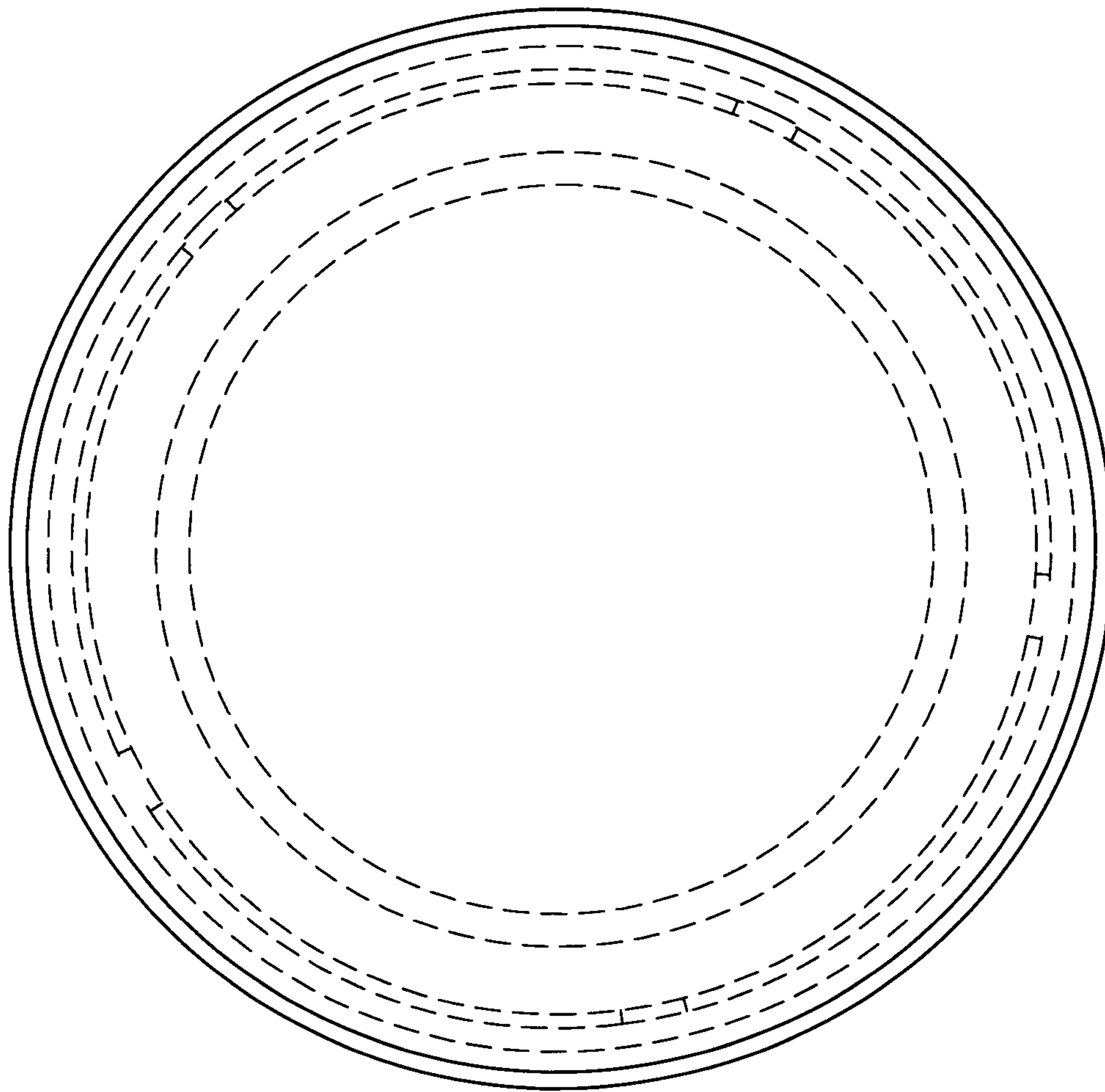

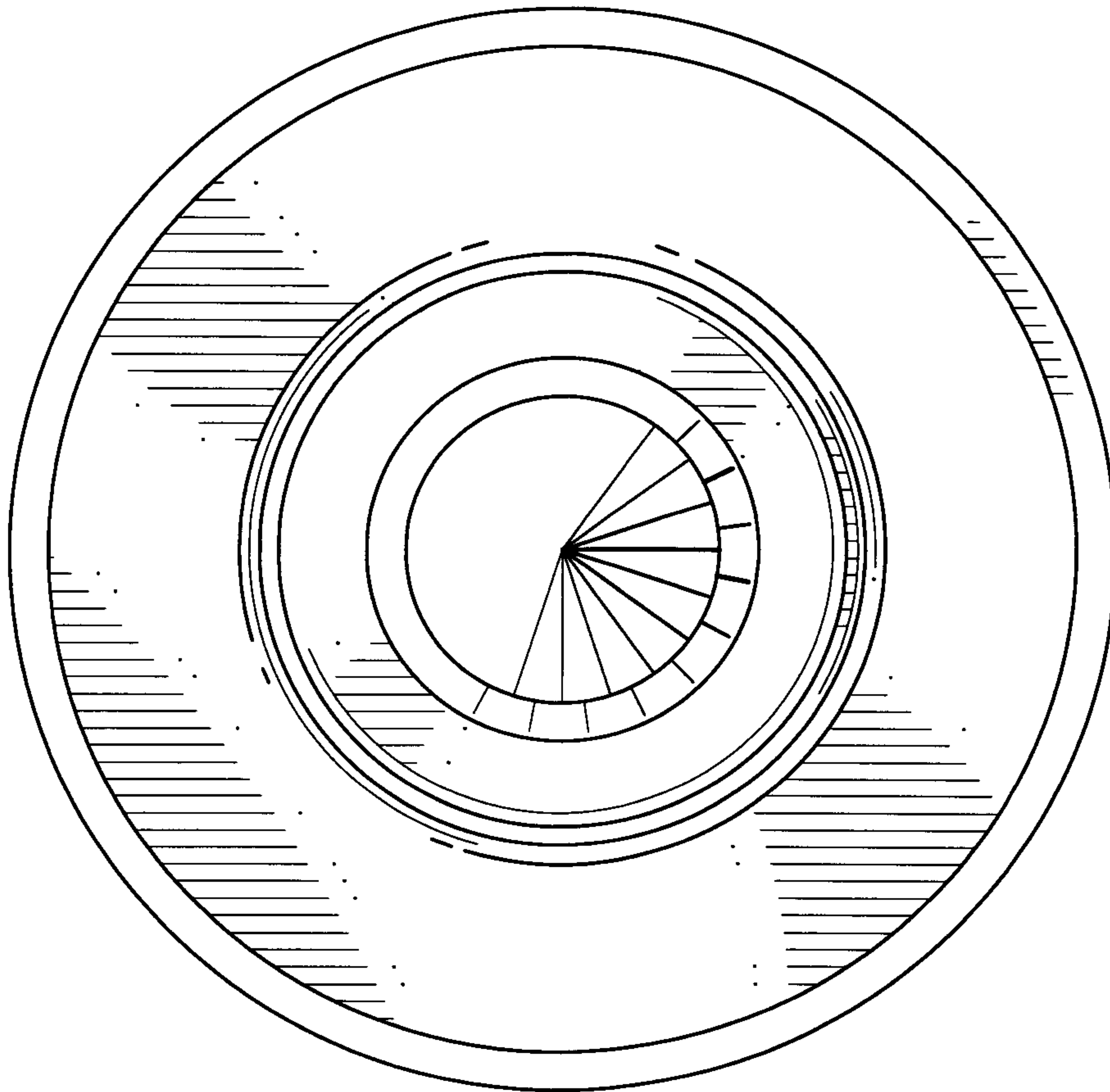

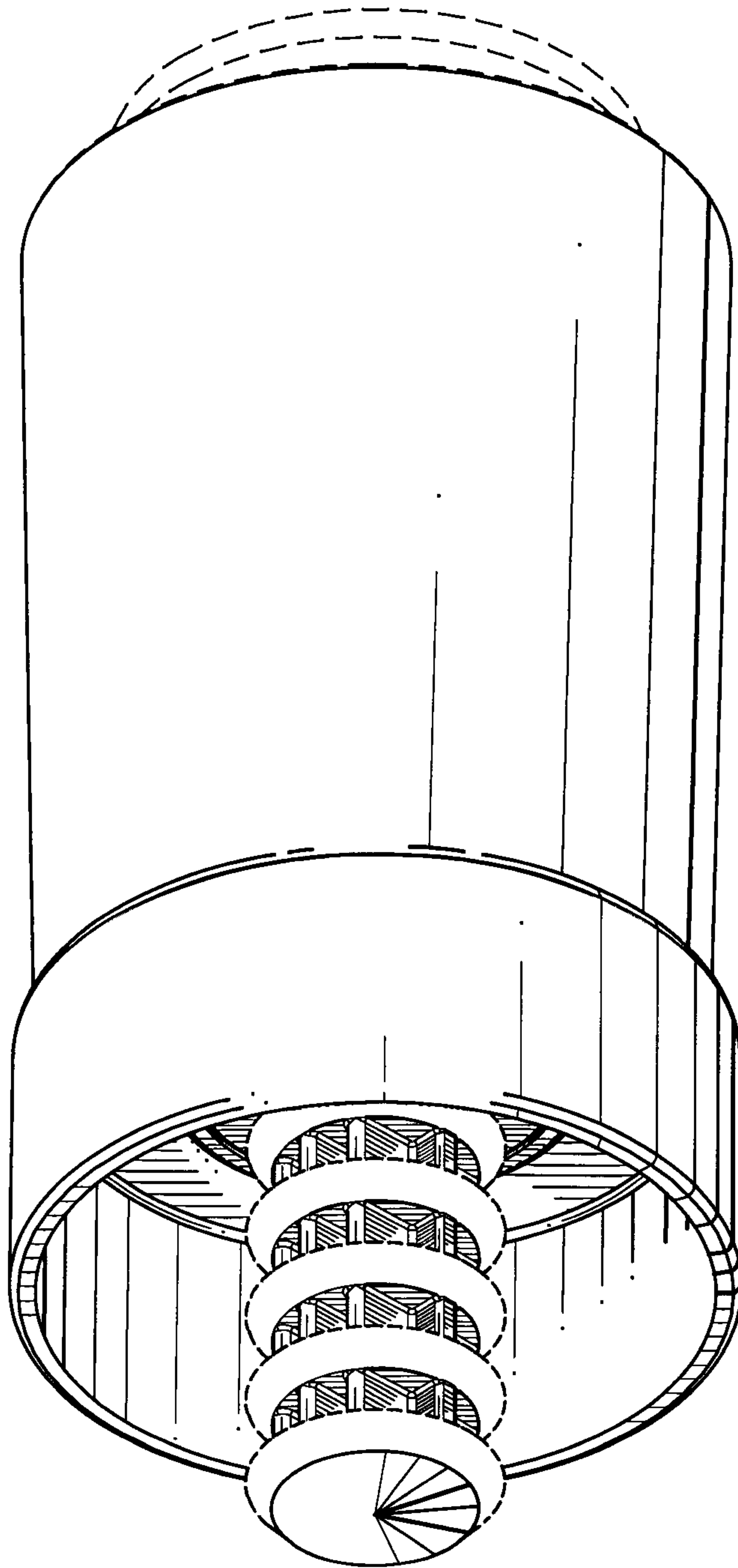
