(57) **CLAIM**

We claim the ornamental design for a utility knife, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a utility knife according to an embodiment of the invention.

FIG. 2 is a left side view of the utility knife shown in FIG. 1.

FIG. 3 is a right side view of the utility knife shown in FIG. 1.

FIG. 4 is a top view of the utility knife shown in FIG. 1.

FIG. 5 is a bottom view of the utility knife shown in FIG. 1.

FIG. 6 is a front view of the utility knife shown in FIG. 1; and, FIG. 7 is a rear view of the utility knife shown in FIG. 1.

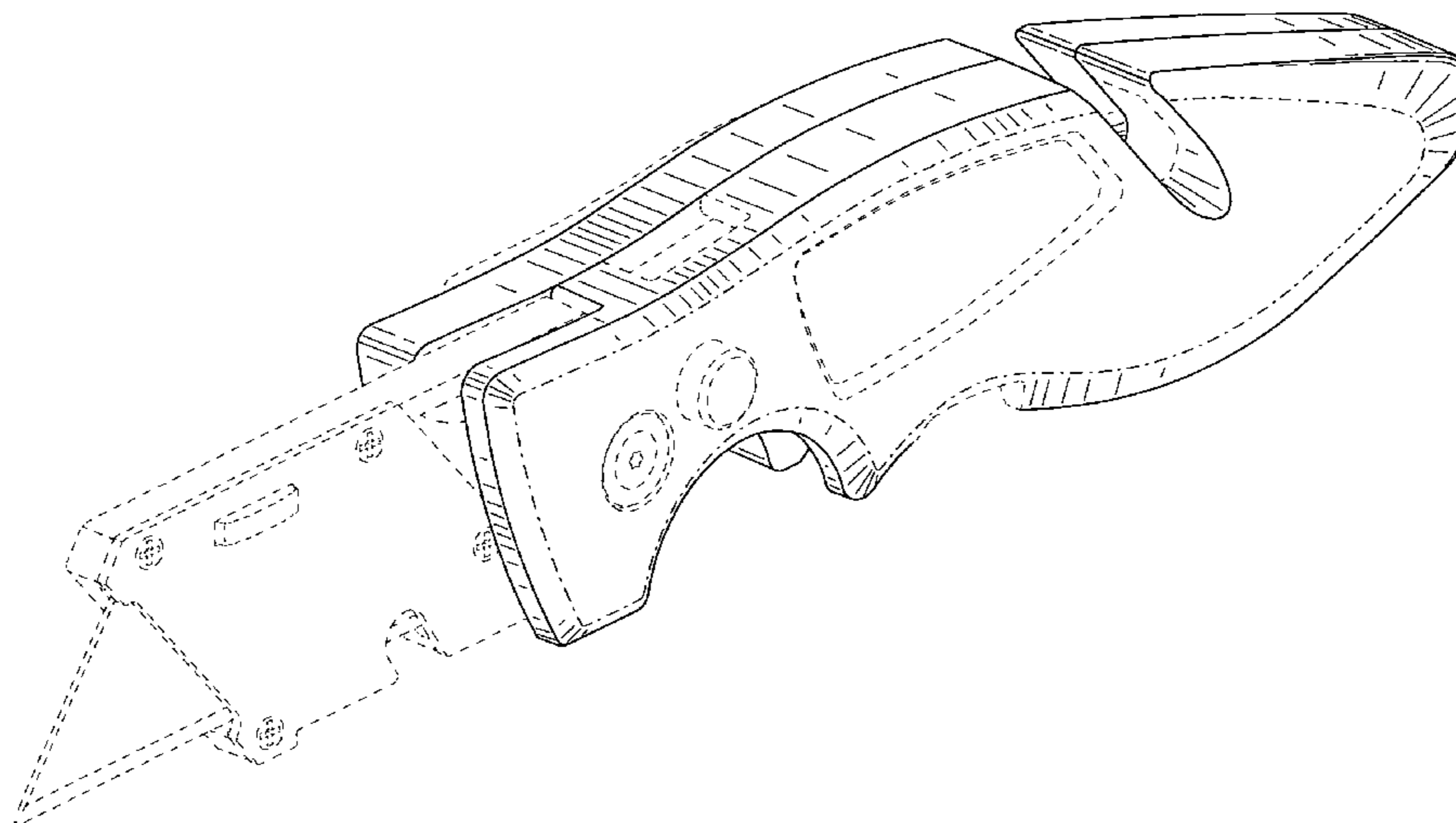

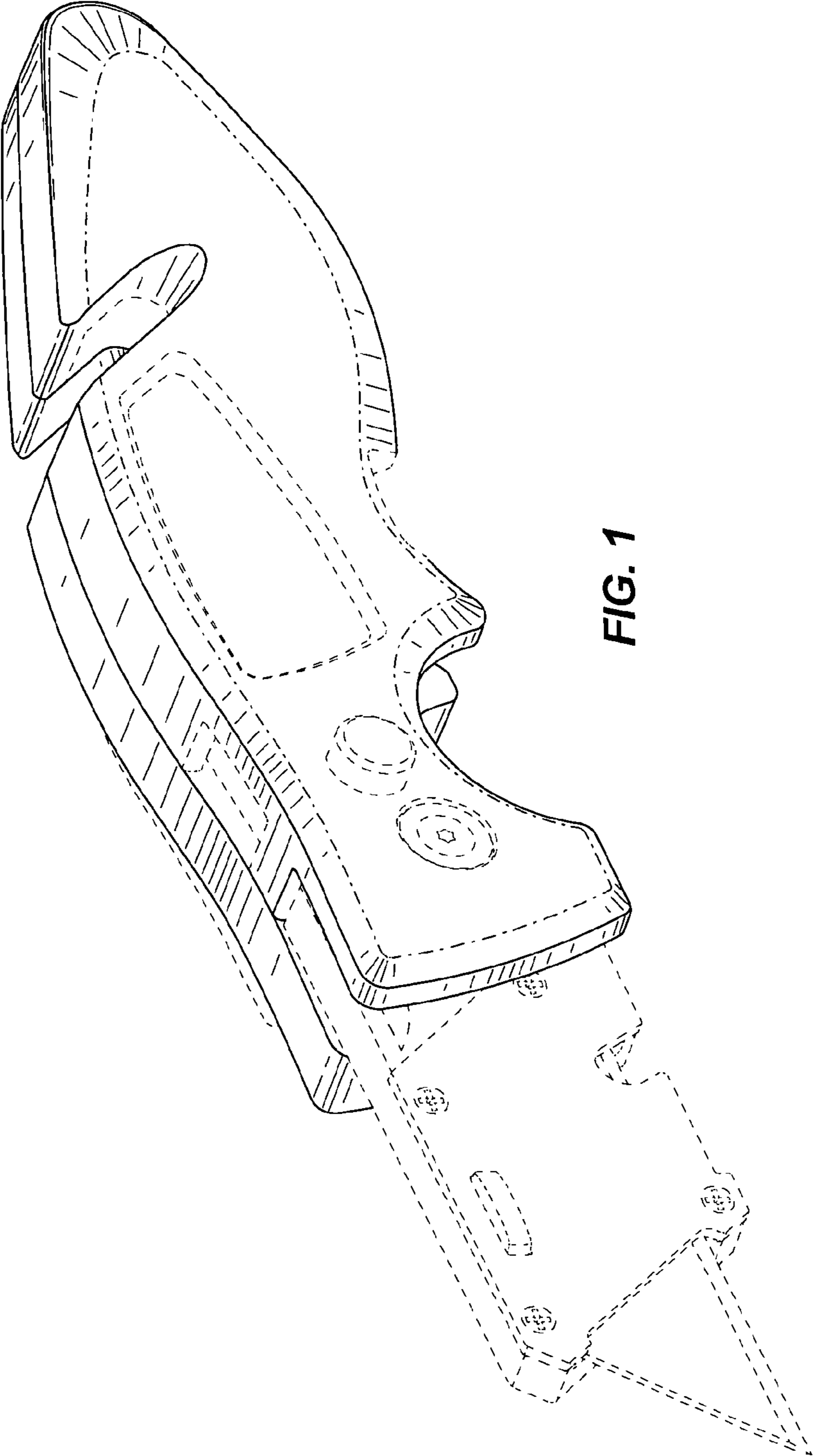

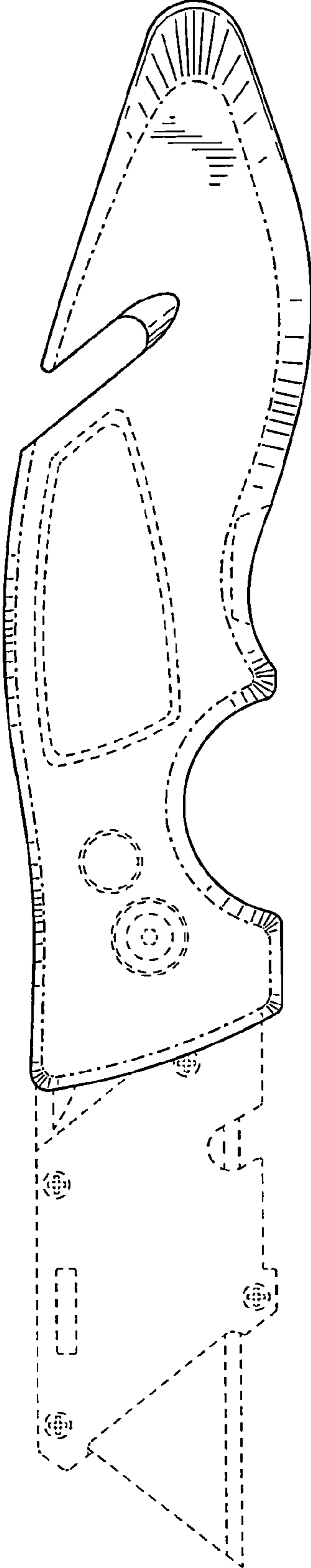

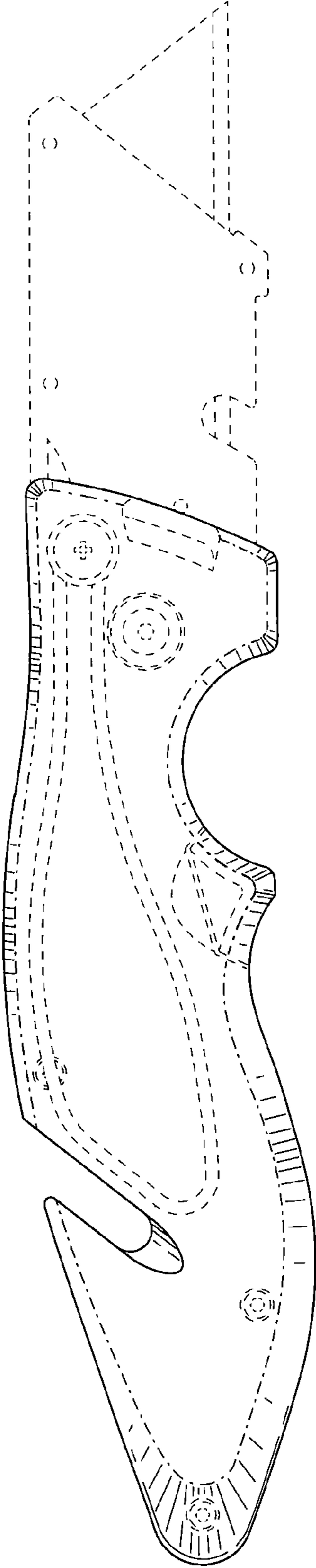

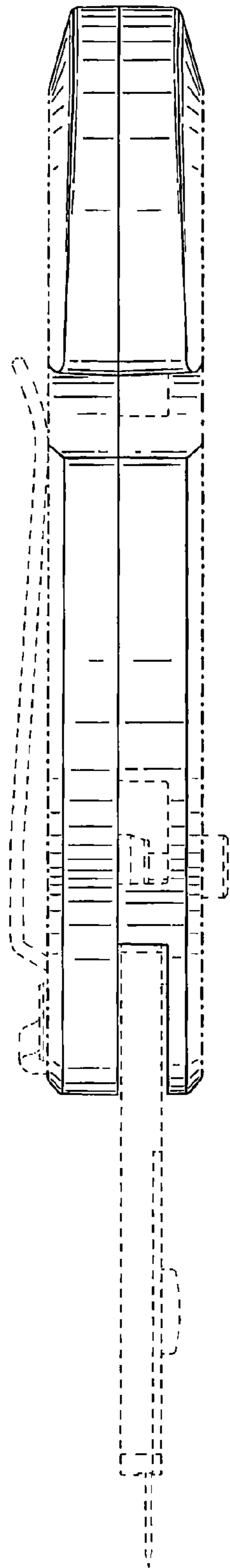

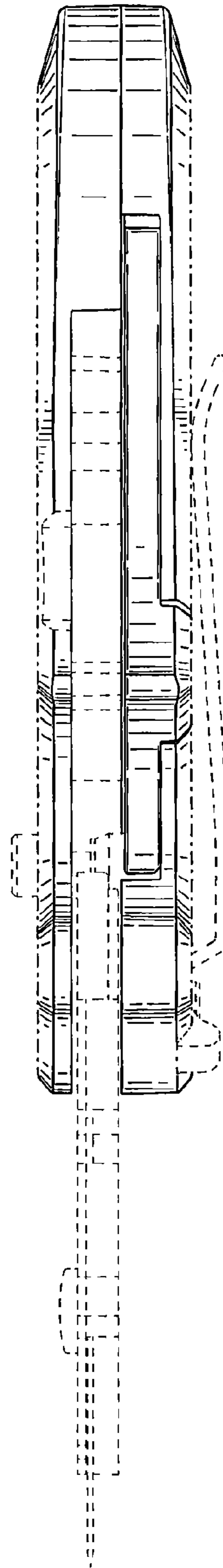

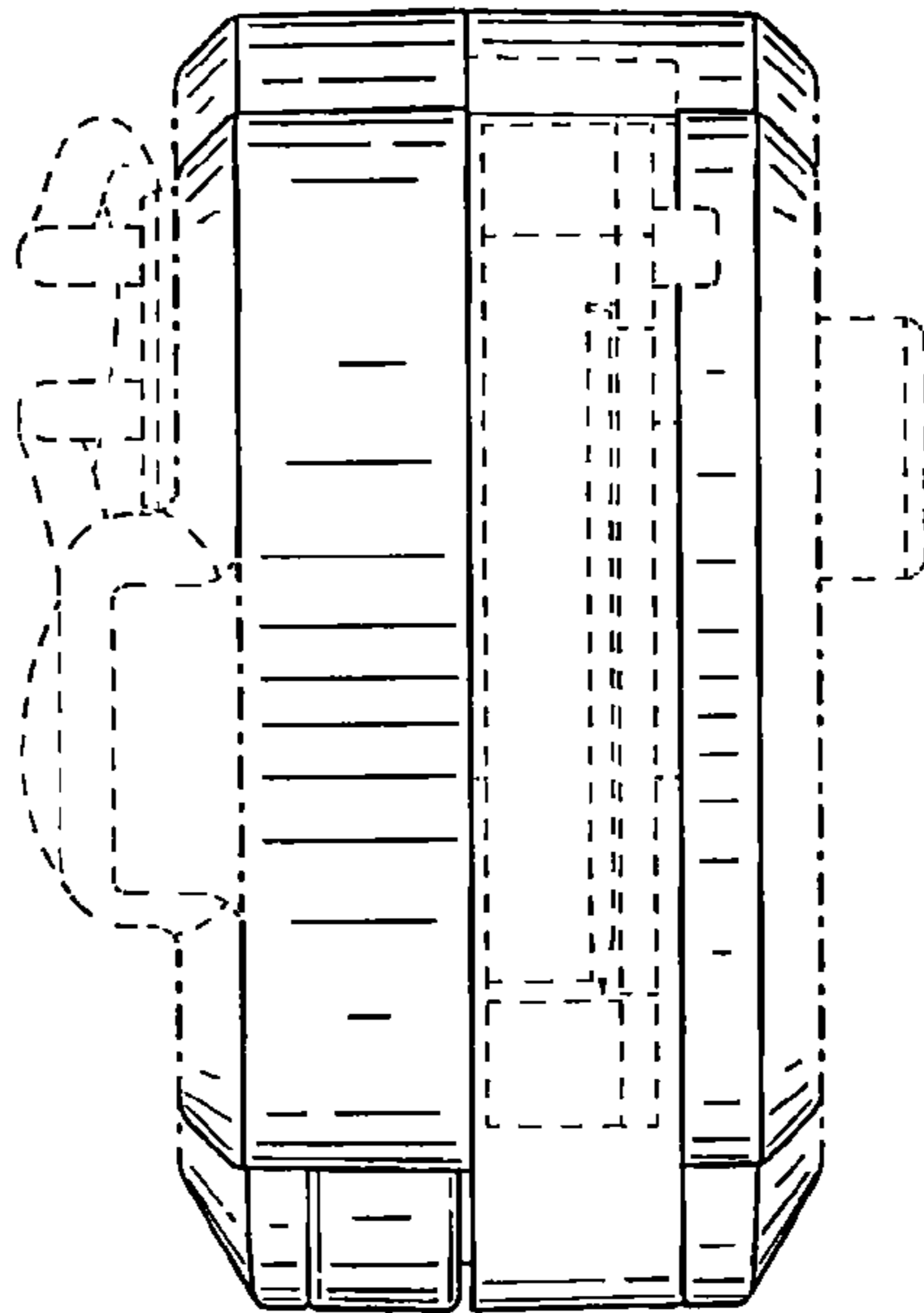

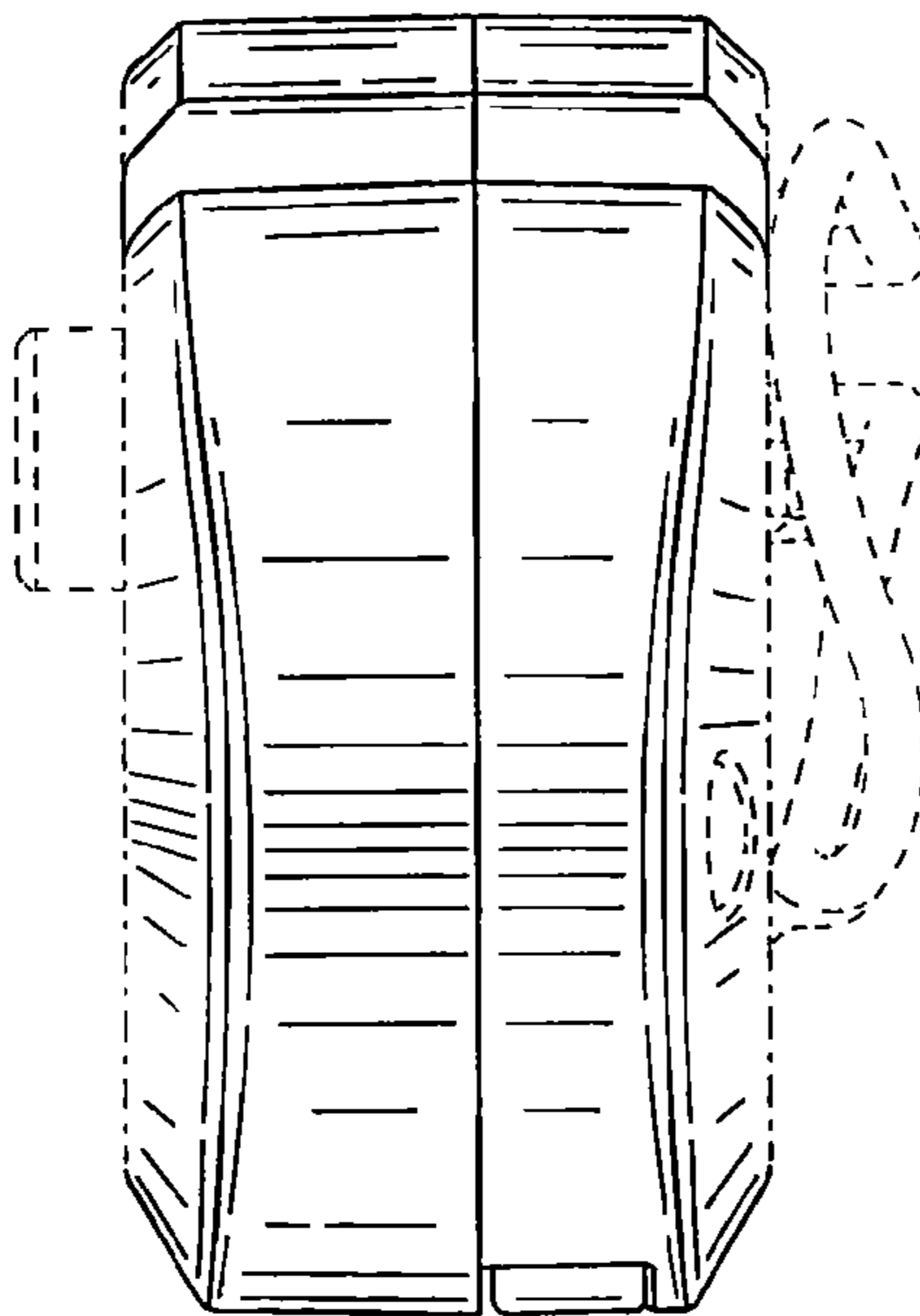
