(57) **CLAIM**

The ornamental design for novelty decoration for backpacks, zippers, or the like, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the front and left side of a novelty decoration for backpacks, zippers, or the like, with the rear and right side perspective being identical, excepting the differences in the broken line disclosure visible in FIG. 3, showing my new design.

FIG. 2 is a front plan view.

FIG. 3 is a back plan view.

FIG. 4 is a top elevation.

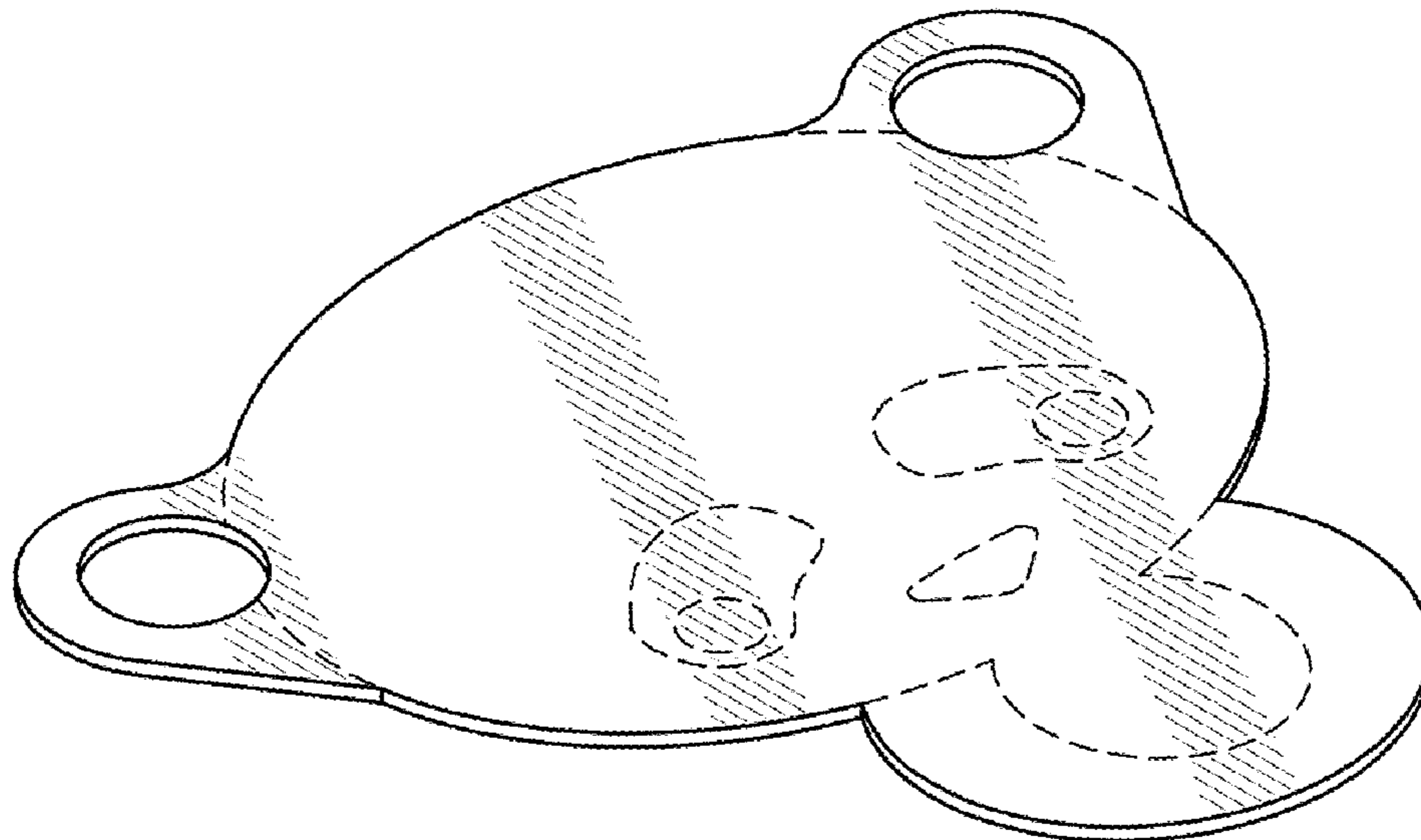
FIG. 5 is a bottom elevation.

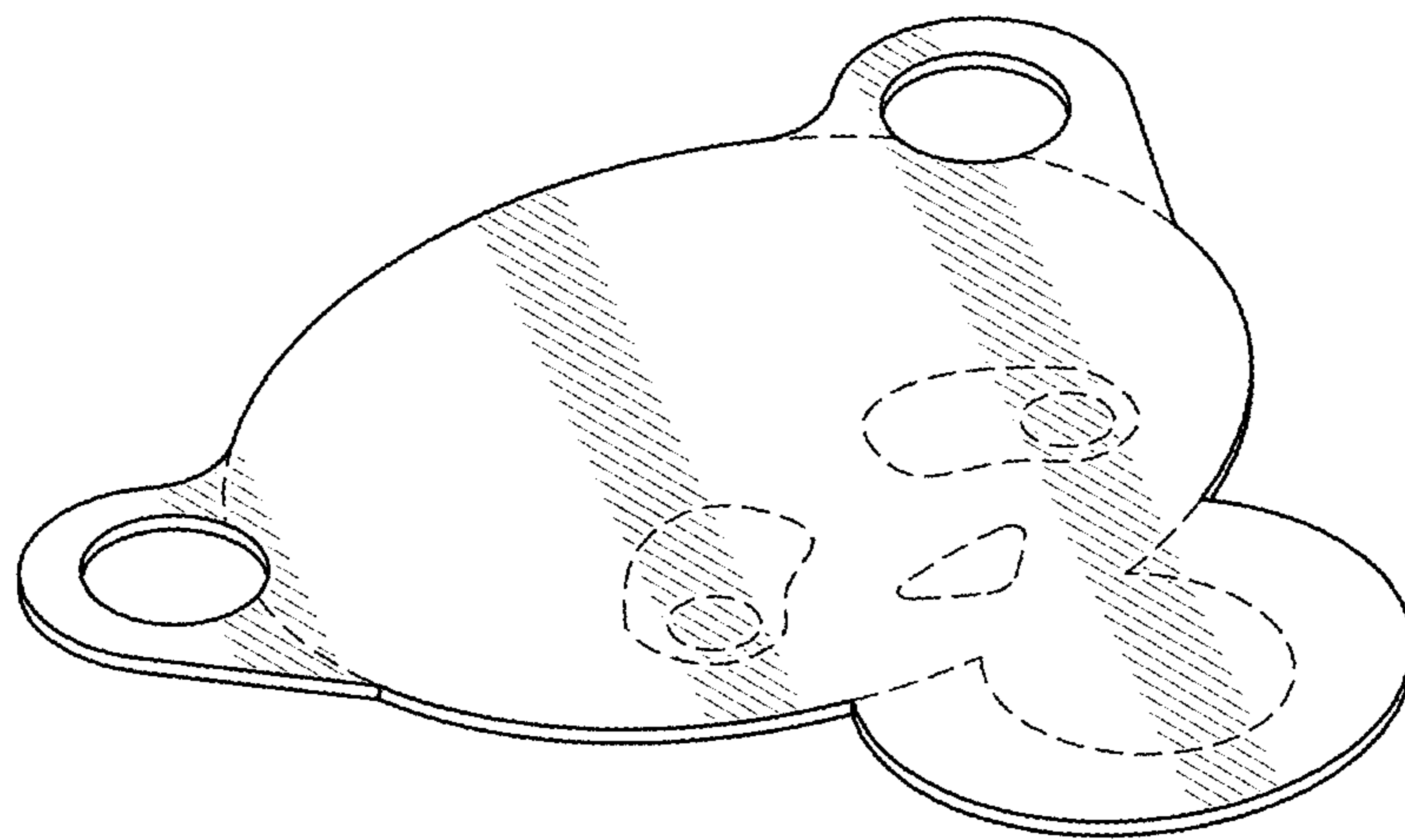

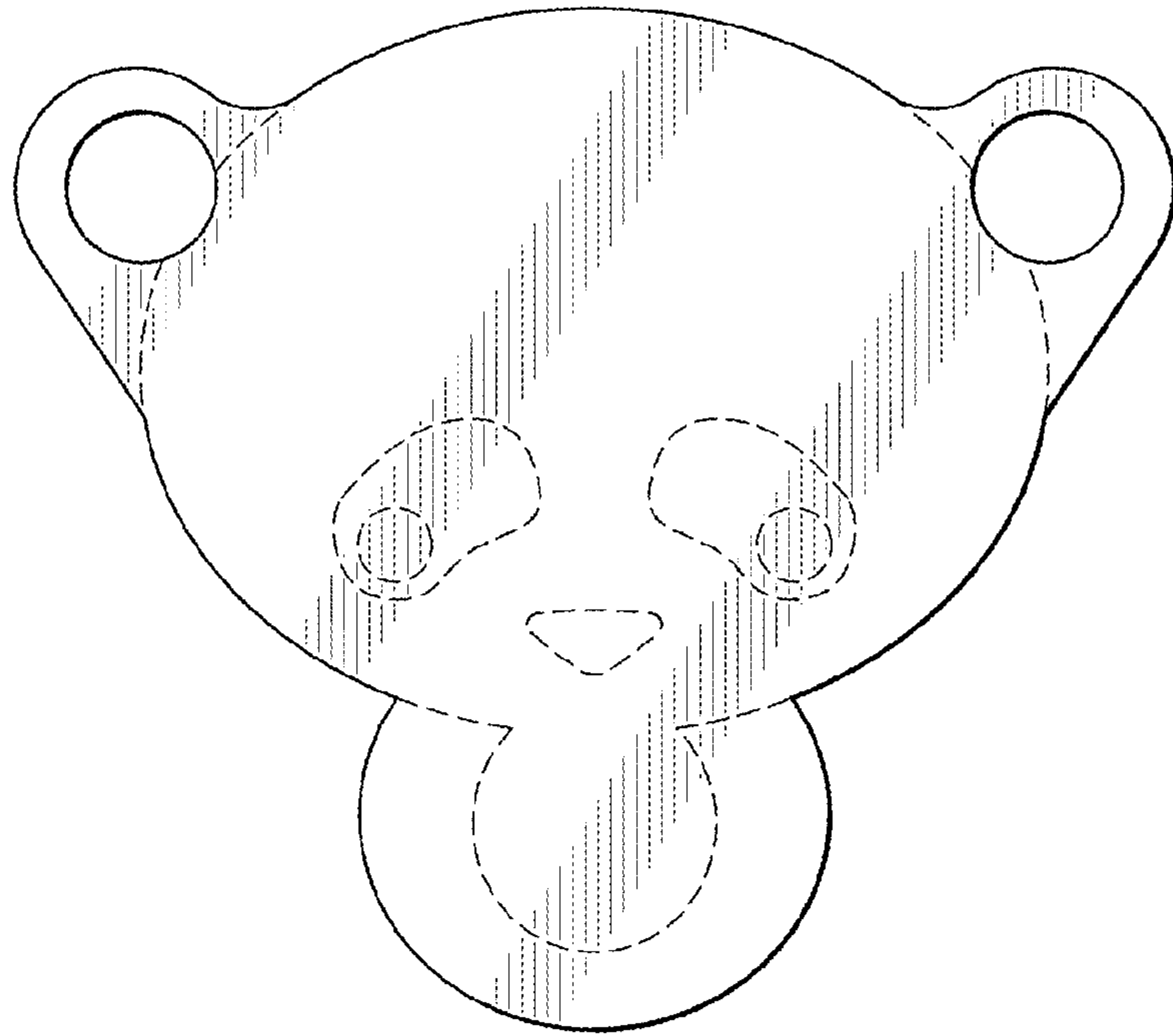

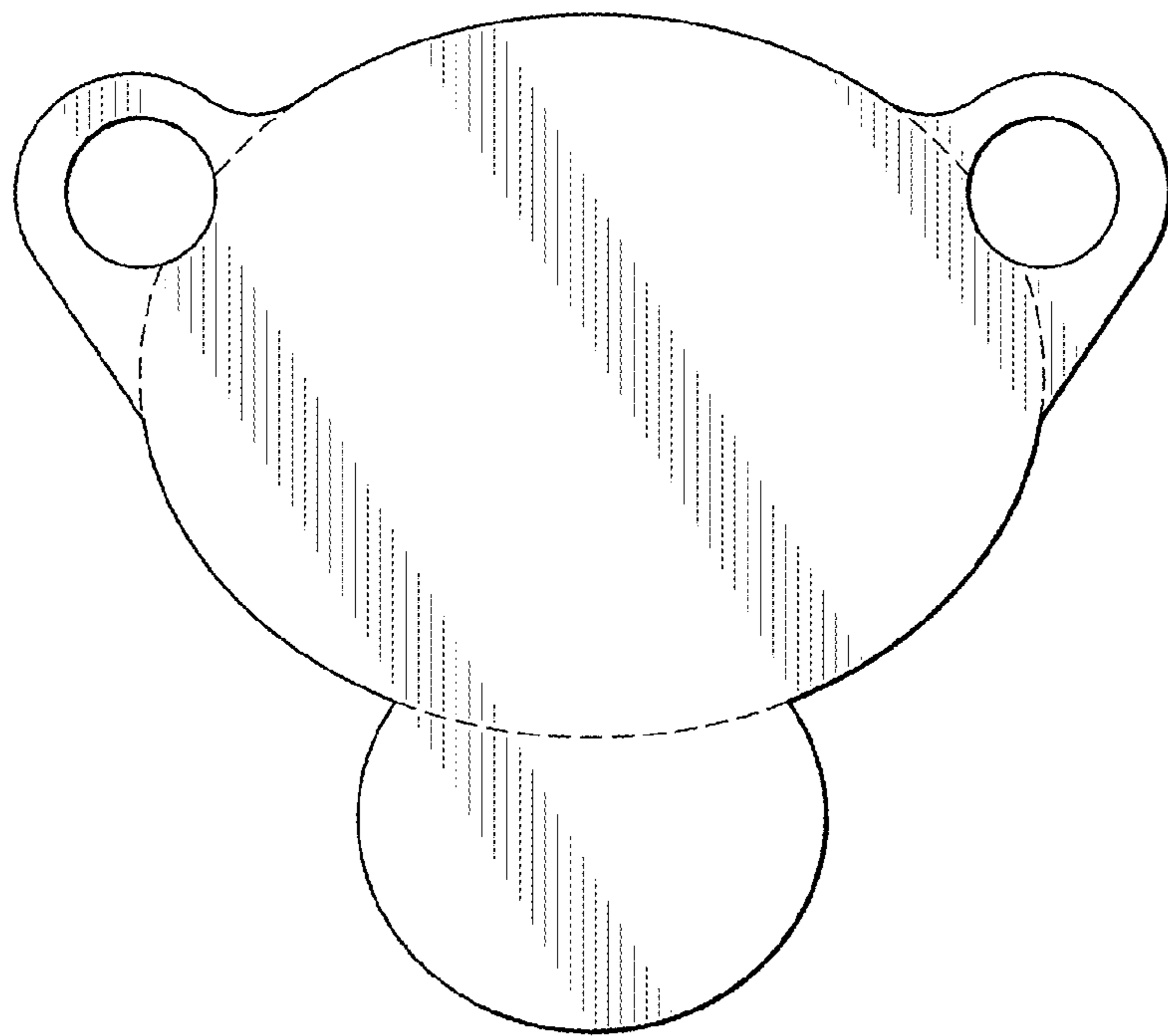

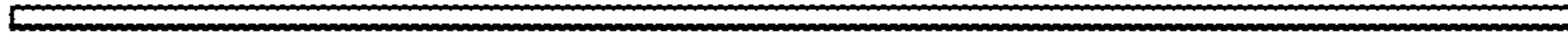

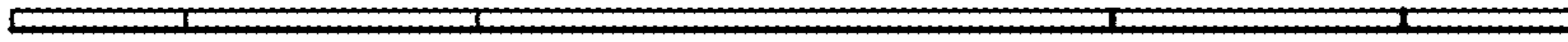

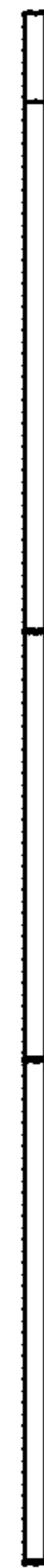
