FIG. 4 illustrates a back view of the telephone of FIG. 1;

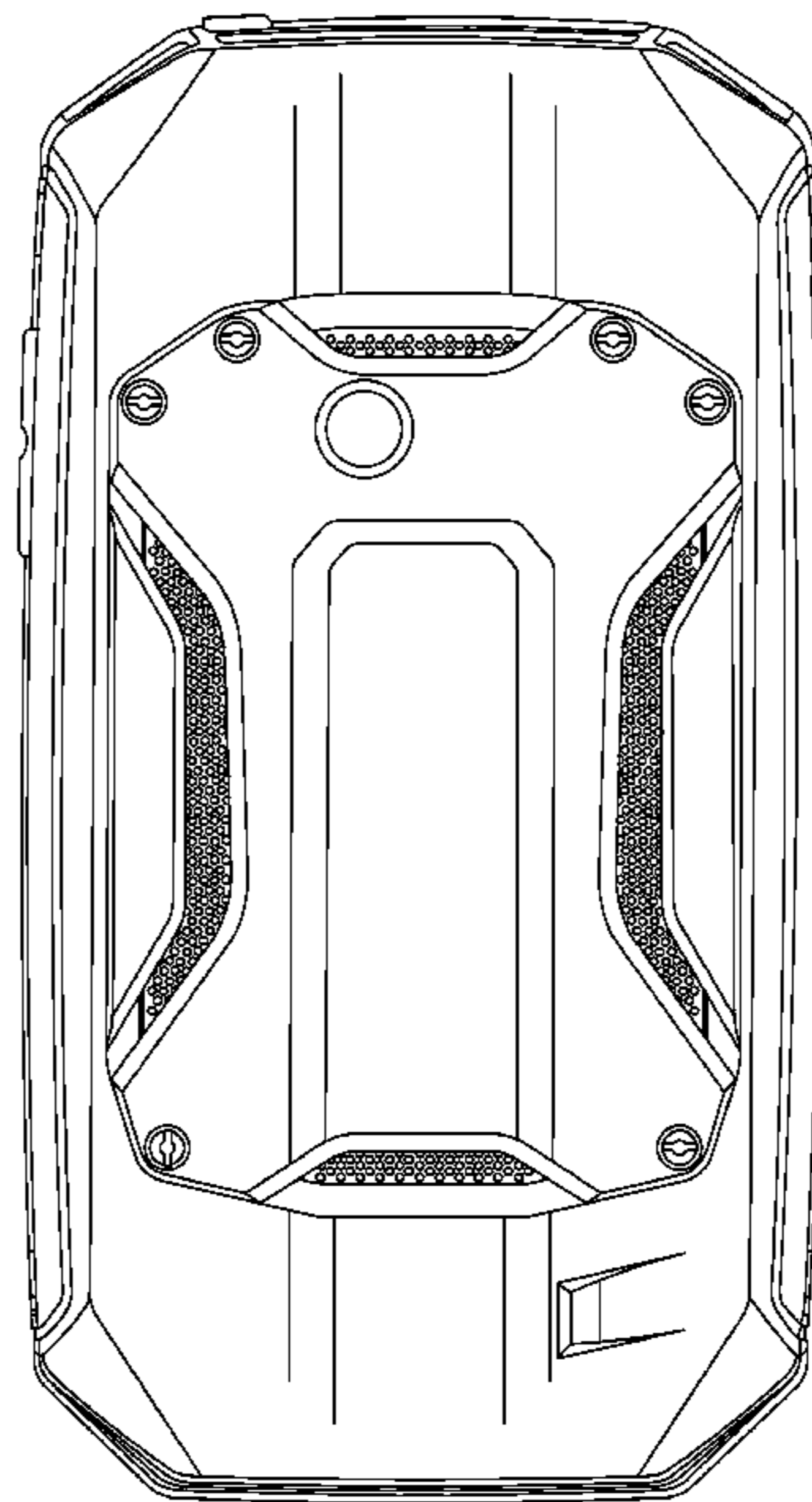
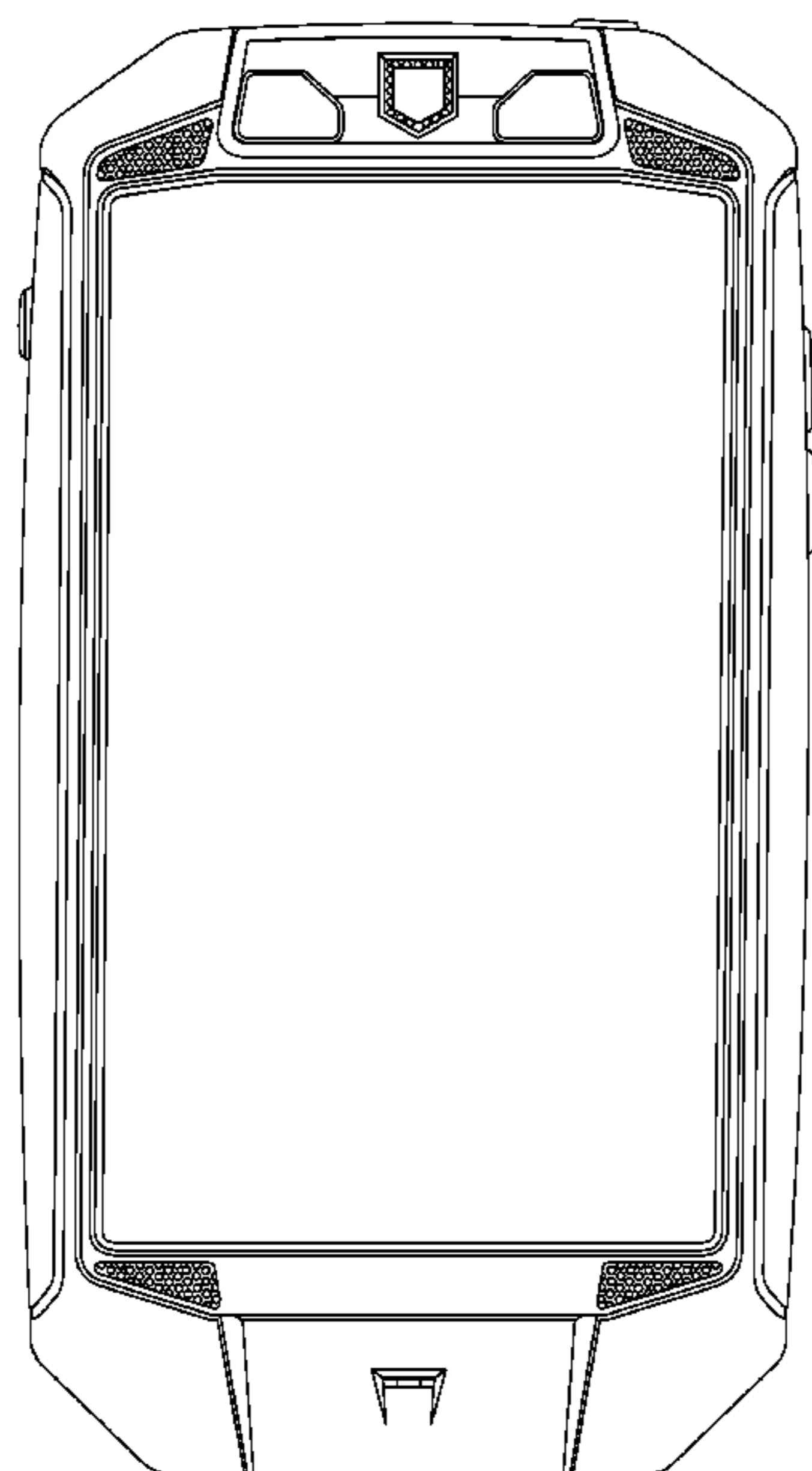
FIG. 5 illustrates a left side view of the telephone of FIG. 1;

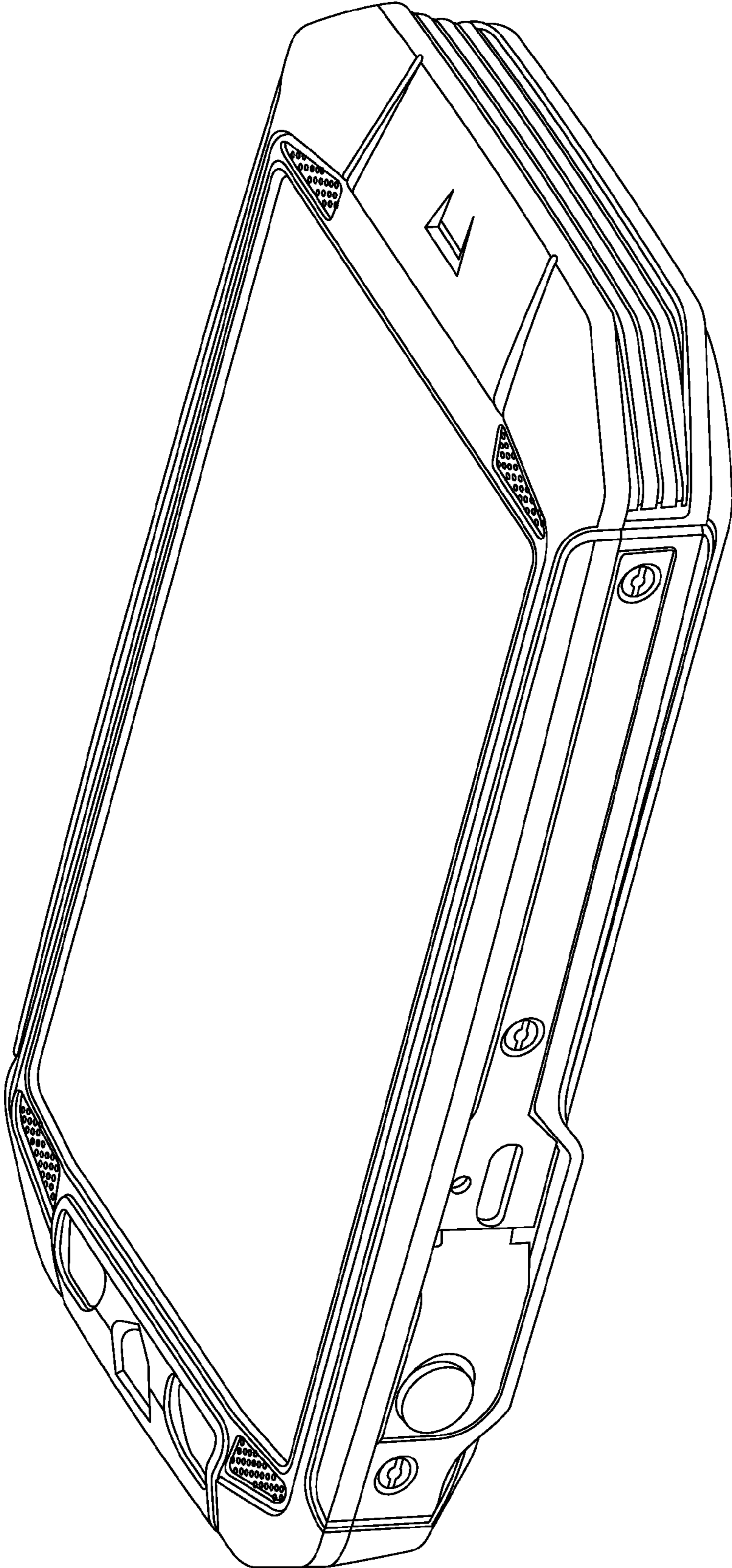

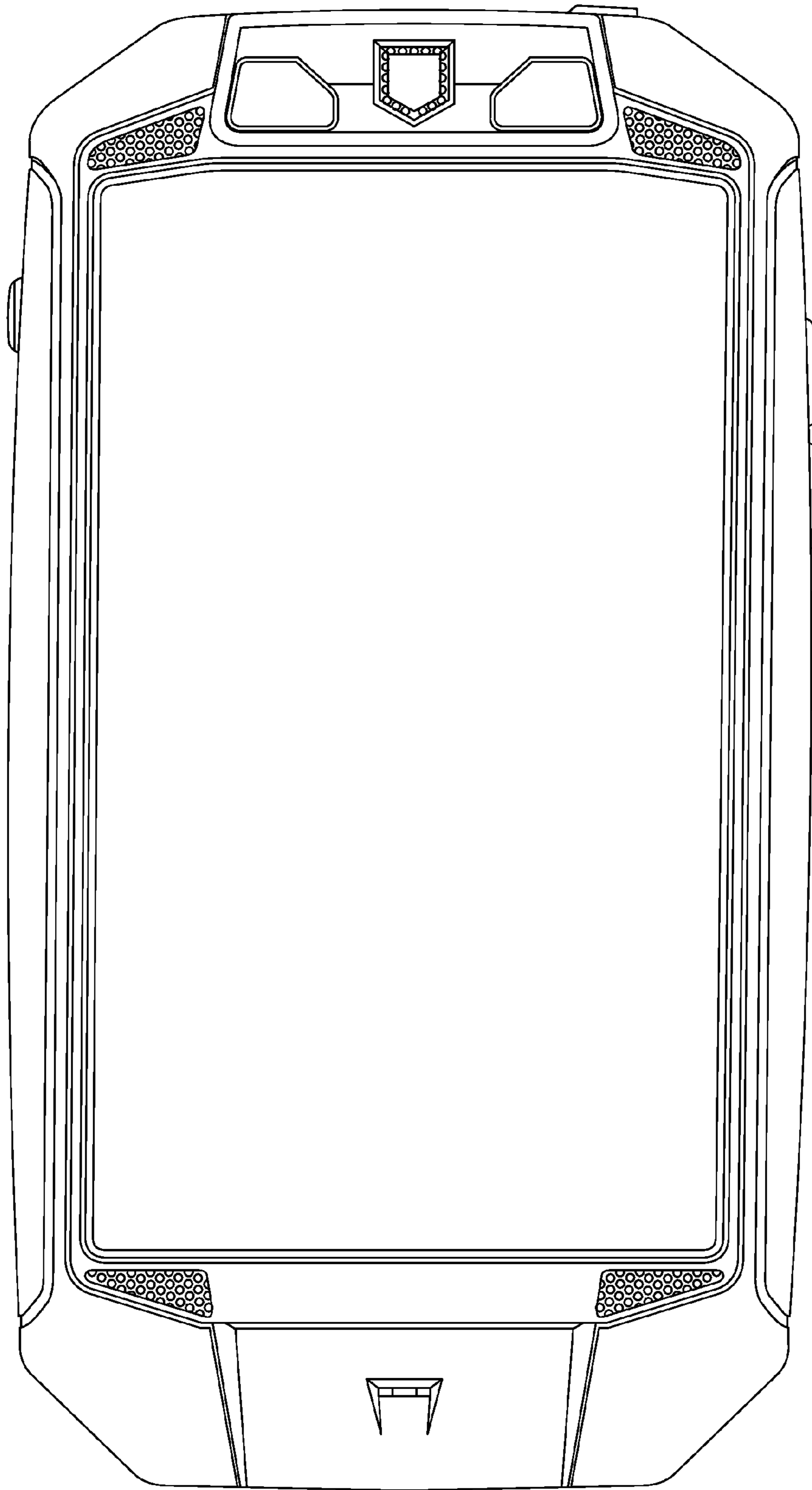

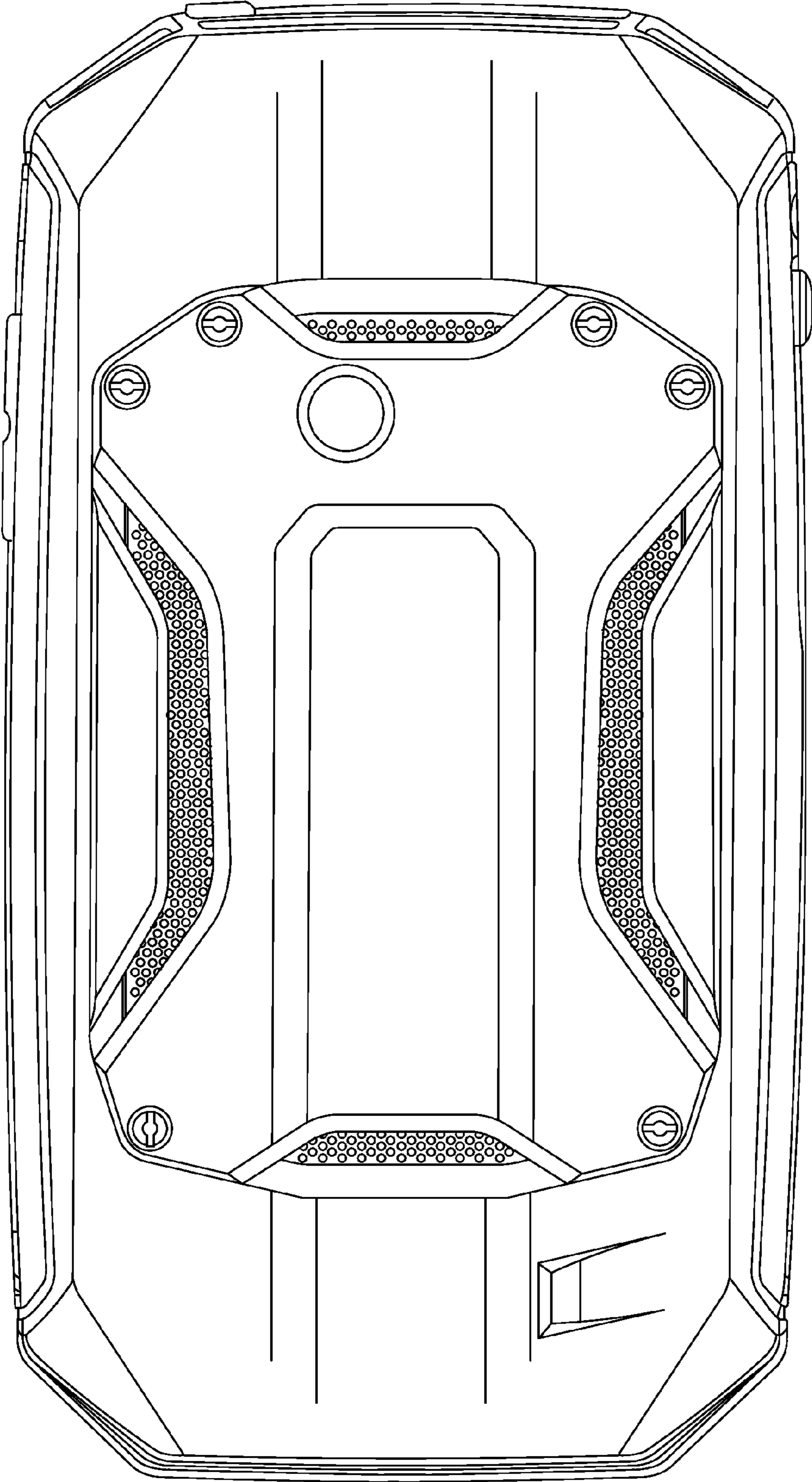

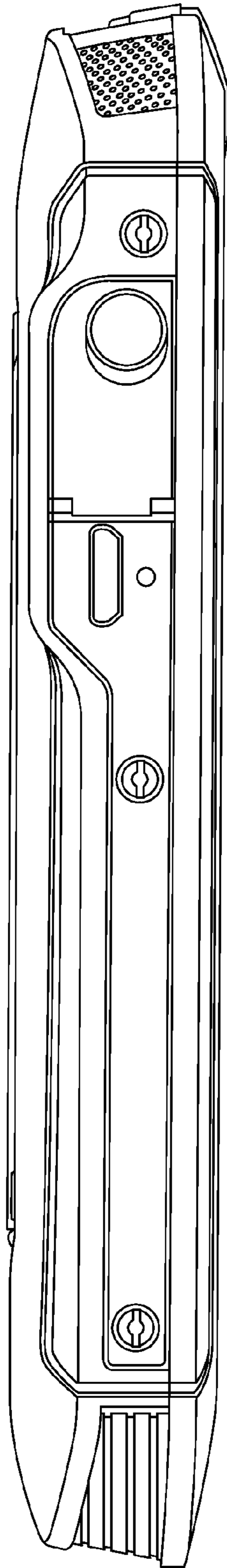

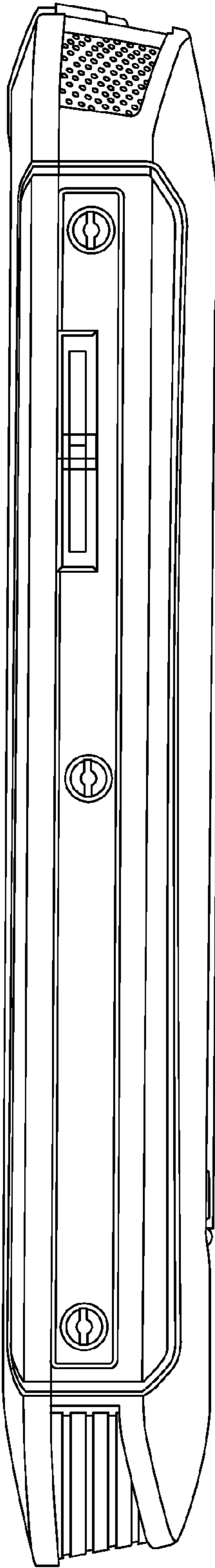

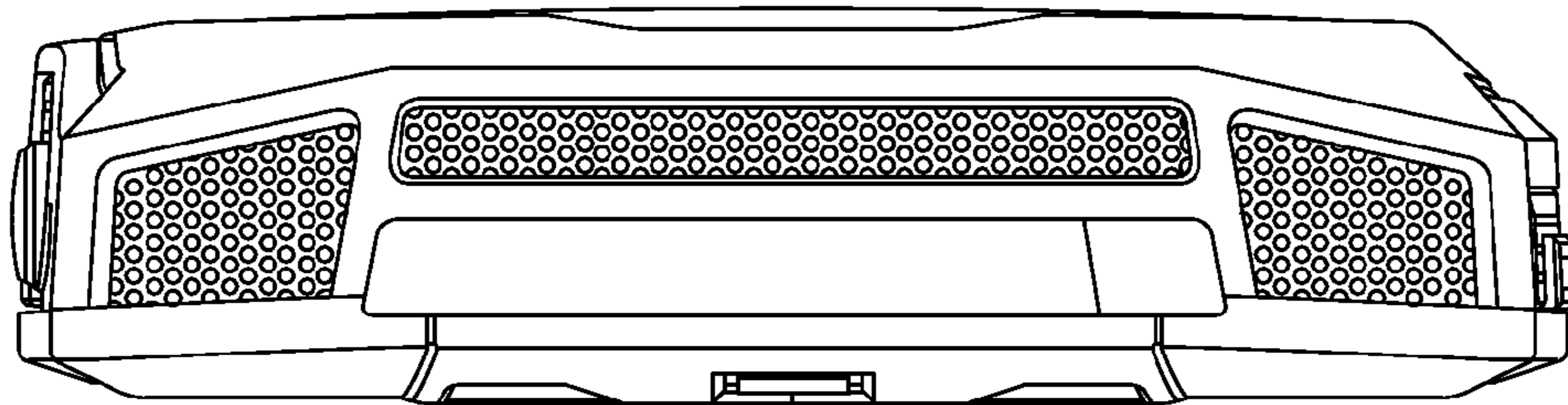

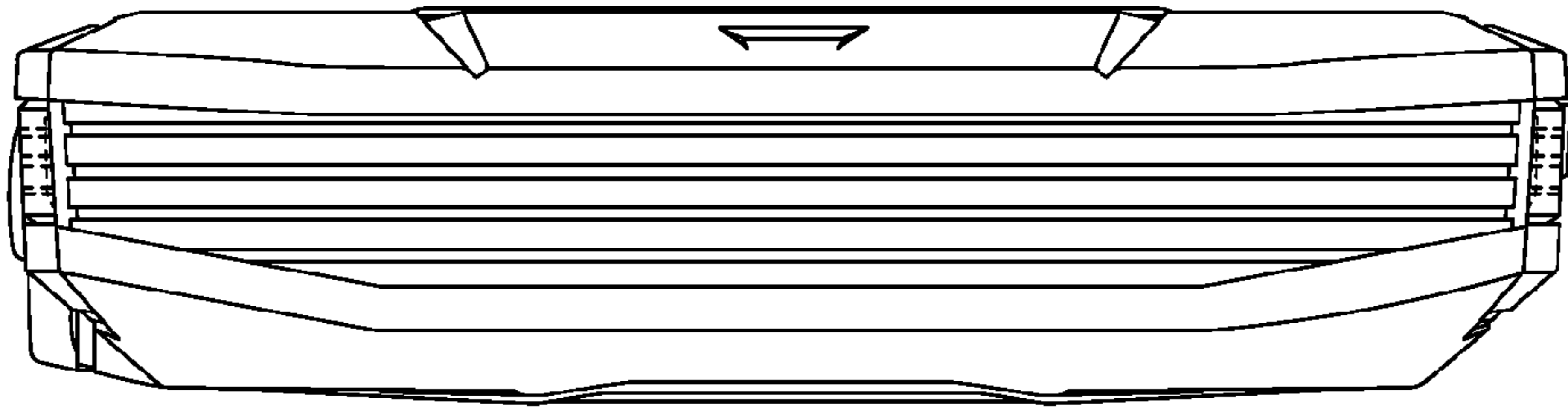

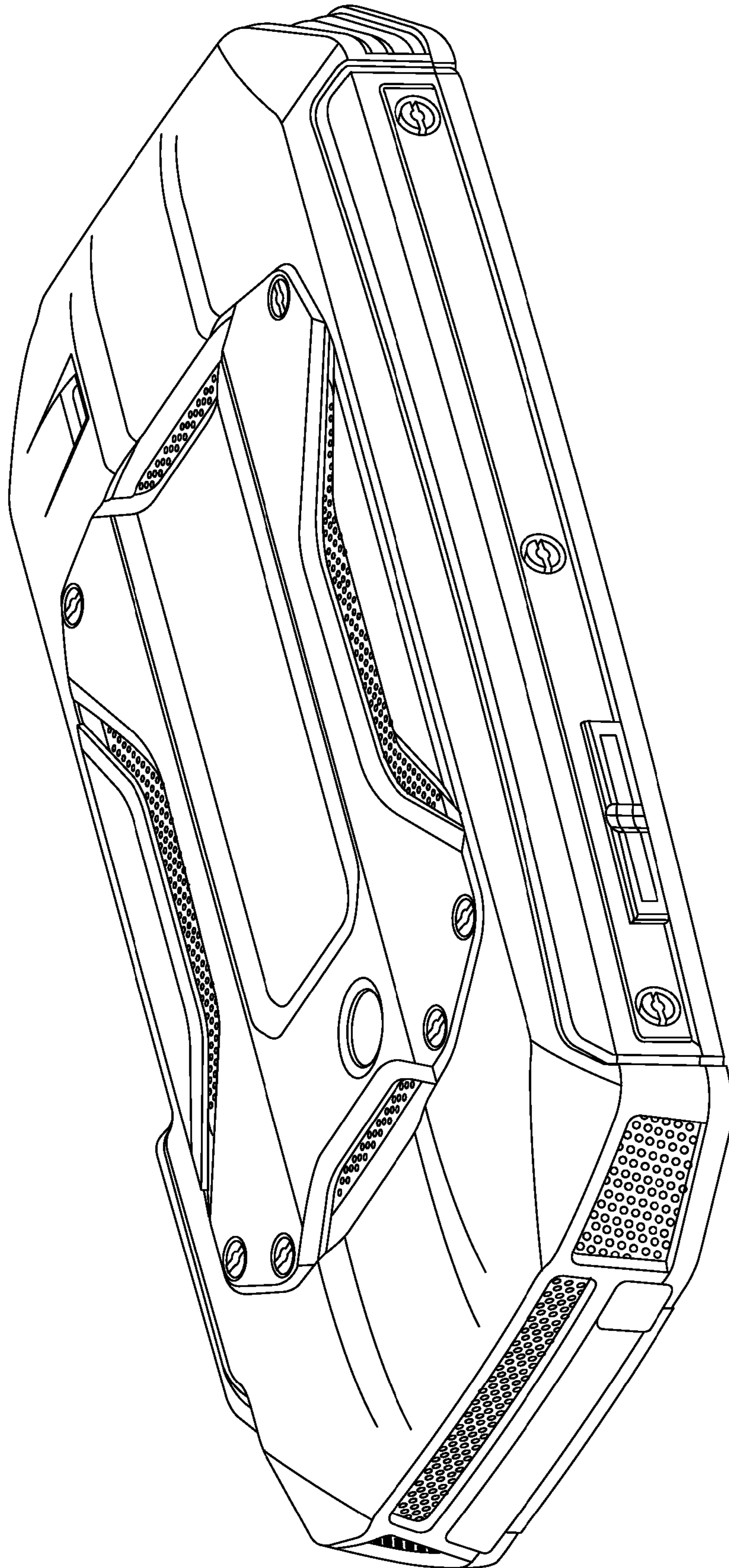
