FIG. 13 is a bottom plan view of the right-hand hand sign of FIG. 8; and,
FIG. 14 is a perspective view from below the rear of the left side of the right-hand hand sign of FIG. 8.

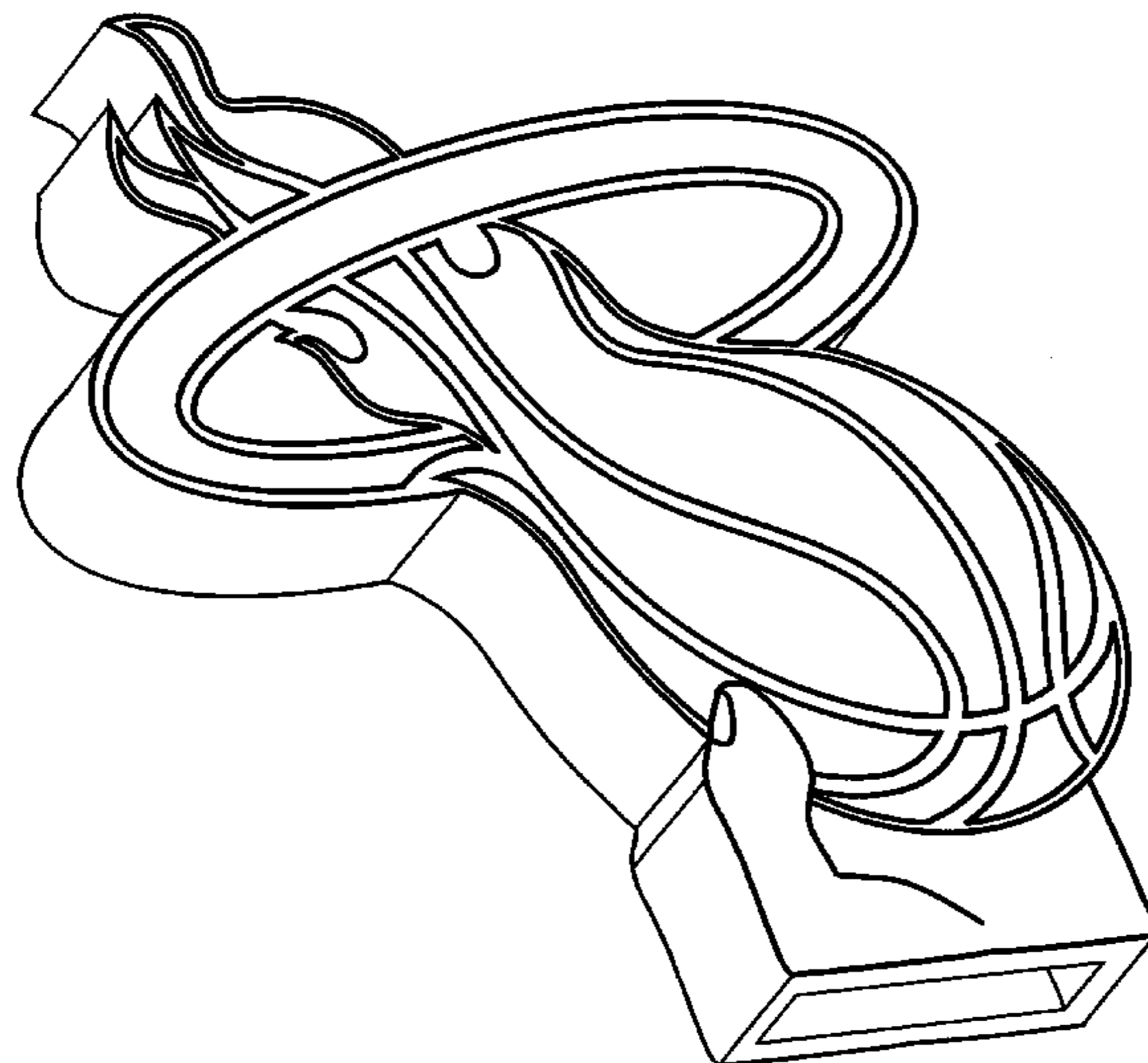

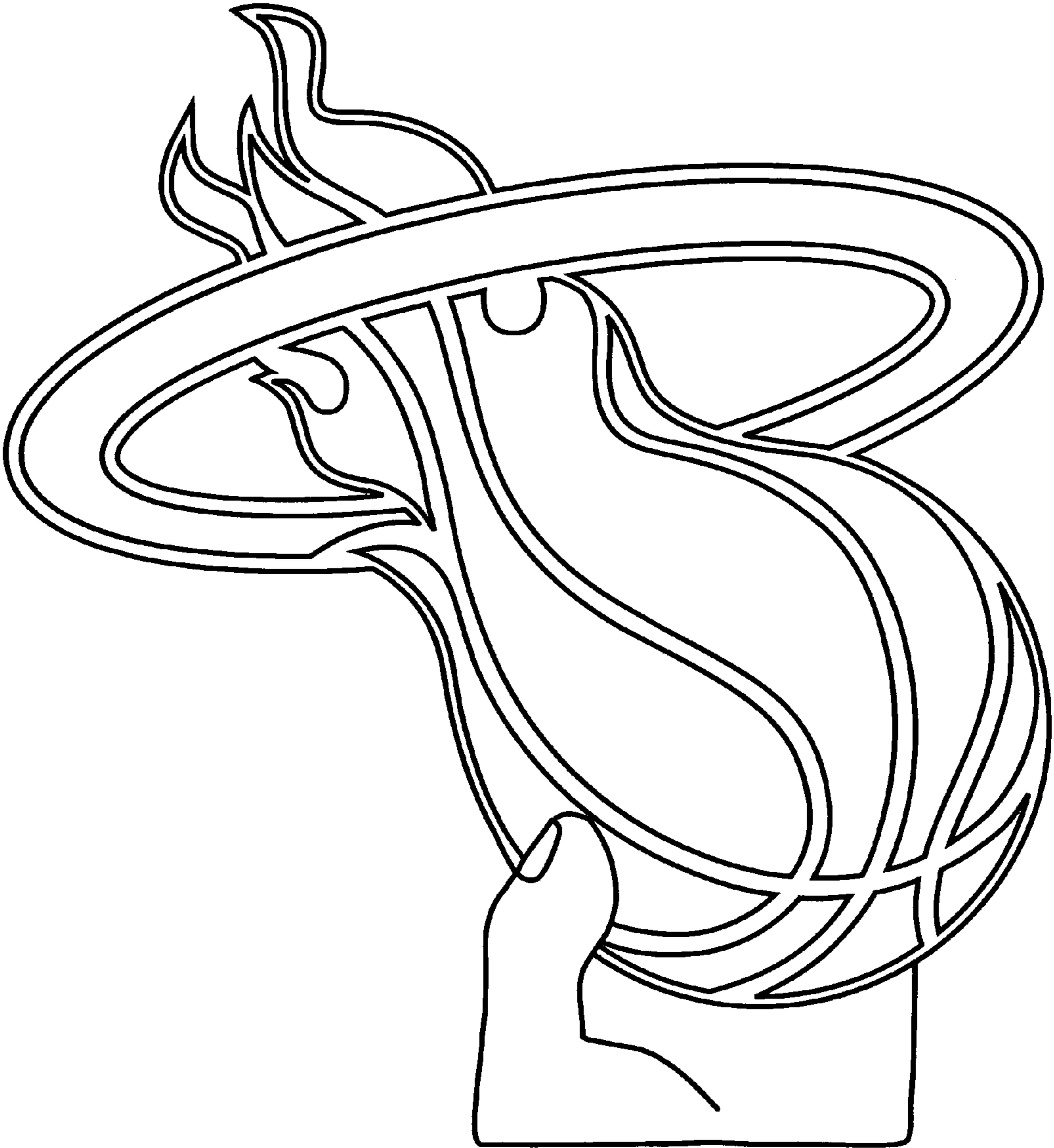

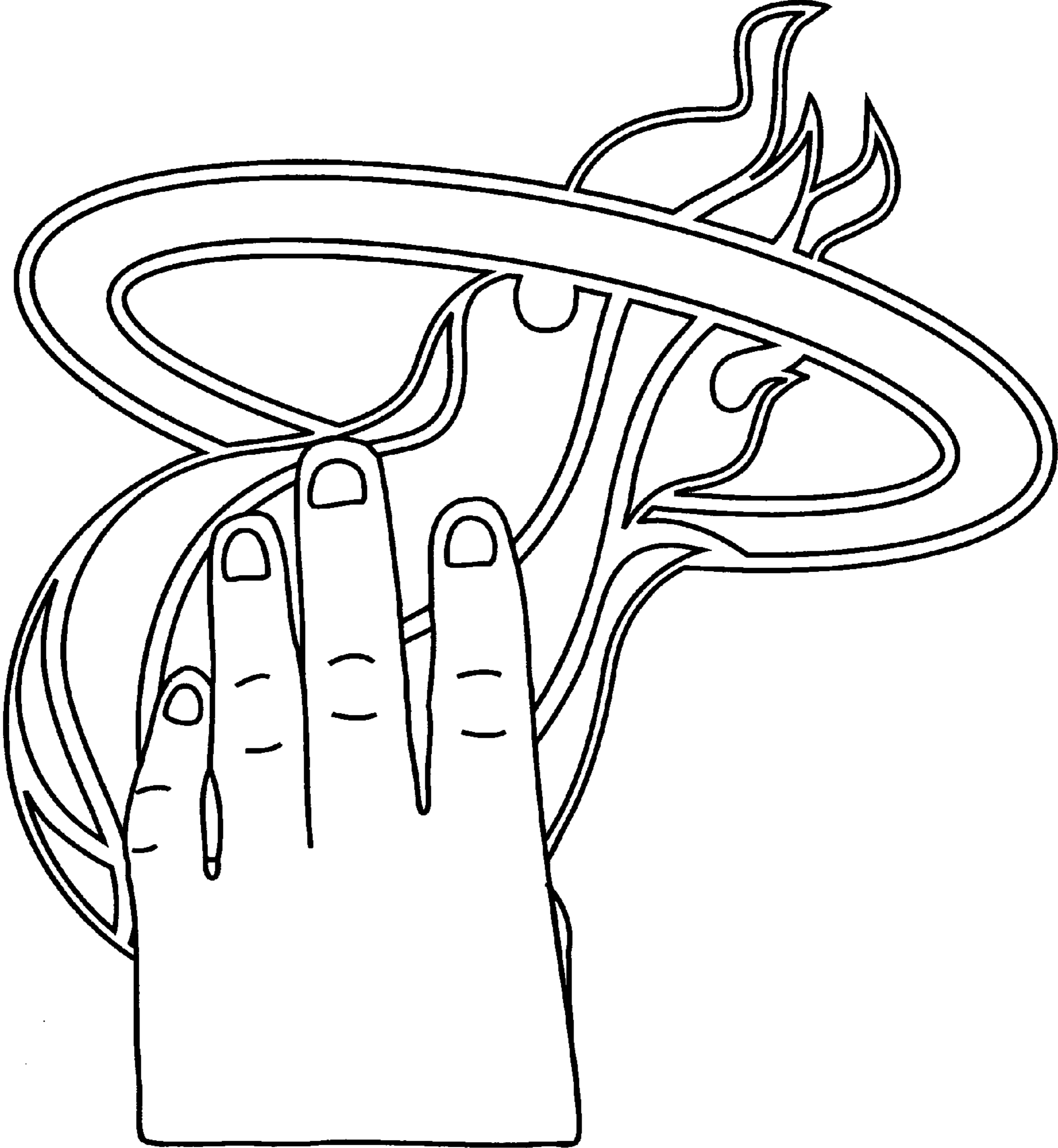

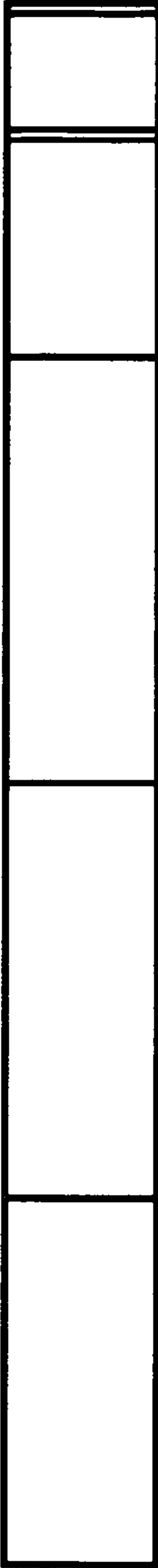

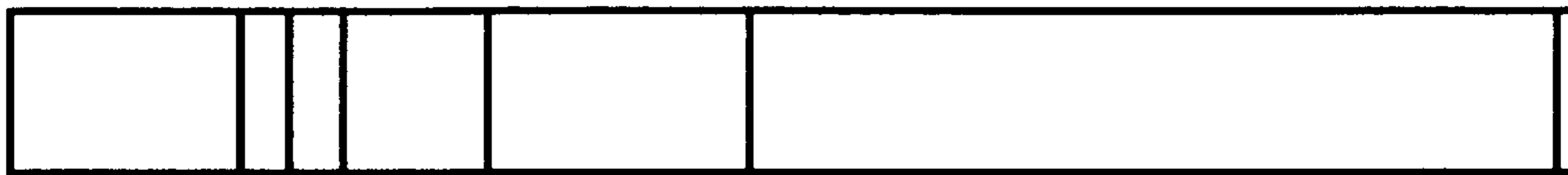

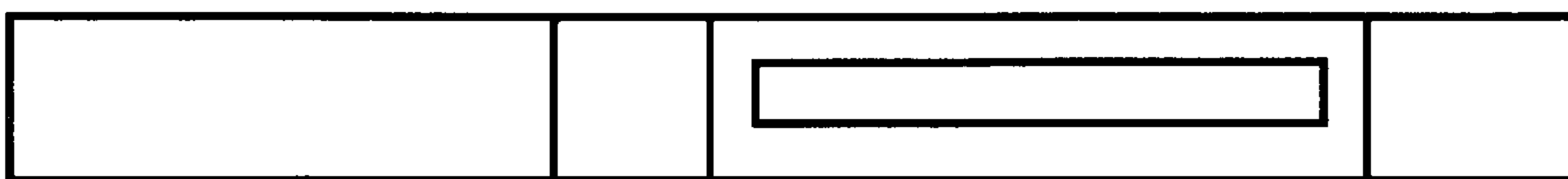

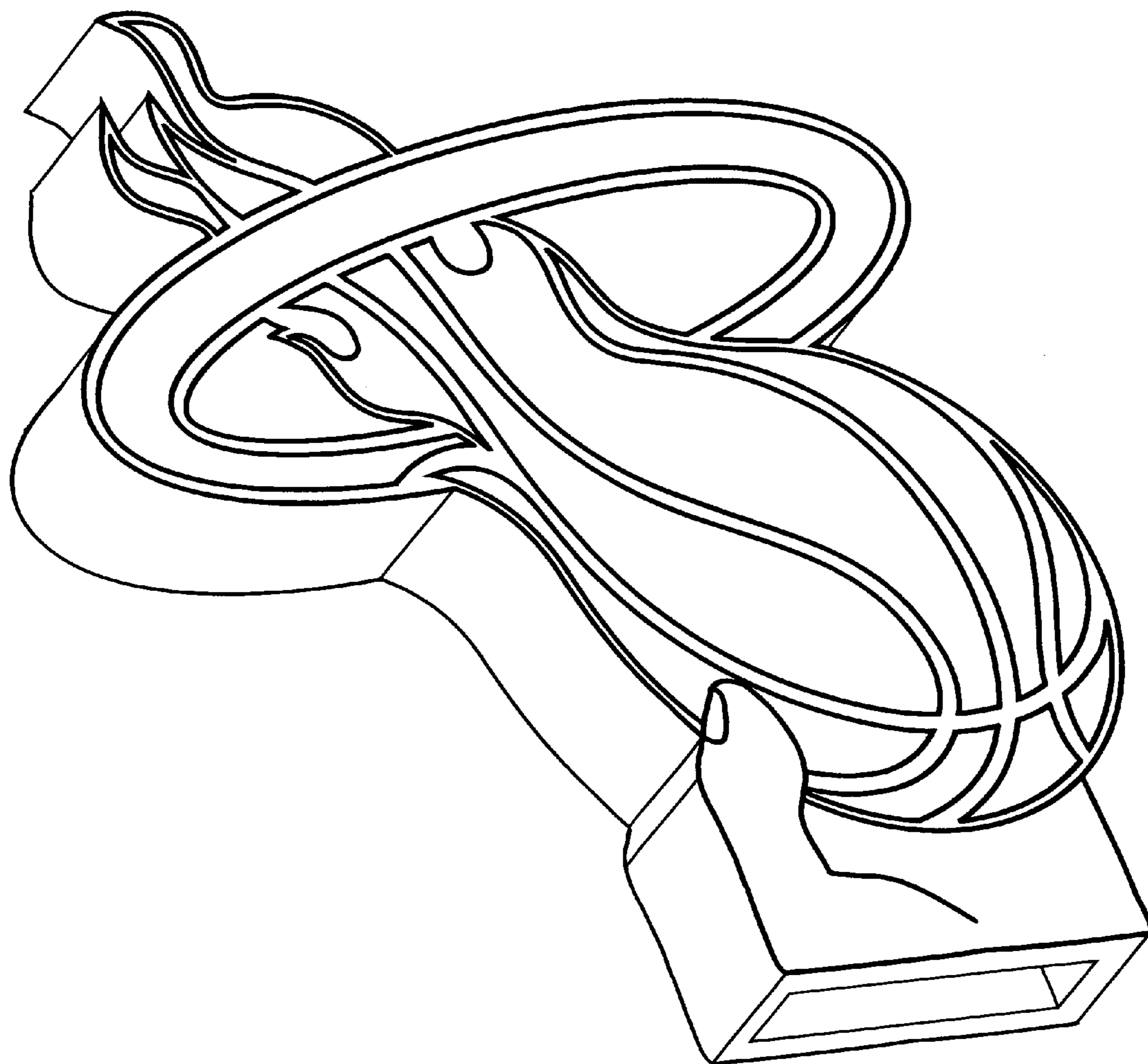

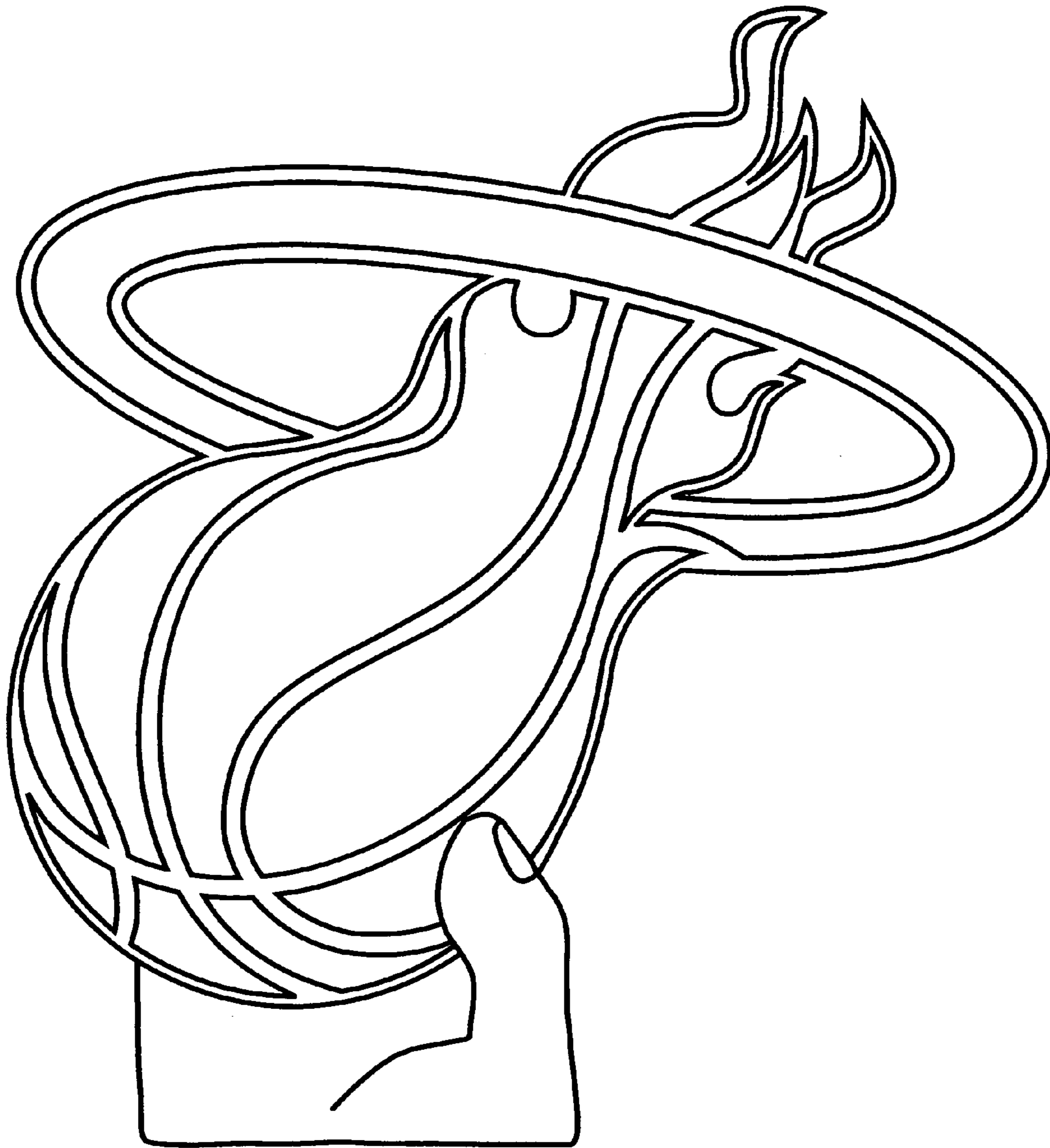

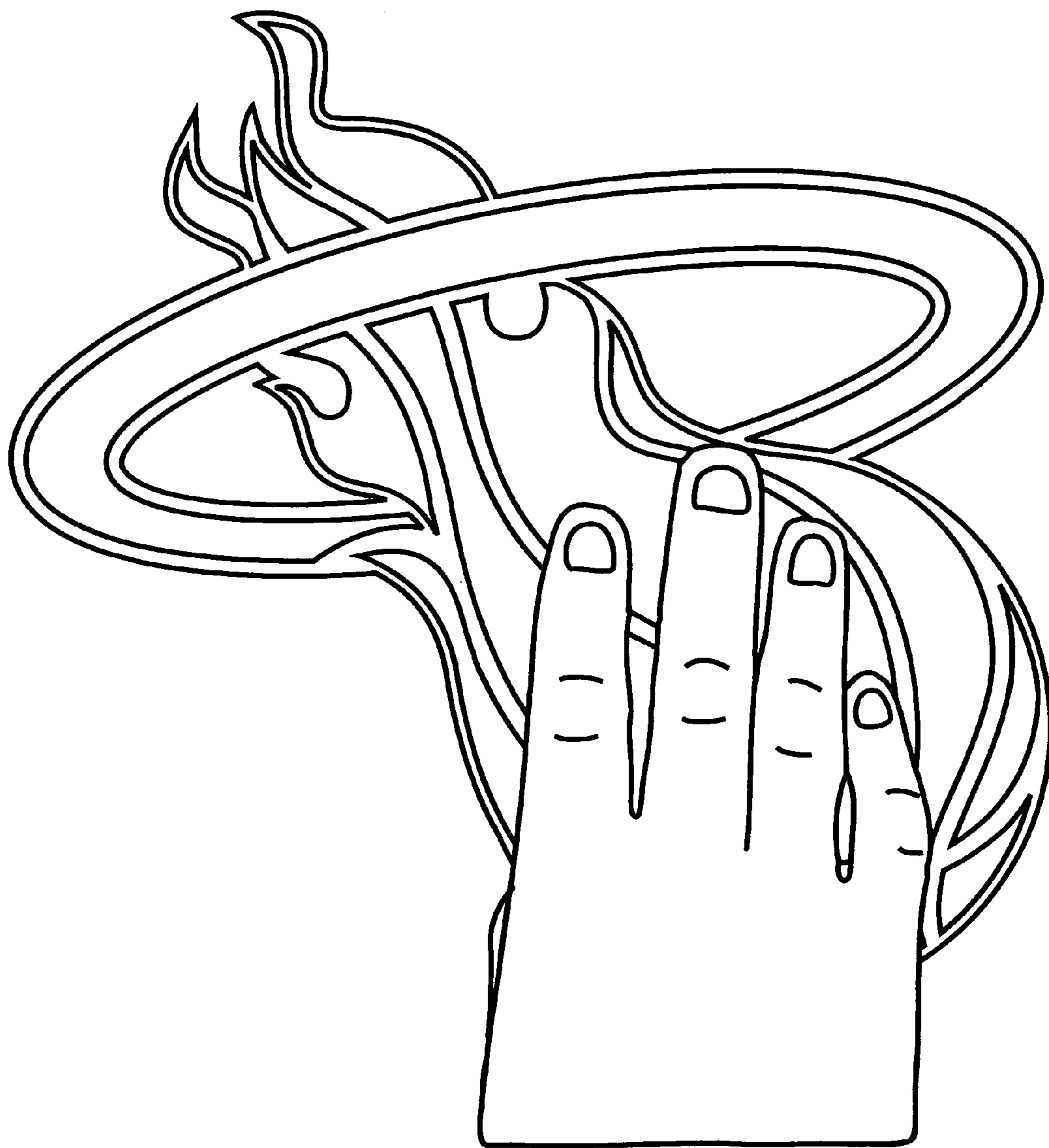

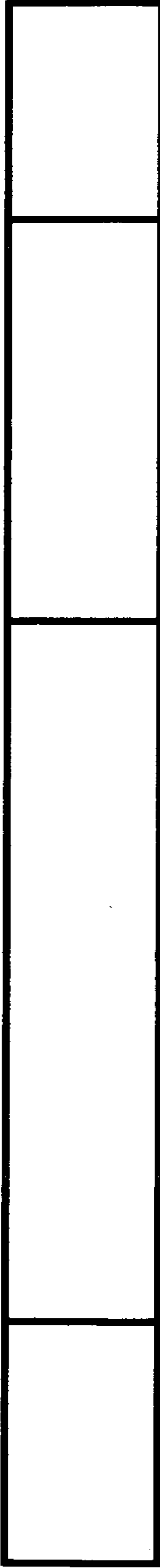

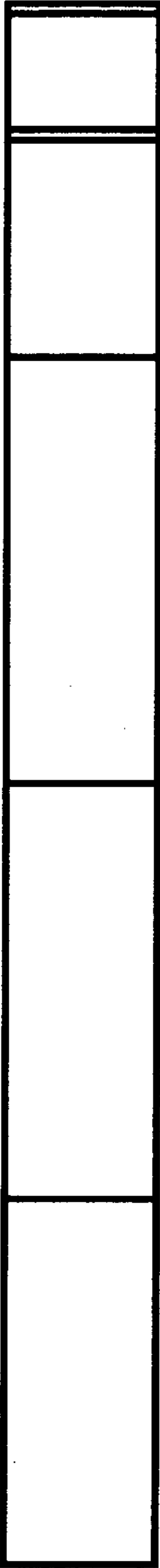

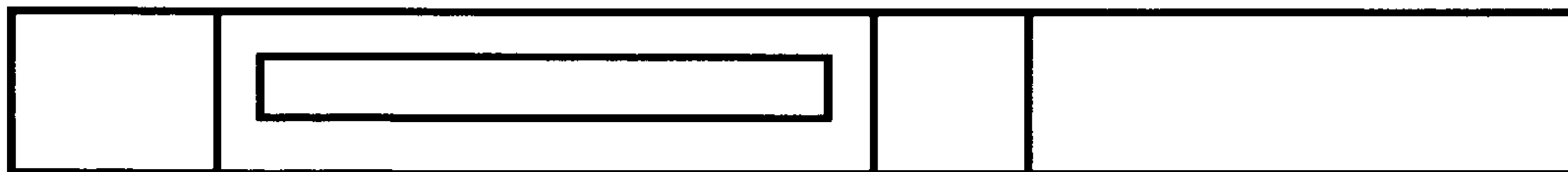

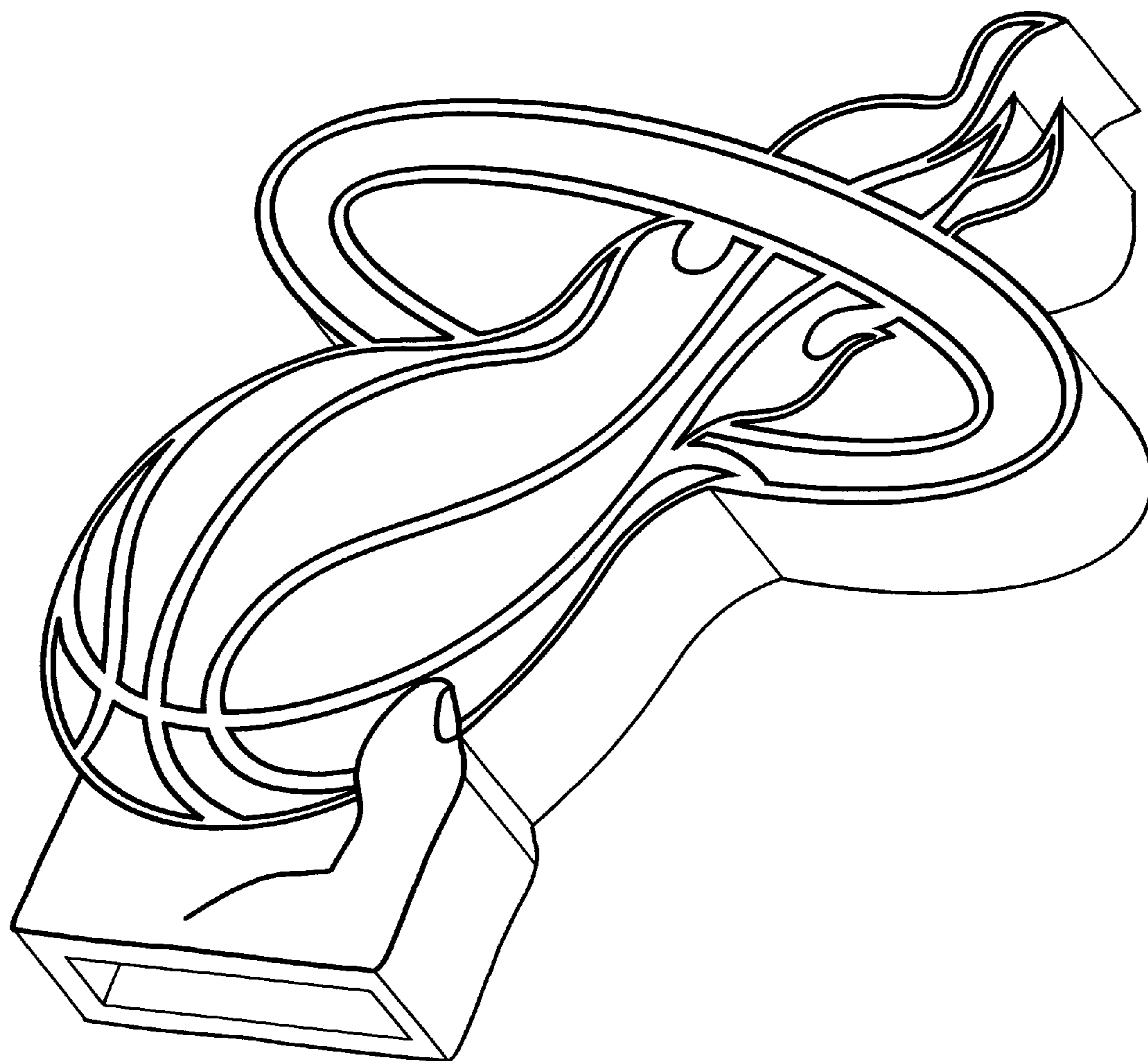
