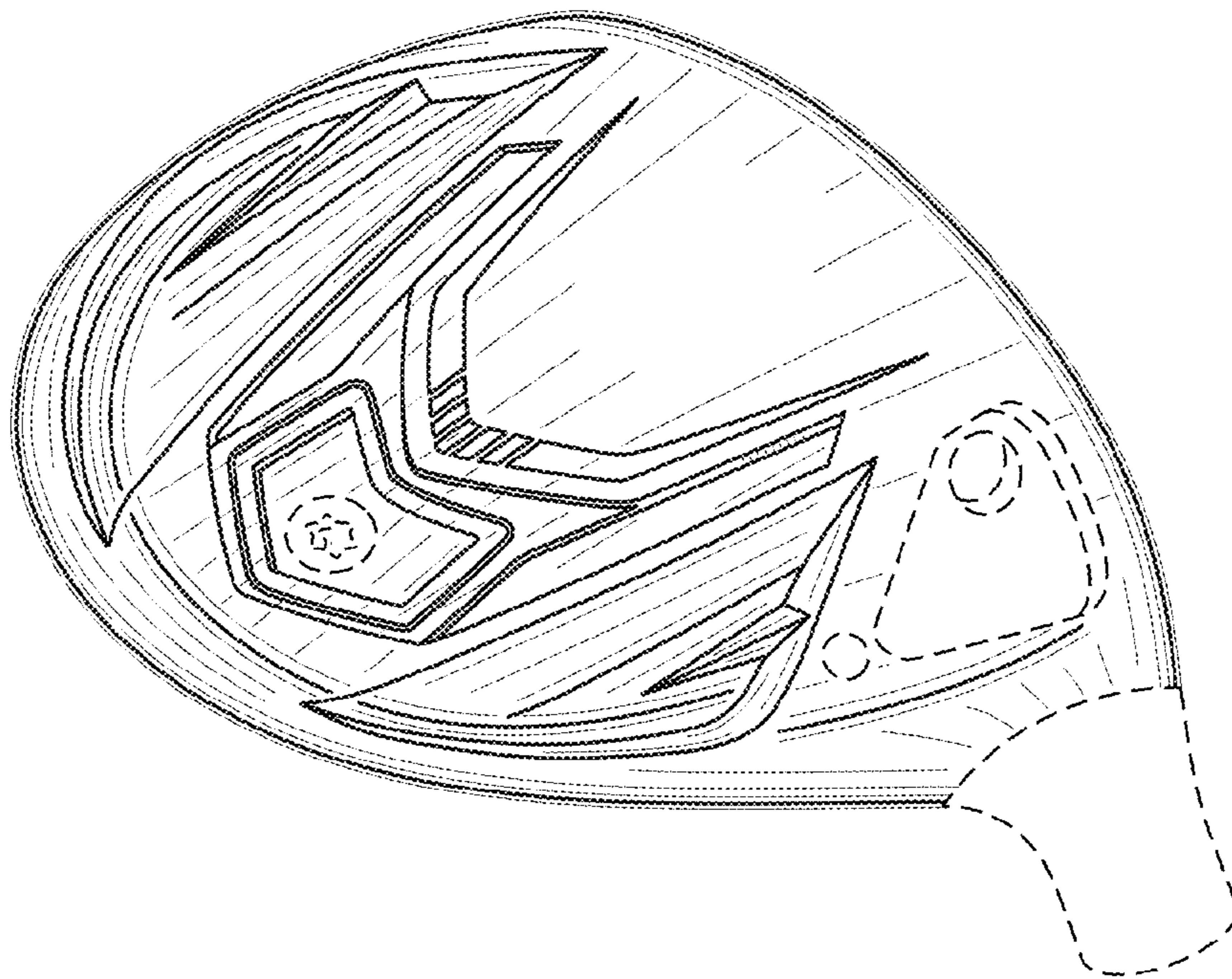
(57) **CLAIM**

The ornamental design for a sole of a golf club head, as shown and described.

**DESCRIPTION**

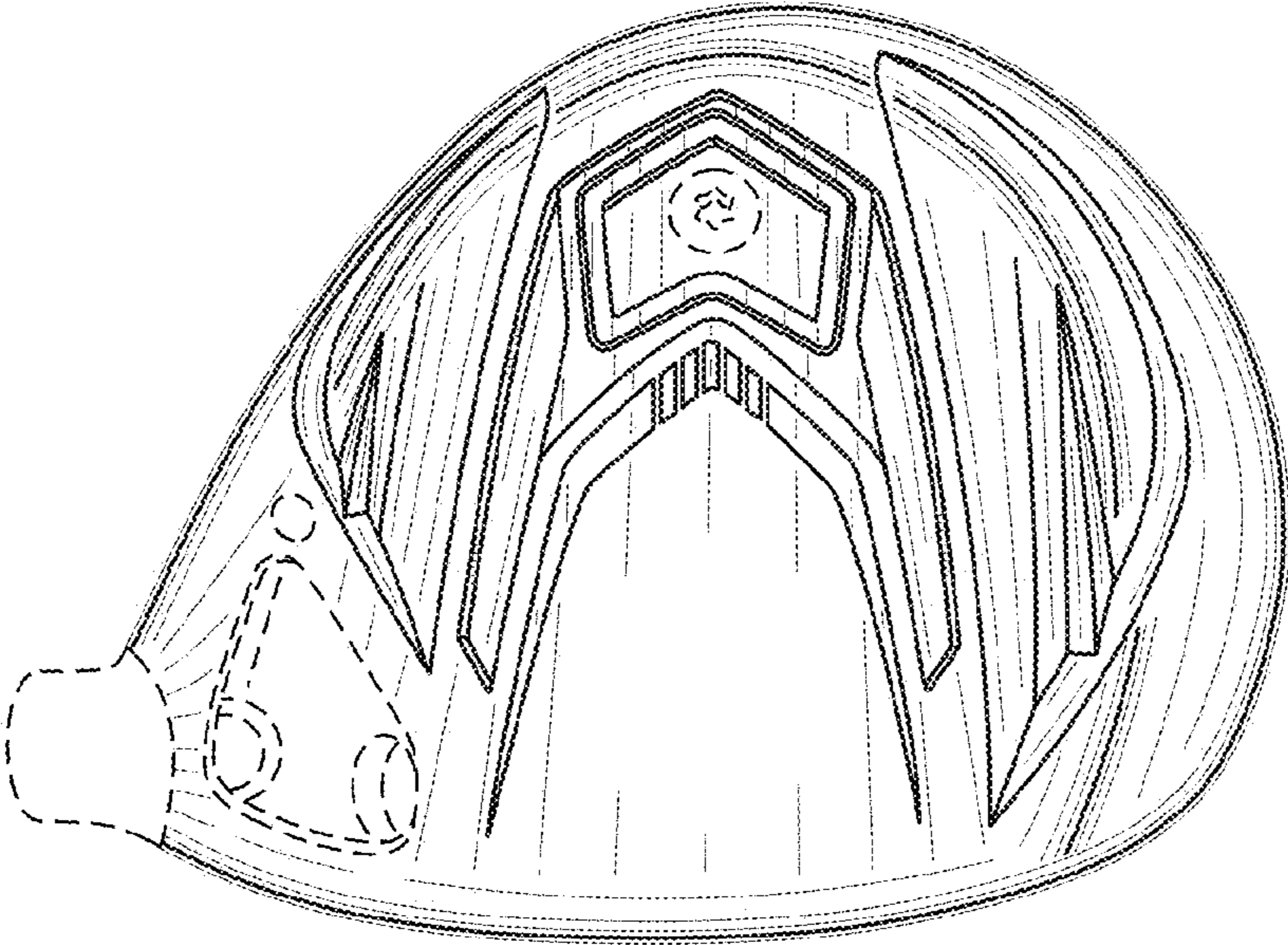

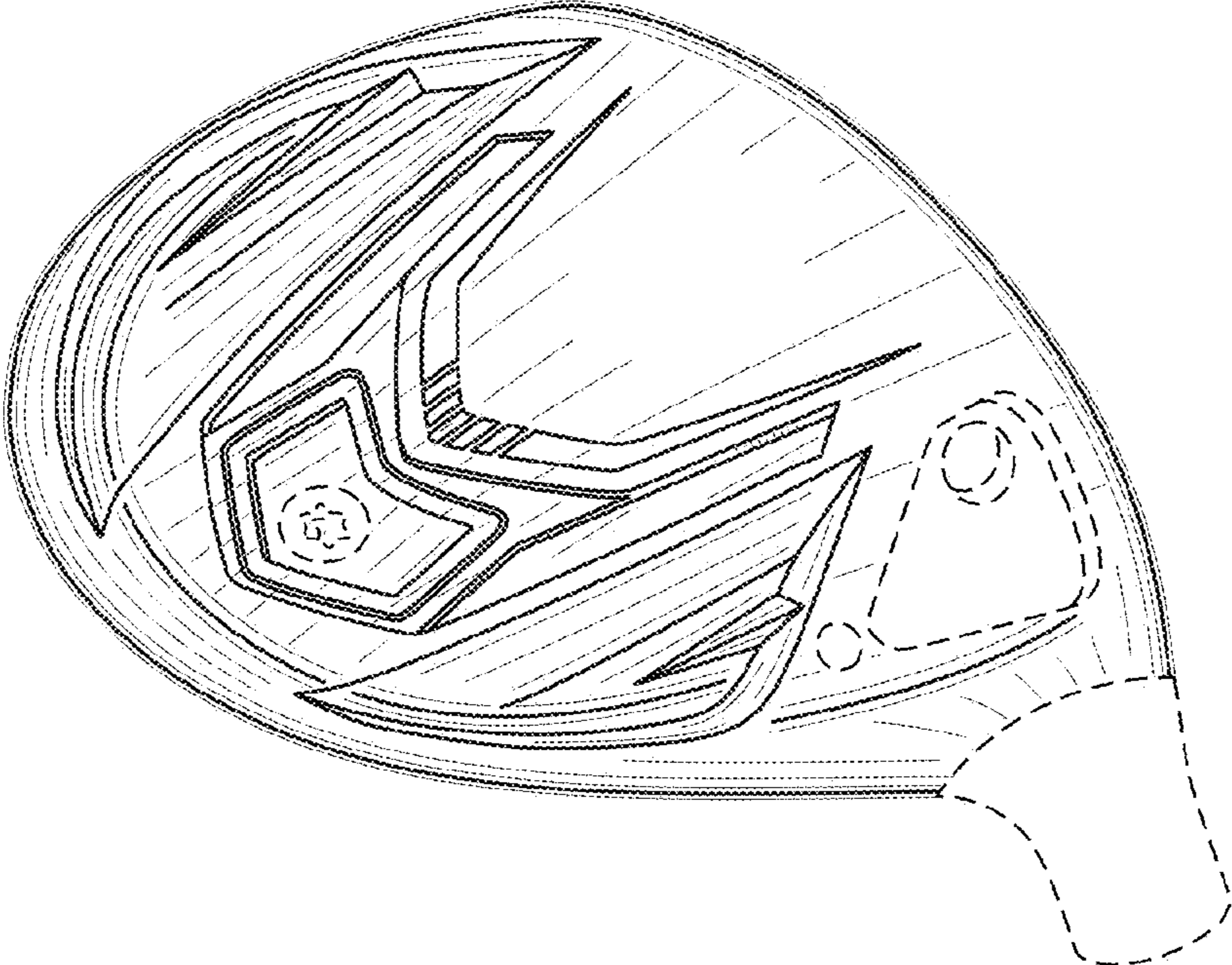
