FIG. 2 is a front view of the boiler exterior case of FIG. 1.

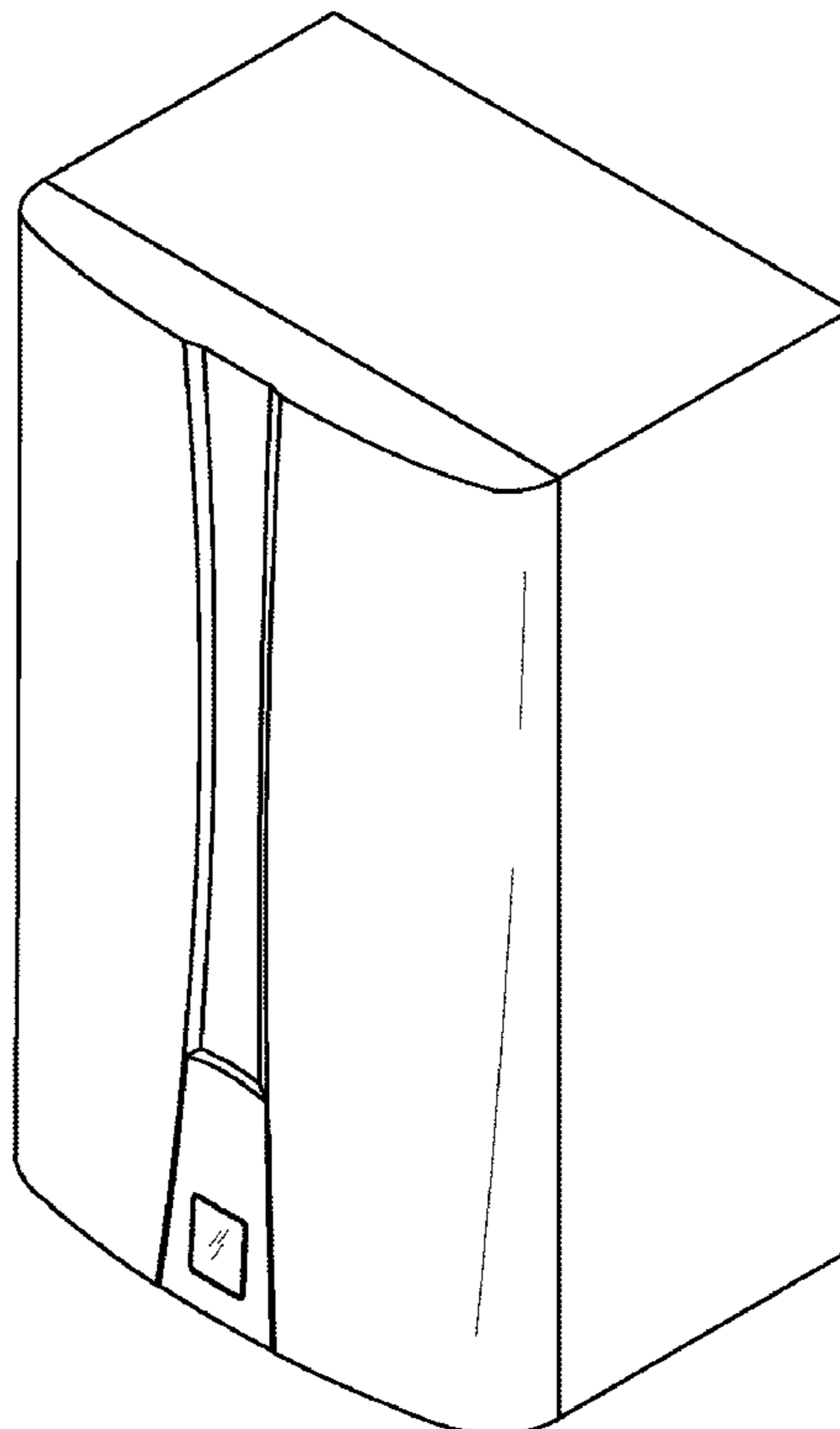
FIG. 3 is a rear view of the boiler exterior case of FIG. 1.

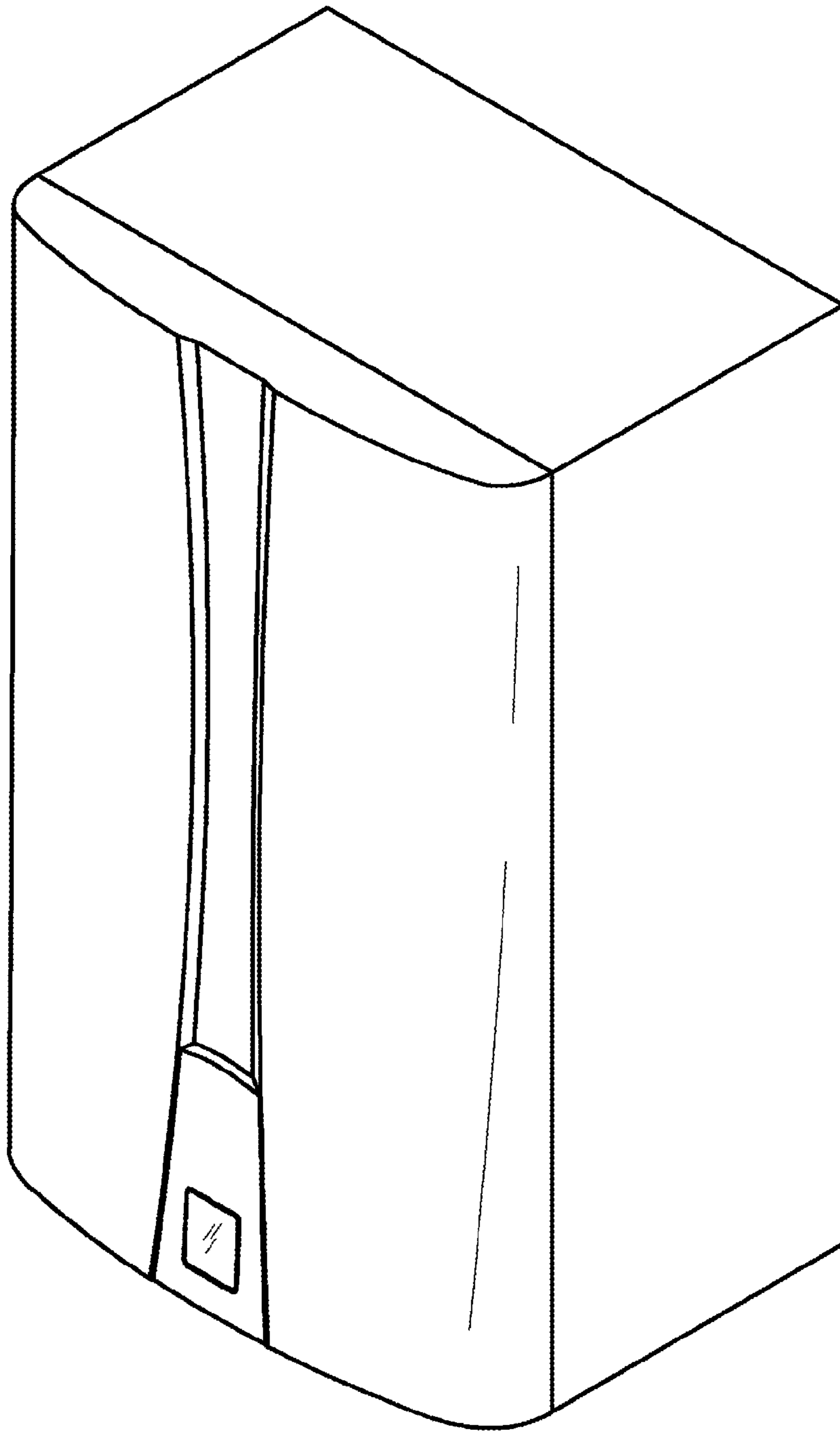

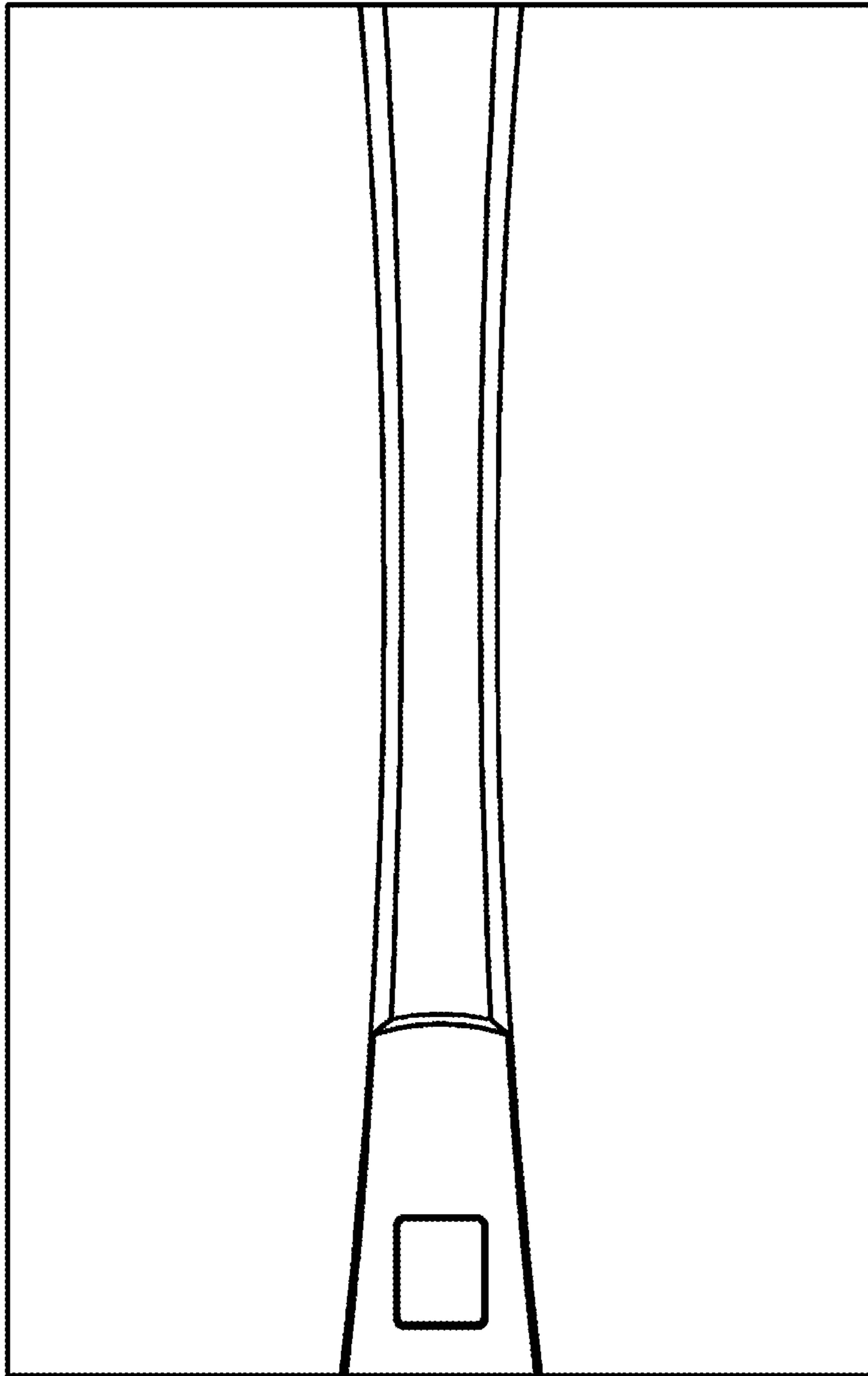
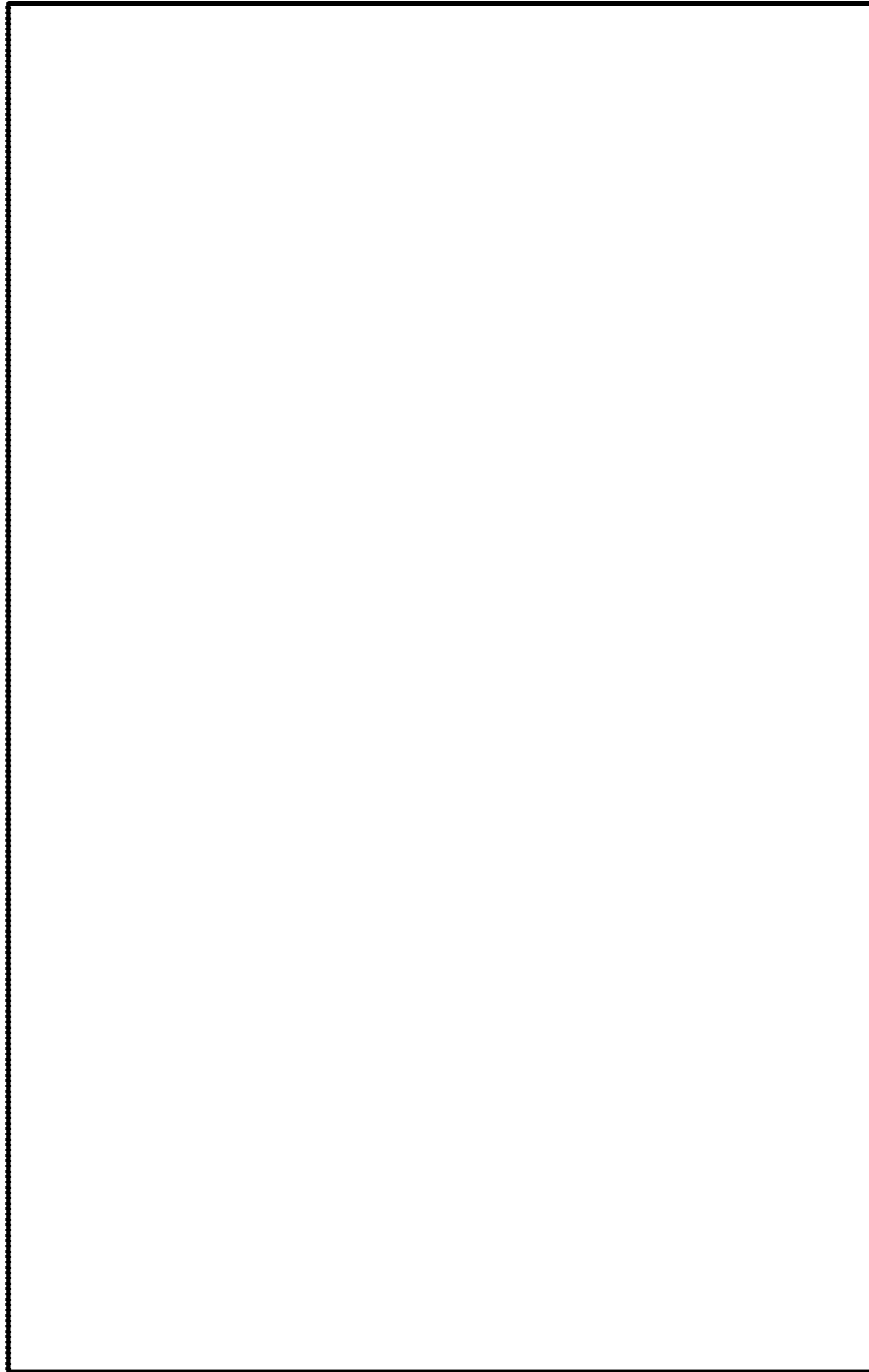

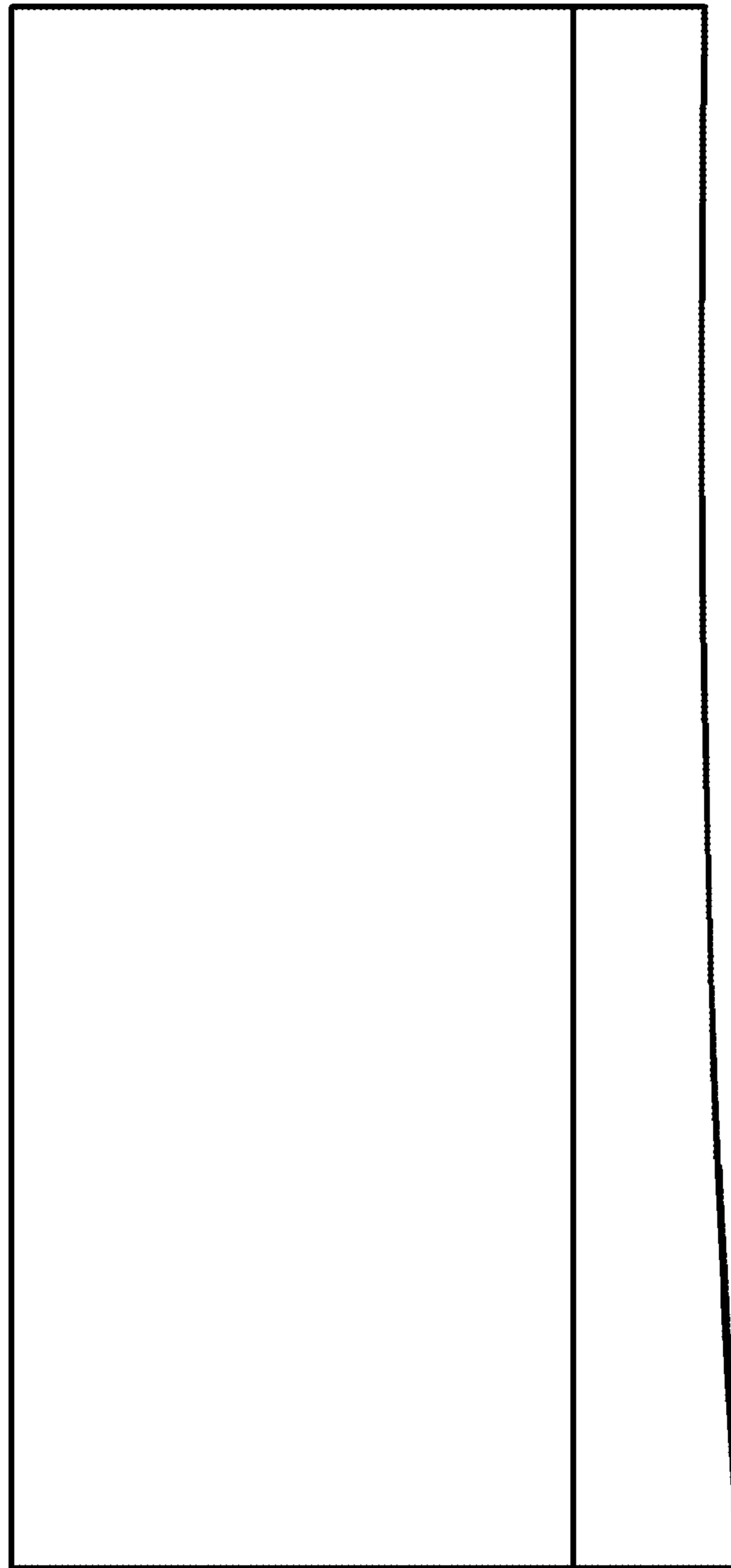

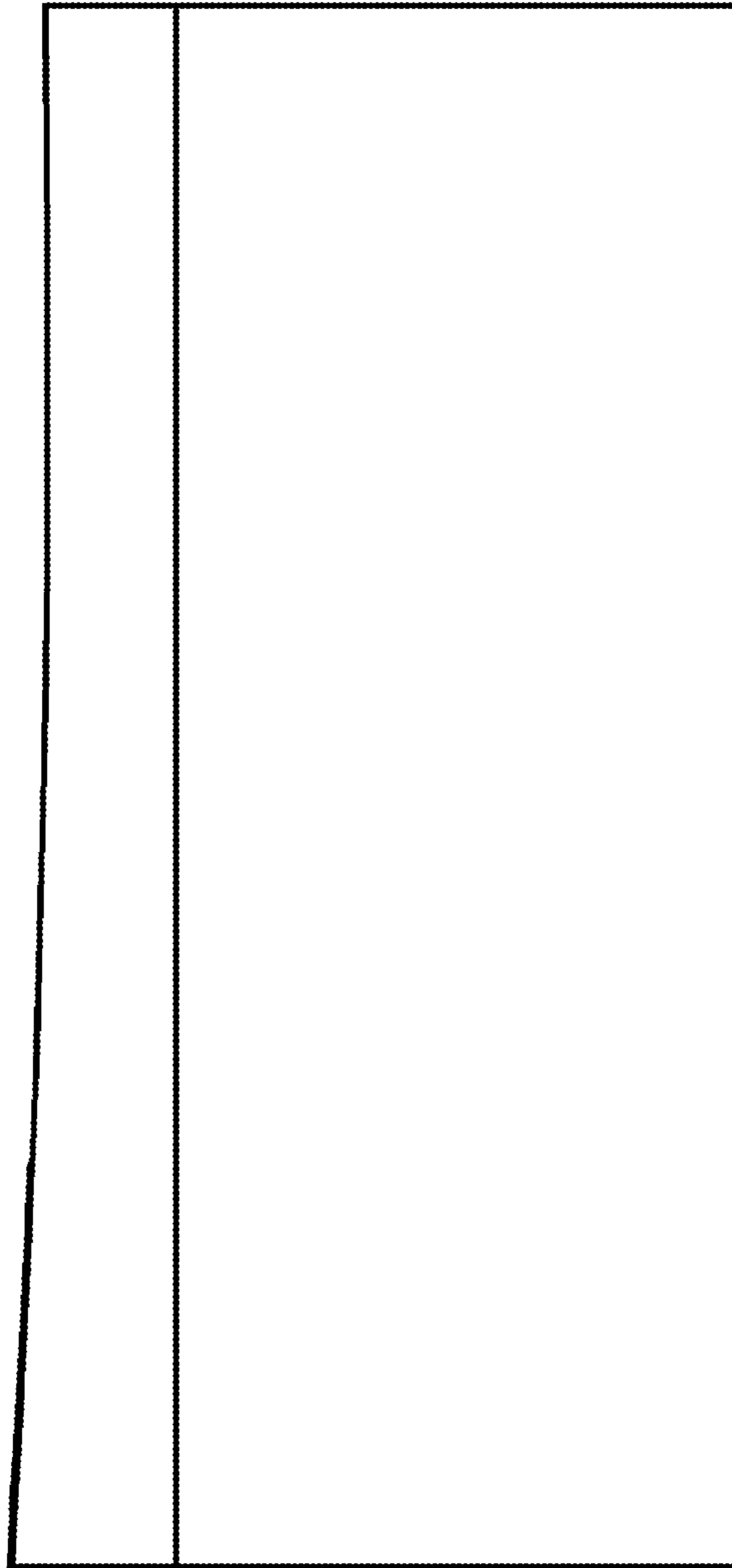

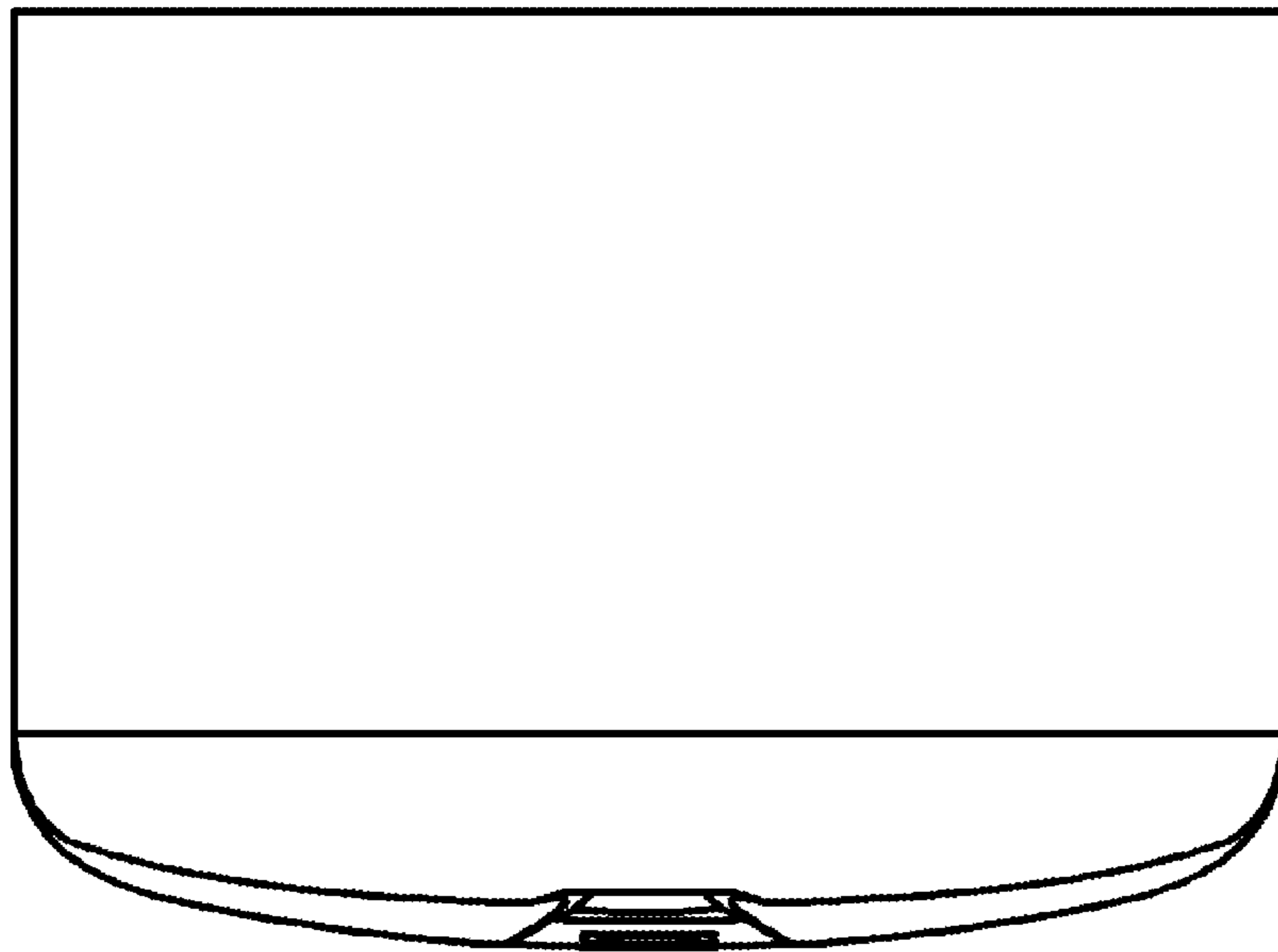

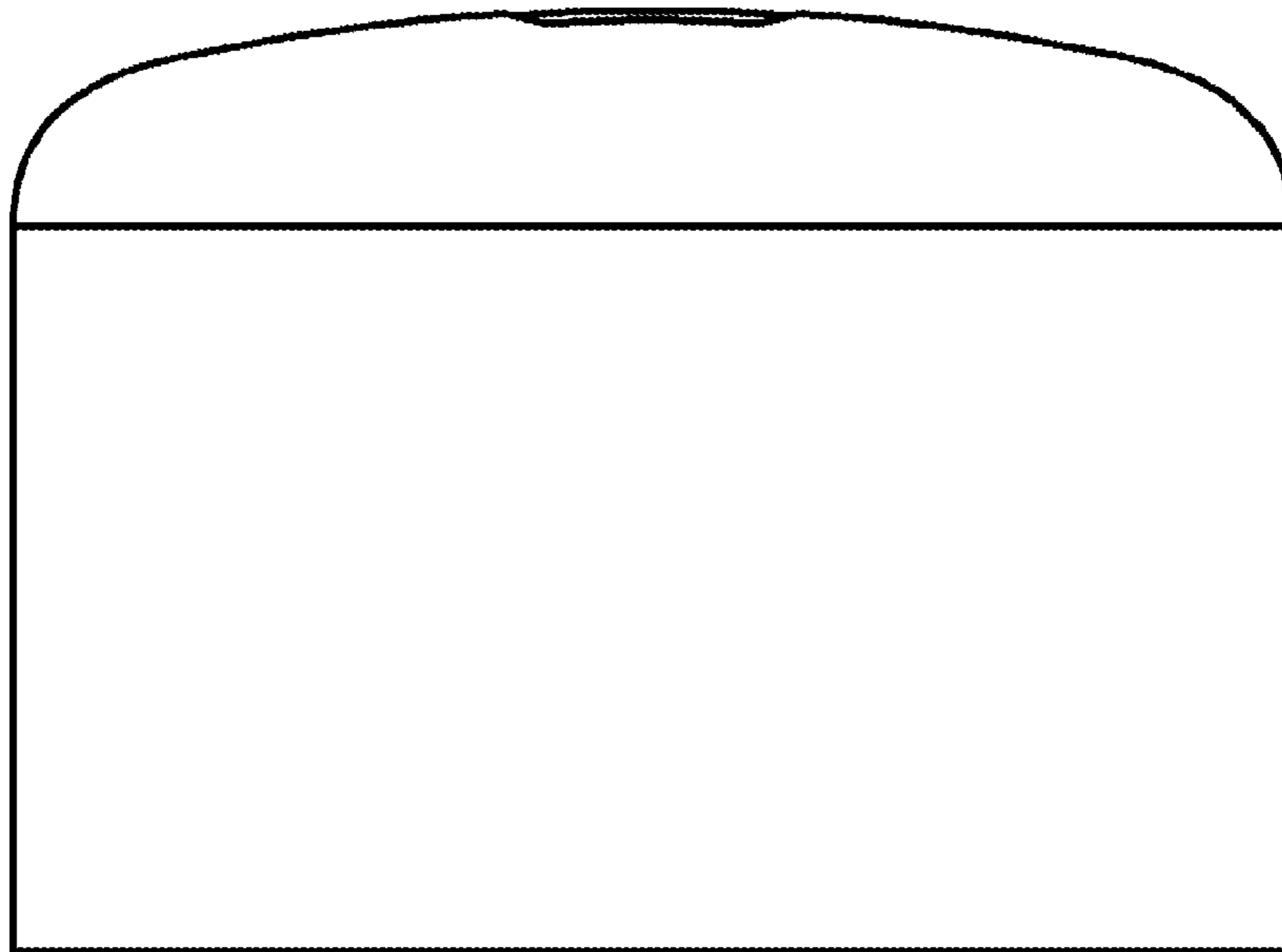
