The ornamental design for a cleaning implement holder, as shown and described.

DESCRIPTION

FIG. 3 is a rear elevational view of a cleaning implement holder;

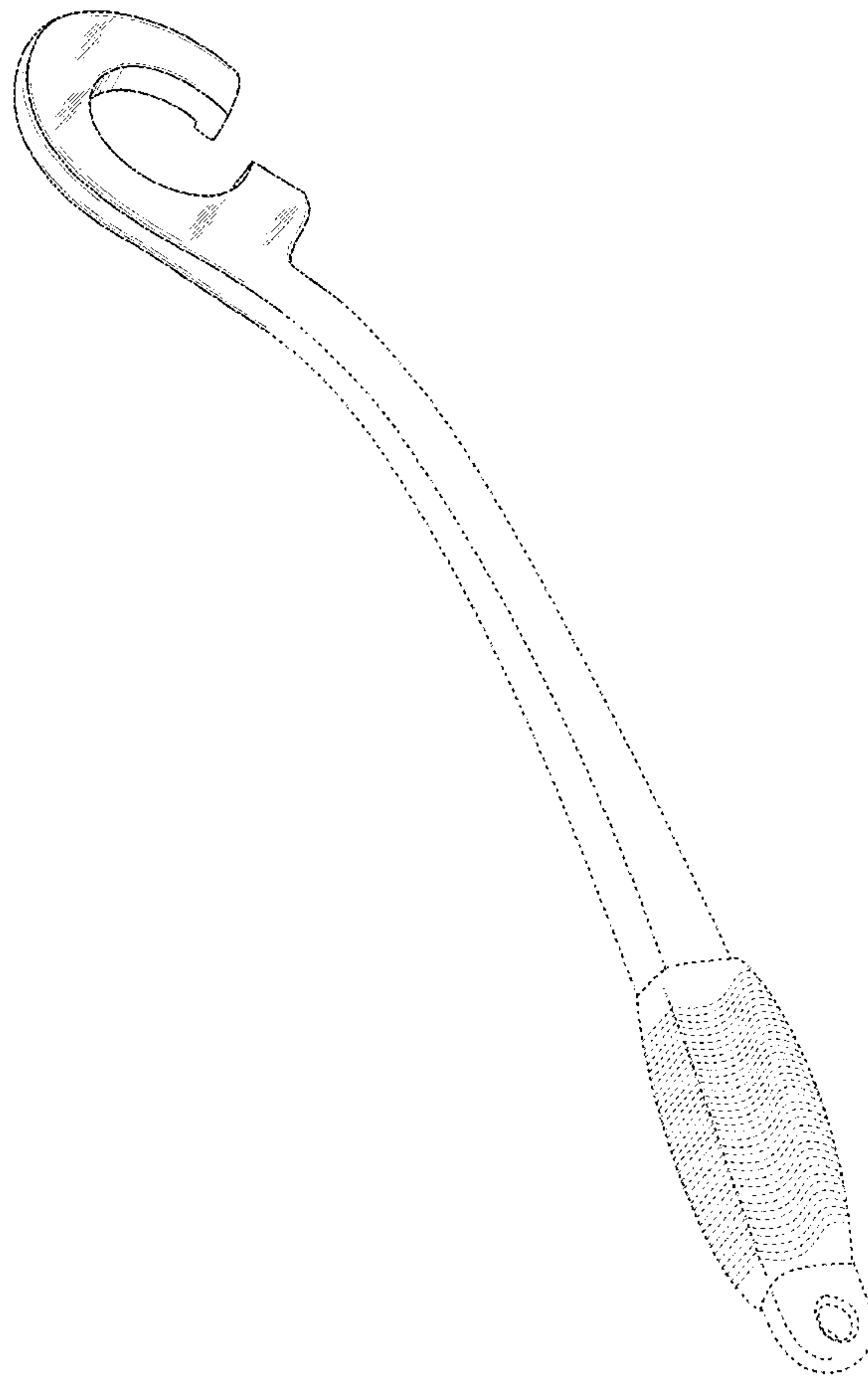
FIG. 4 is a right-side elevational view of a cleaning implement holder;

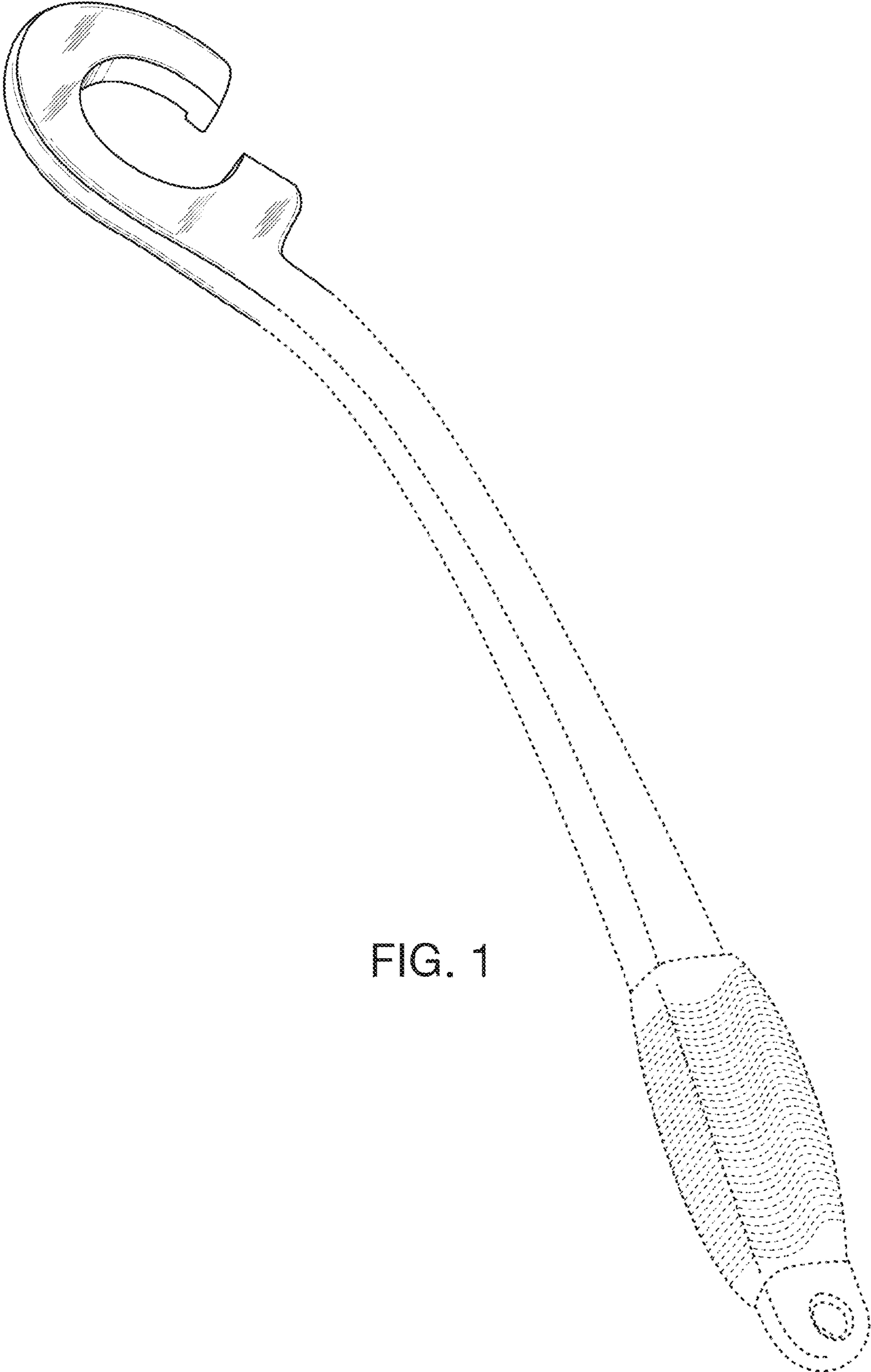

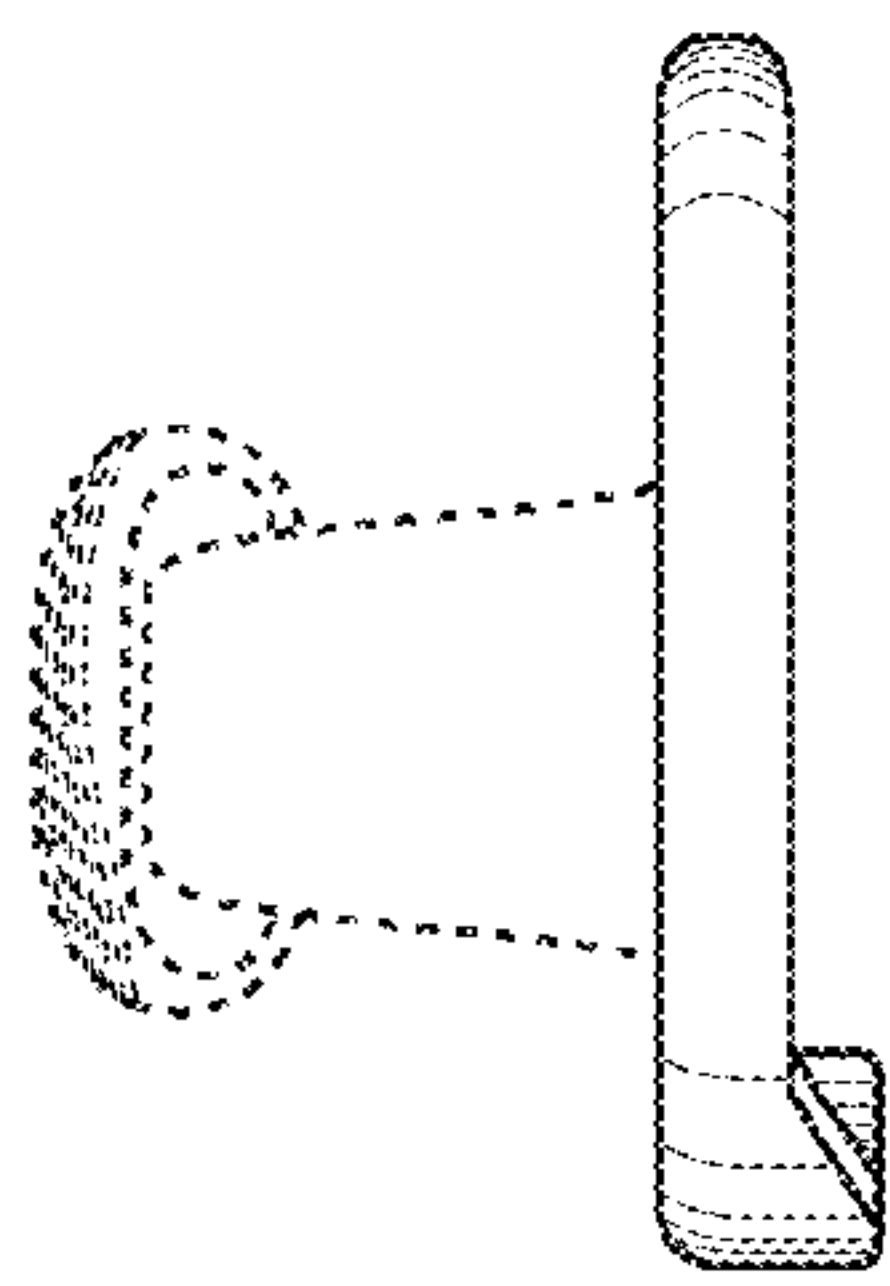

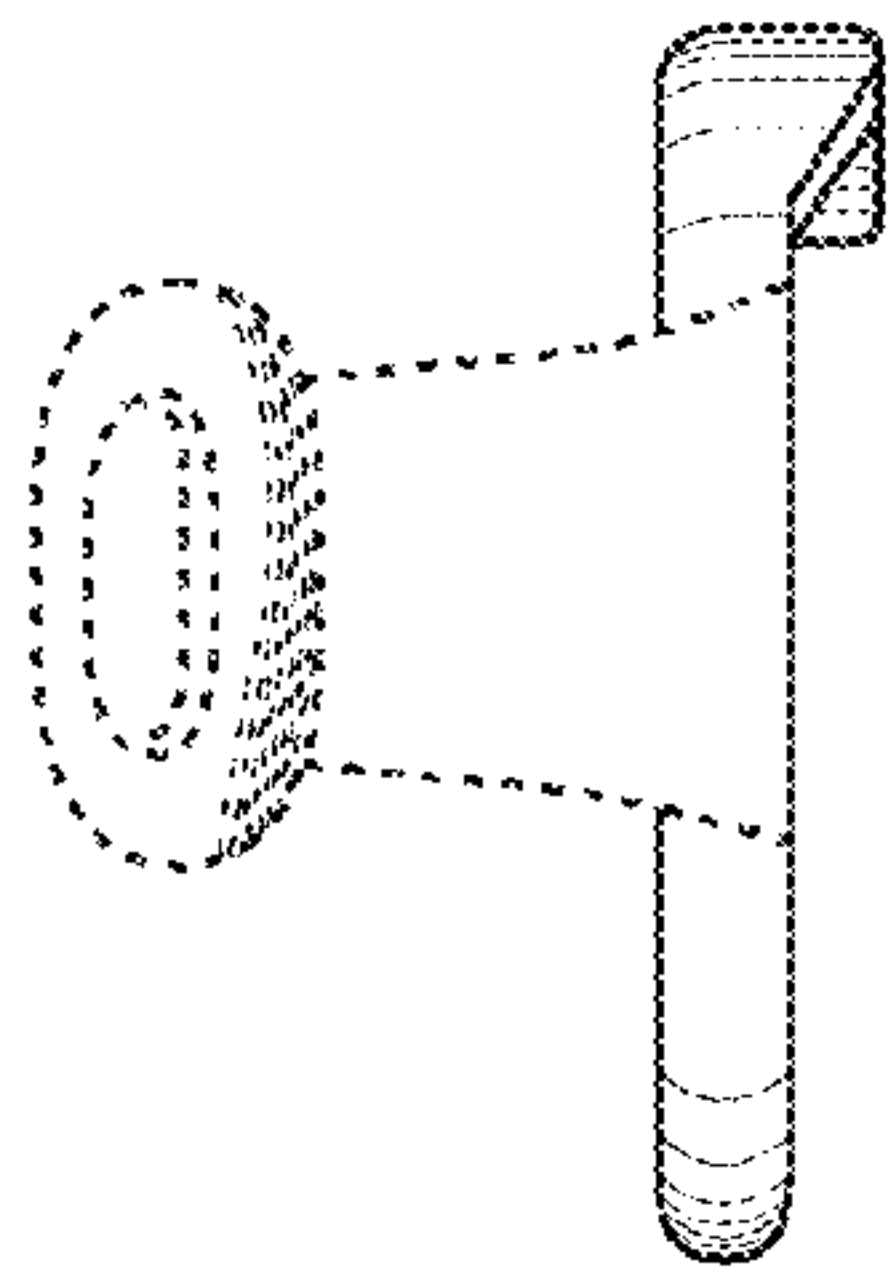

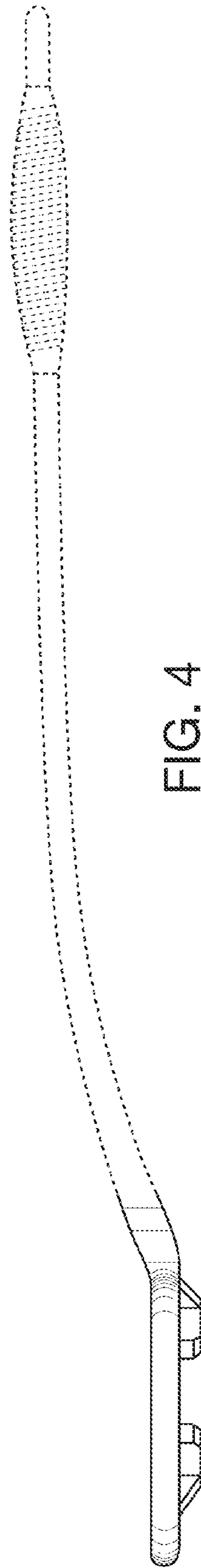

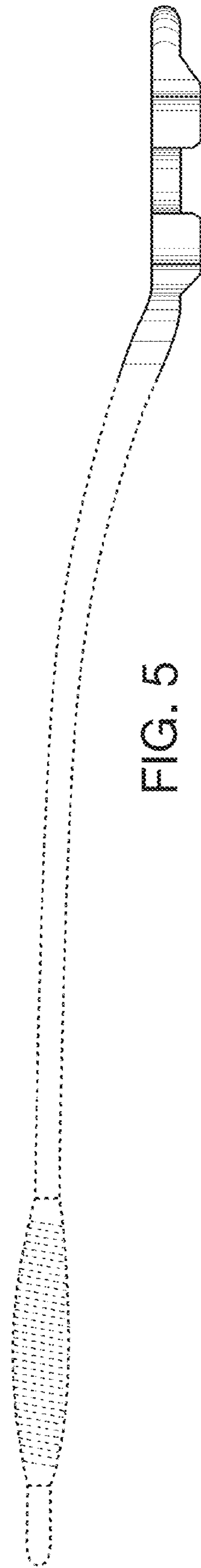

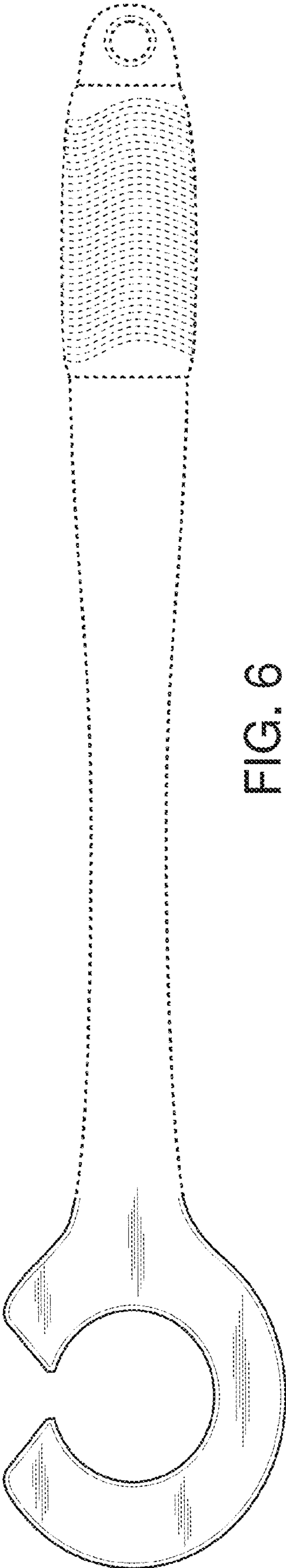

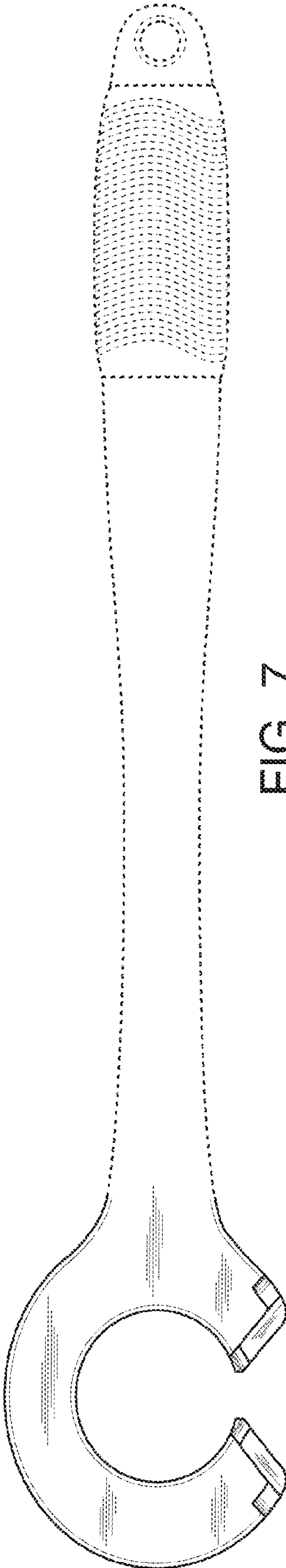
