embodying a new design;

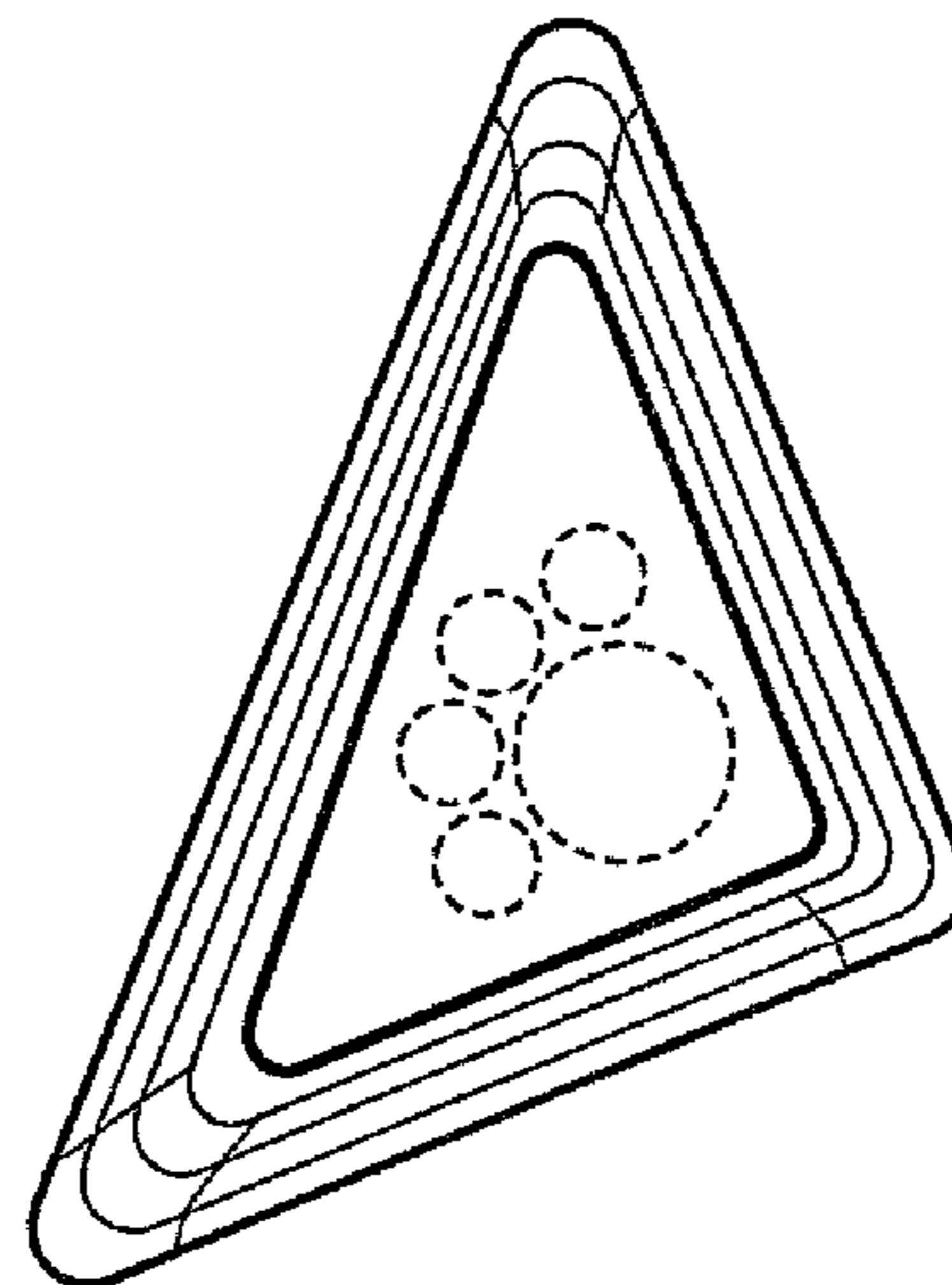
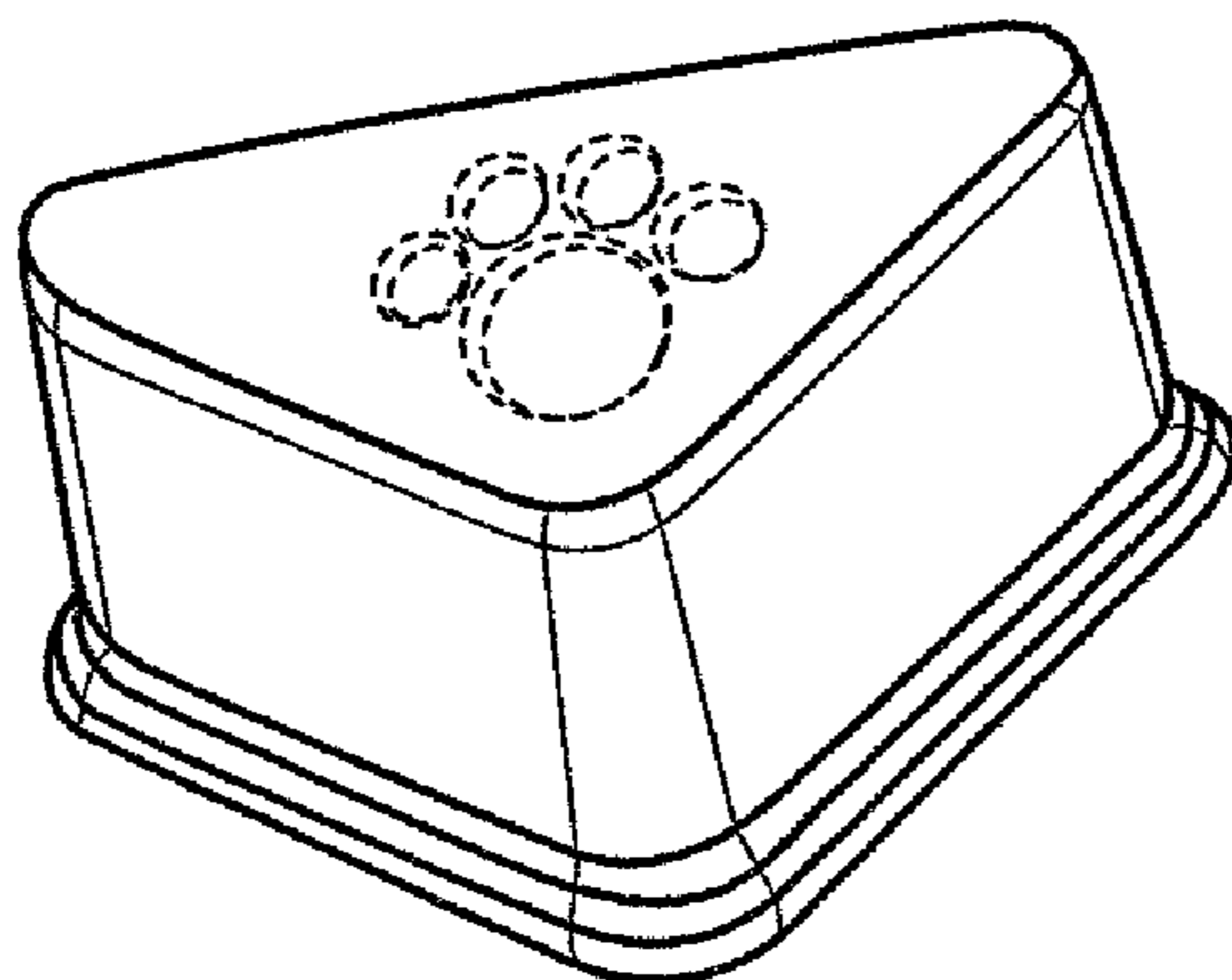
FIG. 2 is a top view thereof;

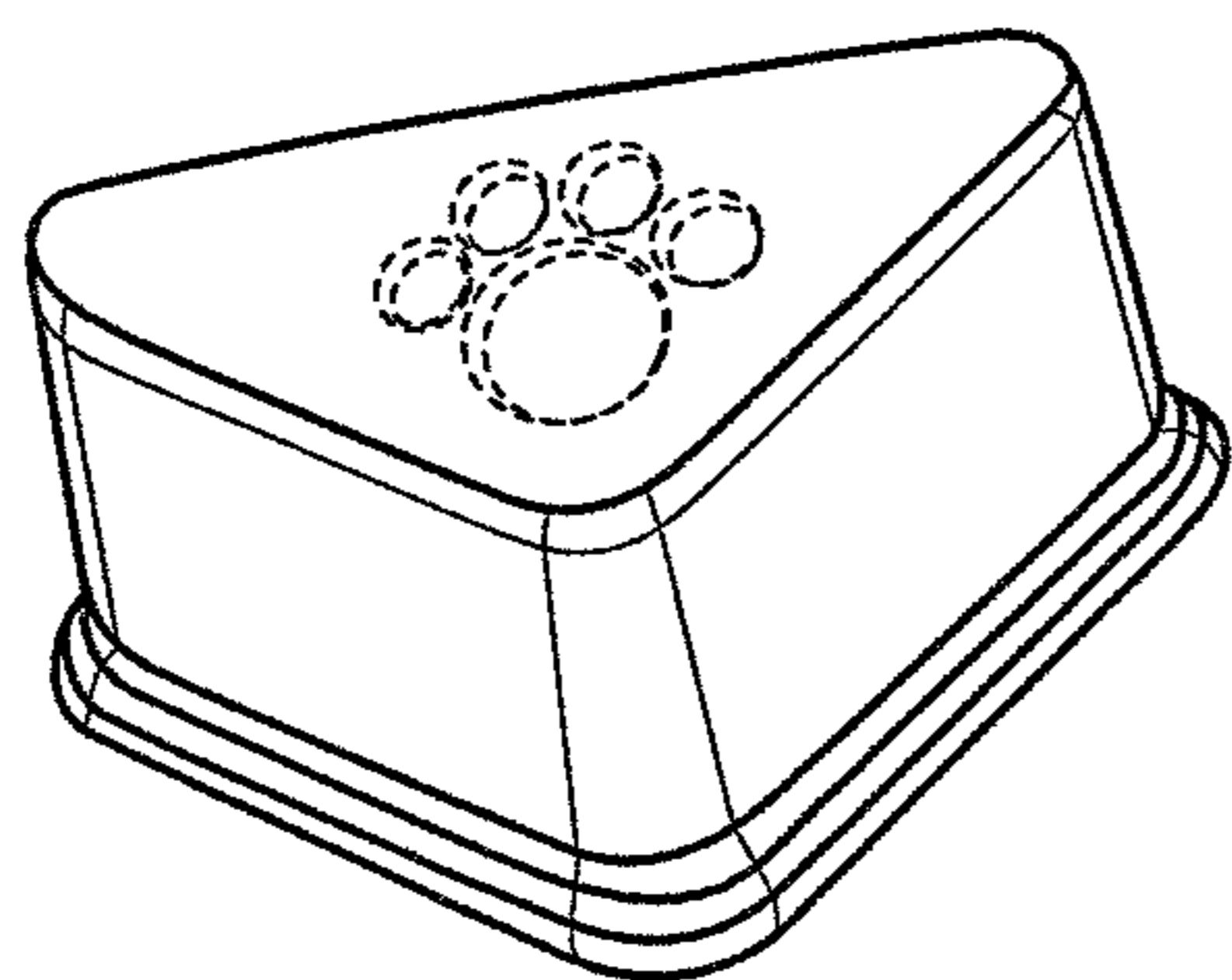

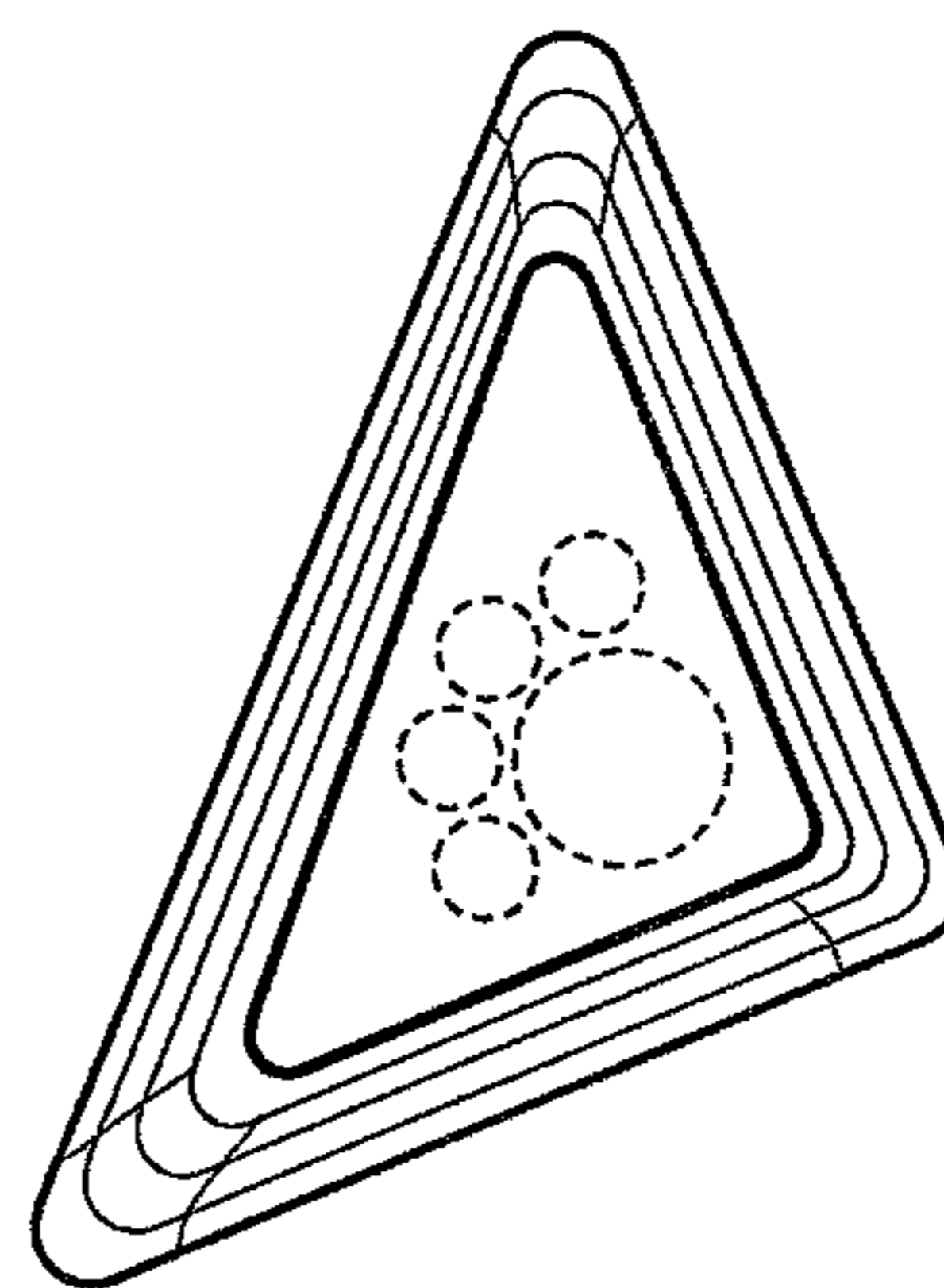

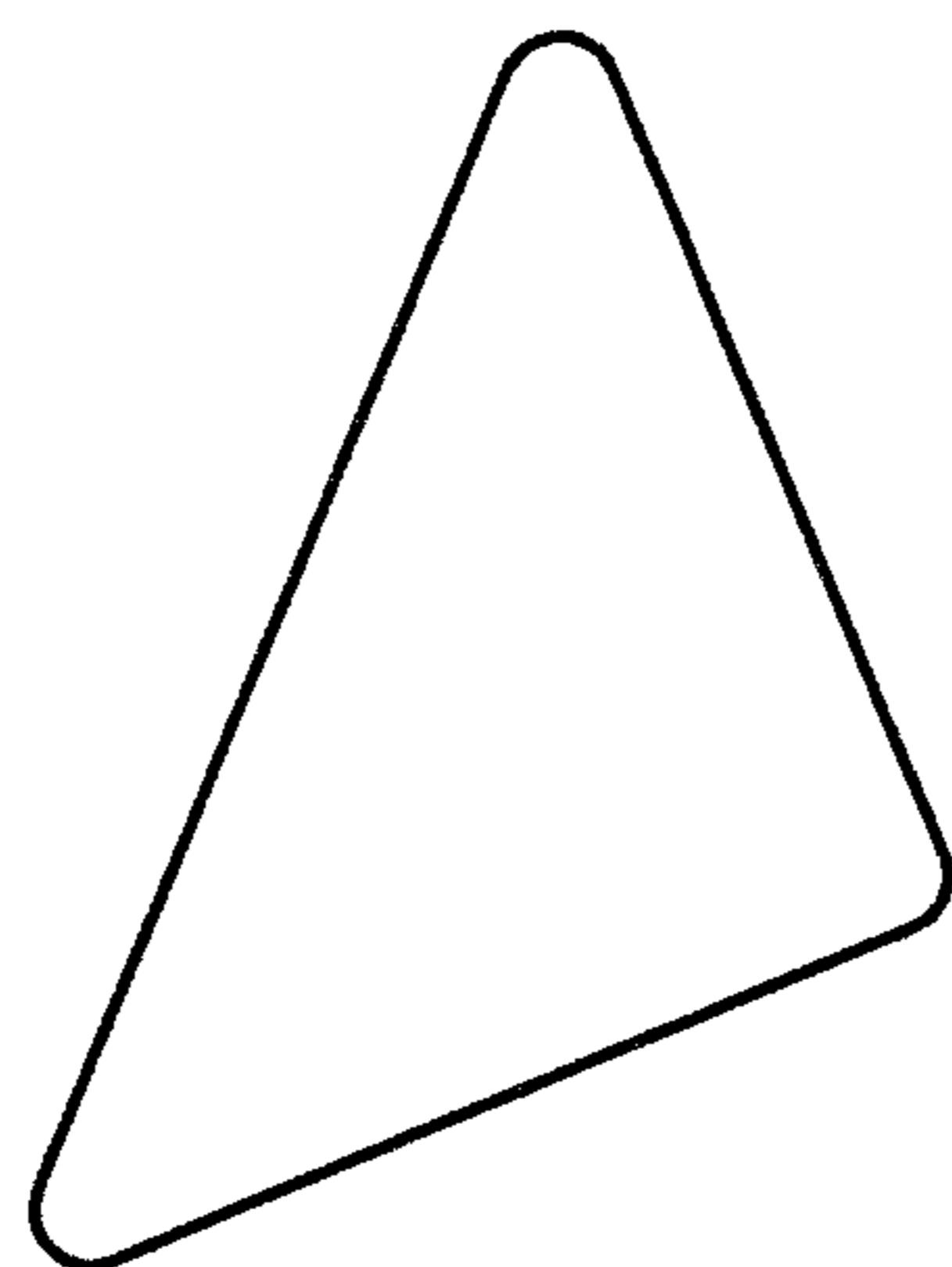

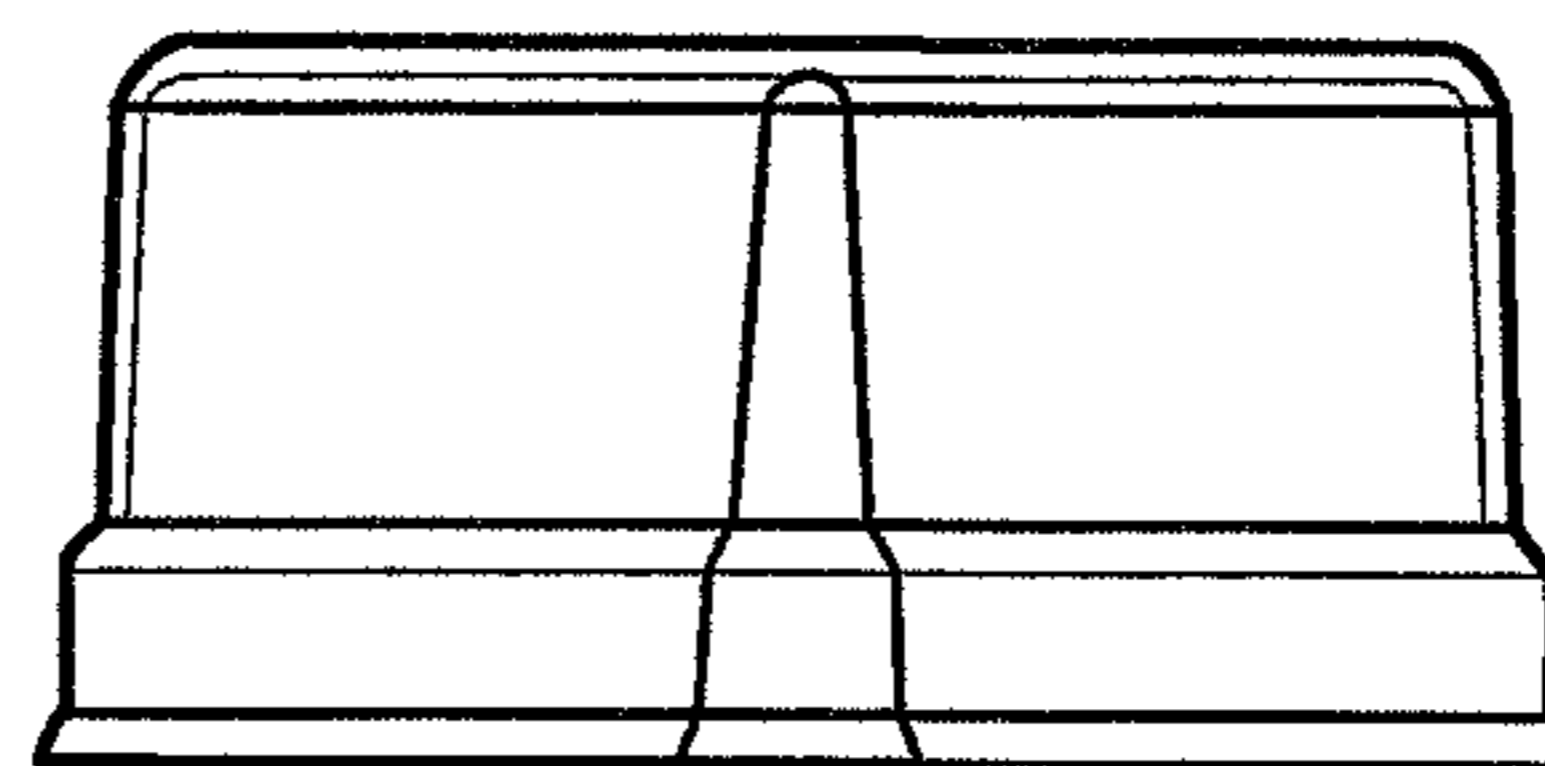
