(57) **CLAIM**

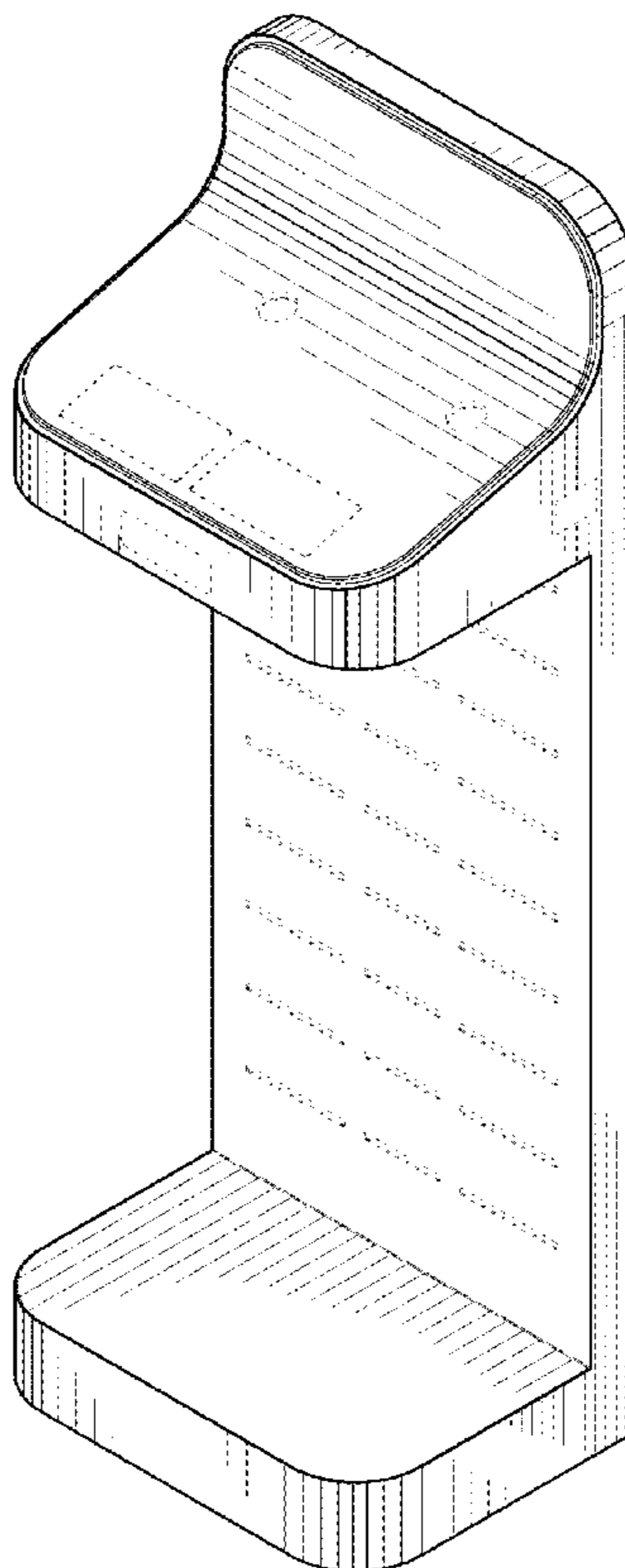
We claim the ornamental design for a retail display fixture, as shown and described.

**DESCRIPTION**

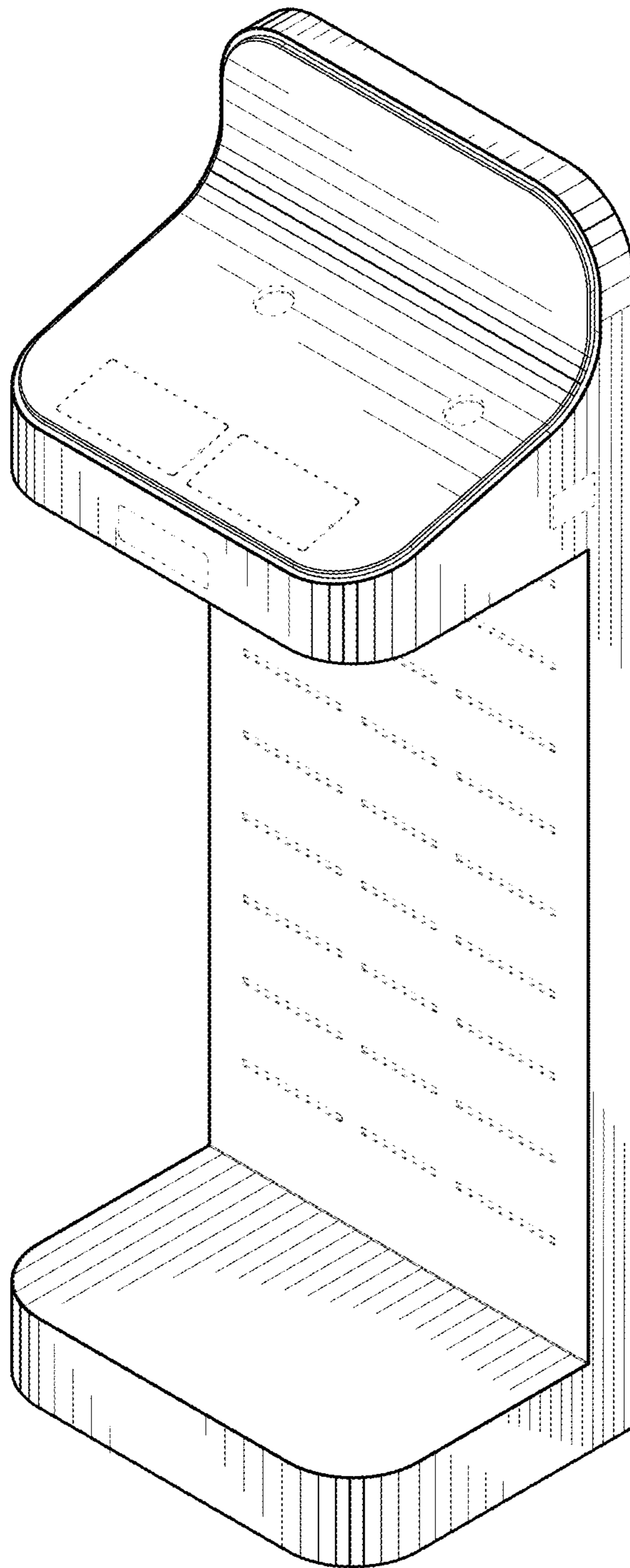

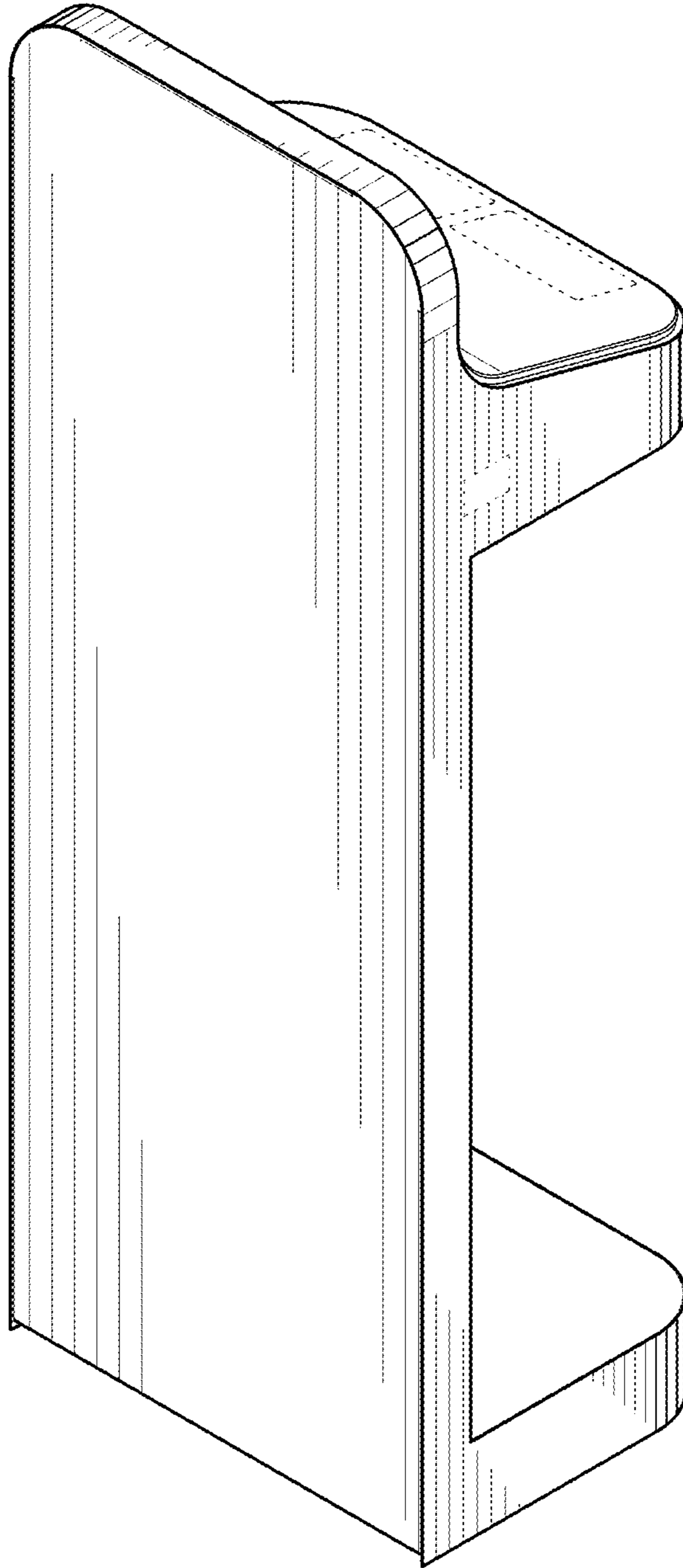

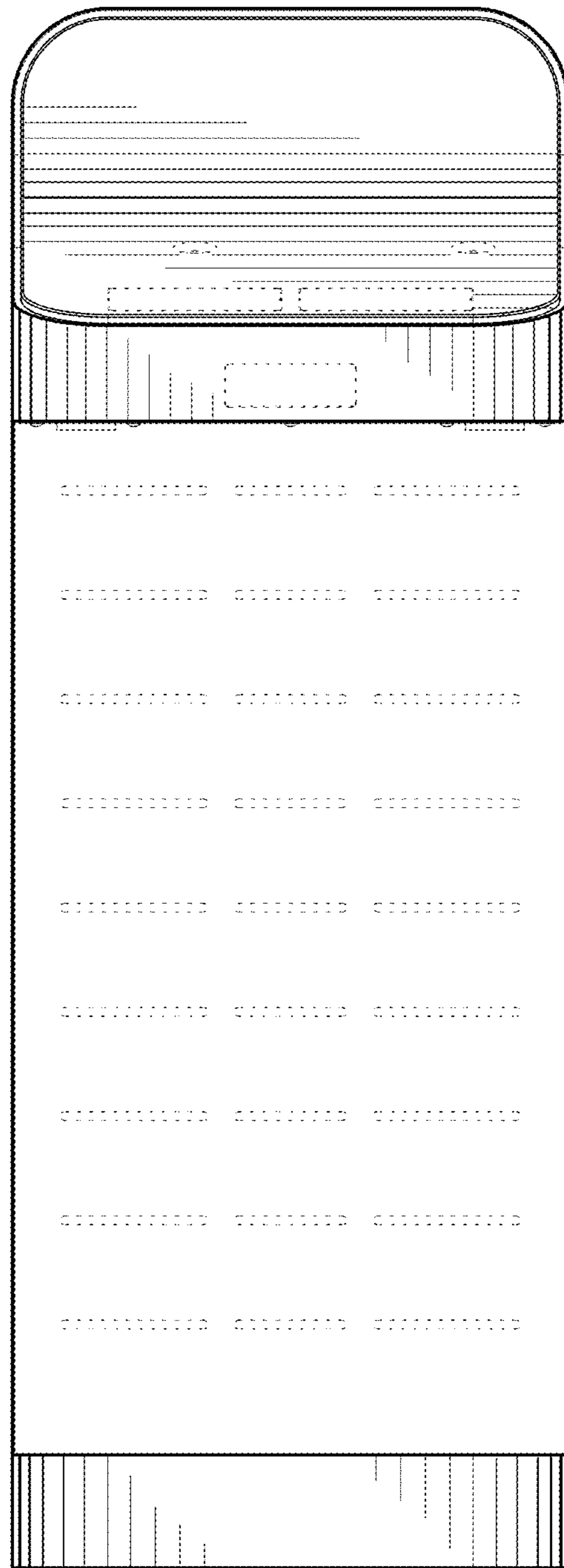

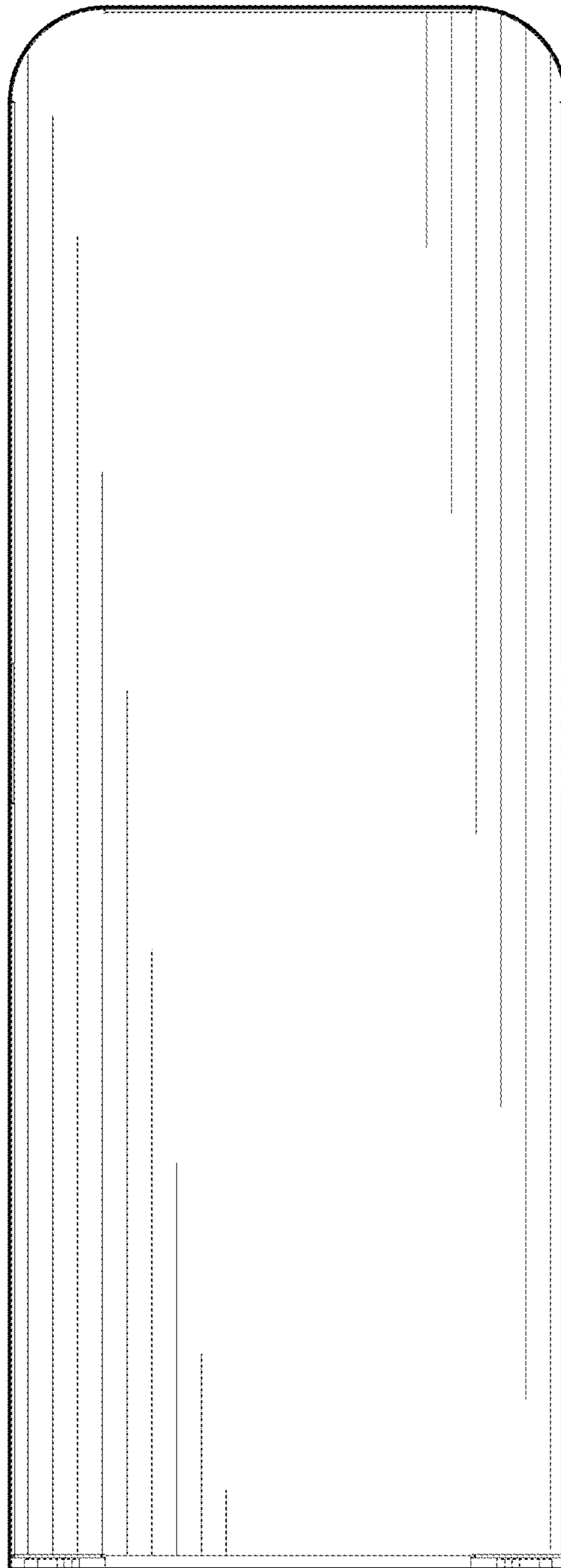

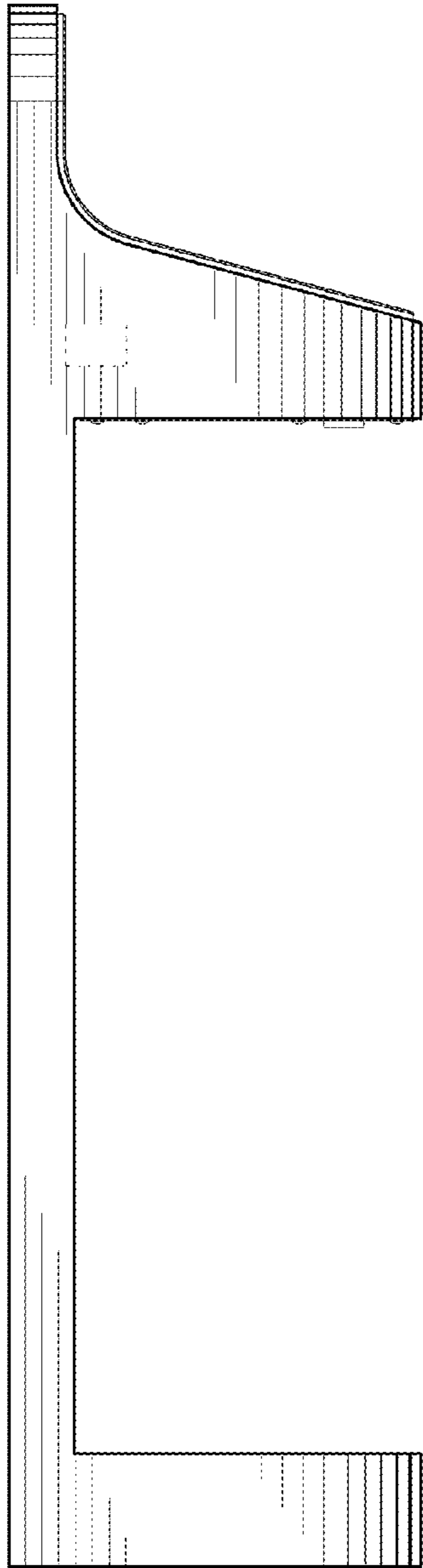

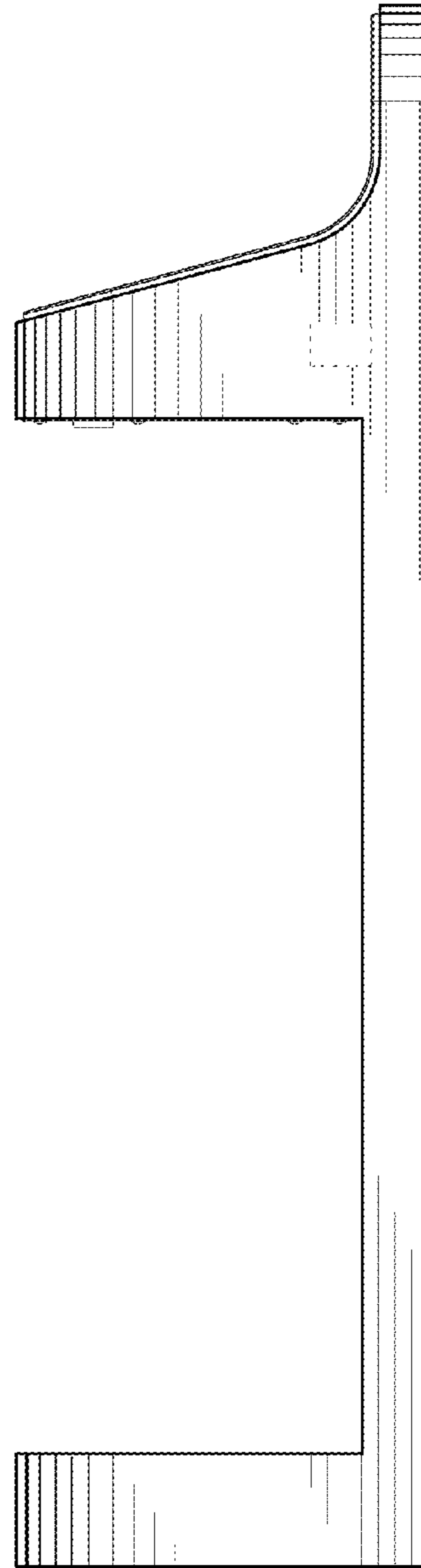

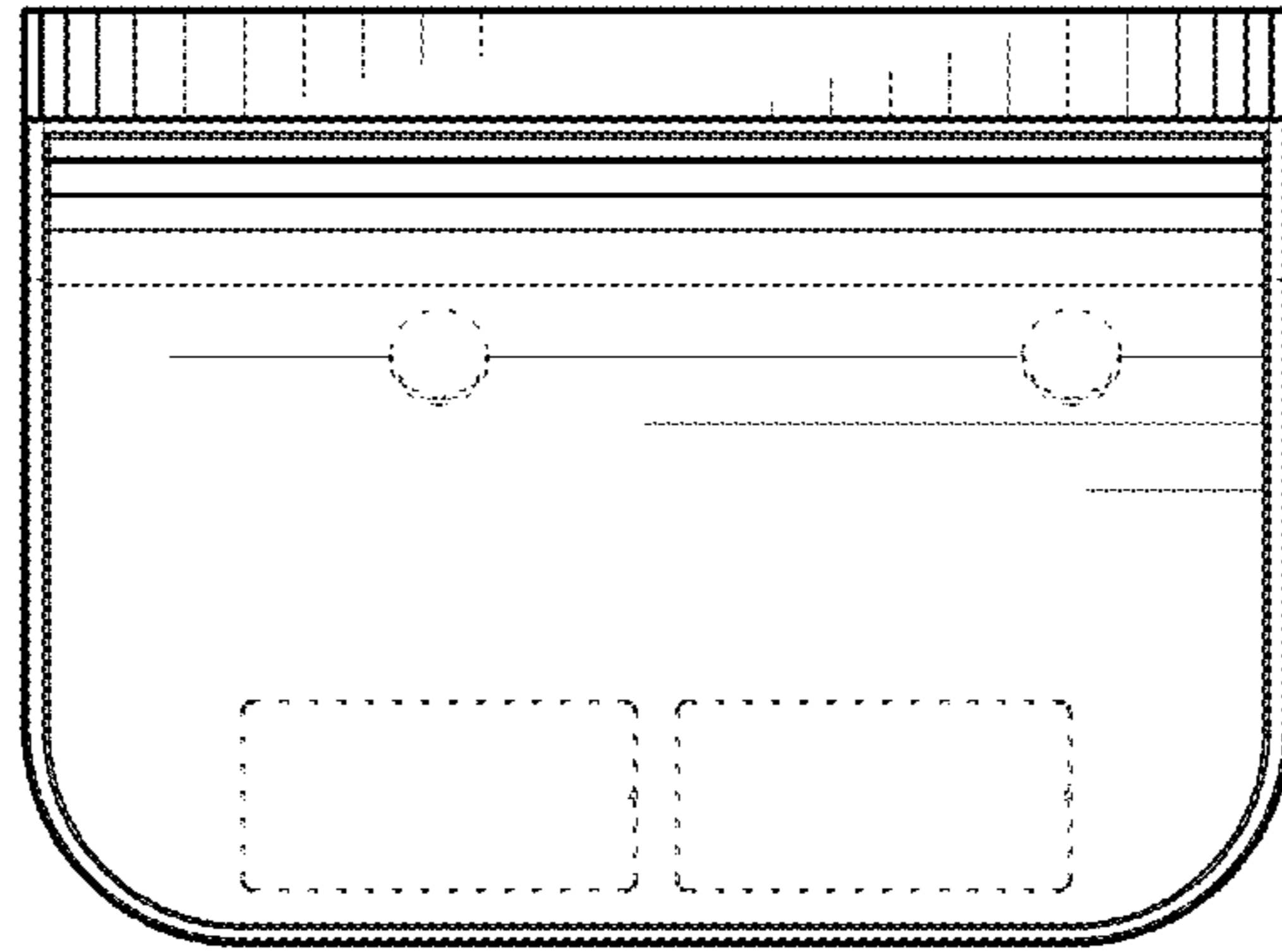

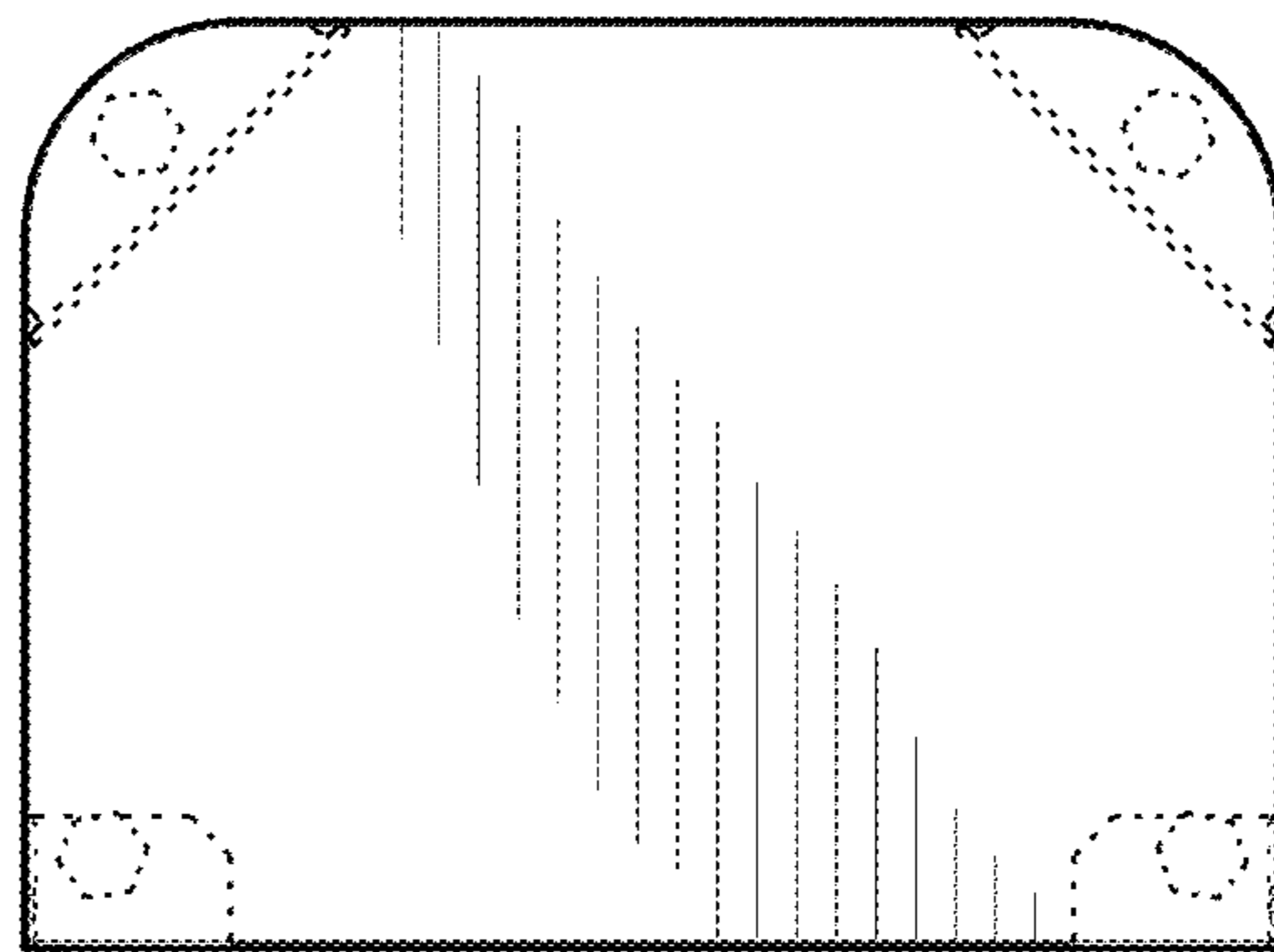
